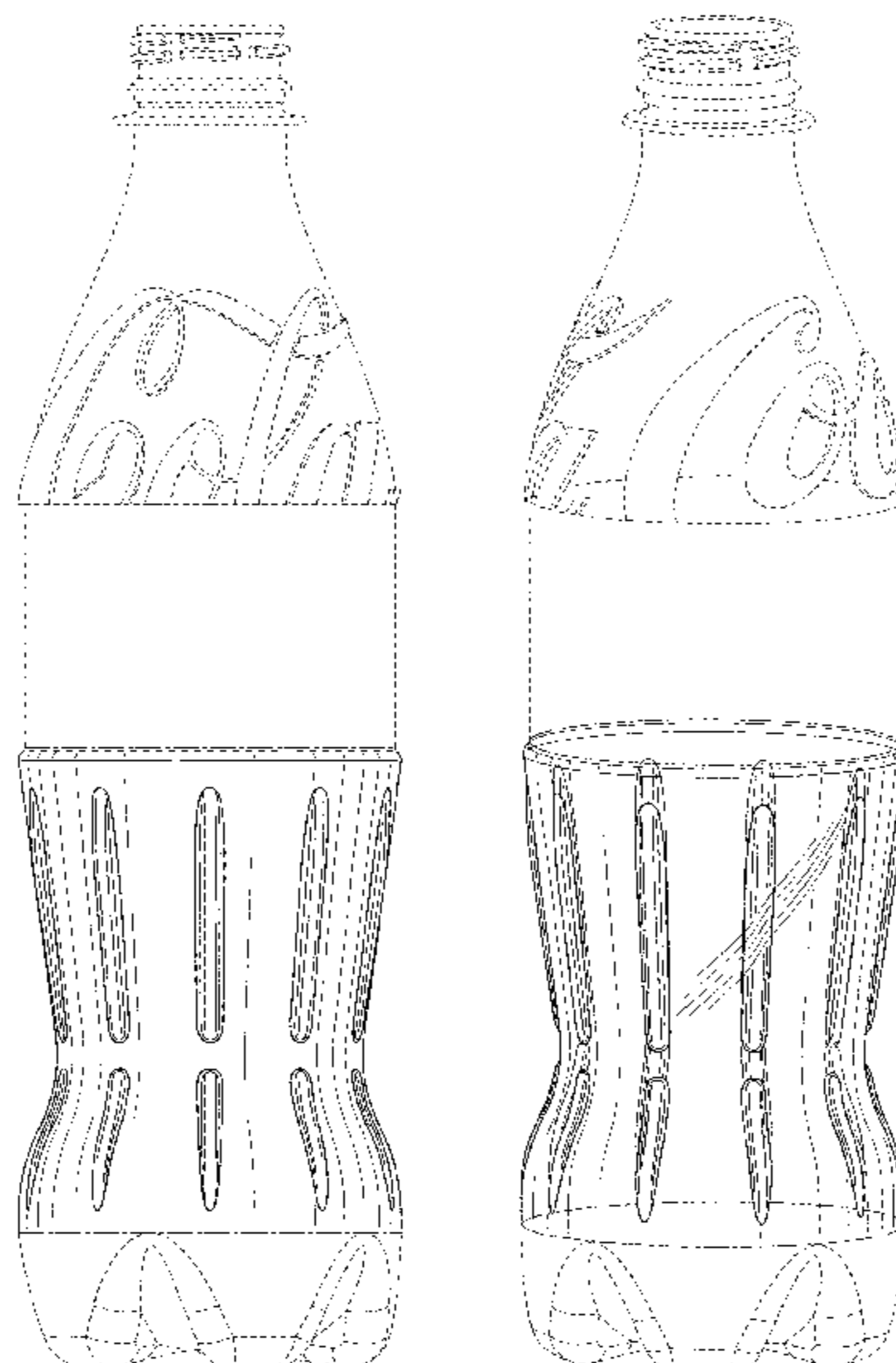
The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a bottle showing our new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a right-side elevation view thereof;
FIG. 5 is a left-side elevation view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a perspective view of a second embodiment of a bottle showing our new design;
FIG. 9 is a front elevation view thereof;
FIG. 10 is a rear elevation view thereof;
FIG. 11 is a right-side elevation view thereof;
FIG. 12 is a left-side elevation view thereof;
FIG. 13 is a top plan view thereof;
FIG. 14 is a bottom plan view thereof;
FIG. 15 is a perspective view of a third embodiment of a bottle showing our new design;
FIG. 16 is a front elevation view thereof;
FIG. 17 is a rear elevation view thereof;
FIG. 18 is a right-side elevation view thereof;
FIG. 19 is a left-side elevation view thereof;
FIG. 20 is a top plan view thereof; and,
FIG. 21 is a bottom plan view thereof.

The dot-dash broken lines in the drawings define the boundaries of the claimed design and form no part thereof. The evenly-dashed broken lines in the drawings illustrate portions of the bottle that form no part of the claimed design. The oblique line shading shown in Embodiments 2 and 3 is used to denote claimed surfaces of the bottle that are transparent; in these embodiments, except for in FIG. 8 and 15, the details of the opposing sides as seen through the claimed transparent surfaces of the bottle have not been shown for ease of illustration and understanding.

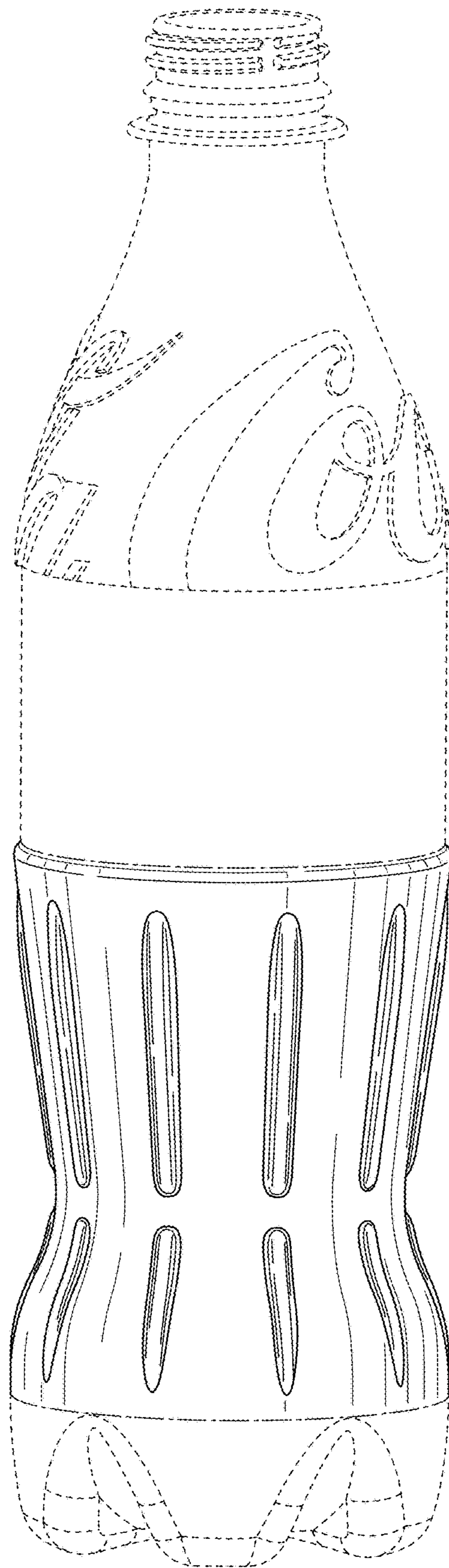

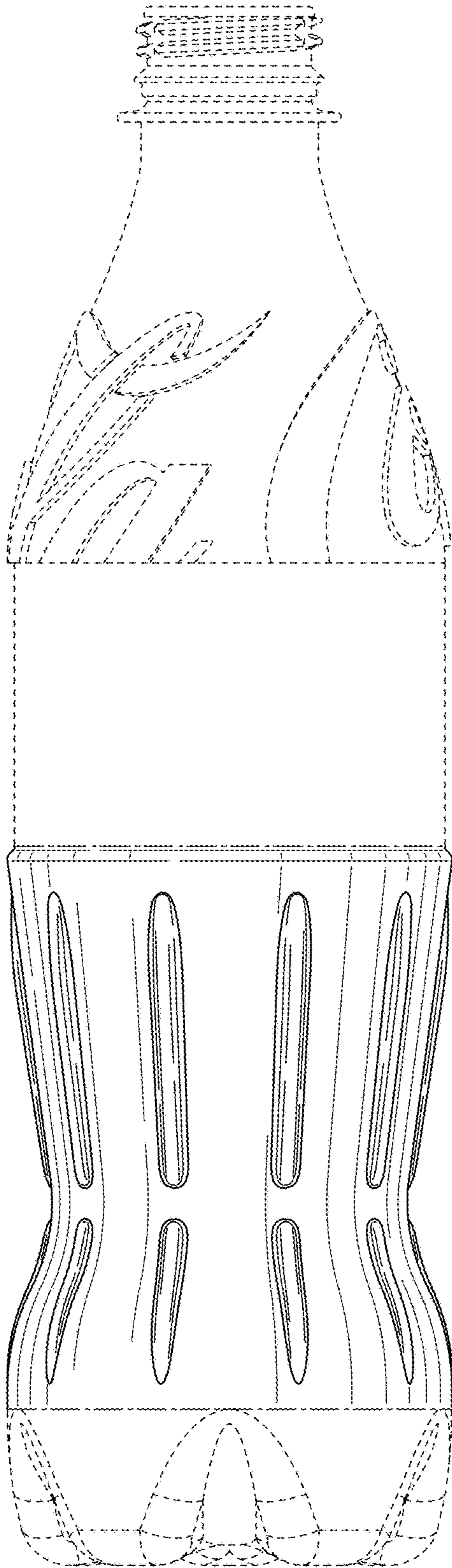

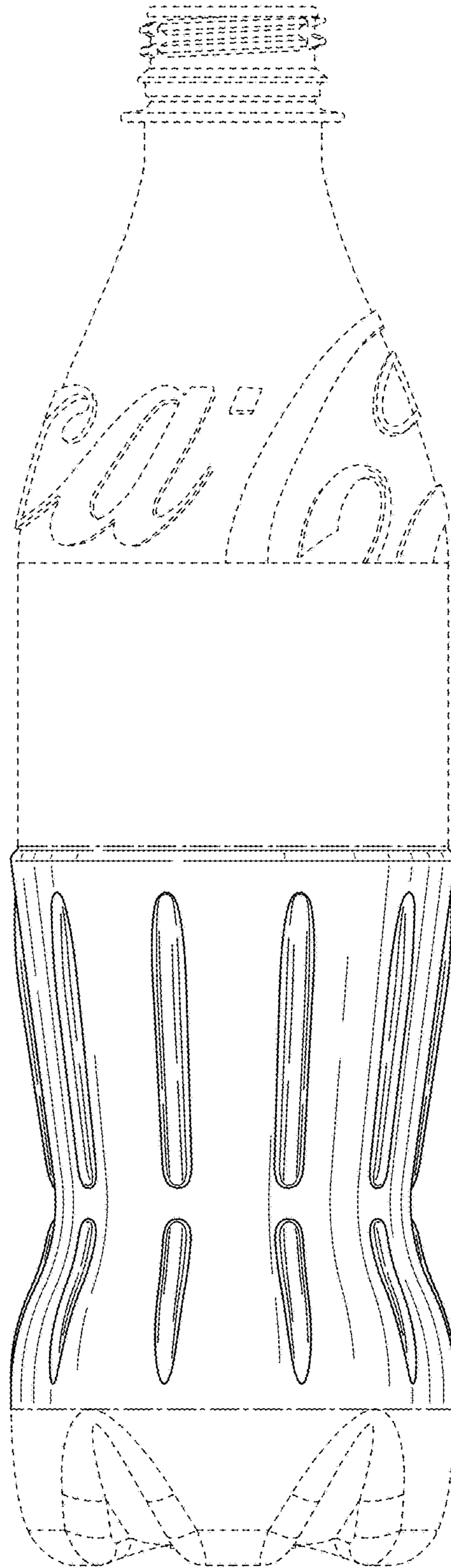

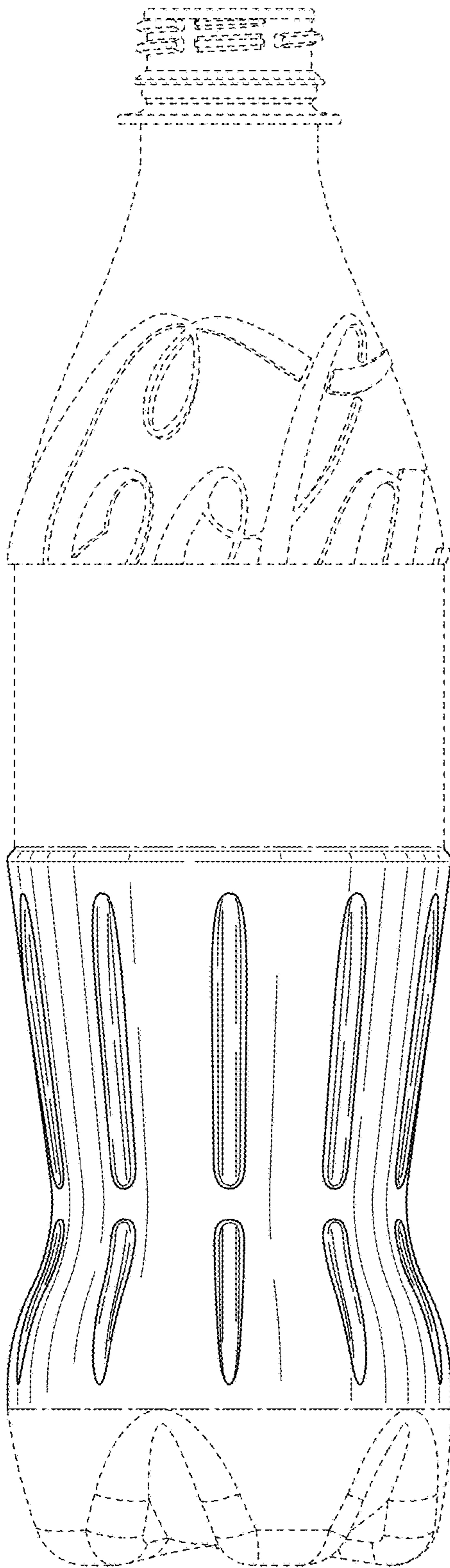

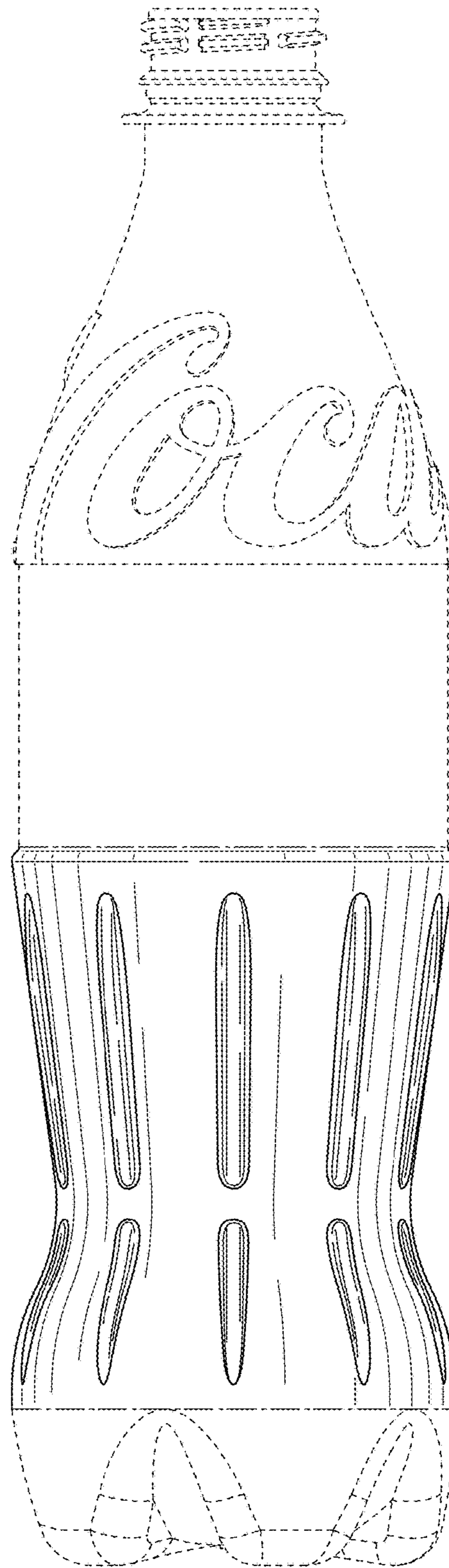

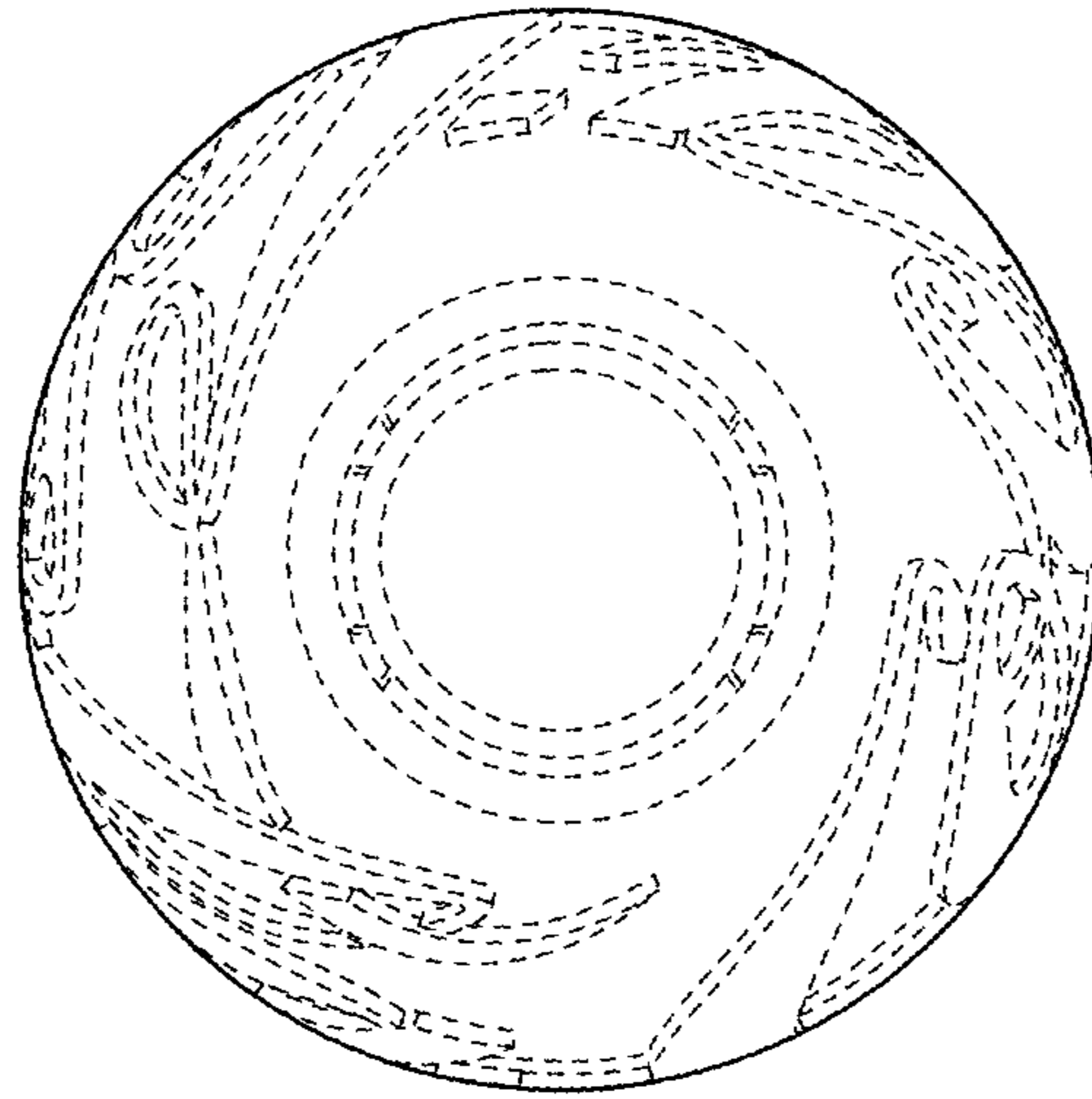

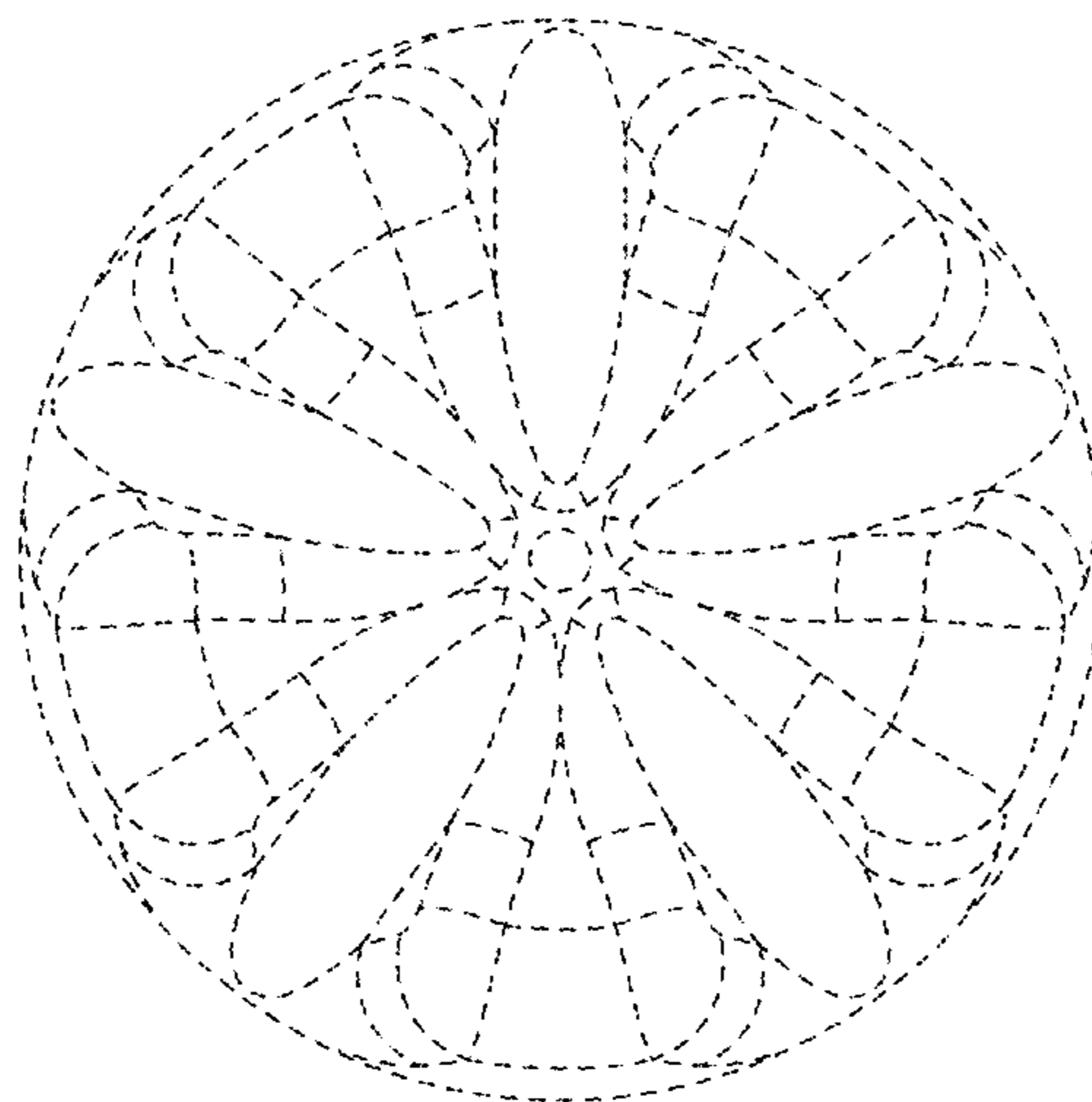

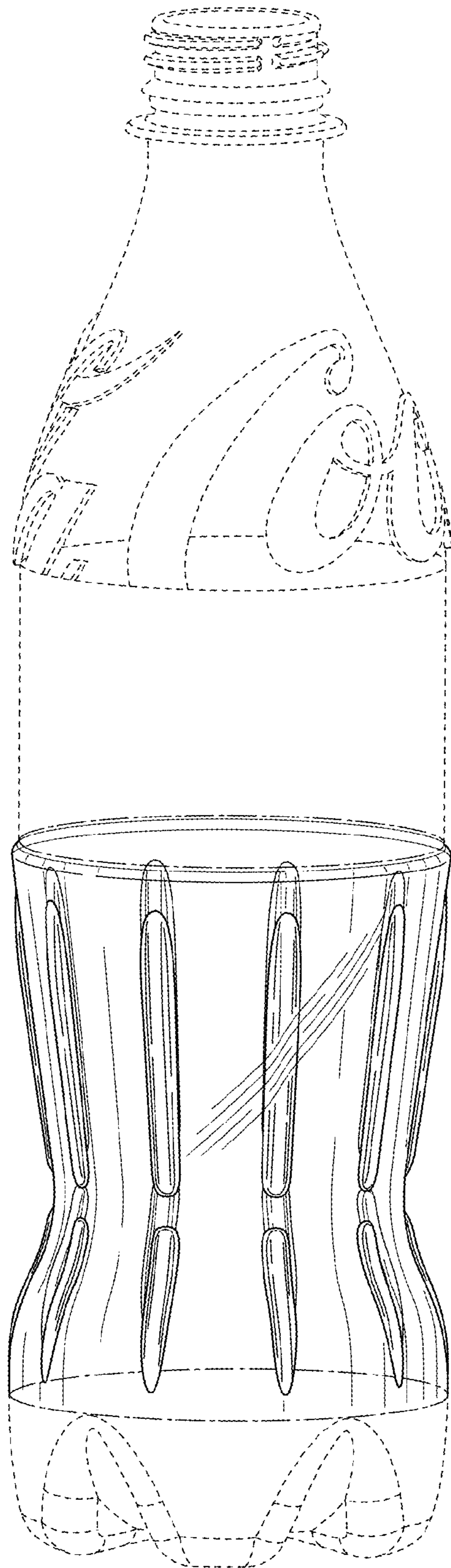

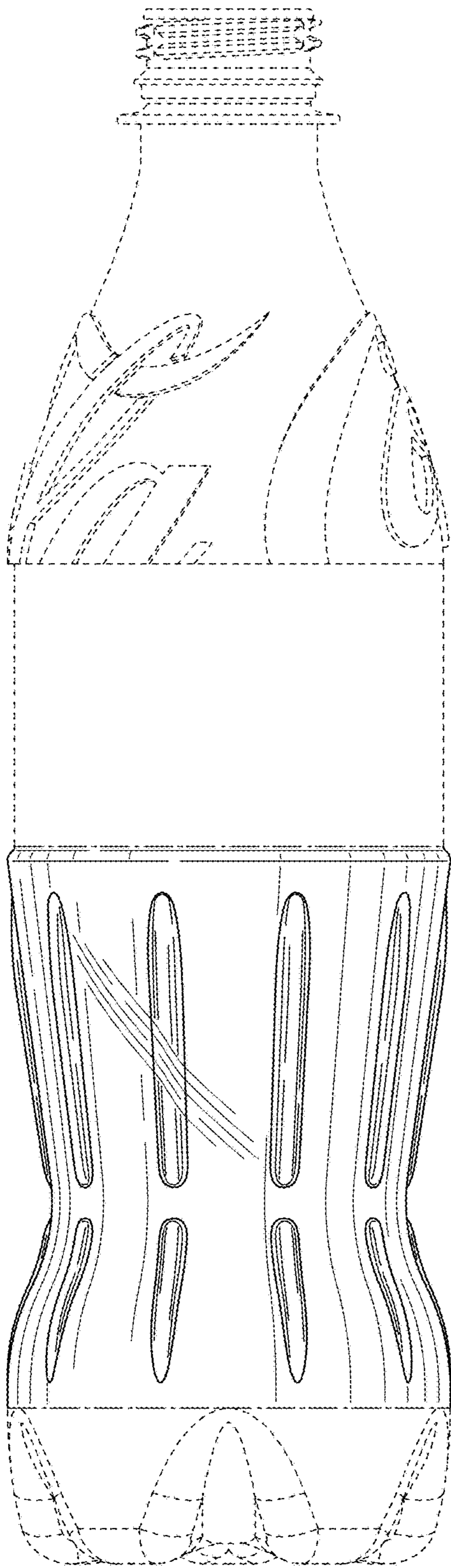

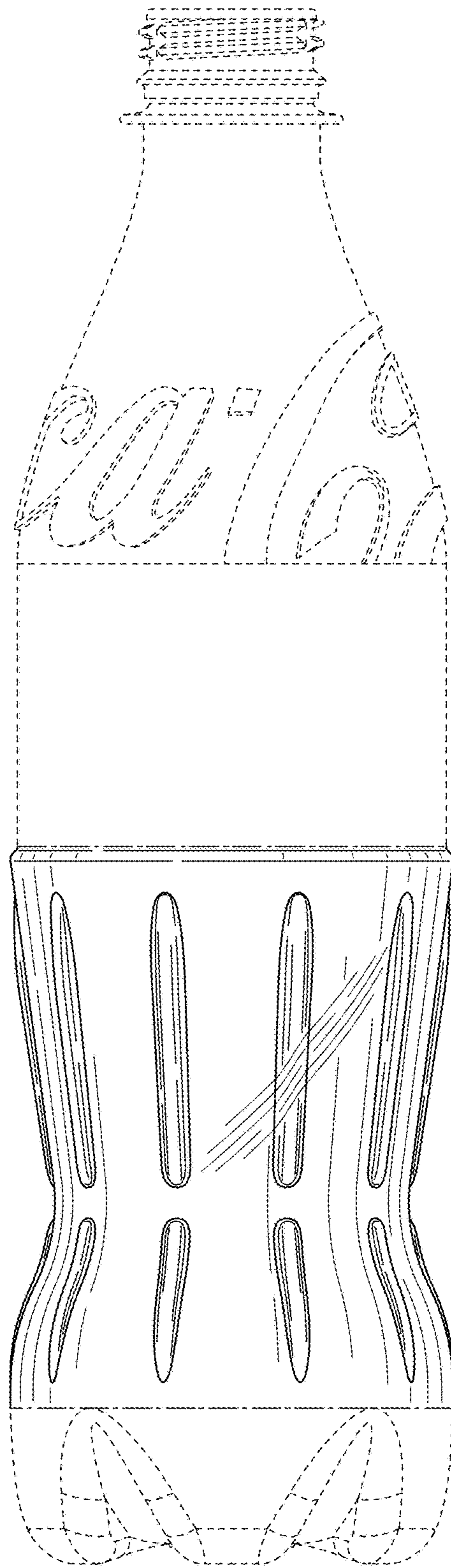

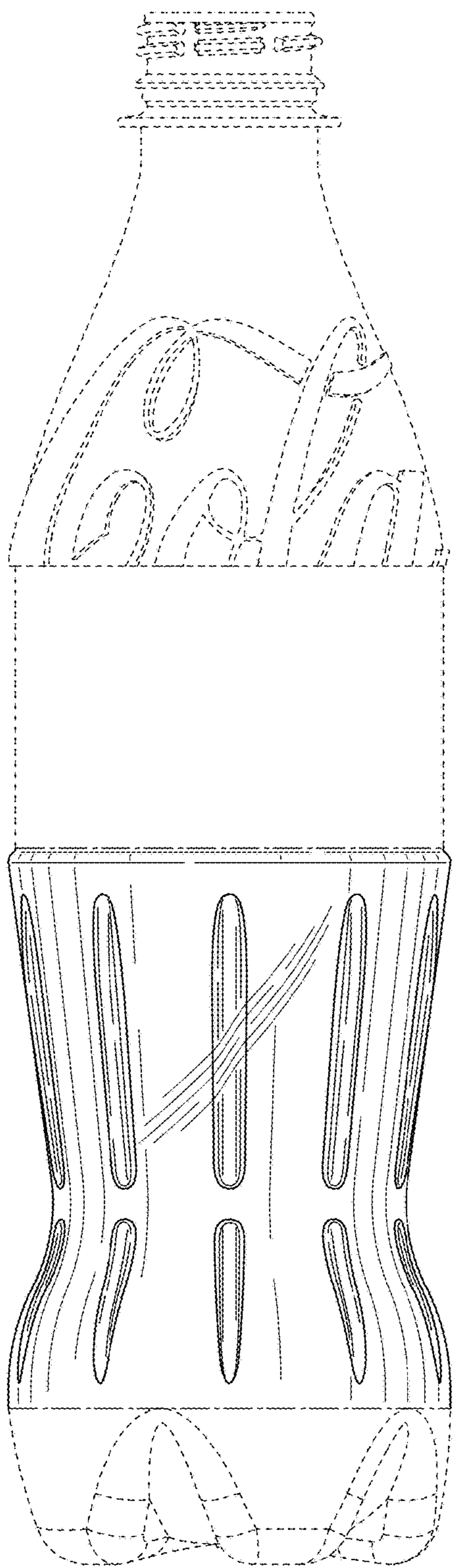

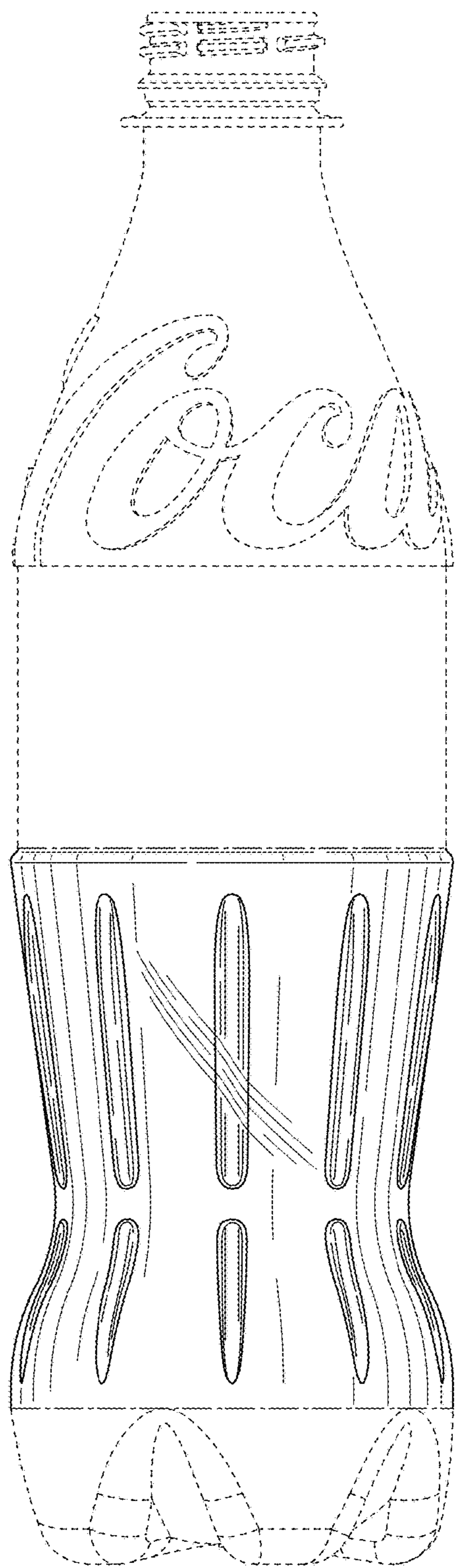

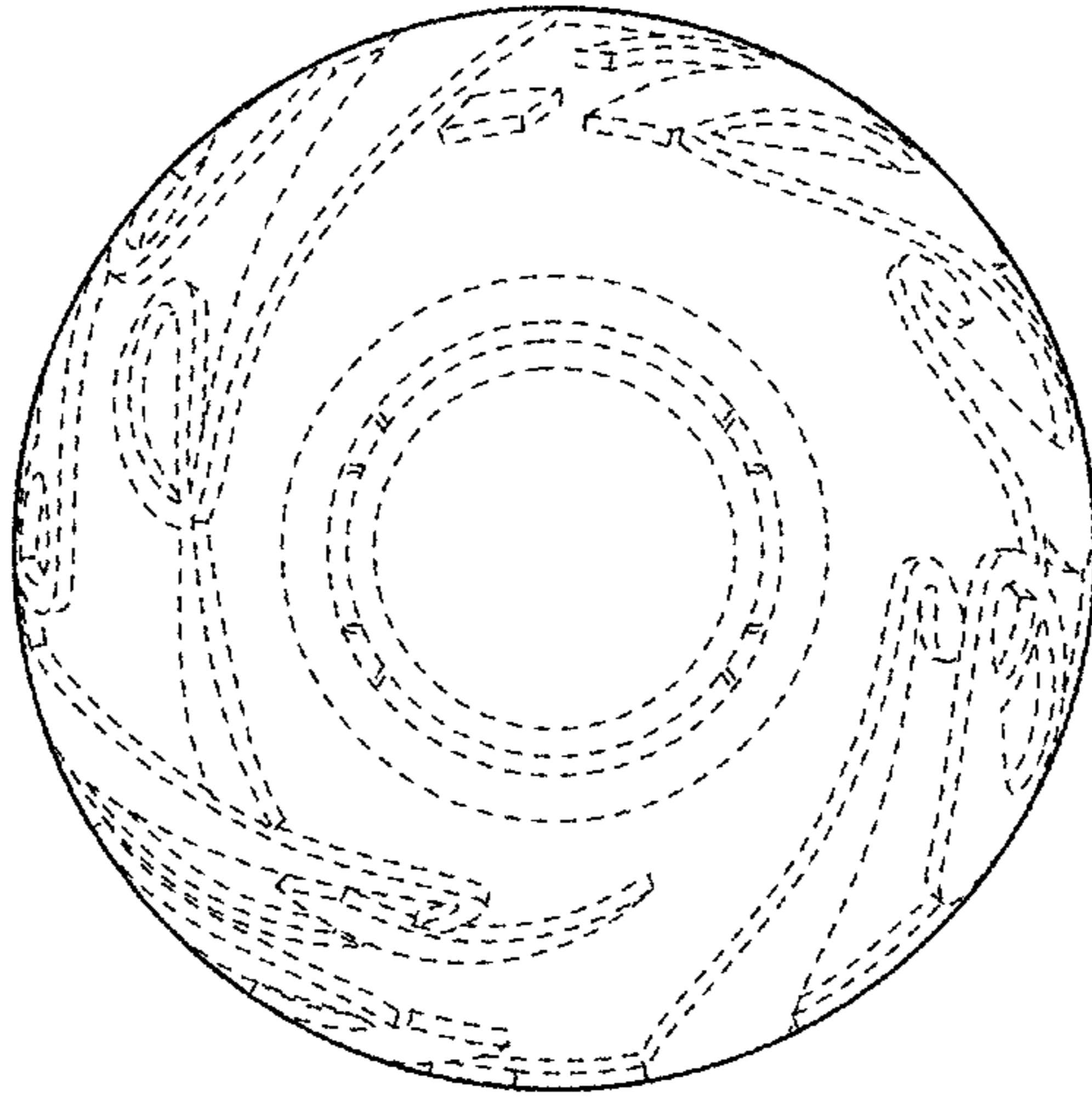

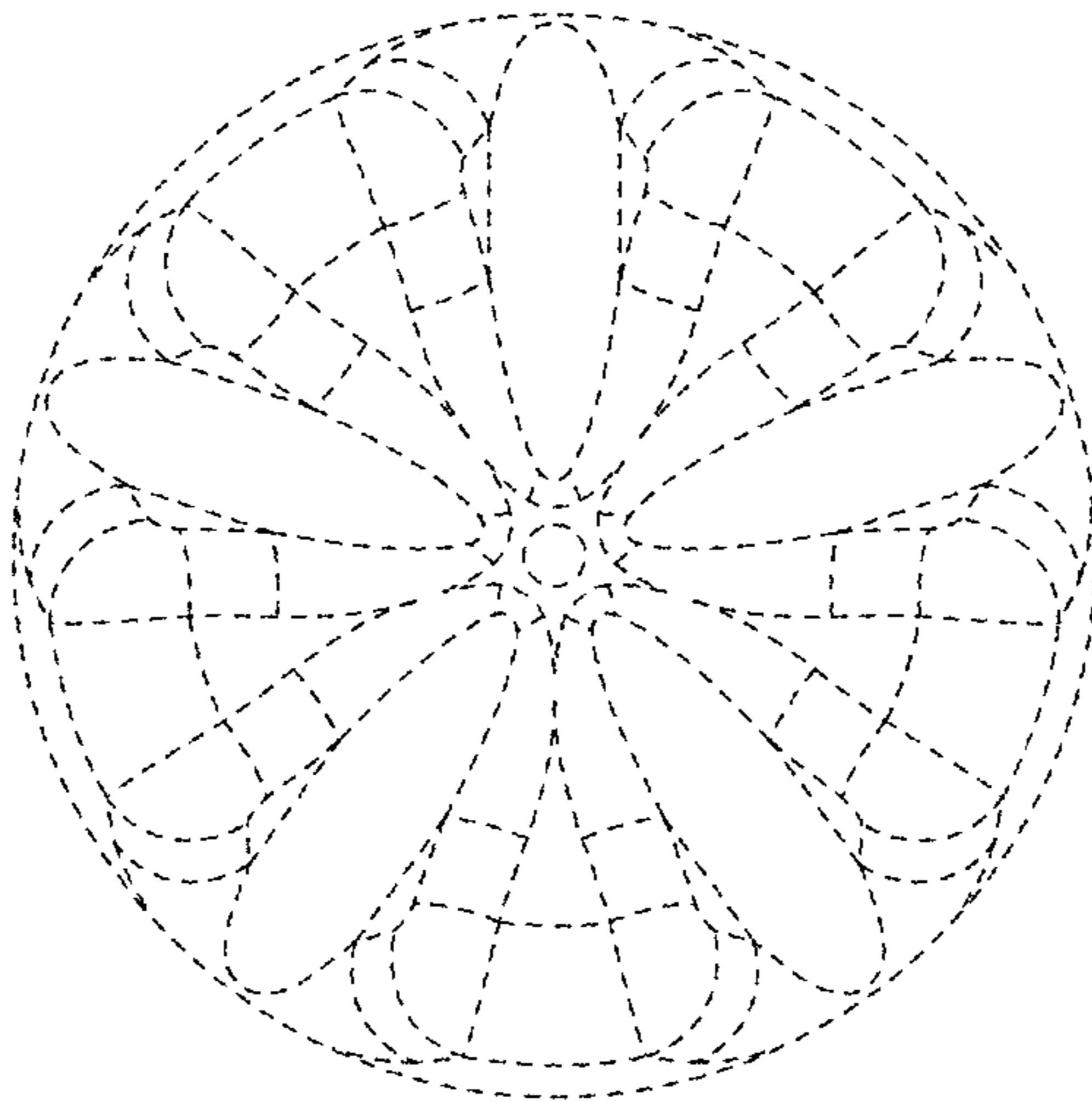

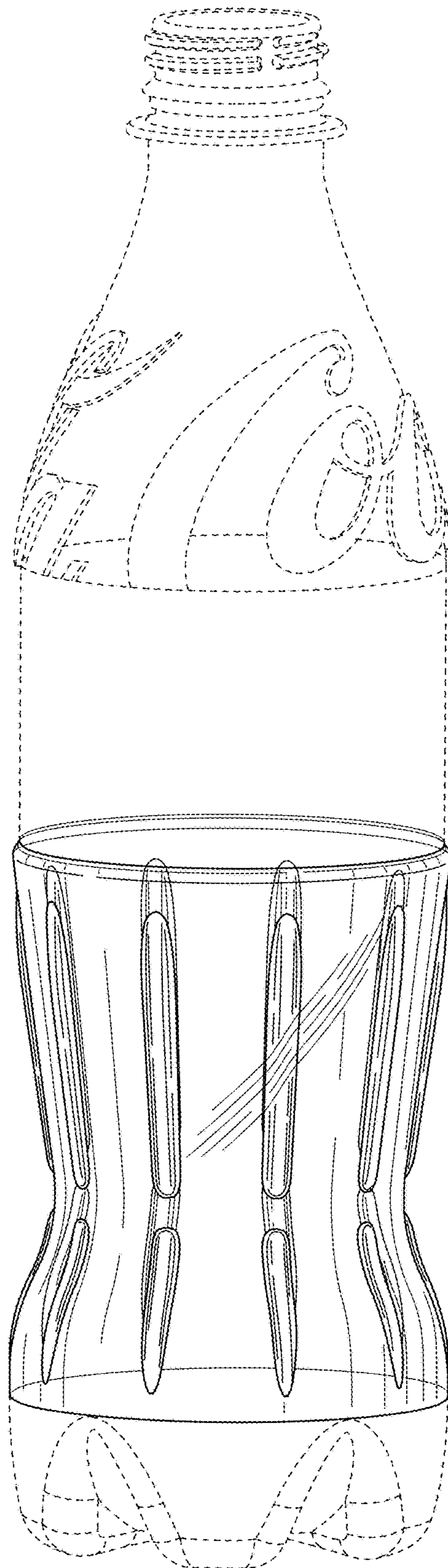

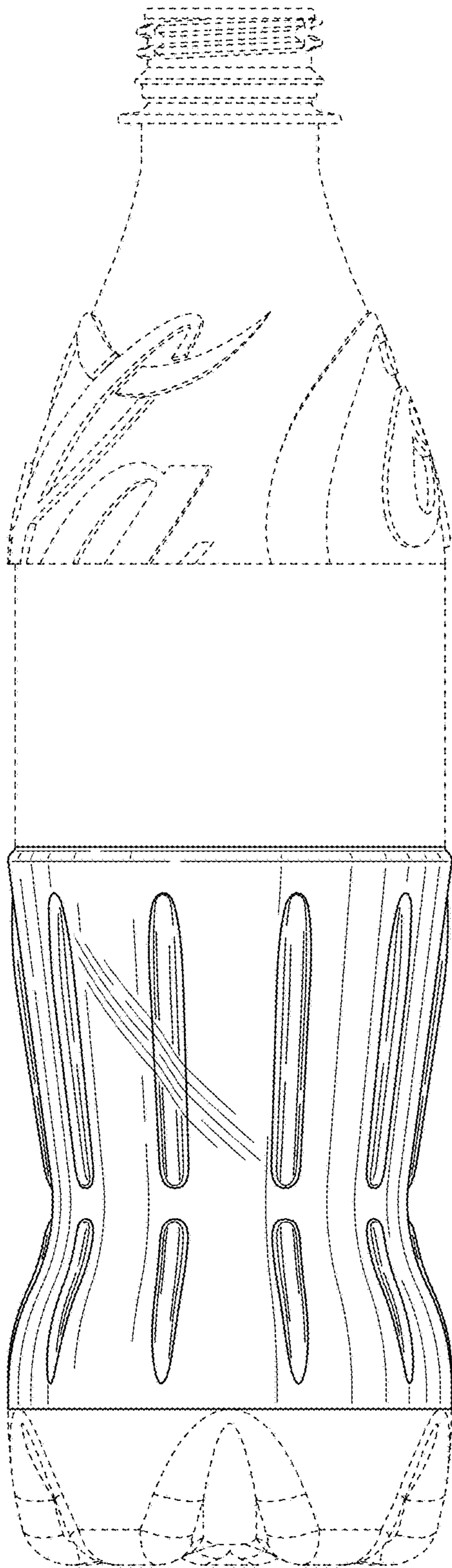

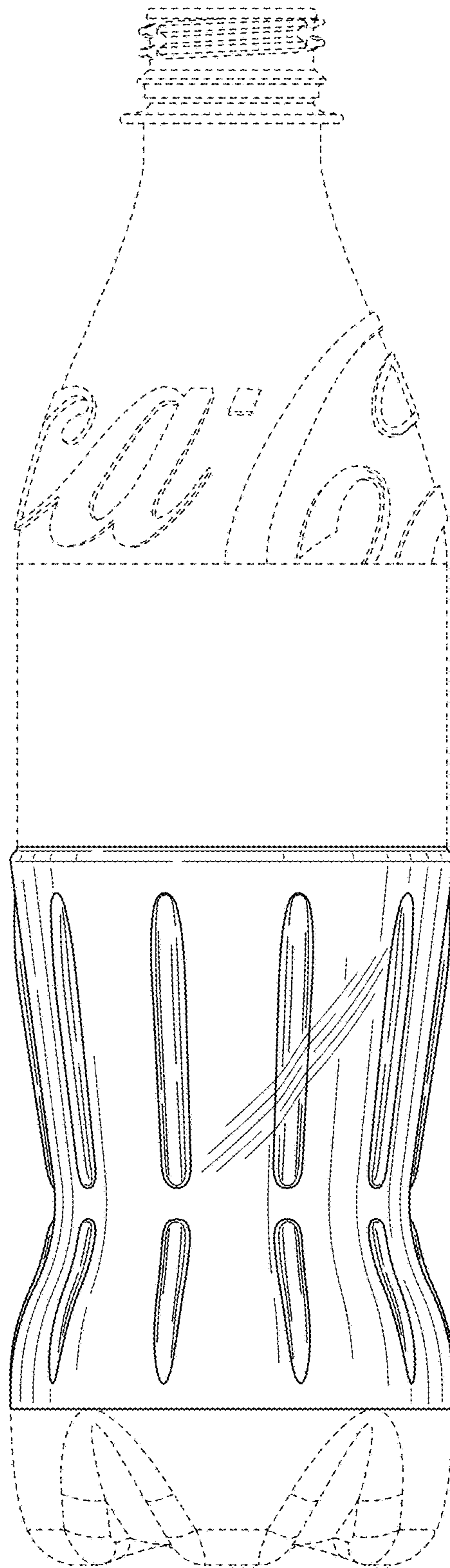

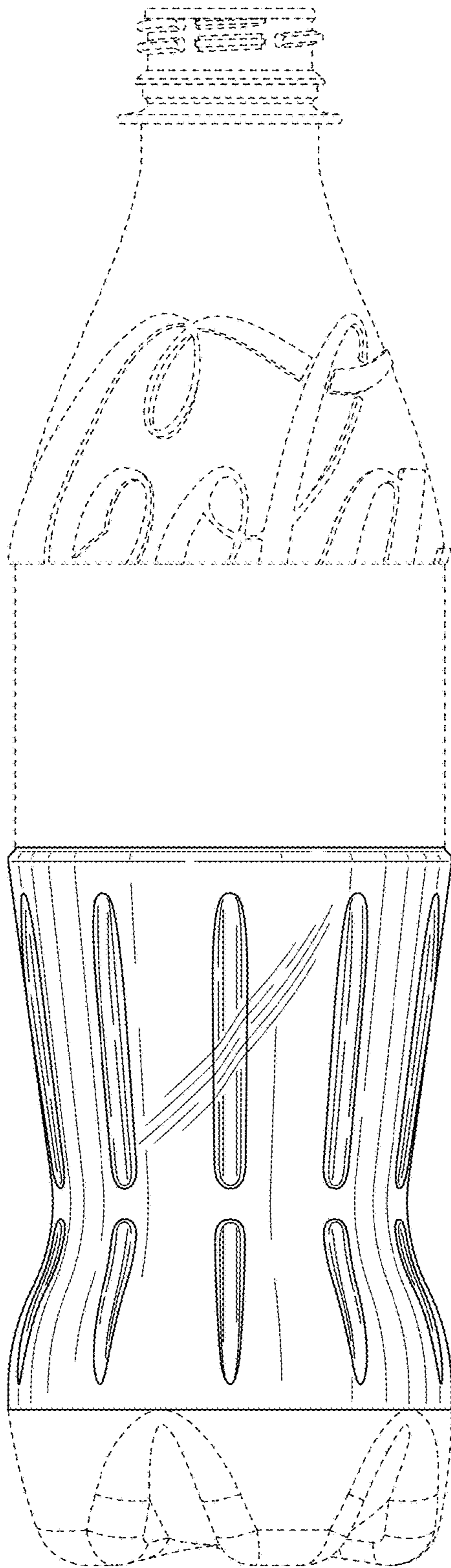

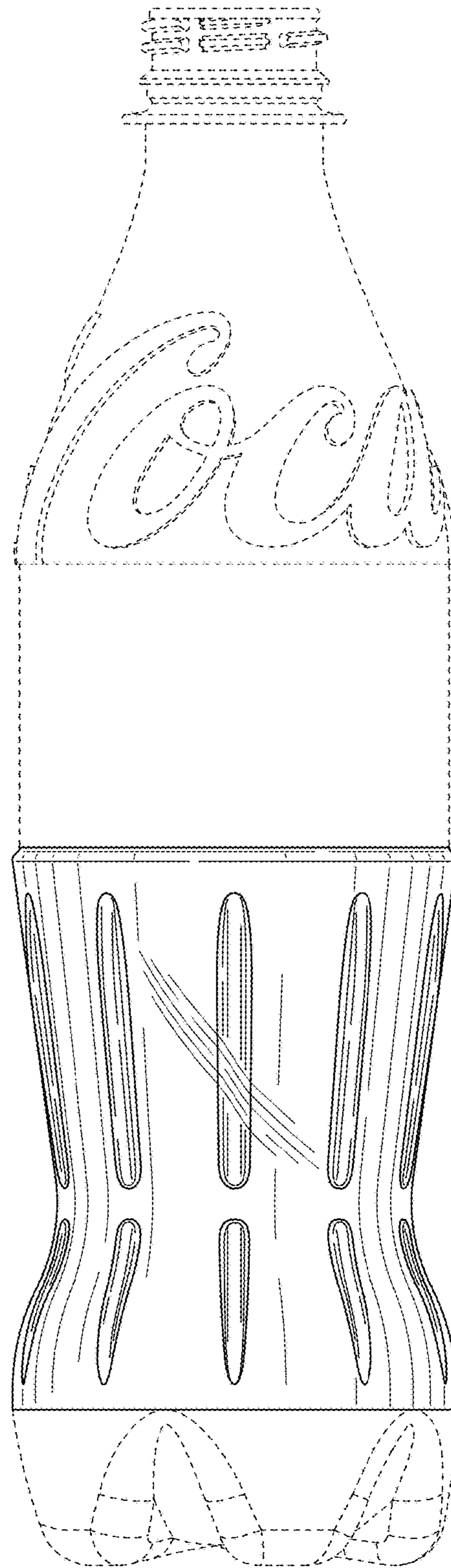

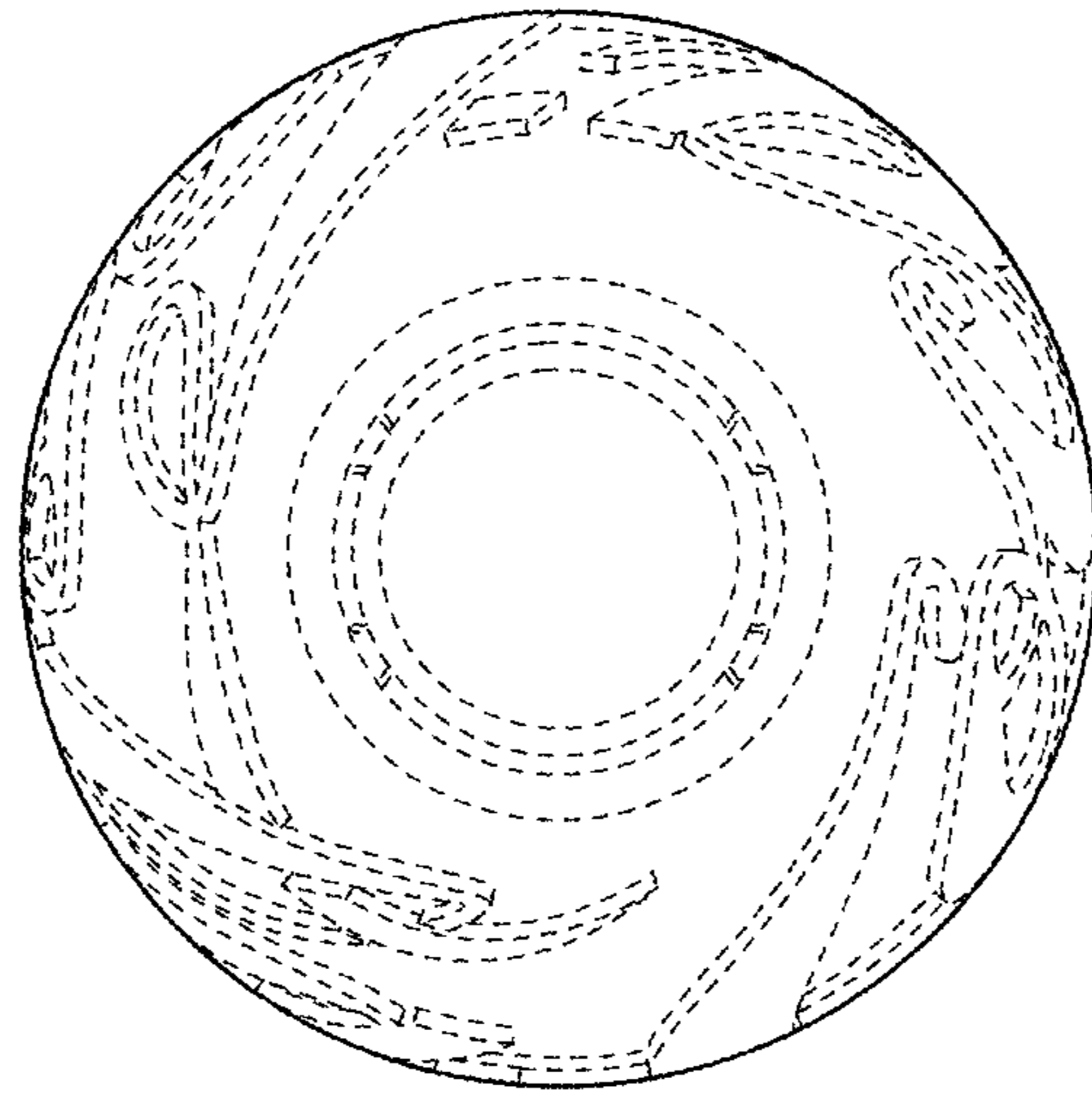

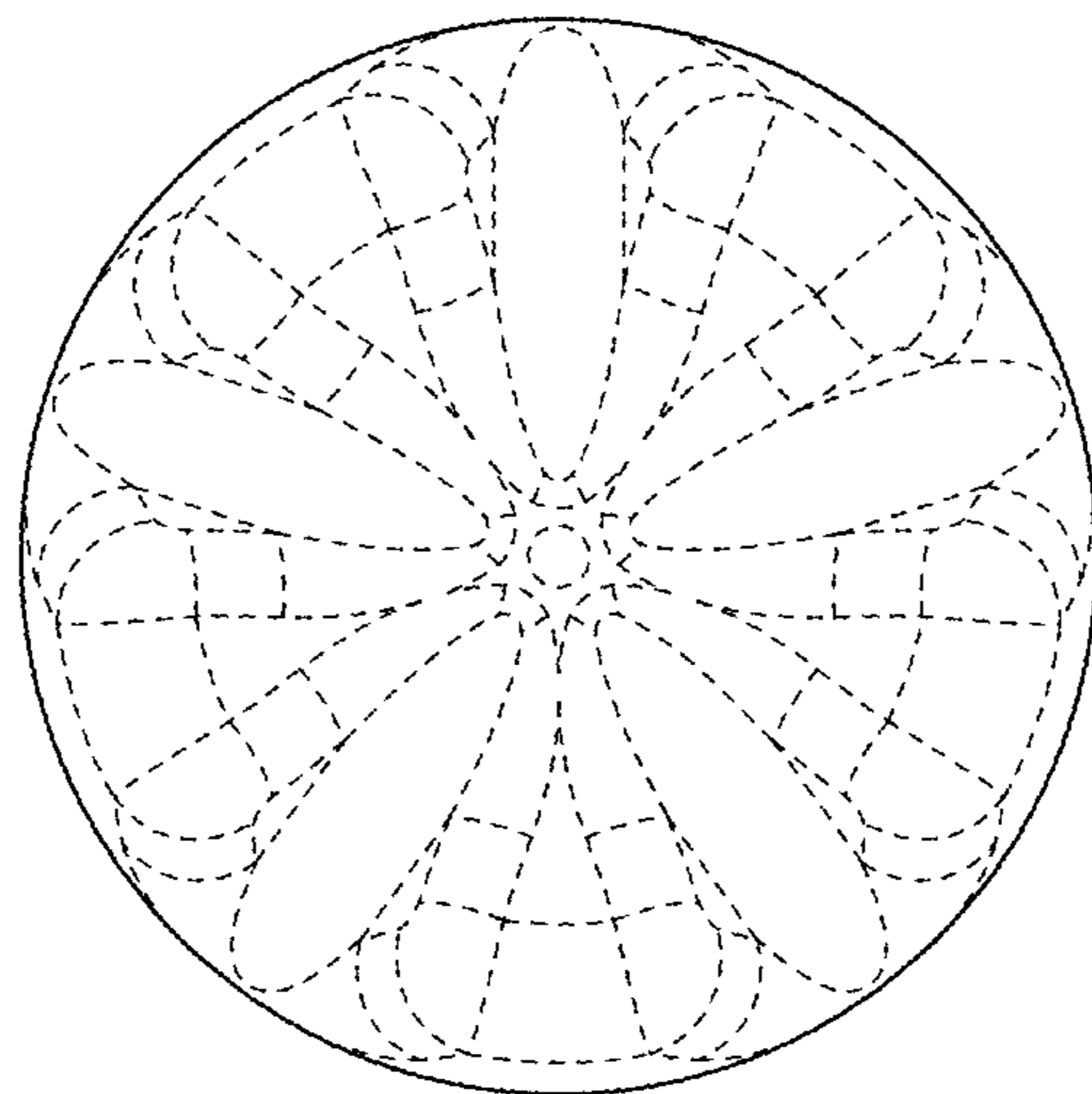
