The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a bottle showing the claimed design;
FIG. 2 is a bottom front perspective view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a left side view, the right side view being a mirror image thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.
The broken lines in the figures show portions of the bottle that form no part of the claimed design.

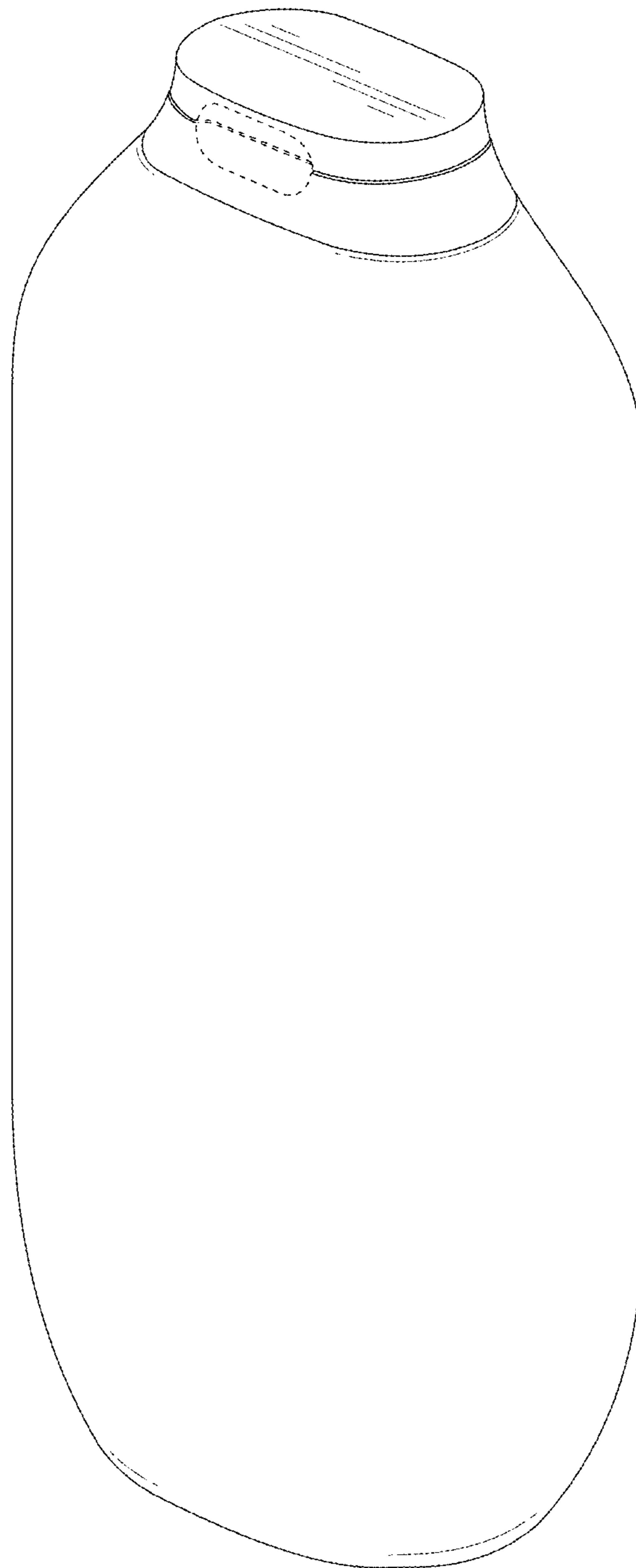

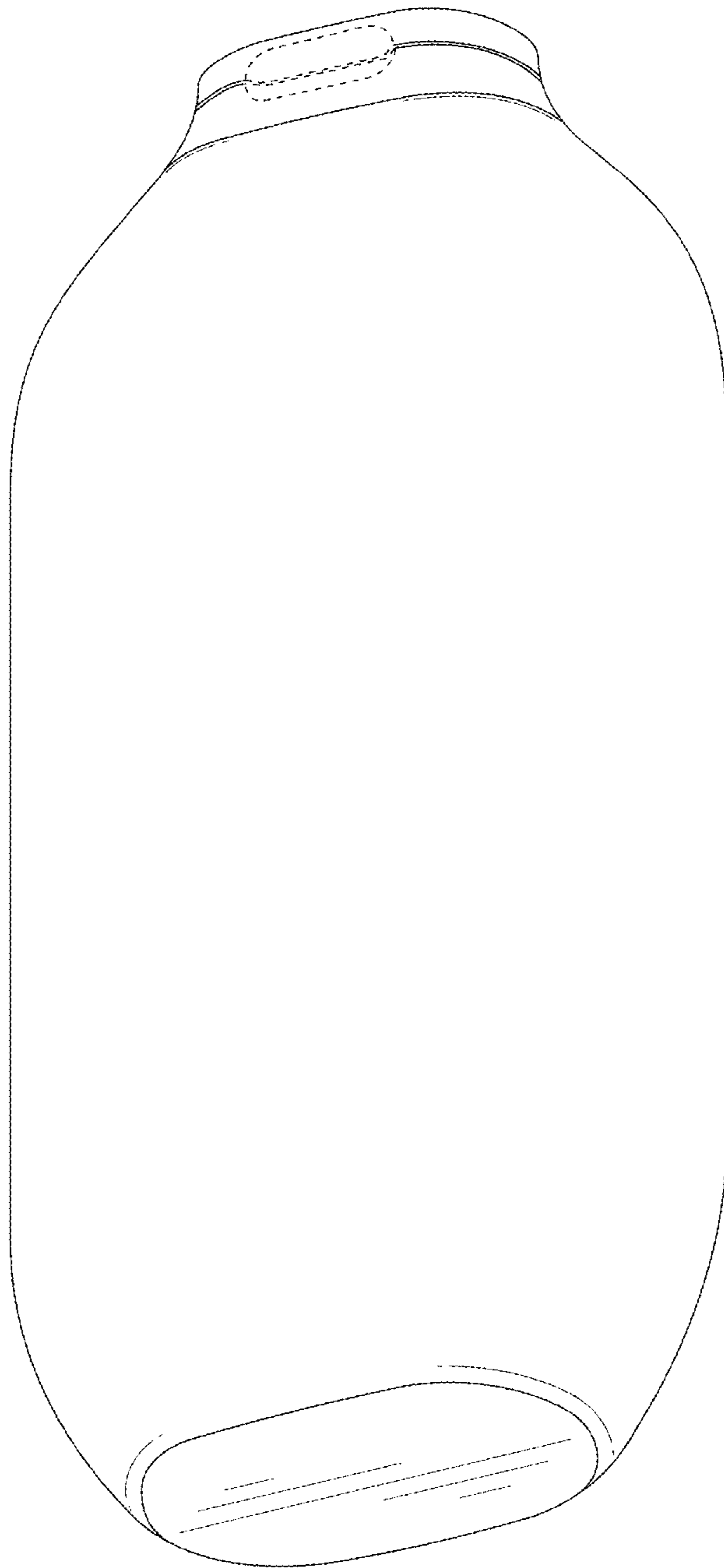

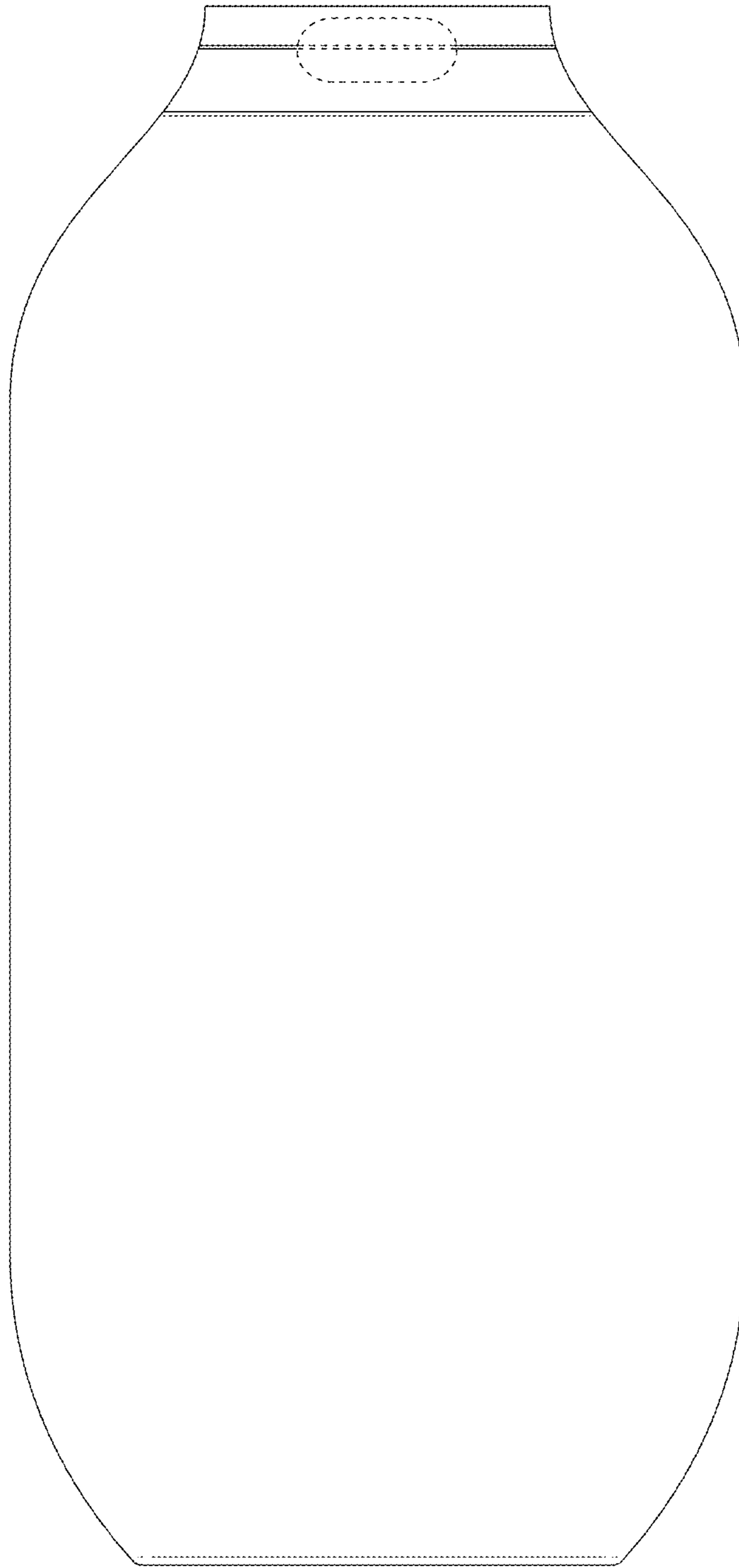

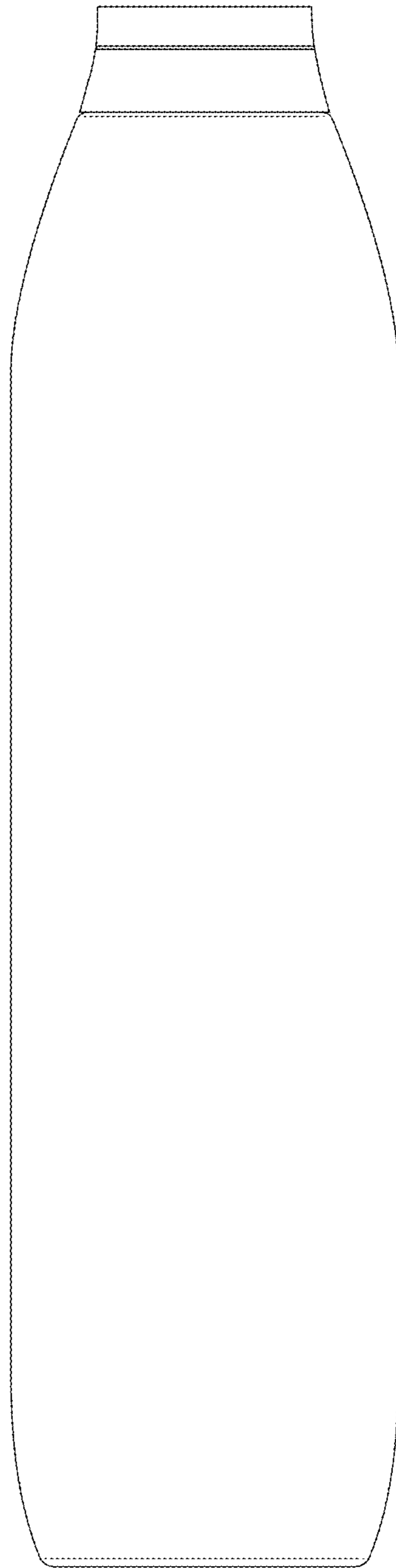

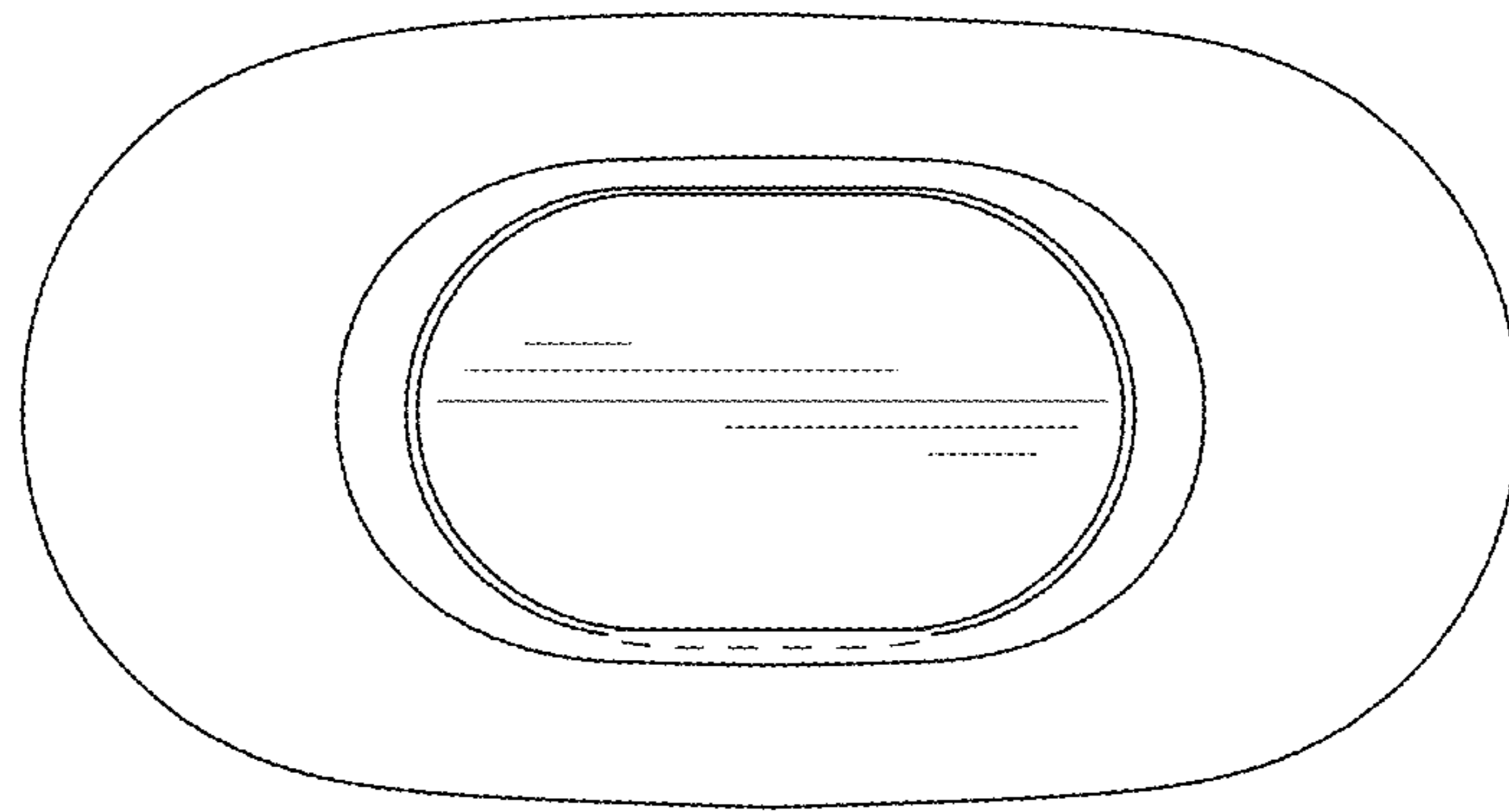

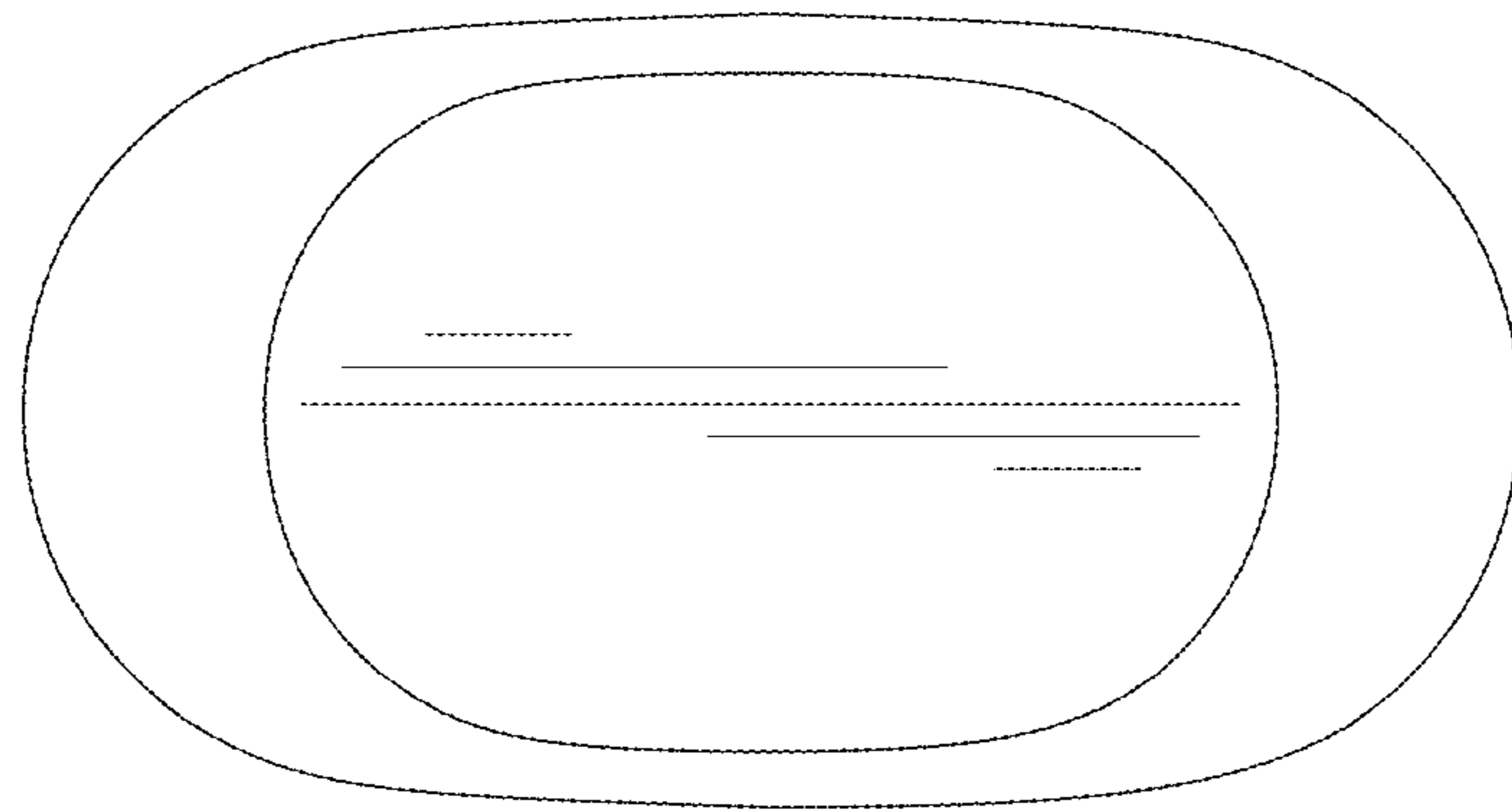
