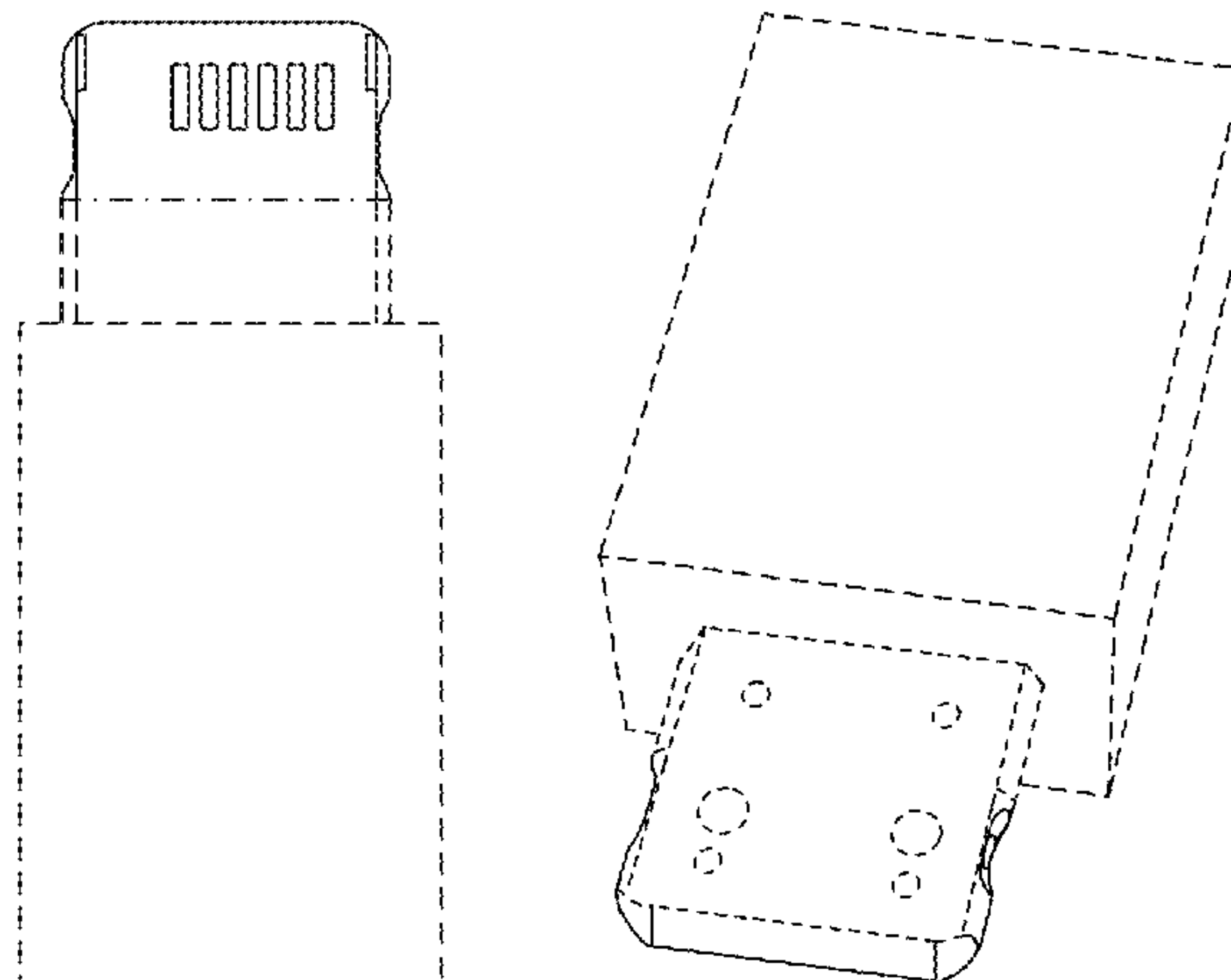


FIG. 19 is a left side elevation view of Embodiments 1 through 44, the right side elevation view being a mirror image thereof.

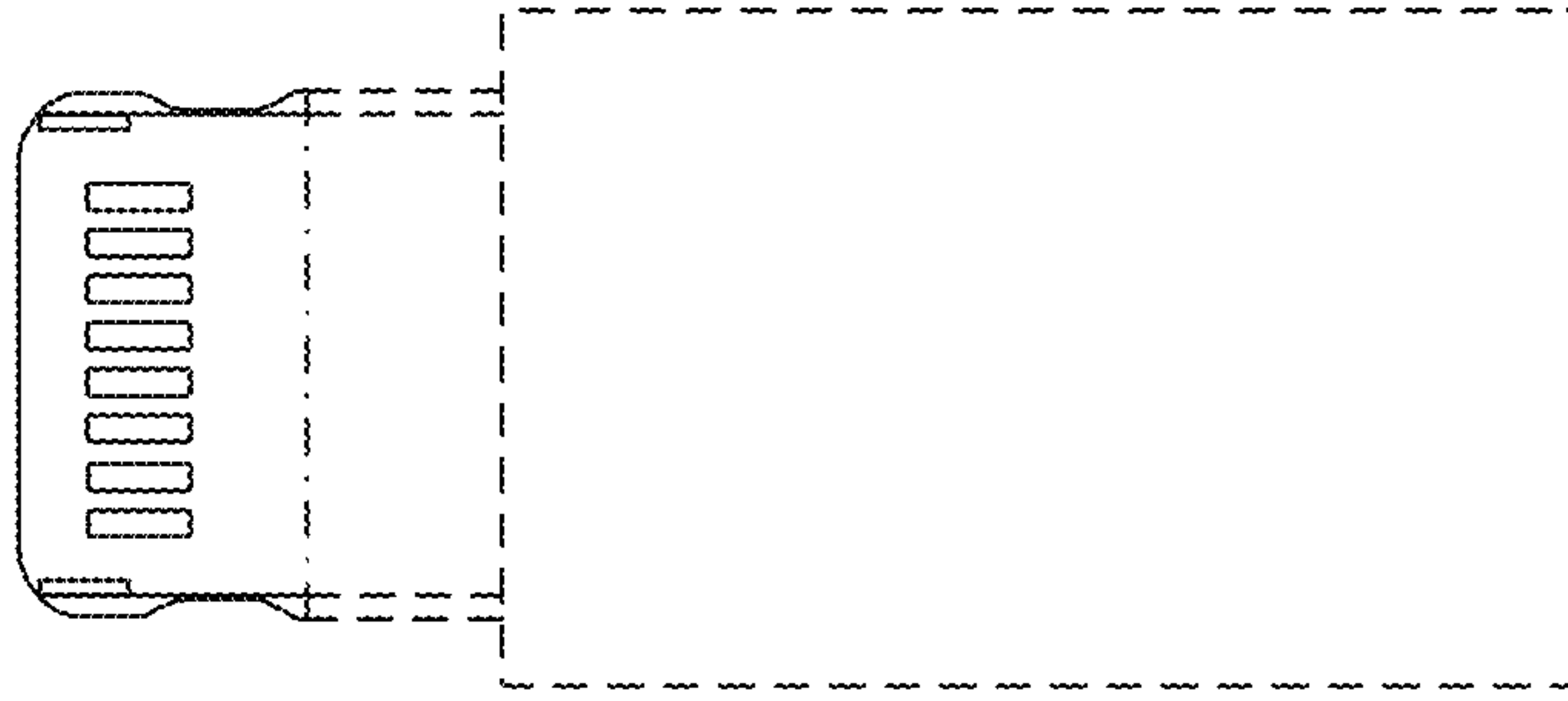

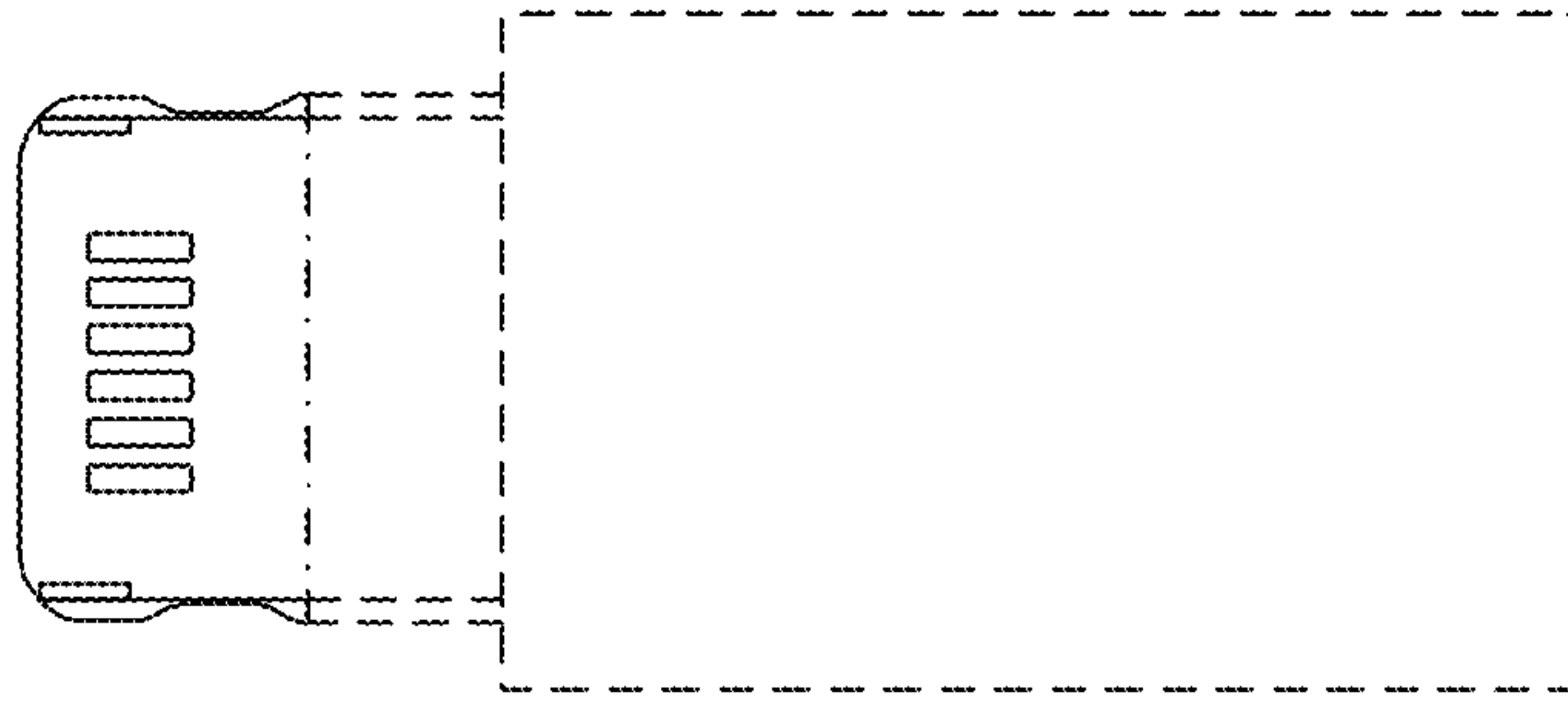

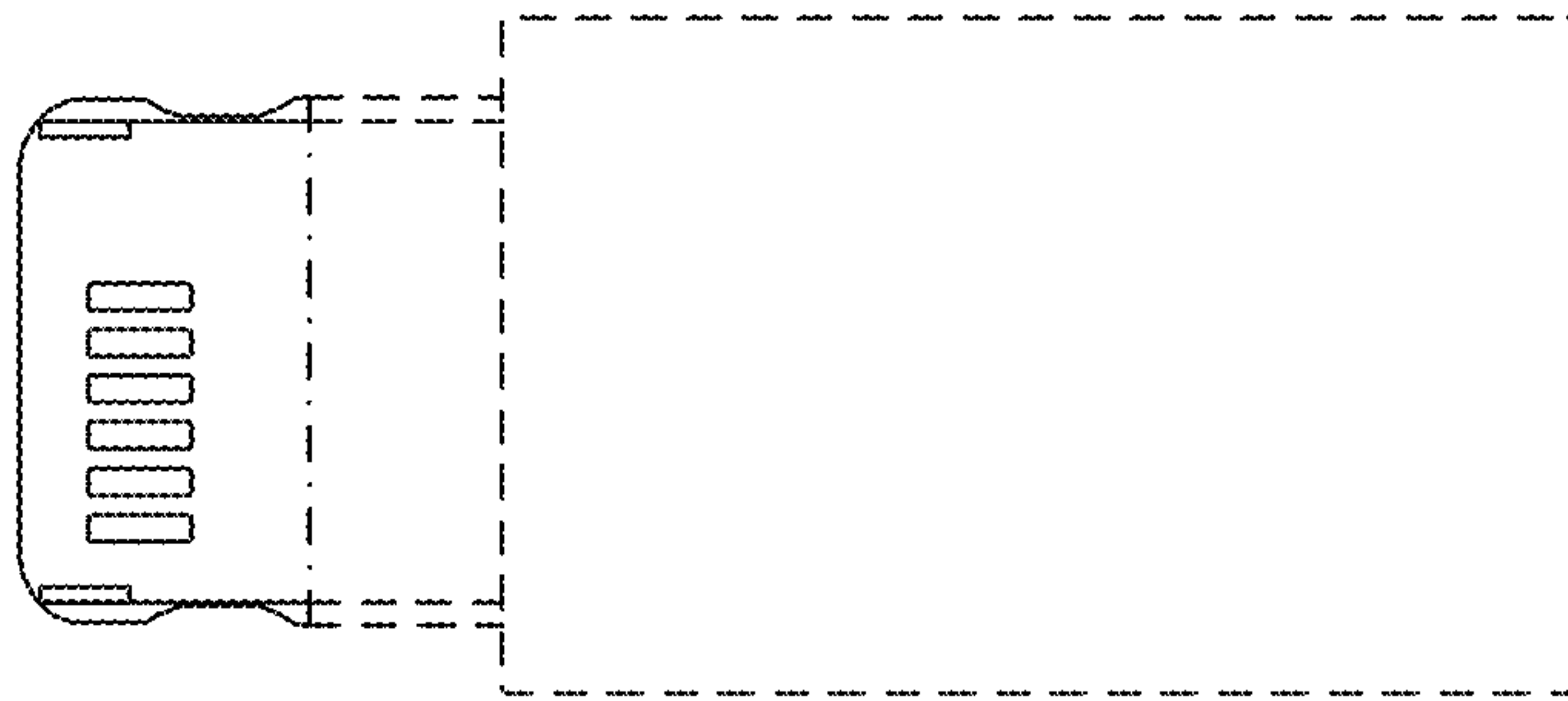

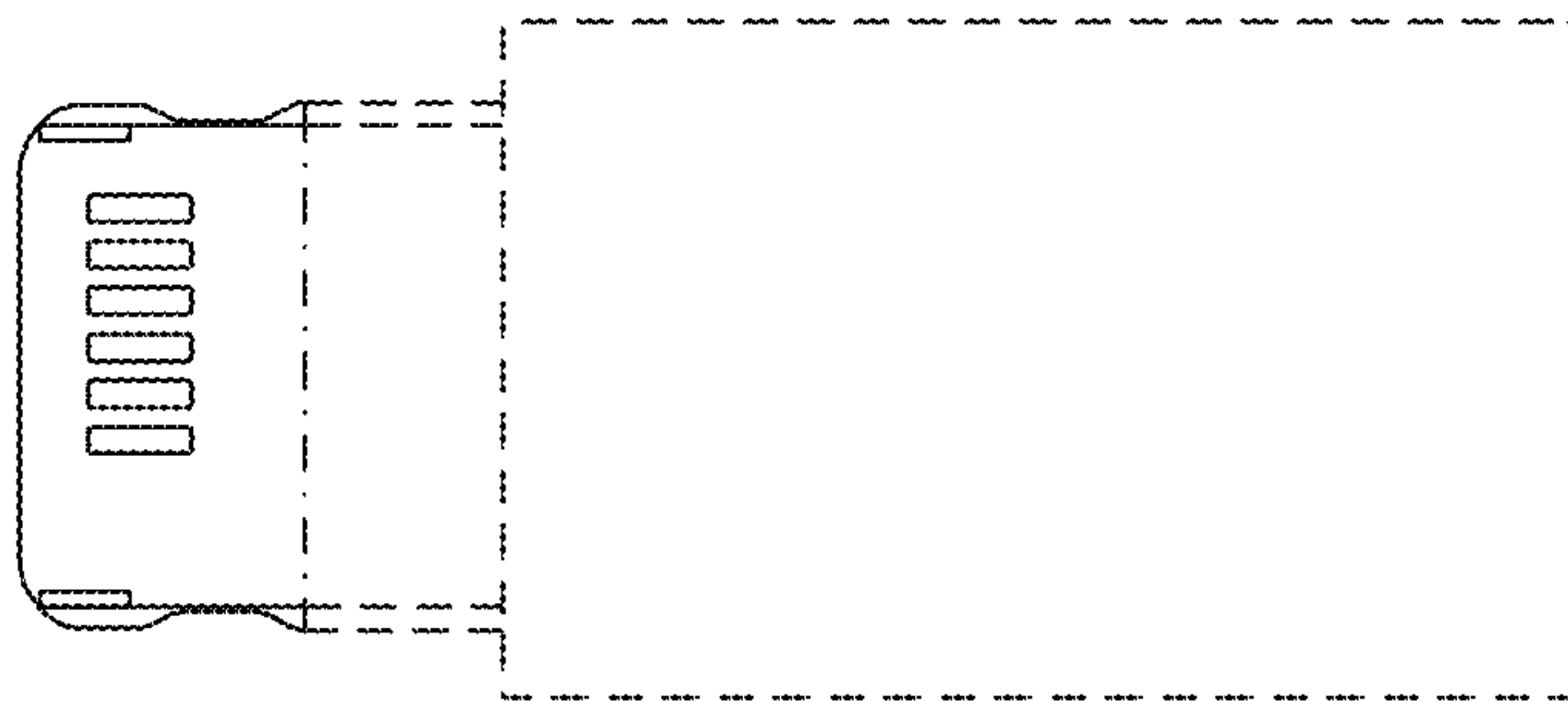

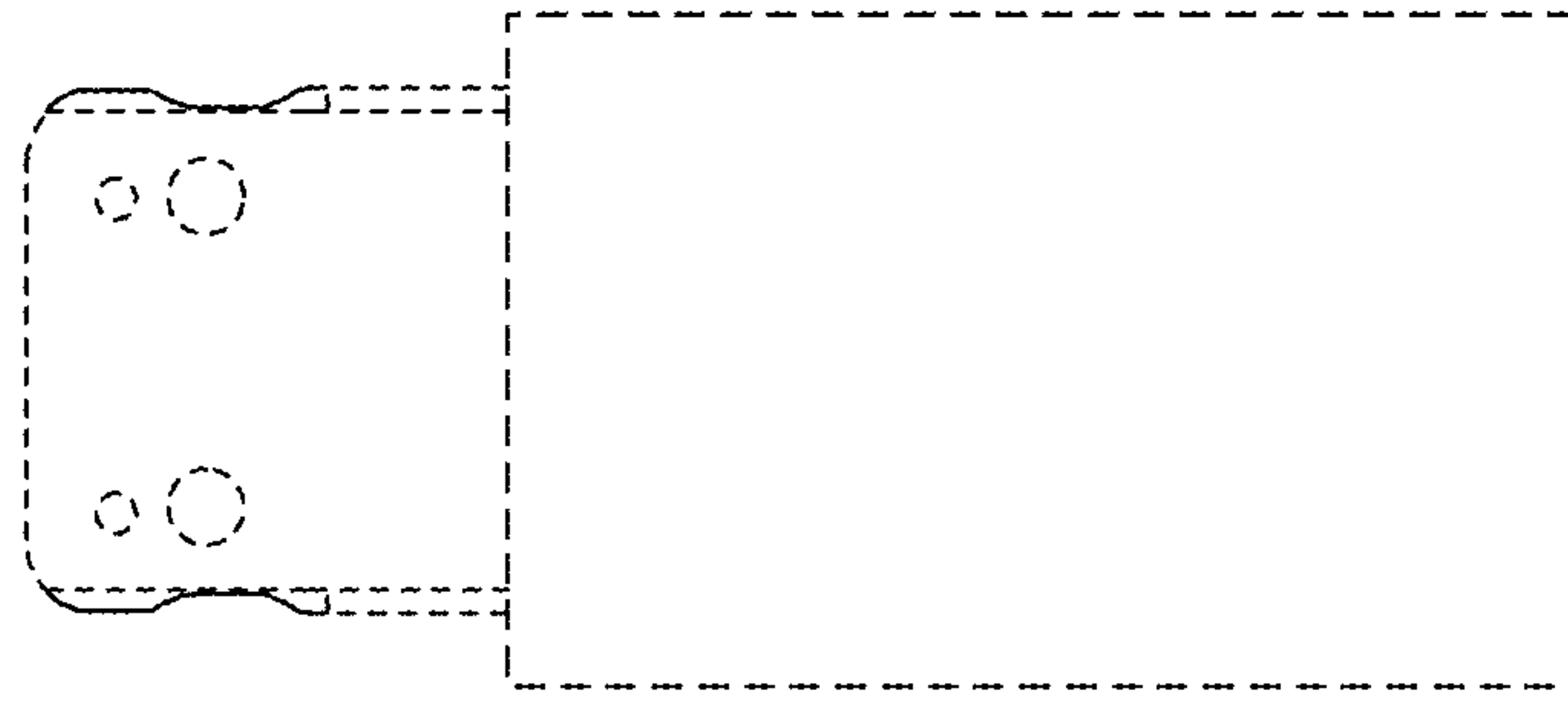

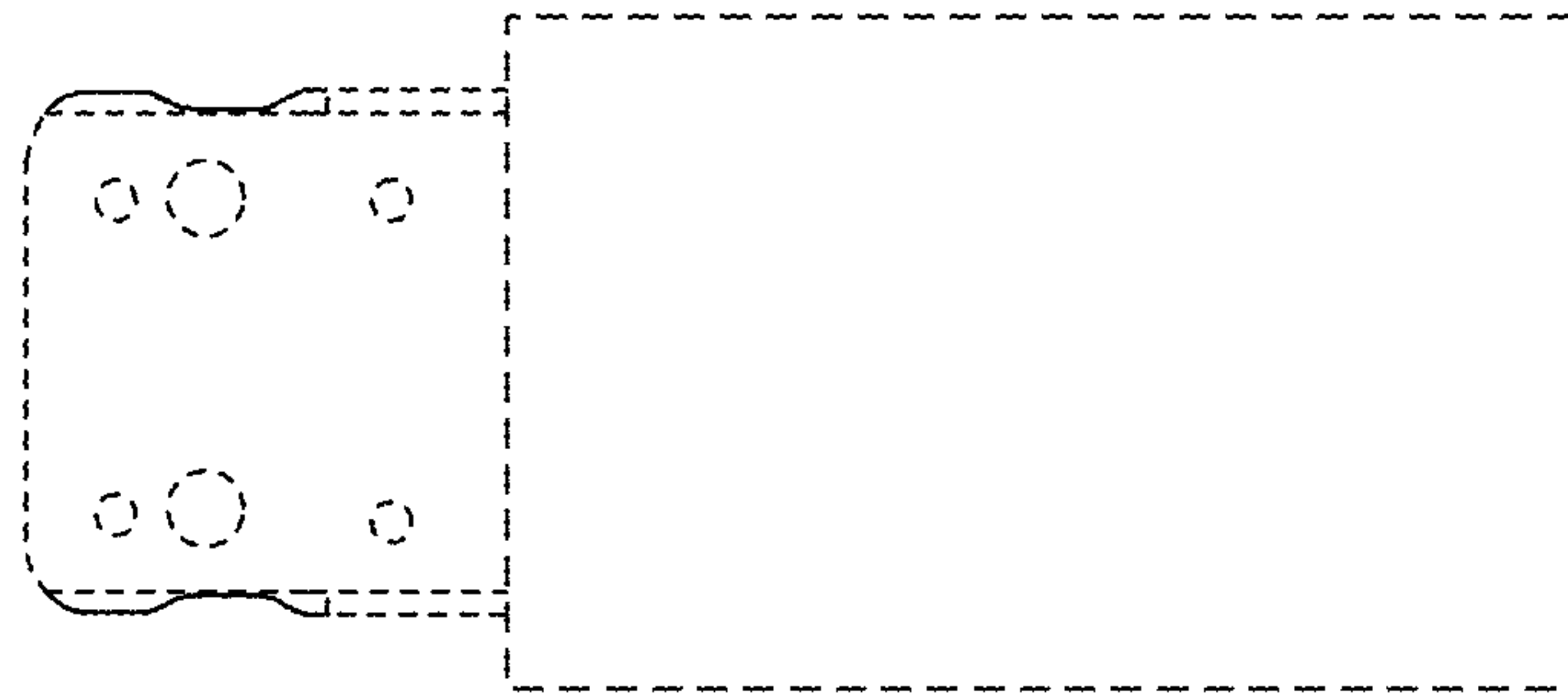

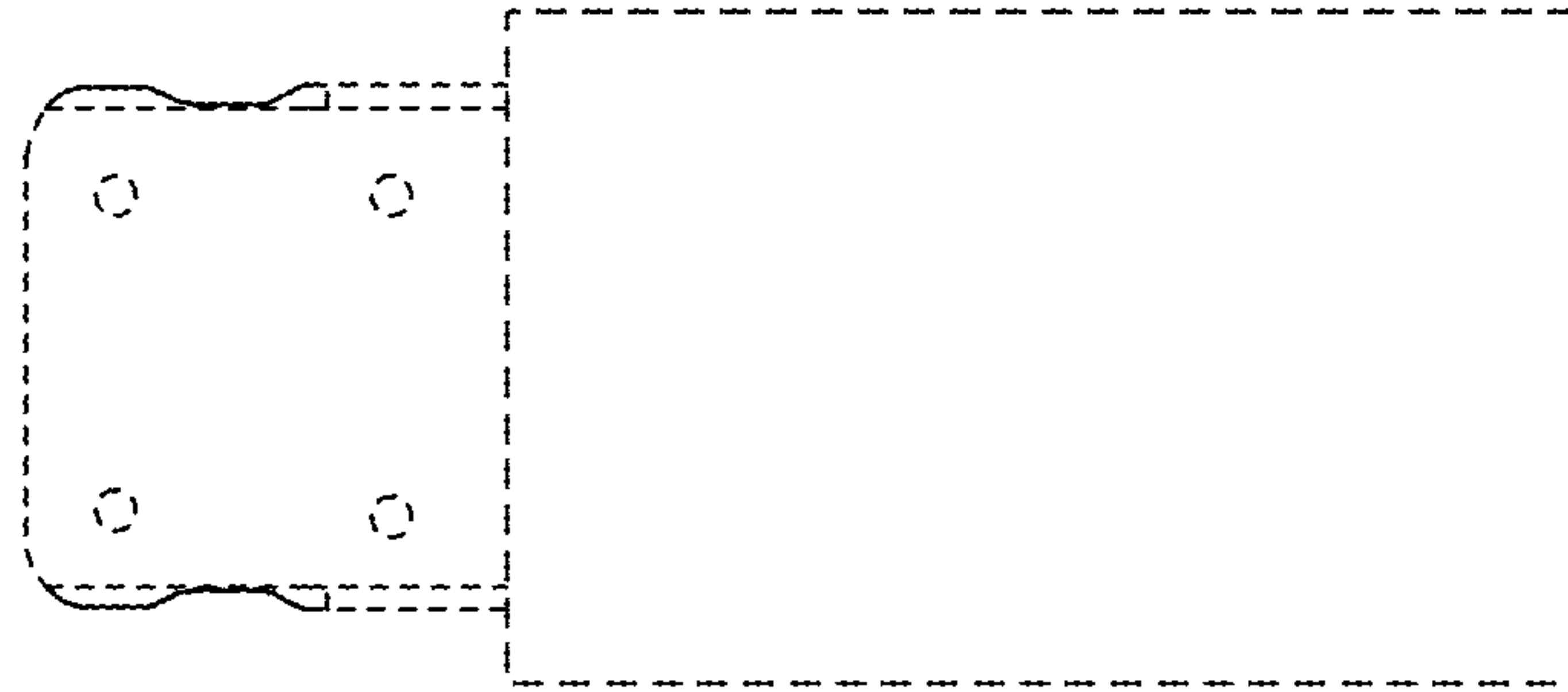

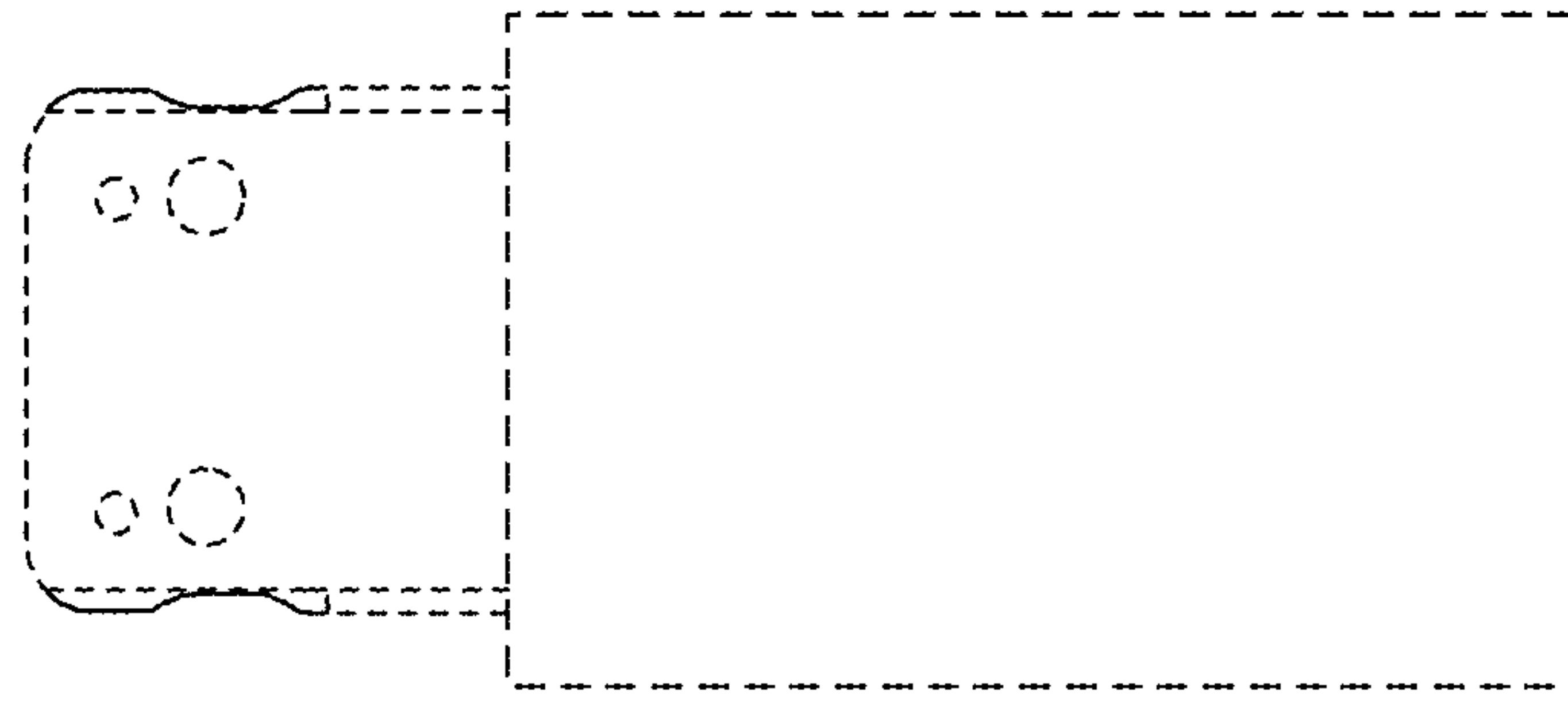

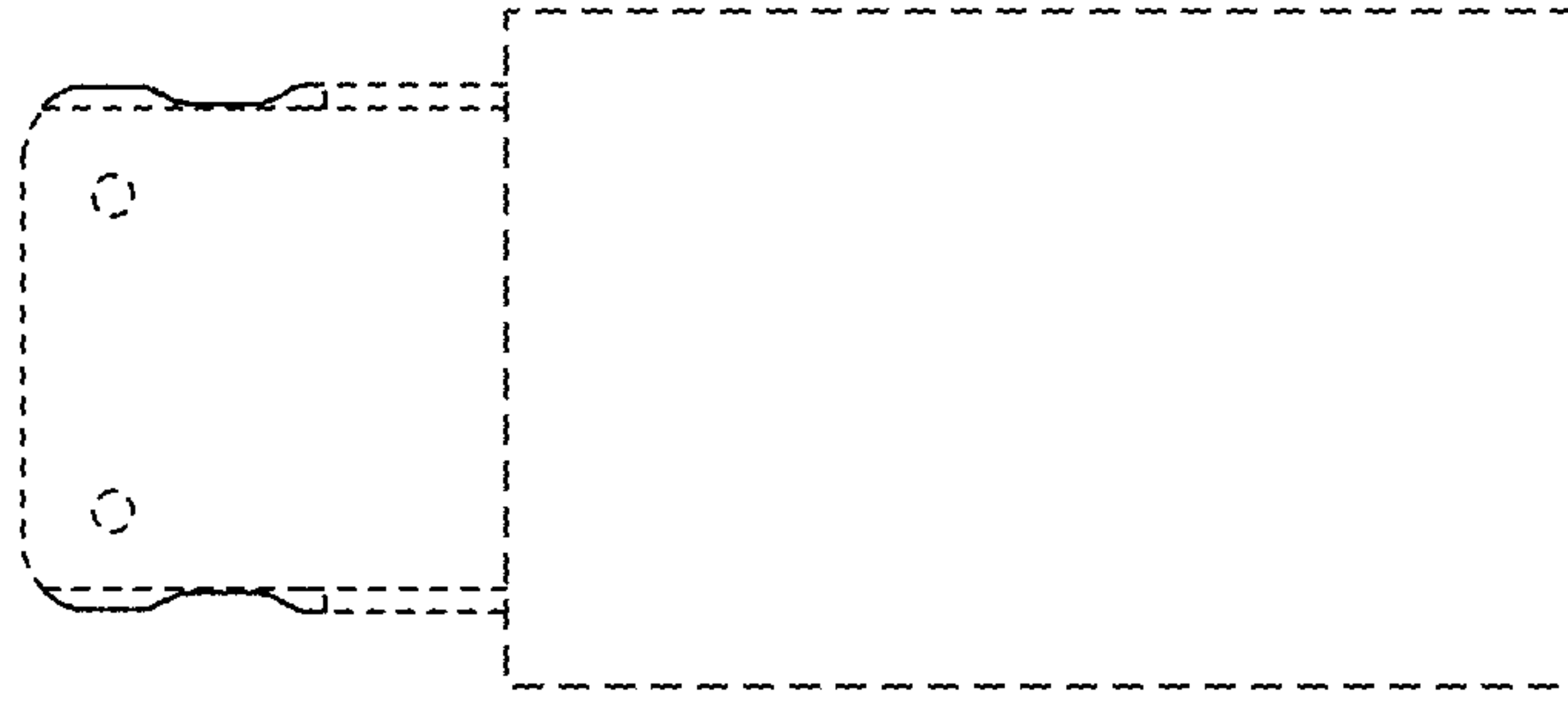

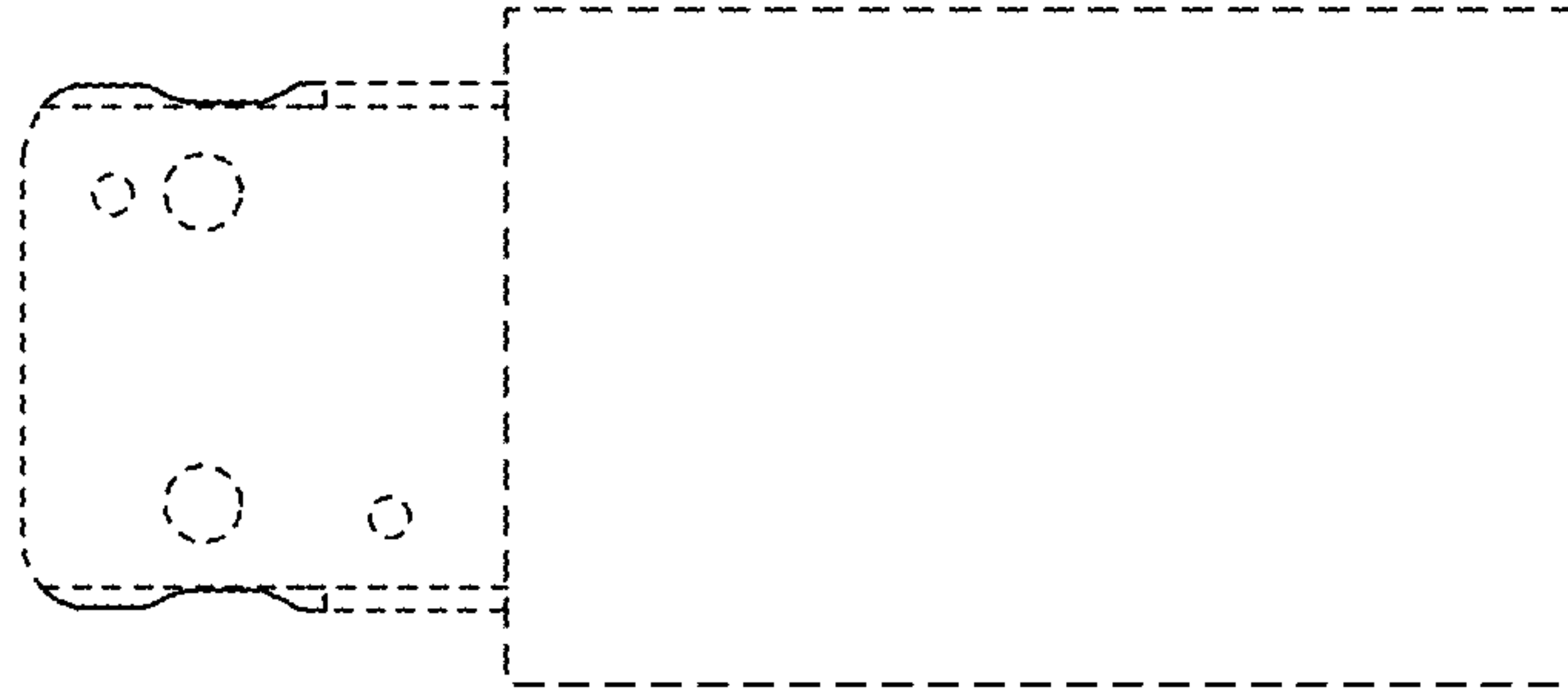

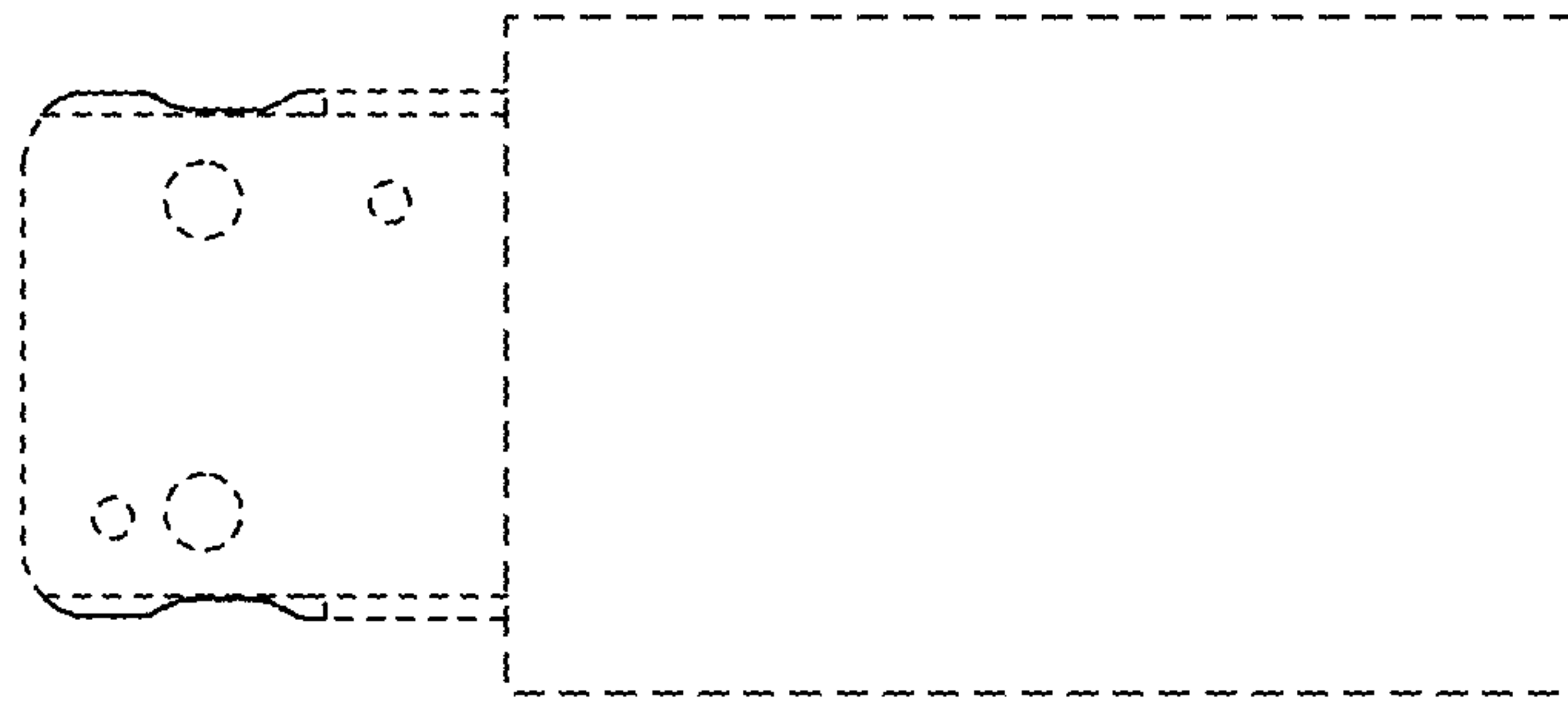

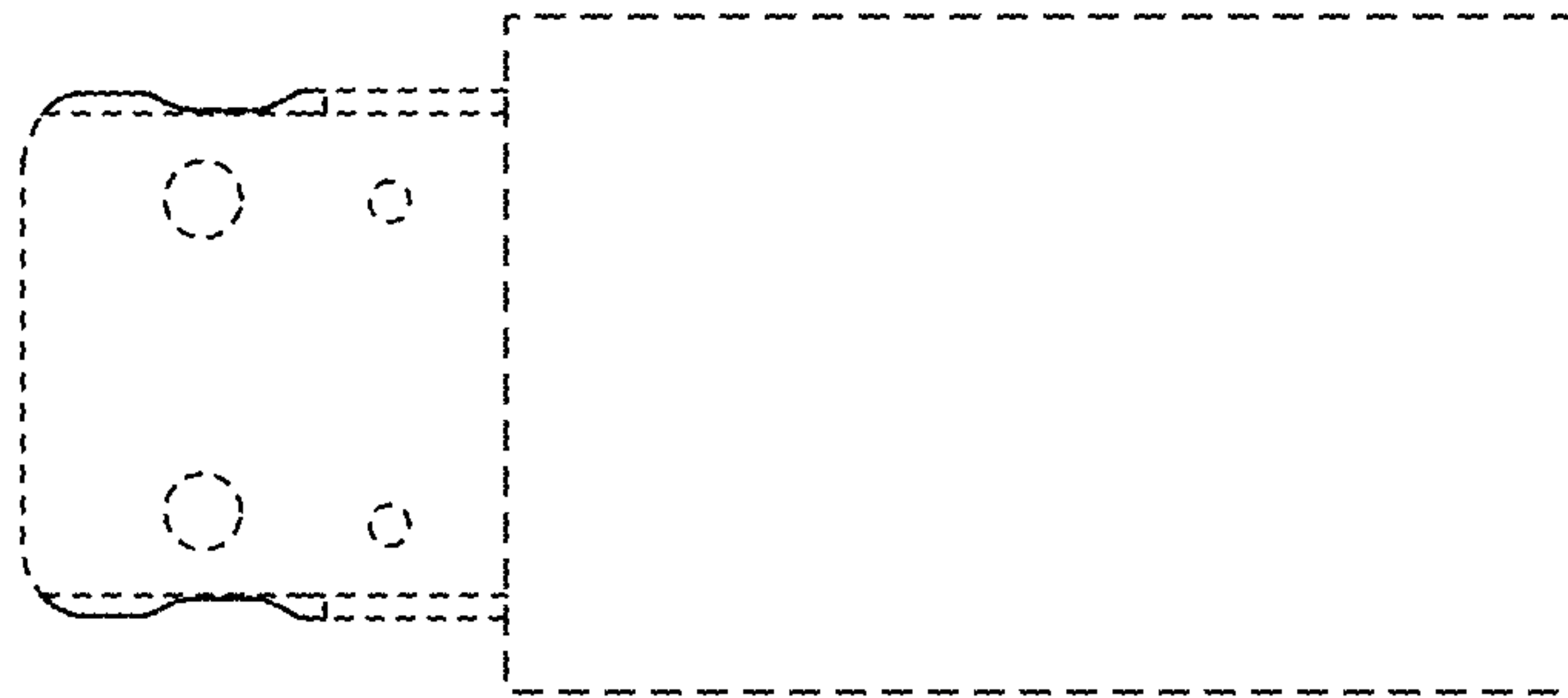

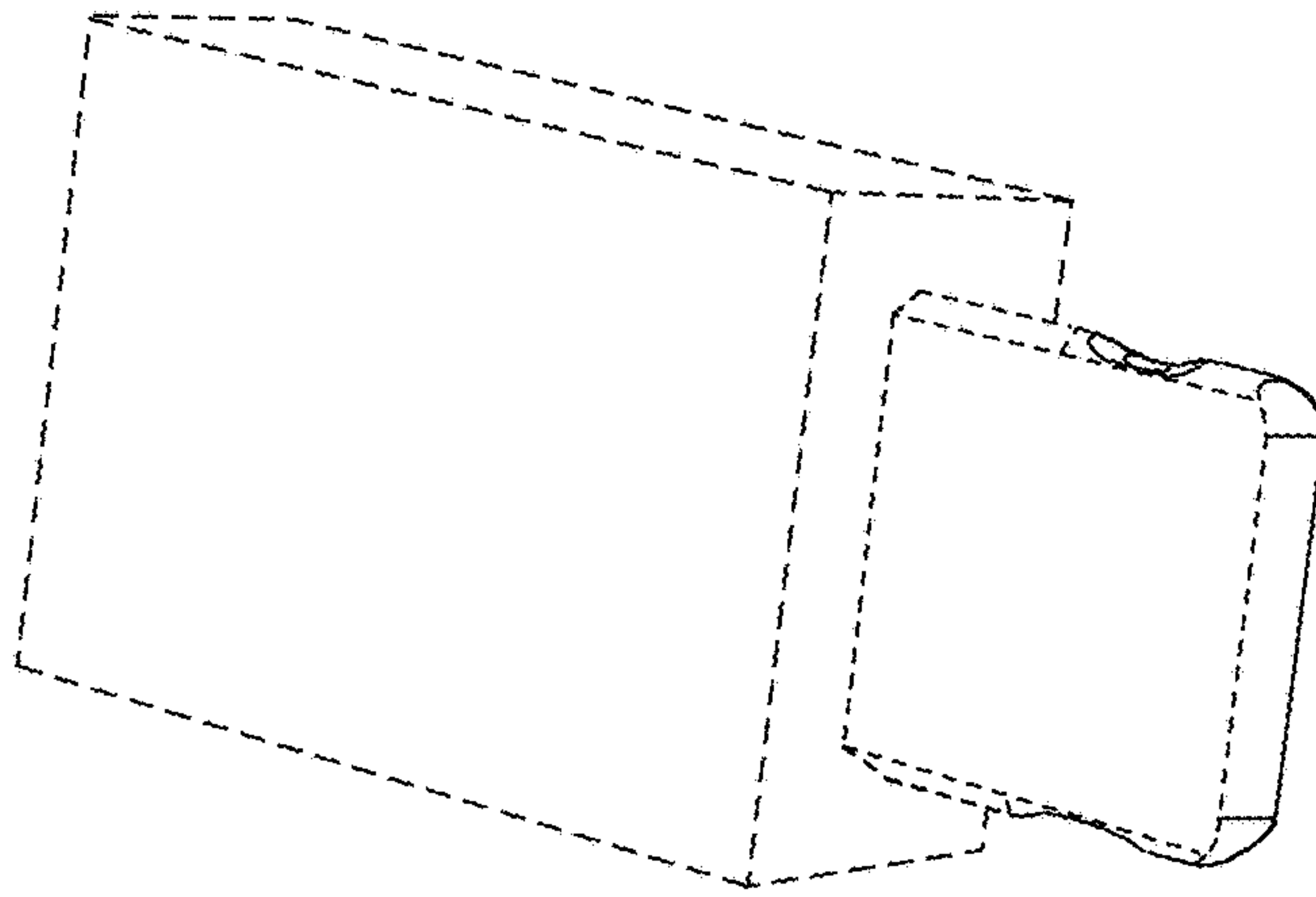

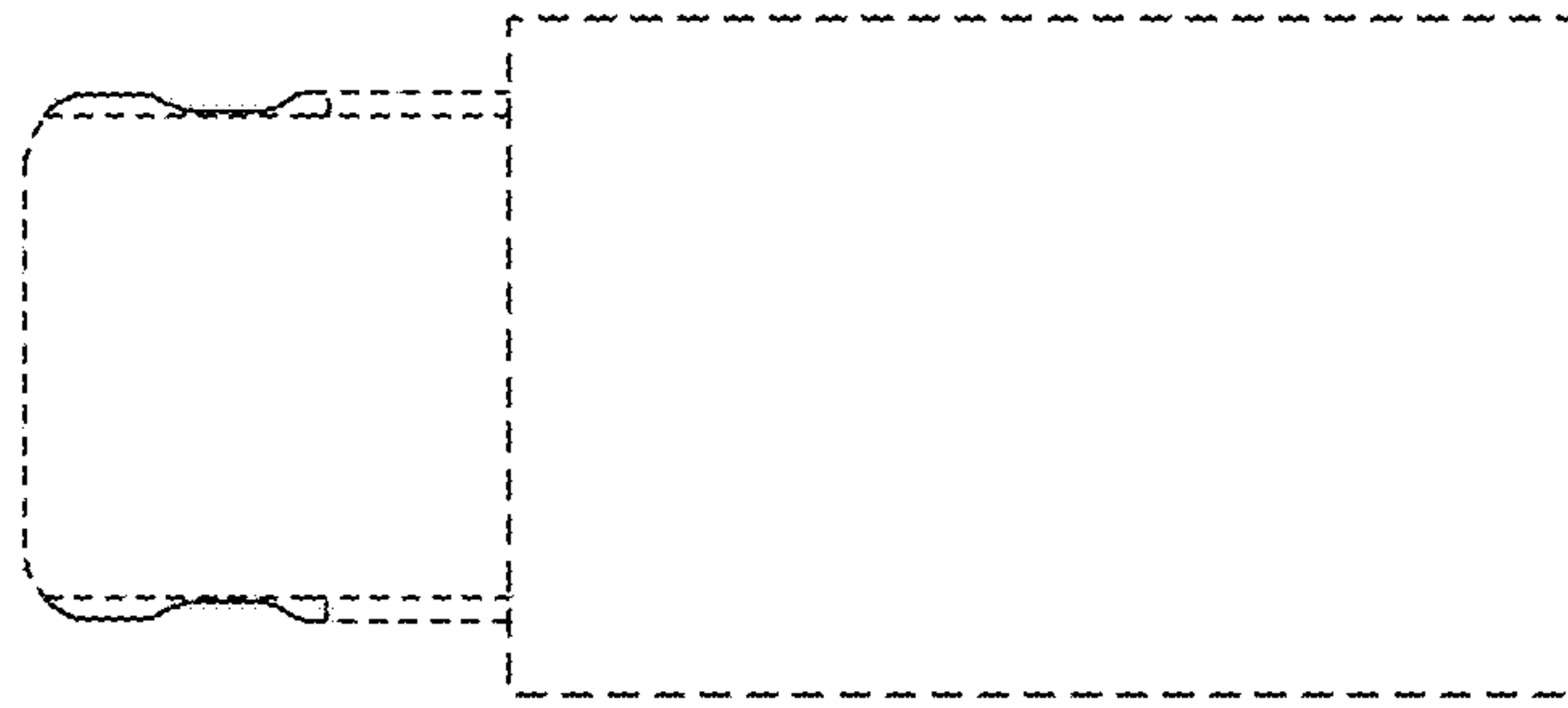

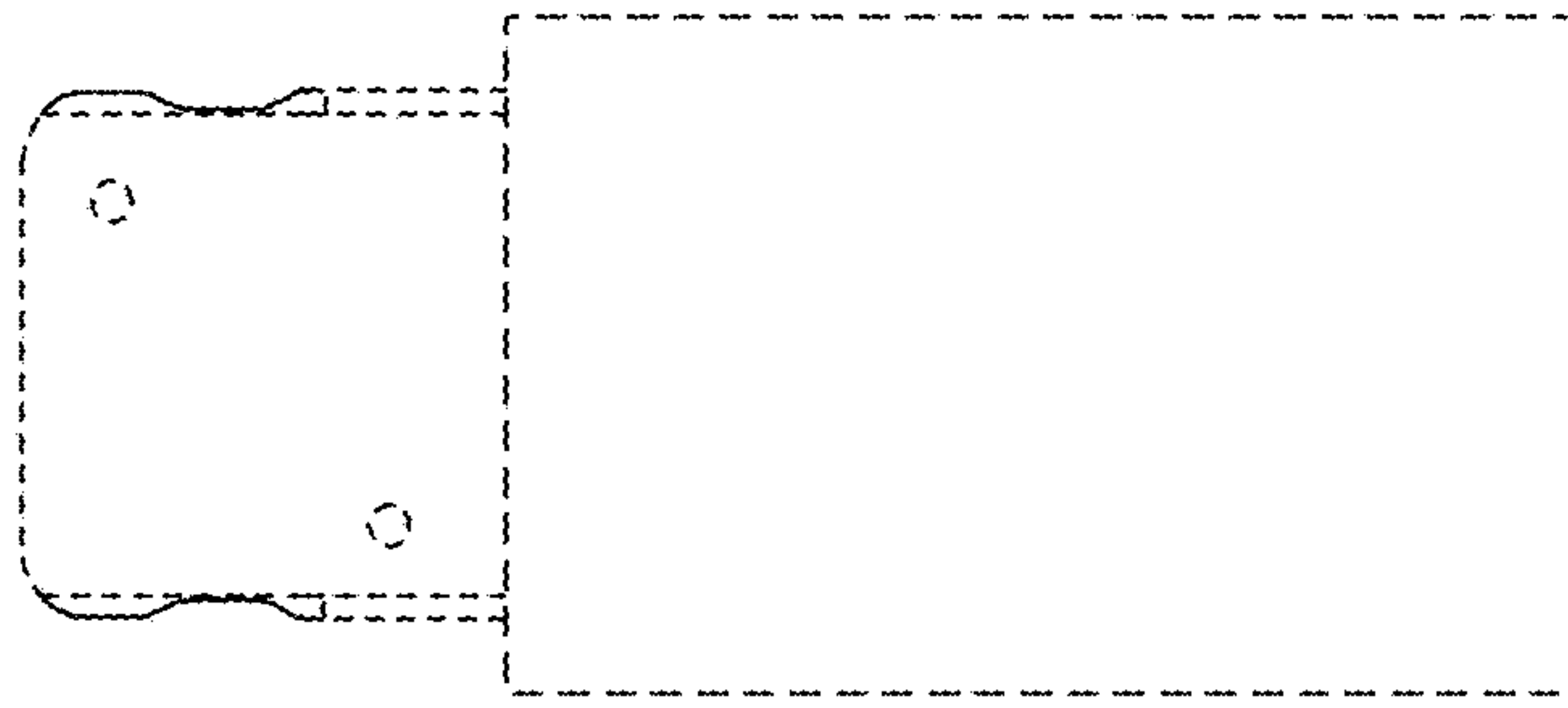

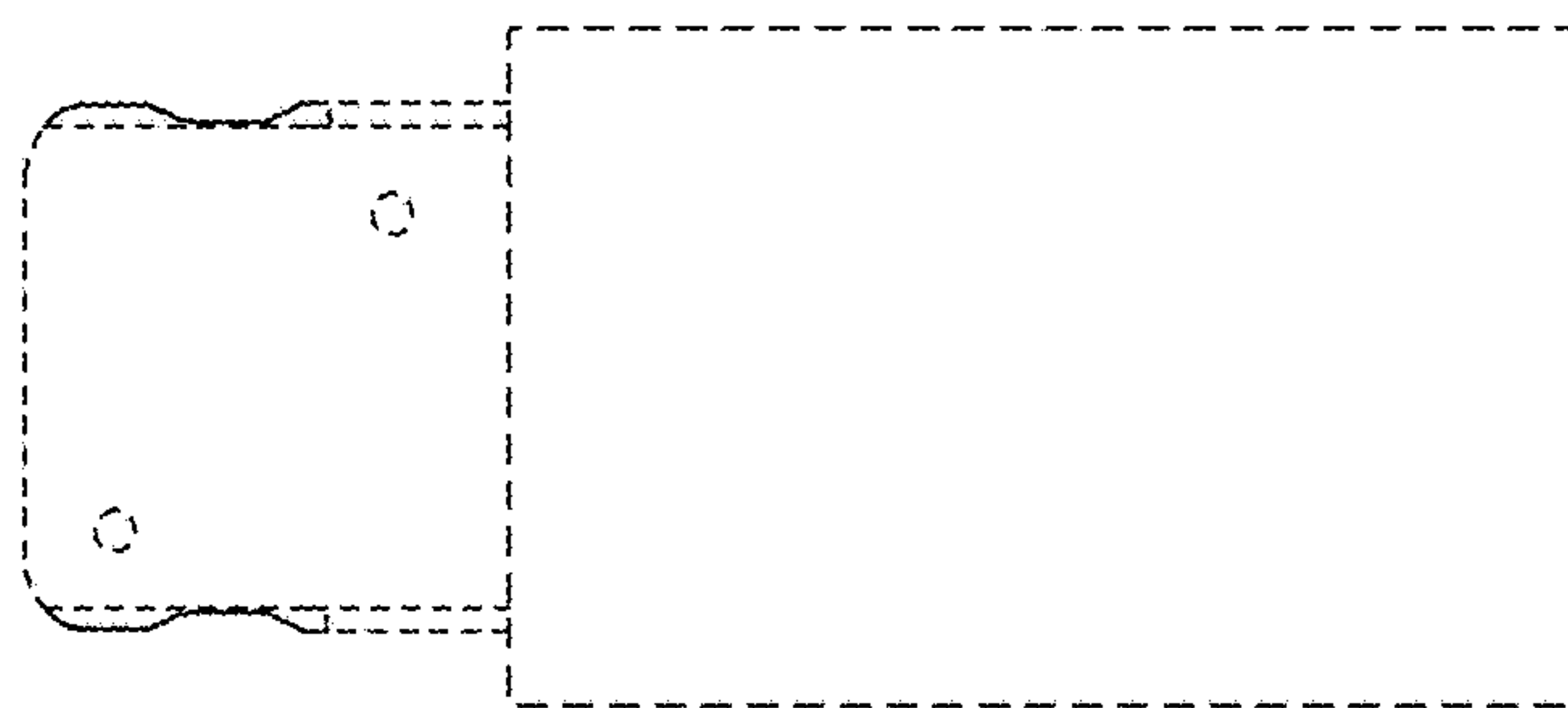

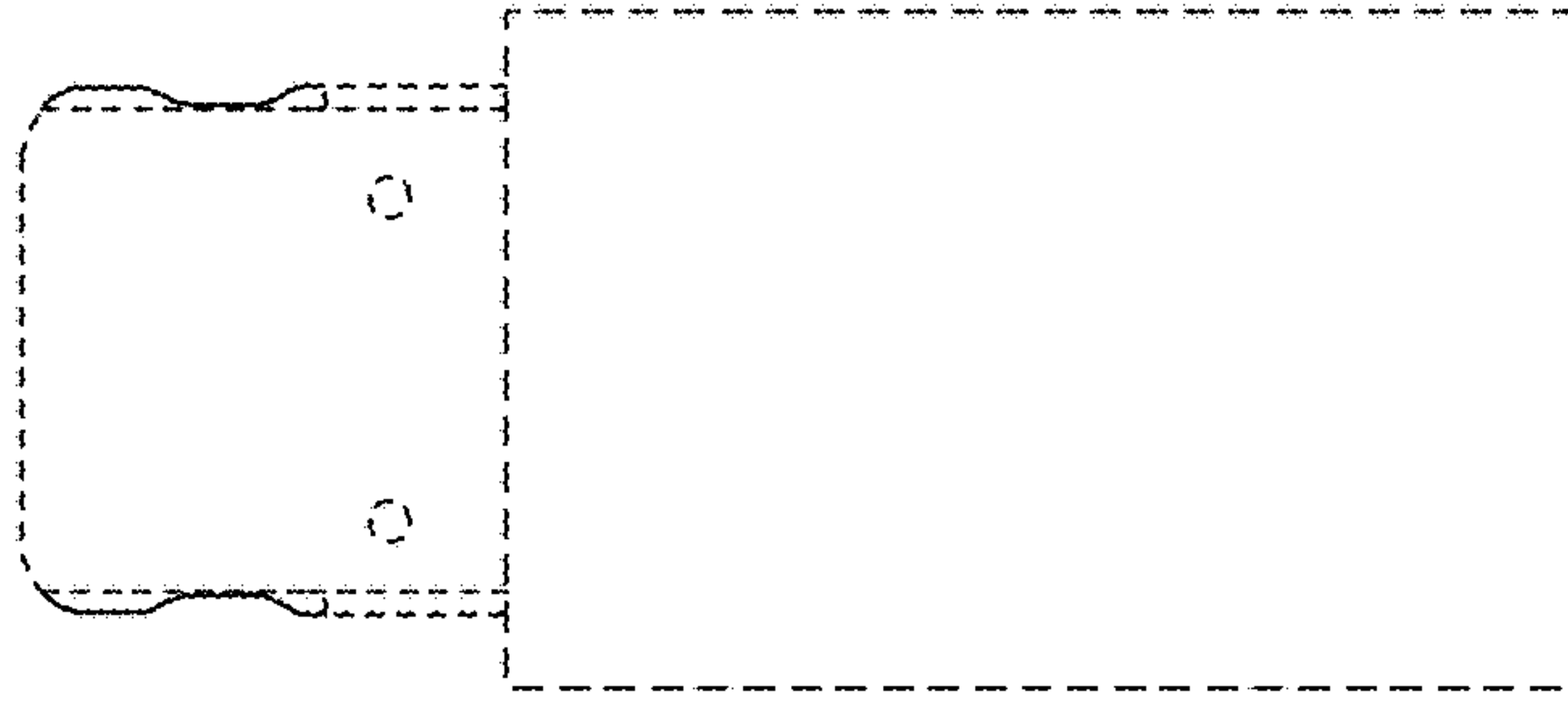

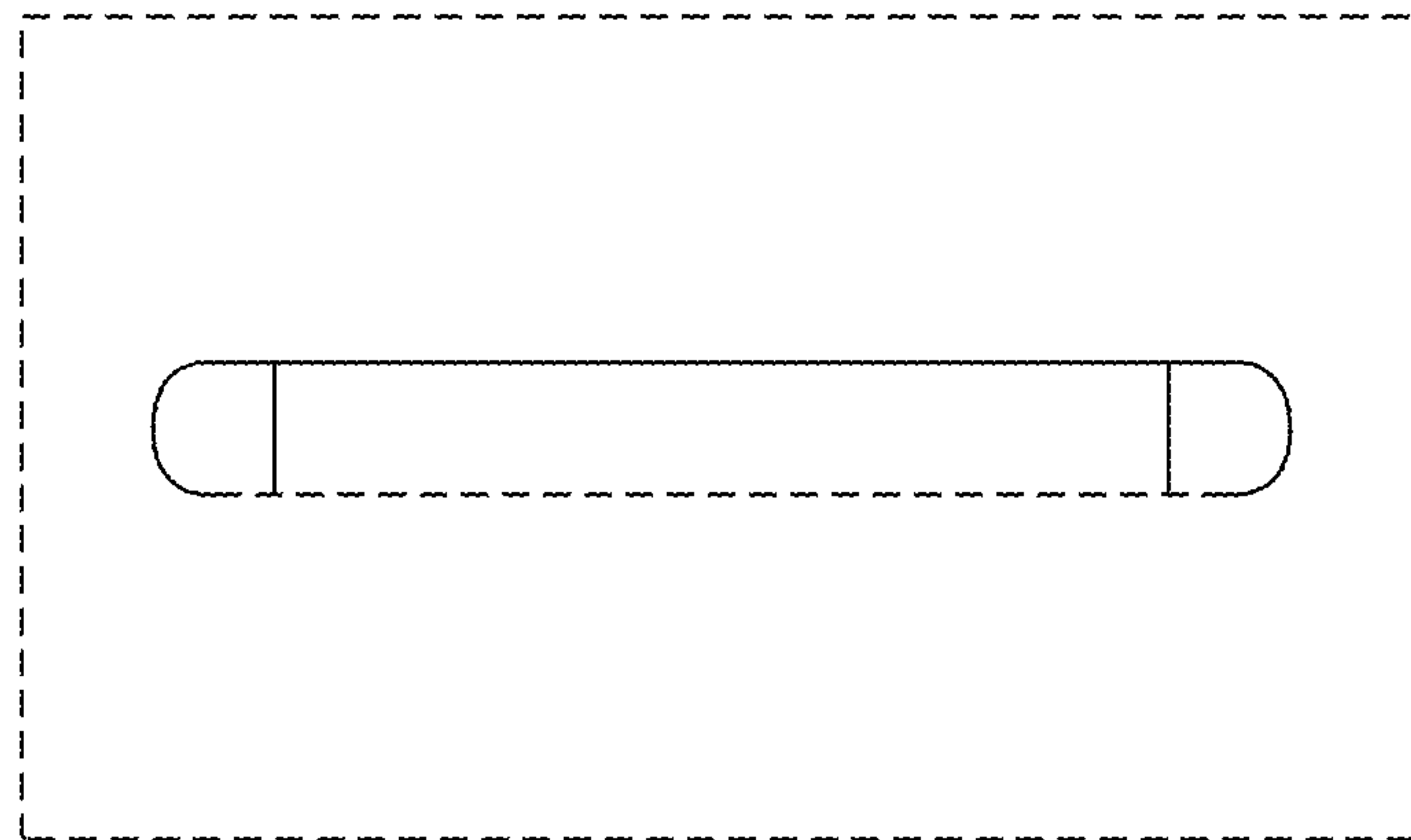

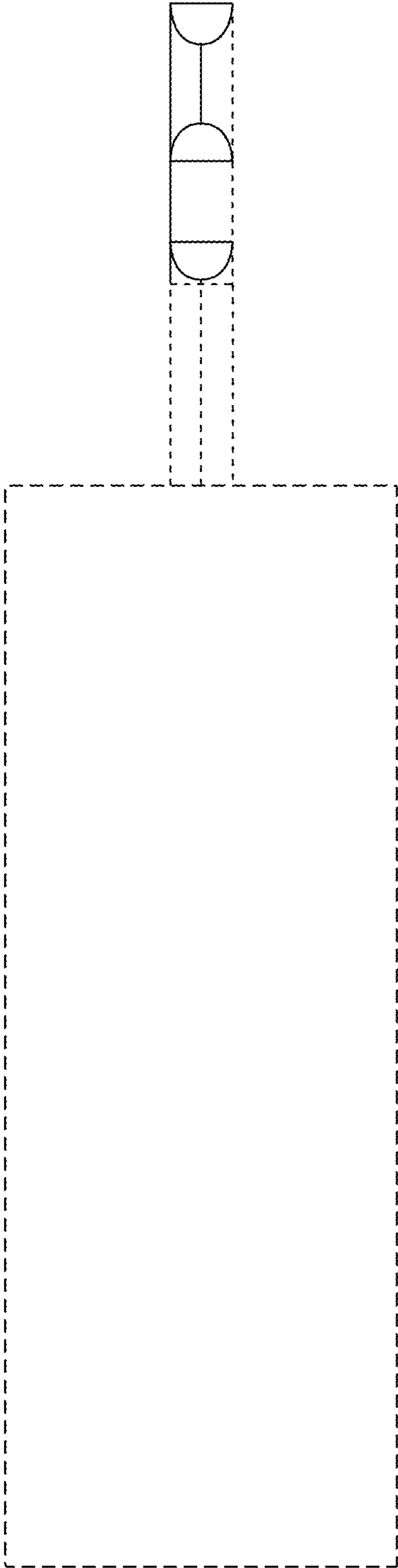
