We claim the ornamental design for an appliance interior
with color, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an appliance interior with
color in a closed configuration according to a closed con-
figuration of our design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a left side elevation view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a front elevation view of the appliance interior with
color in an open configuration of our design;

FIG. 7 is an enlarged top left perspective view thereof;

FIG. 8 is an enlarged top right perspective view thereof;

FIG. 9 is a front elevation view thereof;

FIG. 10 is a partial left perspective view thereof;

FIG. 11 is a partial front elevation view thereof;

FIG. 12 is a partial left perspective view thereof in a first use
condition of the open configuration;

FIG. 13 is a partial front elevation view of a right portion
thereof;

FIG. 14 is a partial right perspective view thereof;

FIG. 15 is a partial front elevation view thereof;

FIG. 16 is a partial right perspective view thereof in a second
use condition of the open configuration; and,

FIG. 17 is a partial front elevation view thereof.

and form no part of the claimed design.

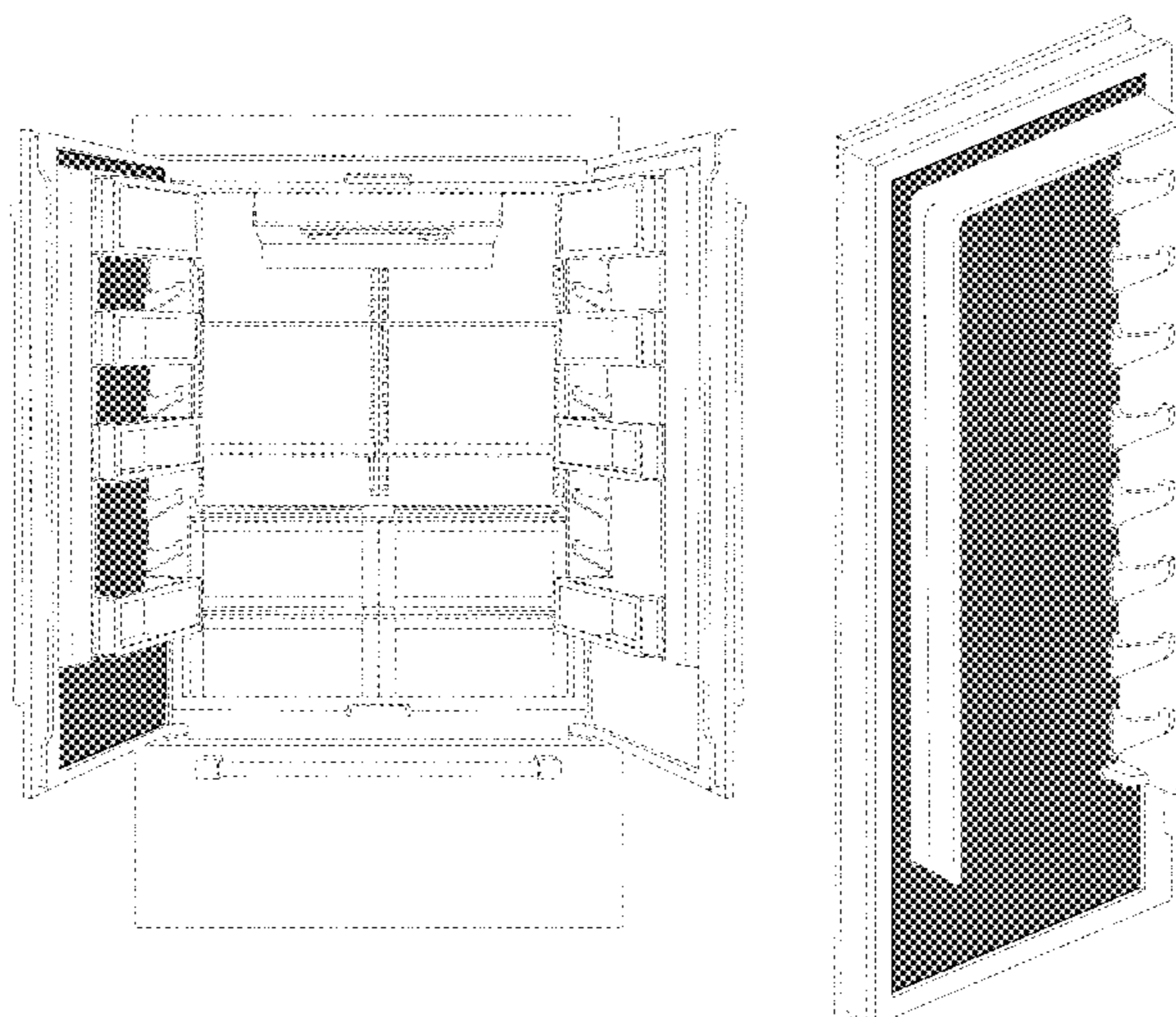
The dark gray interior liner of the refrigerator compartment

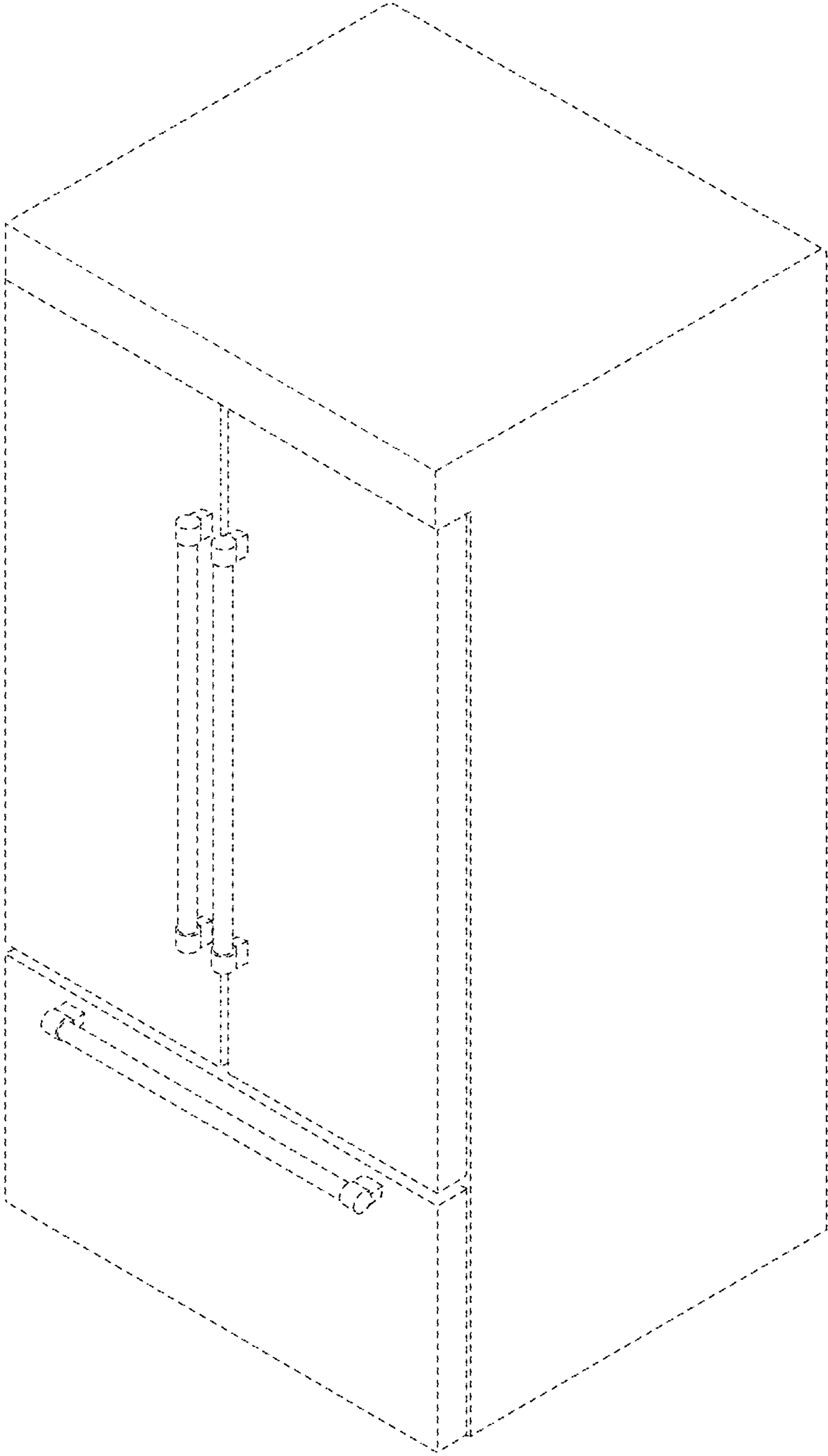

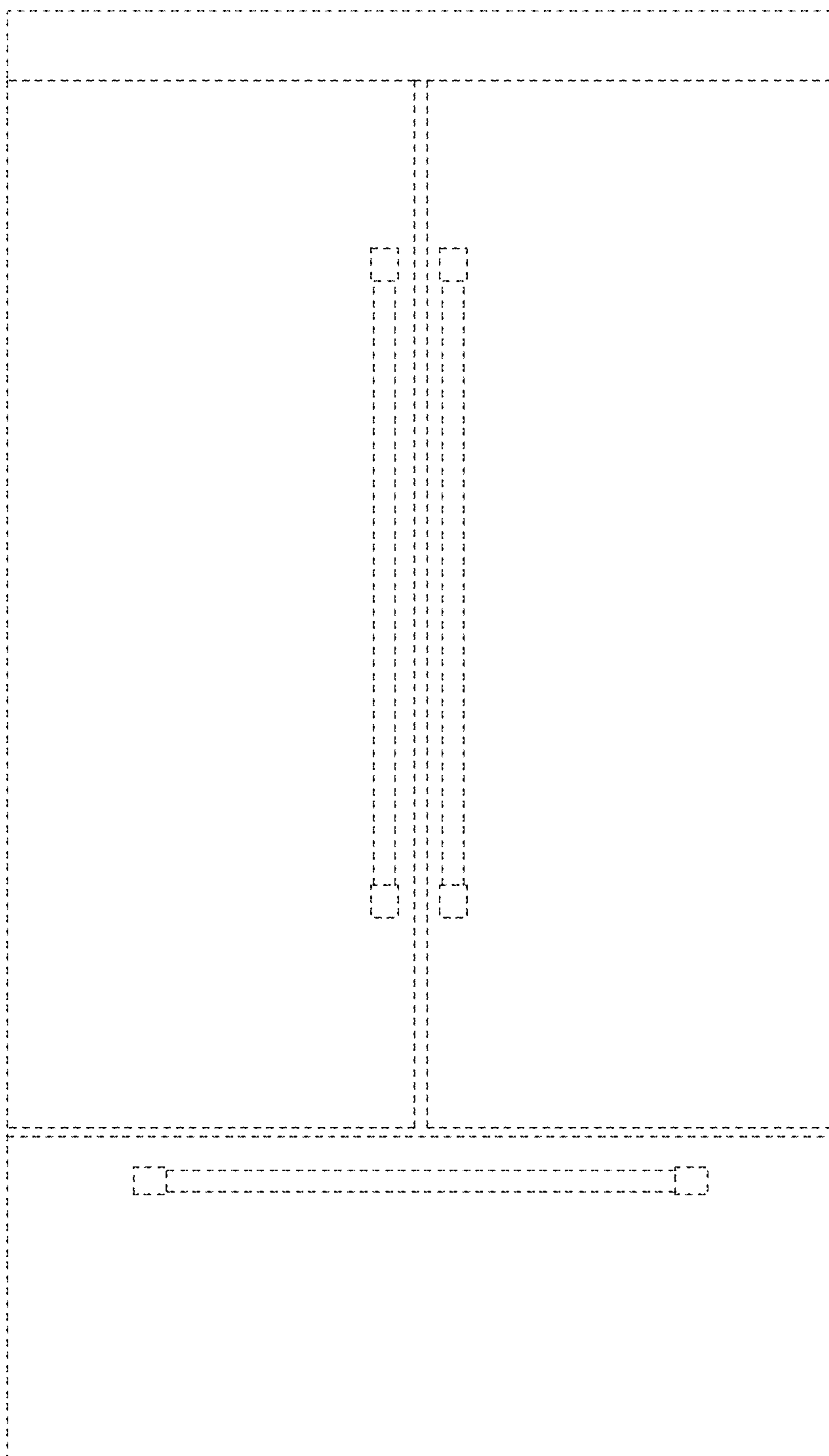

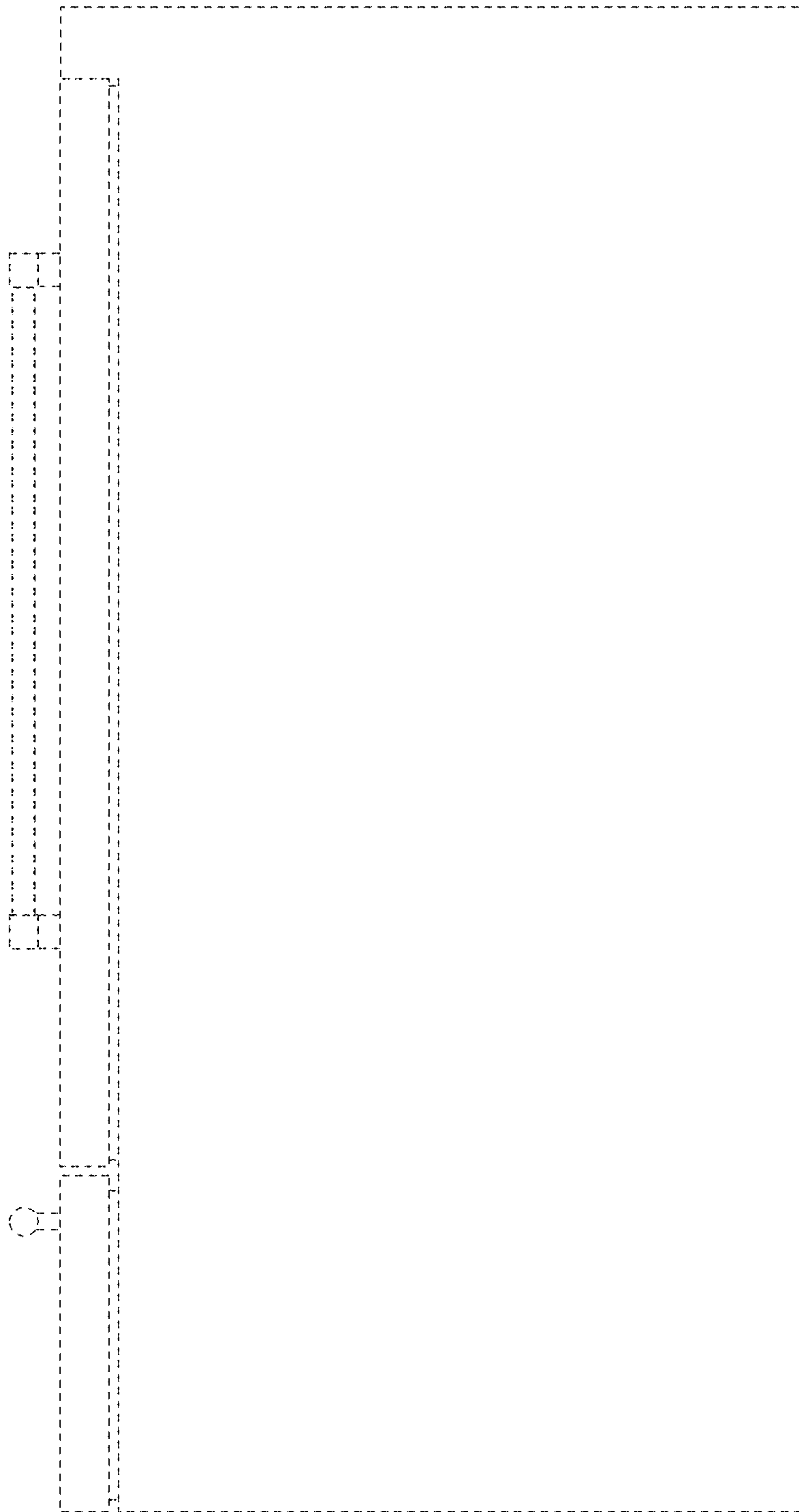

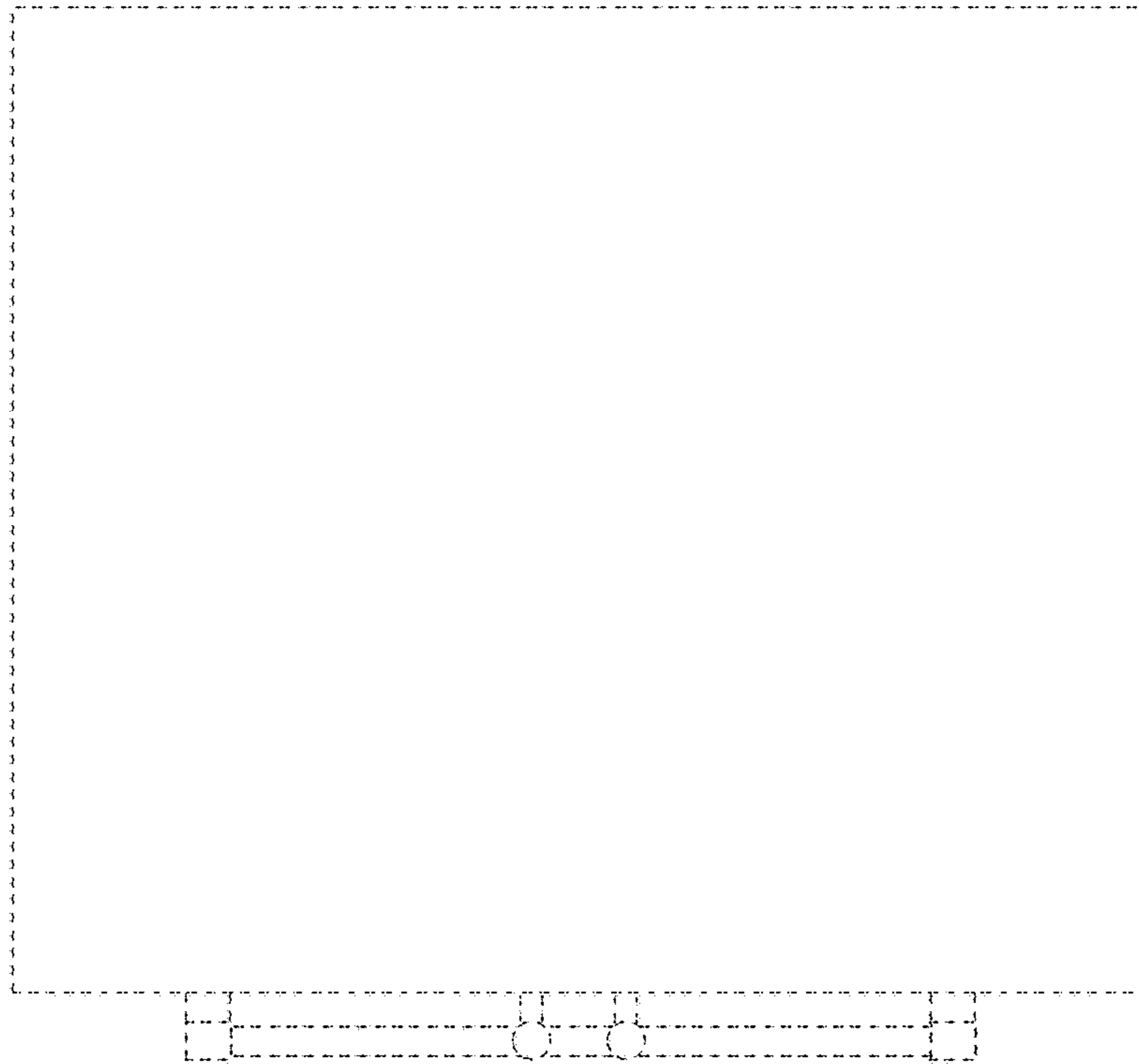

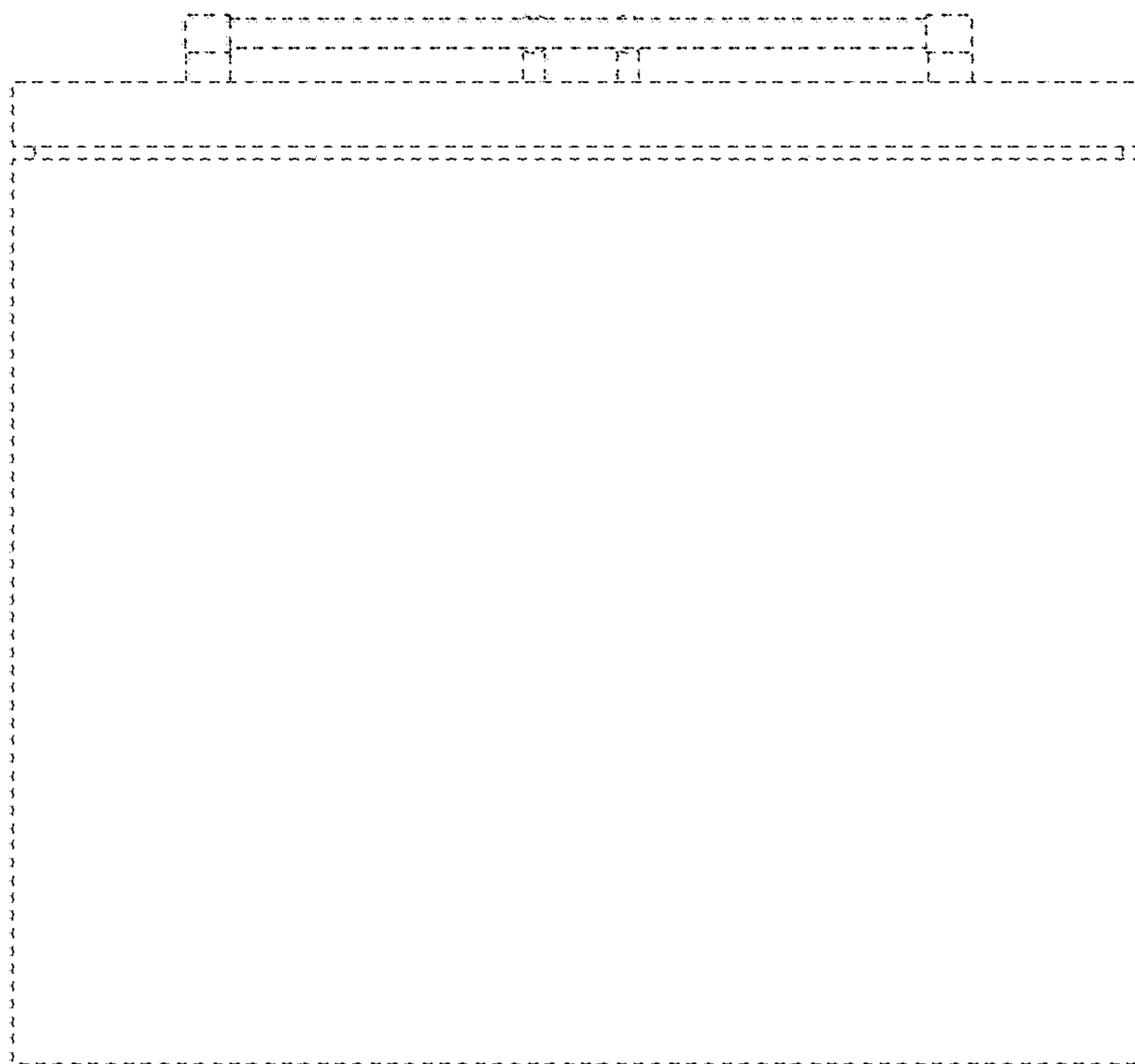

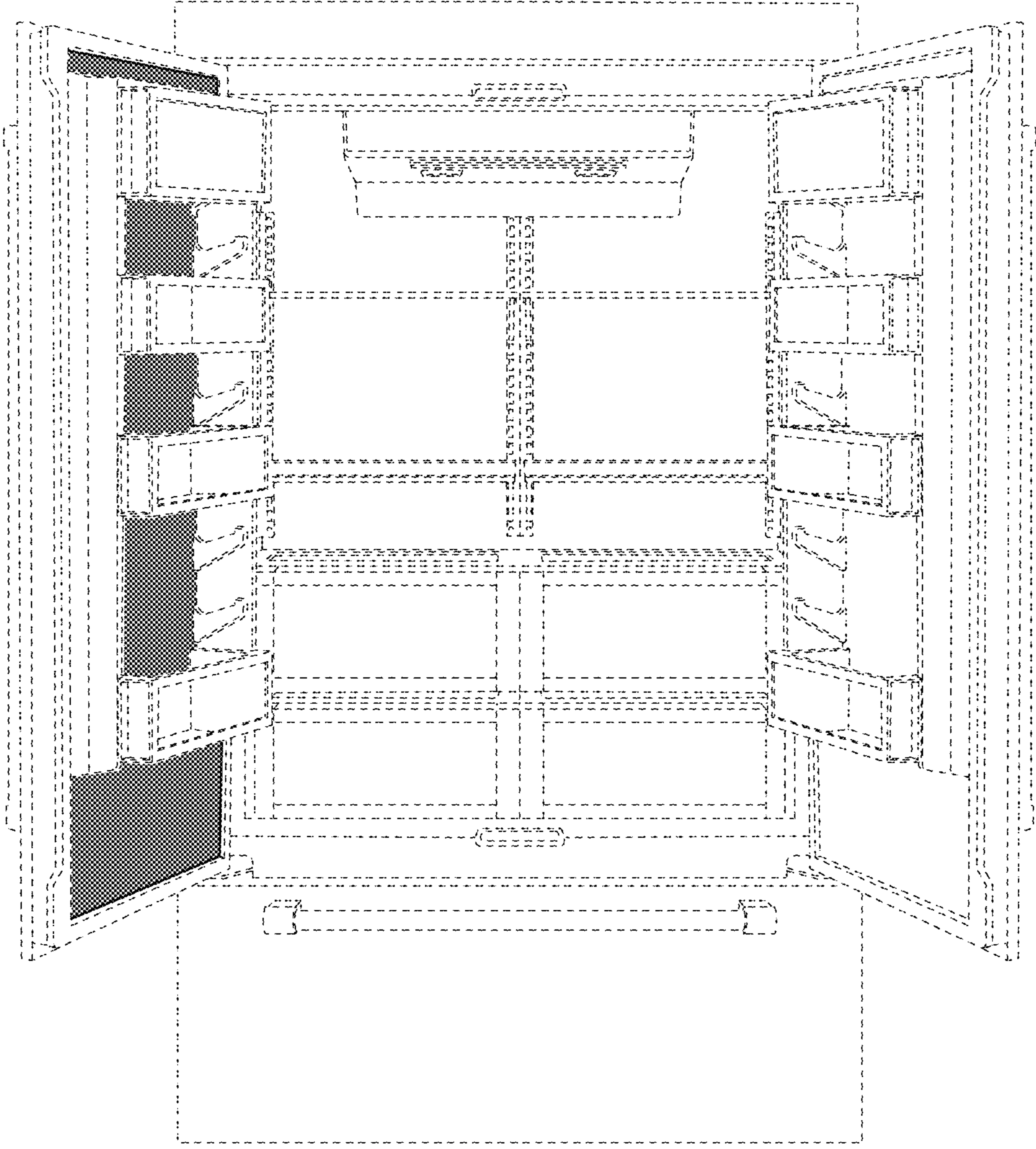
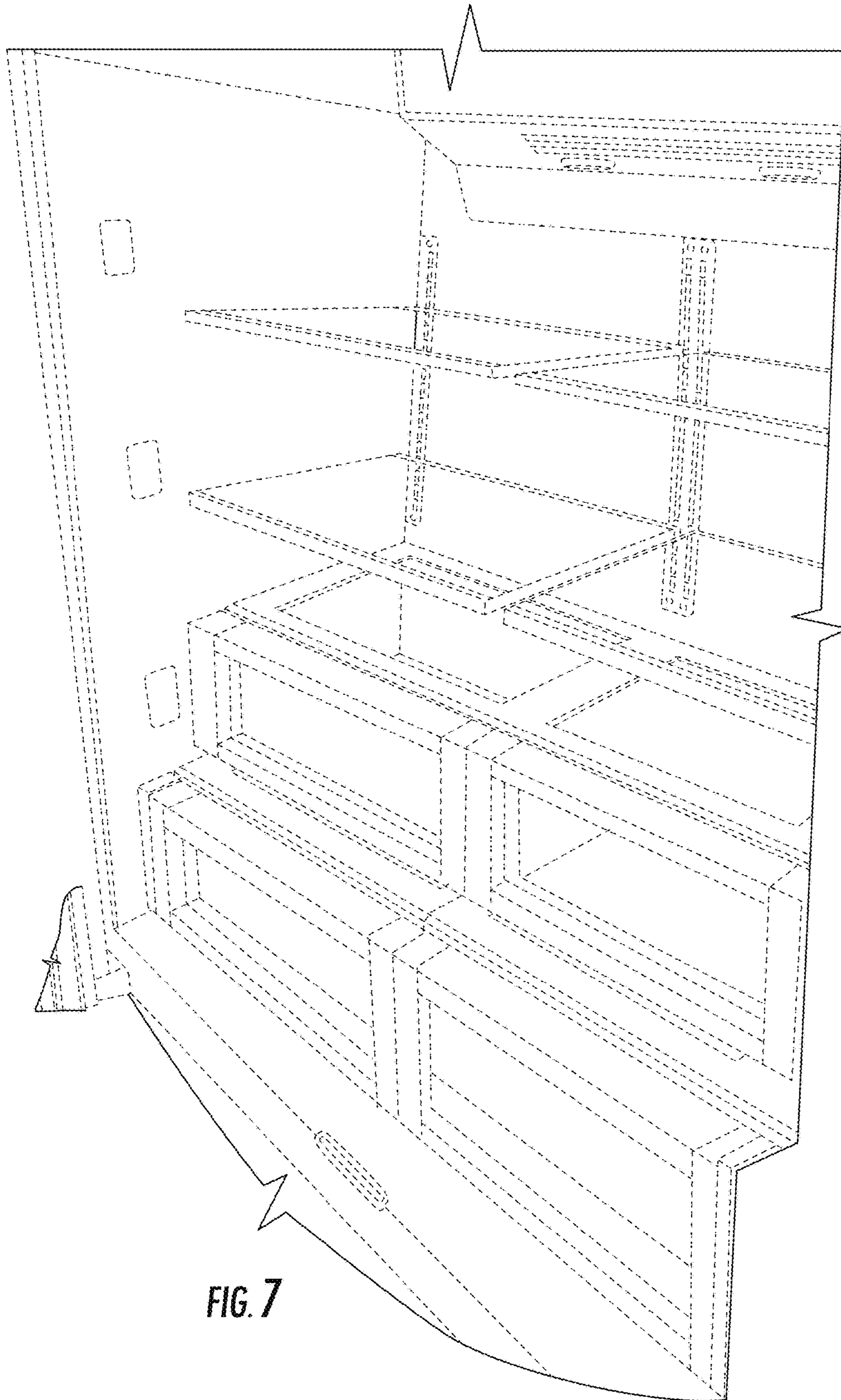

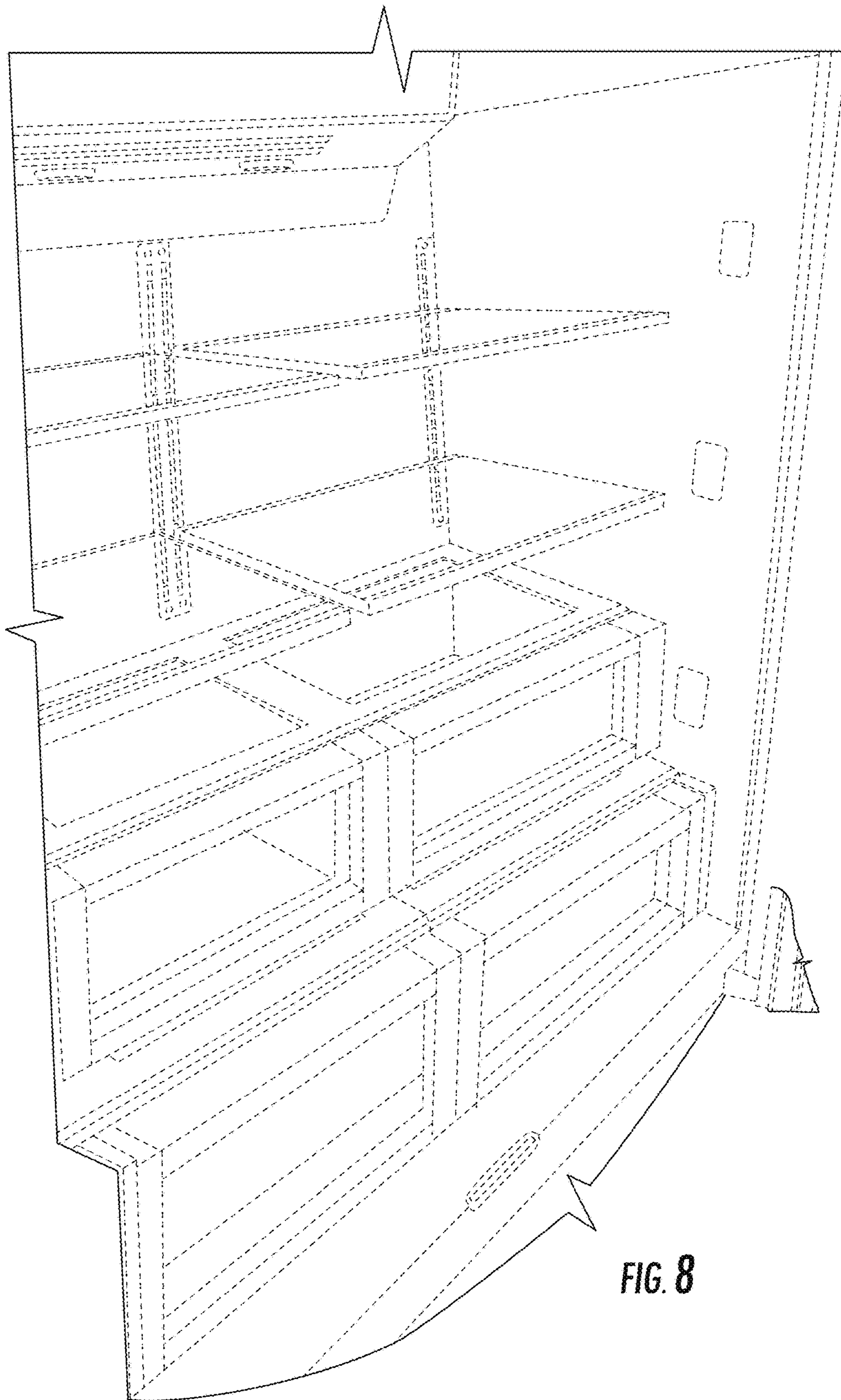

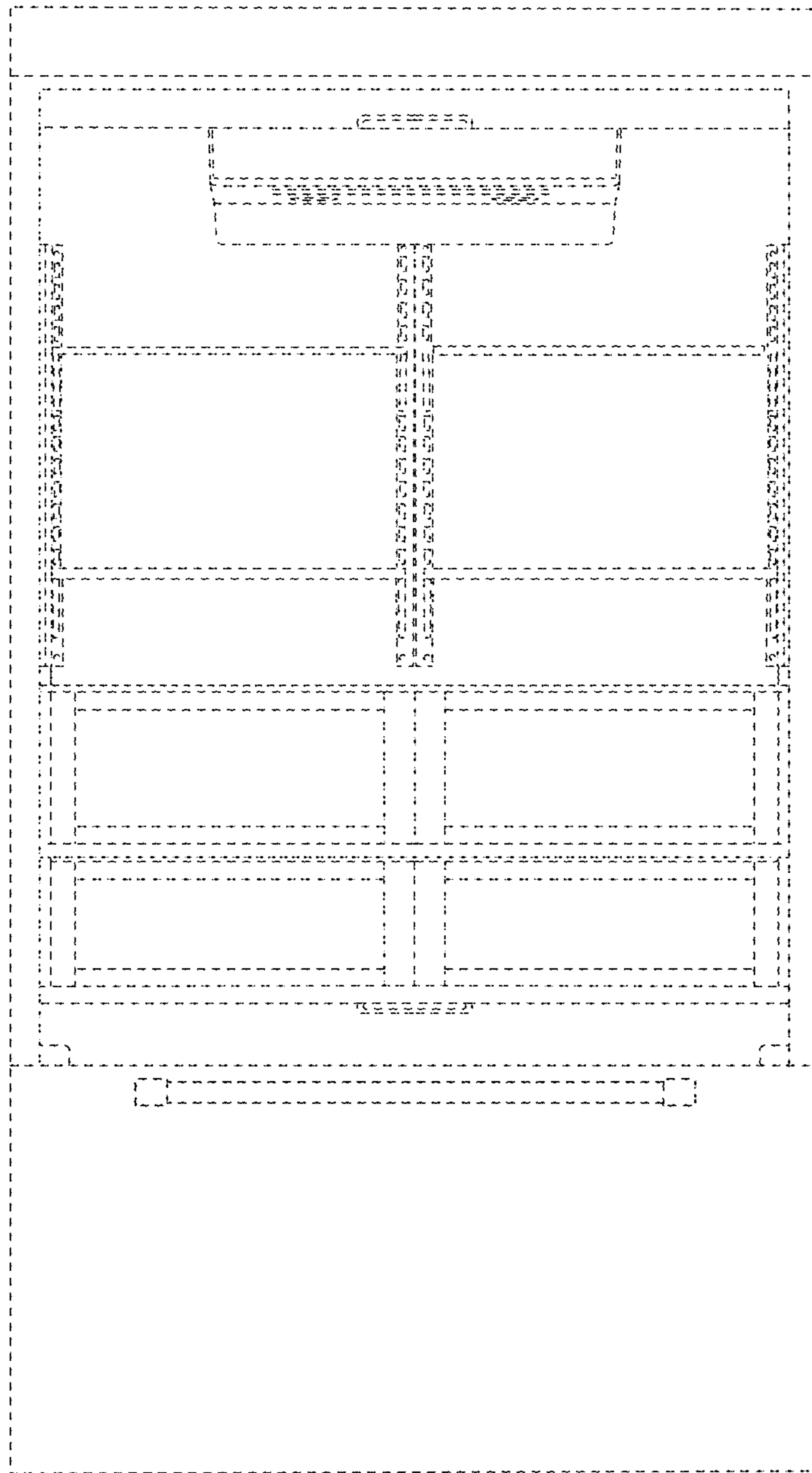

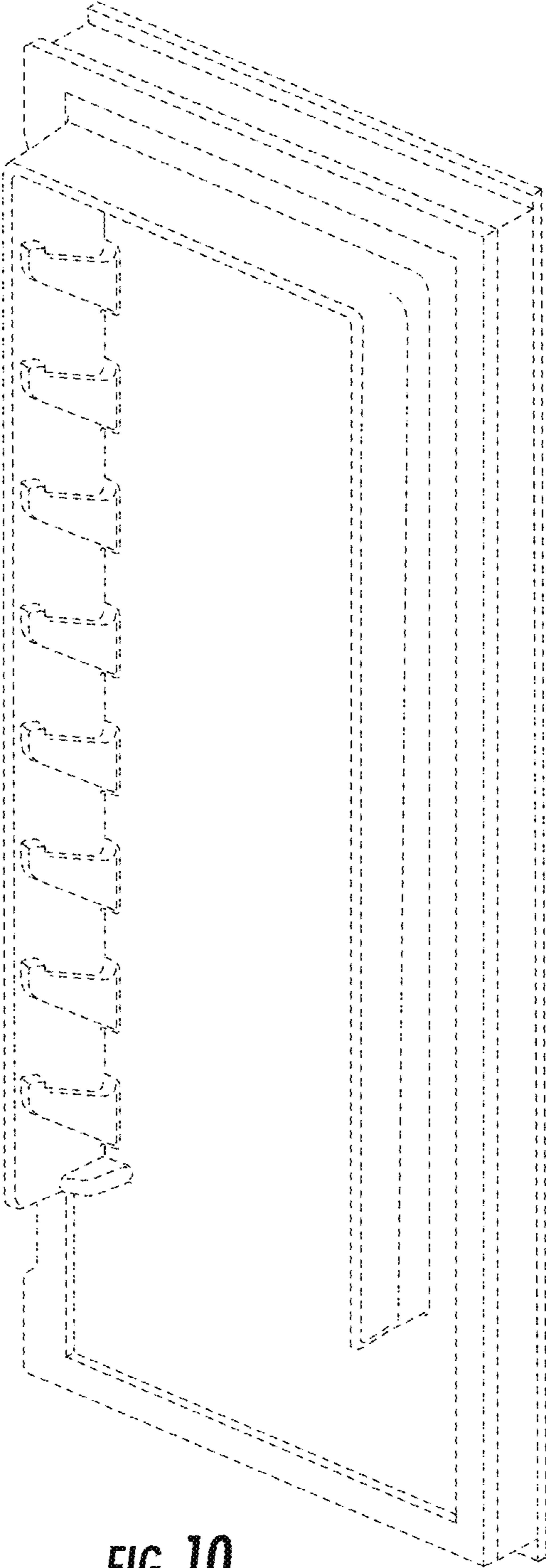

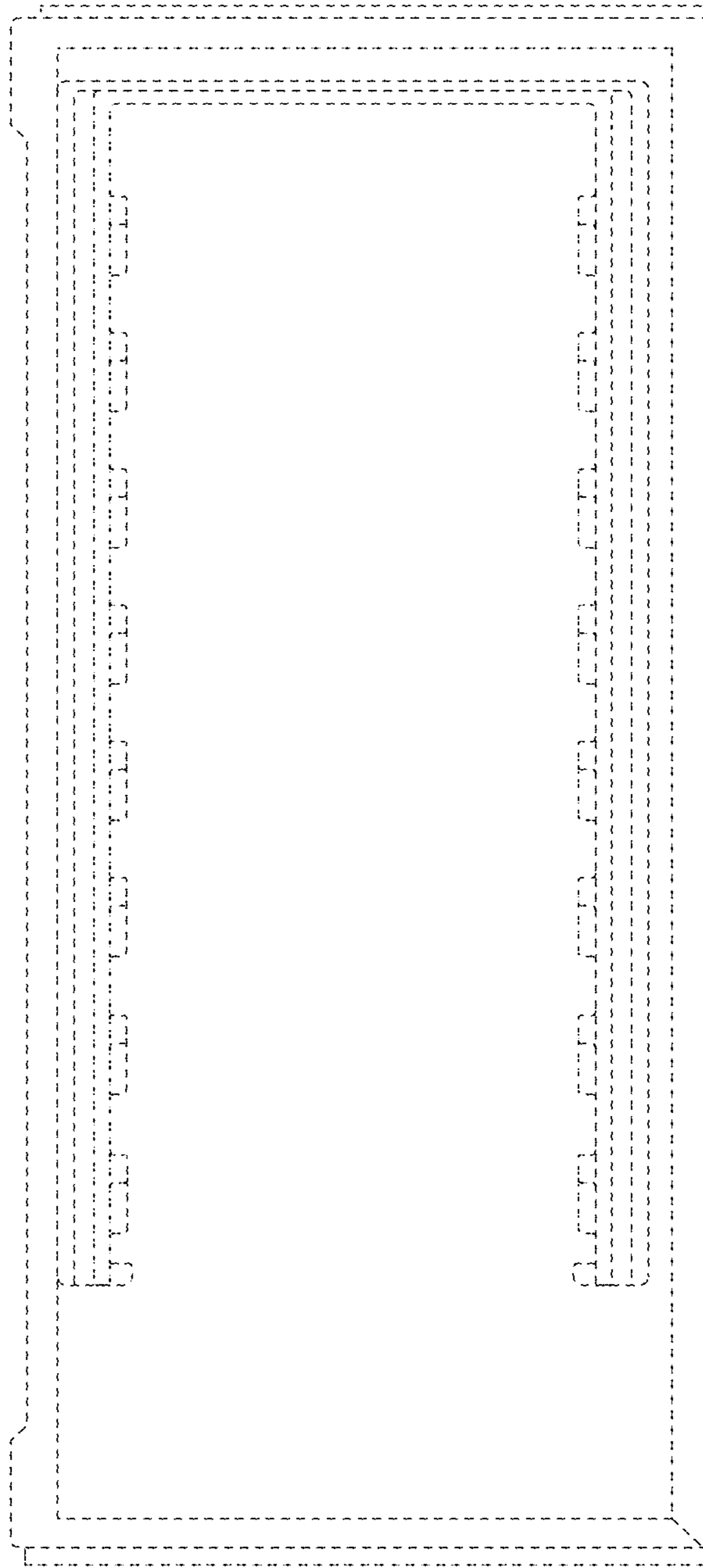

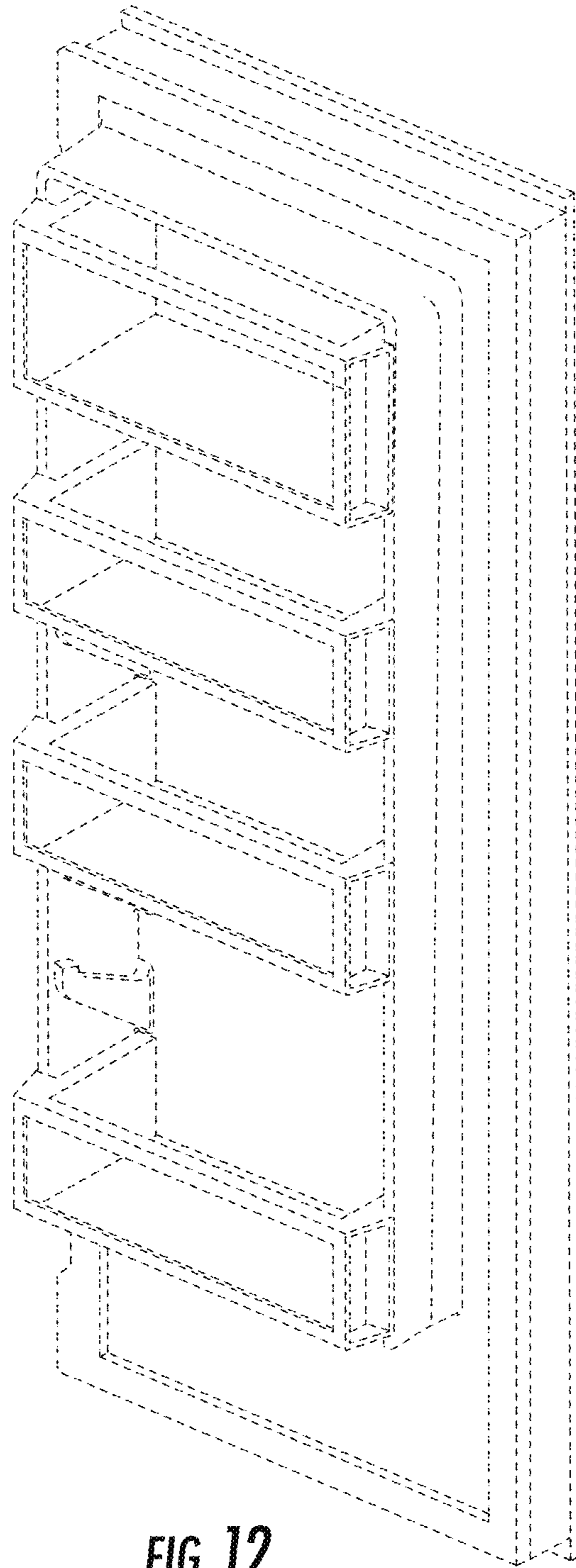

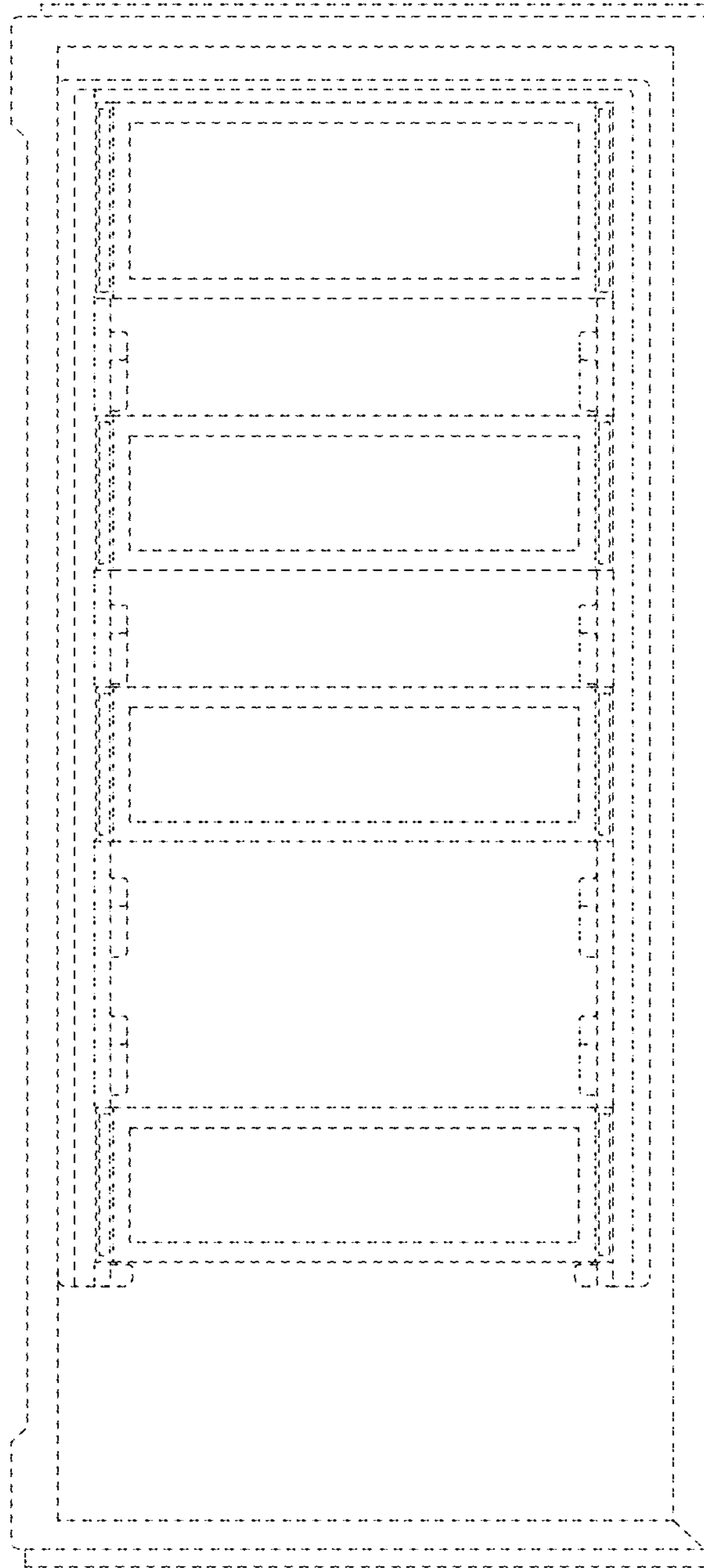

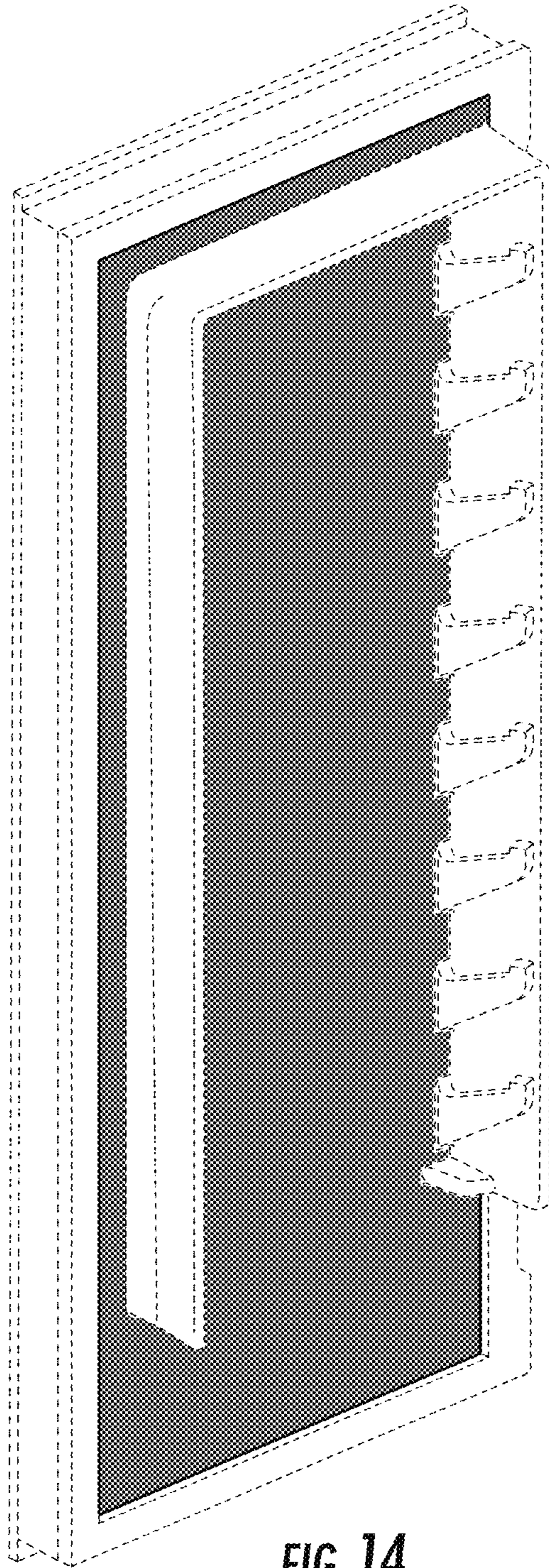

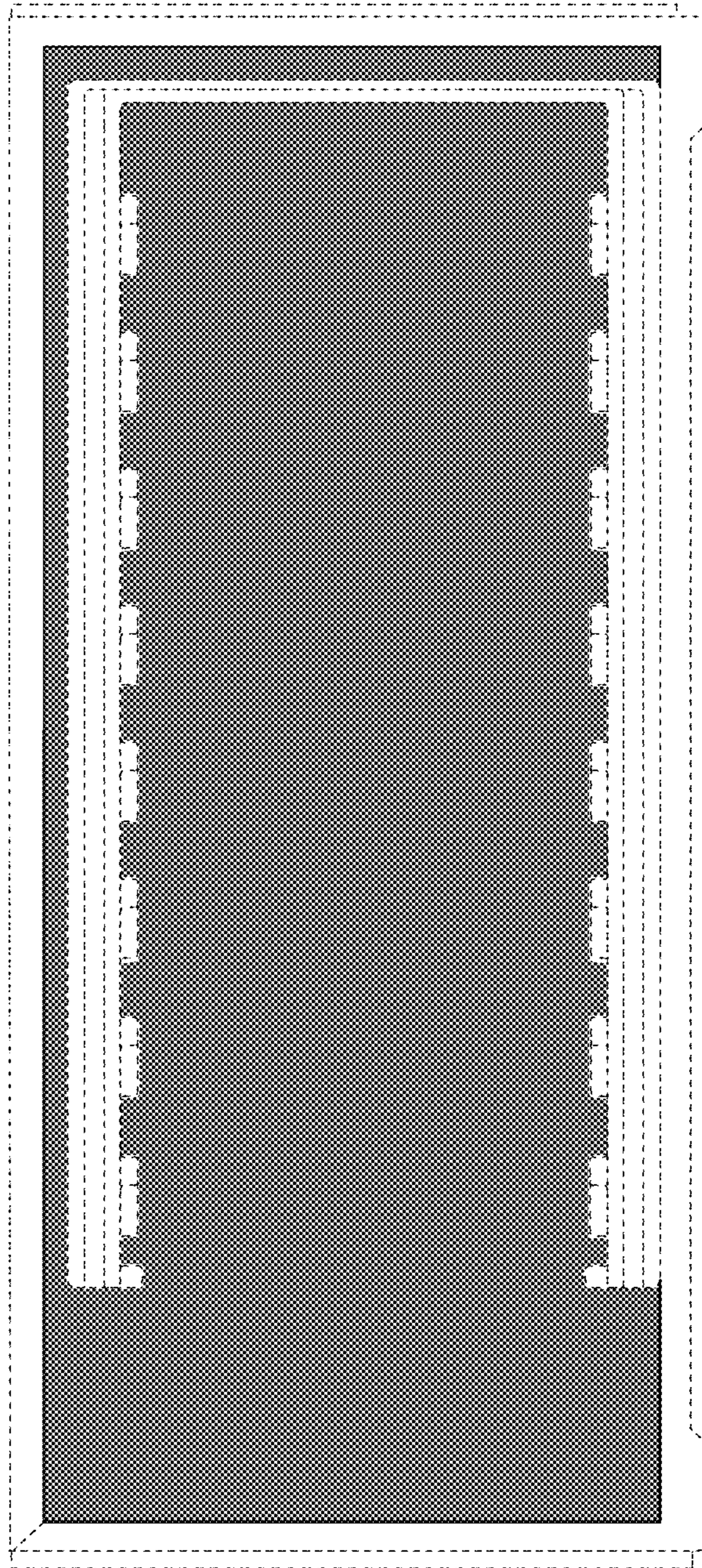

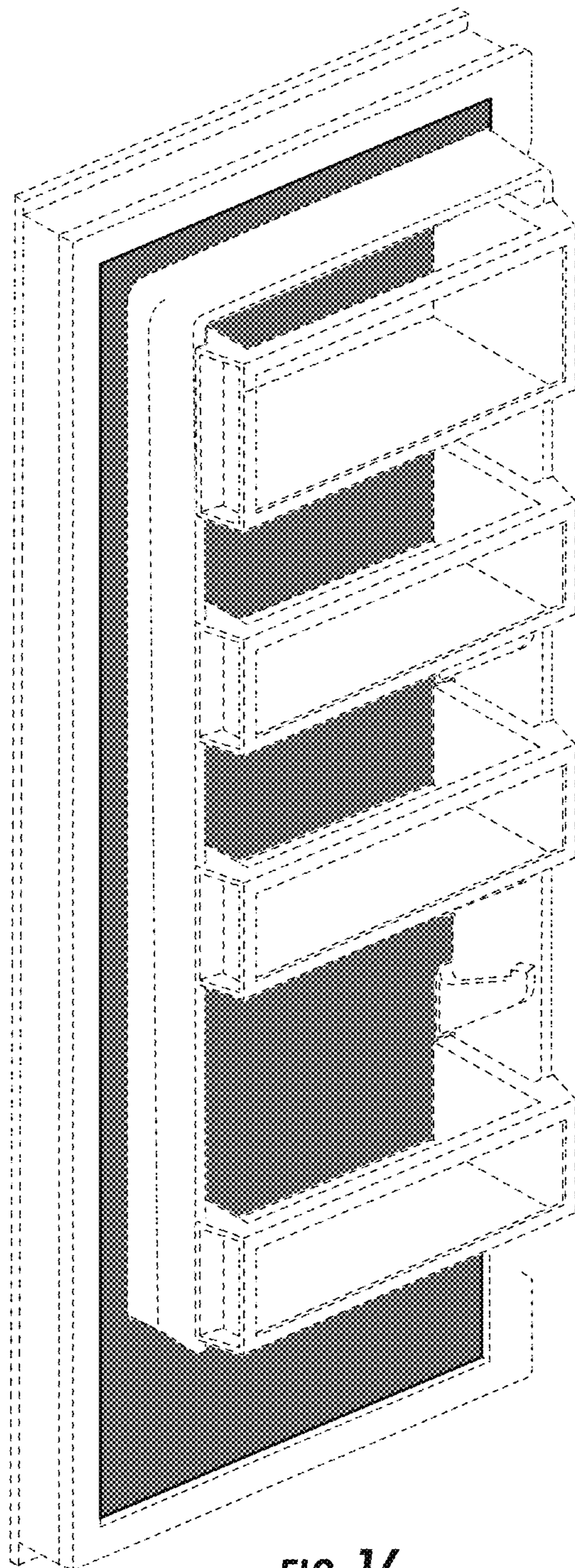

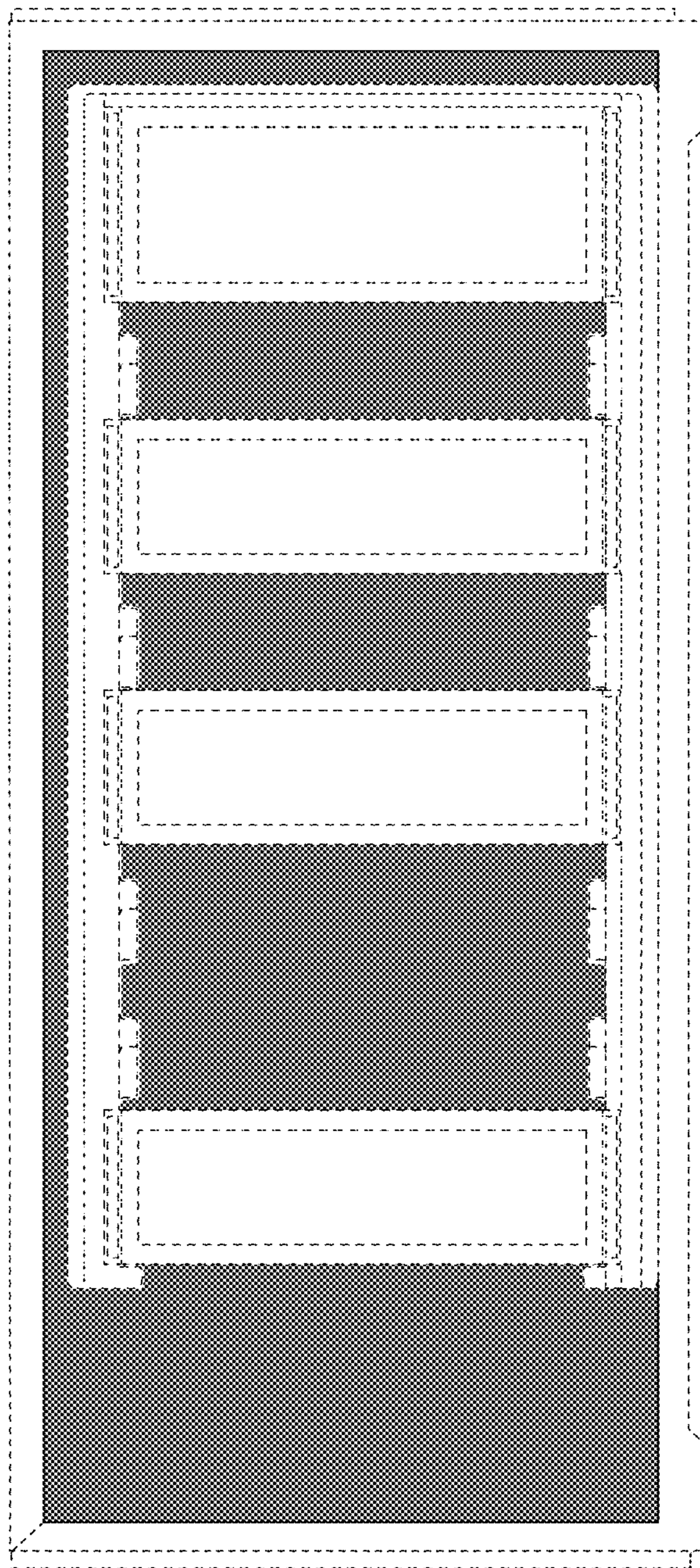
