DESCRIPTION

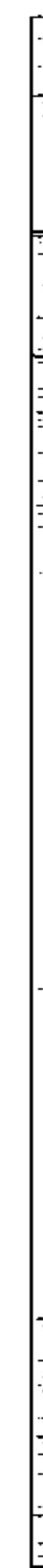
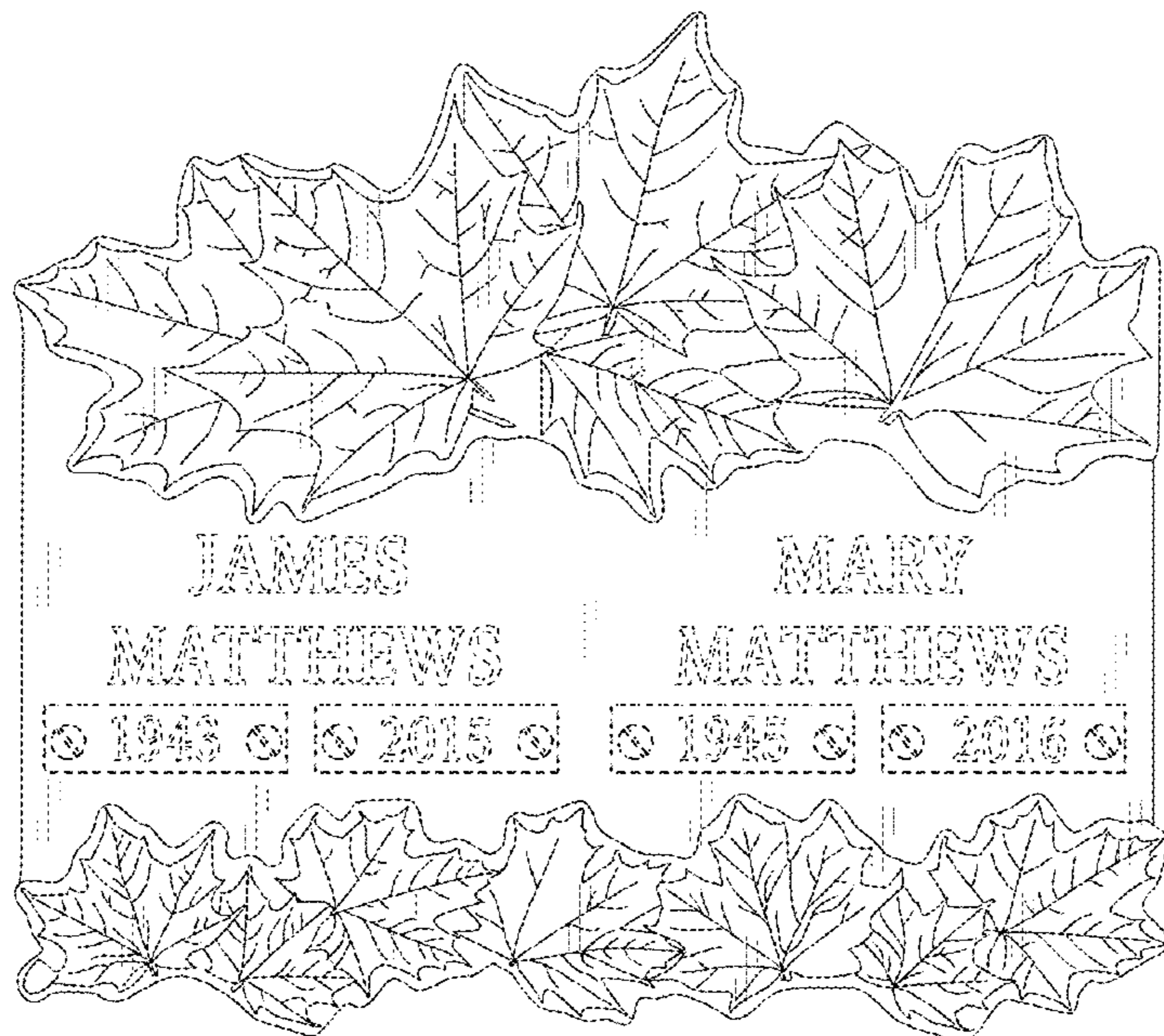
FIG. 1 is a front perspective view of a maple leaf memorial marker, showing the new design;

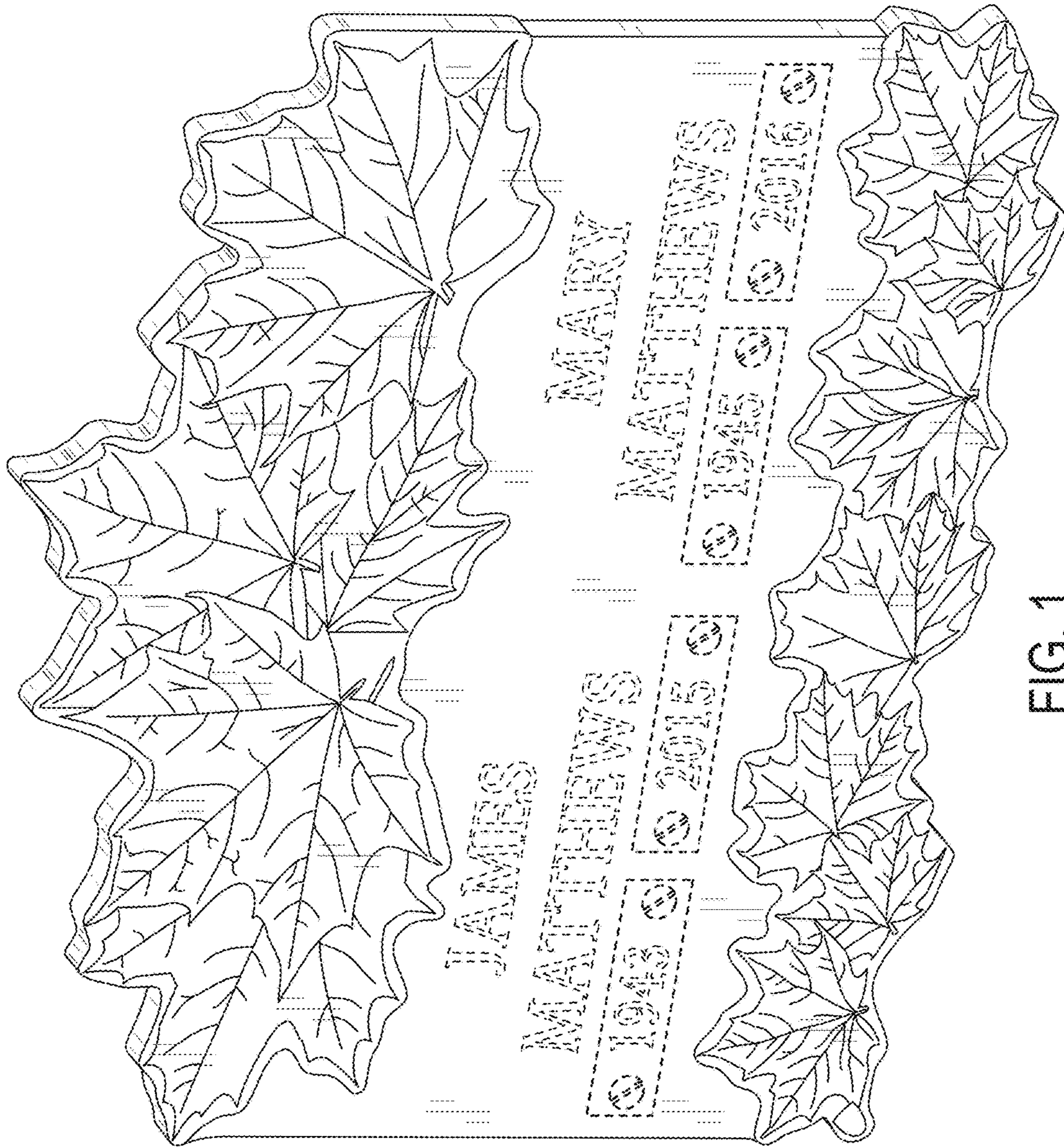

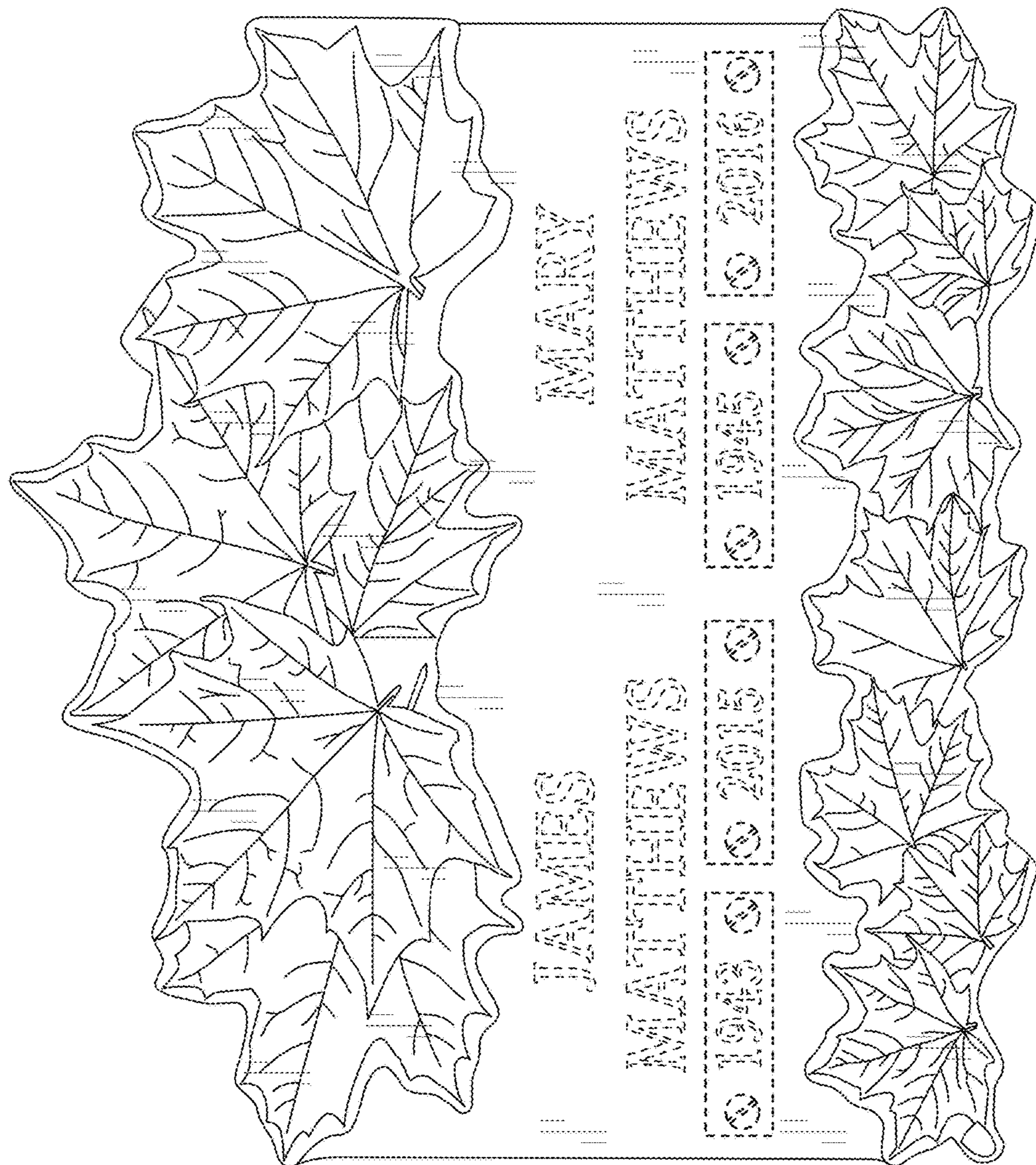

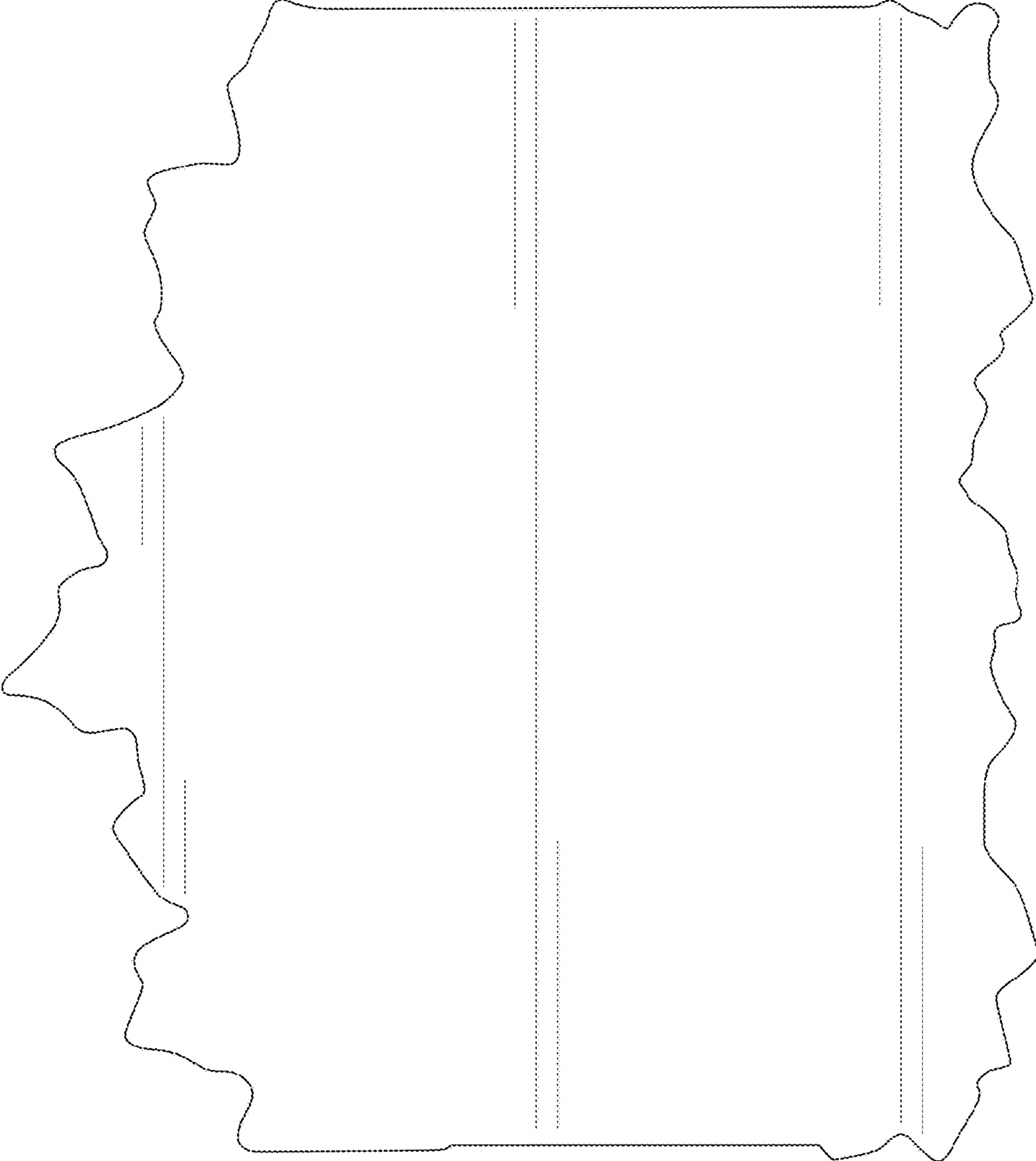

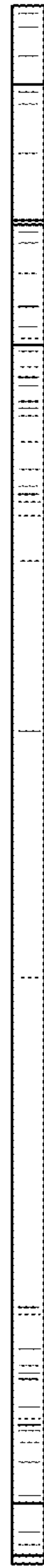

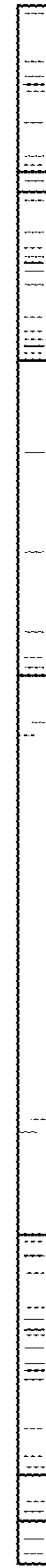

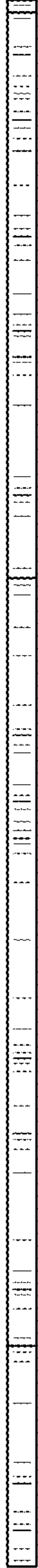
