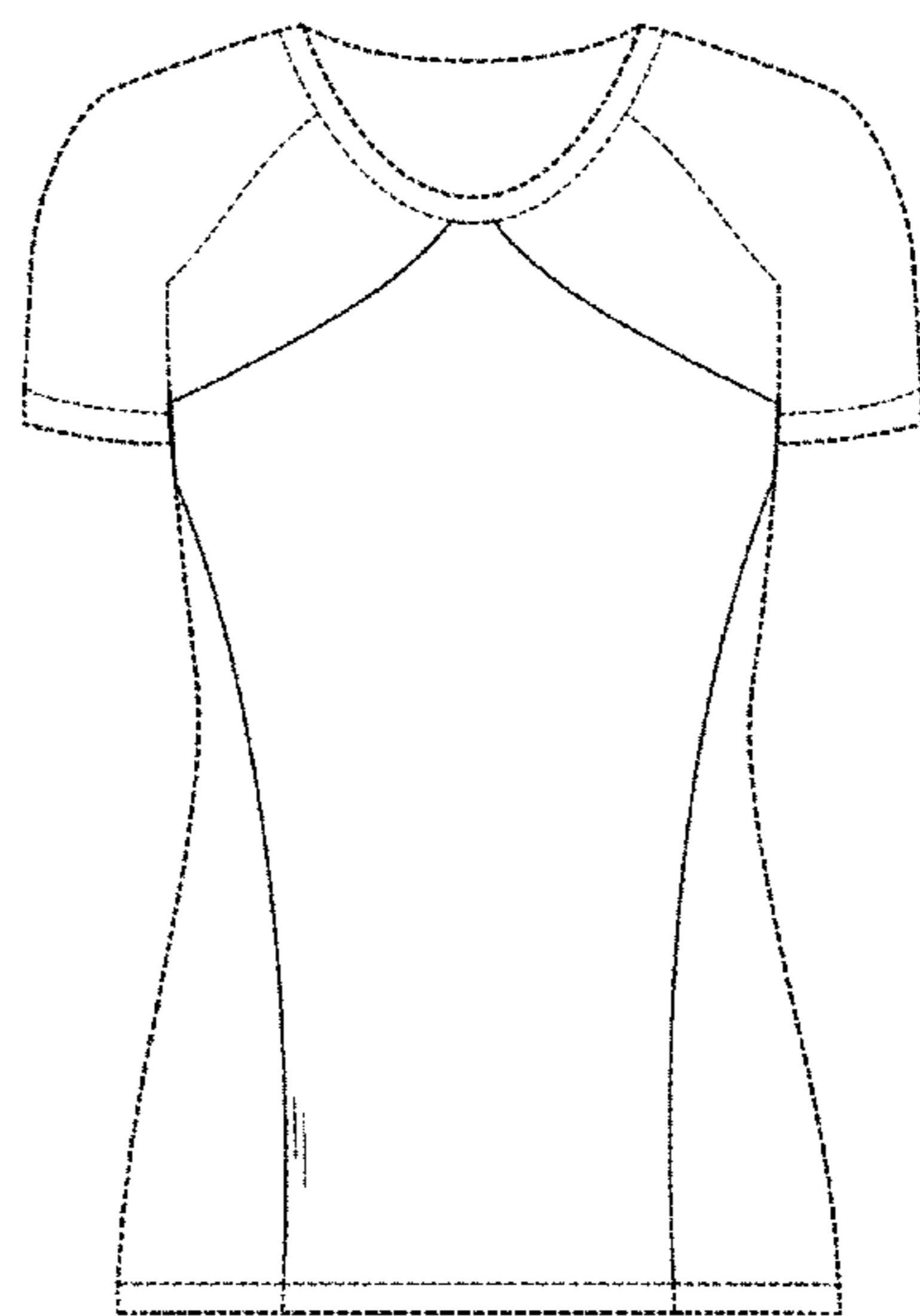
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front view of a shirt according to the design; FIG. 2 is a rear view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a front perspective view thereof; FIG. 6 is a rear perspective view thereof; and, FIG. 7 is a front view thereof shown in a environment of use. The portions of the shirt shown in broken lines in FIGS. 1-7 do not form part of the claimed design. The broken lines showing of the head, neck, arms, hands, and legs in FIG. 7 is for the purpose of illustrating environment and forms no part of the claimed design.

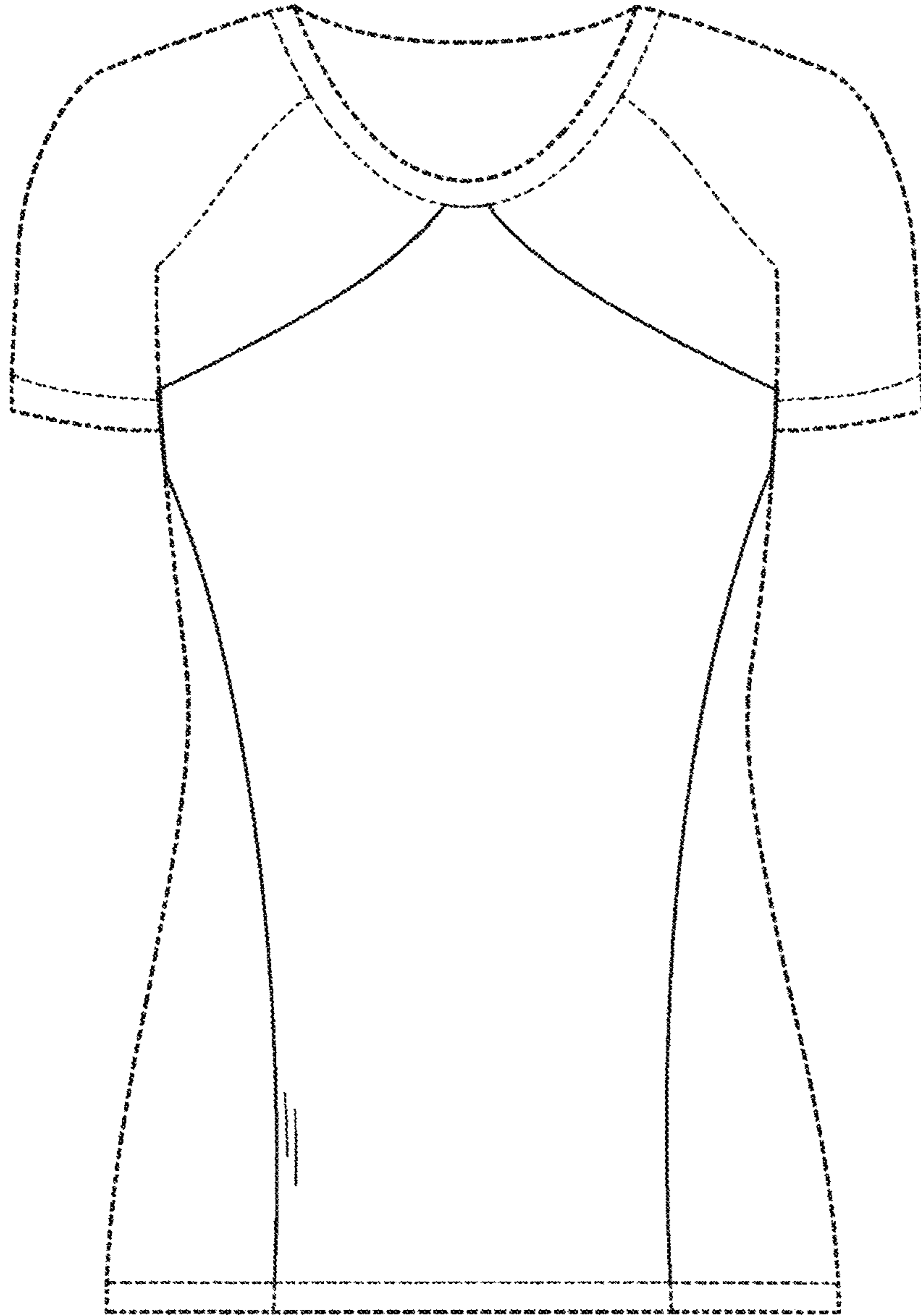

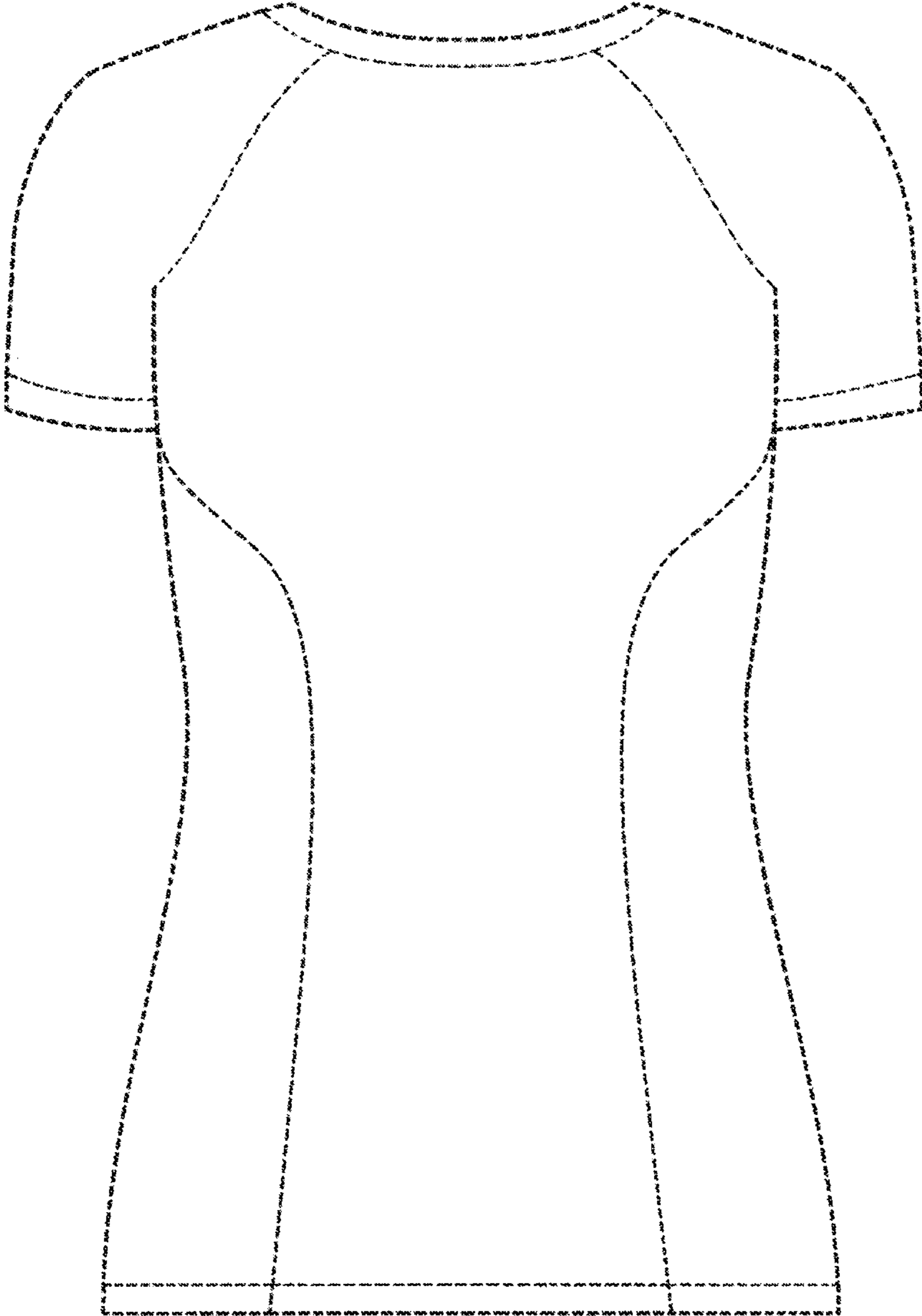

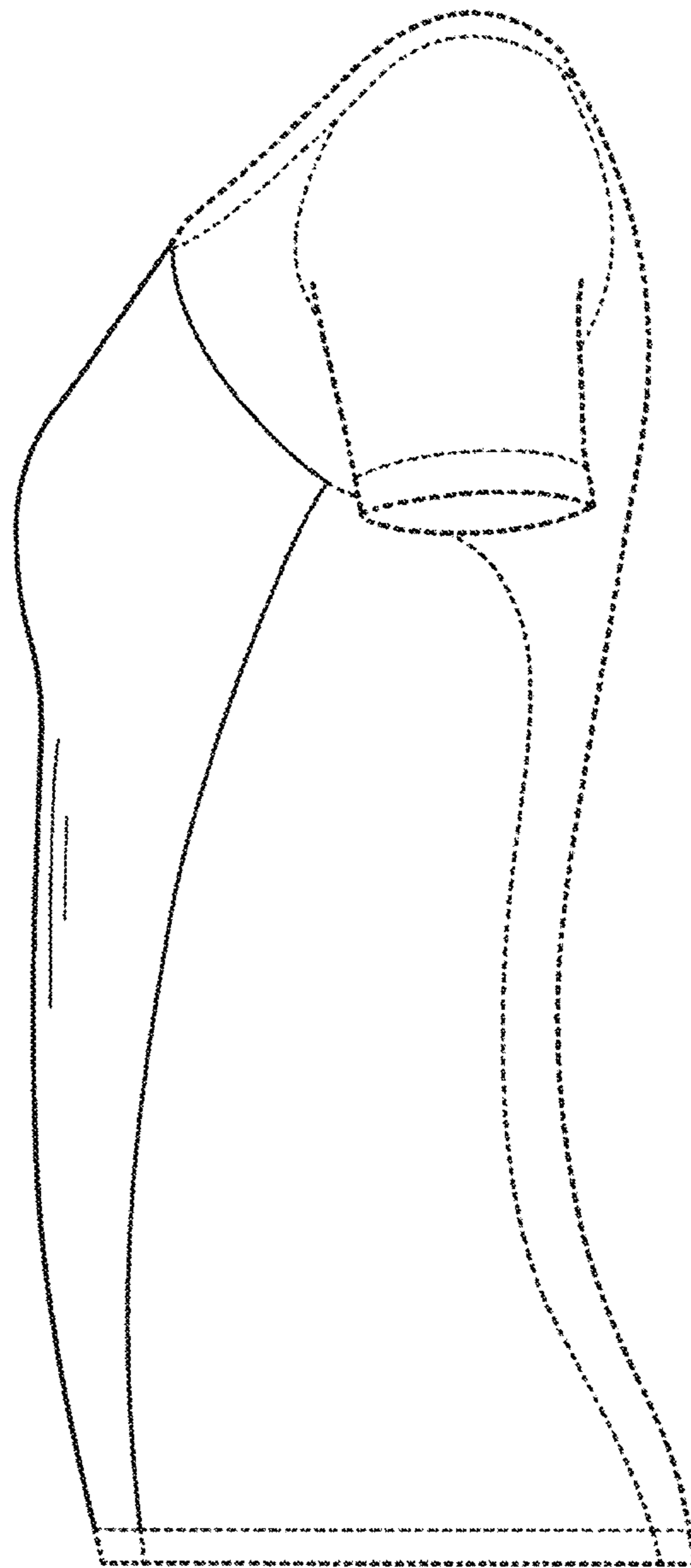

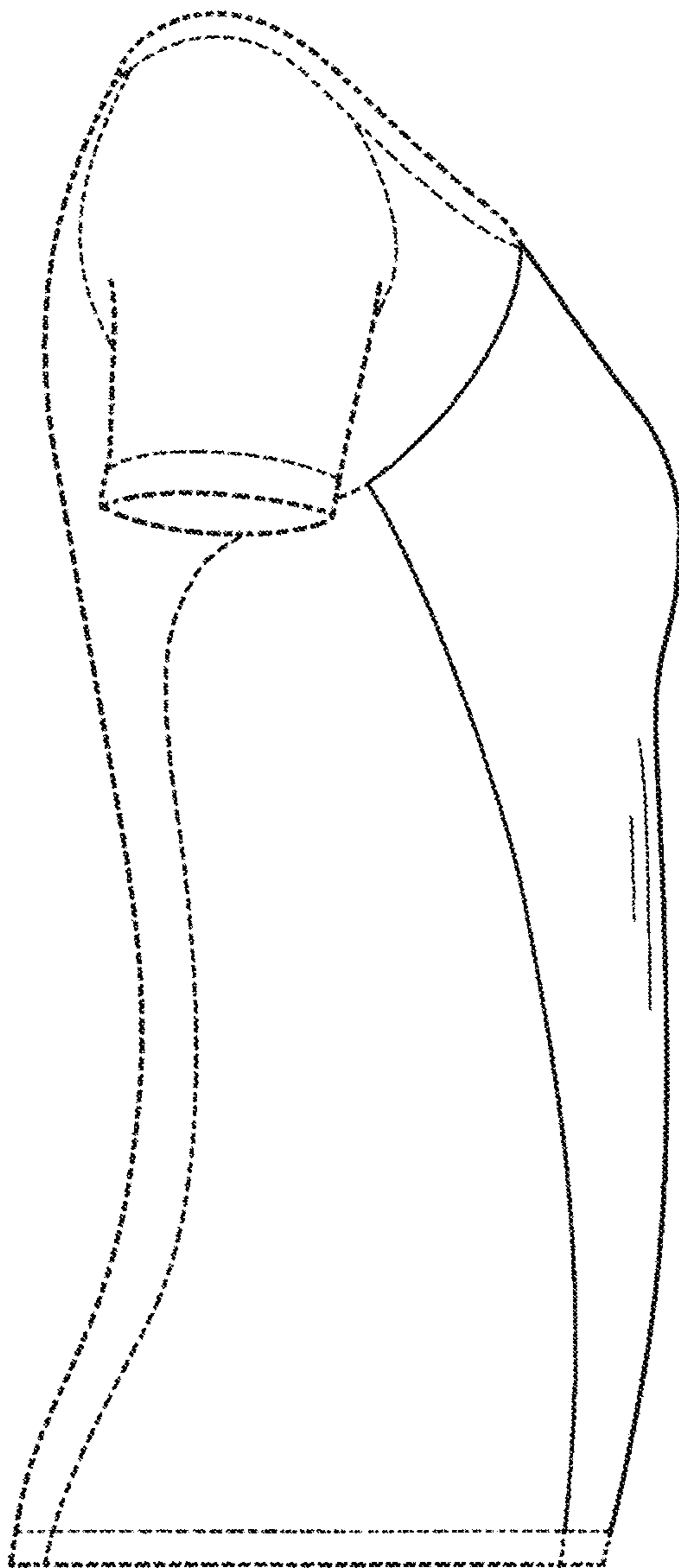

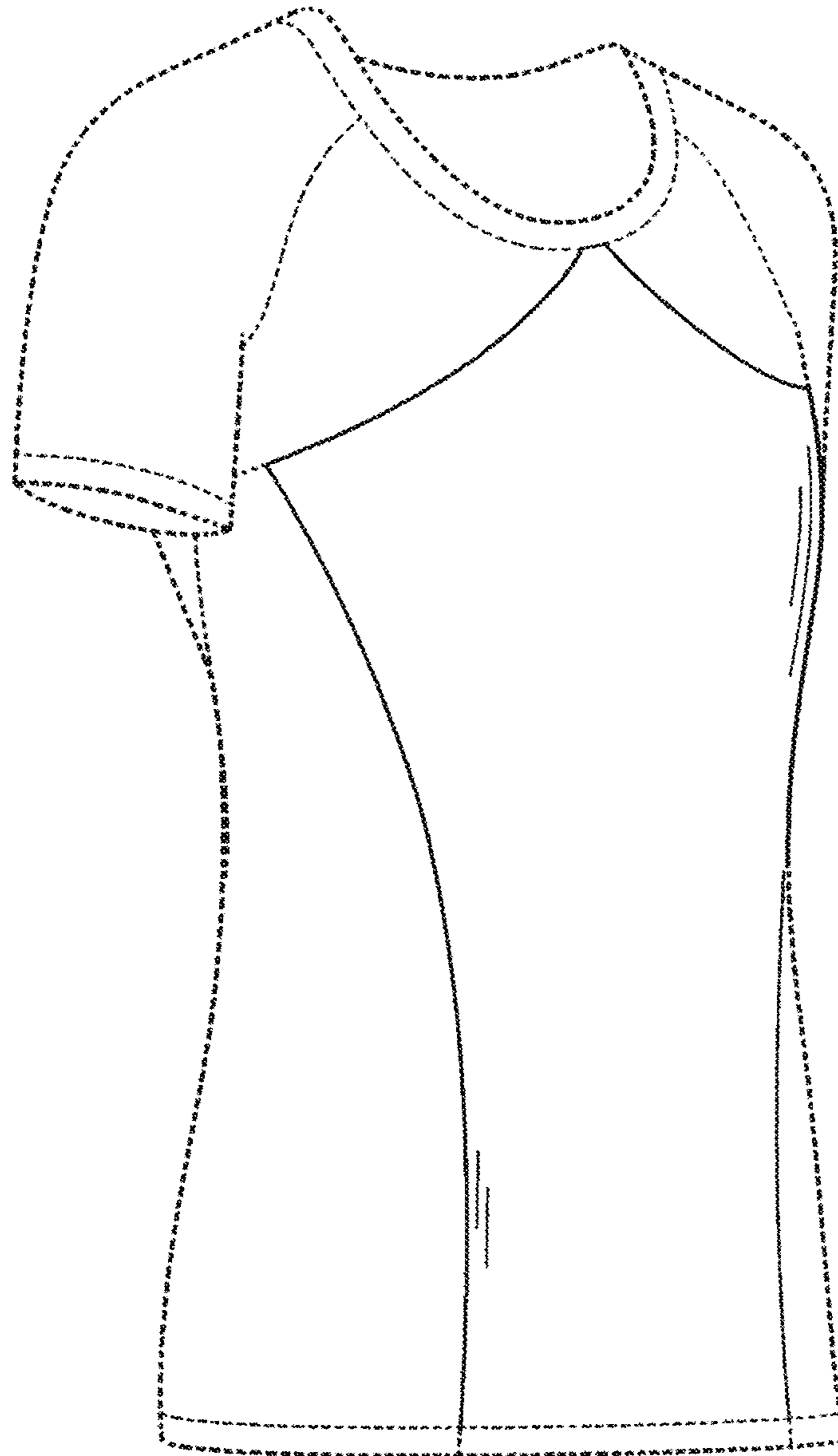

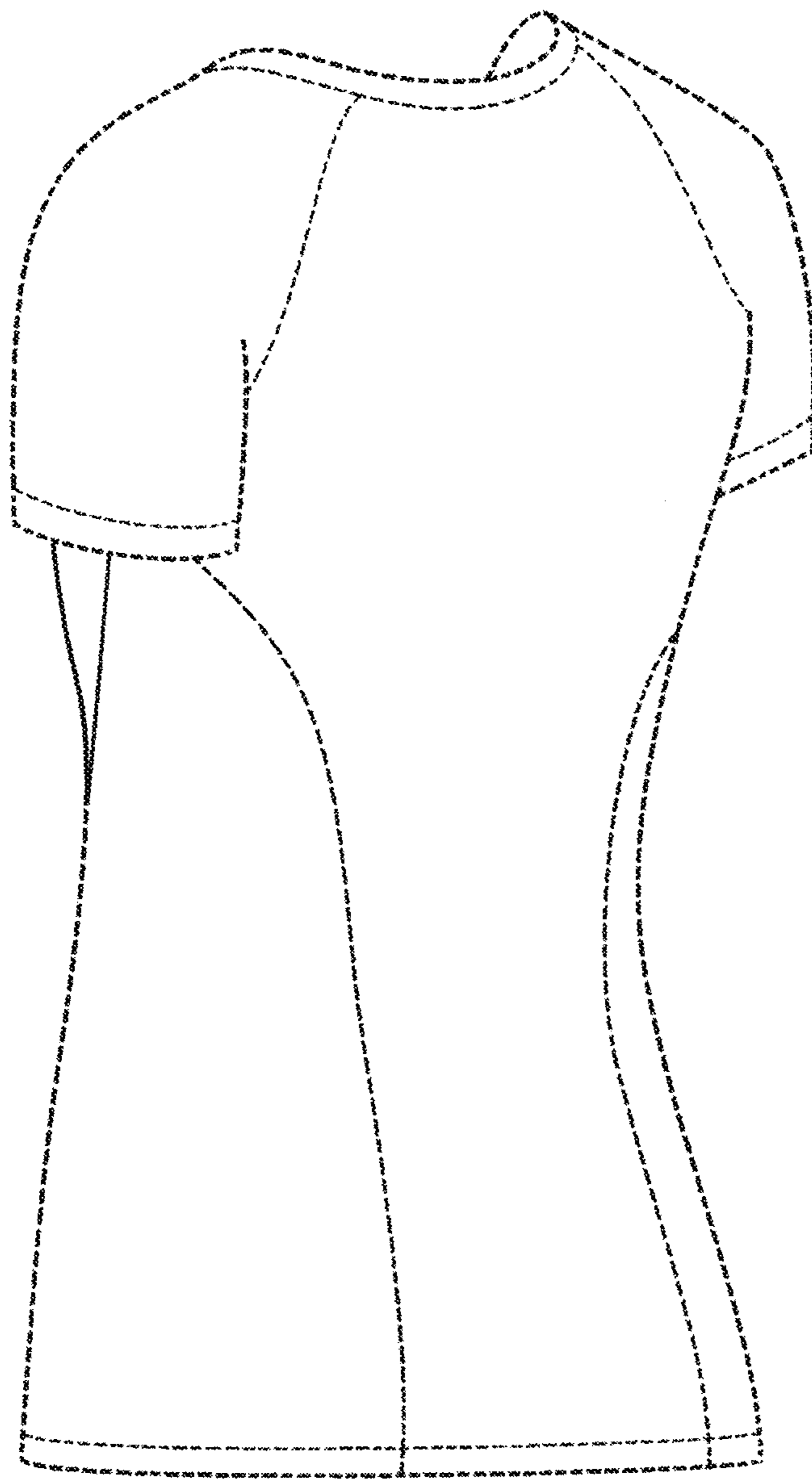

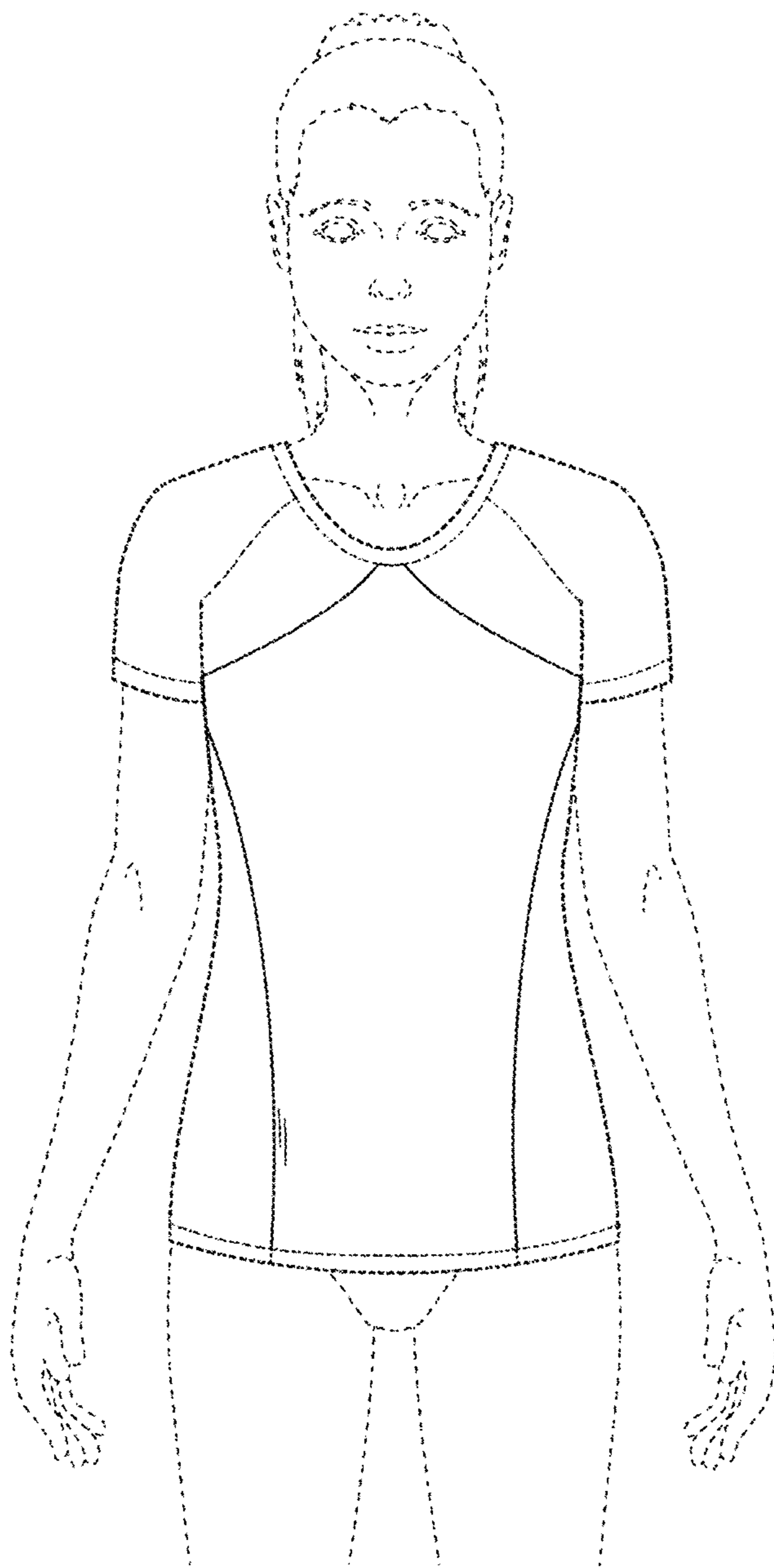
