An ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a shoe showing my new design;  
 FIG. 2 is a side elevational view of the inside (arch-side) thereof;  
 FIG. 3 is a side elevational view of the outside thereof;  
 FIG. 4 is a top plan view thereof;  
 FIG. 5 is a bottom plan view thereof;  
 FIG. 6 is an elevational front (toe) view thereof; and,  
 FIG. 7 is an elevational rear (heel) view thereof.

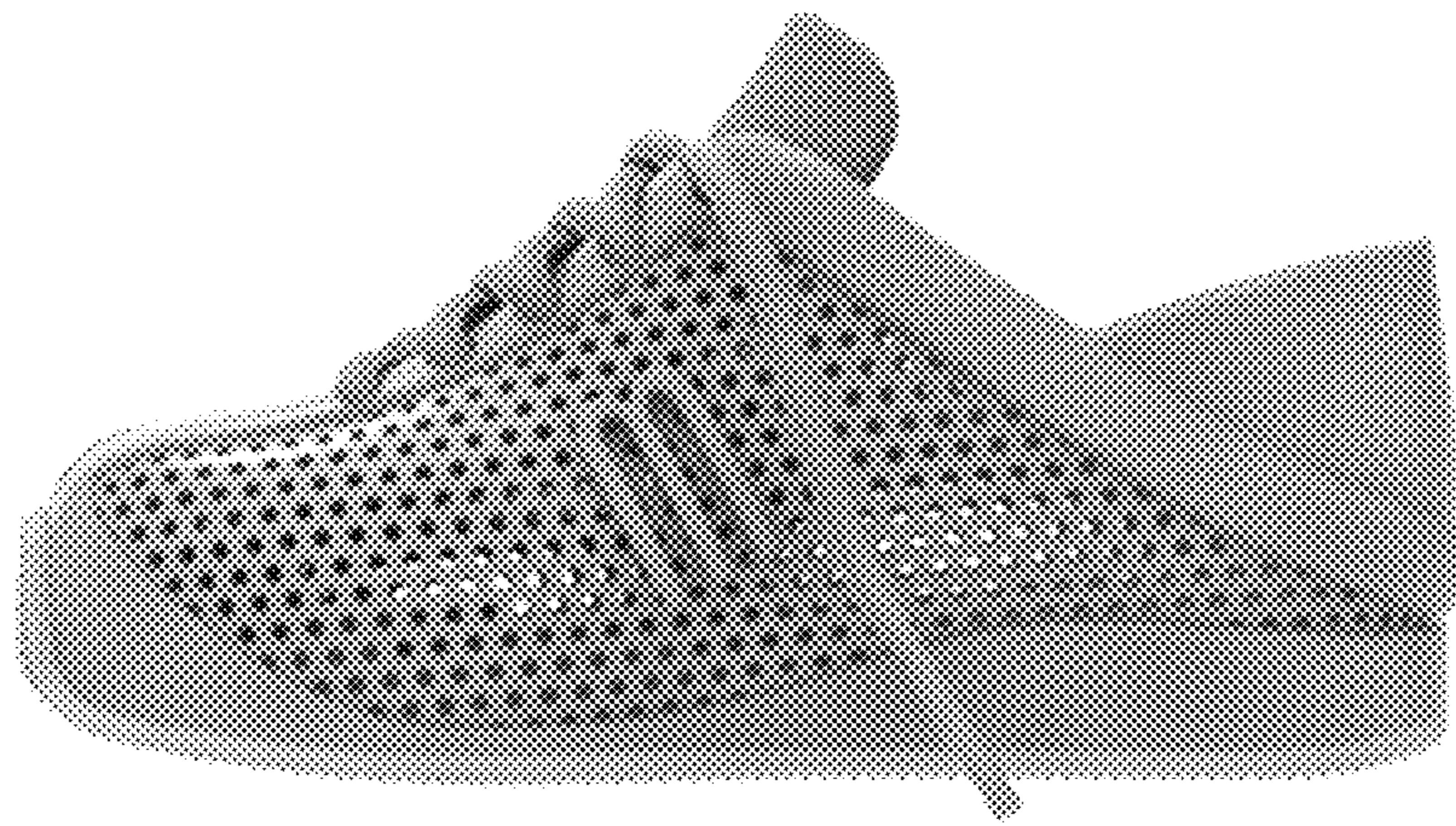

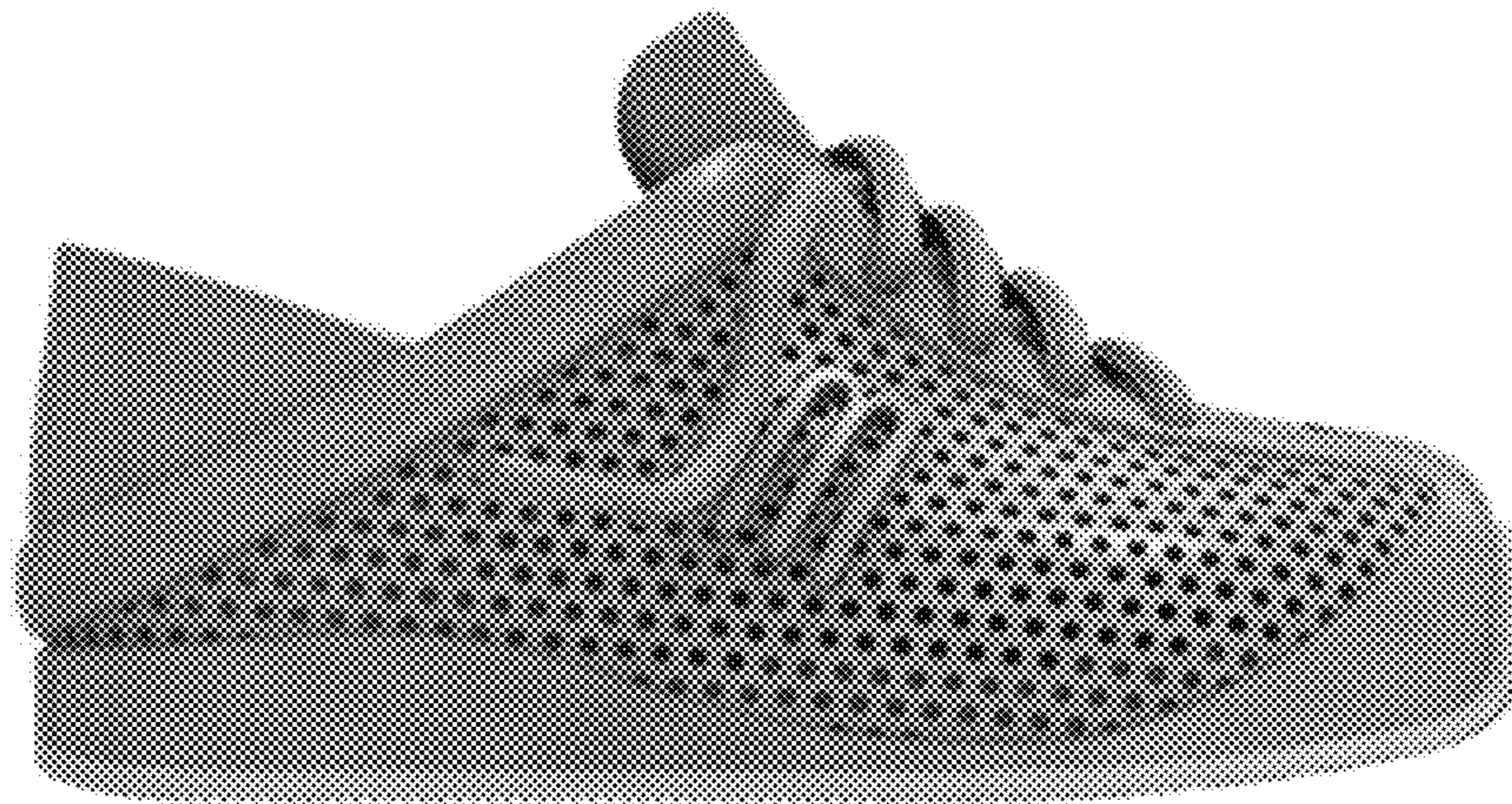

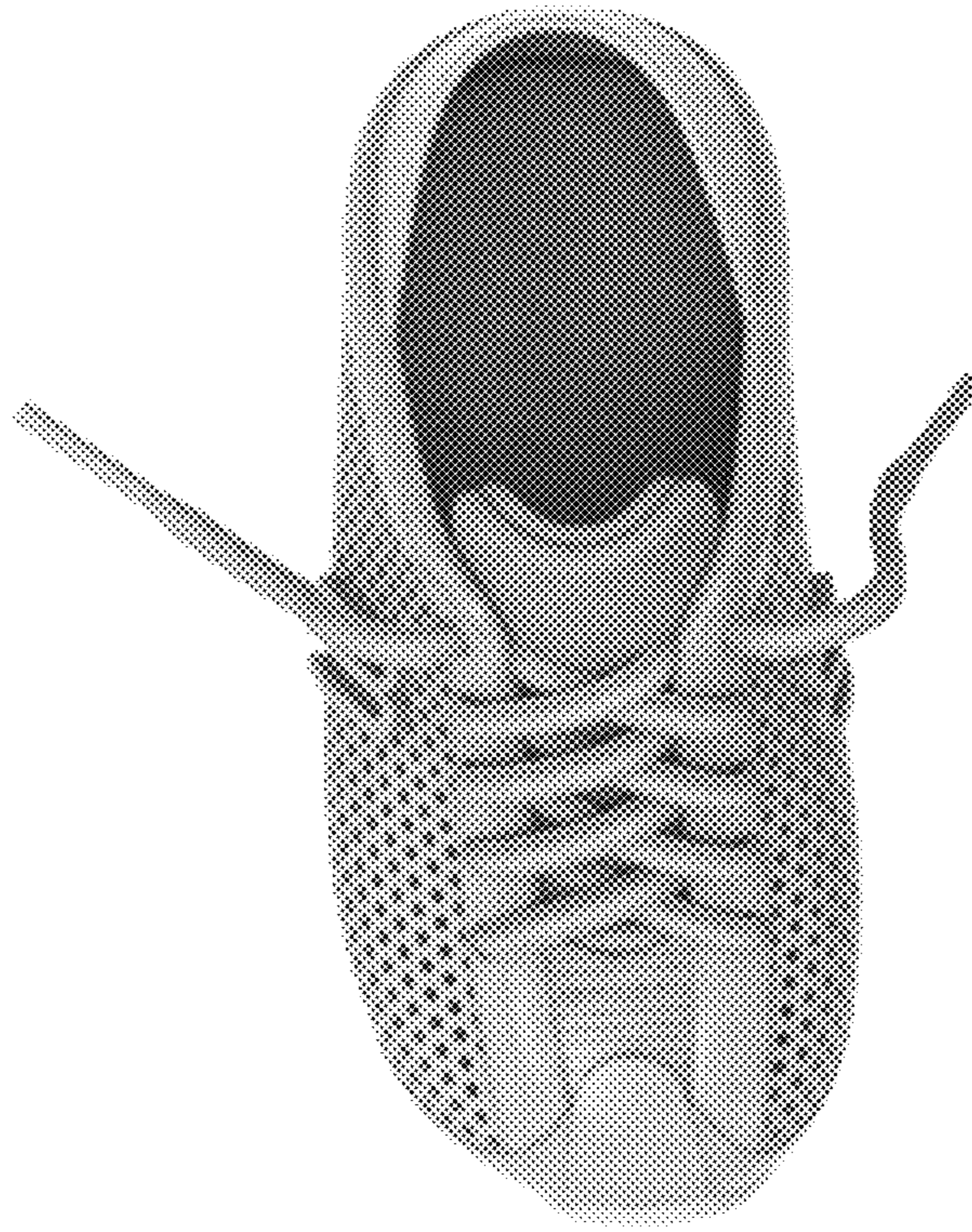

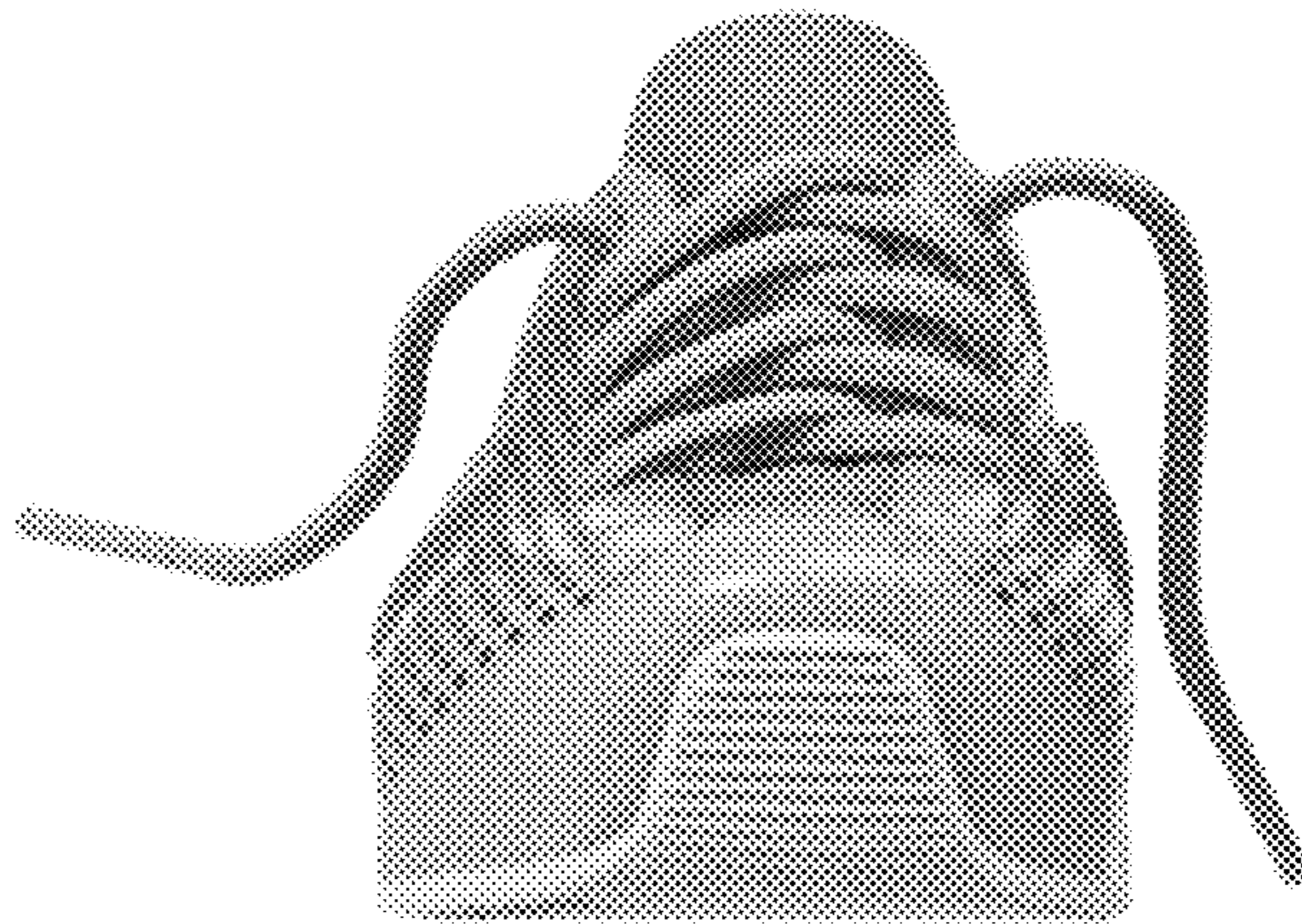

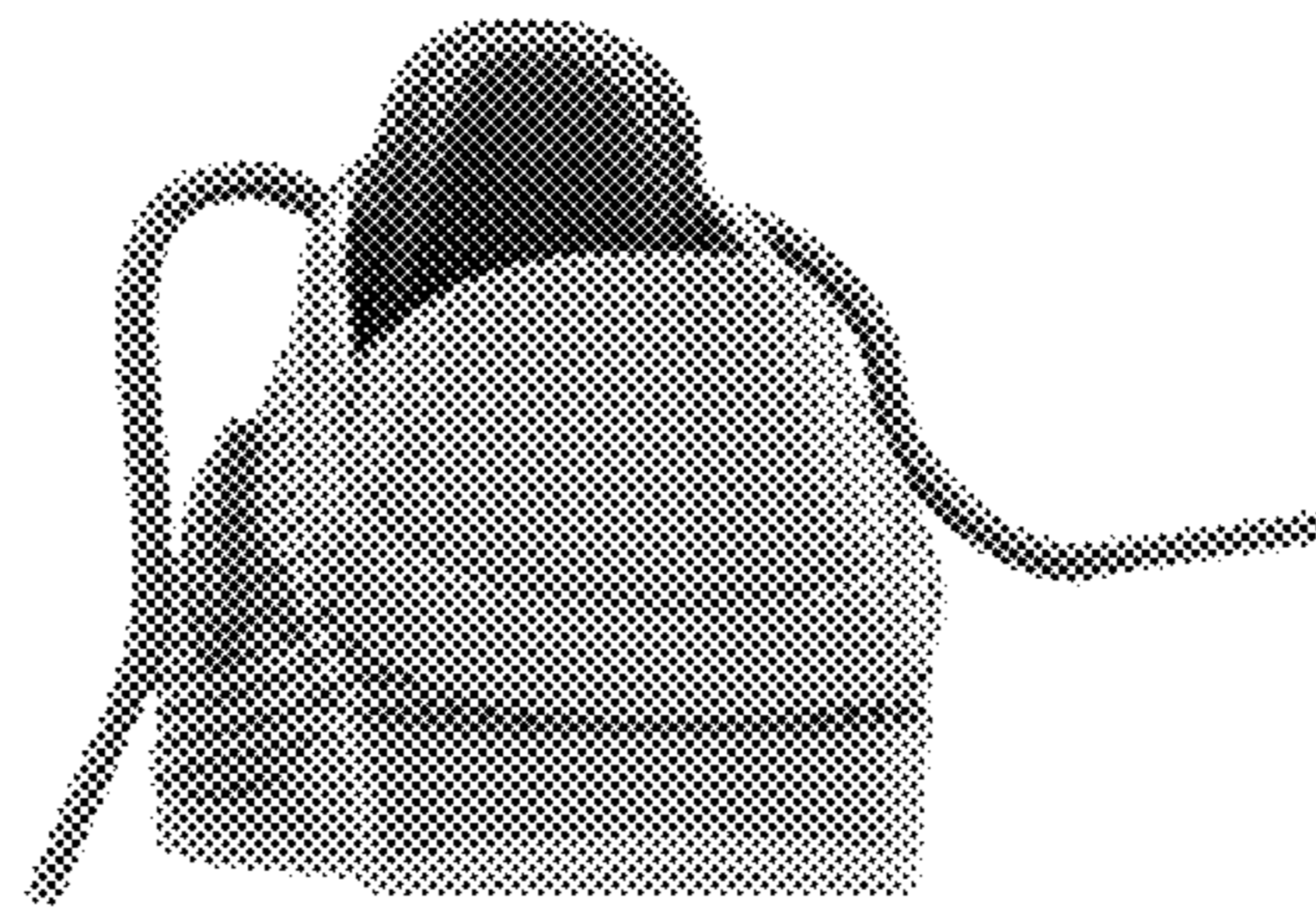
