(57) **CLAIM**

I claim the ornamental design for a sandal, as shown and described.

DESCRIPTION

FIG. 1 is a top view of my sandal;
FIG. 2 is a left side view thereof;
FIG. 3 is a right side view thereof;
FIG. 4 is a front left perspective view thereof;
FIG. 5 is a front right perspective view thereof;
FIG. 6 is a rear right perspective view thereof;
FIG. 7 is a rear left perspective view thereof;
FIG. 8 is a rear view thereof;
FIG. 9 is a close-up front left perspective view thereof;
FIG. 10 is a close-up front right perspective view thereof;
FIG. 11 is a close-up front view thereof; and,
FIG. 12 is a partial enlarged view of the front toe portion thereof.

Photos are of the right shoe from a pair of shoes, and the left shoe (not shown) has corresponding mirror image views, as applicable.

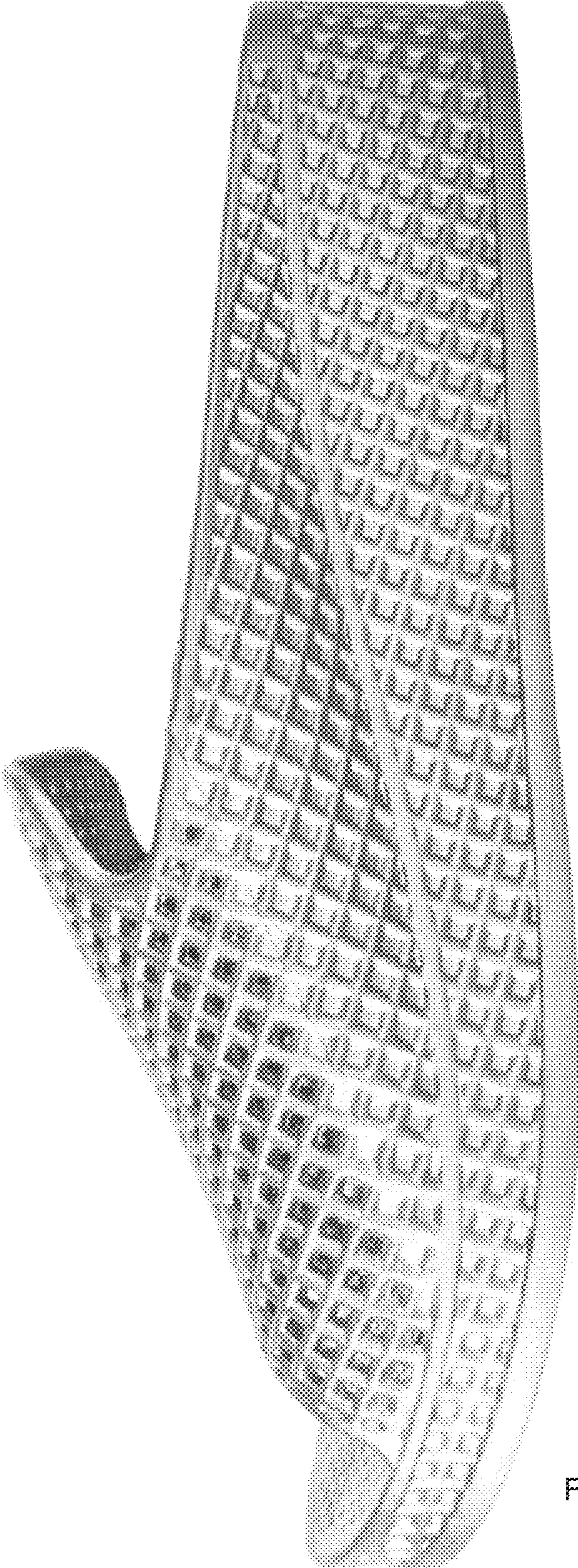

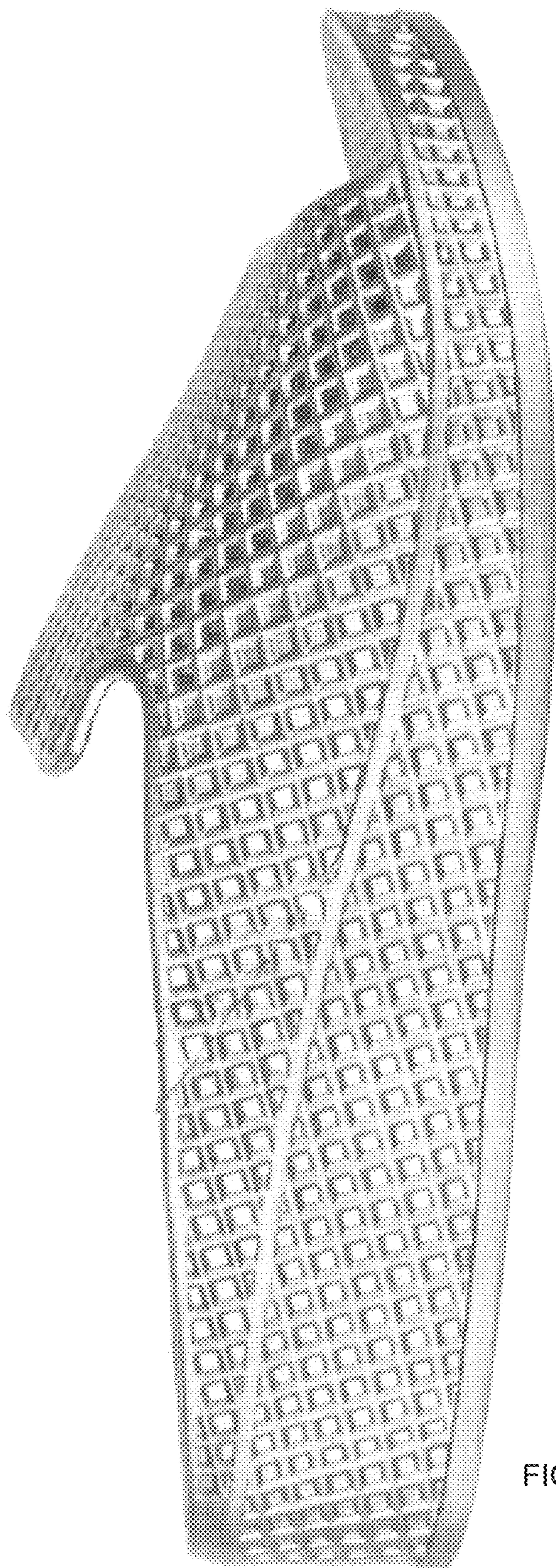

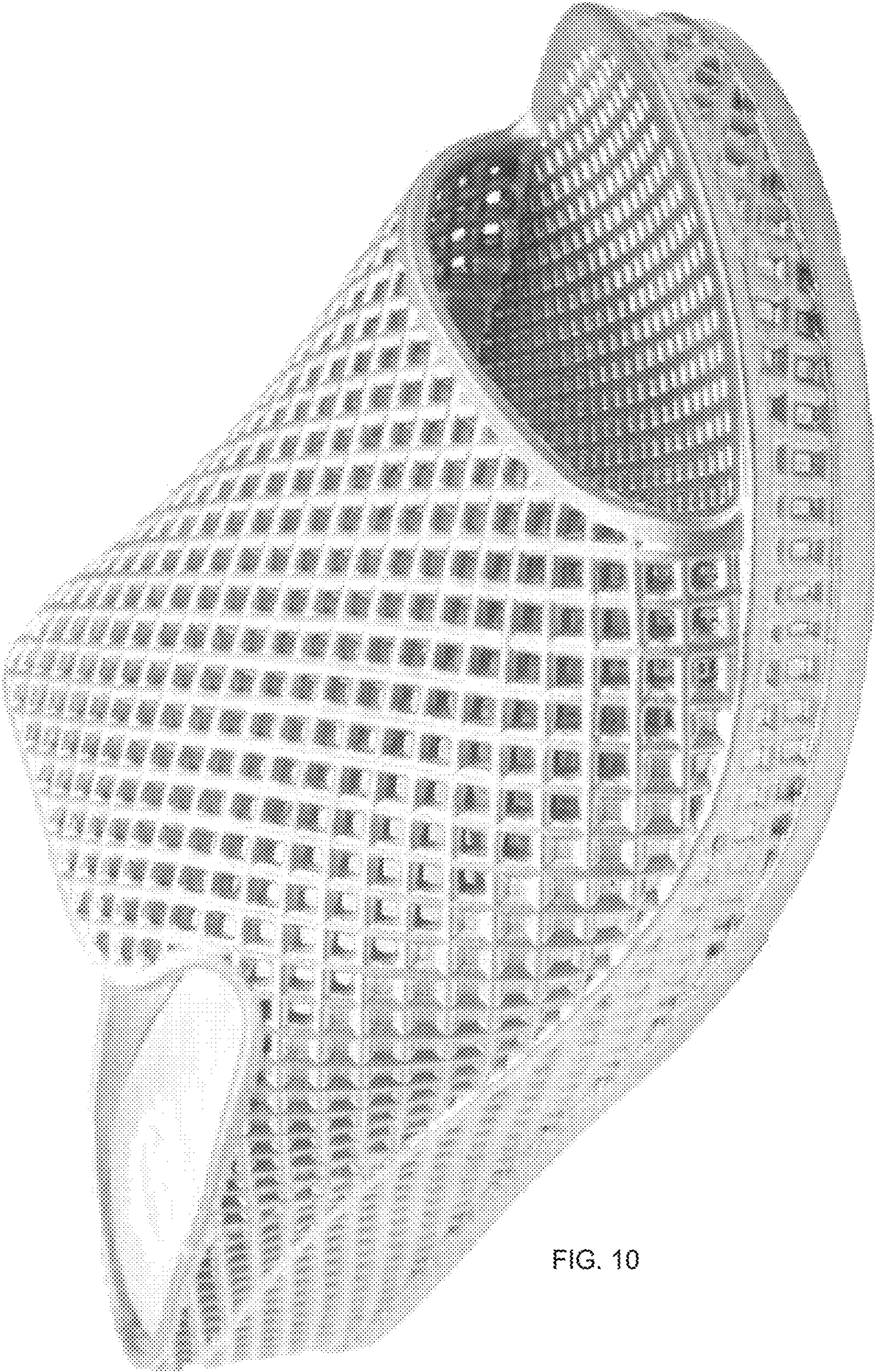

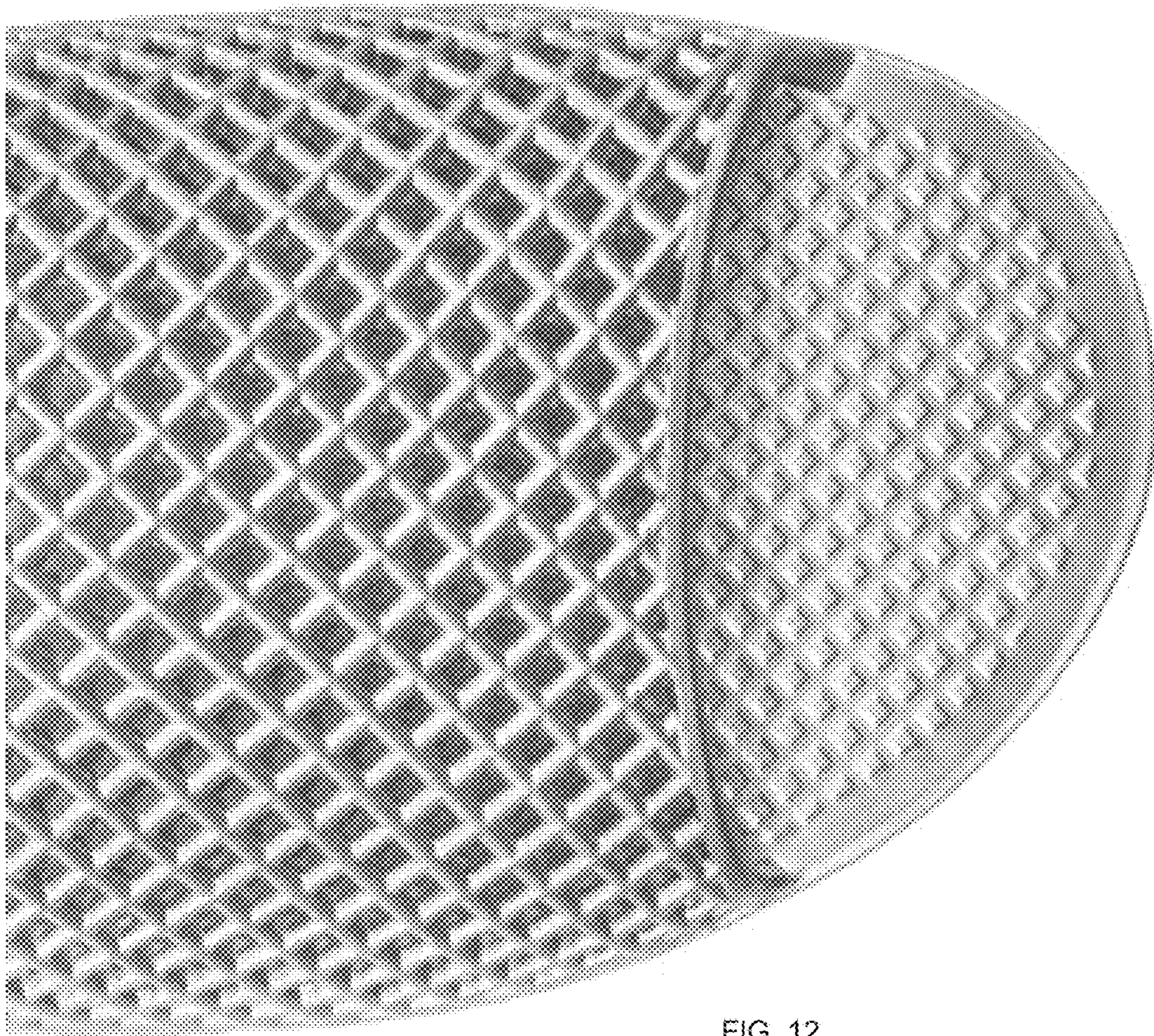
