(57) **CLAIM**

The ornamental design for clog with two decorative foxing stripes, toe bumper with decorative surface texture, and heel license plate, as shown and described.

DESCRIPTION

FIG. 1 is a right perspective view of a clog with two decorative foxing stripes, toe bumper with decorative surface texture, and heel license plate, showing our new design.

FIG. 10 is a right side elevation view thereof.

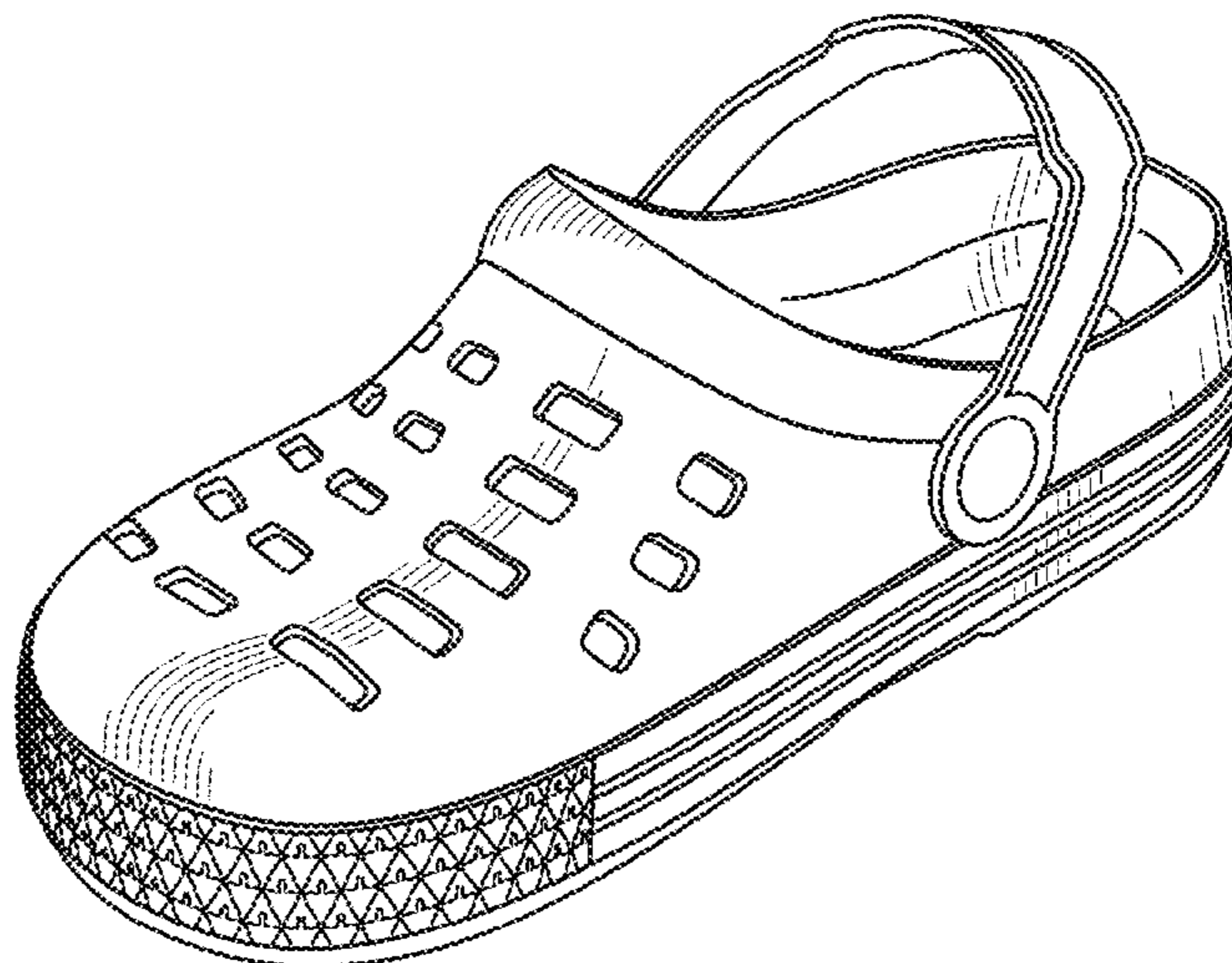
FIG. 11 is bottom plan view thereof.

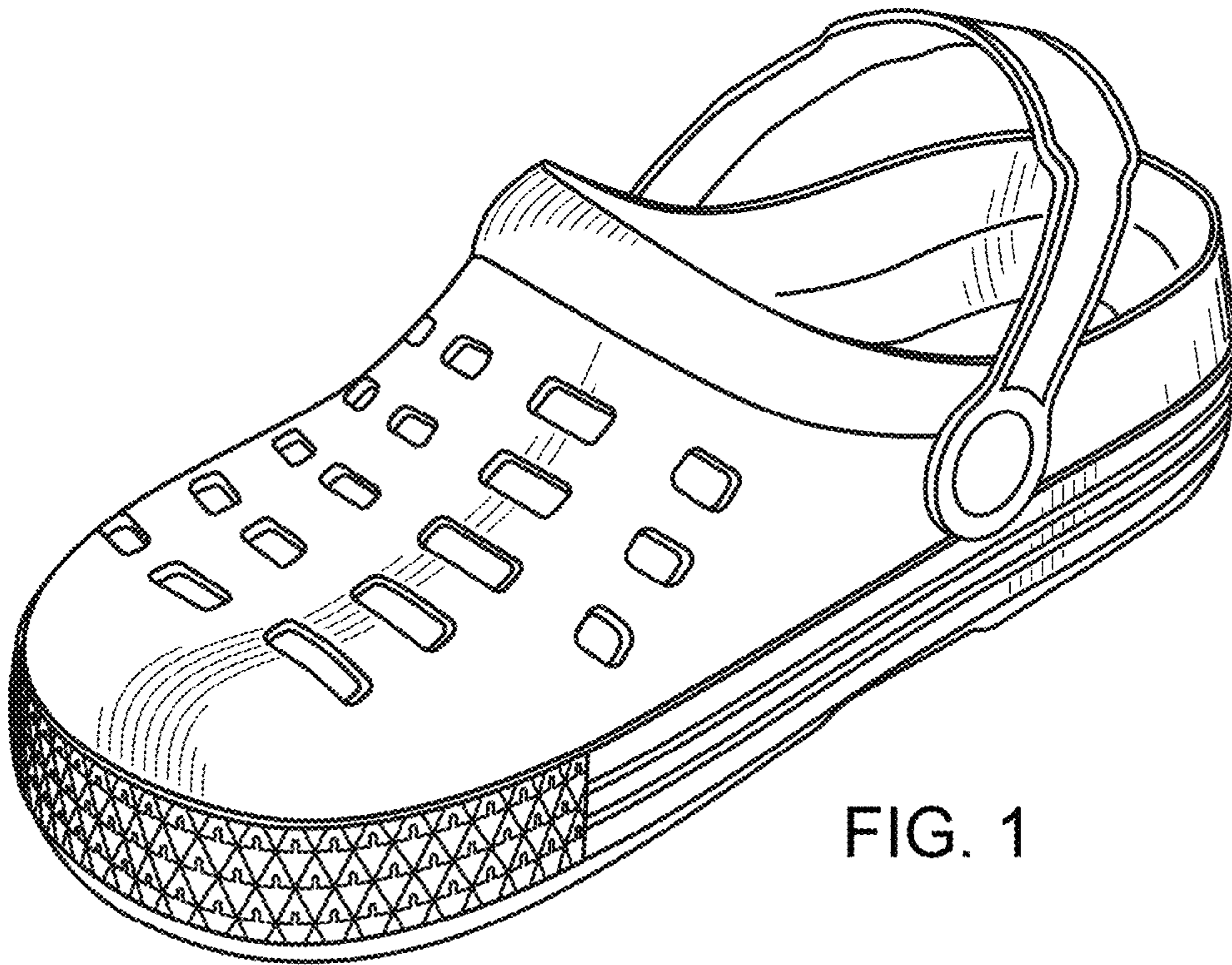

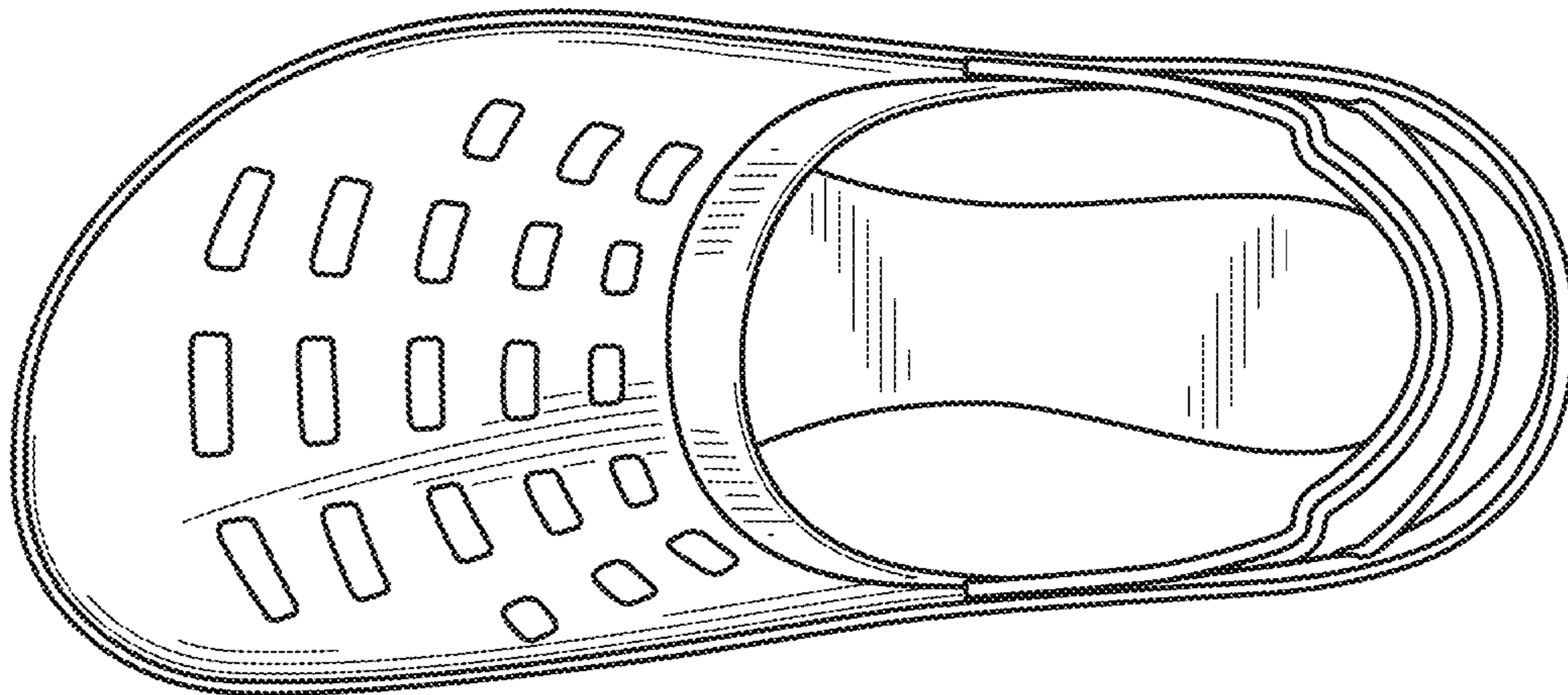

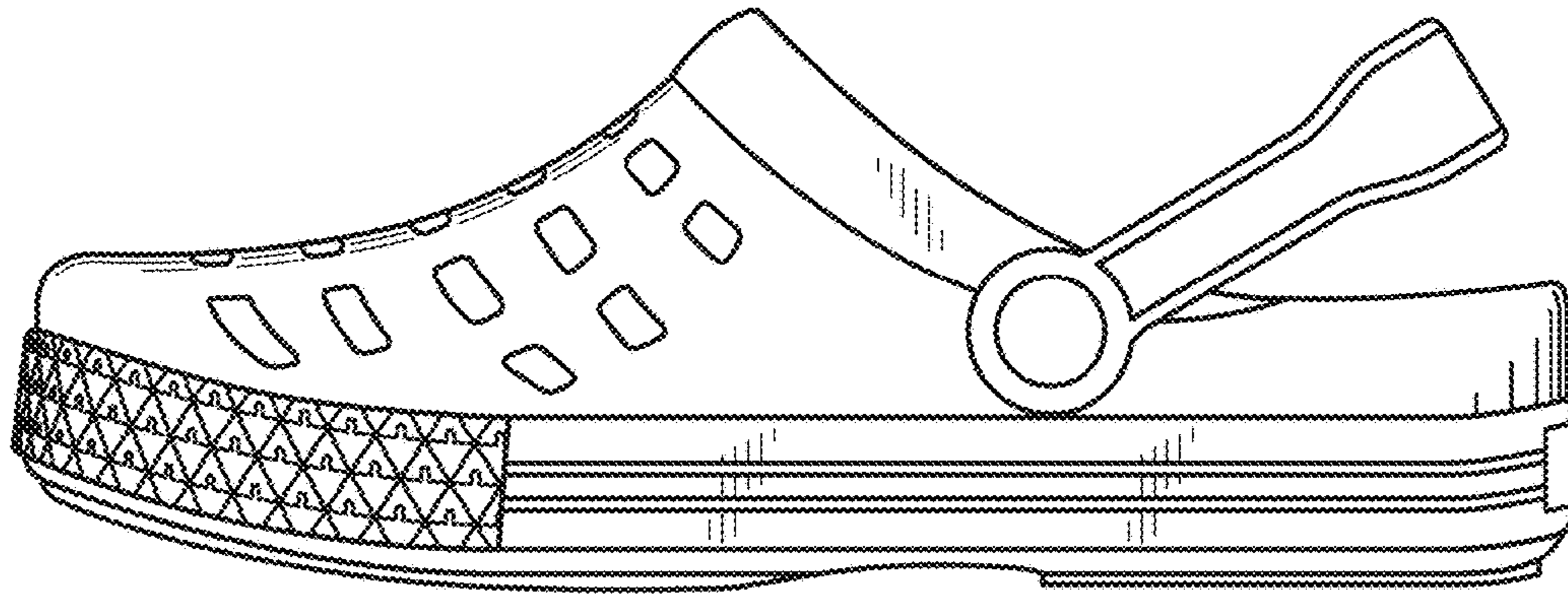

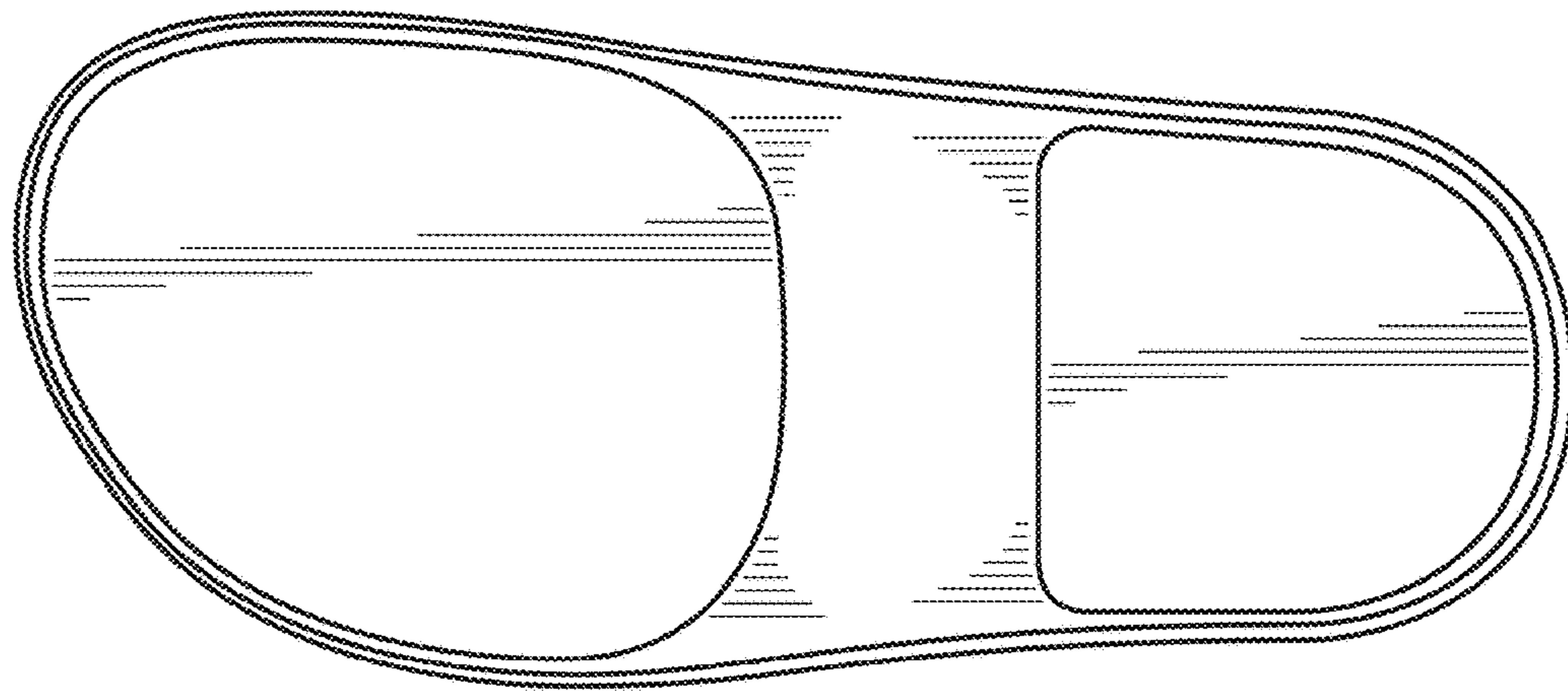

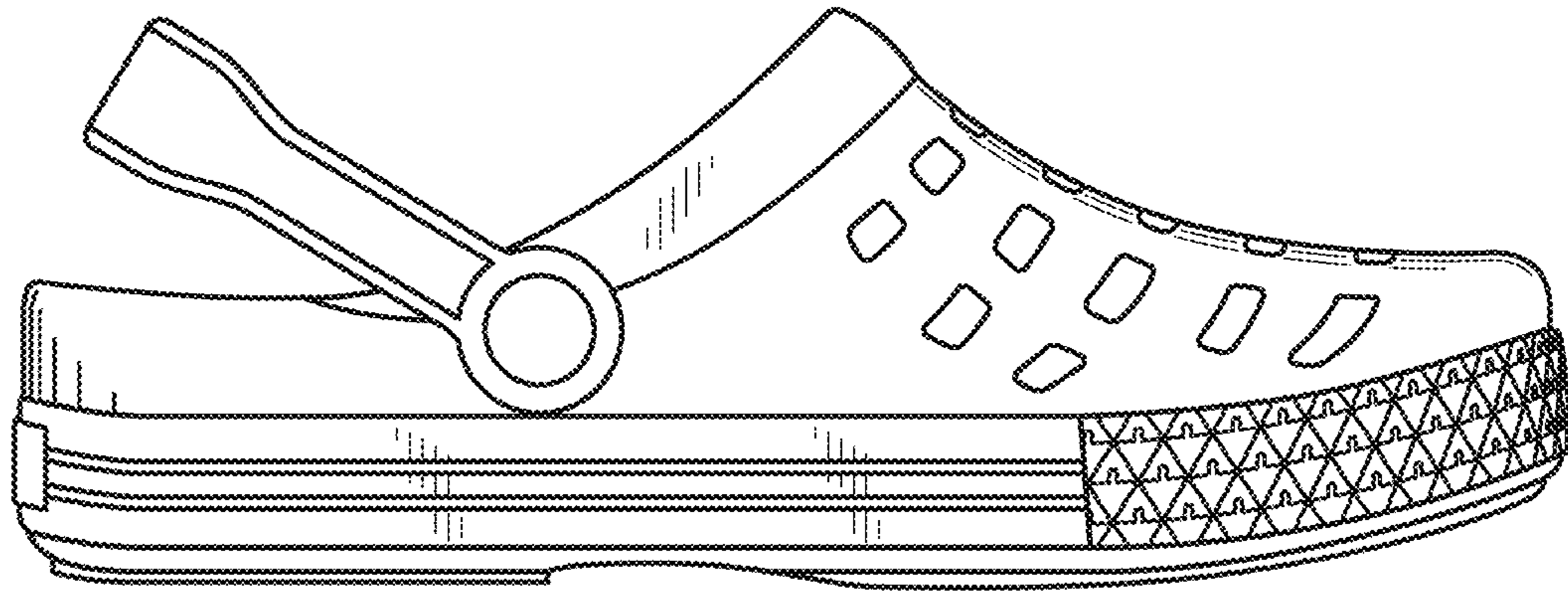

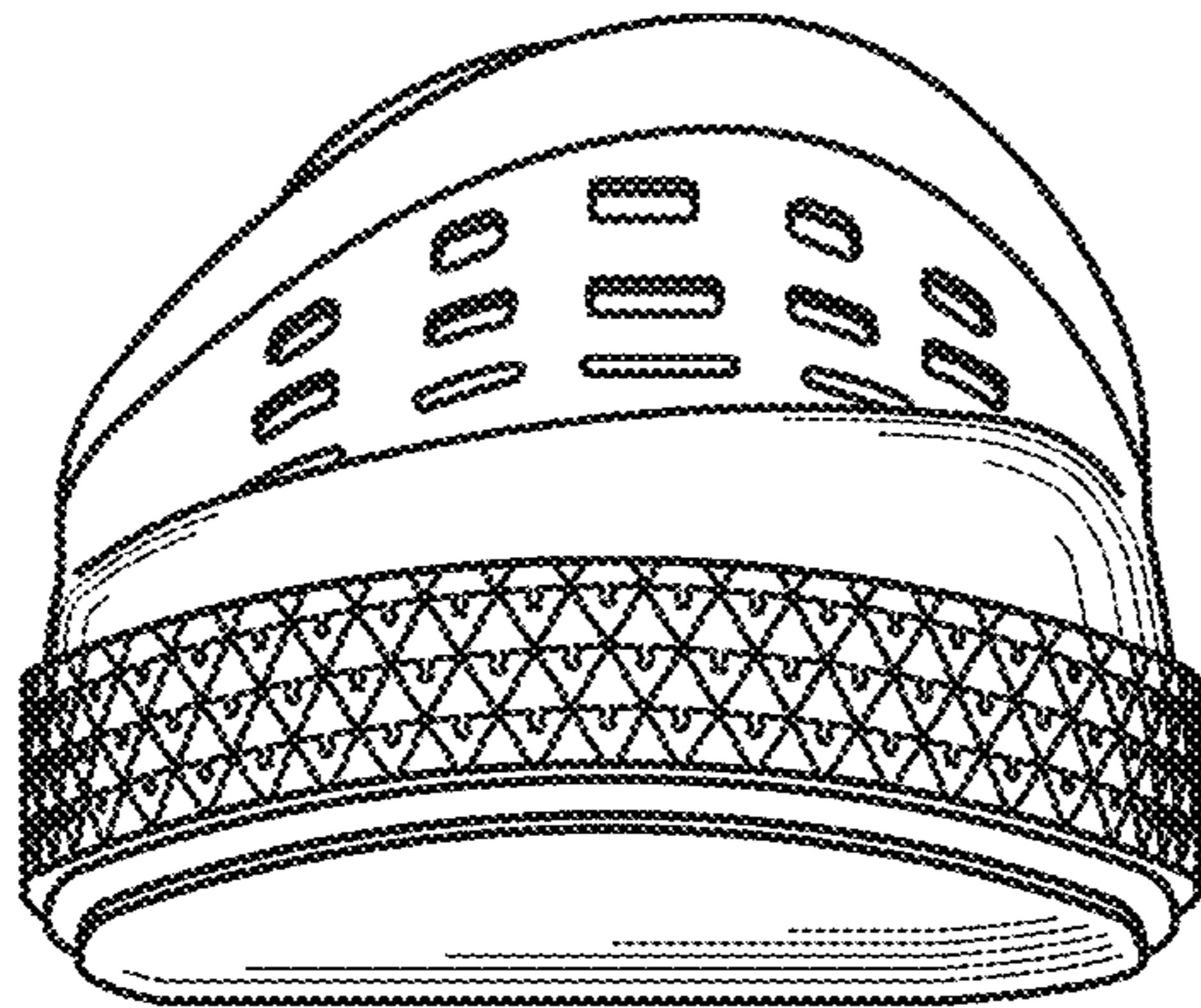

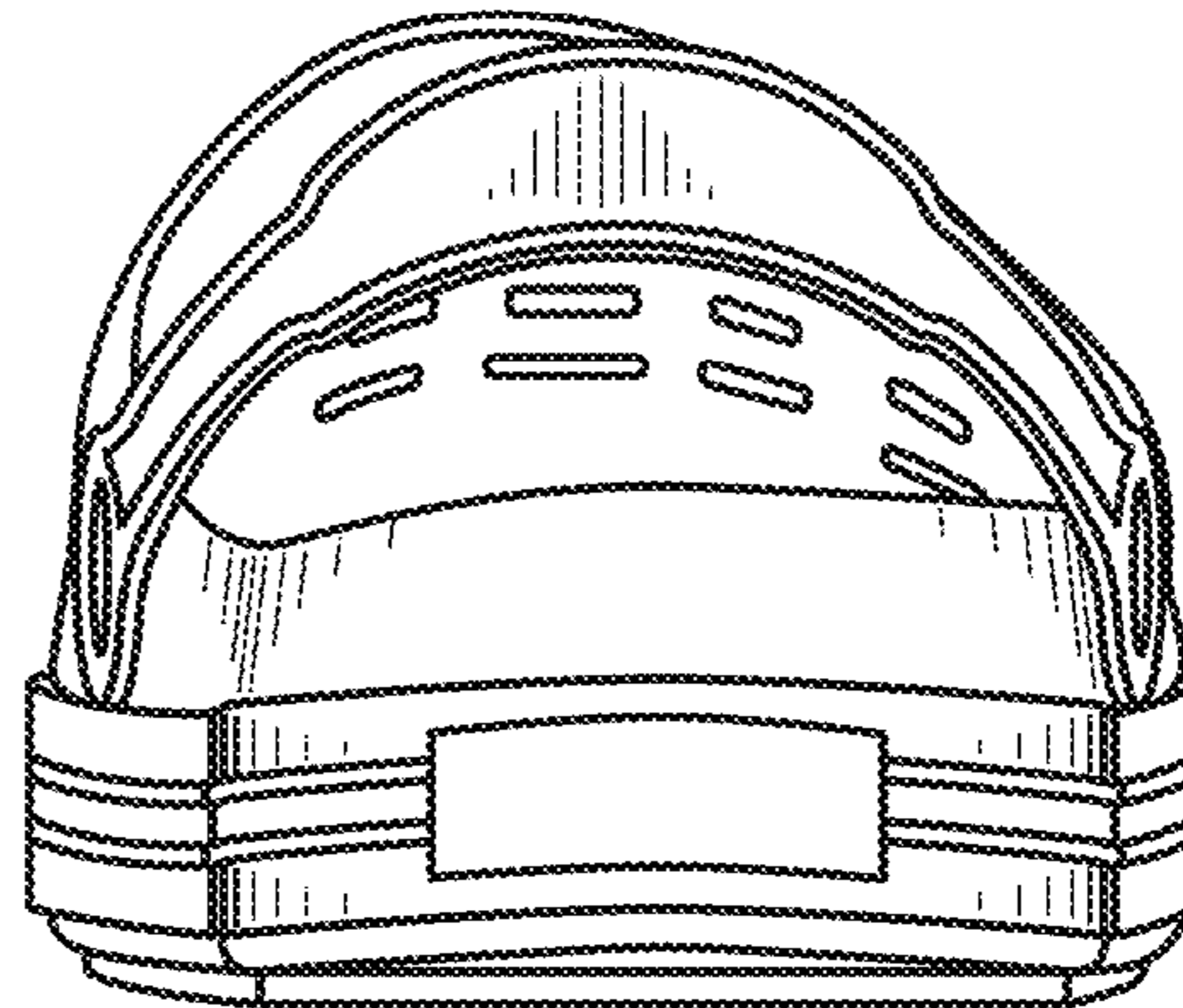

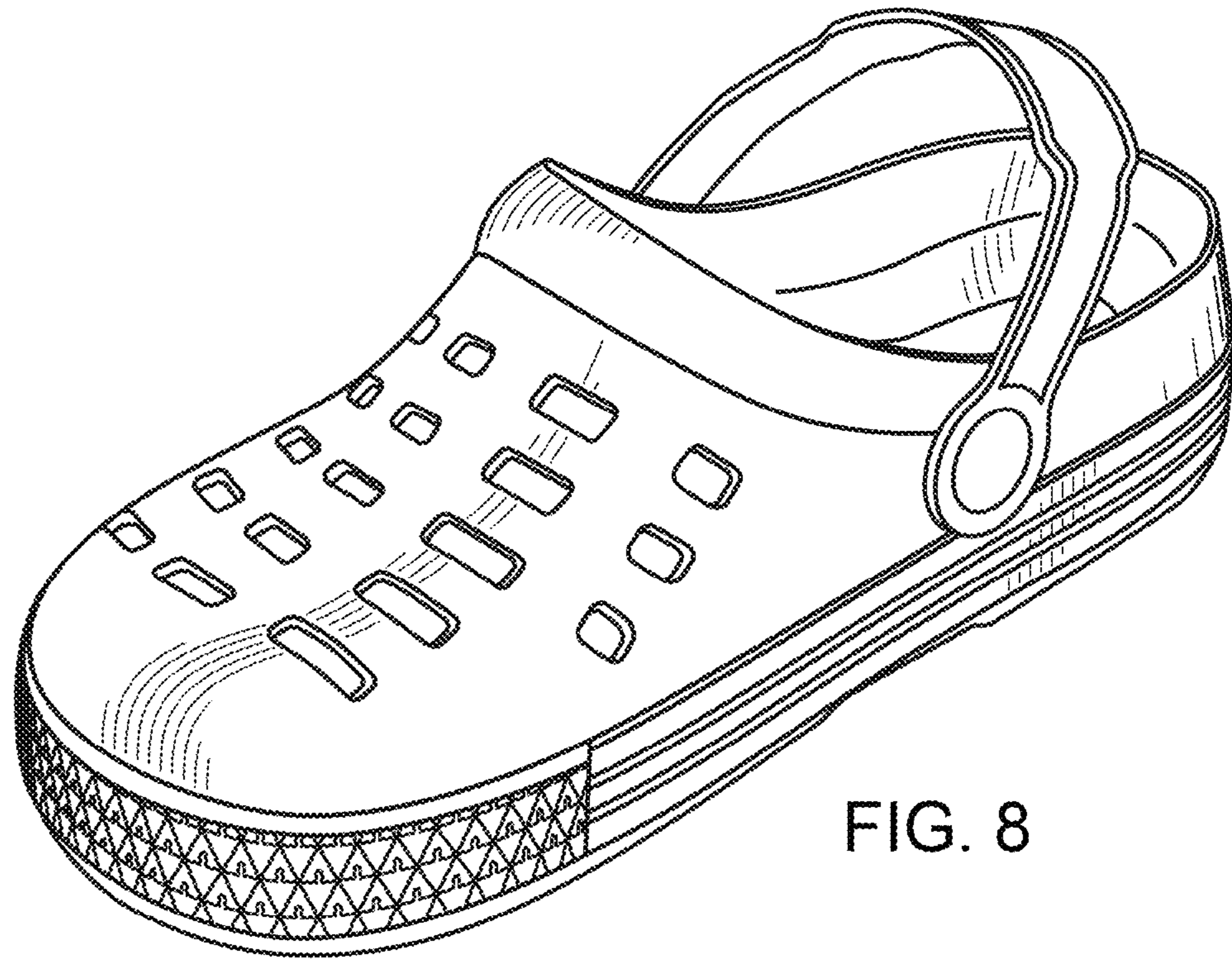

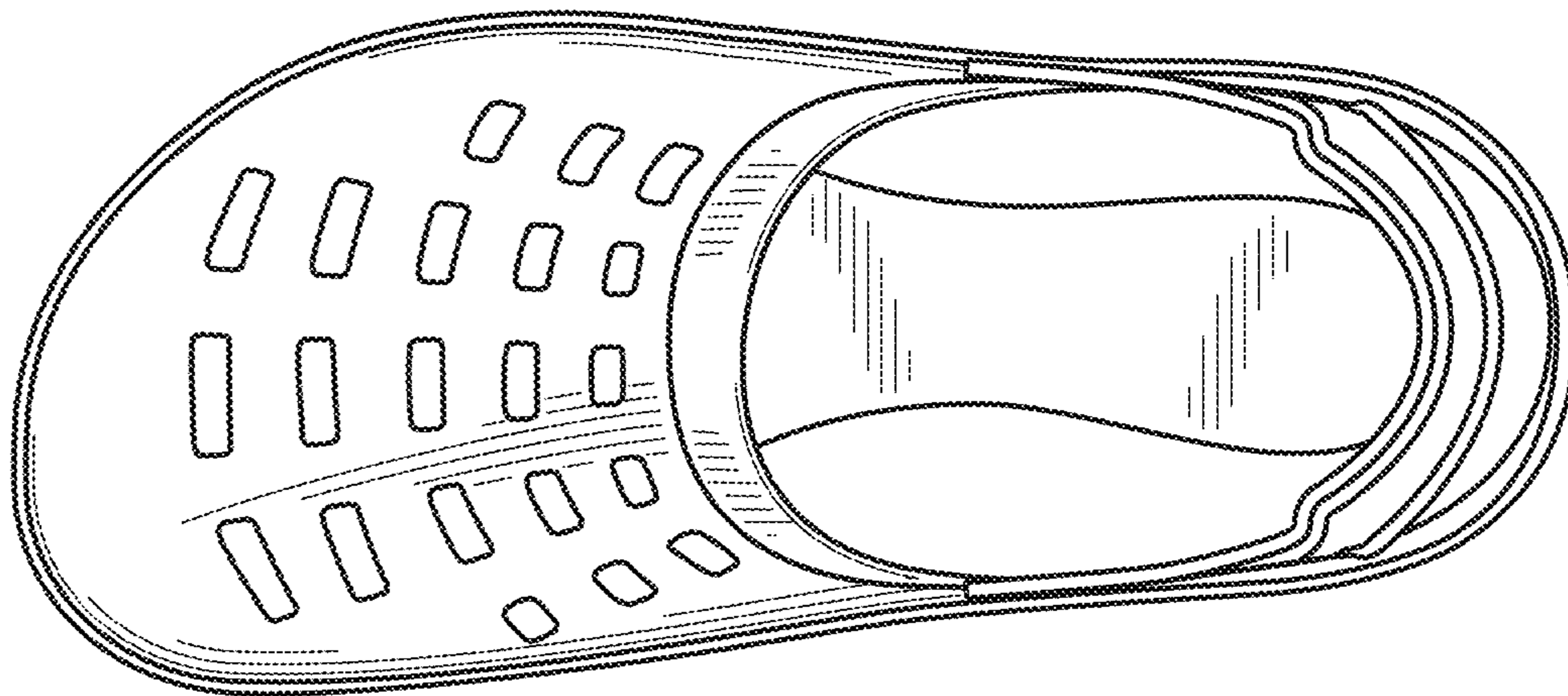

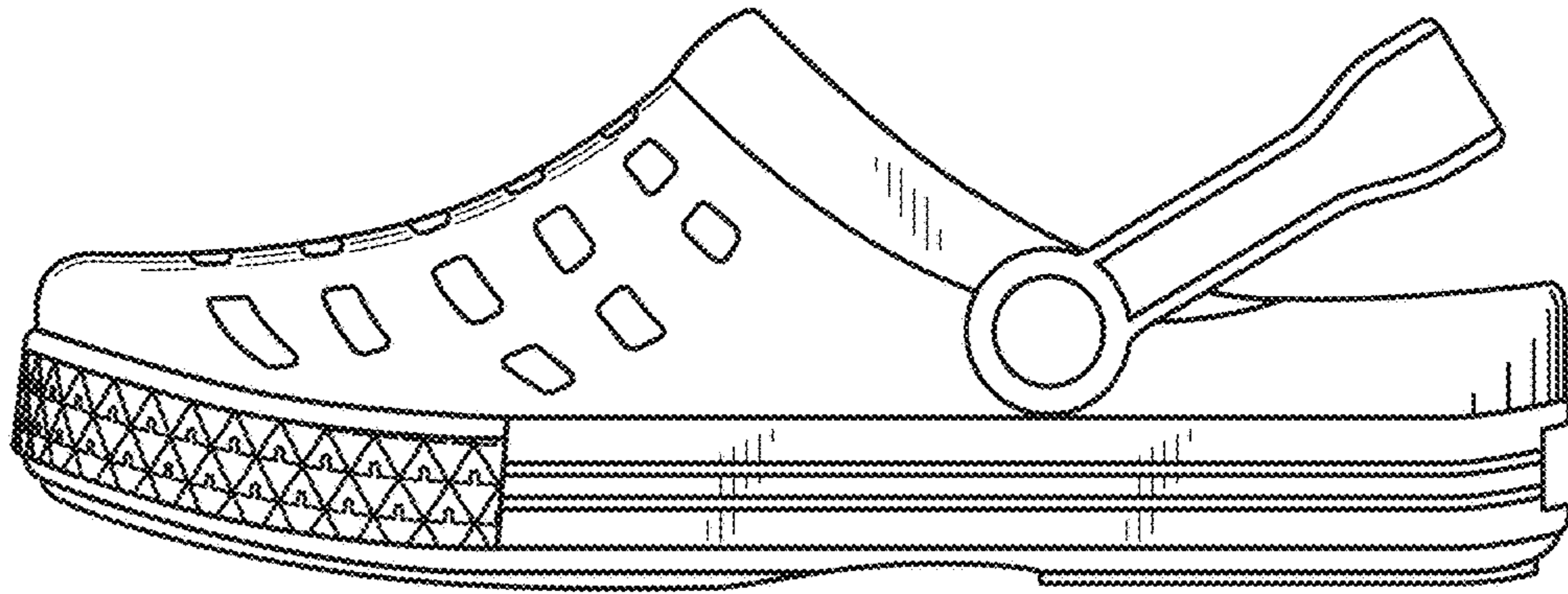

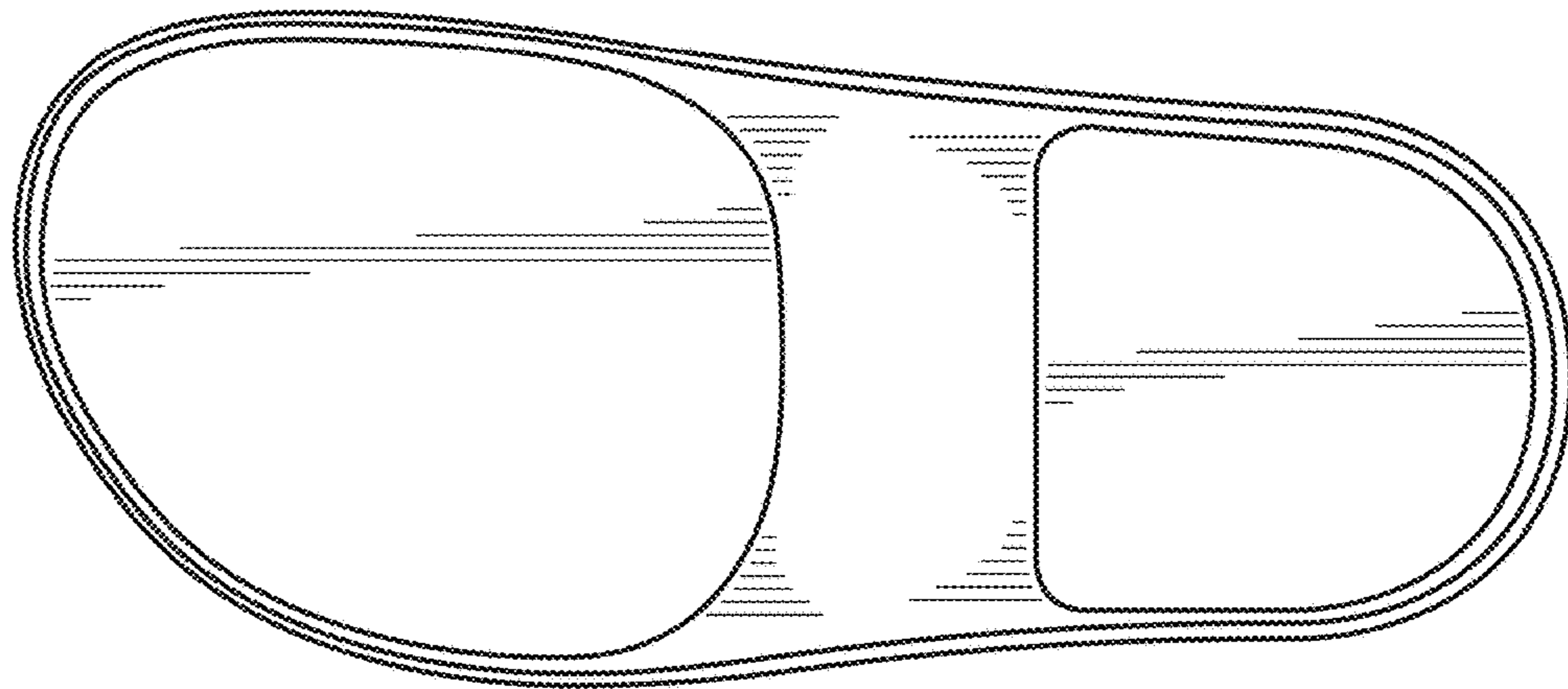

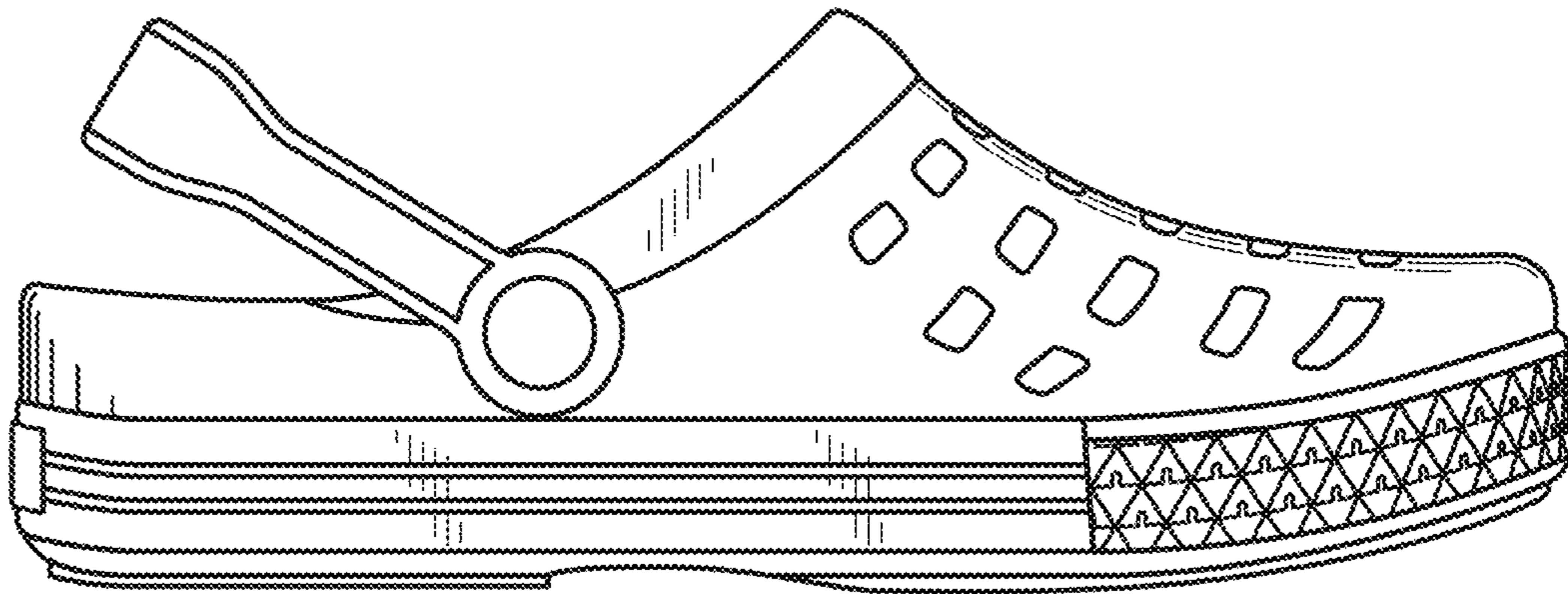

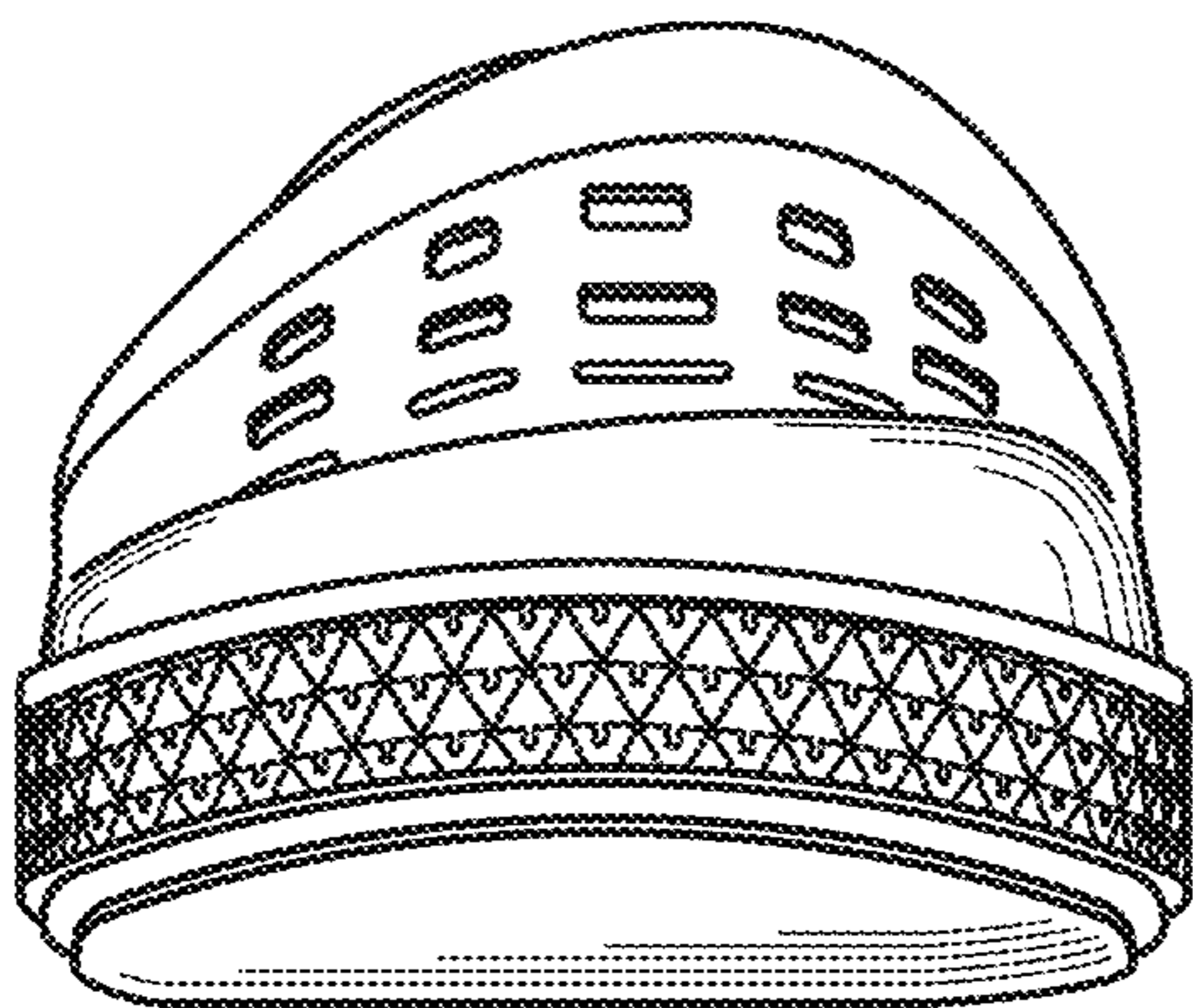

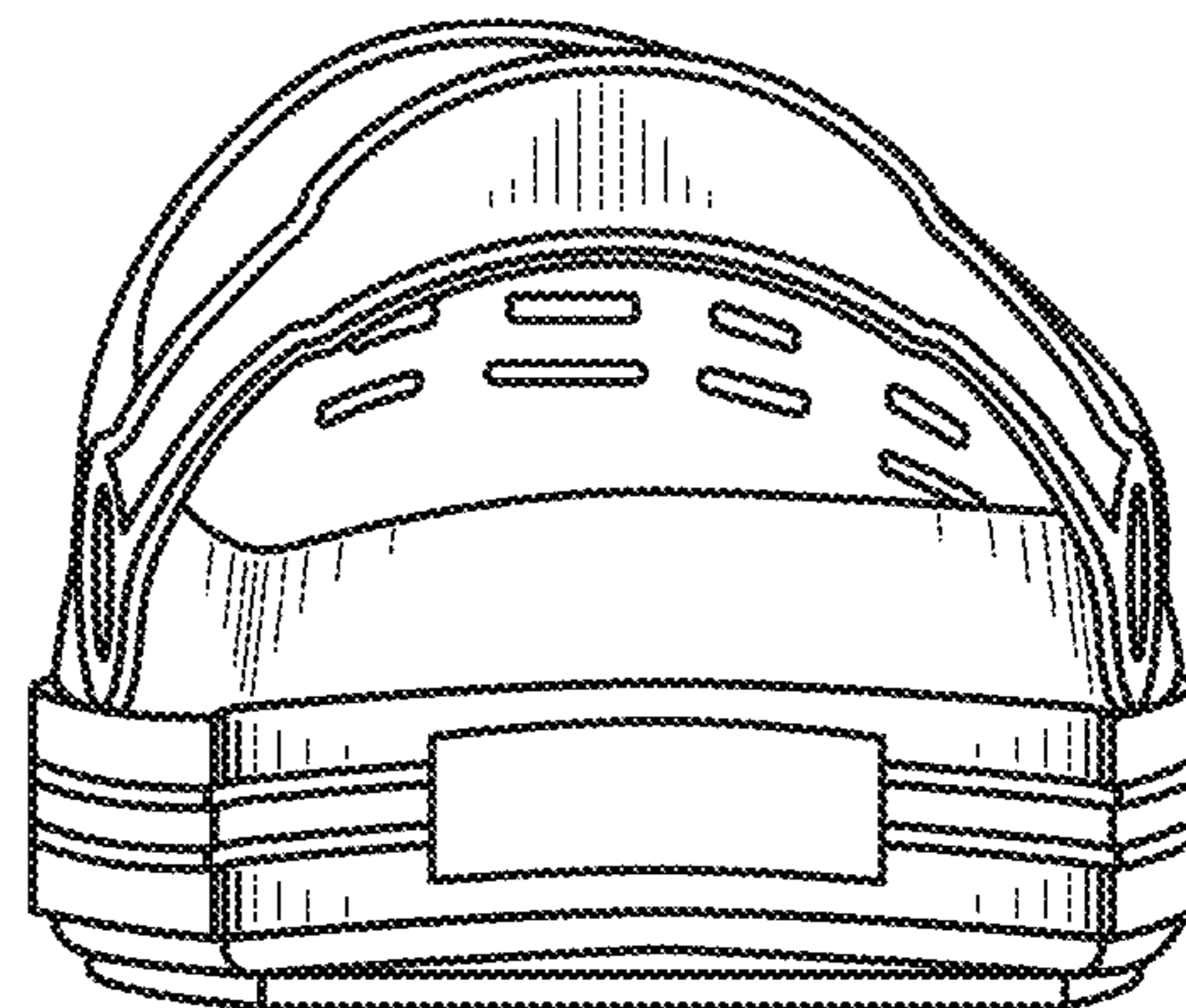
