The ornamental design for a shoe upper, as shown and described.

**DESCRIPTION**

FIG. 1 is the first perspective view of the shoe upper showing my new design;

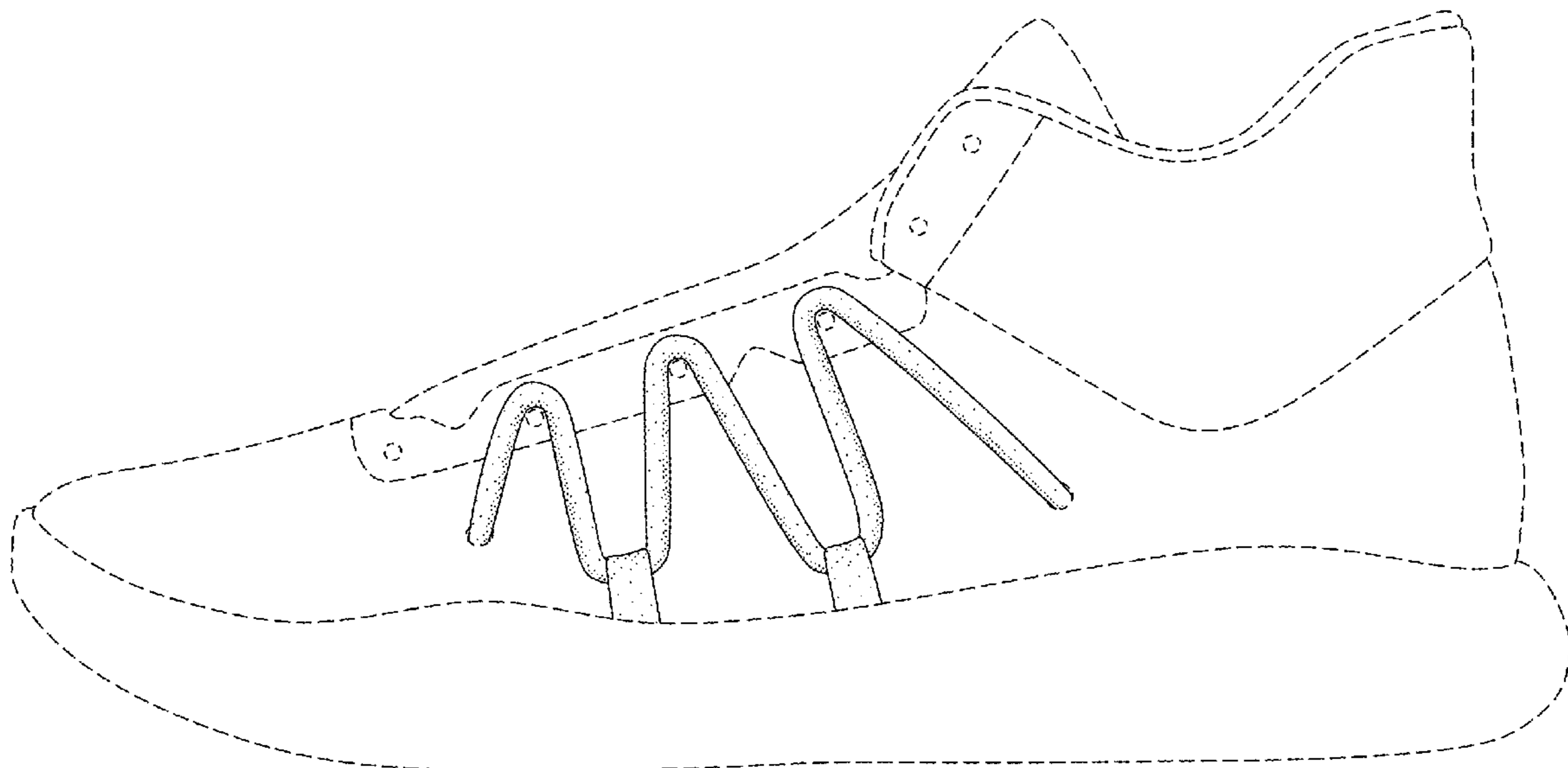
FIG. 2 is a side view thereof; and,

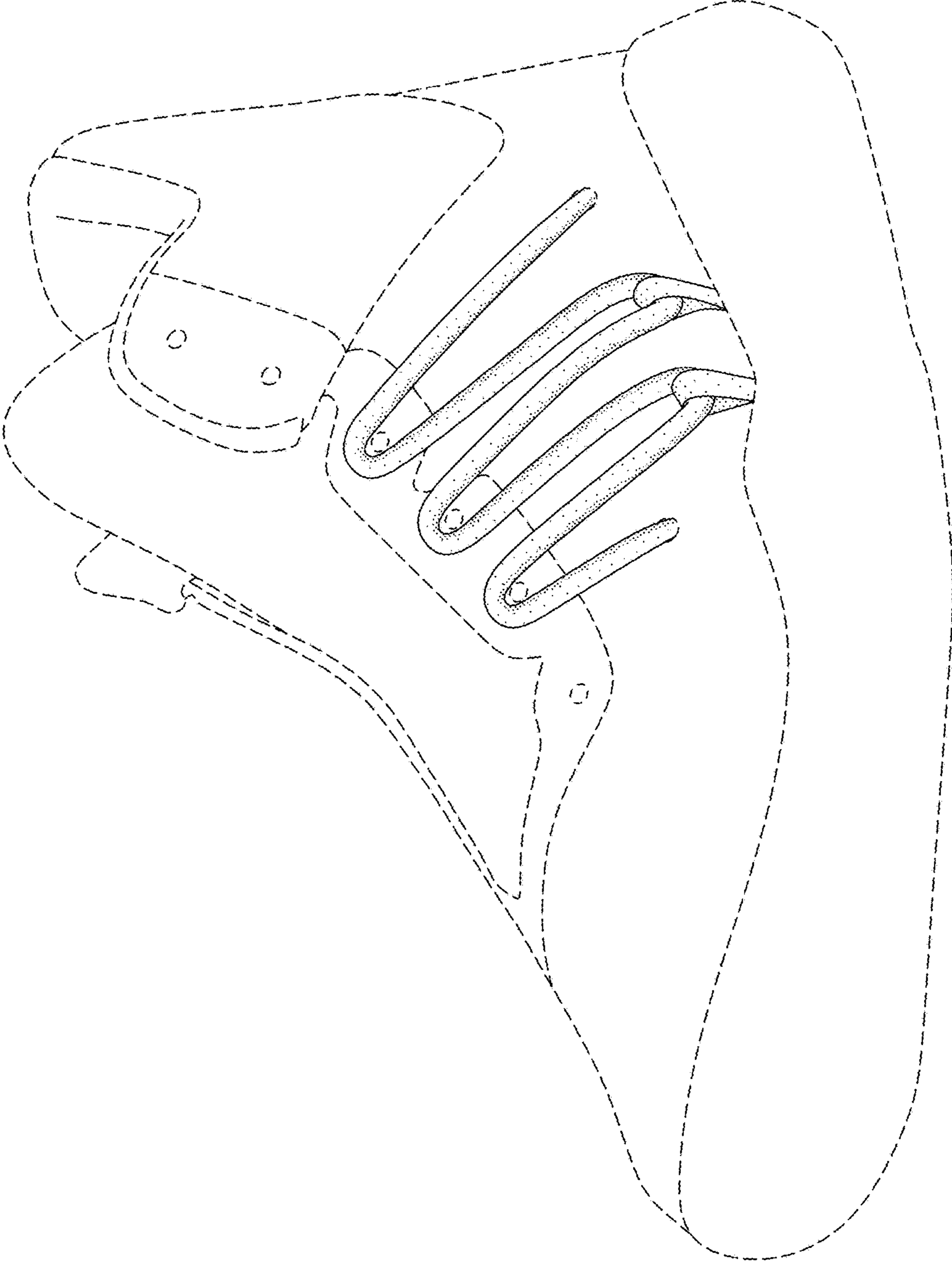

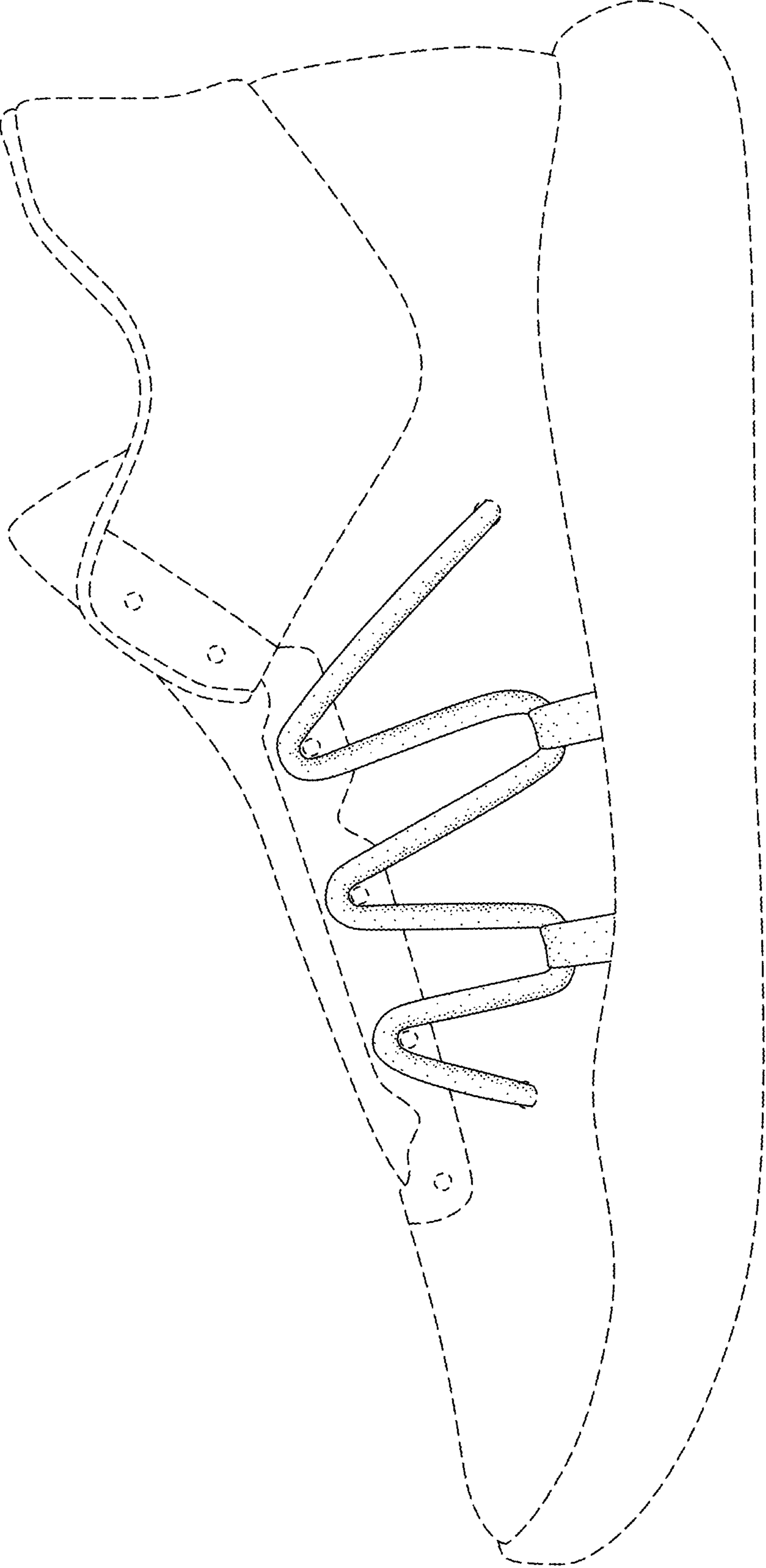

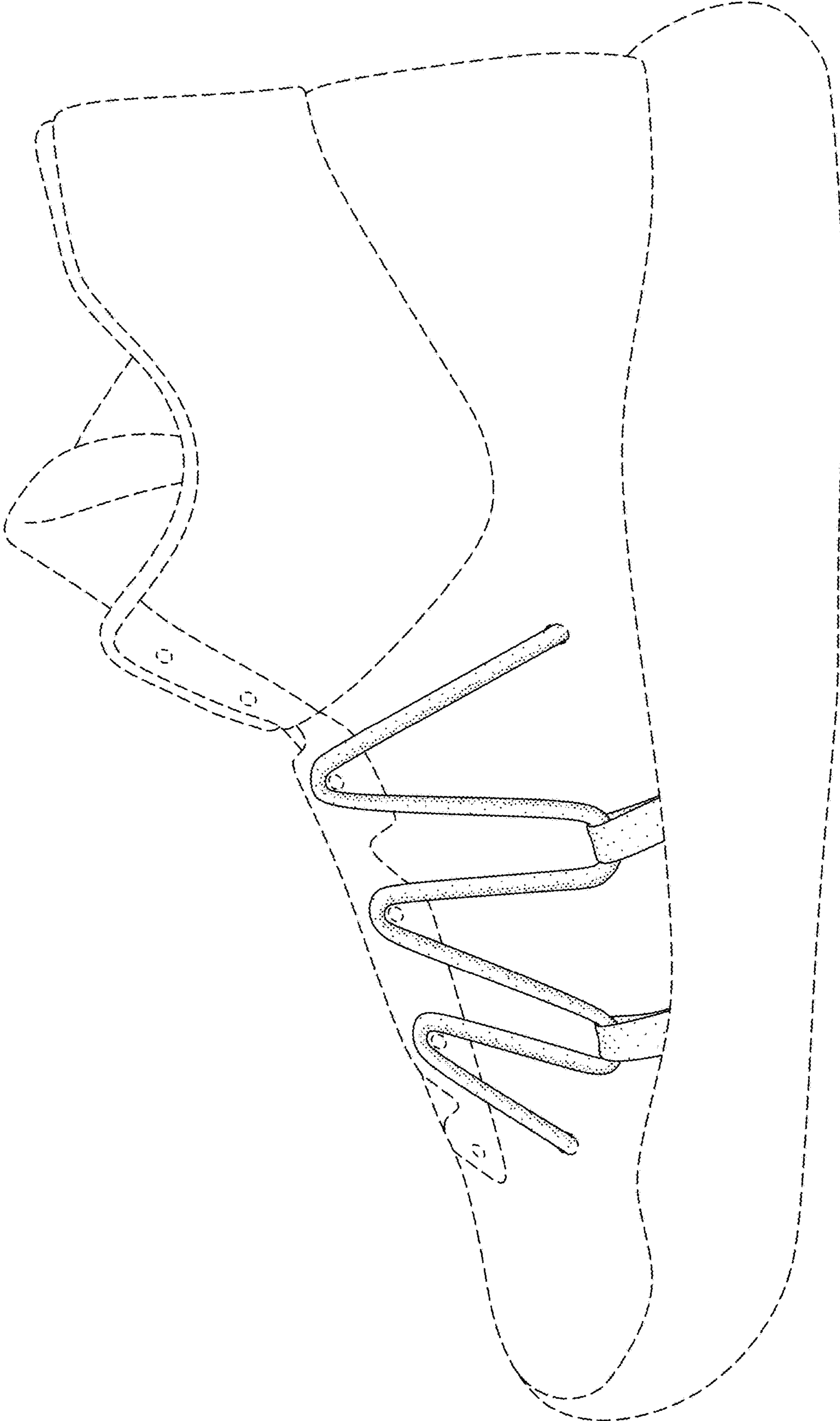
