(57) **CLAIM**

The ornamental design for a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of a shoe upper according to the present invention, within a first environment of use. FIG. 2 is a perspective view thereof. FIG. 3 is a side elevational view of the shoe upper, within a second environment of use. FIG. 4 is a perspective view thereof. FIG. 5 is a side elevational view of the shoe upper, within a third environment of use. FIG. 6 is a perspective view thereof. FIG. 7 is a side elevational view of the shoe upper, within a fourth environment of use; and, FIG. 8 is a perspective view thereof. The dashed lines illustrate unclaimed environmental structure.

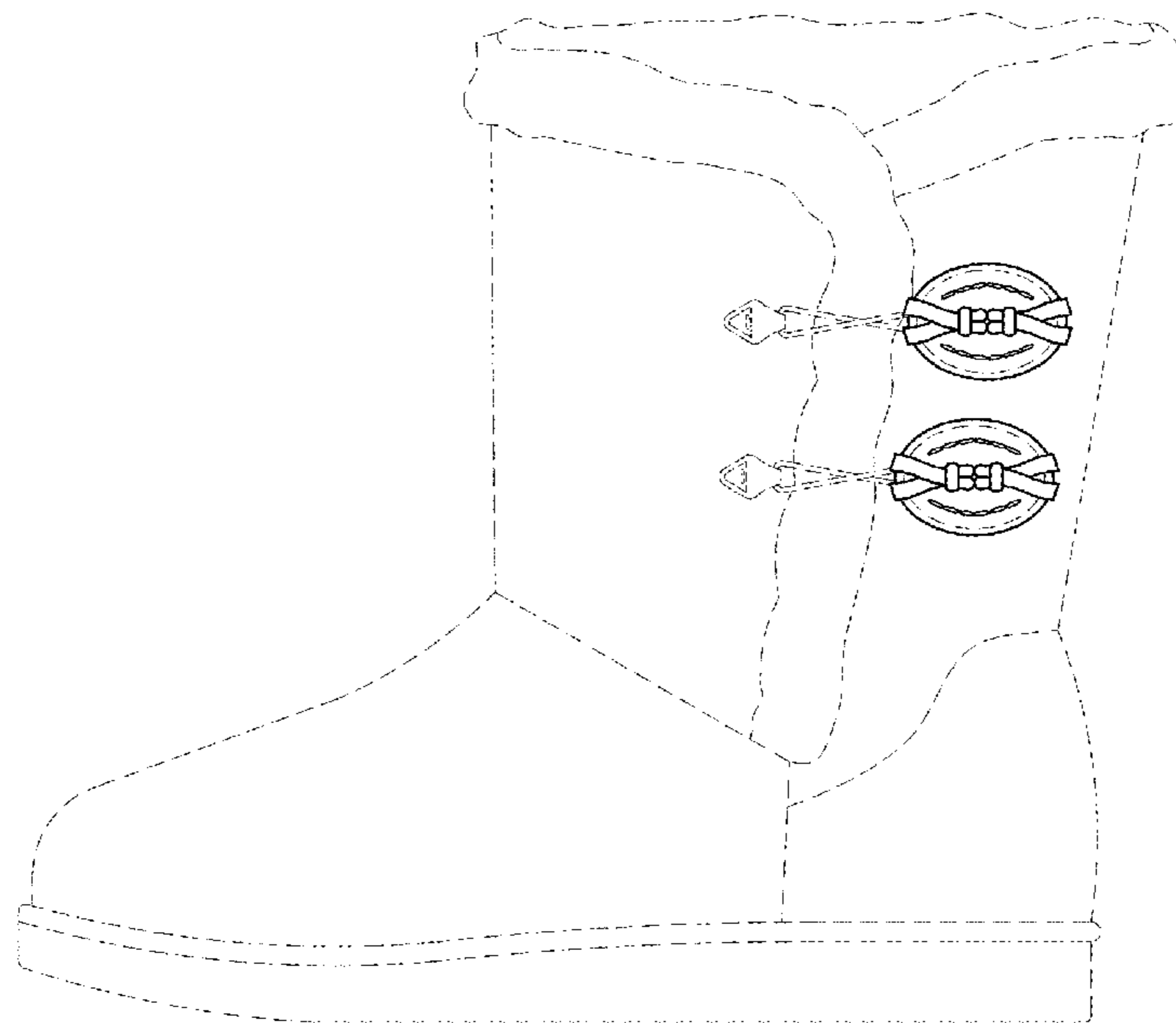

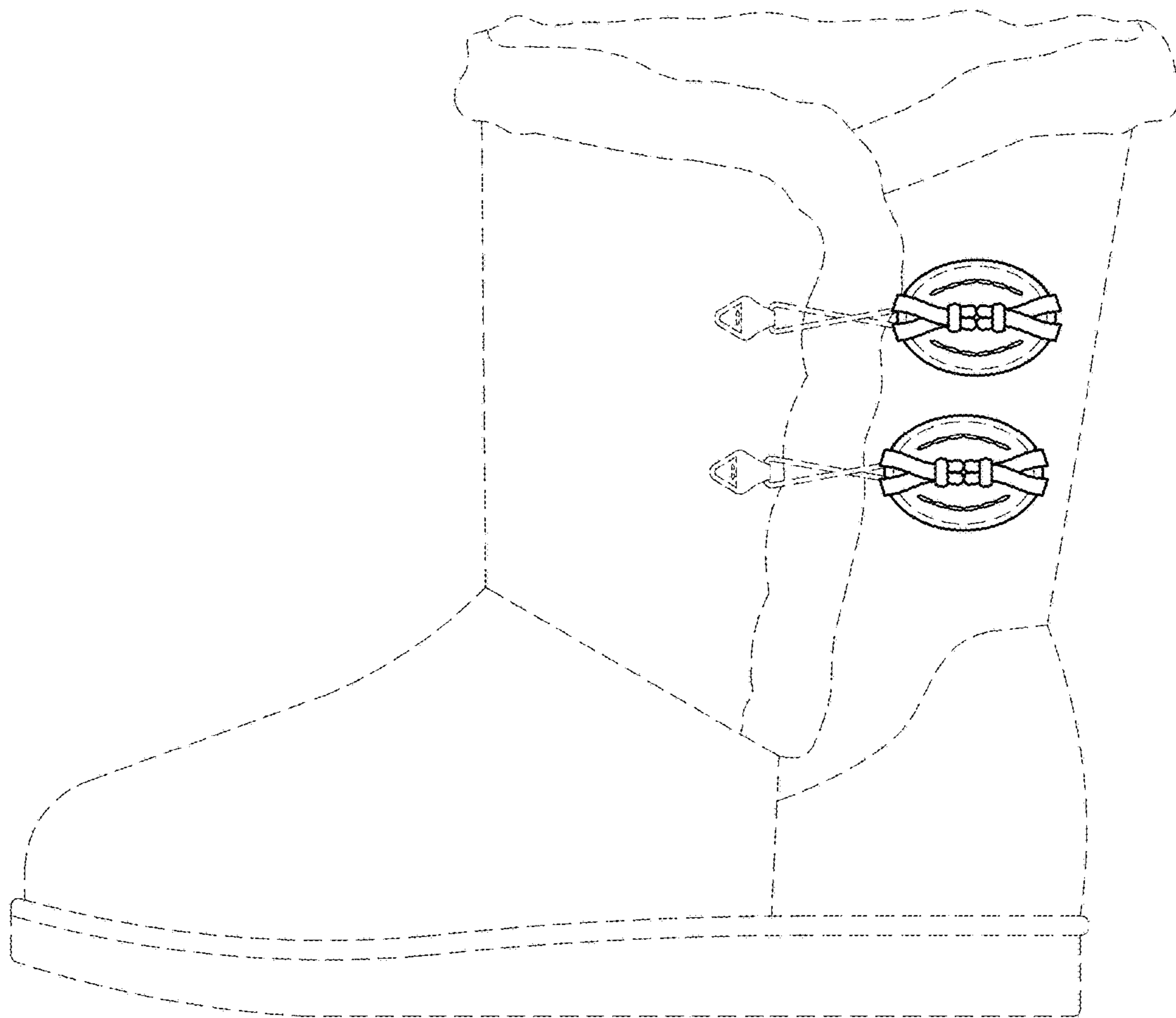

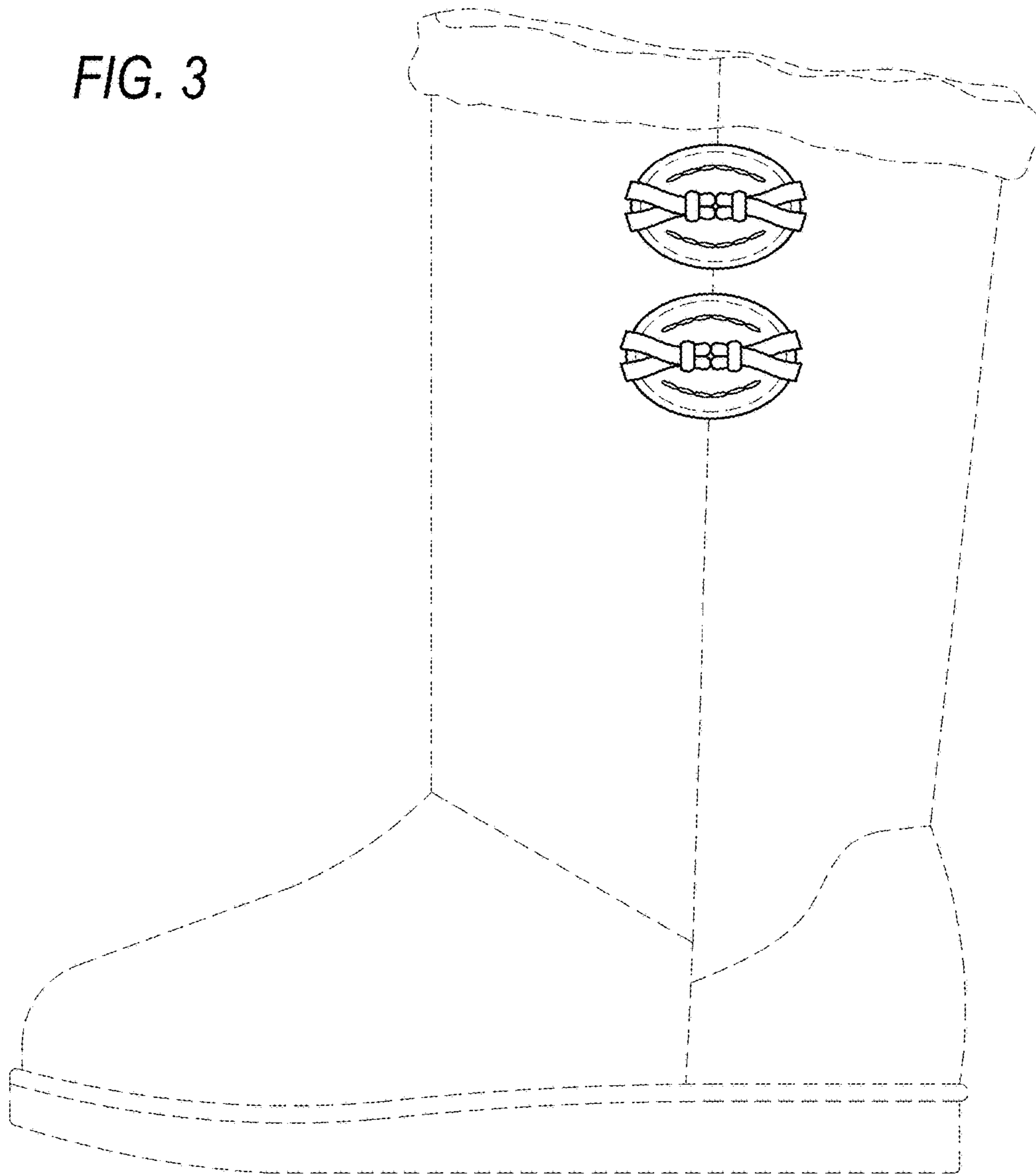

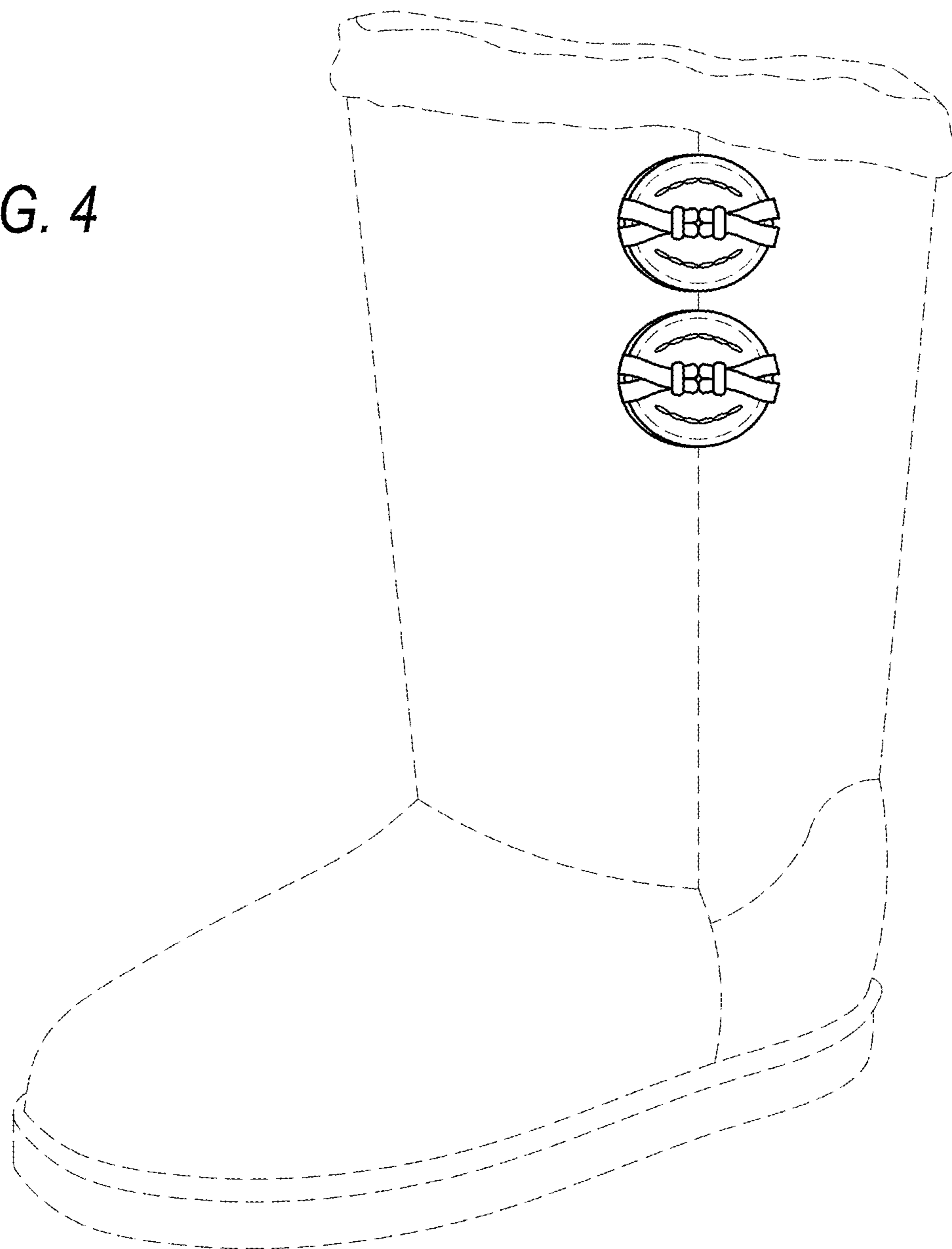

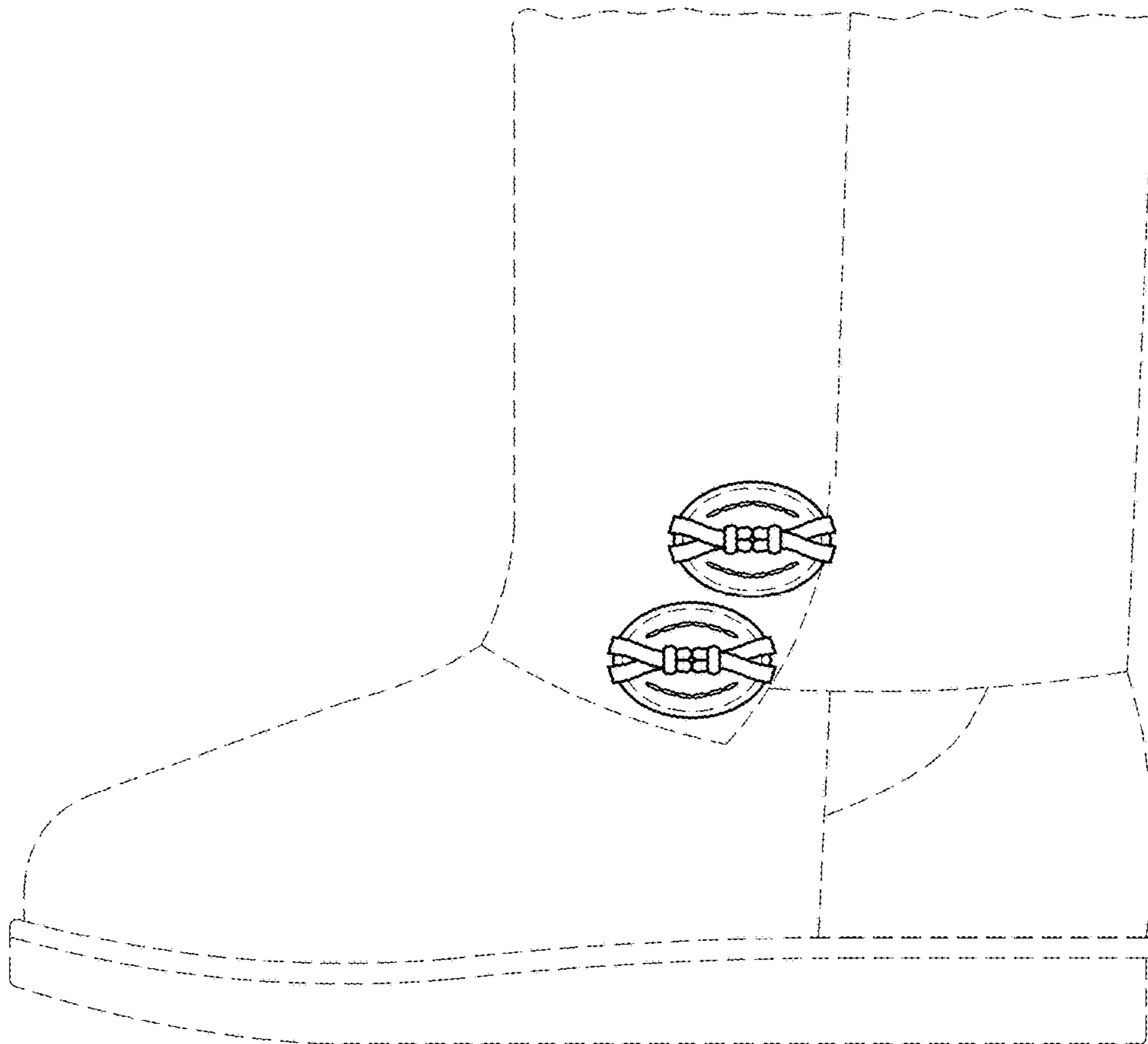

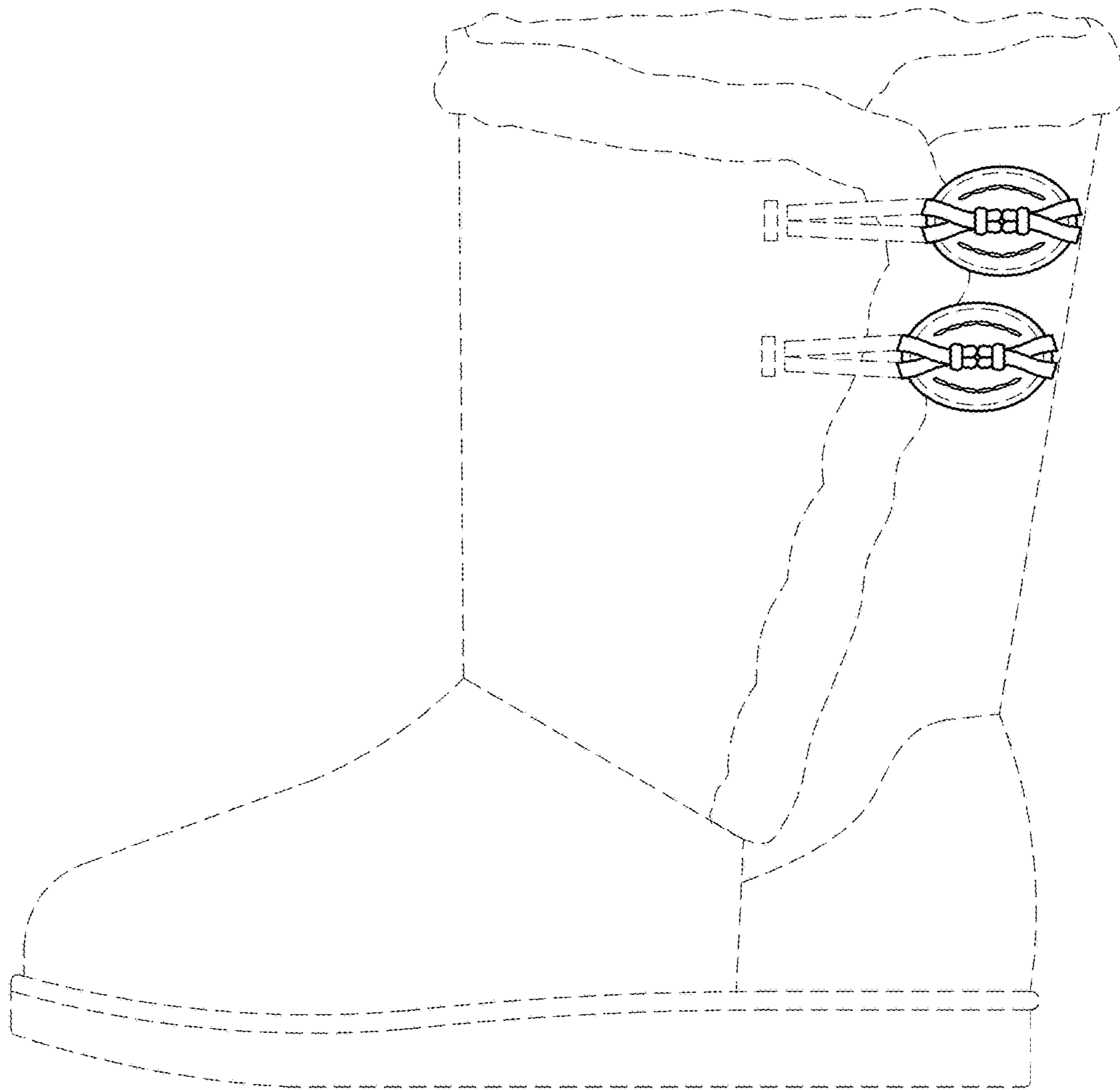
