I claim the ornamental design for a bag, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the bag showing the new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a left side view thereof;  
FIG. 5 is a right side view thereof;

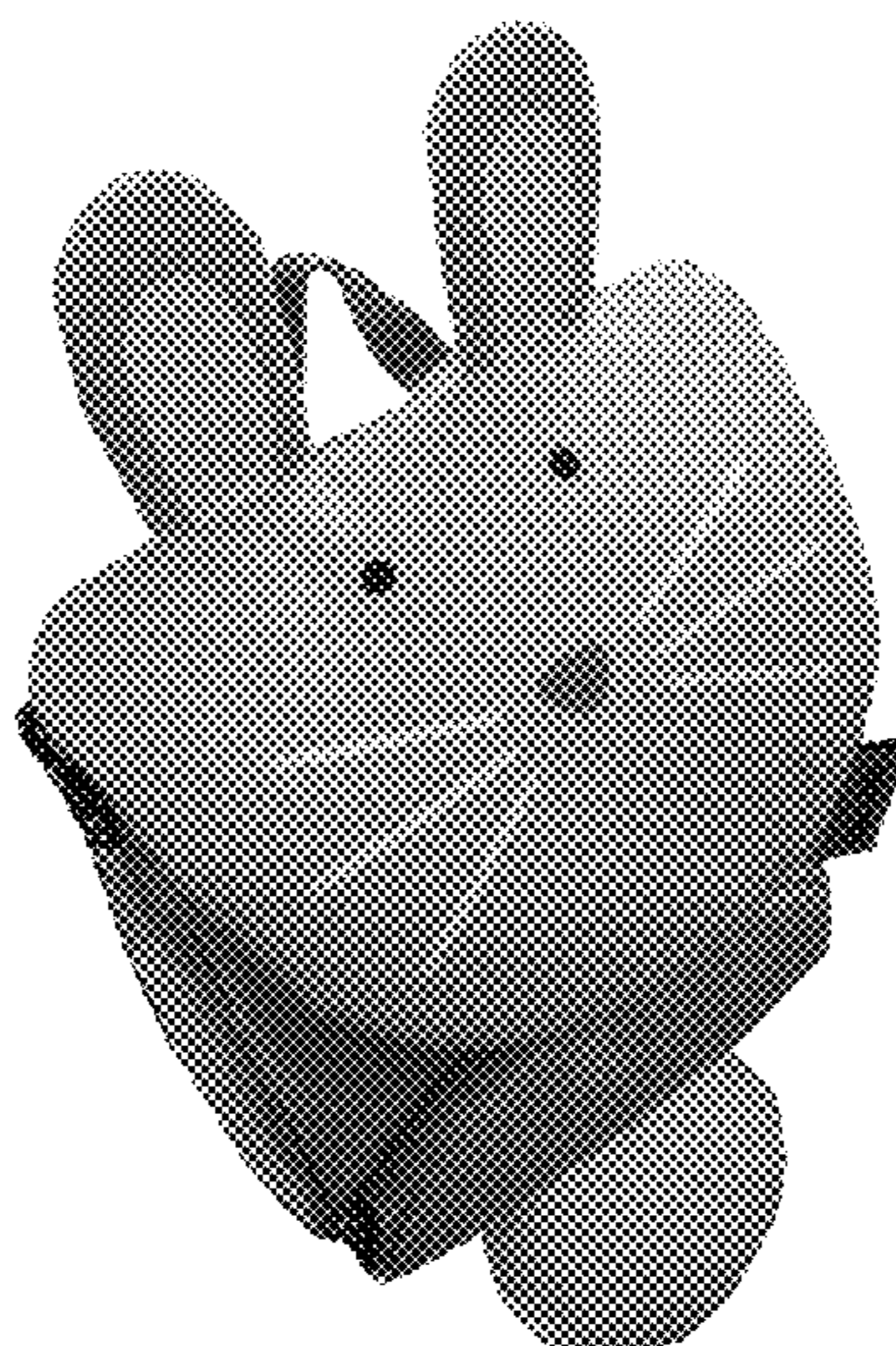

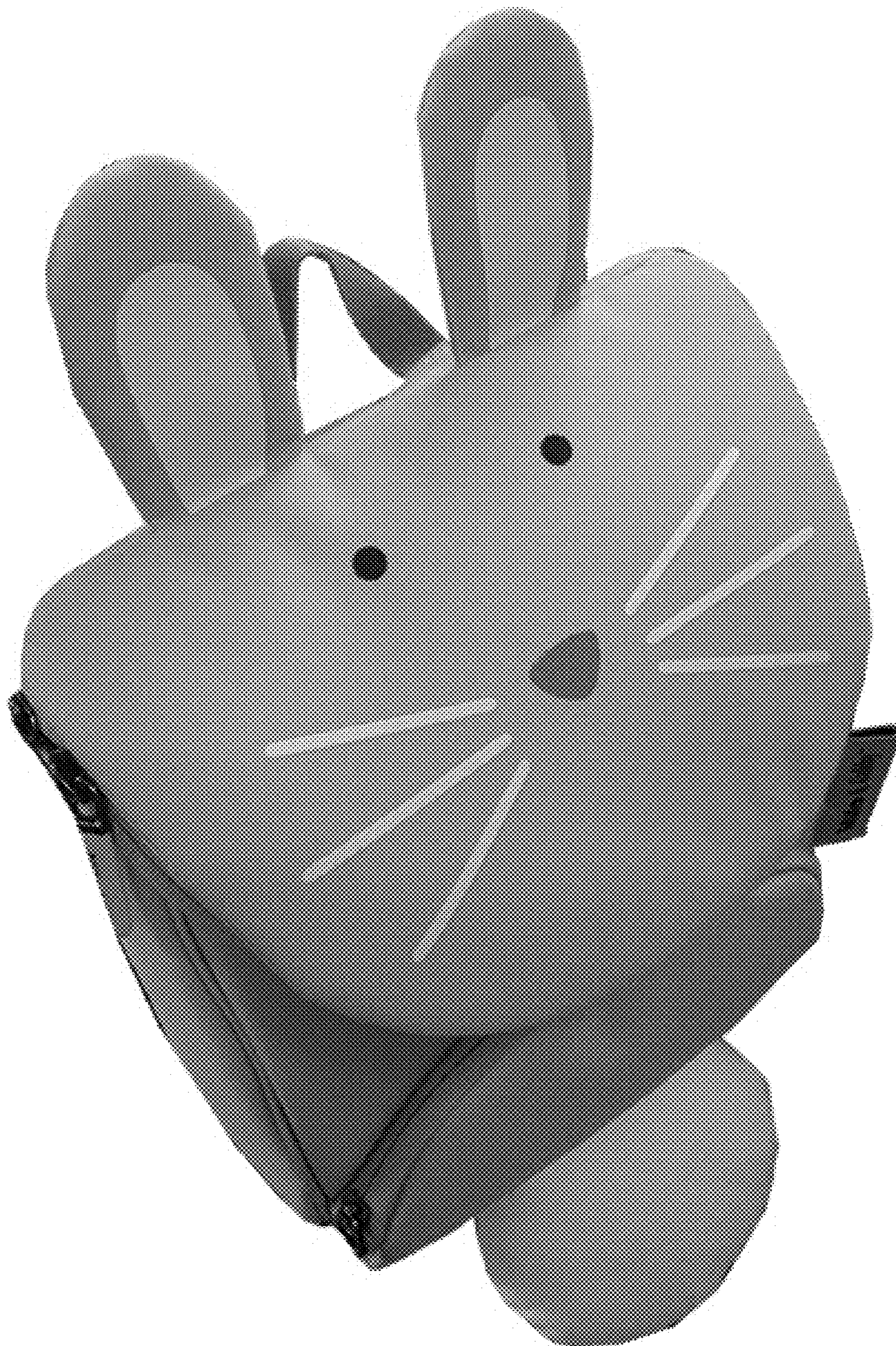

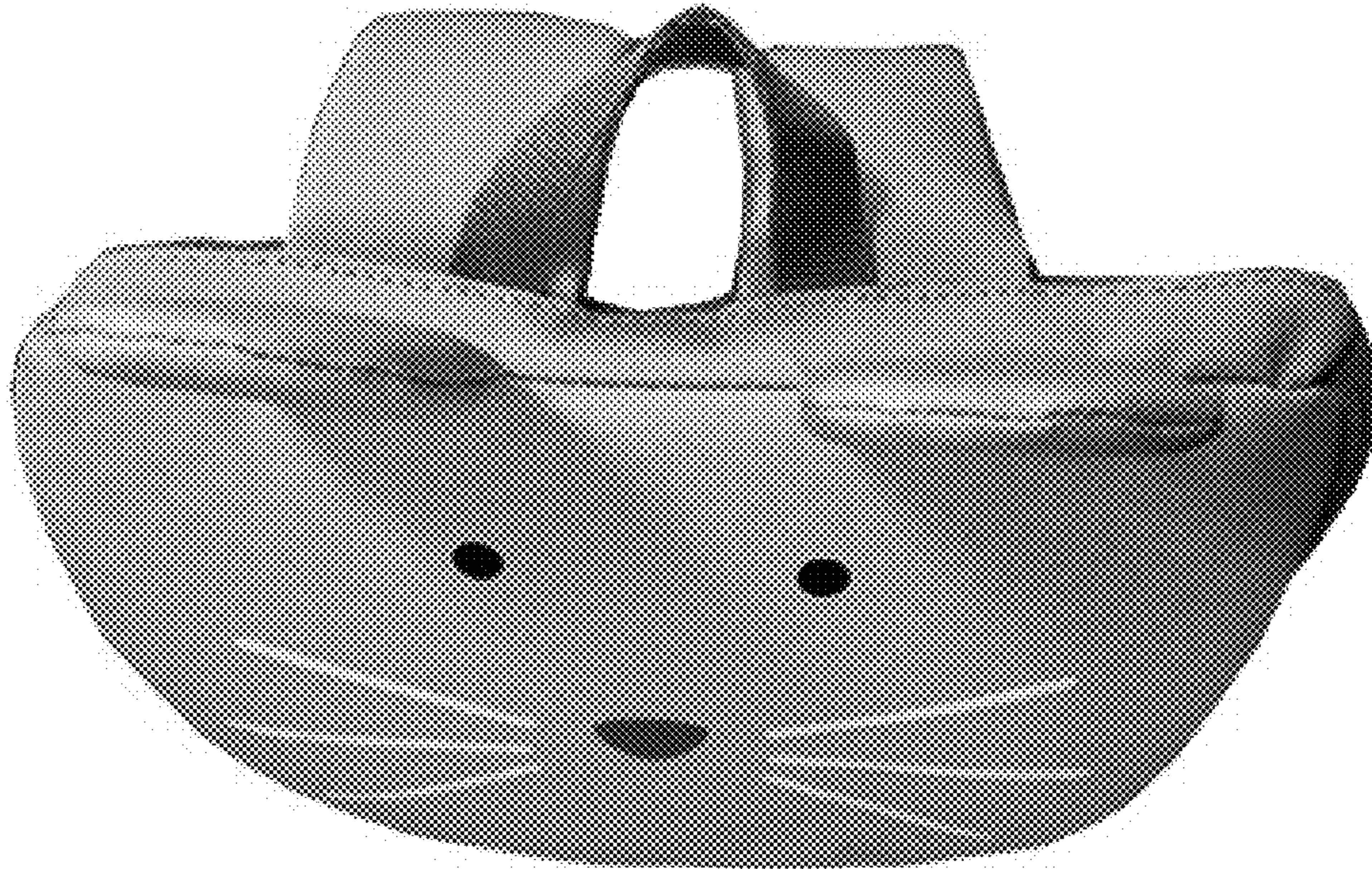
