The ornamental design for a bag, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a bag showing the new design;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a back elevation view thereof;  
FIG. 4 is a left elevation view thereof;  
FIG. 5 is a right elevation view thereof;  
FIG. 6 is a bottom plan view thereof; and,  
FIG. 7 is a top plan view thereof, with the strap removed.

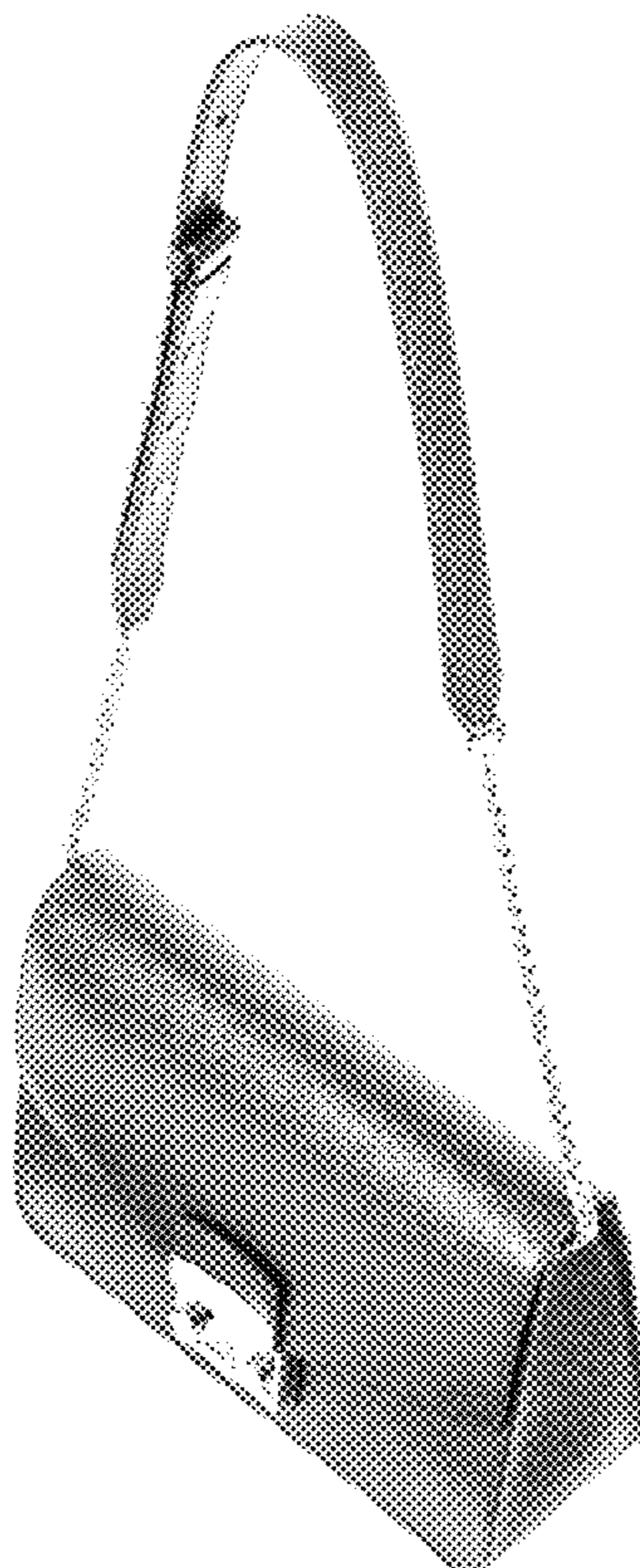

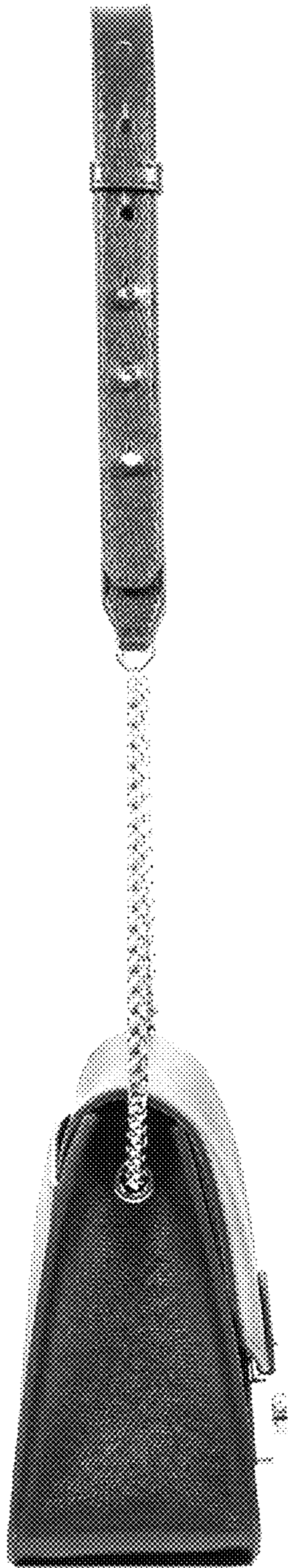

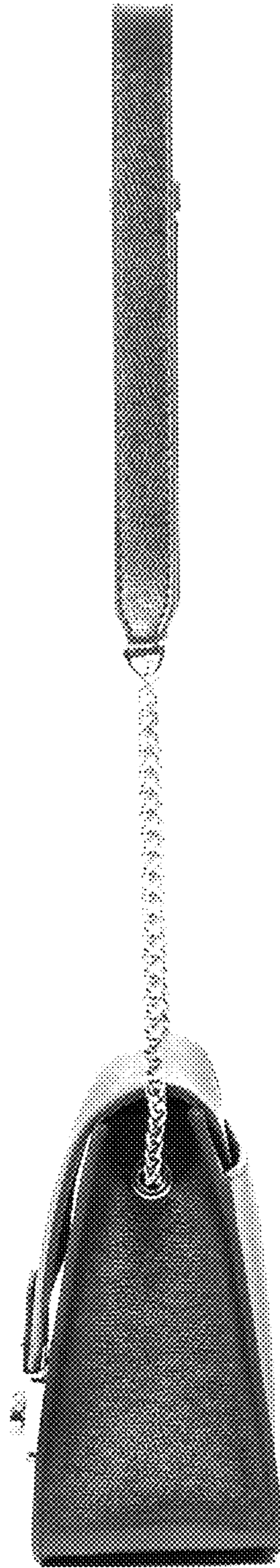

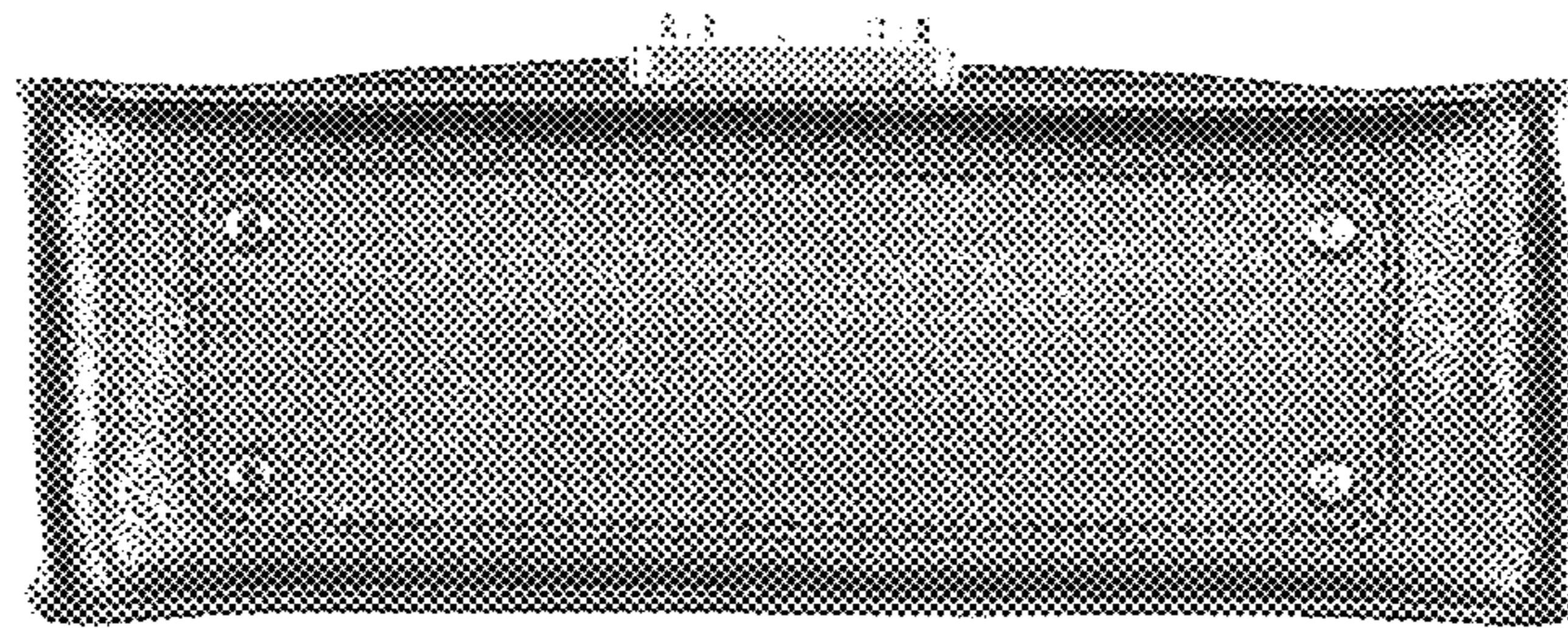

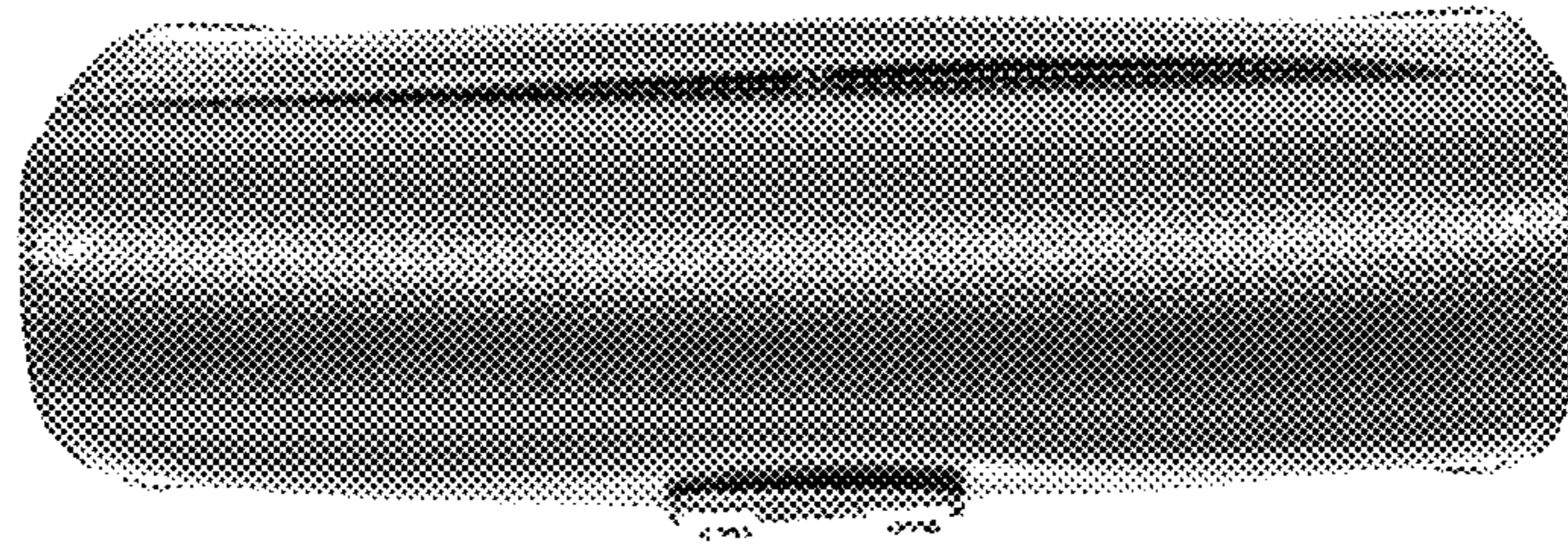
