(57) **CLAIM**

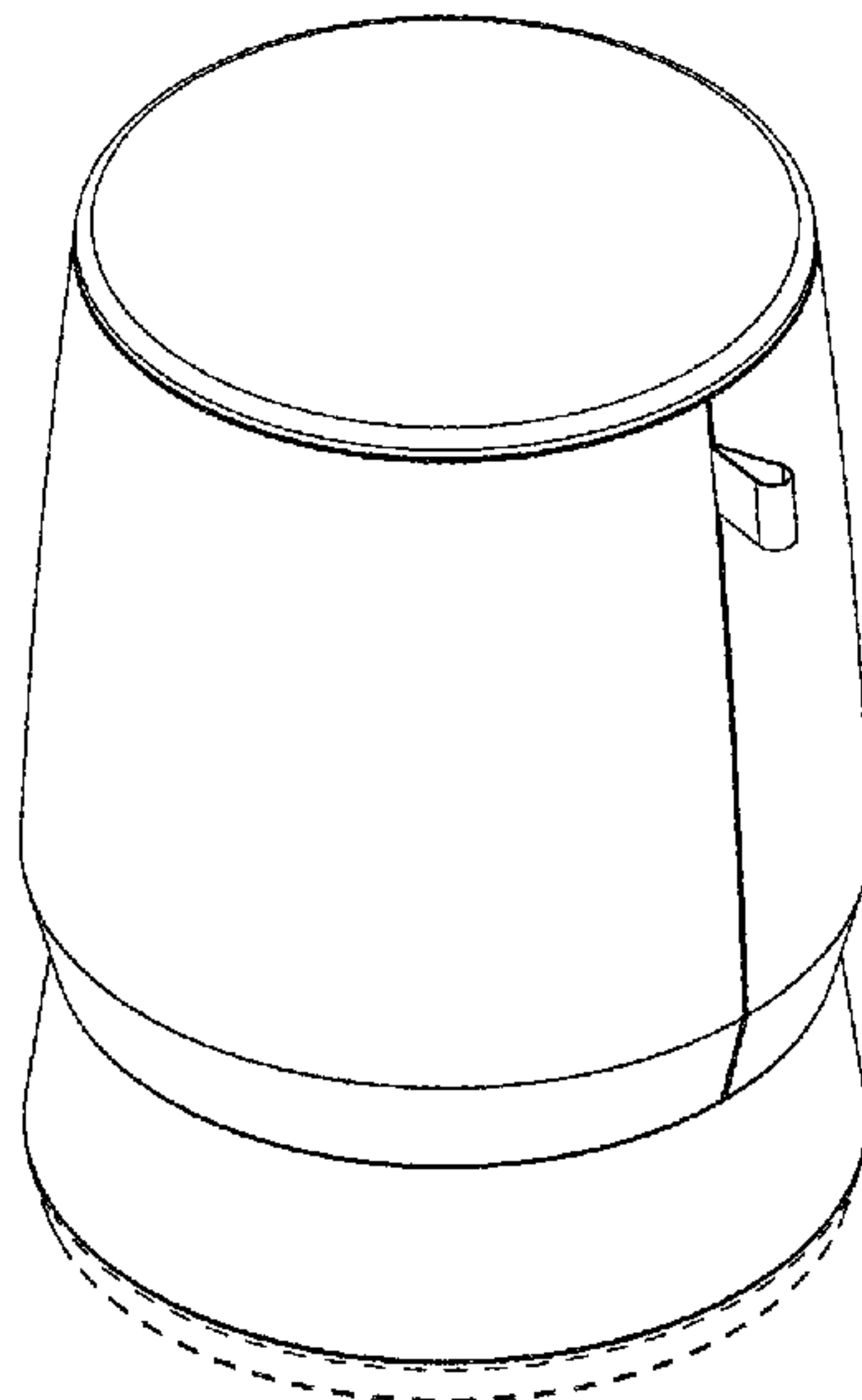
What is claimed is the ornamental design for a stool, as shown and described.

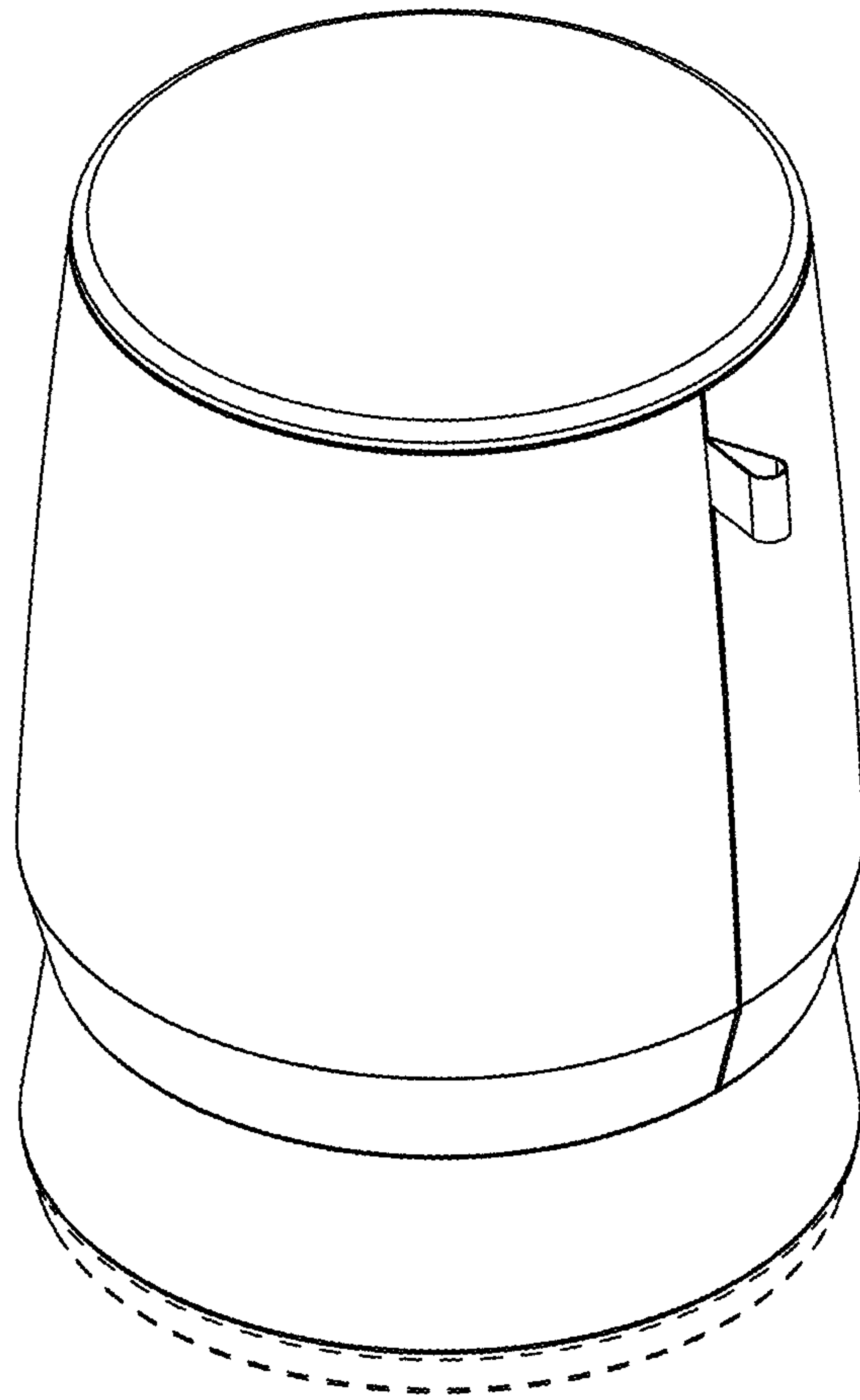
**DESCRIPTION**

The broken lines in the drawings depict portions of the stool that form no part of the claimed design.

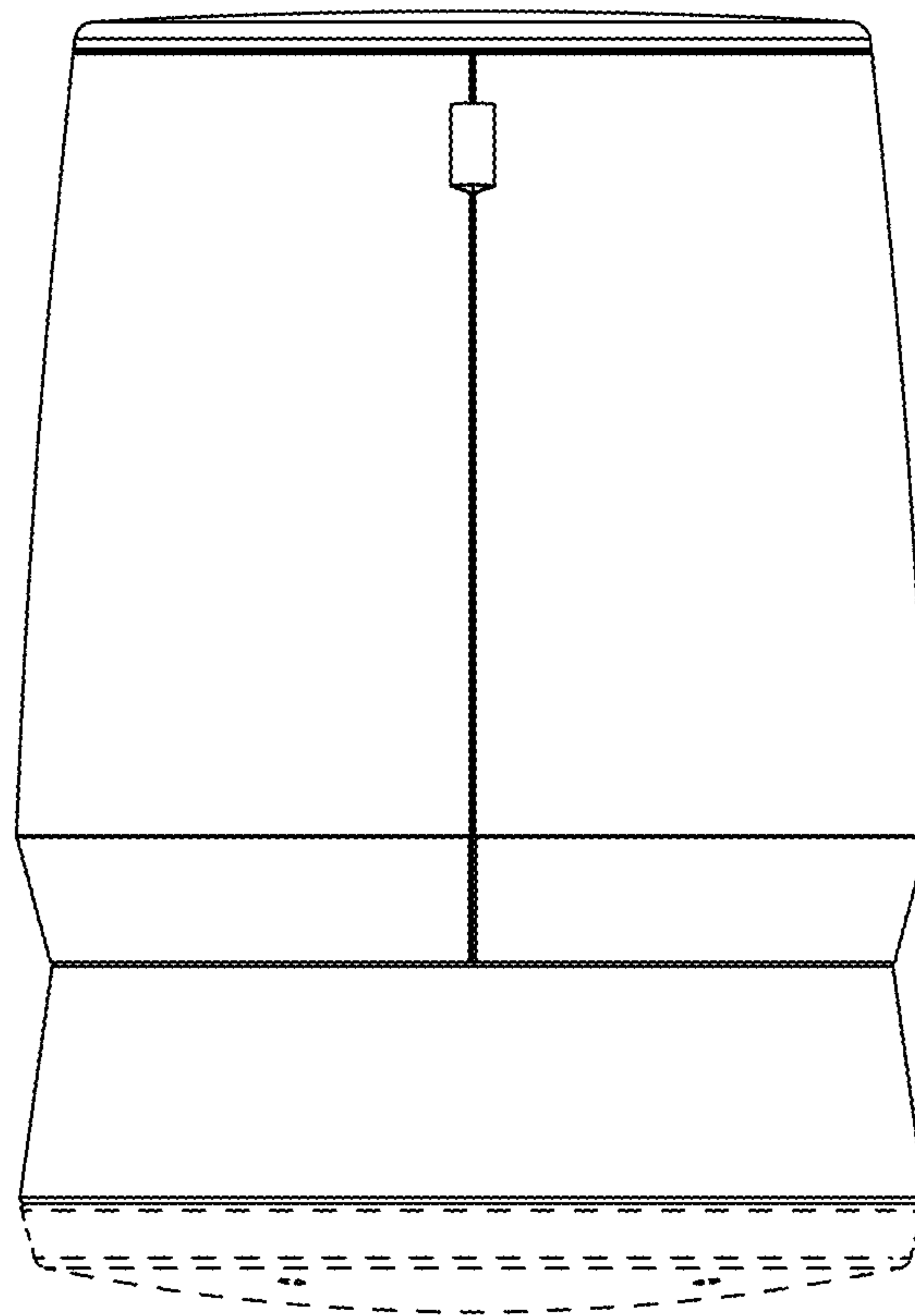

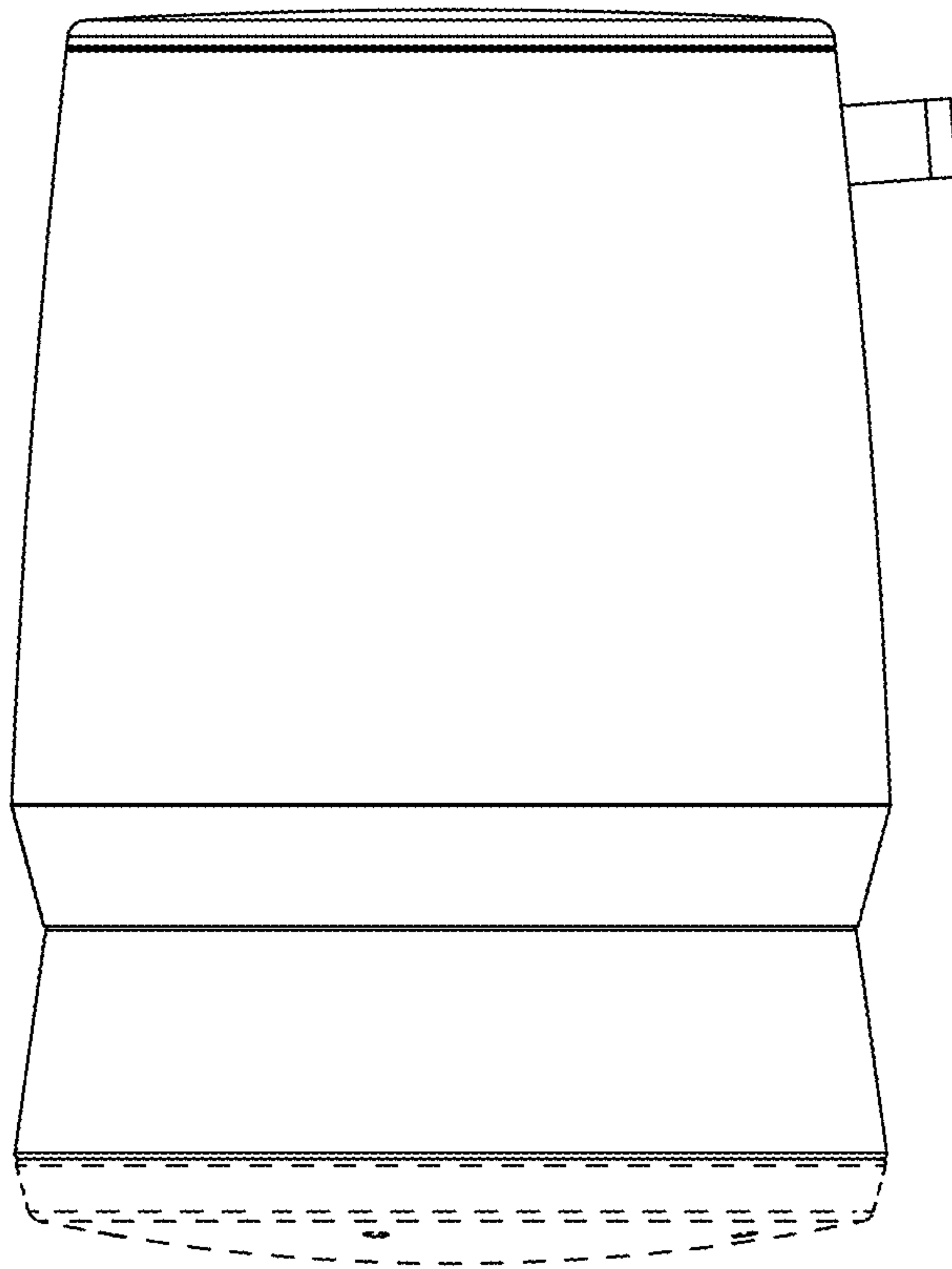
