DESCRIPTION

FIG. 1 is a perspective view of a knife handle showing our new design;

FIG. 5 is an enlarged rear view thereof;

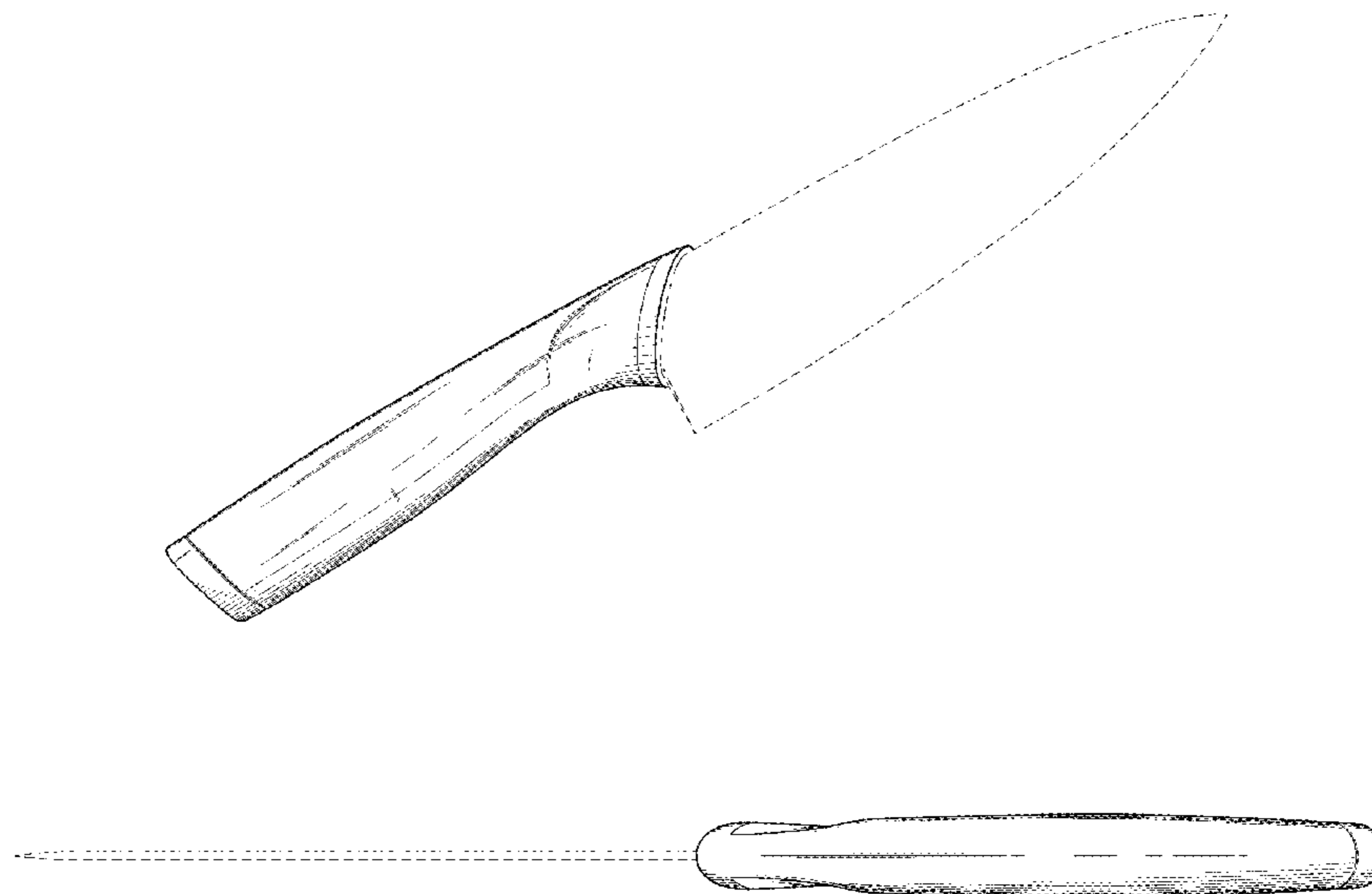
FIG. 6 is a right side view thereof; and,

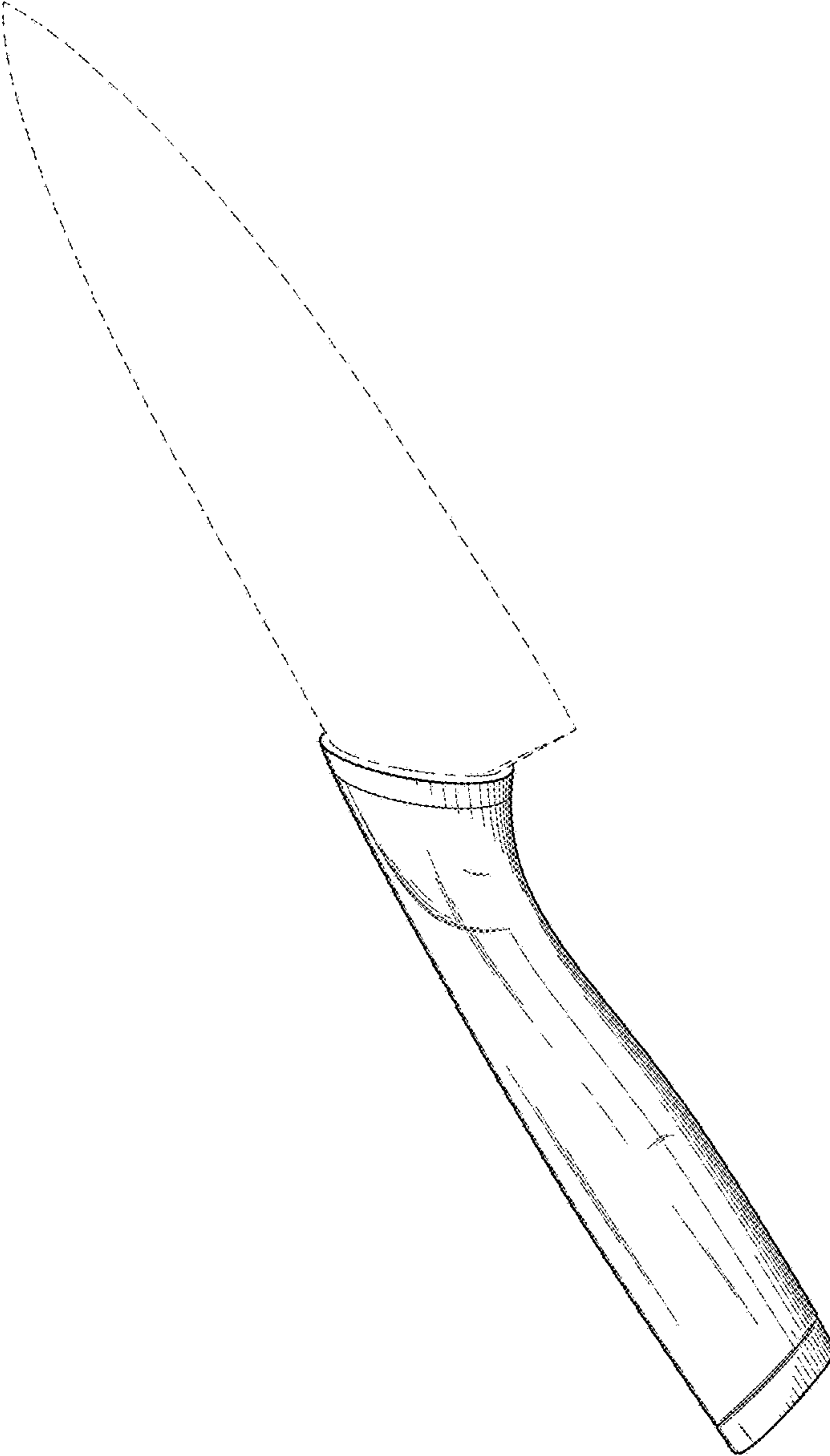

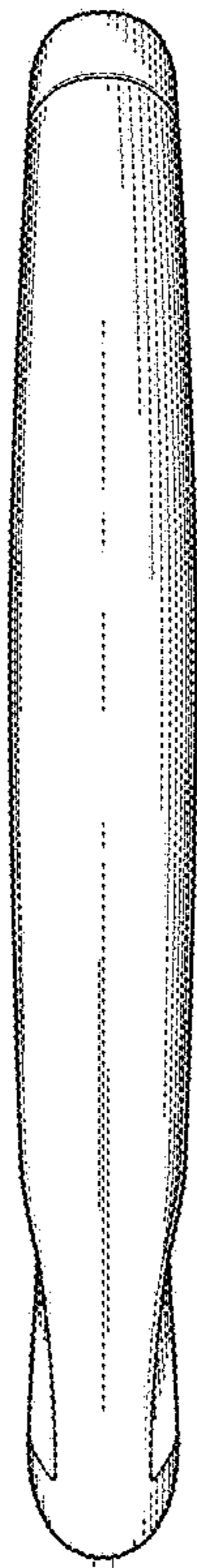

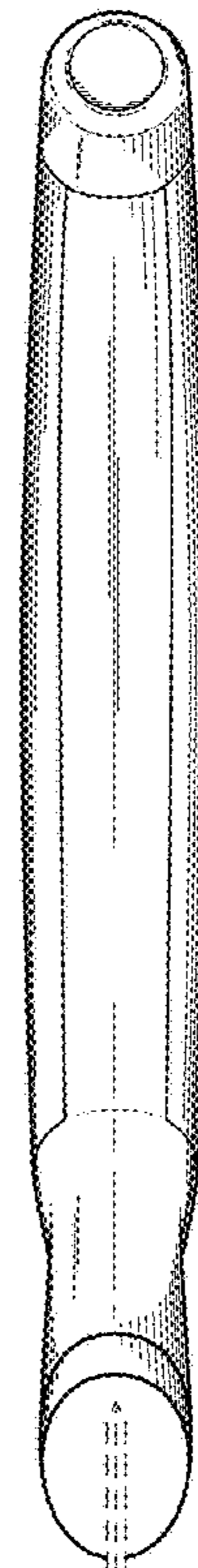

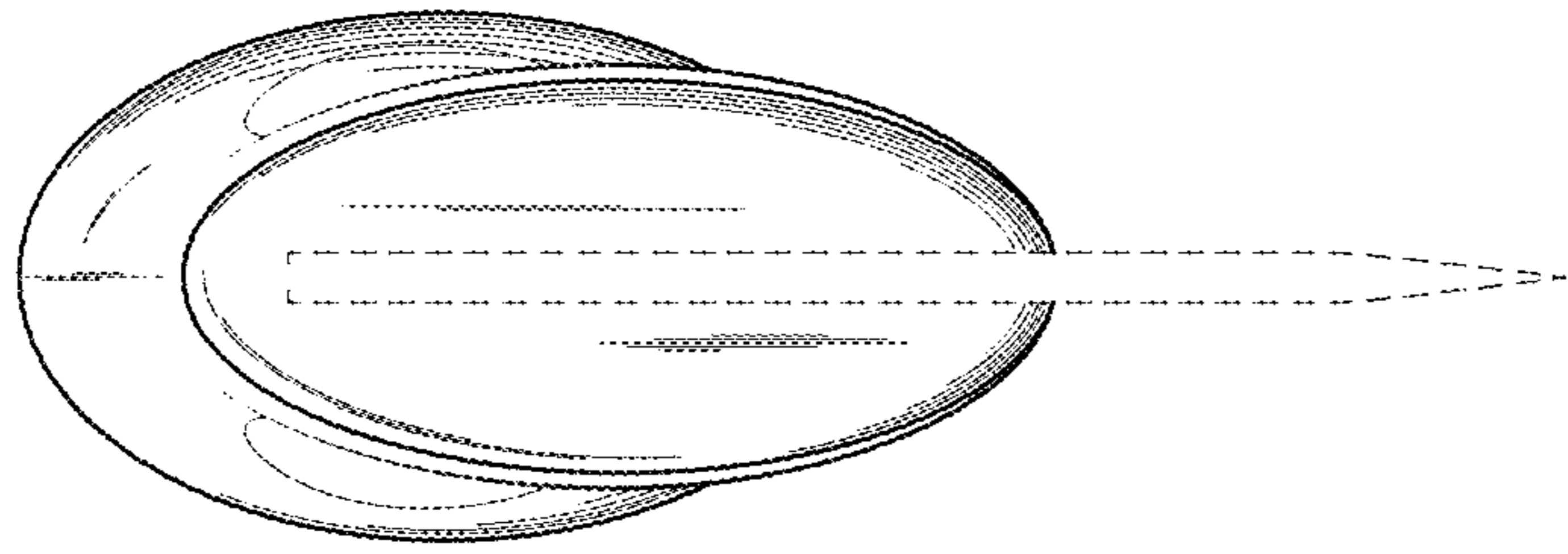

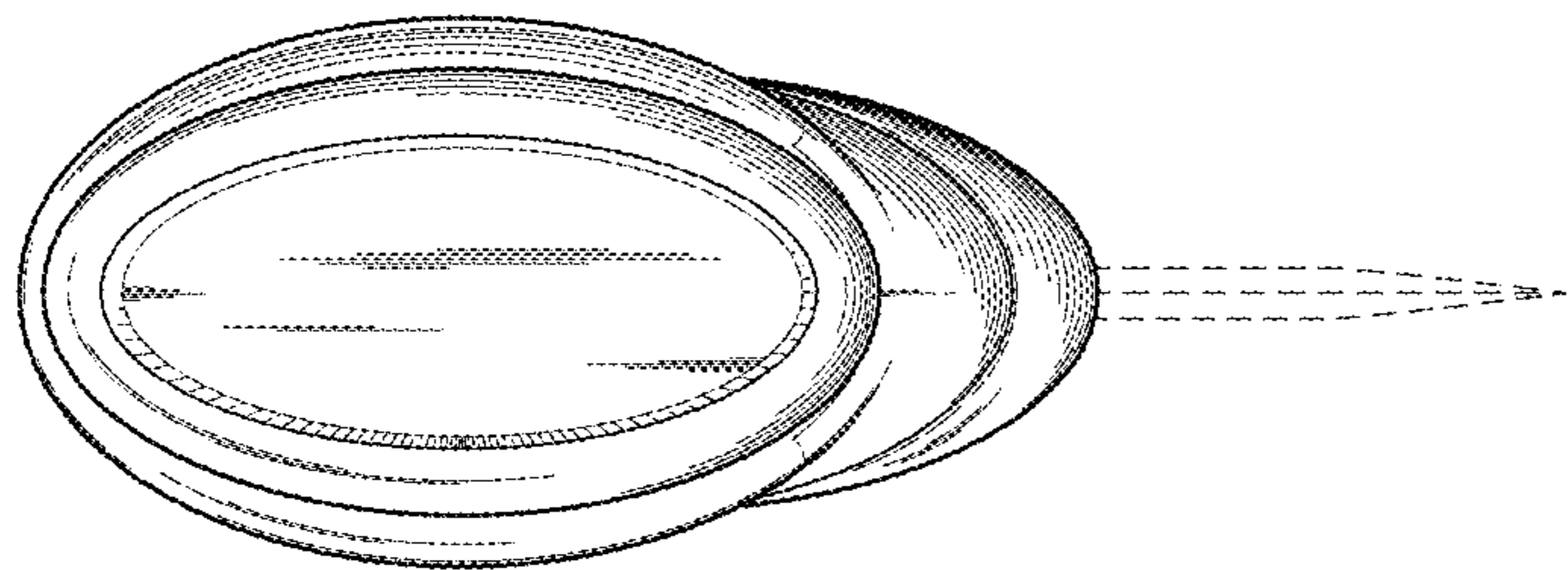

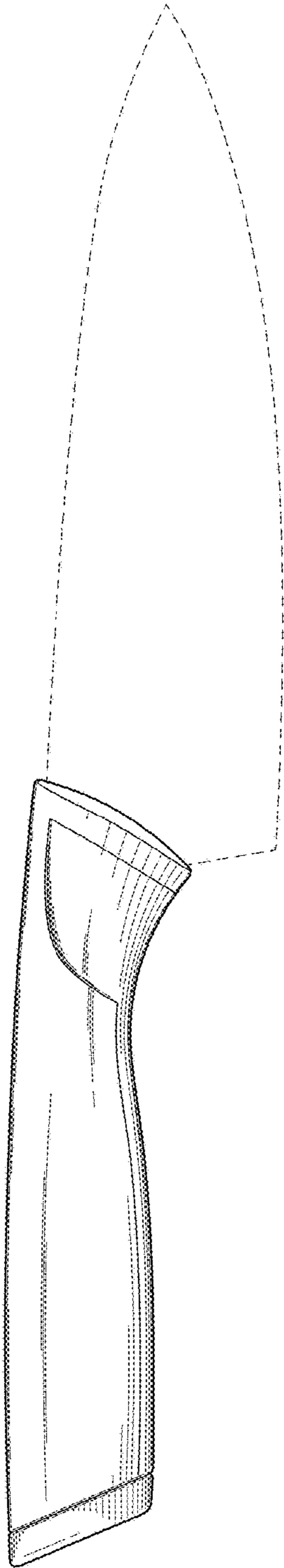

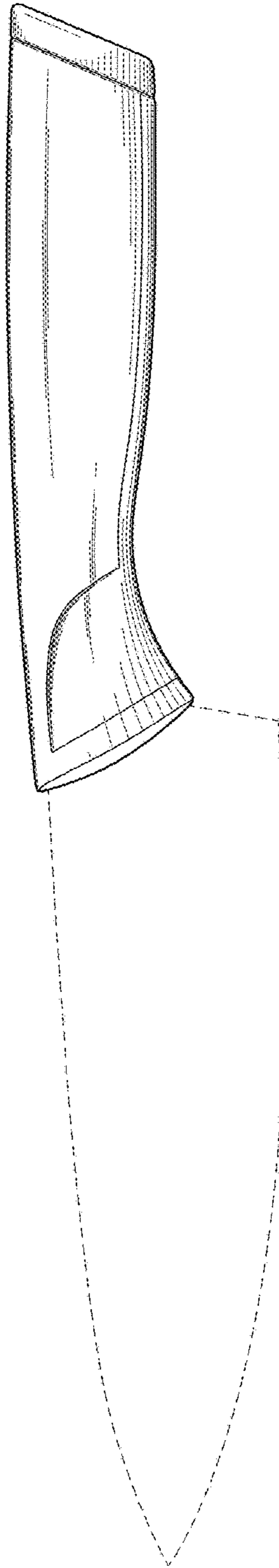
