**DESCRIPTION**

FIG. 1 is a front elevational view of a pirate mug showing our new design;

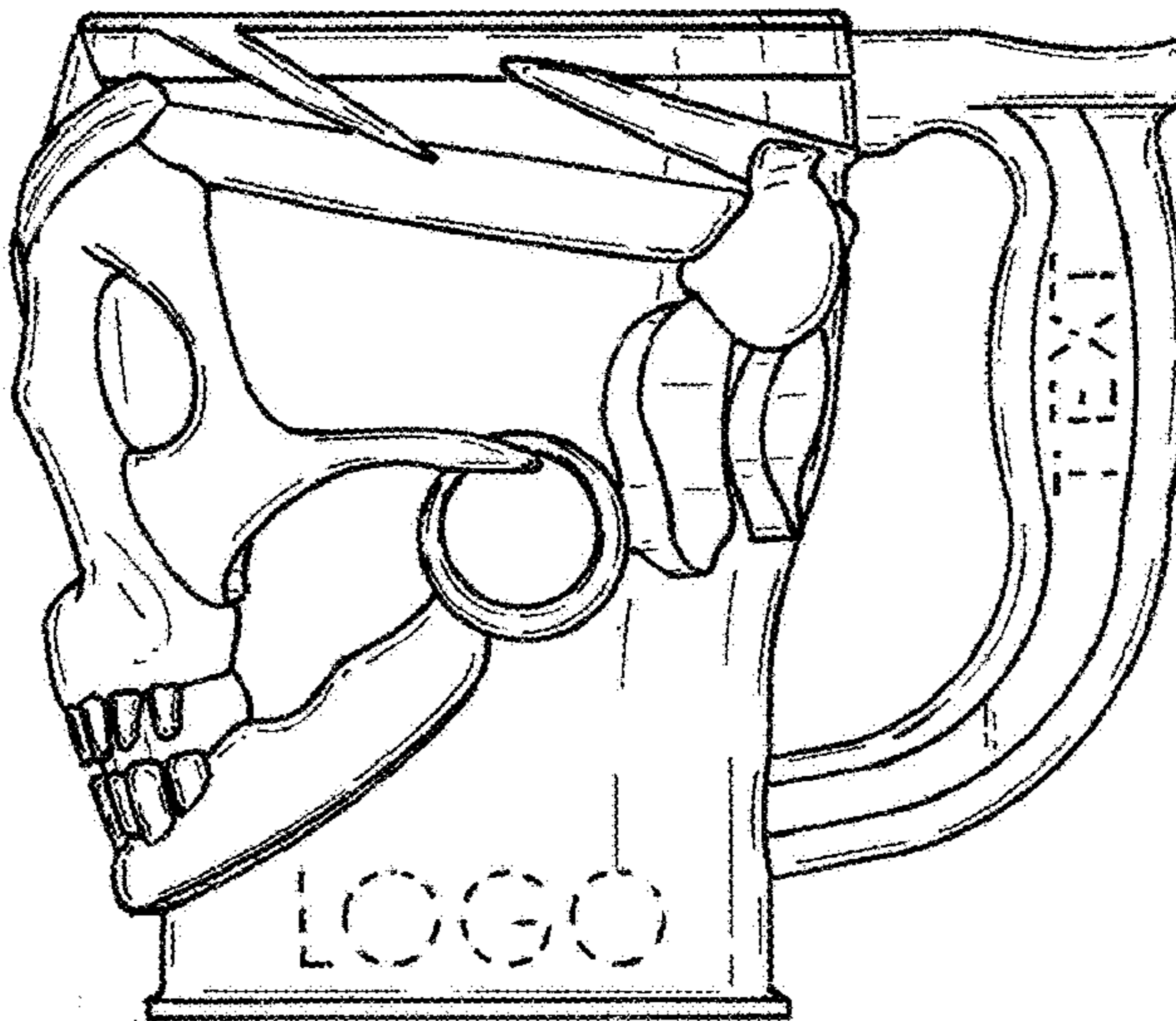
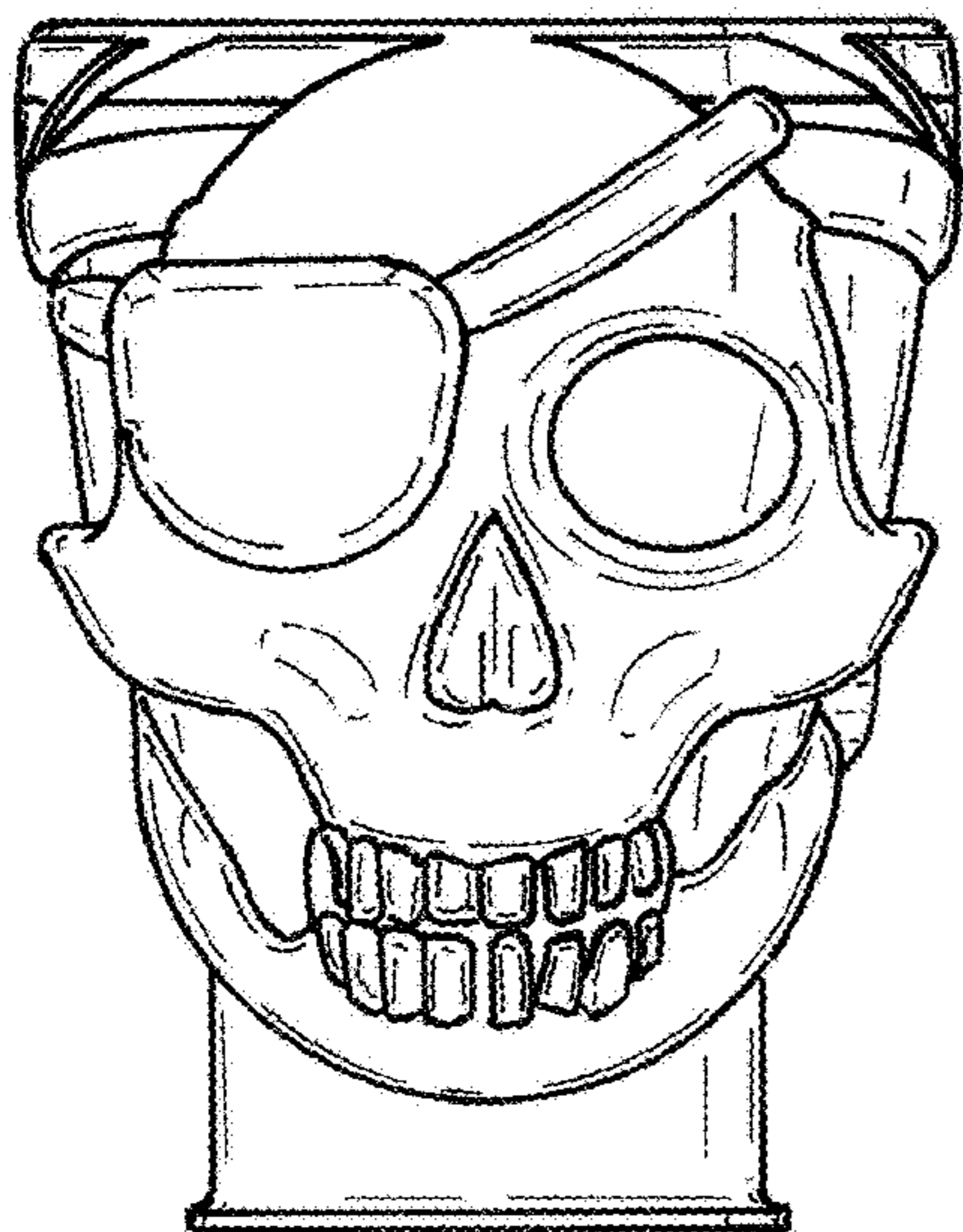

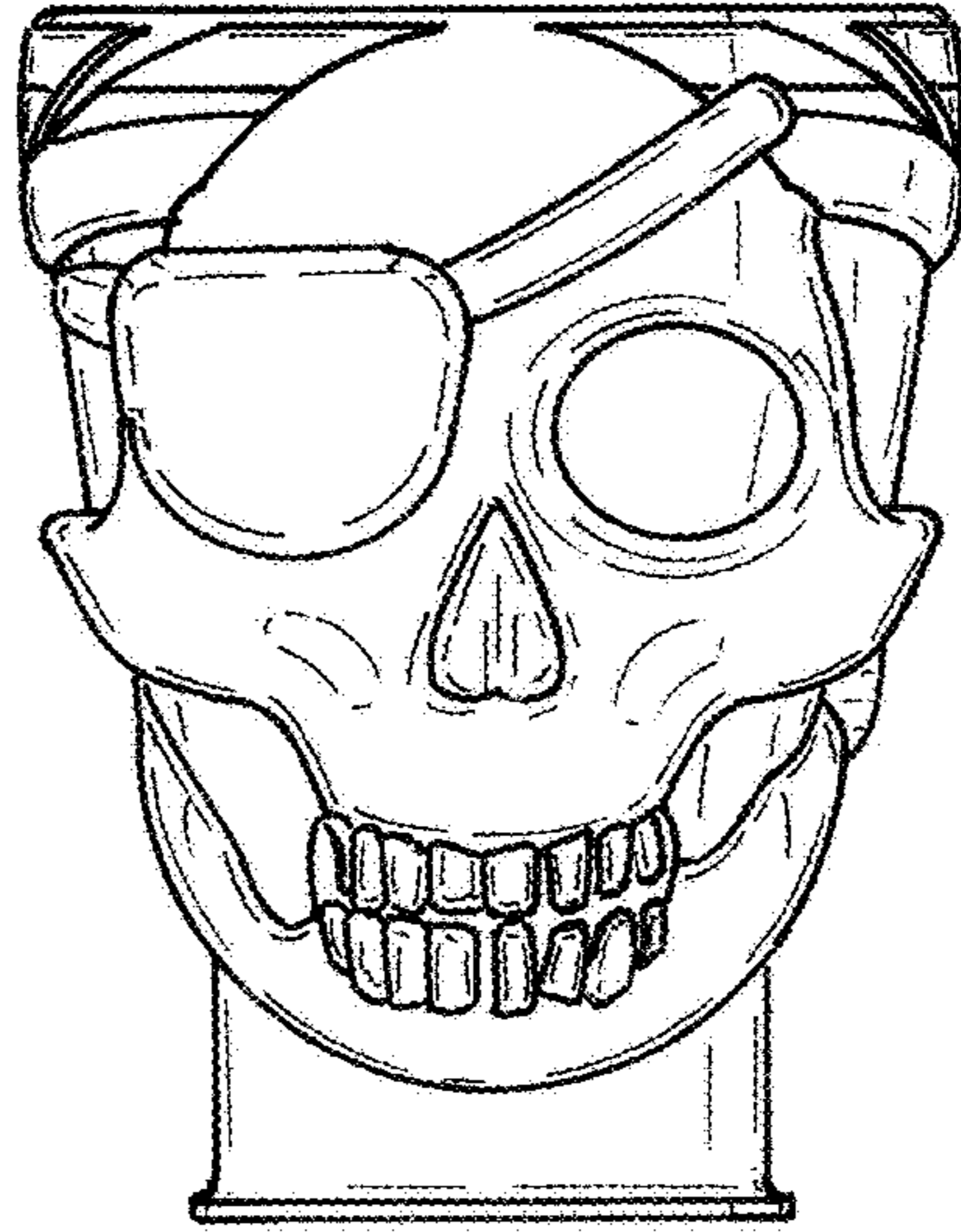

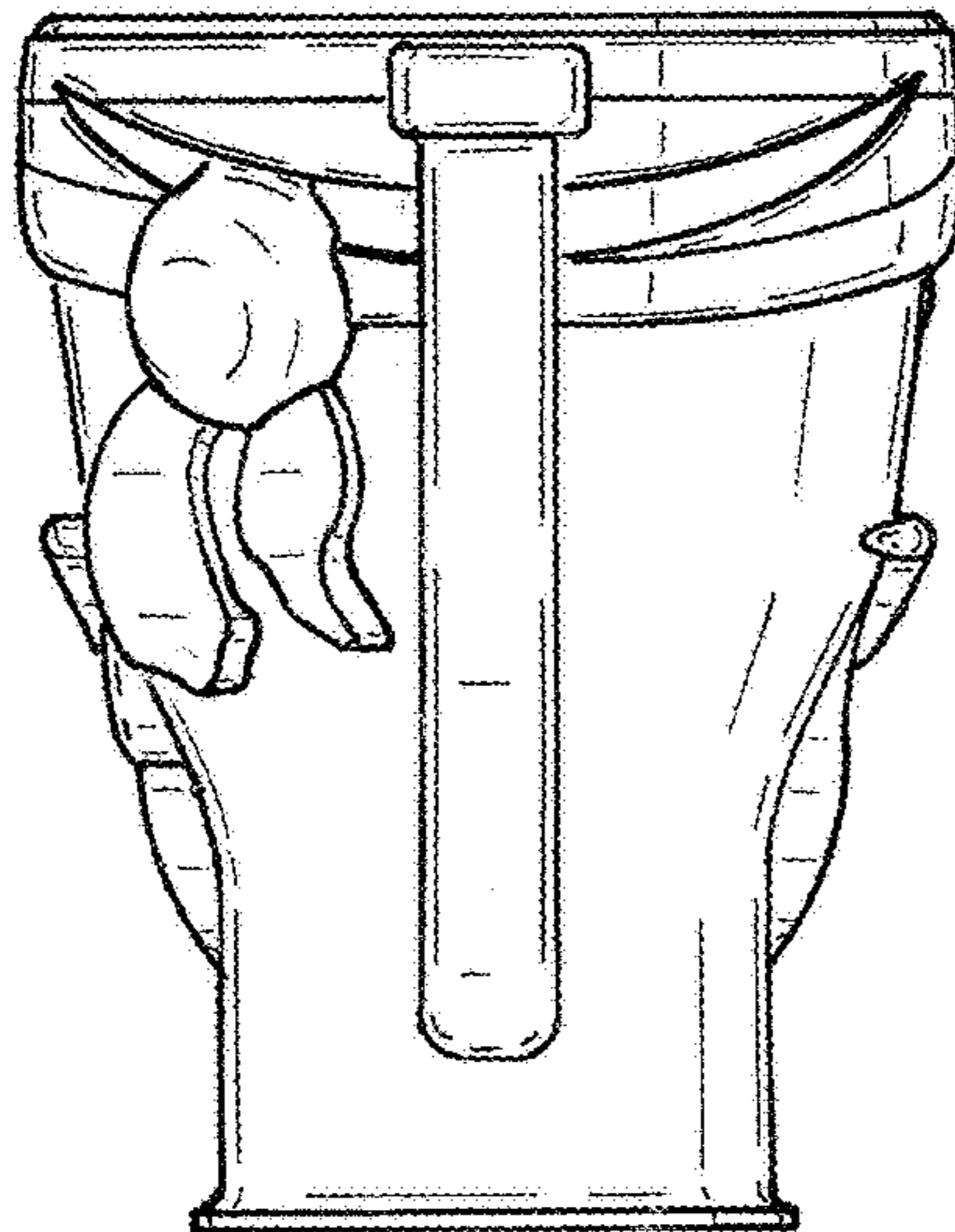

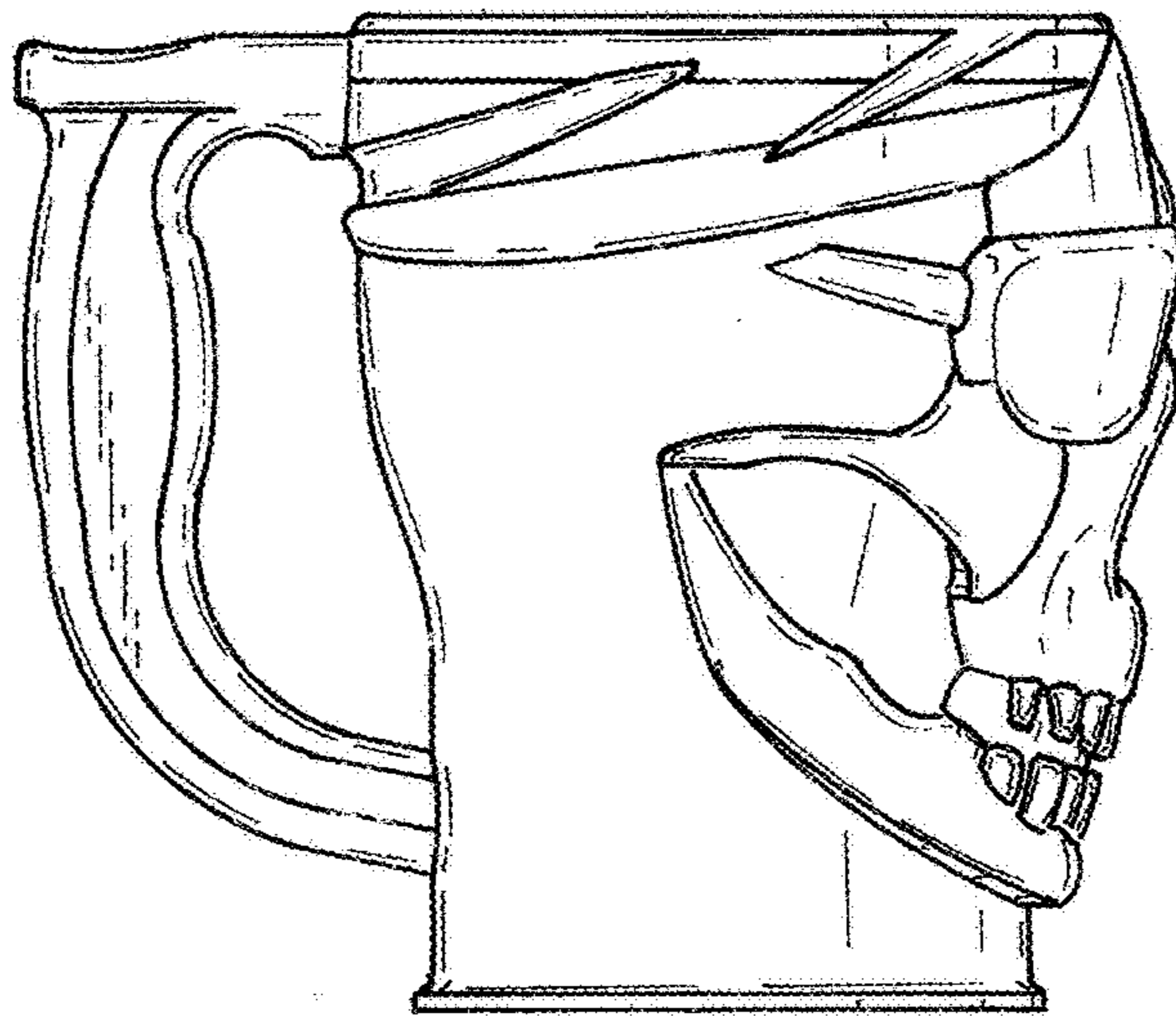
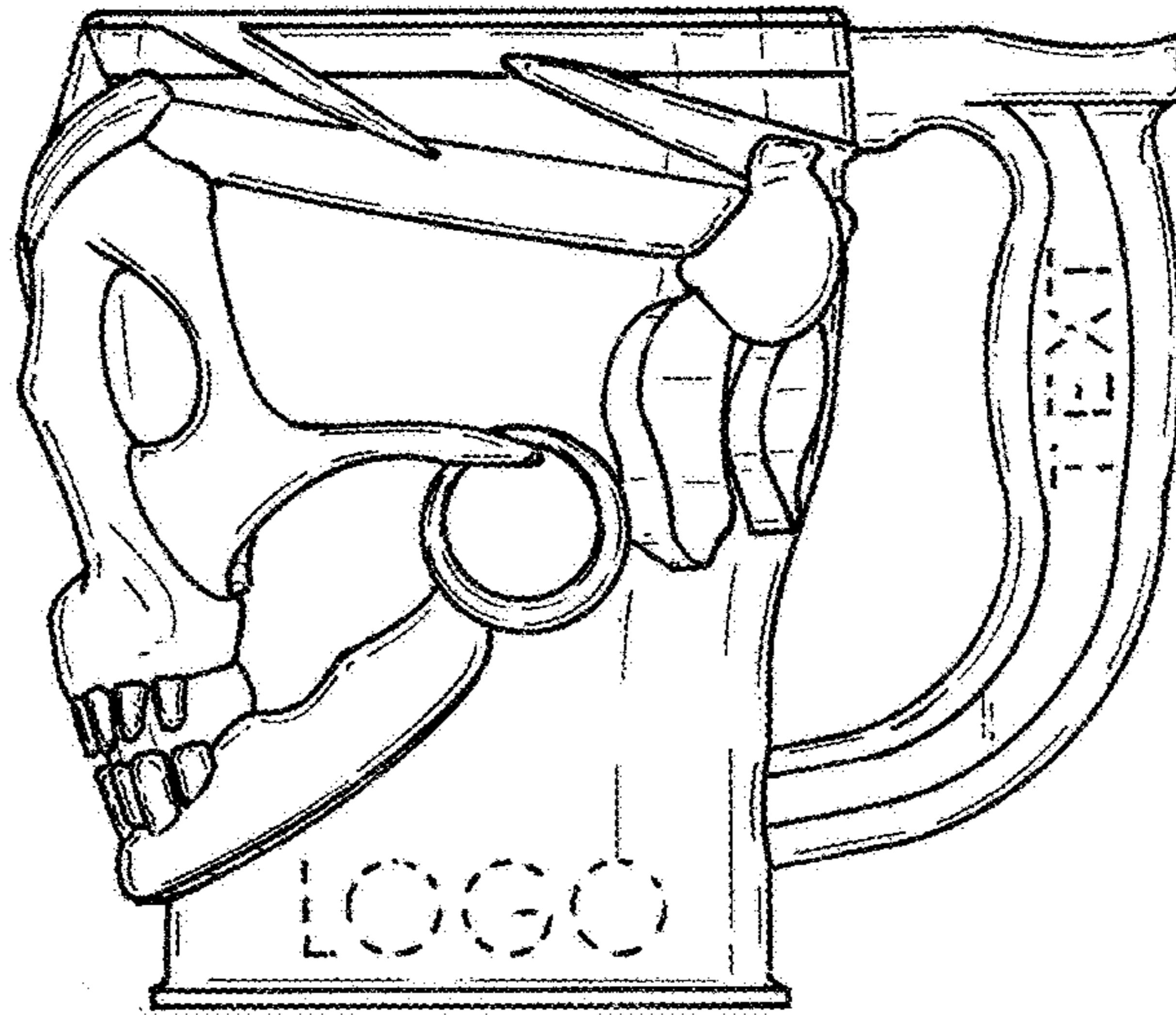

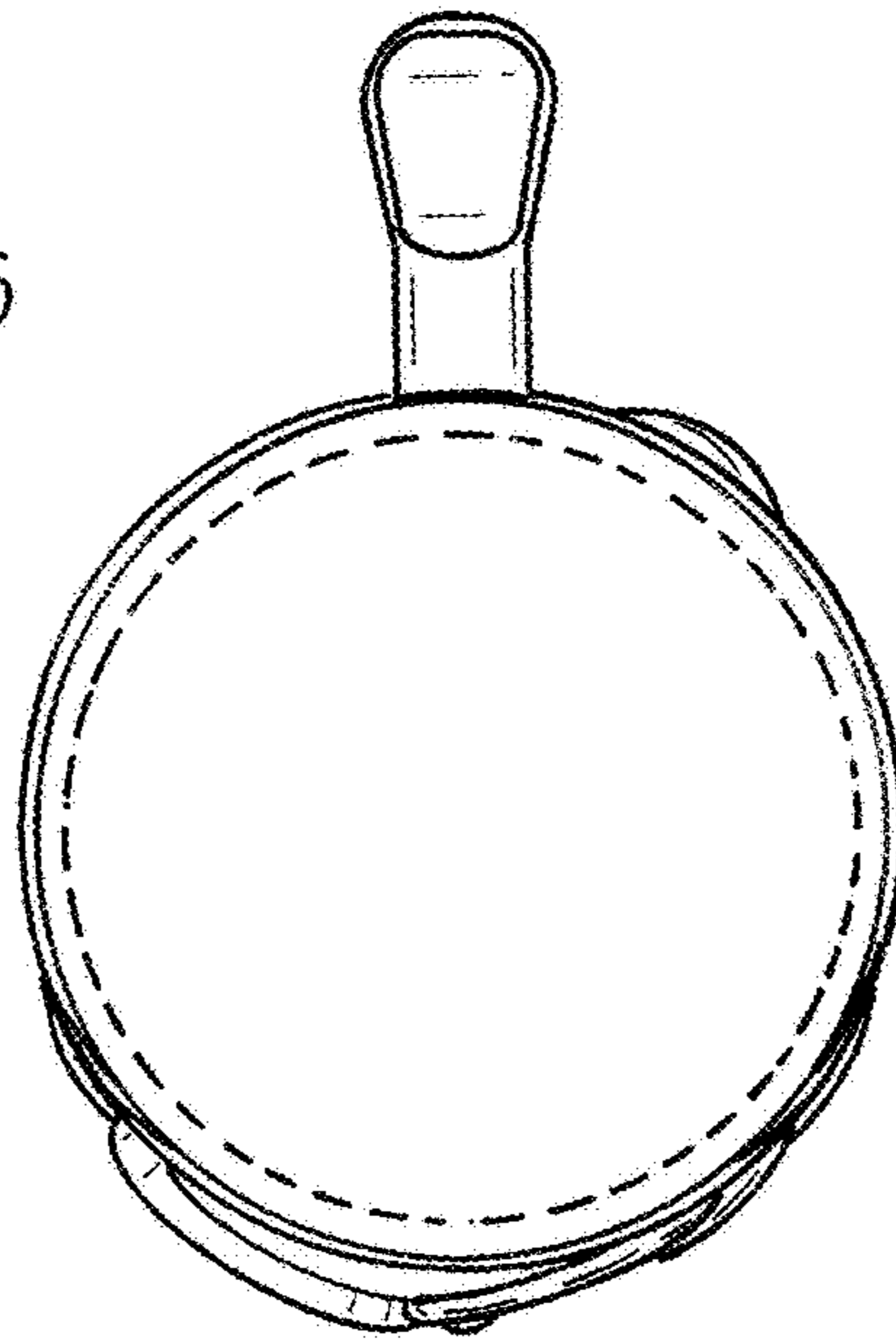
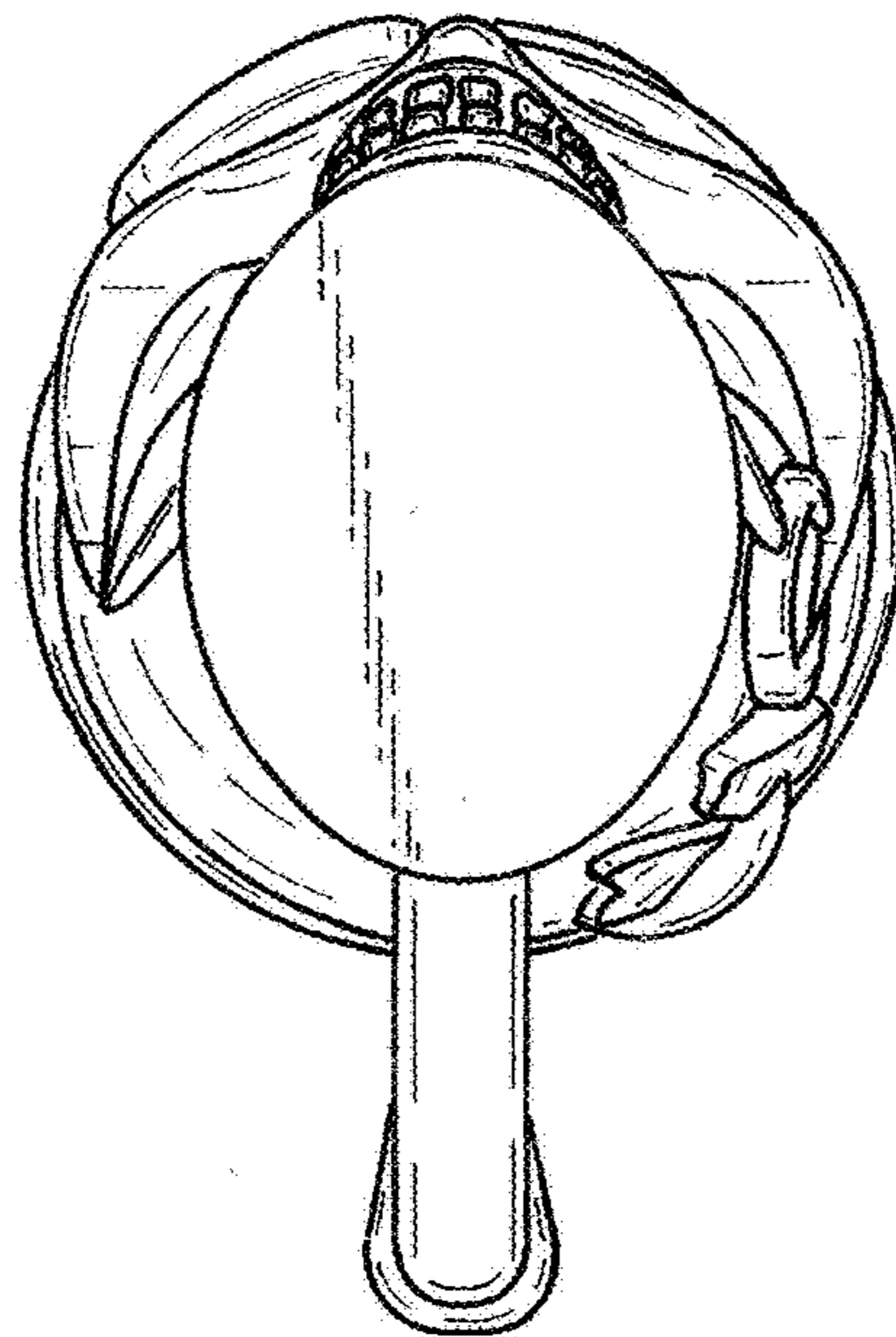

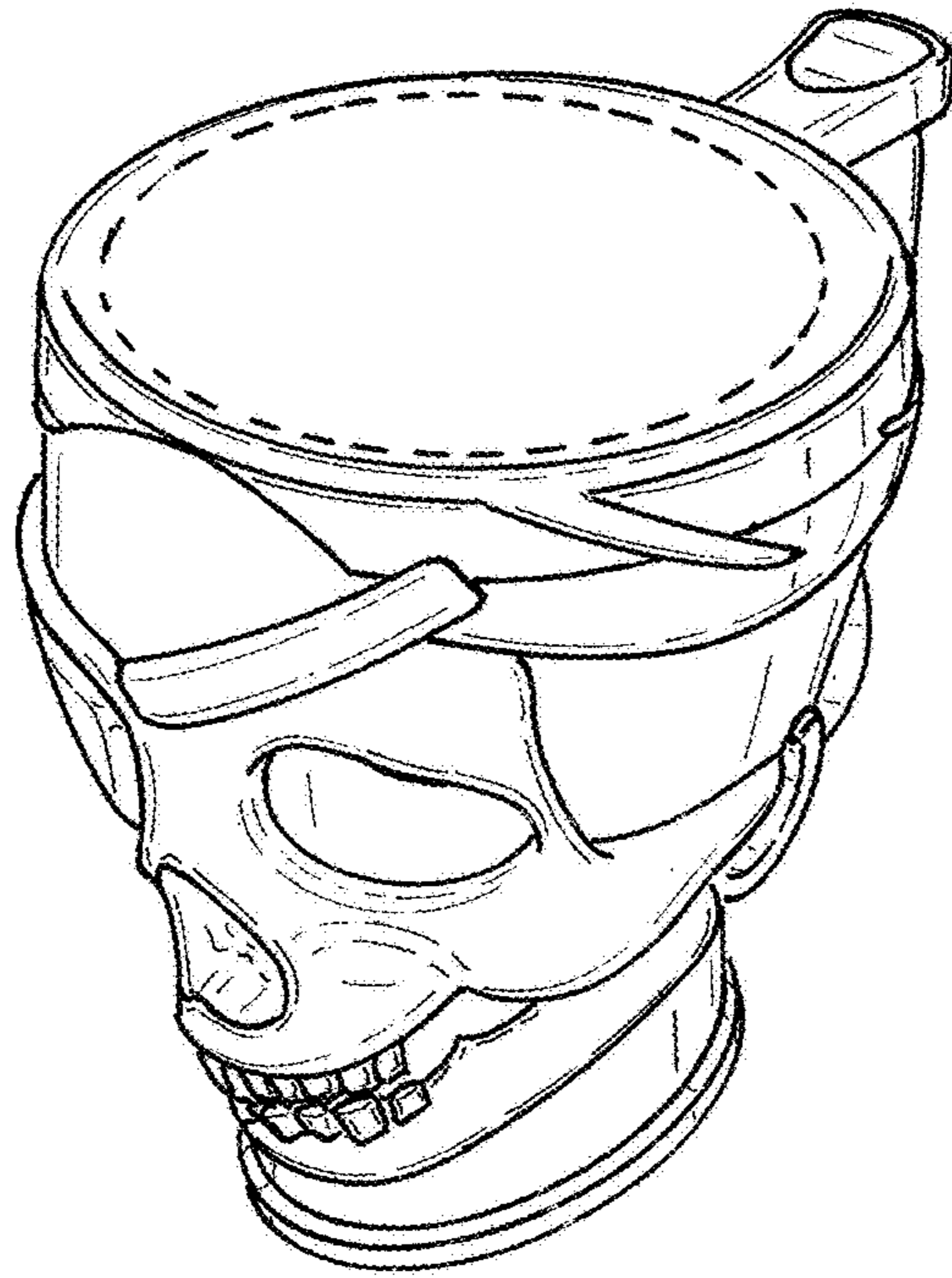
