(57) **CLAIM**

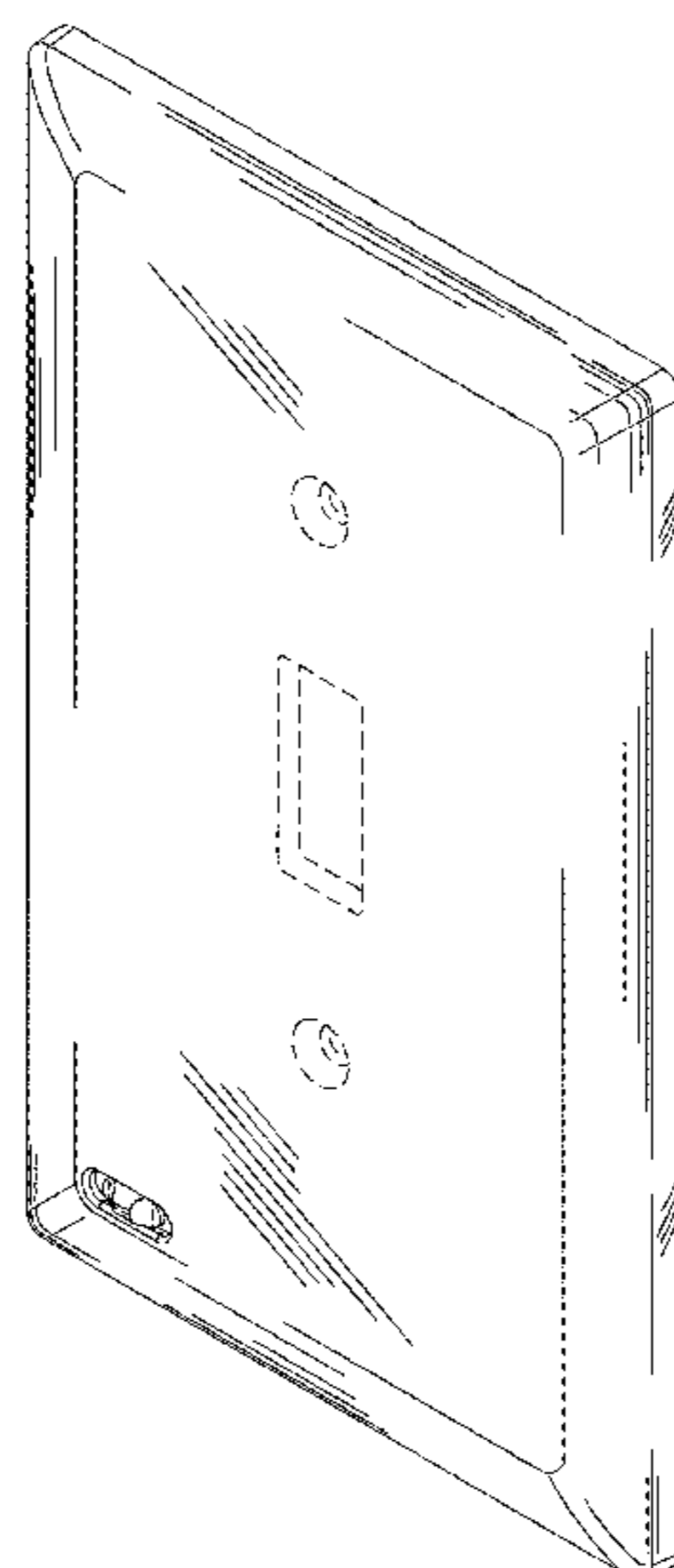
The ornamental design for a illuminated light switch plate, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective of an illuminated light switch plate showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom perspective view thereof; and,
FIG. 8 is a front perspective view of a second embodiment of an illuminated light switch plate.
The broken lines represent portions of the design that form no part of the claim. The back of the light switch guidelight is not visible during use and forms no part of the claimed design. Consequently, the back of the illuminated light switch plate is not illustrated.

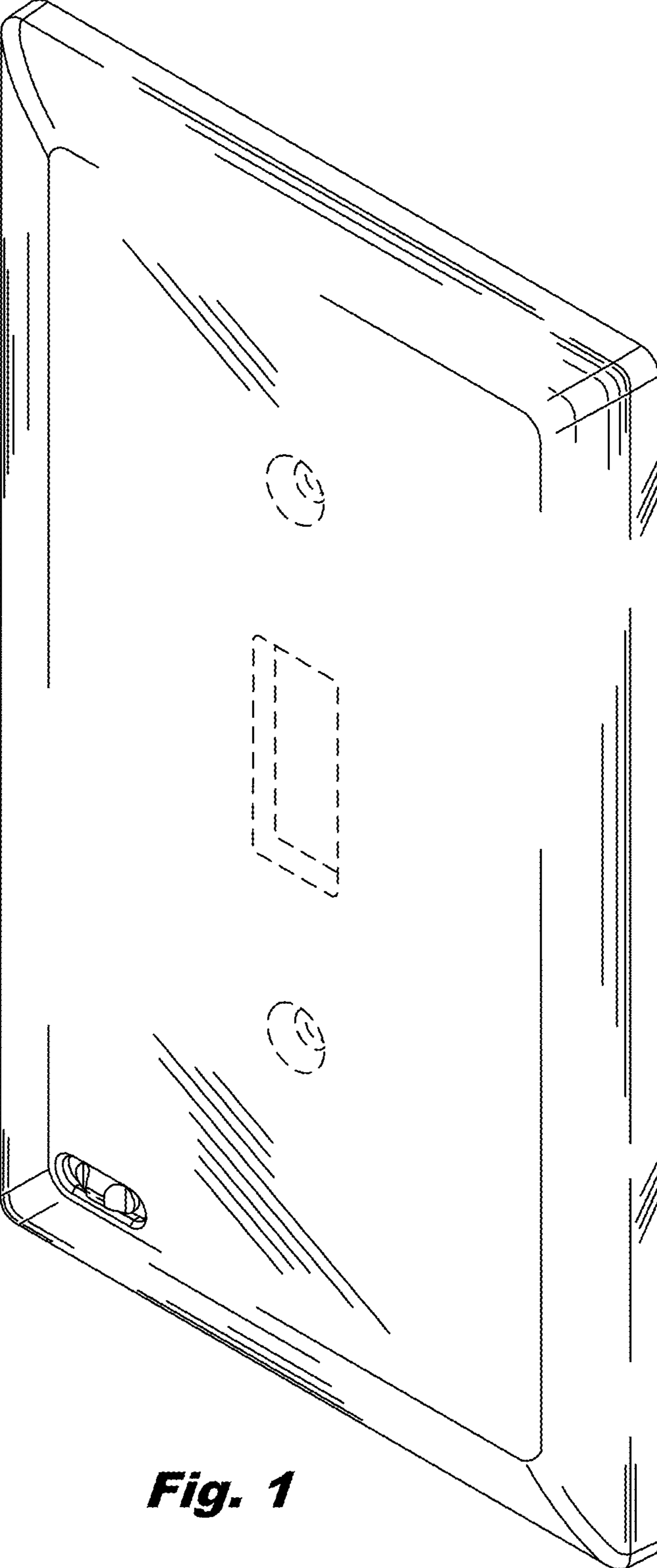

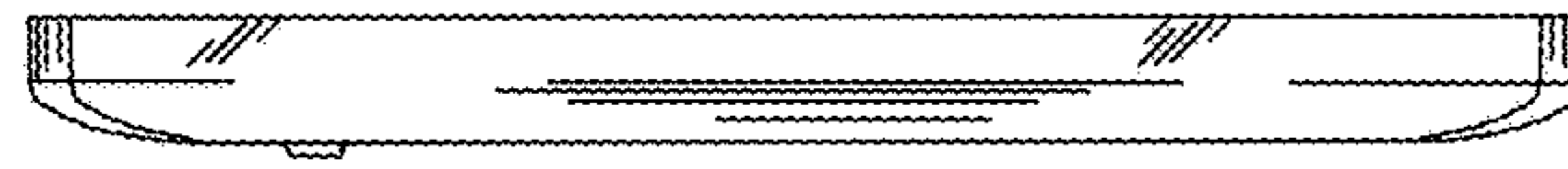

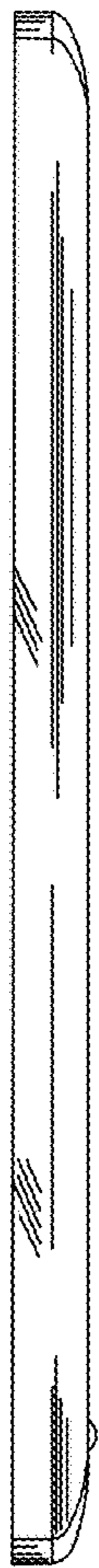

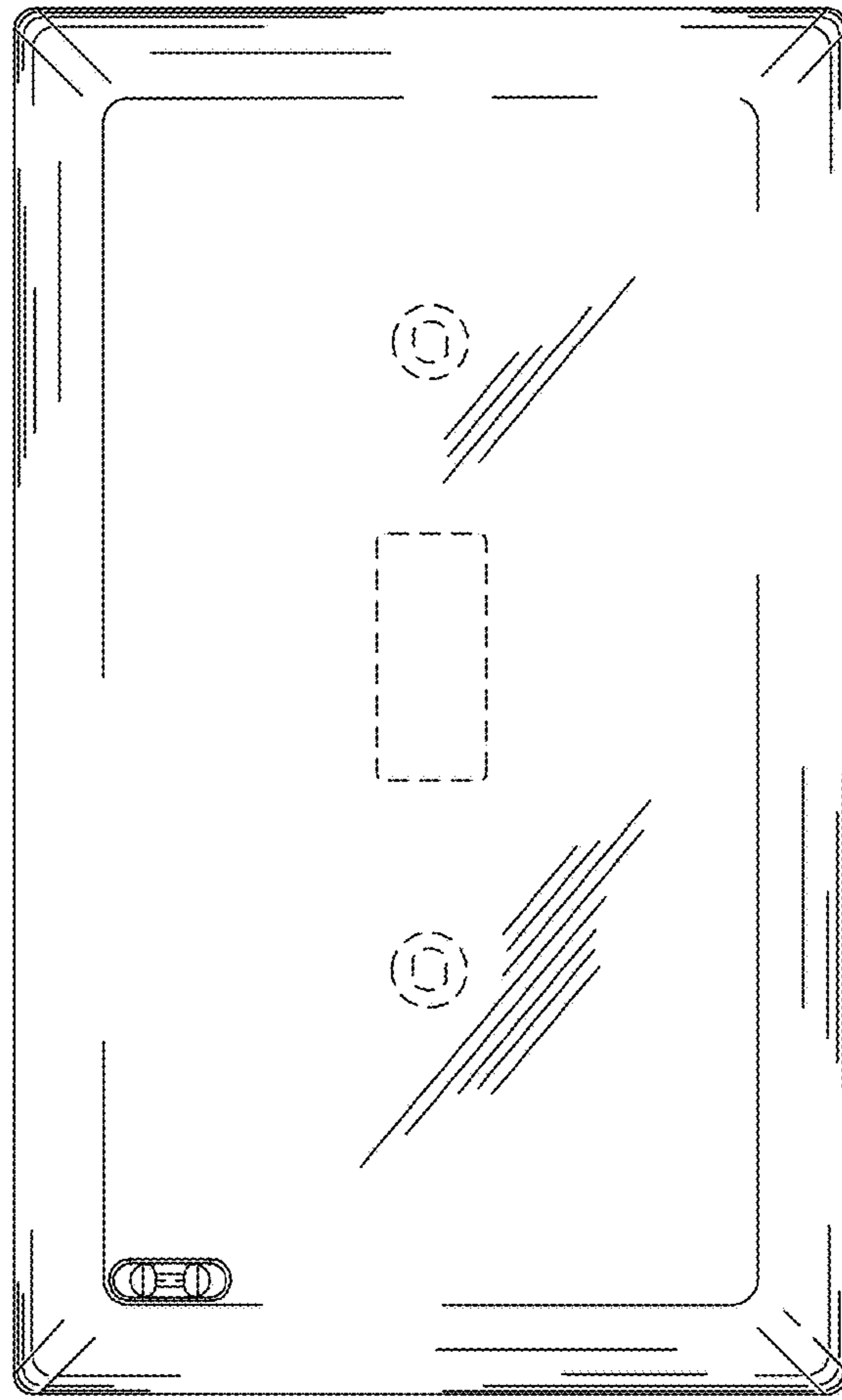

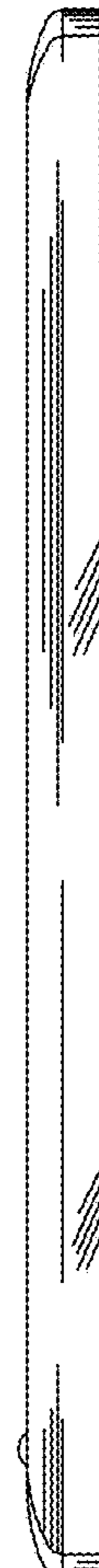

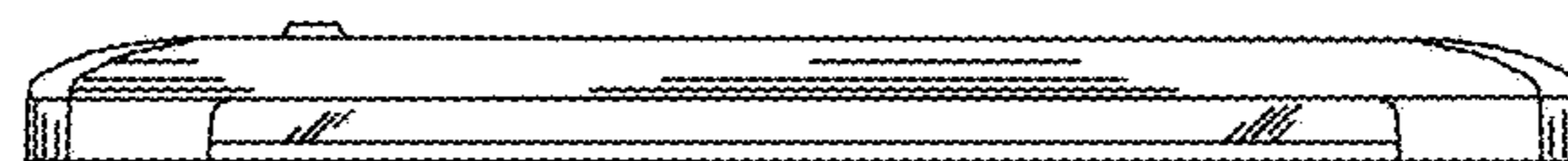

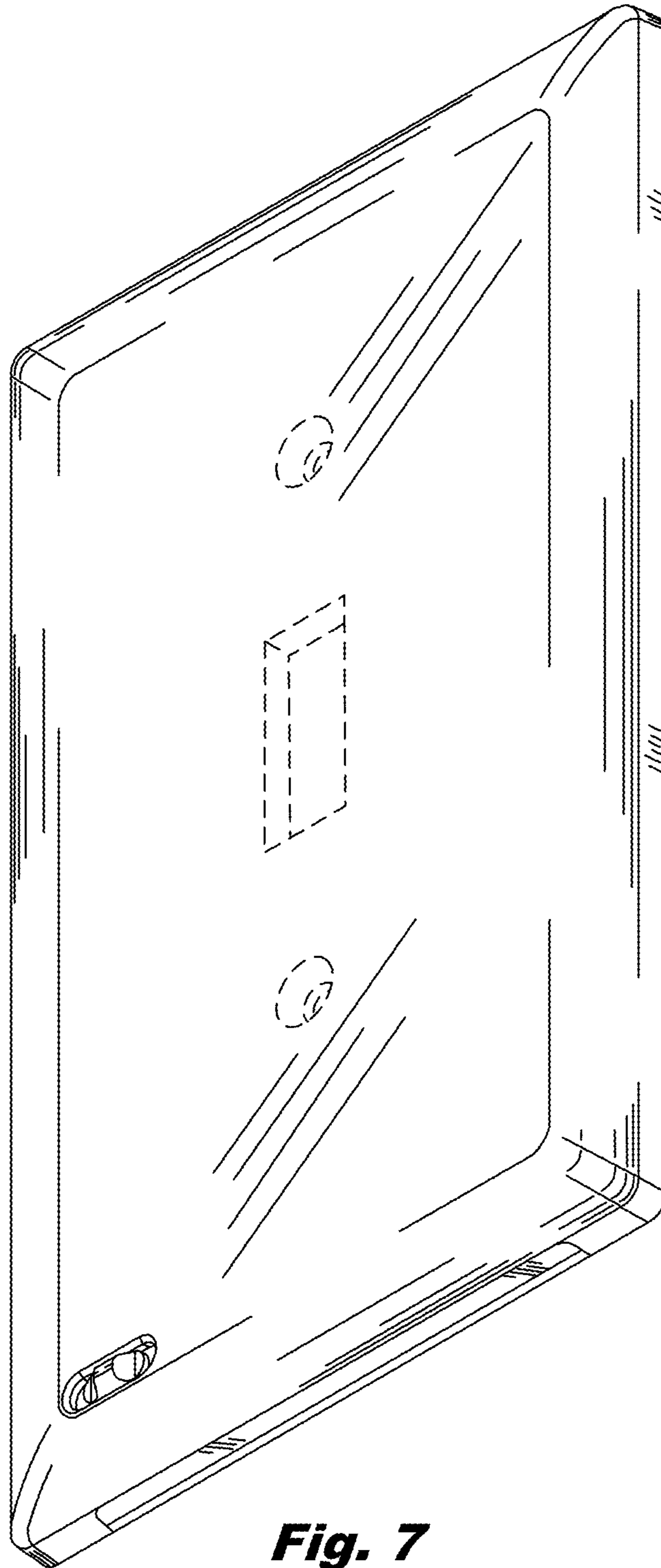

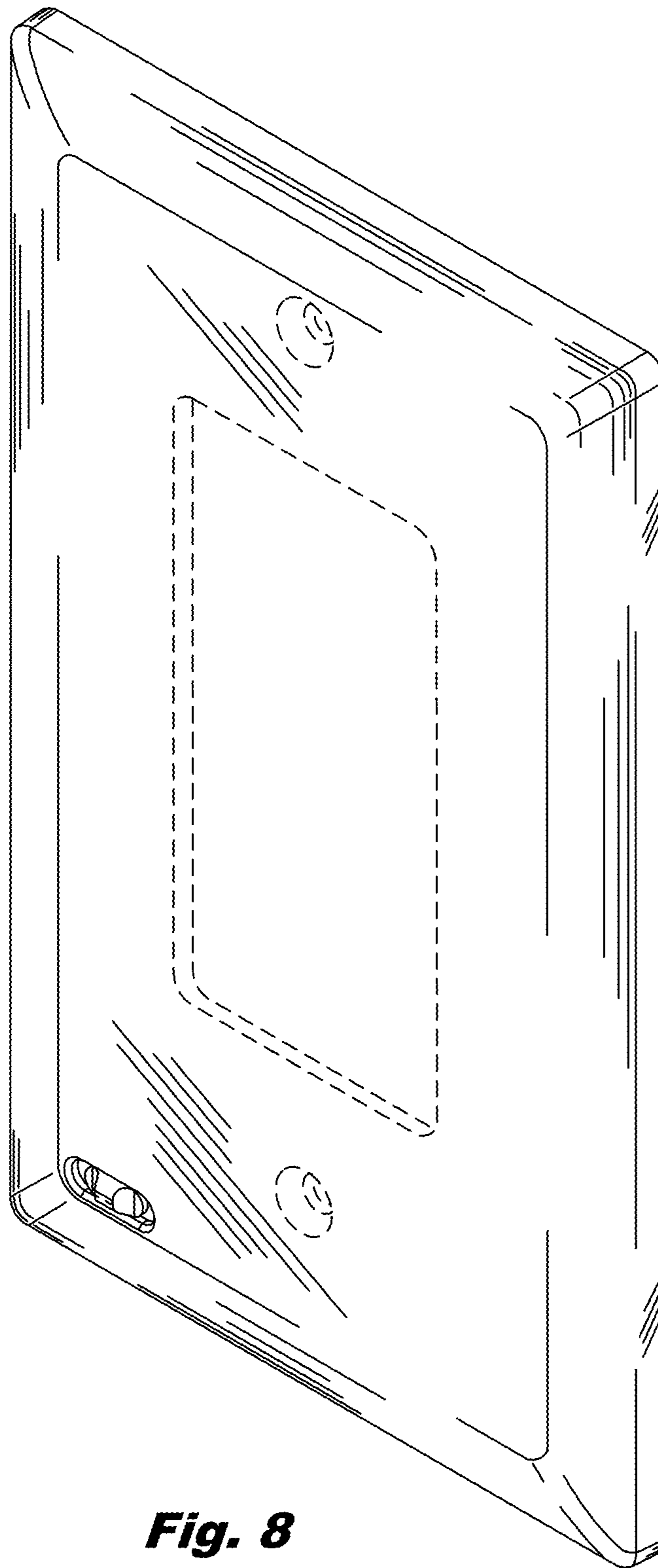
