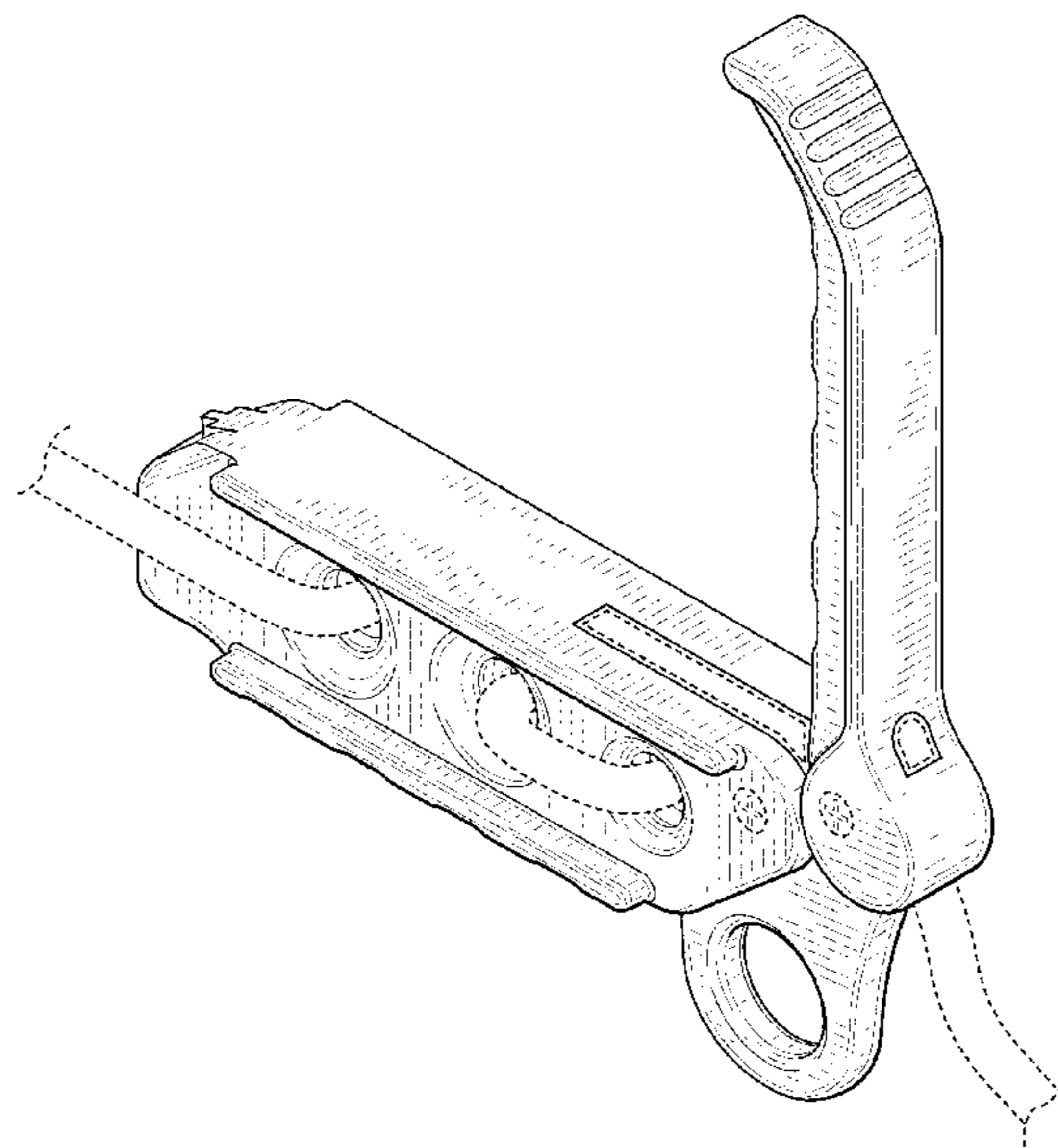
(57) **CLAIM**

The ornamental design for a descent device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the descent device in a closed position;
FIG. 2 is a top down view of the descent device of FIG. 1;
FIG. 3 is a bottom up view of the descent device of FIG. 1;
FIG. 4 is a broad side view of the descent device of FIG. 1;
FIG. 5 is a narrow side view of the descent device of FIG. 1;
FIG. 6 is a narrow side view of the descent device of FIG. 1, showing the narrow side opposite the side shown in FIG. 5; and,
FIG. 7 is a perspective view of the descent device of FIG. 1 in an open position, and shown with a rope passing through the descent device.
The broken lines shown represent unclaimed subject matter and form no part of the claimed design.

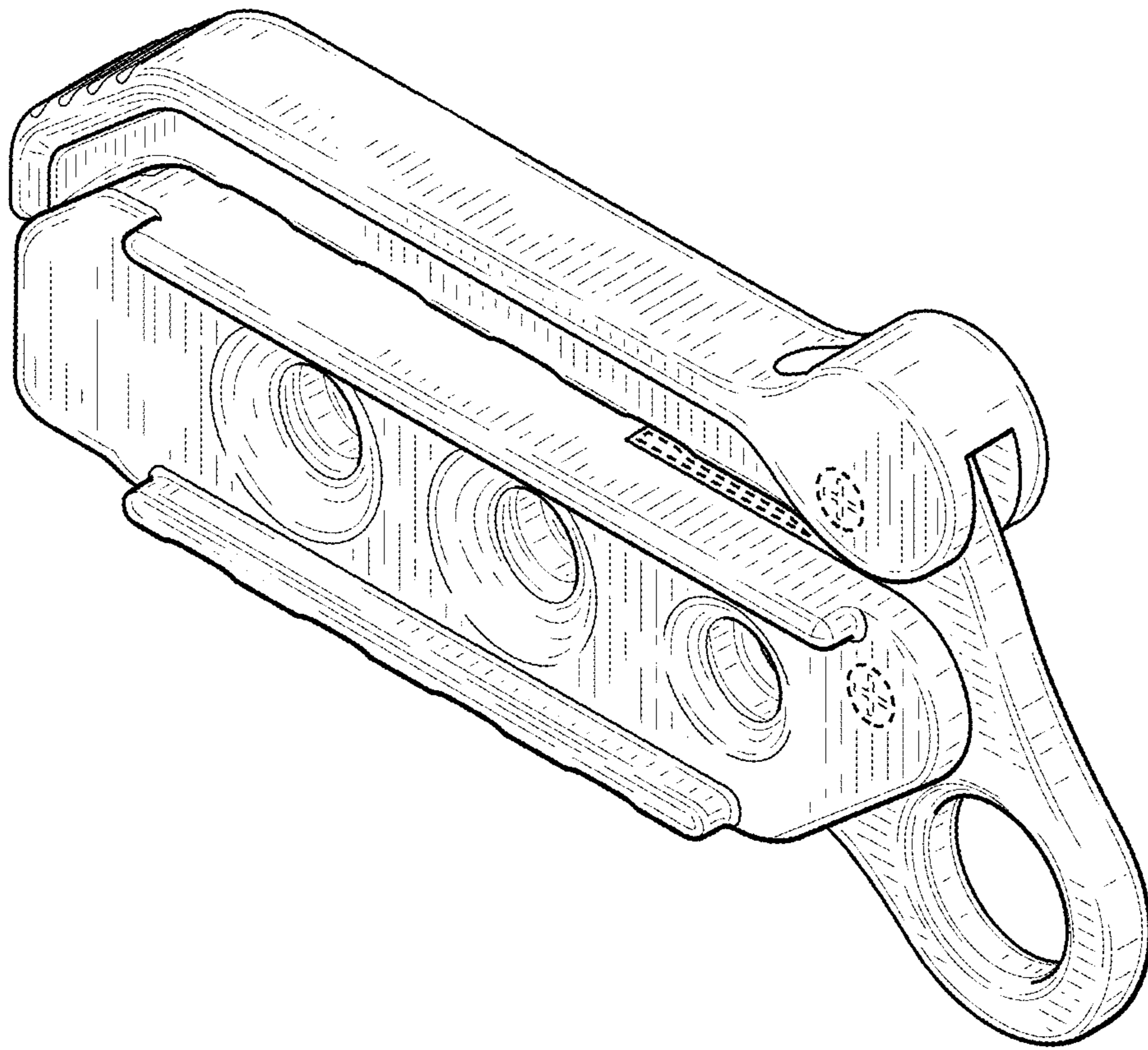

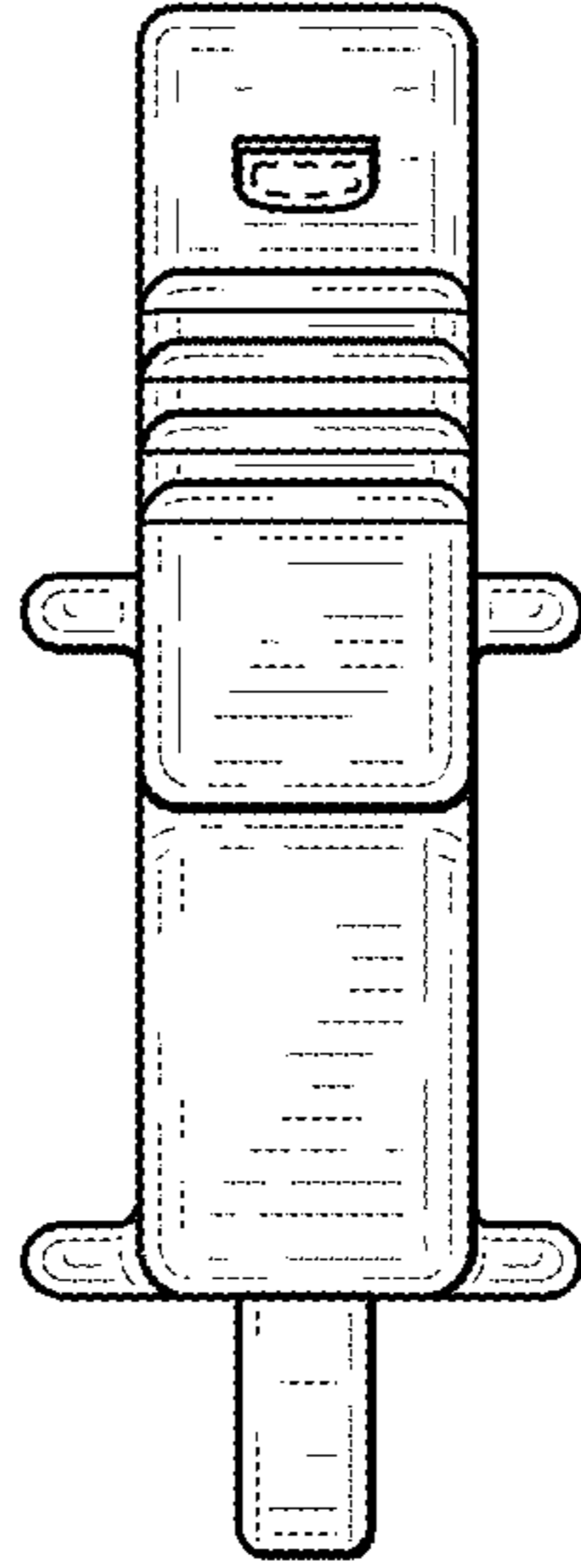

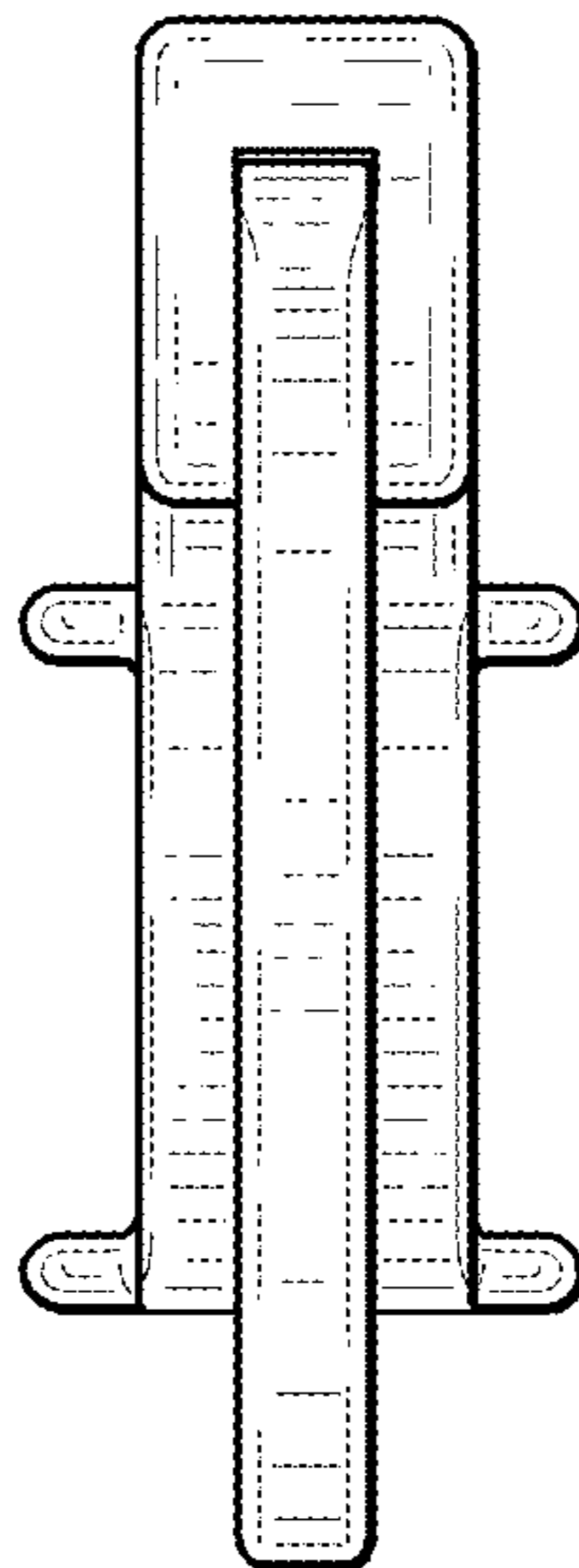

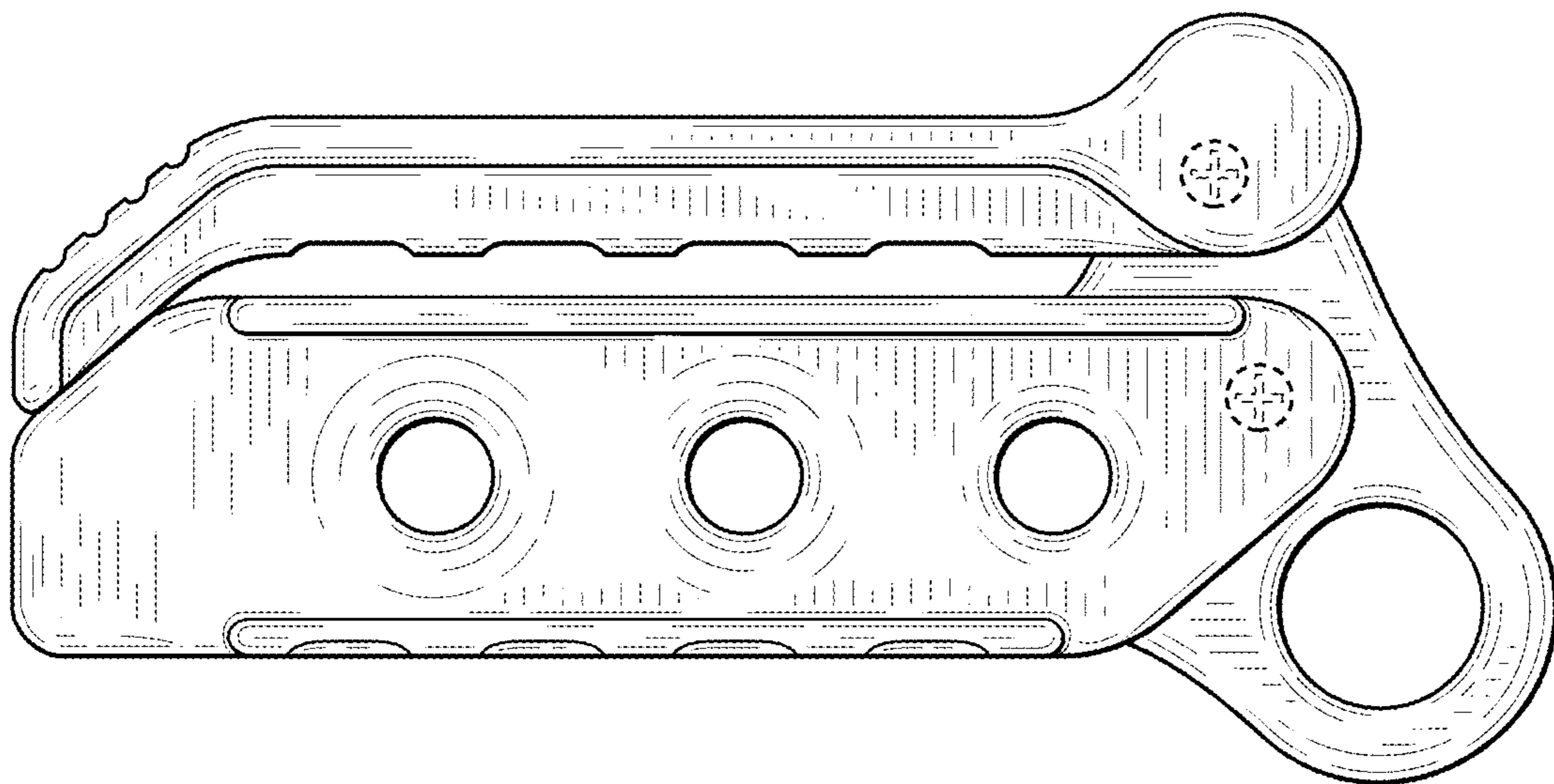

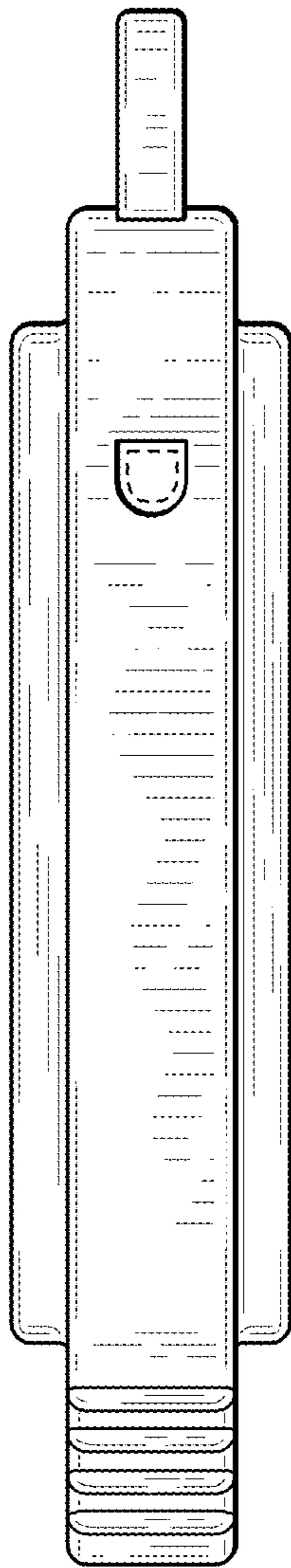

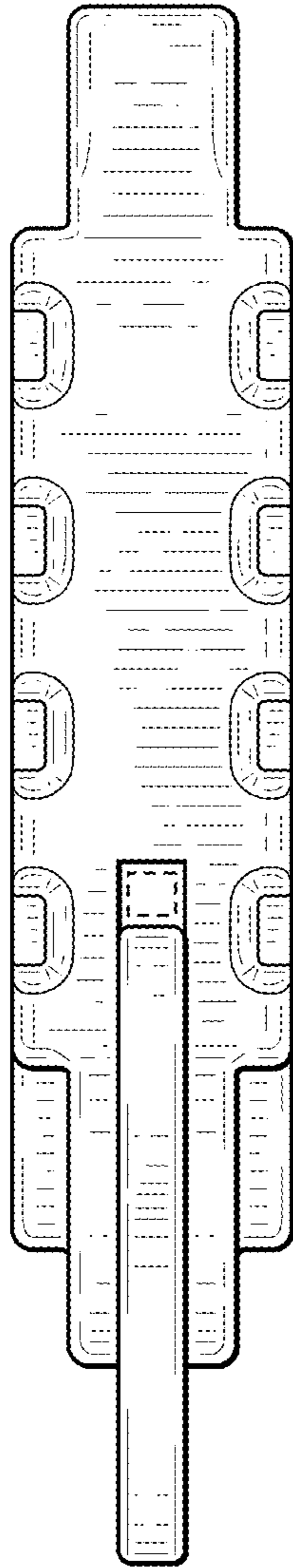

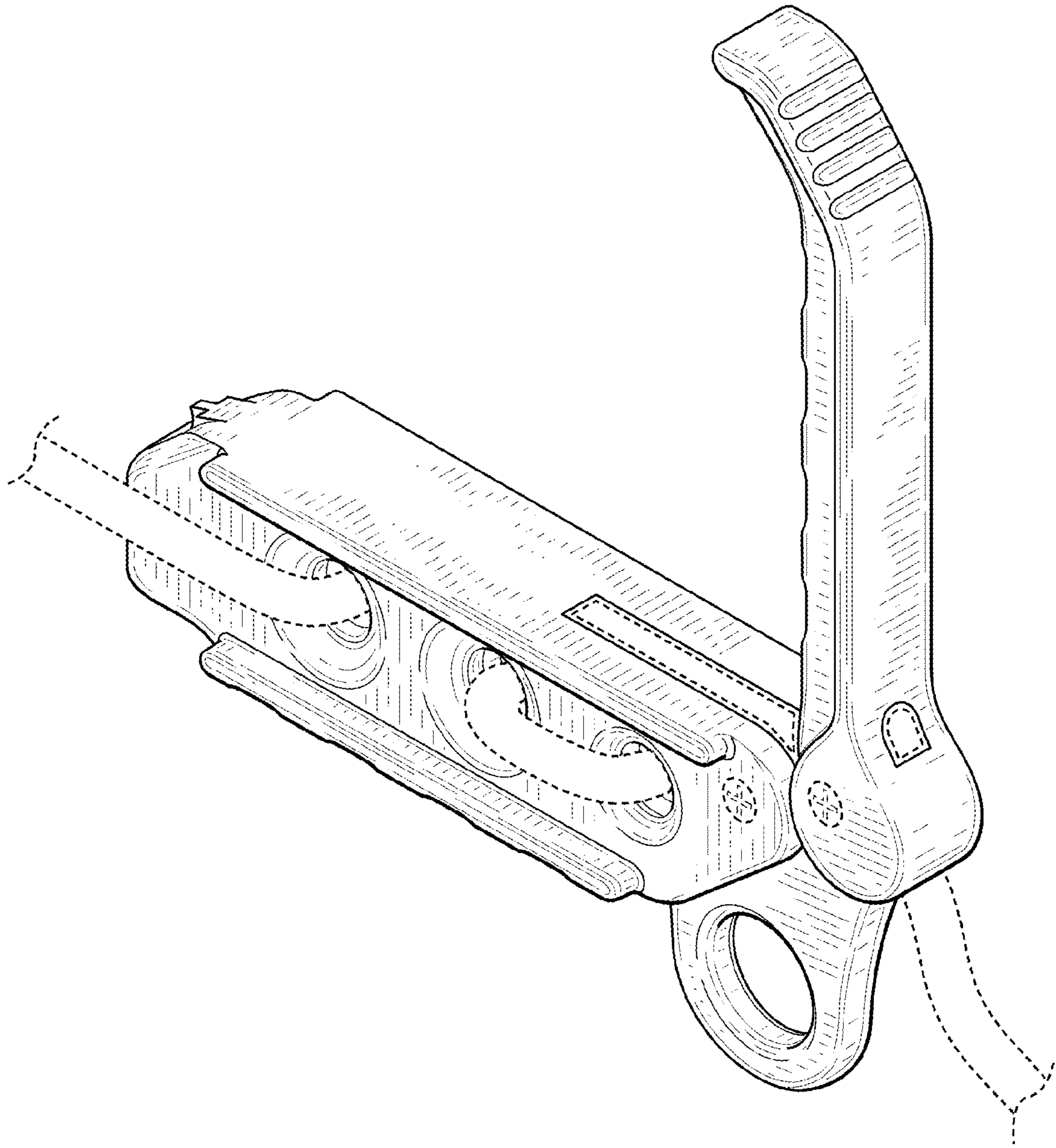
