The ornamental design for a packaging film, as shown and
described.

DESCRIPTION

FIG. 1 is a perspective view of a packaging film, showing
our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a top view thereof;

FIG. 5 is a bottom view thereof;

FIG. 6 is a left side view thereof;

FIG. 7 is a right side view thereof; and,

FIG. 8 is a reference perspective view showing a usage state
thereof, shown for clarity of disclosure.

The packaging film according to the present design appli-
cation is fully transparent and is able to surround plural
magnetic tape cartridges as one package with a rear label
side being exposed. The broken lines represent environment
and form no part of the claimed design.

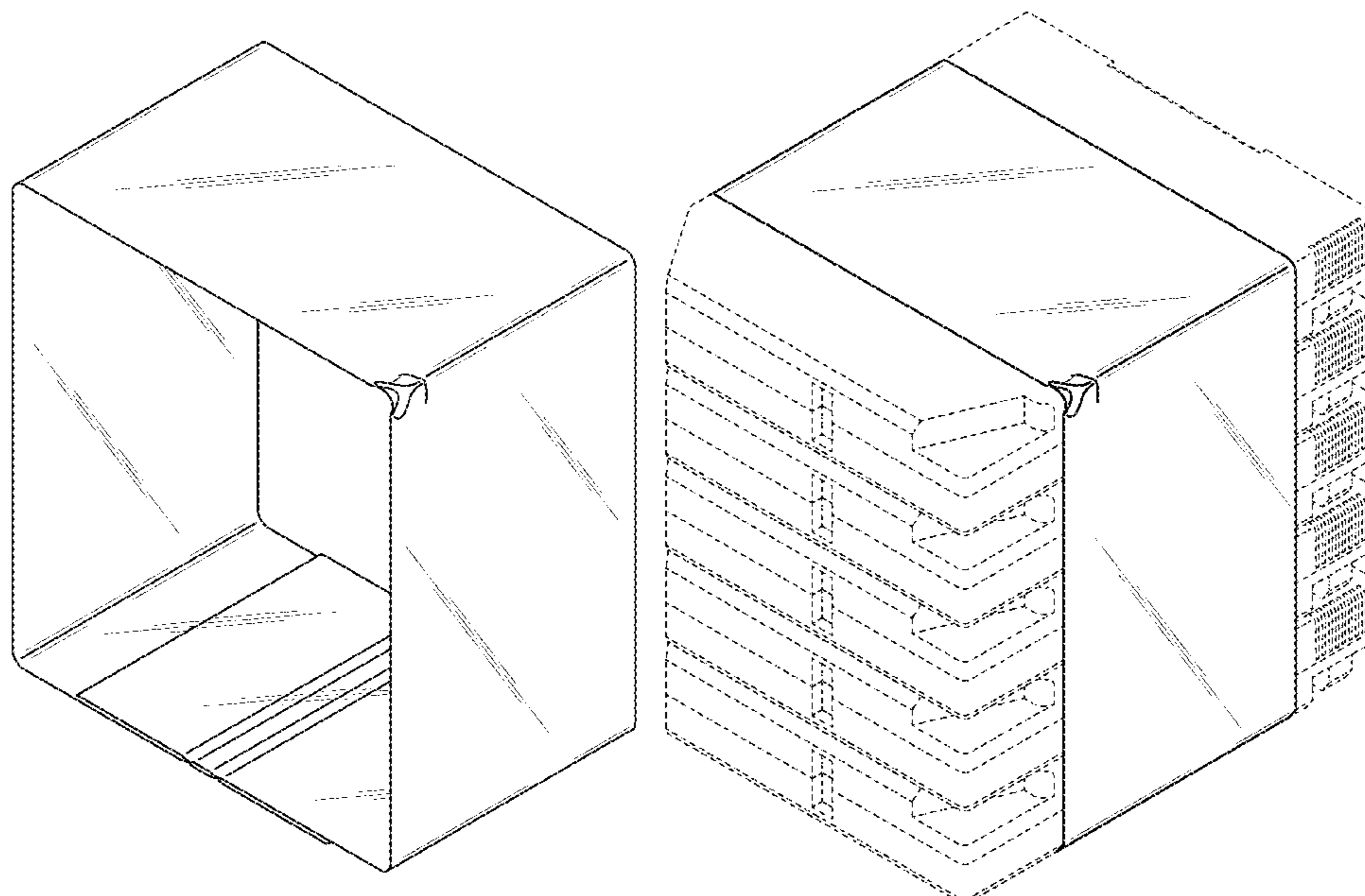

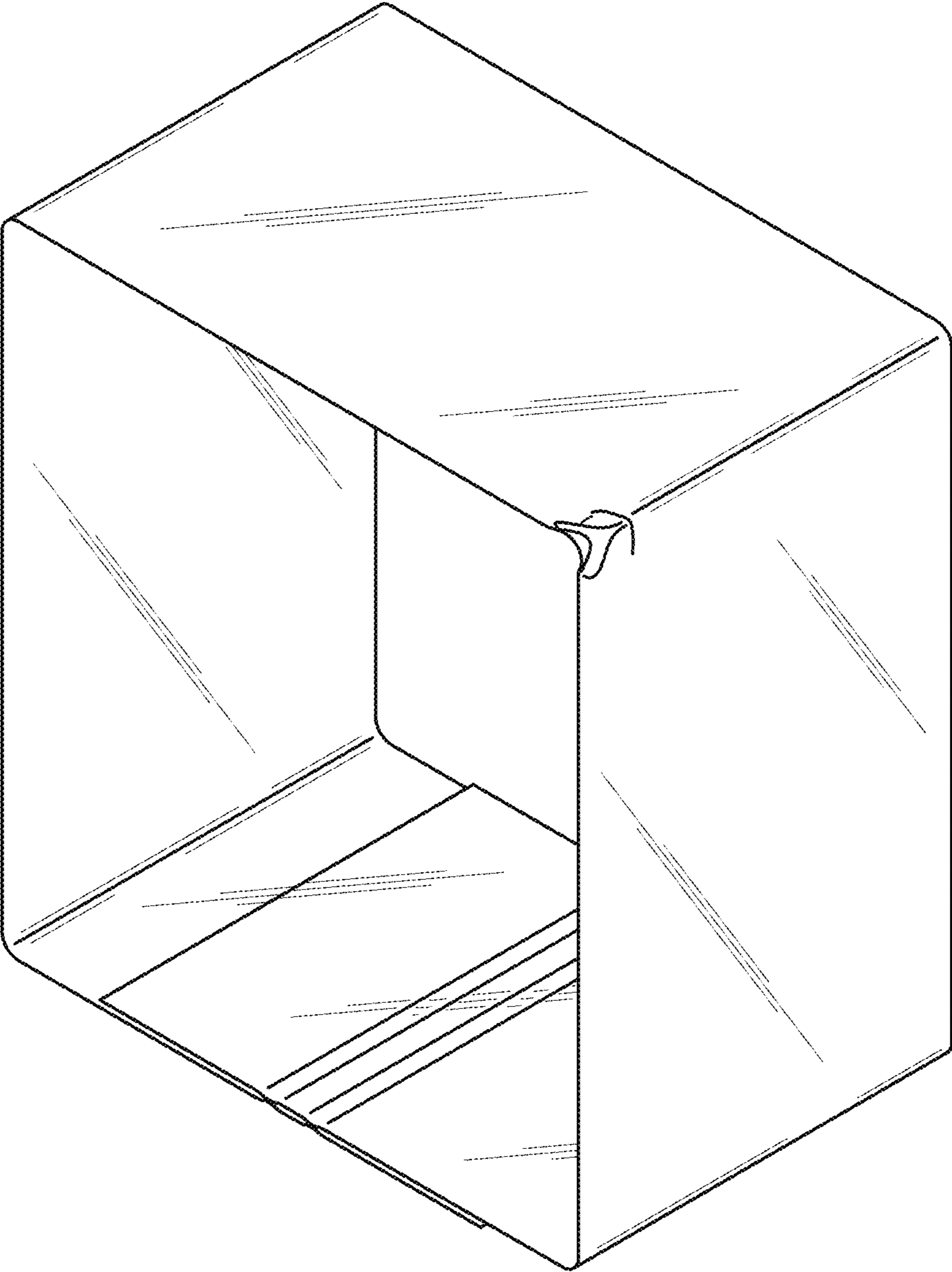

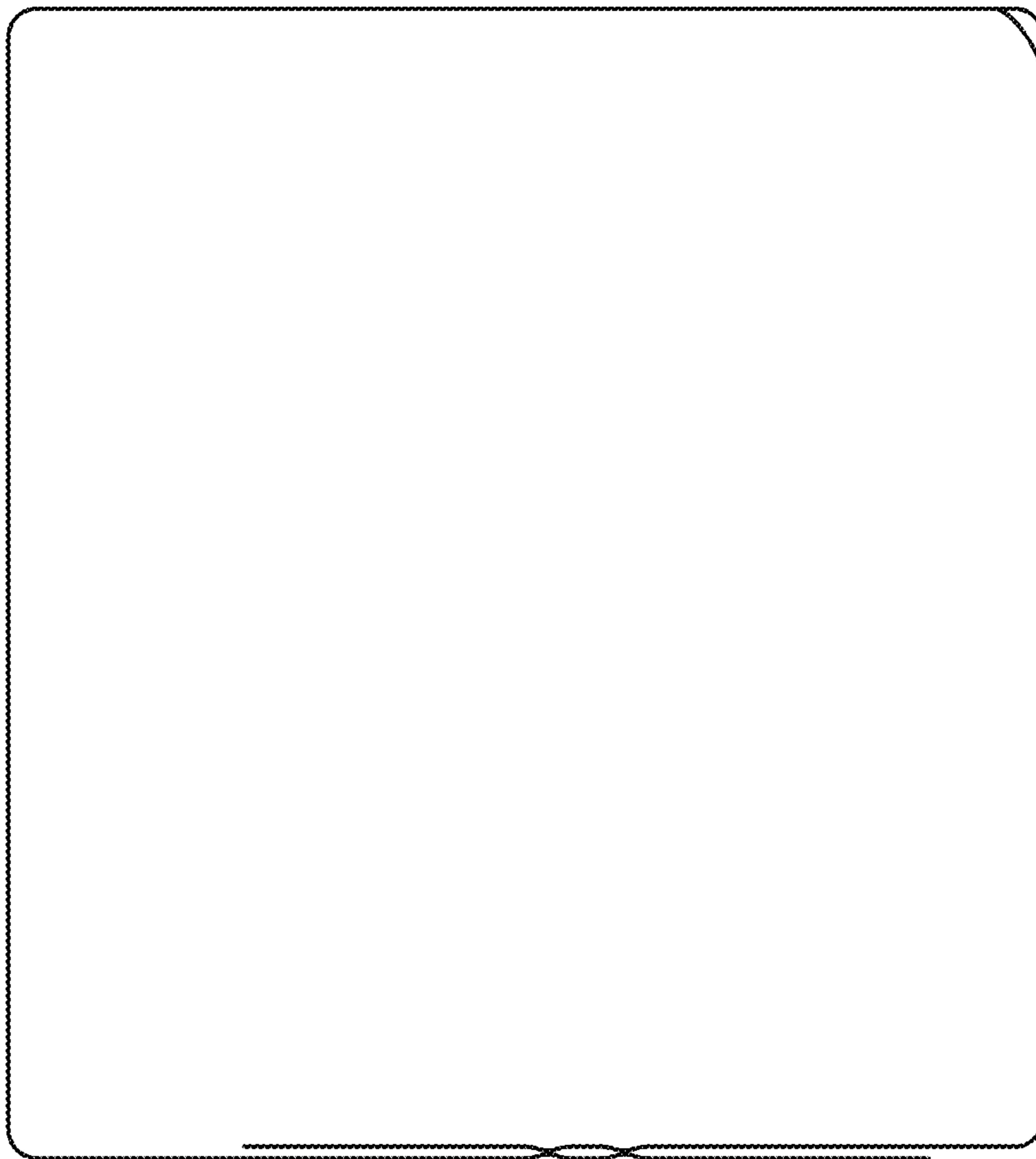

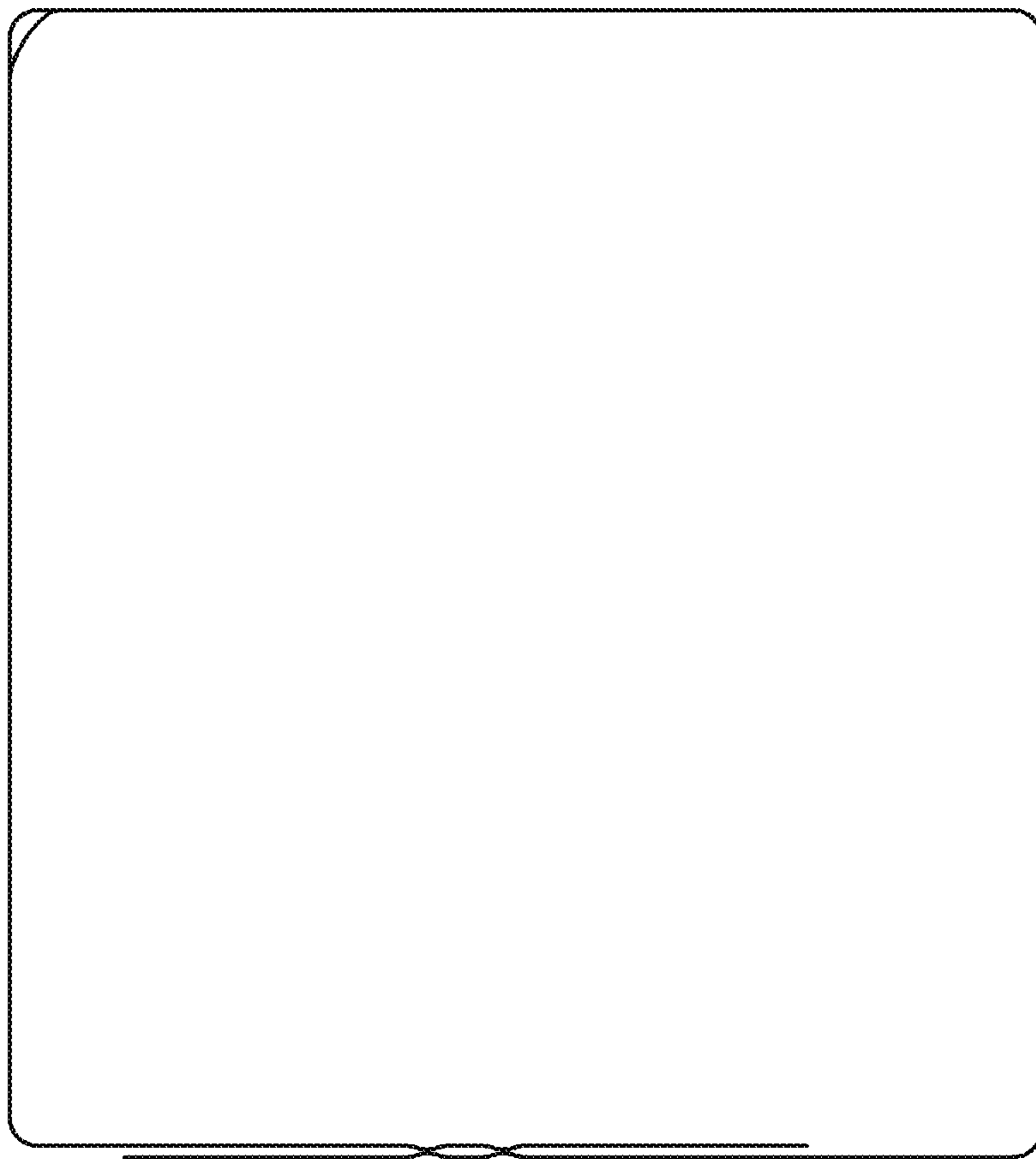

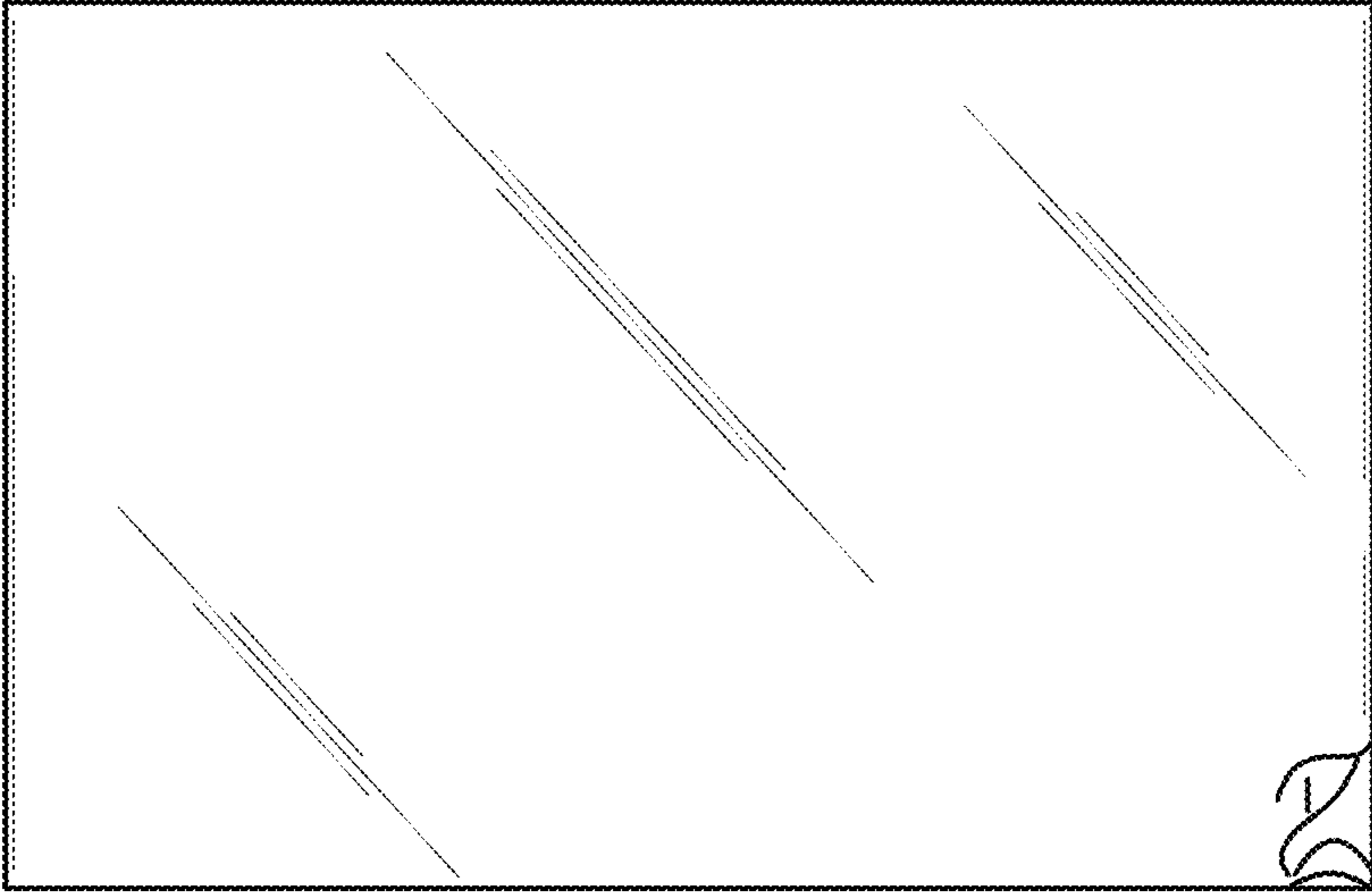

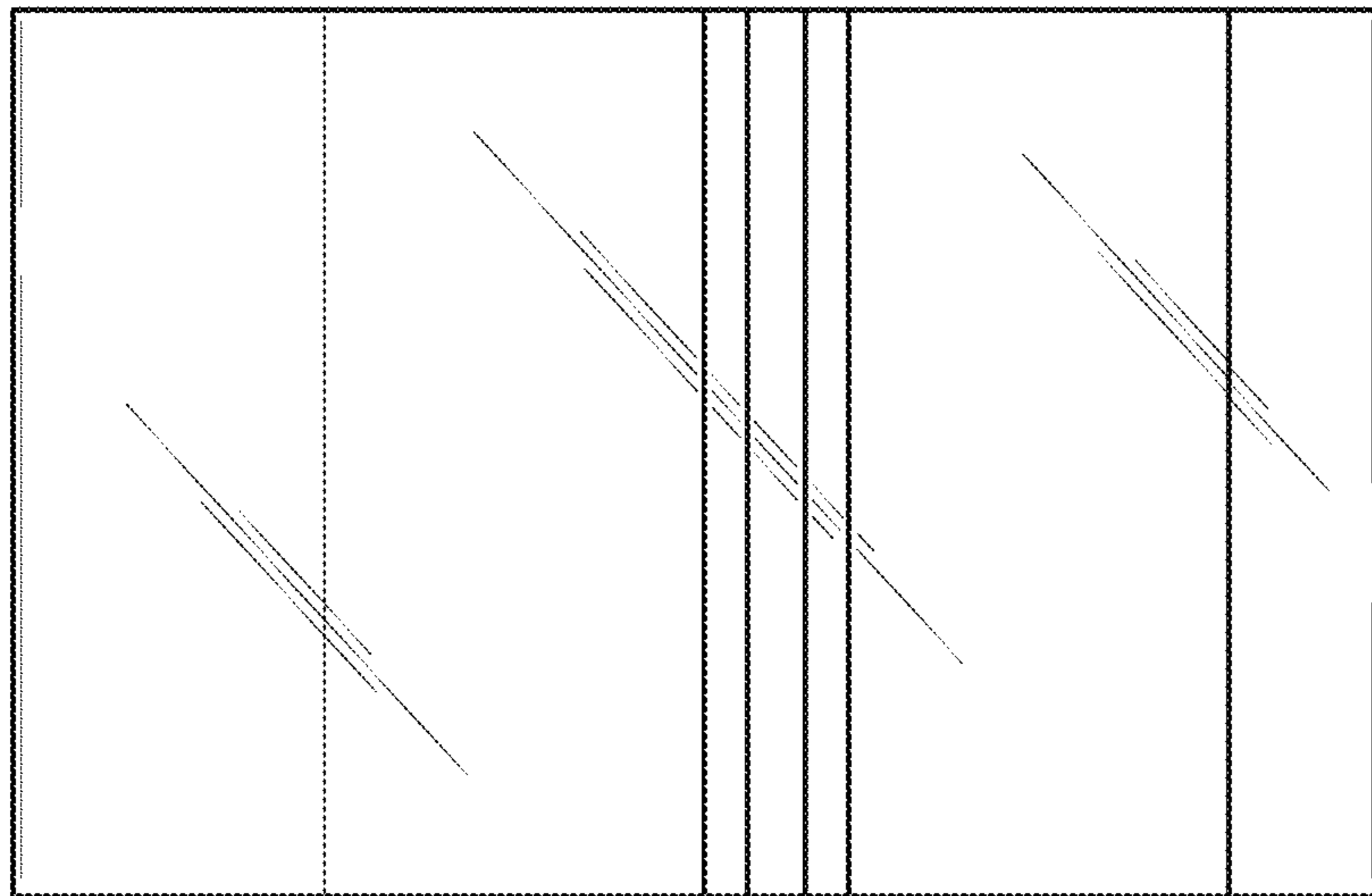

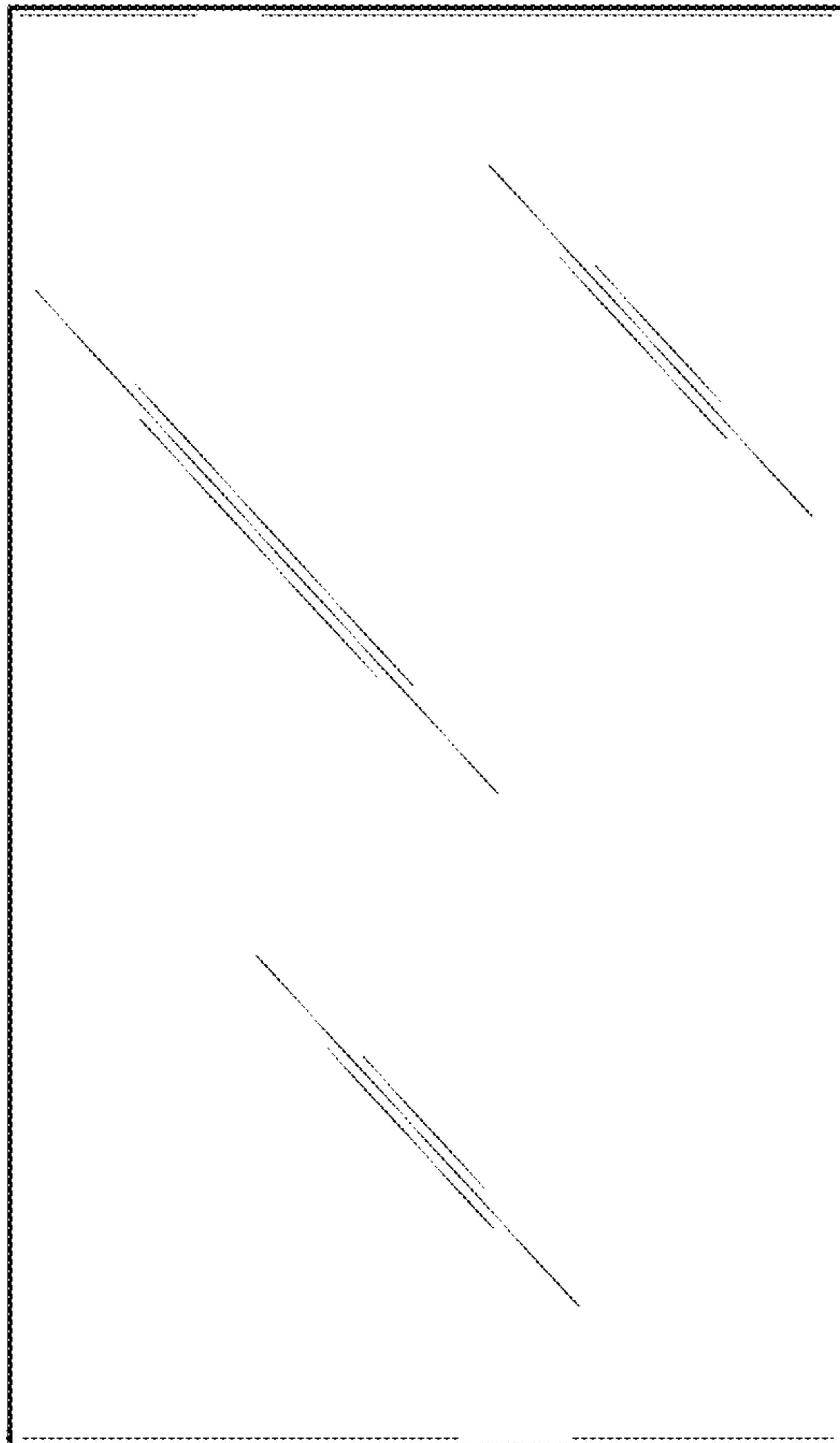

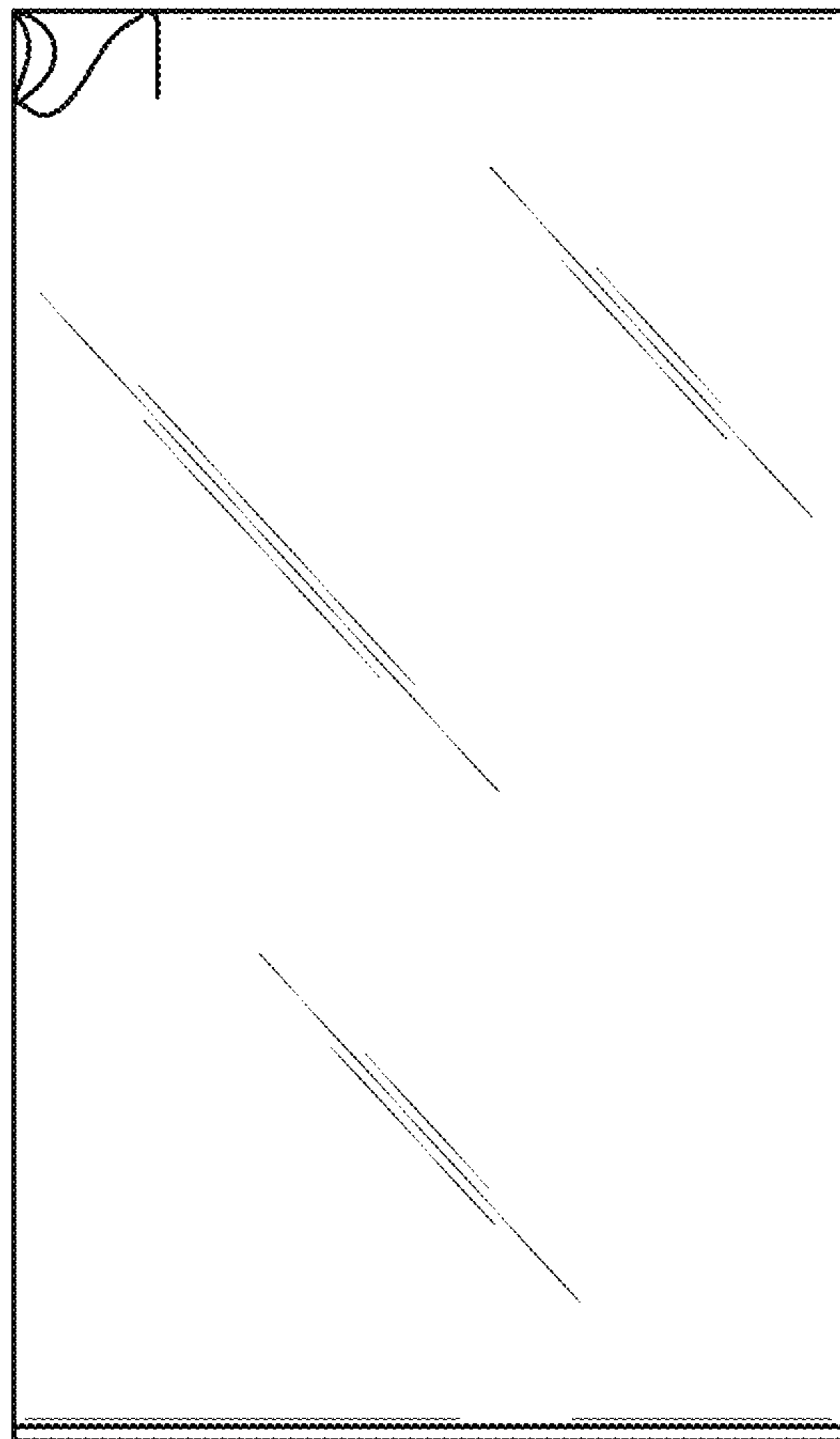
