The ornamental design for a clip mechanism, as shown and described herein.

DESCRIPTION

FIG. 1 is a top perspective view of a clip mechanism according to one embodiment of the present invention.

FIG. 2 is a front view of a clip mechanism according to the embodiment of the present invention shown in FIG. 1.

FIG. 3 is a rear view of a clip mechanism according to the embodiment of the present invention shown in FIG. 1.

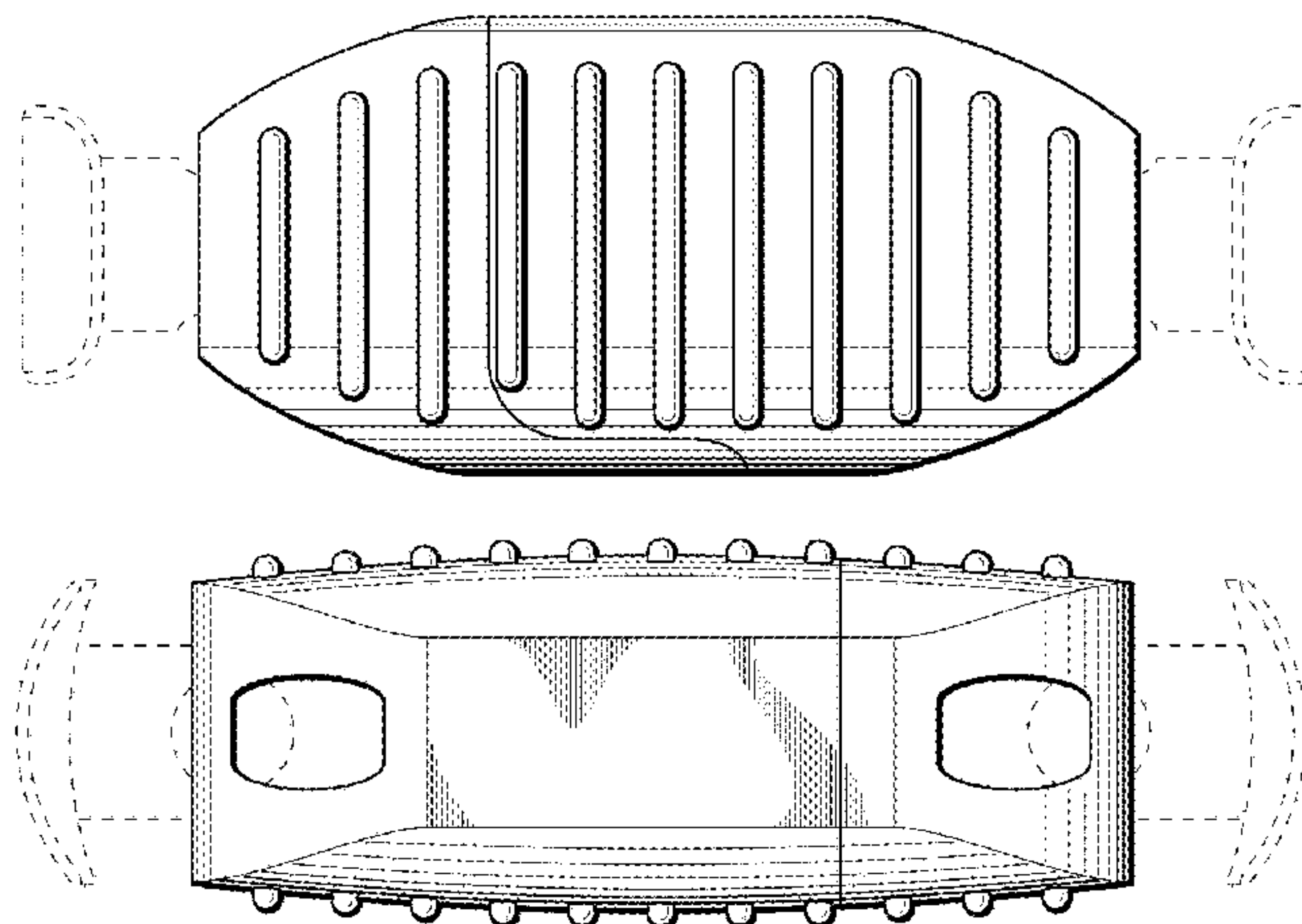

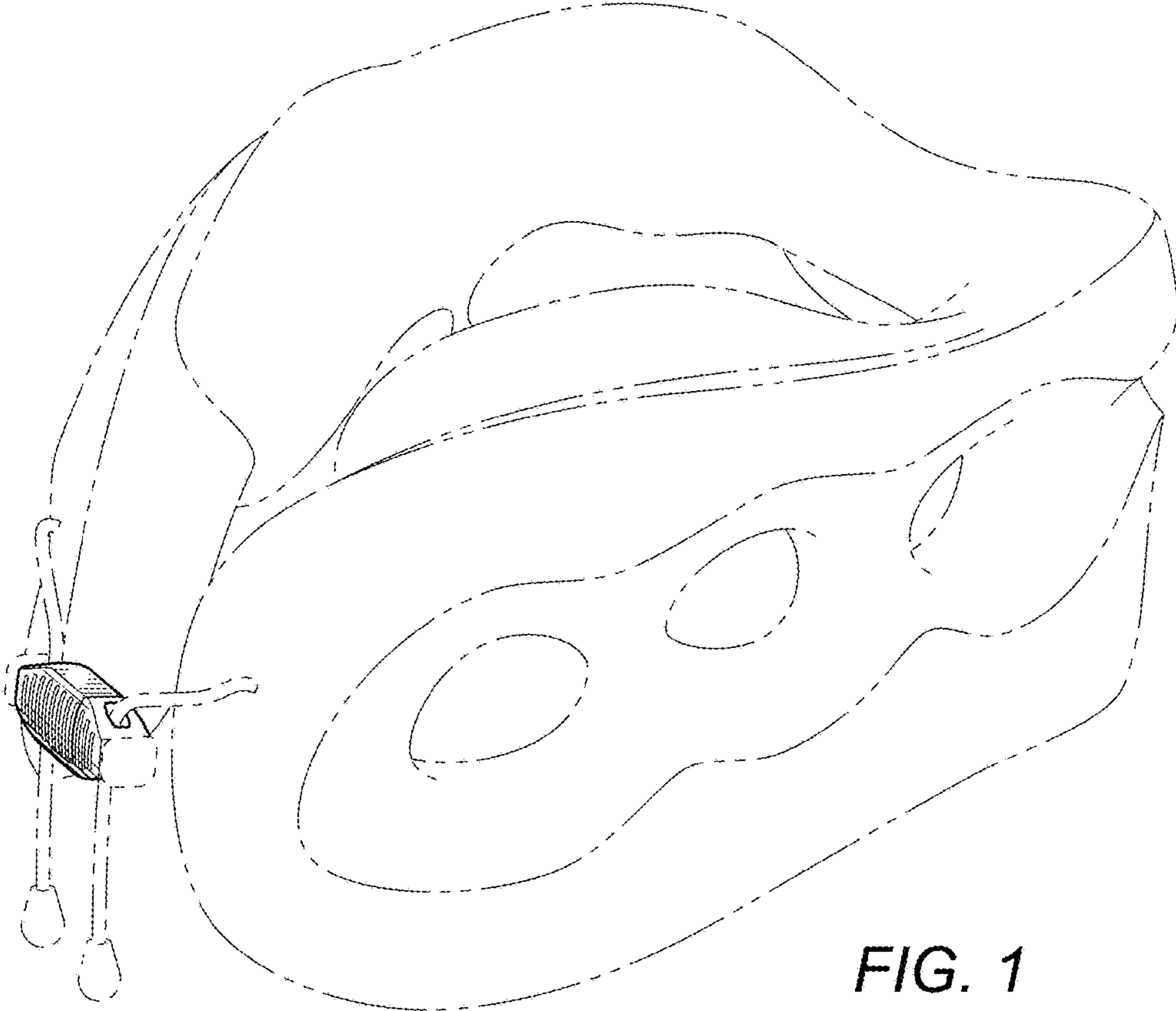

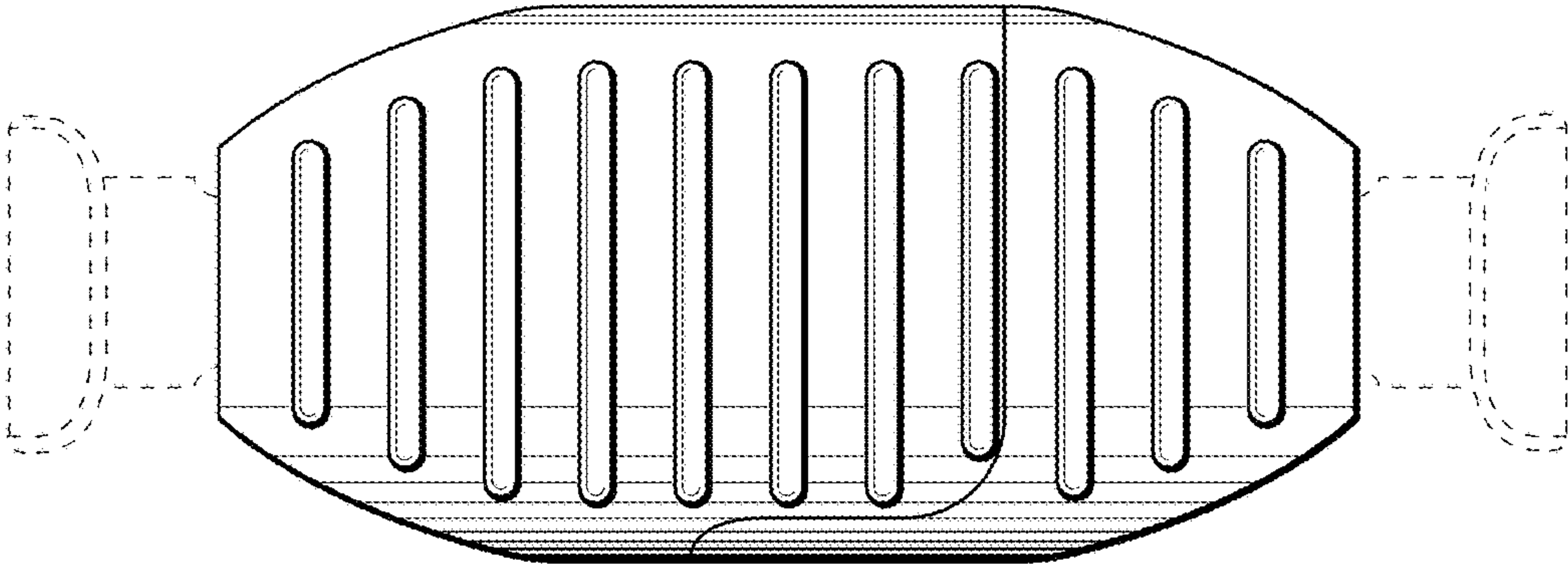

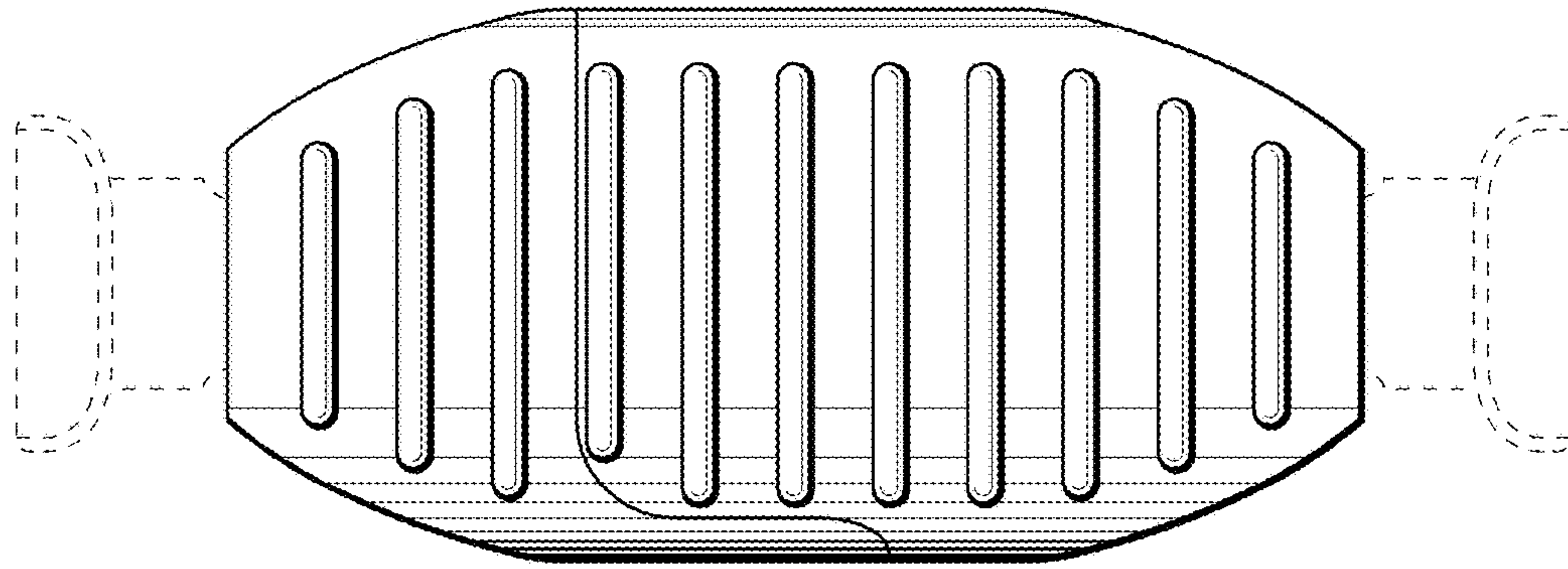

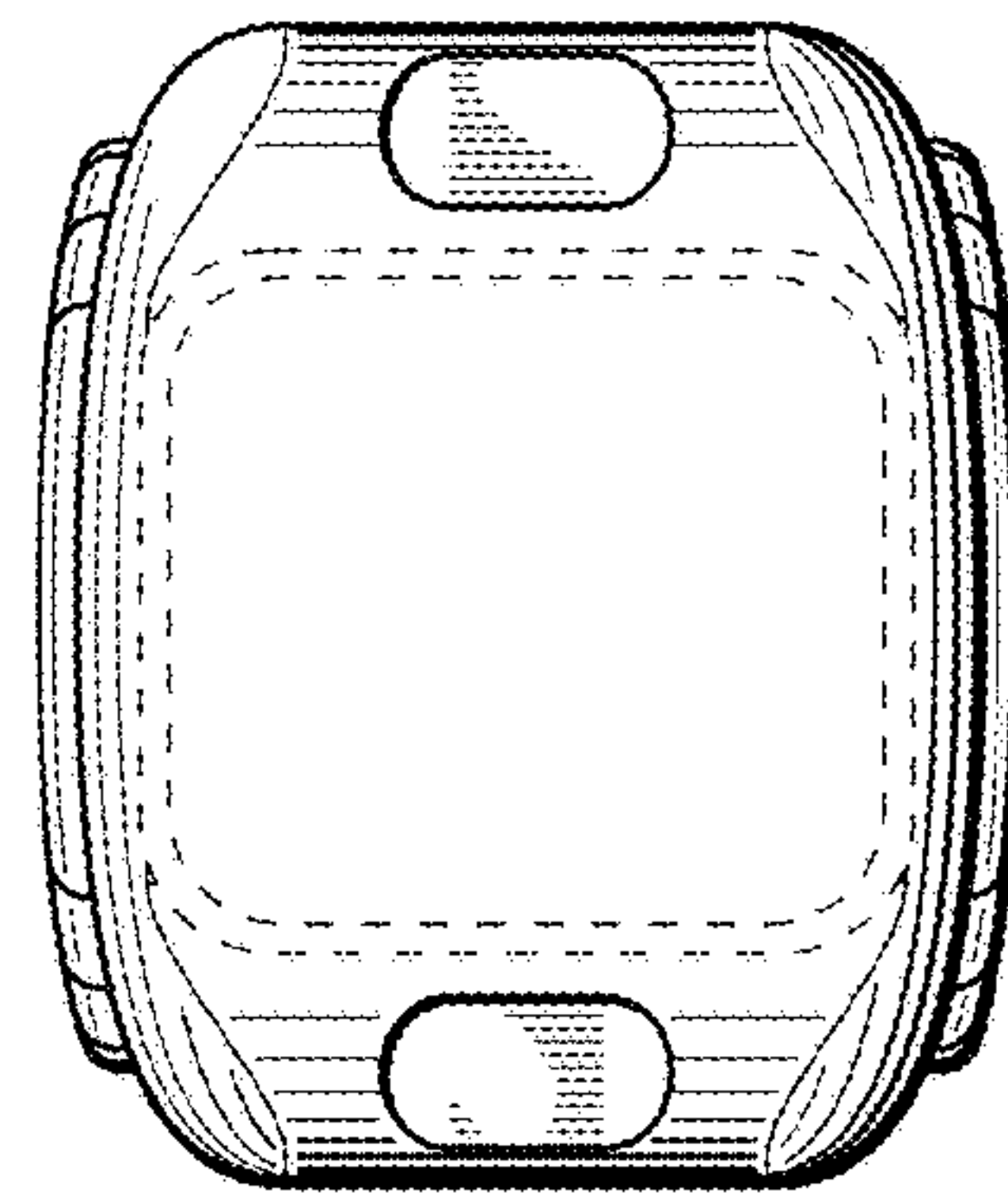

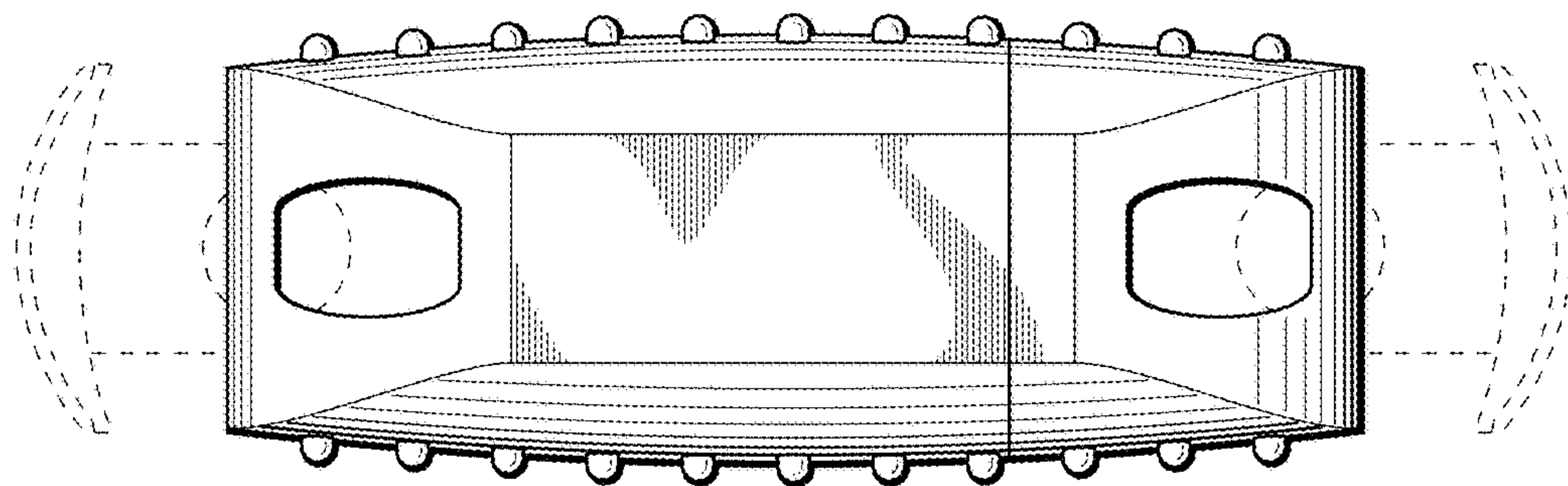

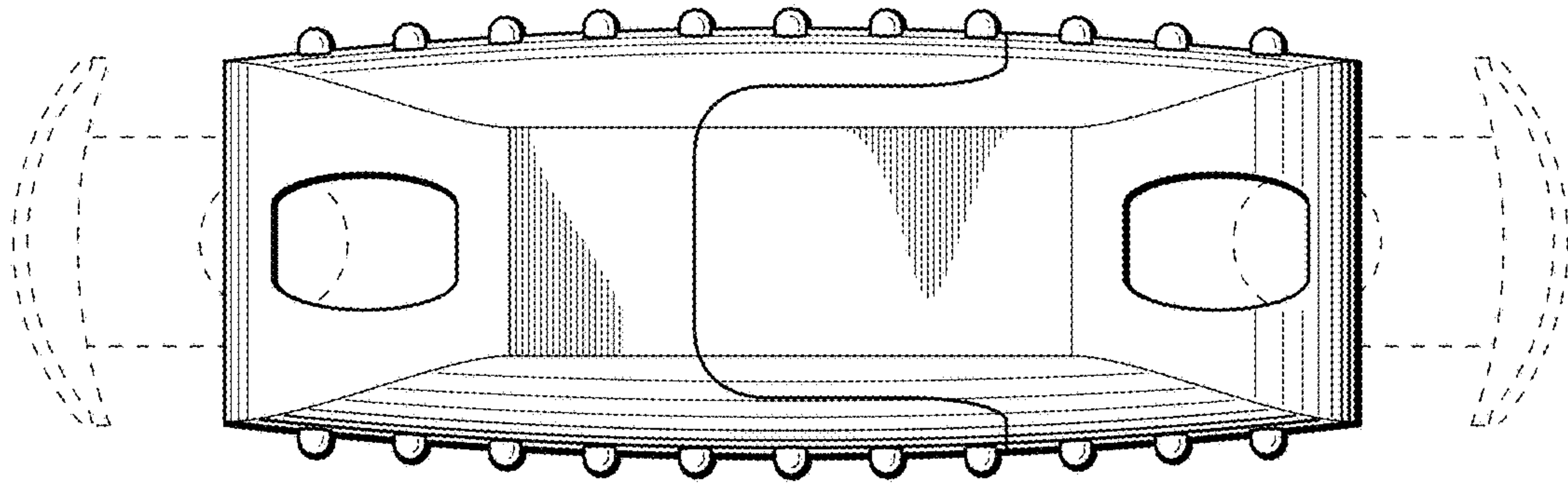

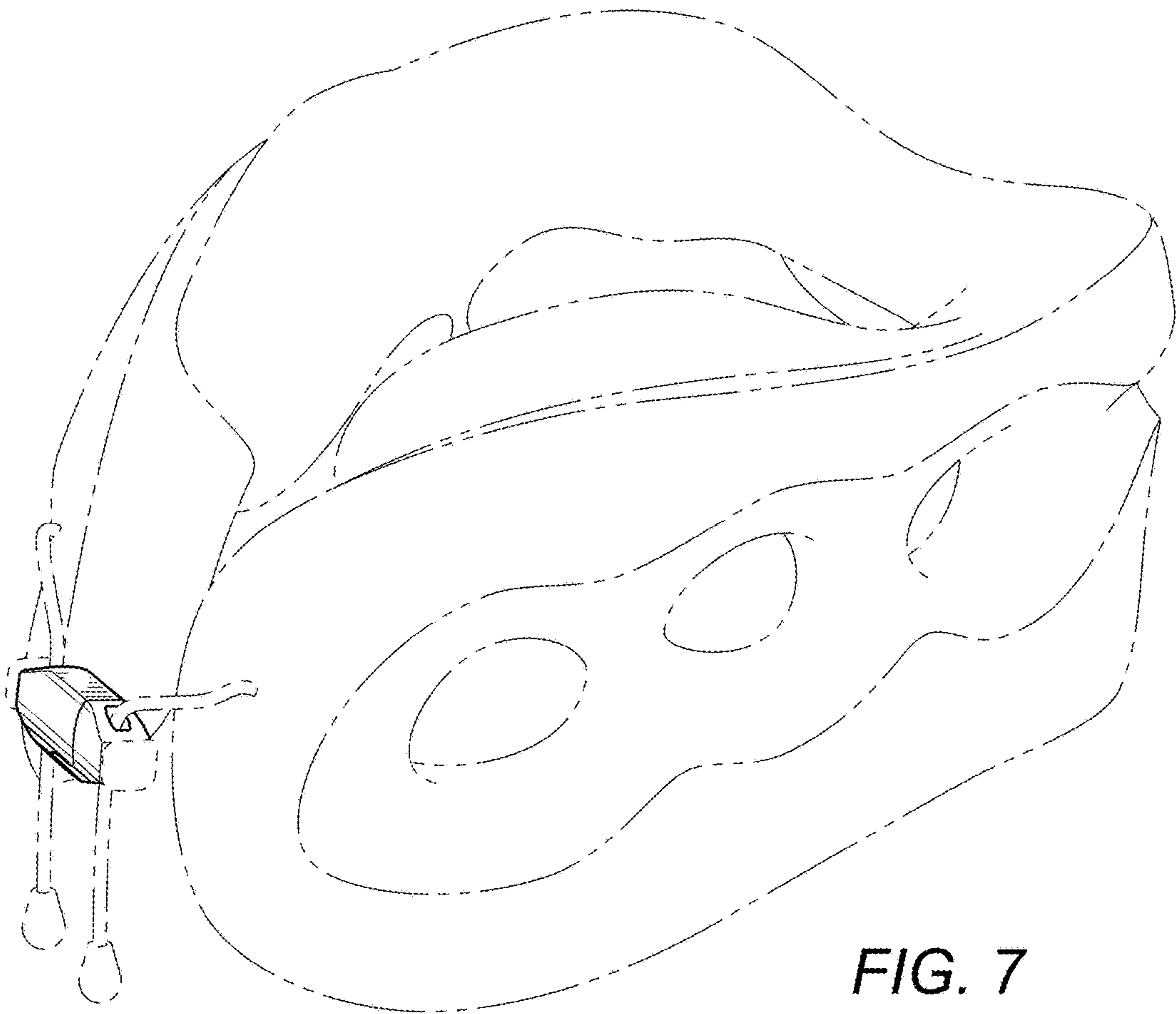

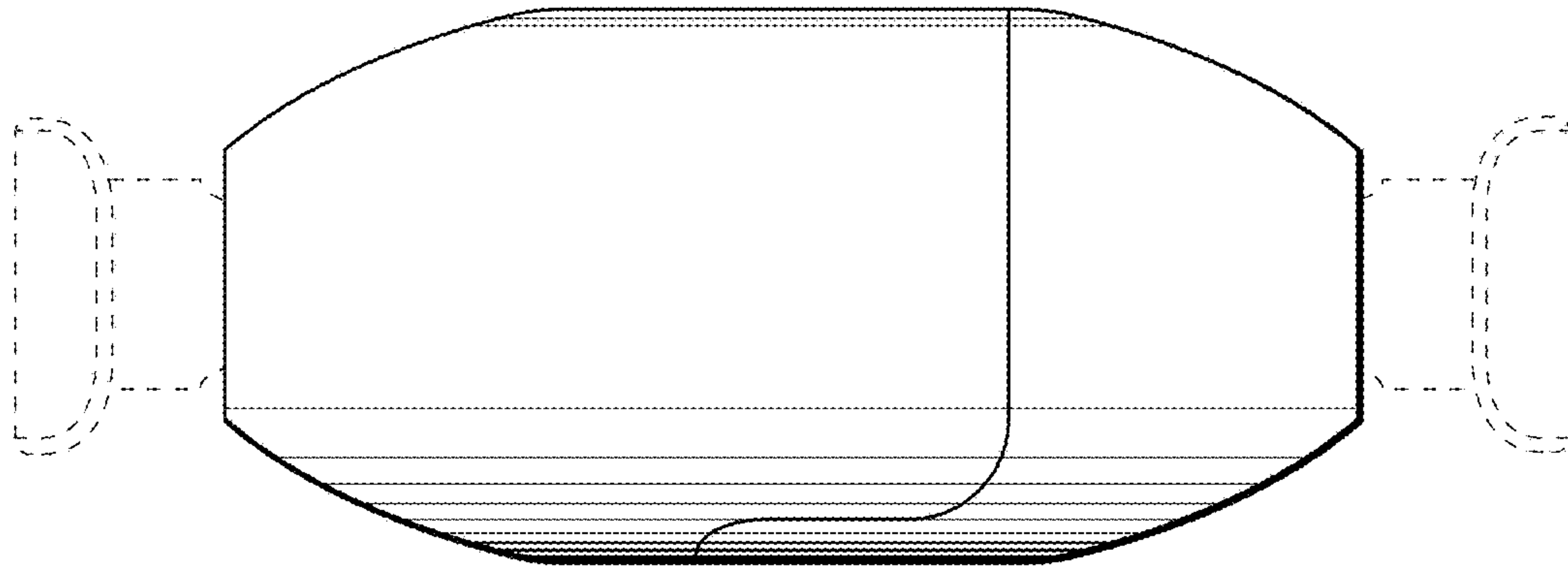

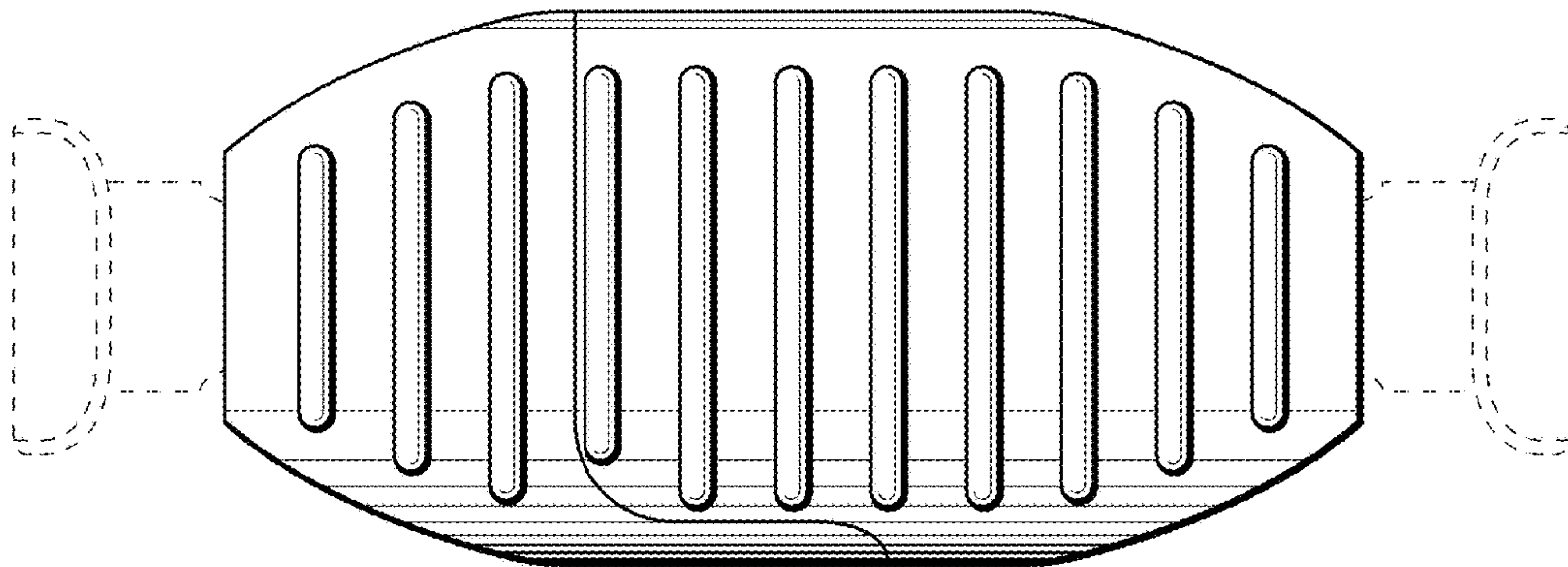

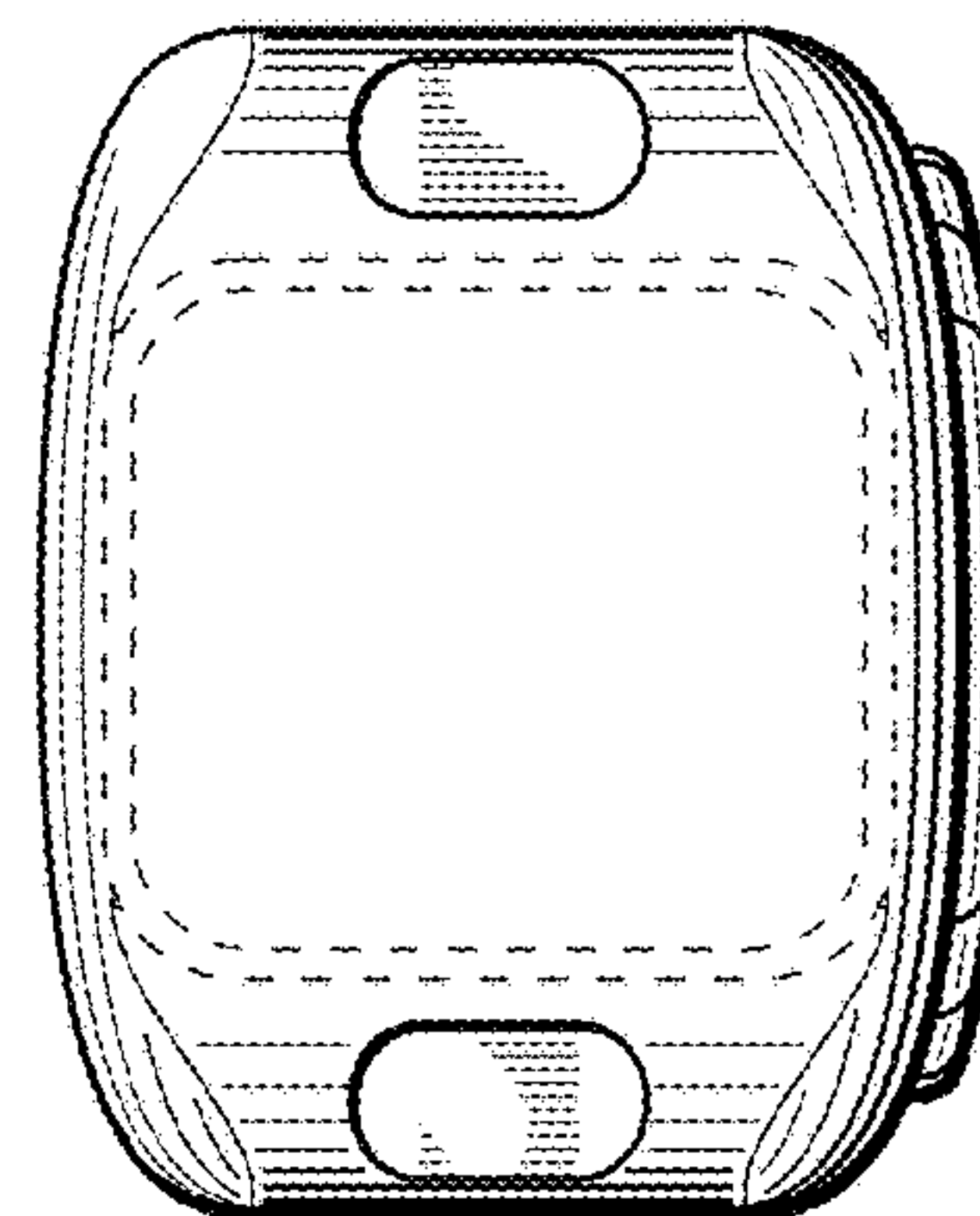

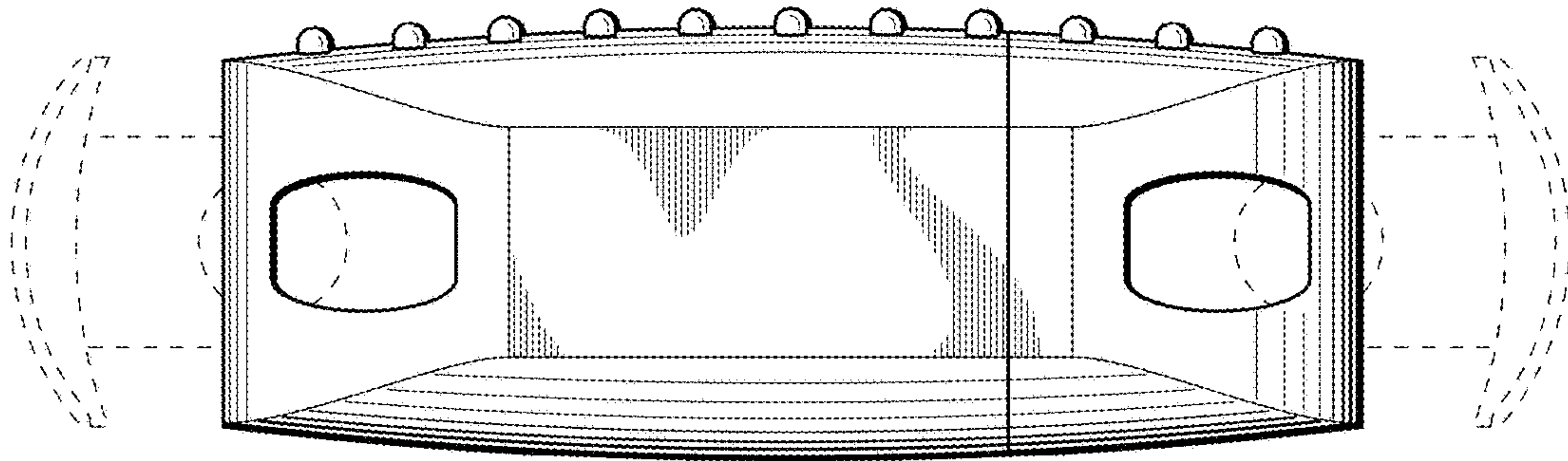
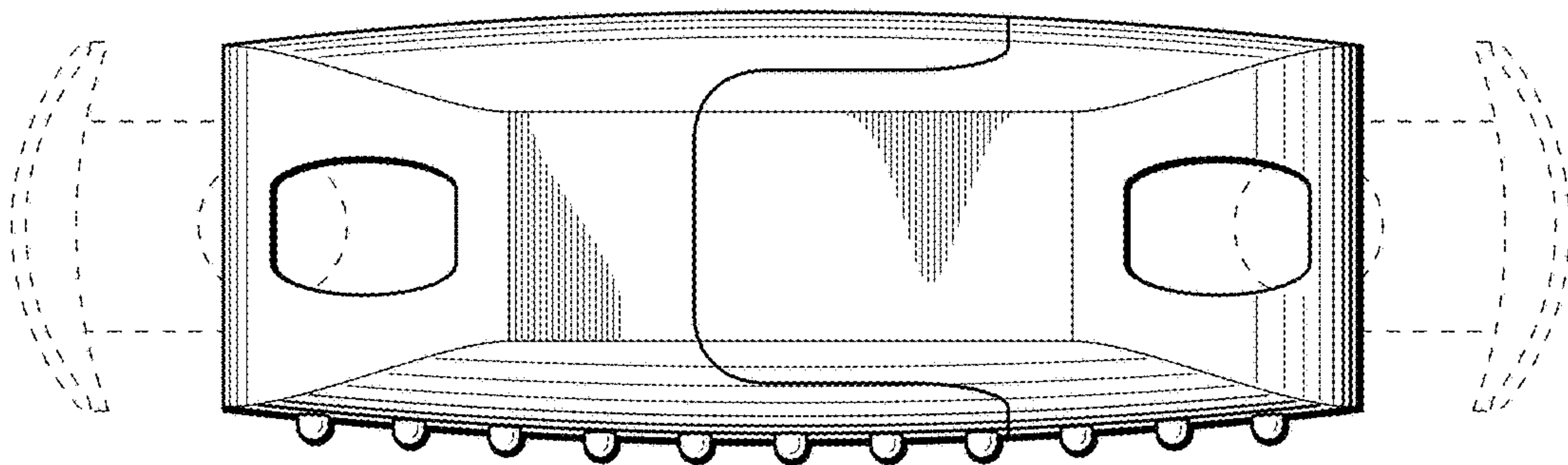

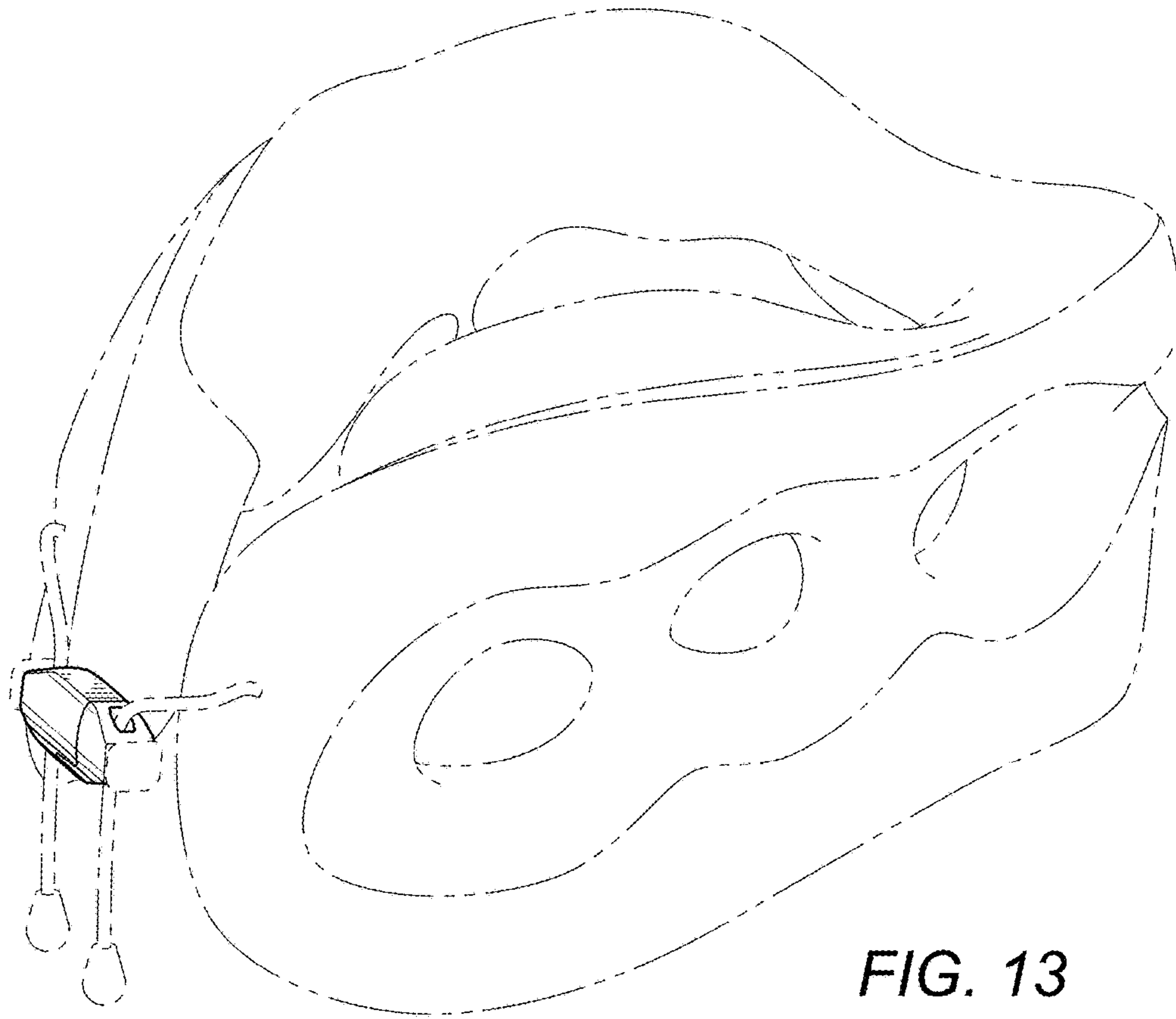

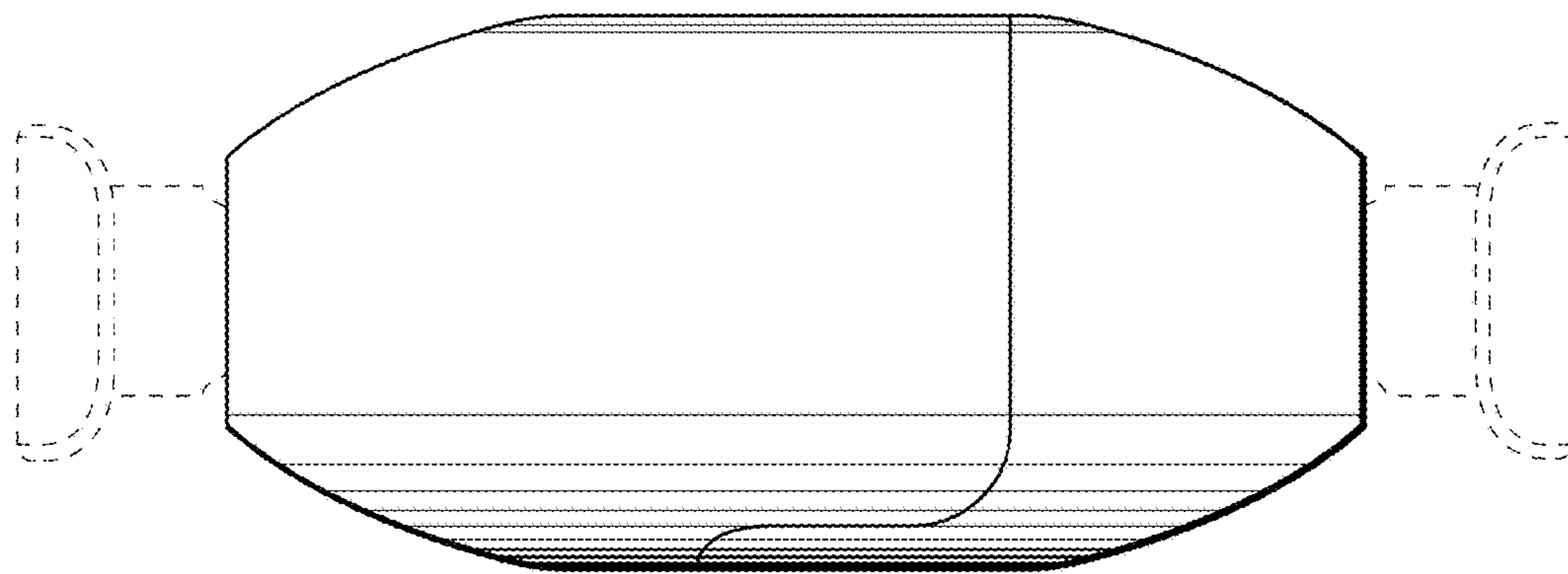

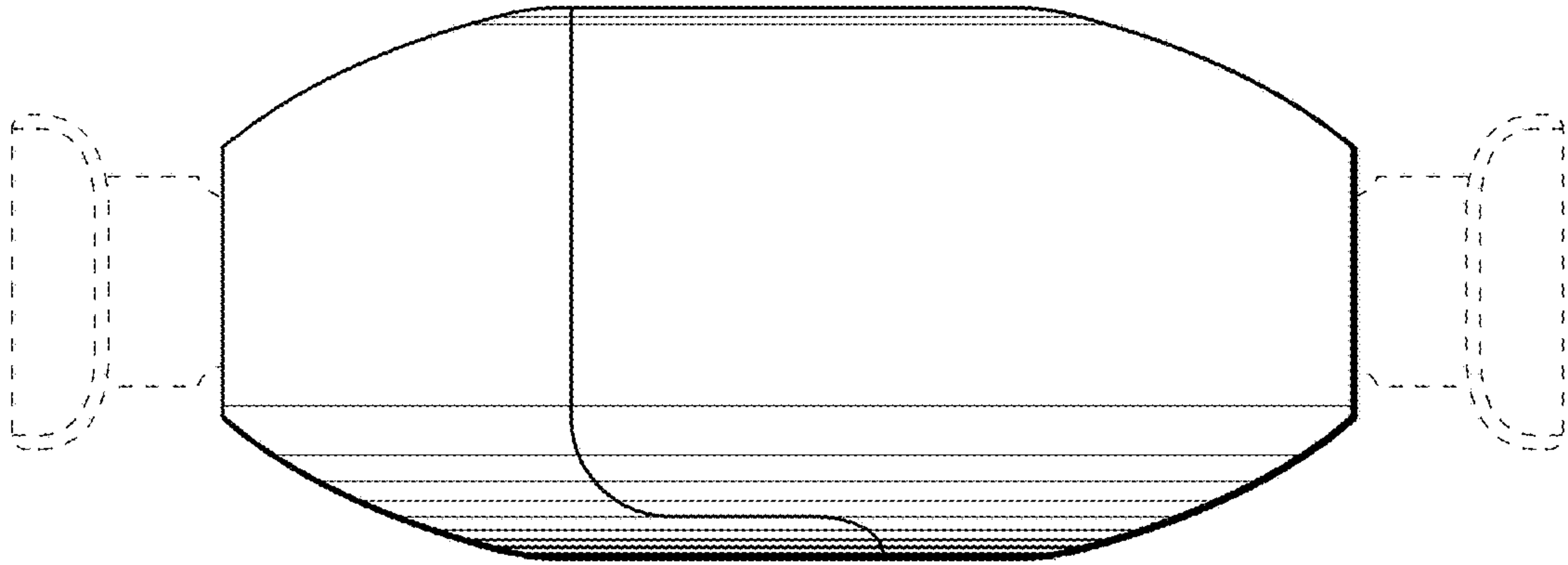

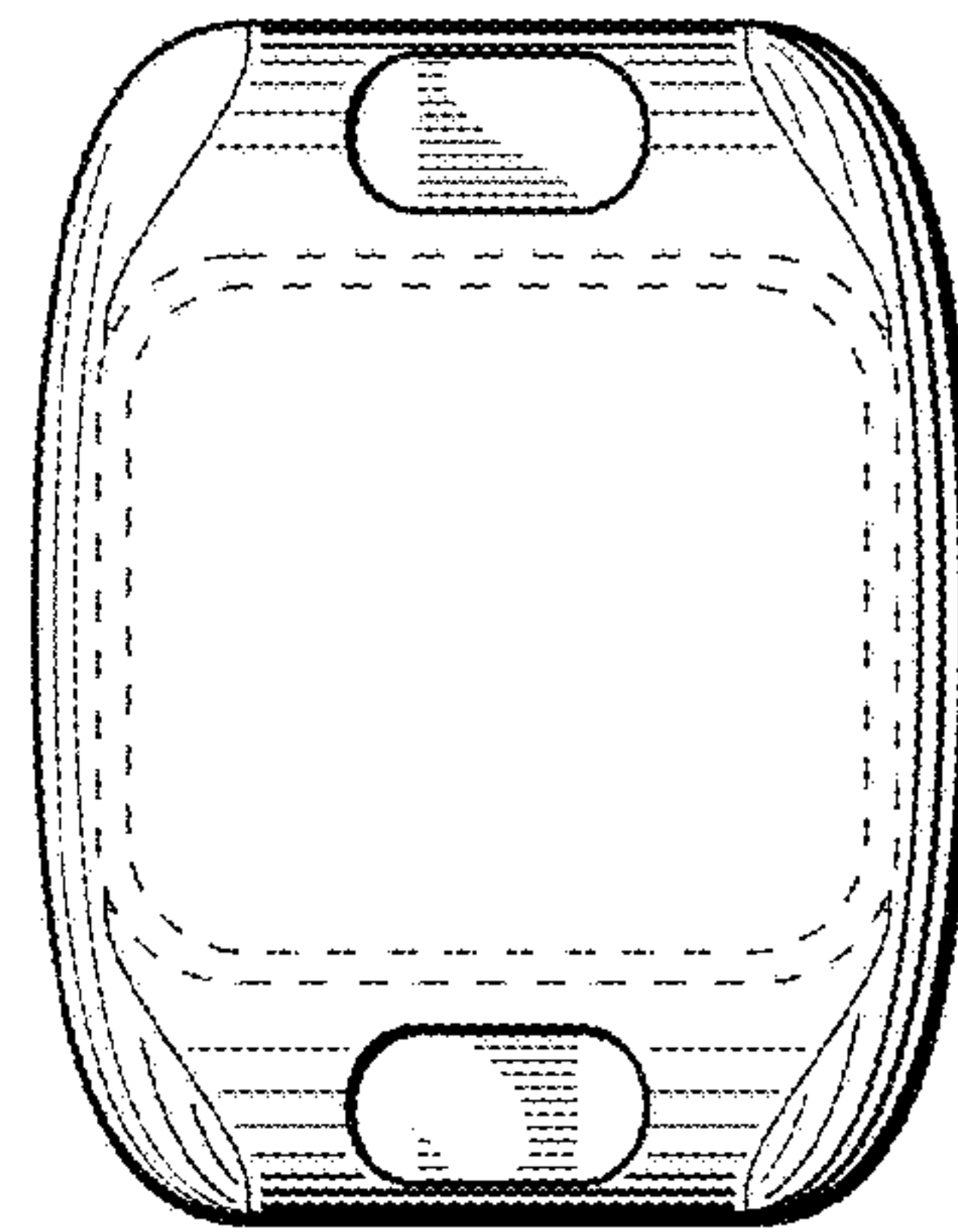

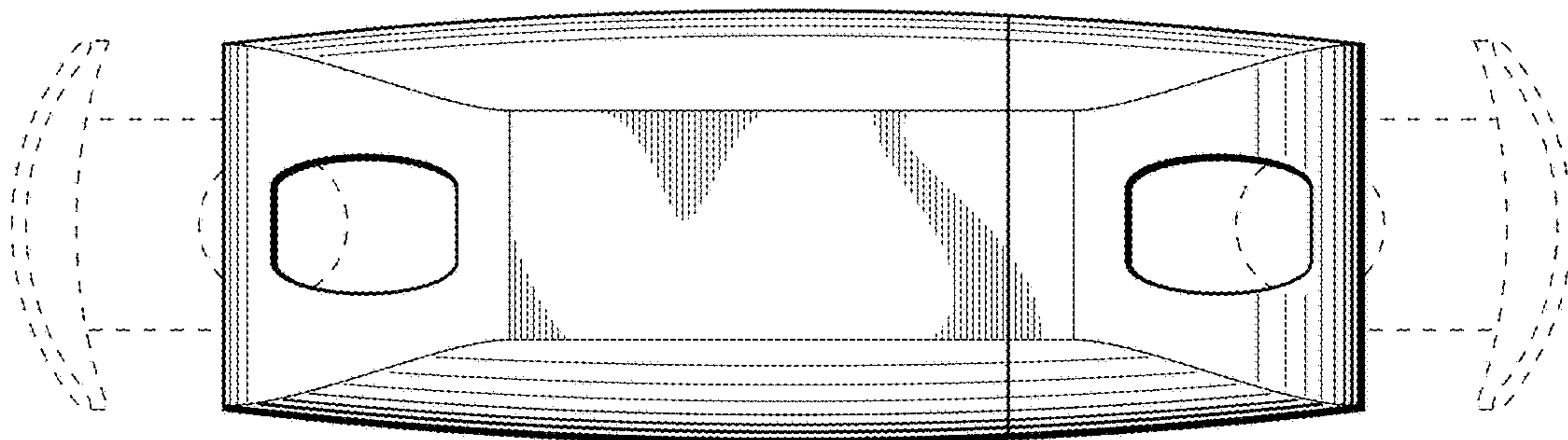

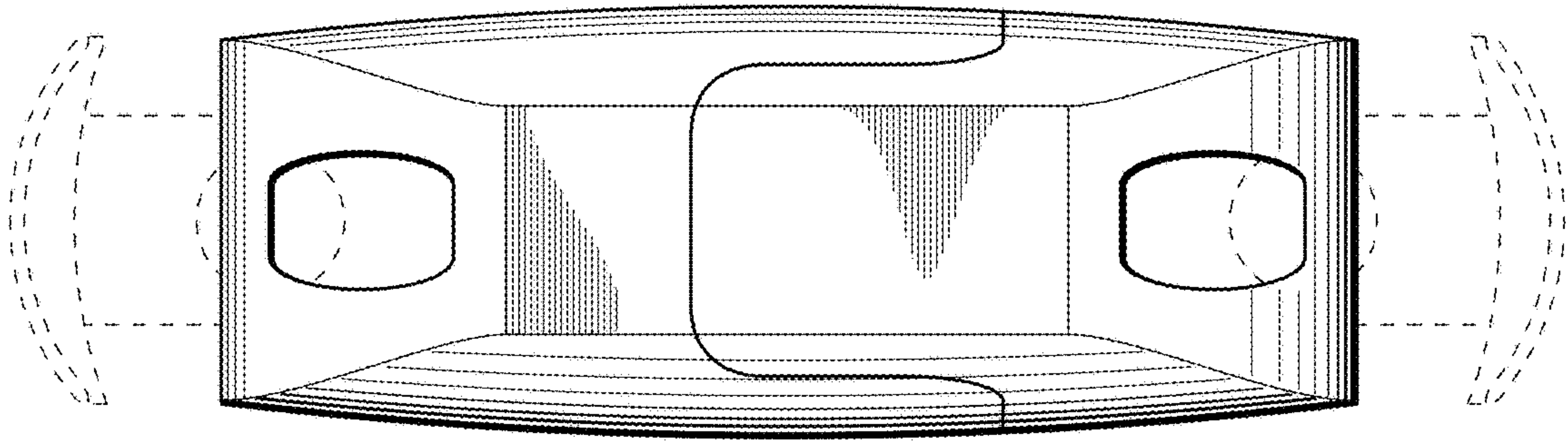

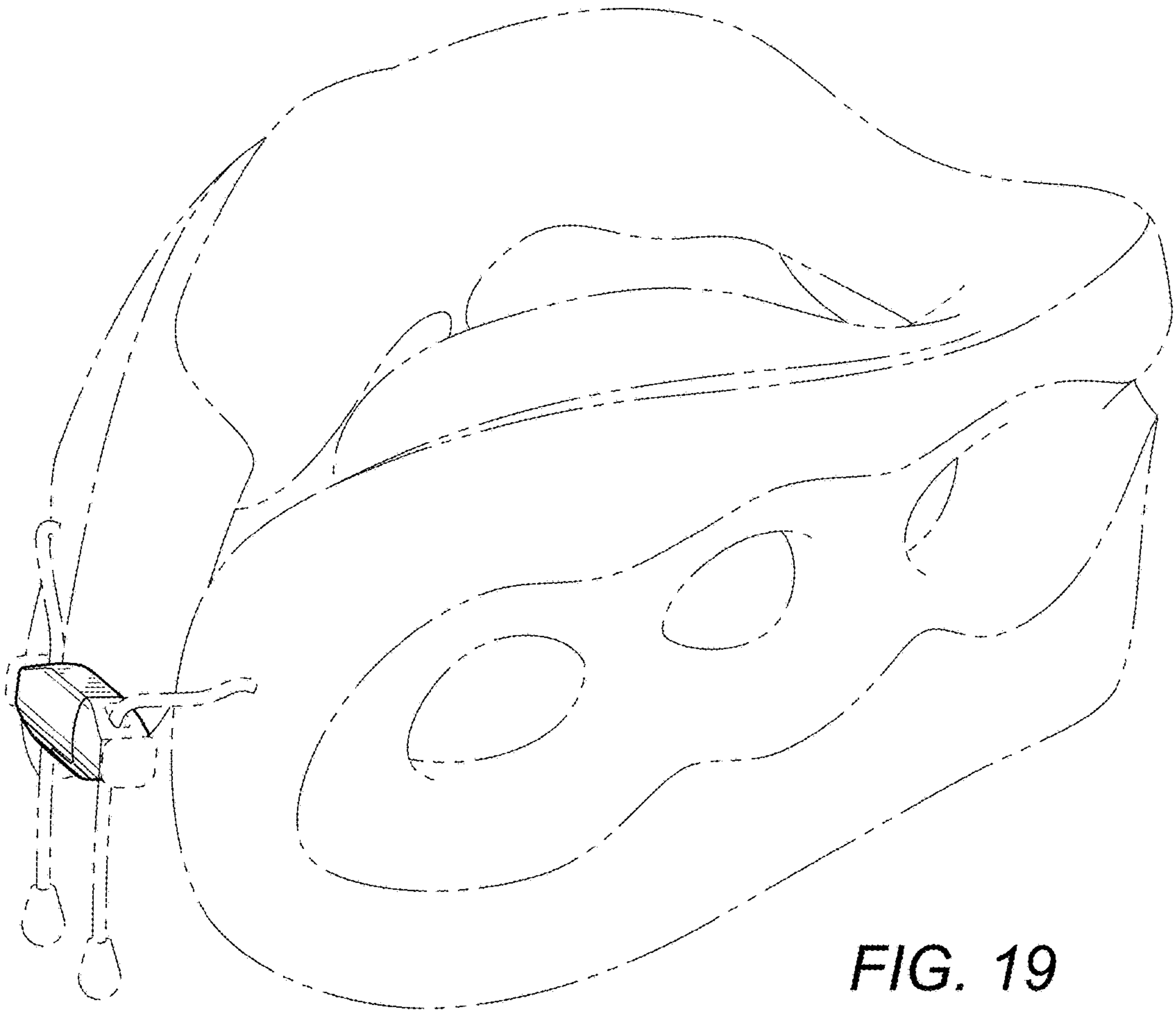

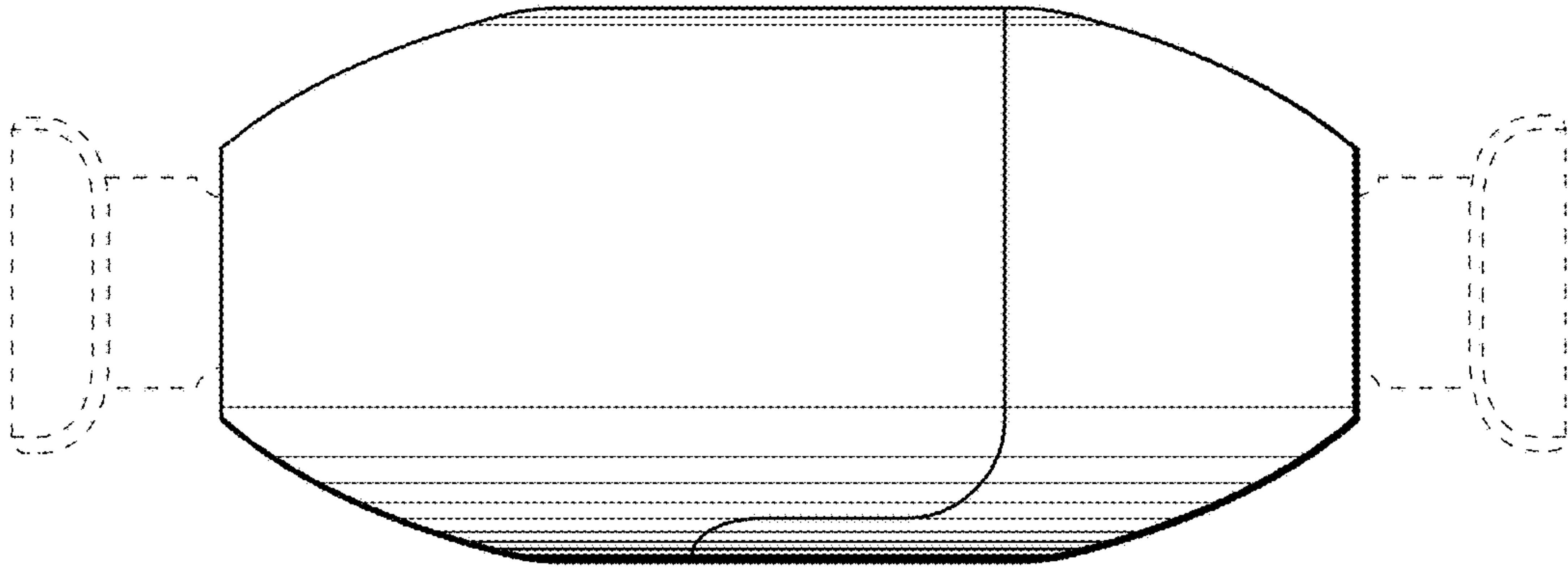

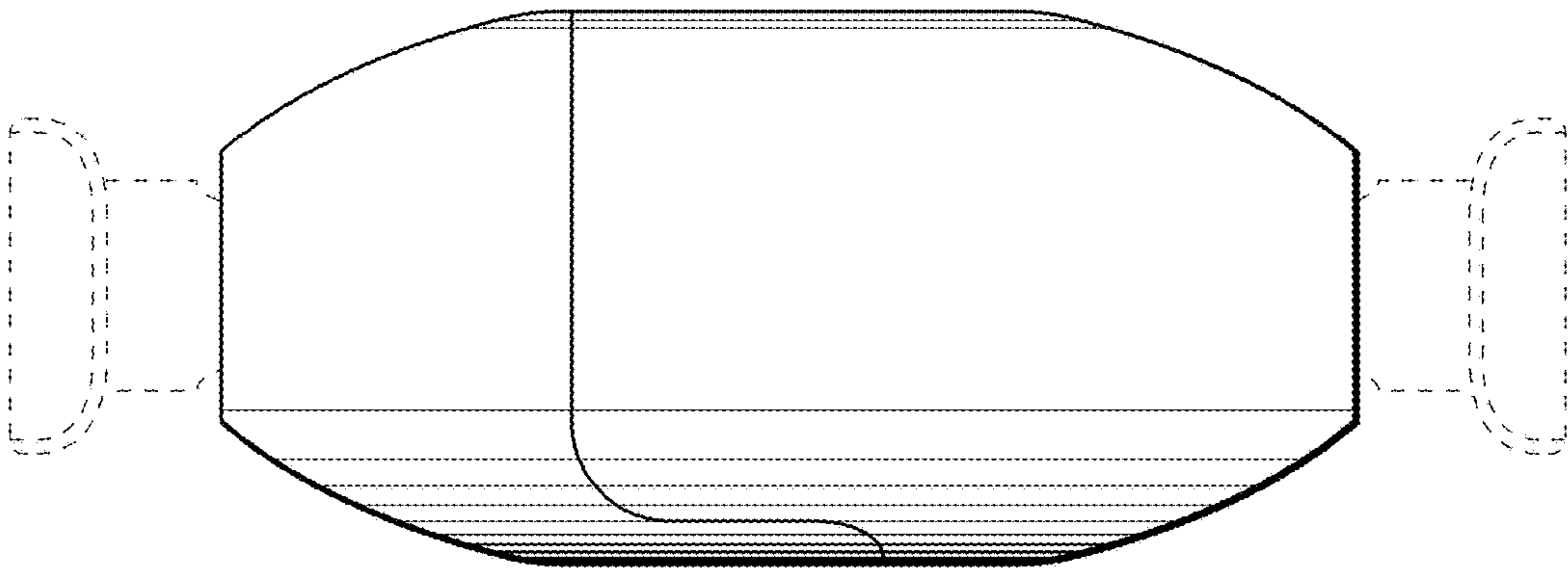

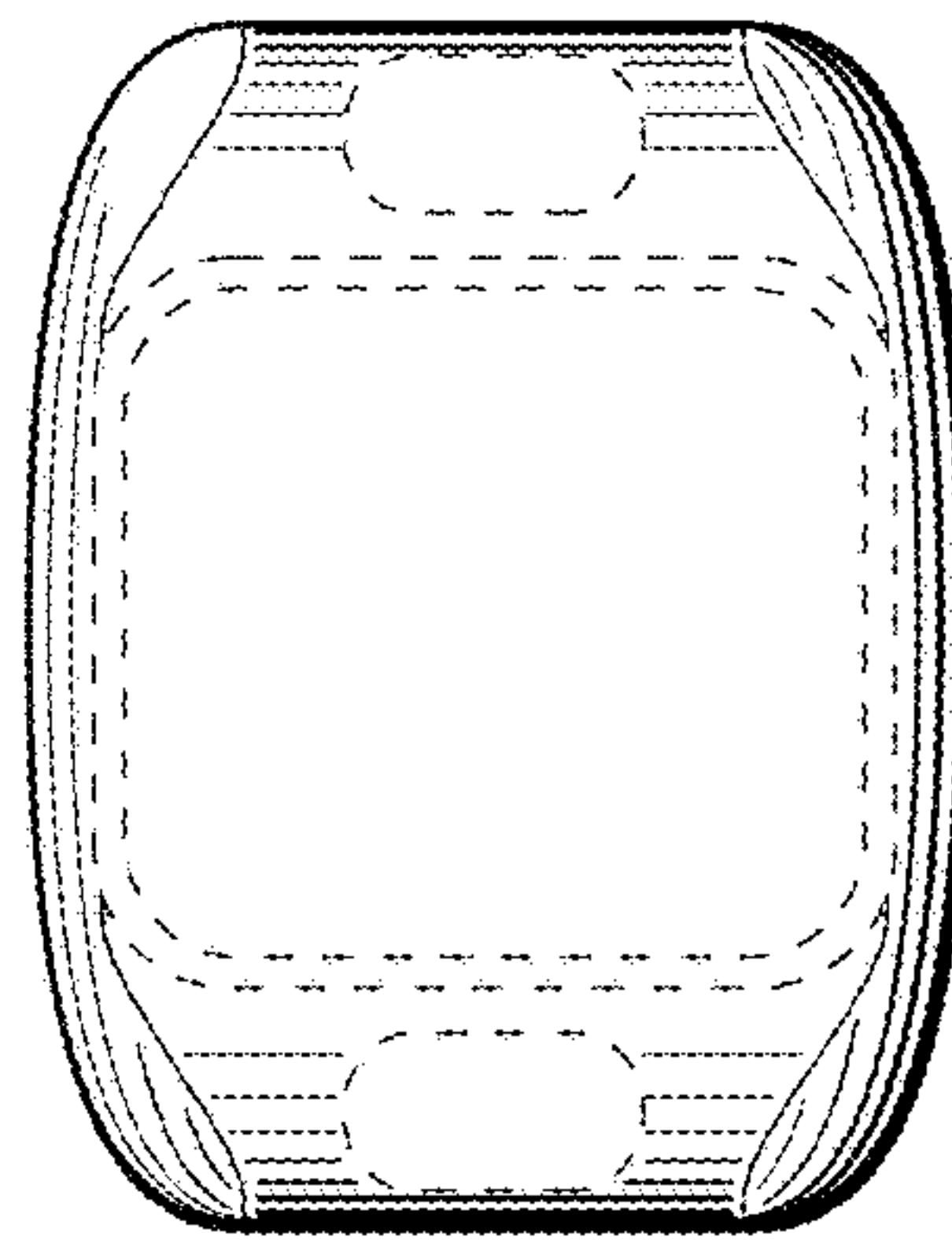

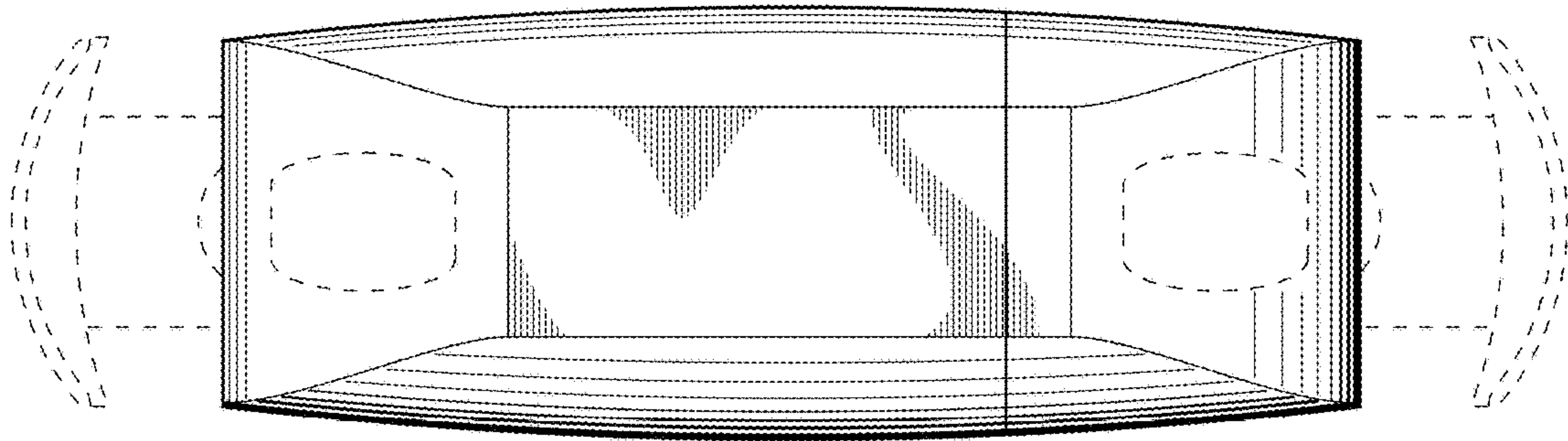
