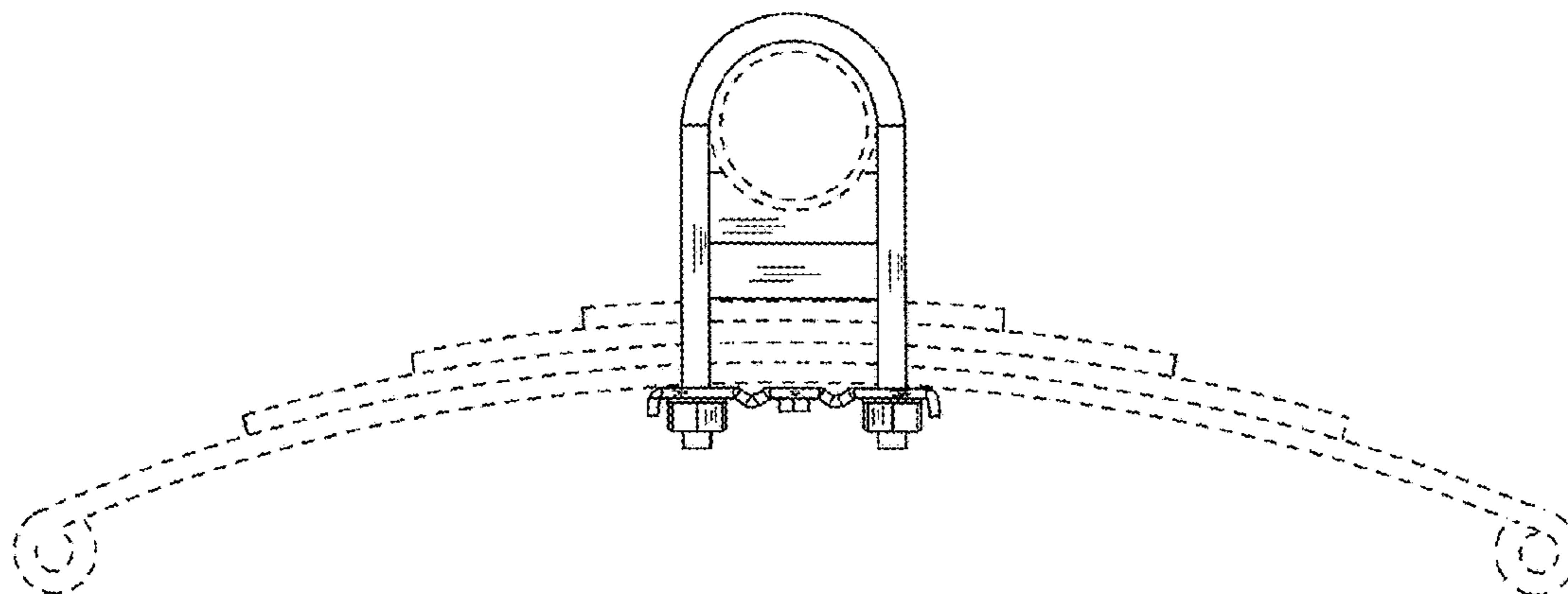
(57) **CLAIM**

The ornamental design for a suspension, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a suspension showing a first embodiment of our design, the rear elevational view being identical;
 FIG. 2 is a bottom plan view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is an enlarged bottom, right side perspective view thereof, the bottom, left side perspective view being a mirror image thereof;
 FIG. 5 is a front elevation view of a second embodiment of a suspension.
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is a top plan view thereof;
 FIG. 8 is an enlarged bottom, right side perspective view thereof, the bottom, left side perspective view being a mirror image thereof;
 FIG. 9 is a front elevation view of a third embodiment of a suspension, the rear elevation being identical;
 FIG. 10 is a bottom plan view thereof;
 FIG. 11 is a top plan view thereof; and,
 FIG. 12 is an enlarged bottom right side perspective view thereof; the bottom, left side perspective view being a mirror image thereof.
 The portions shown in broken lines are for the purpose of illustrating portions of the suspension that form no part of the claimed design. The left and right side of the design are identical.

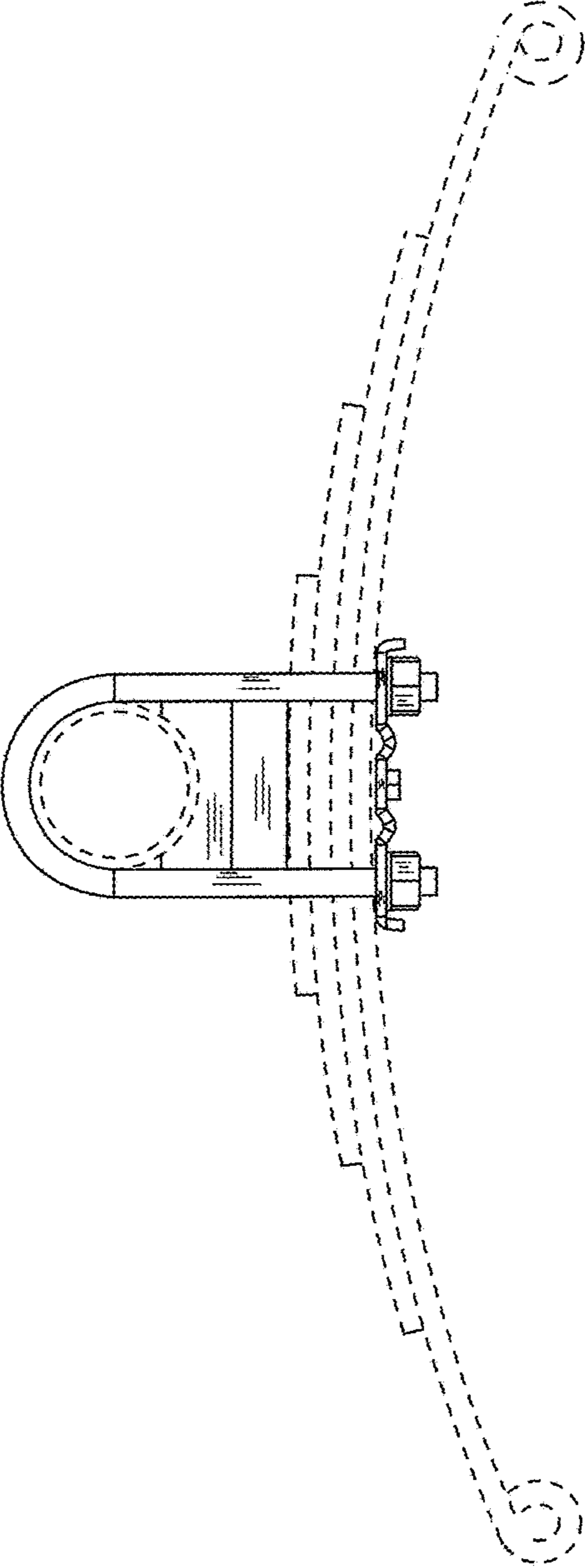
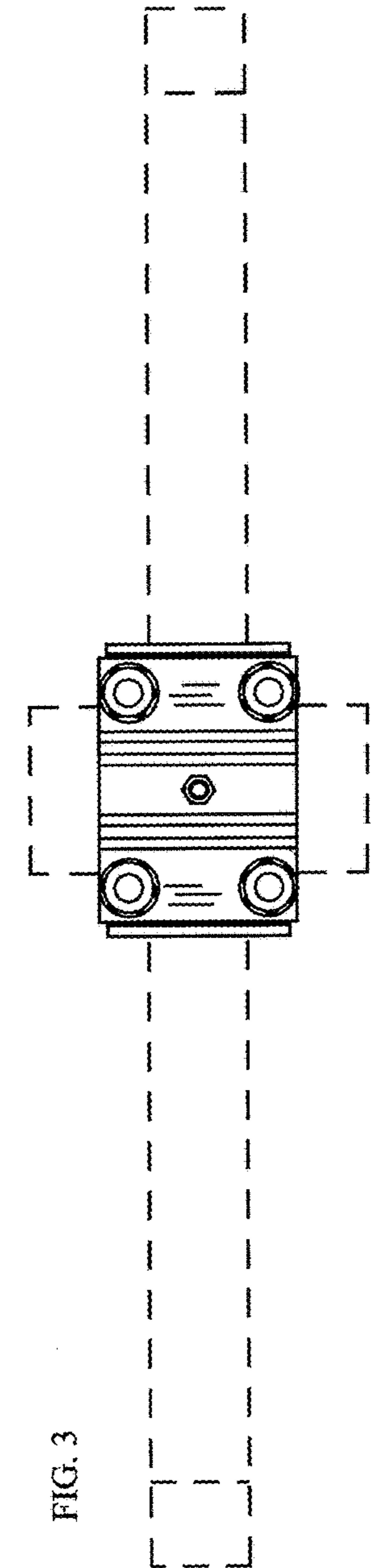
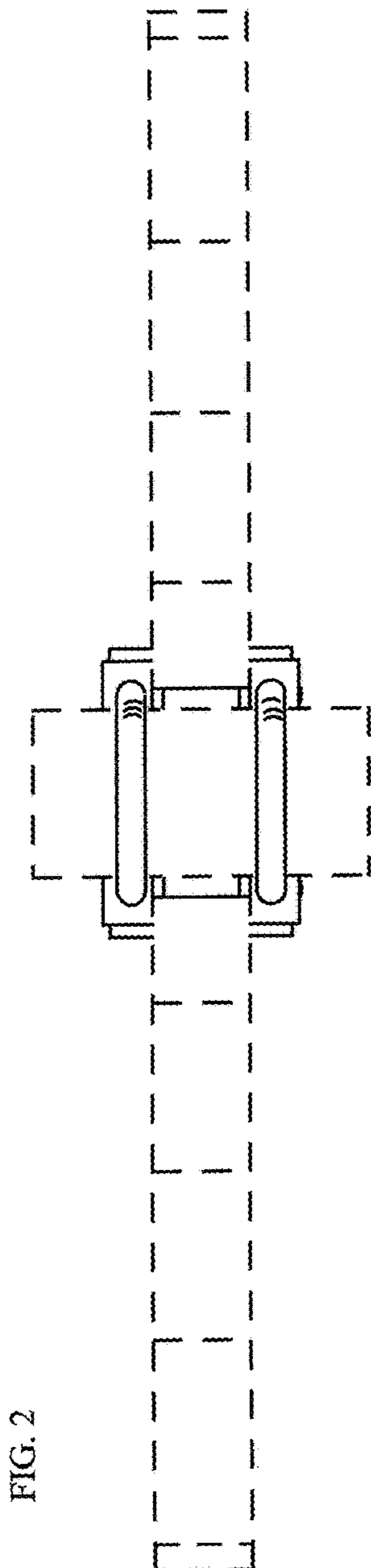

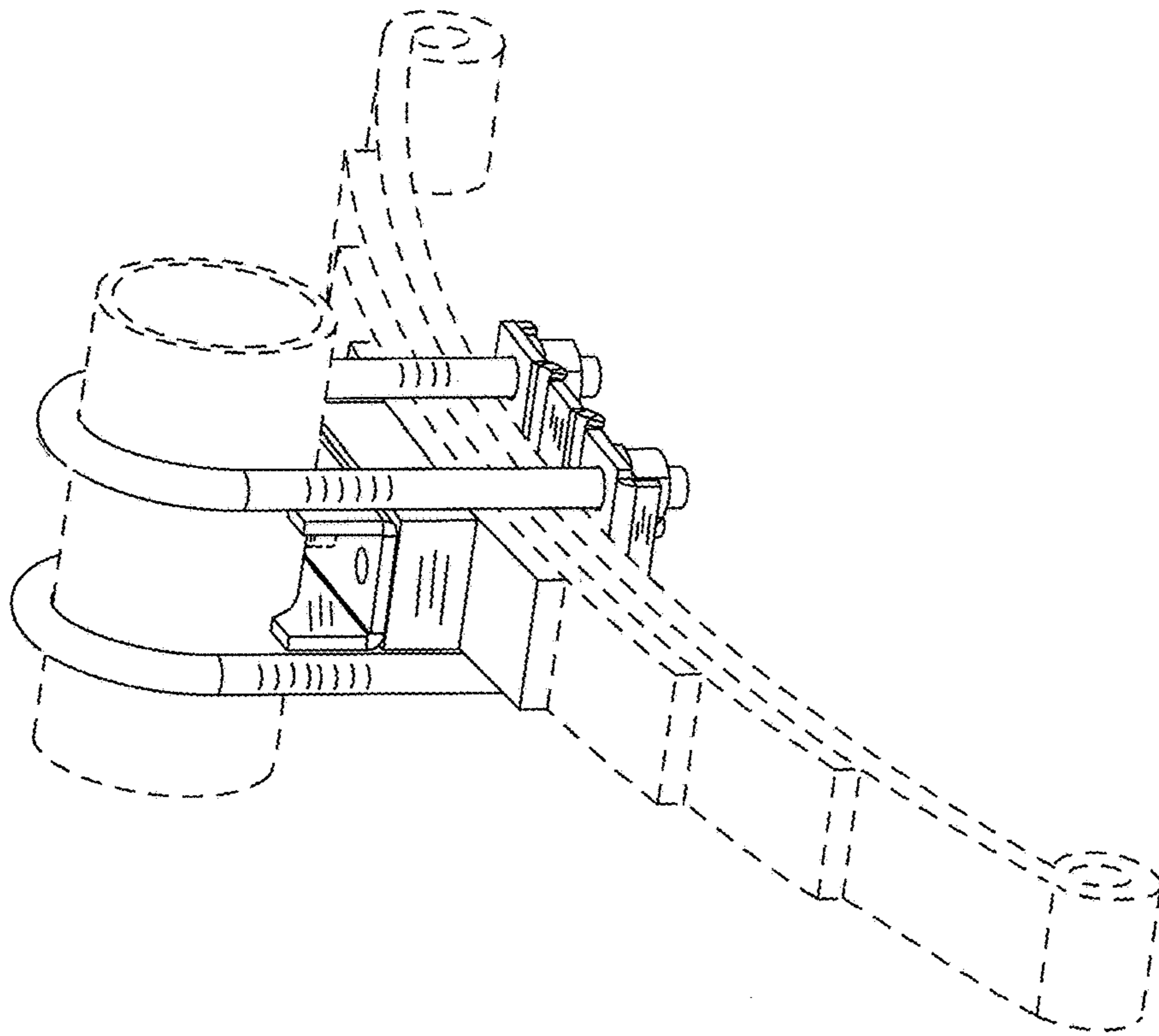

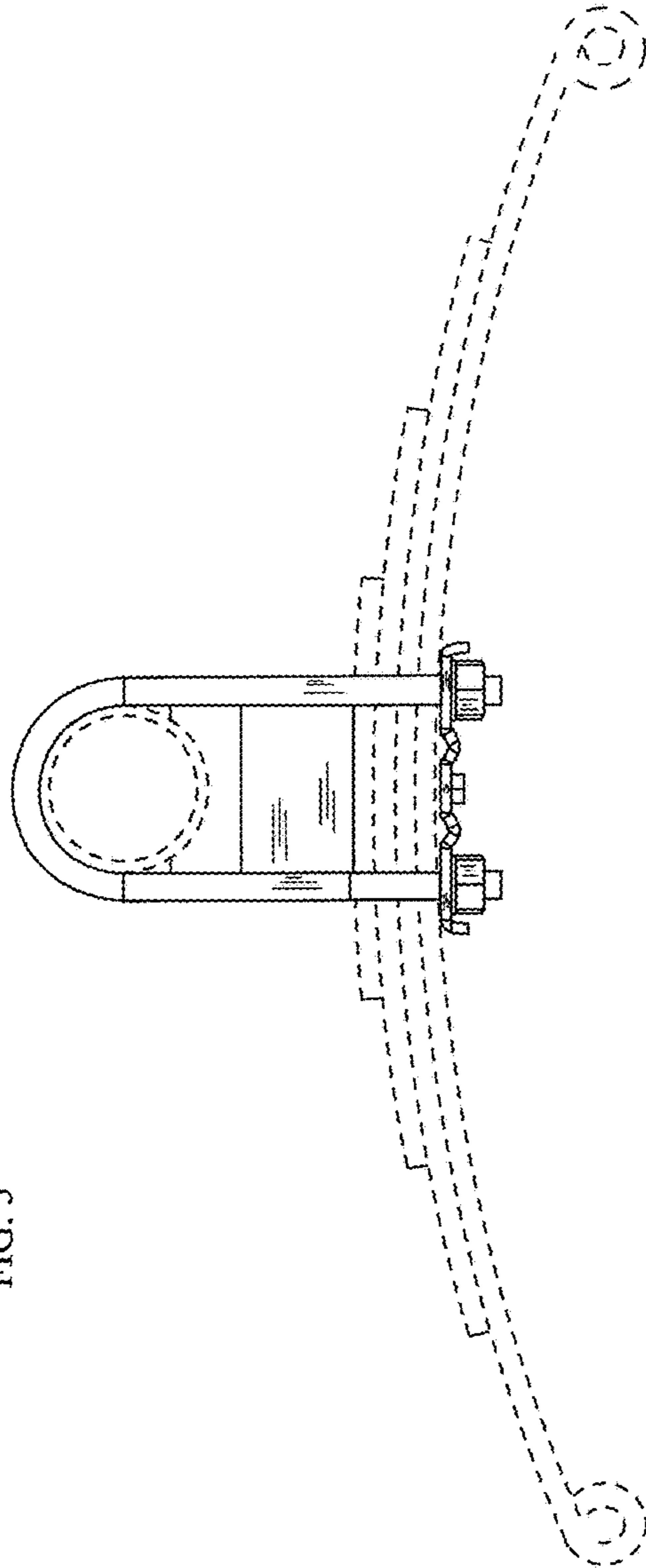
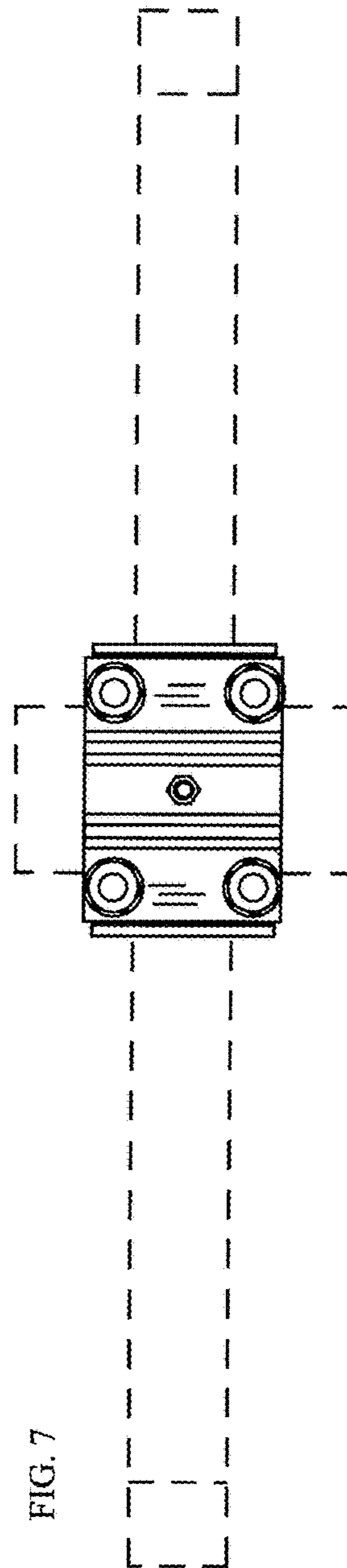
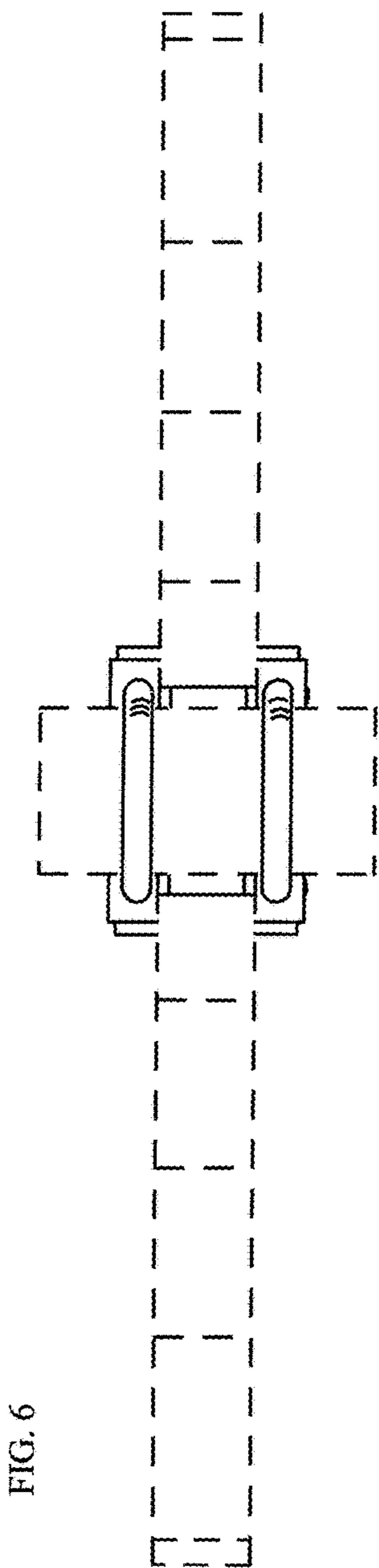

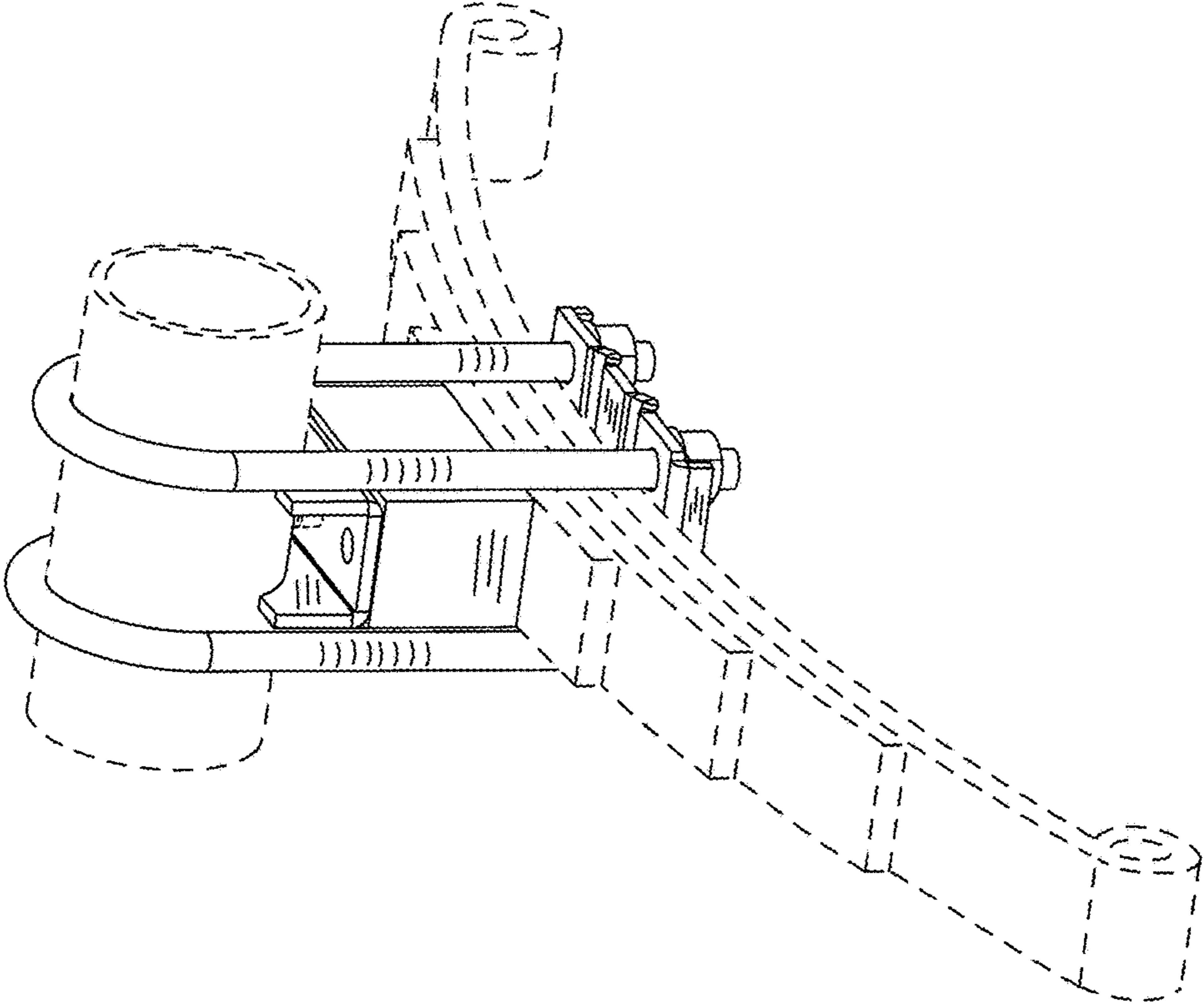

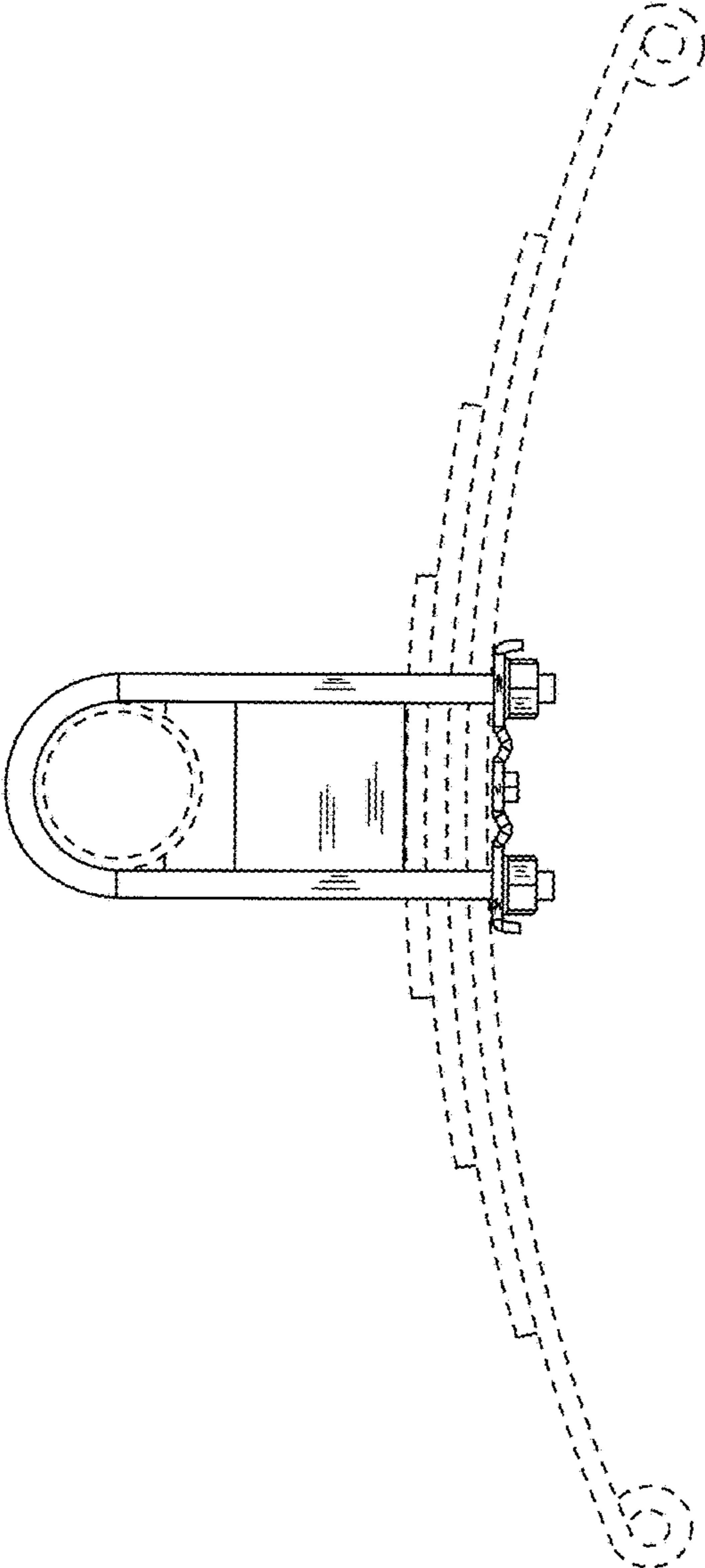
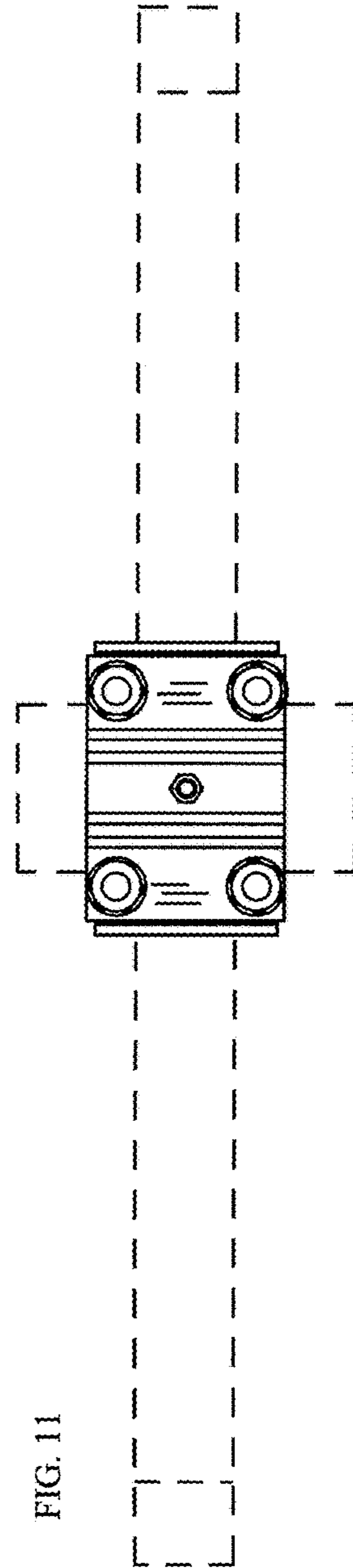
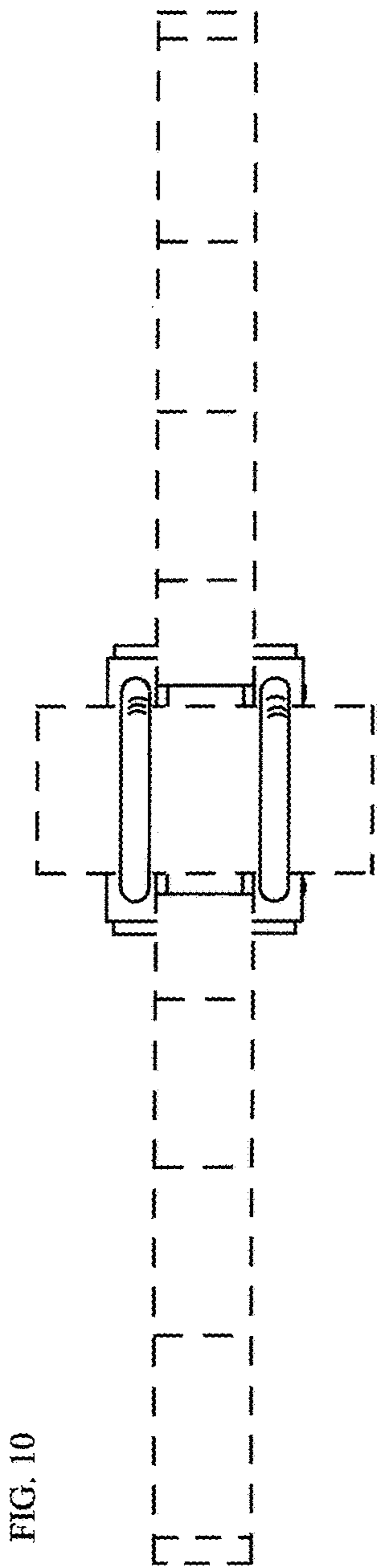

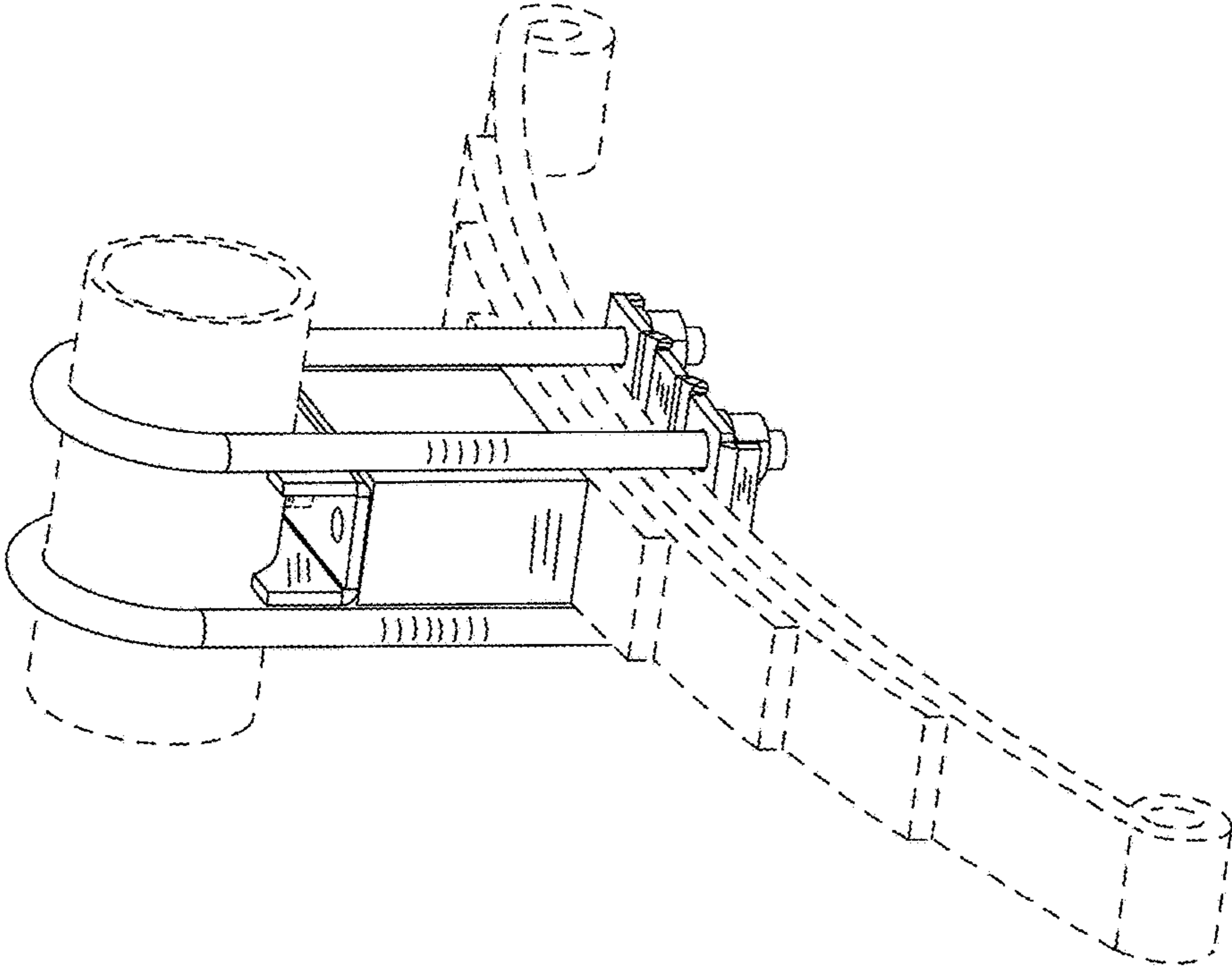
