(57) **CLAIM**

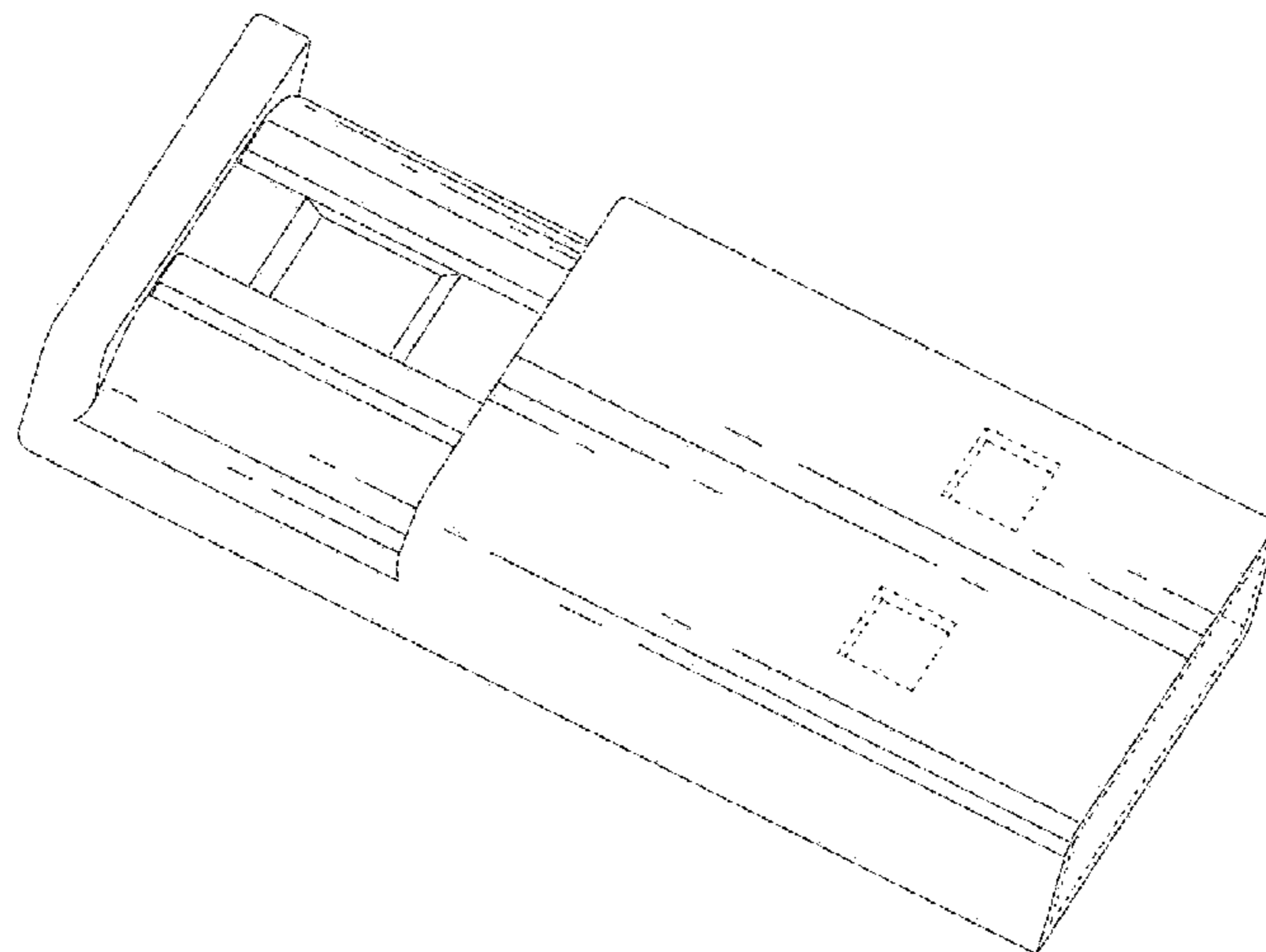
The ornamental design for a USB charger, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, left, bottom perspective view of a USB charger showing our new design;

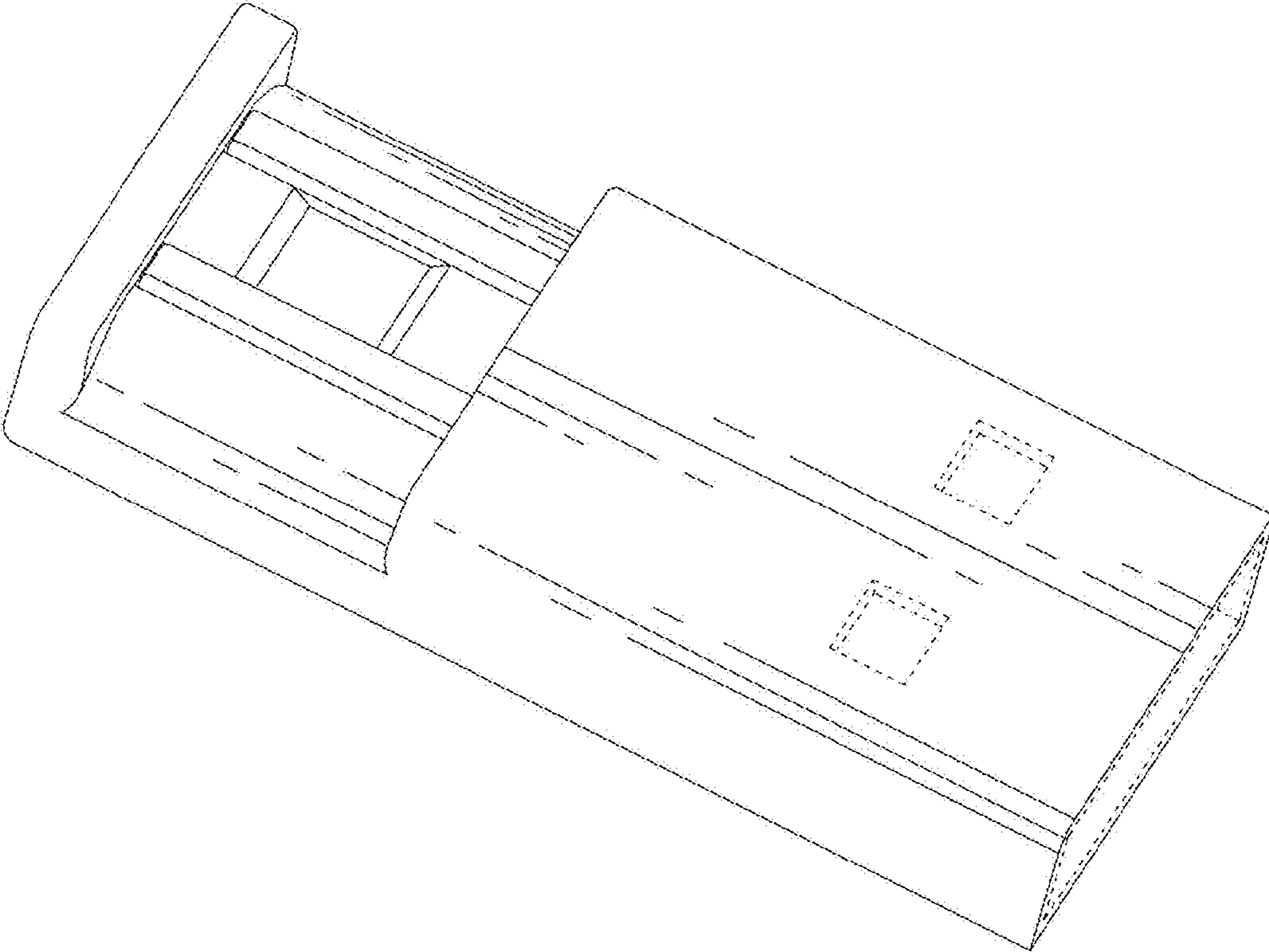

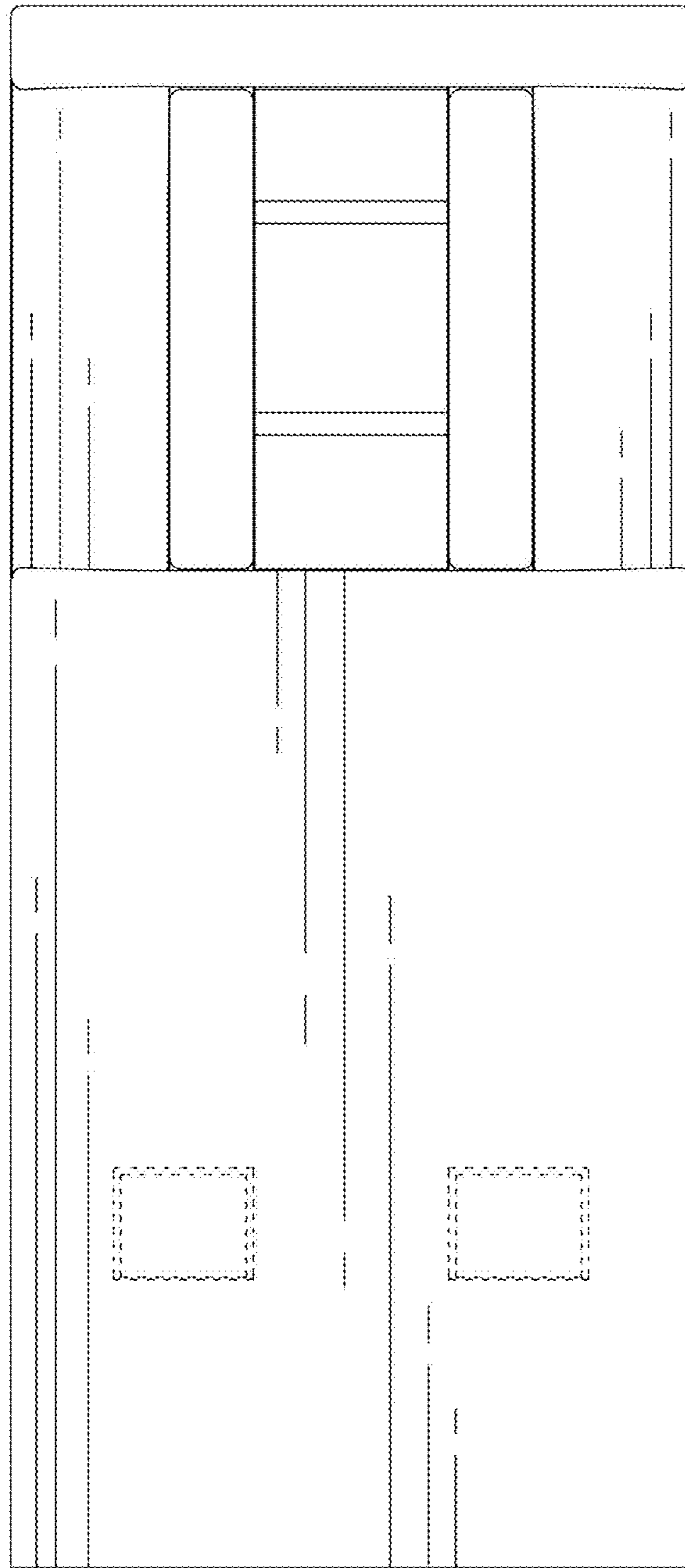

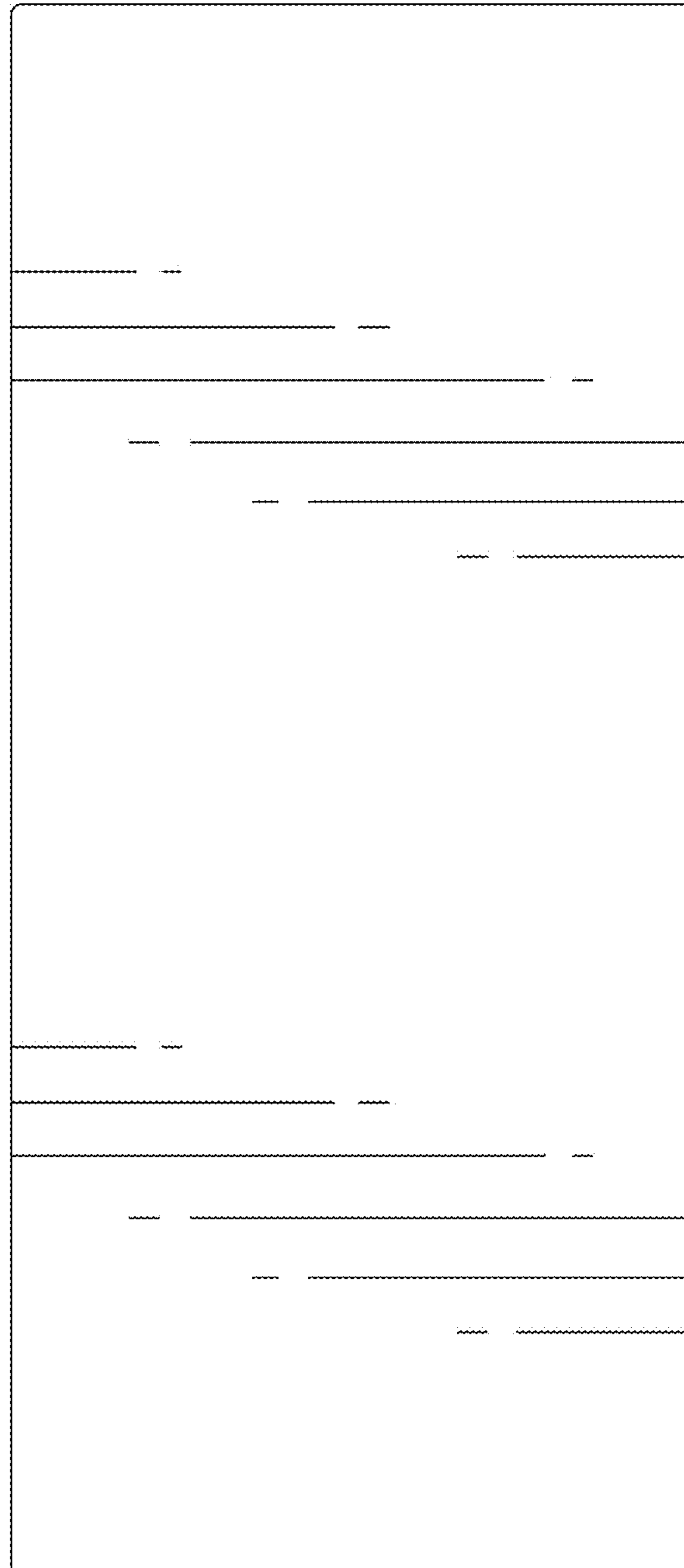

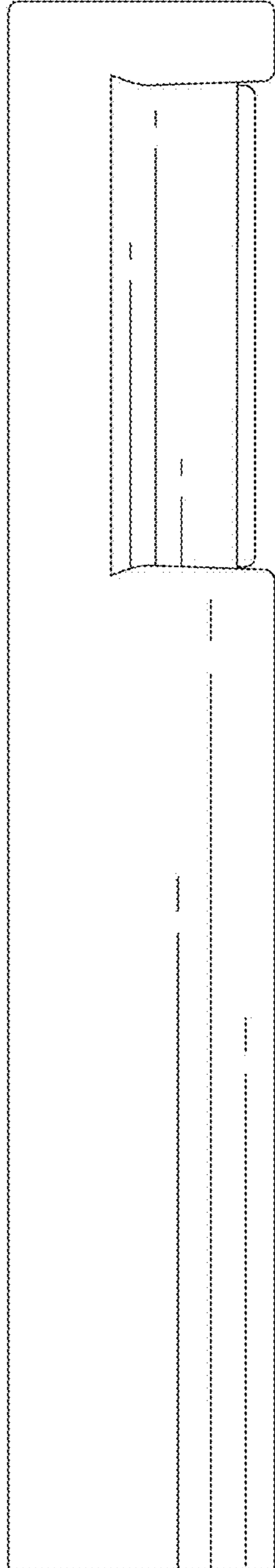

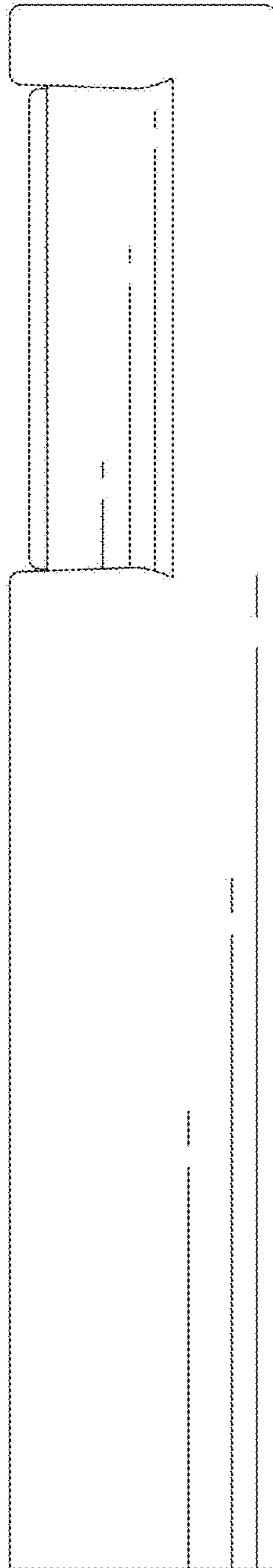

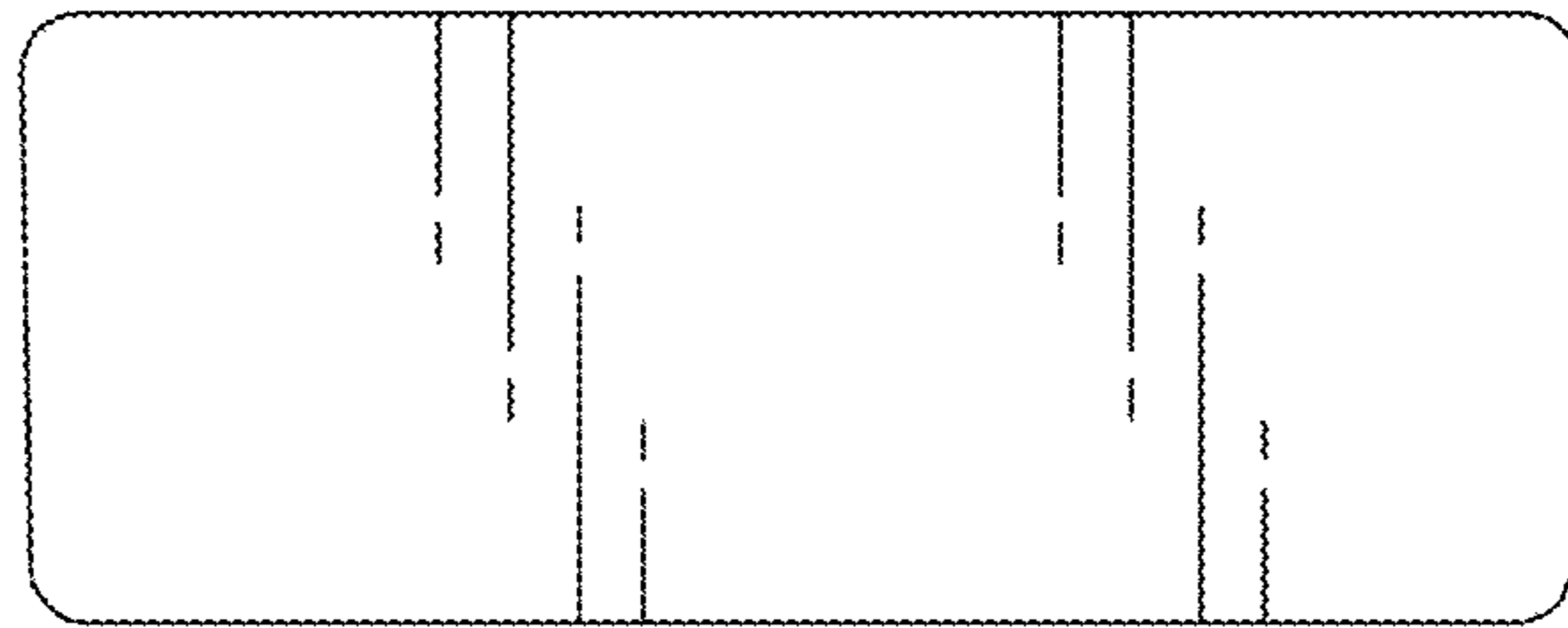

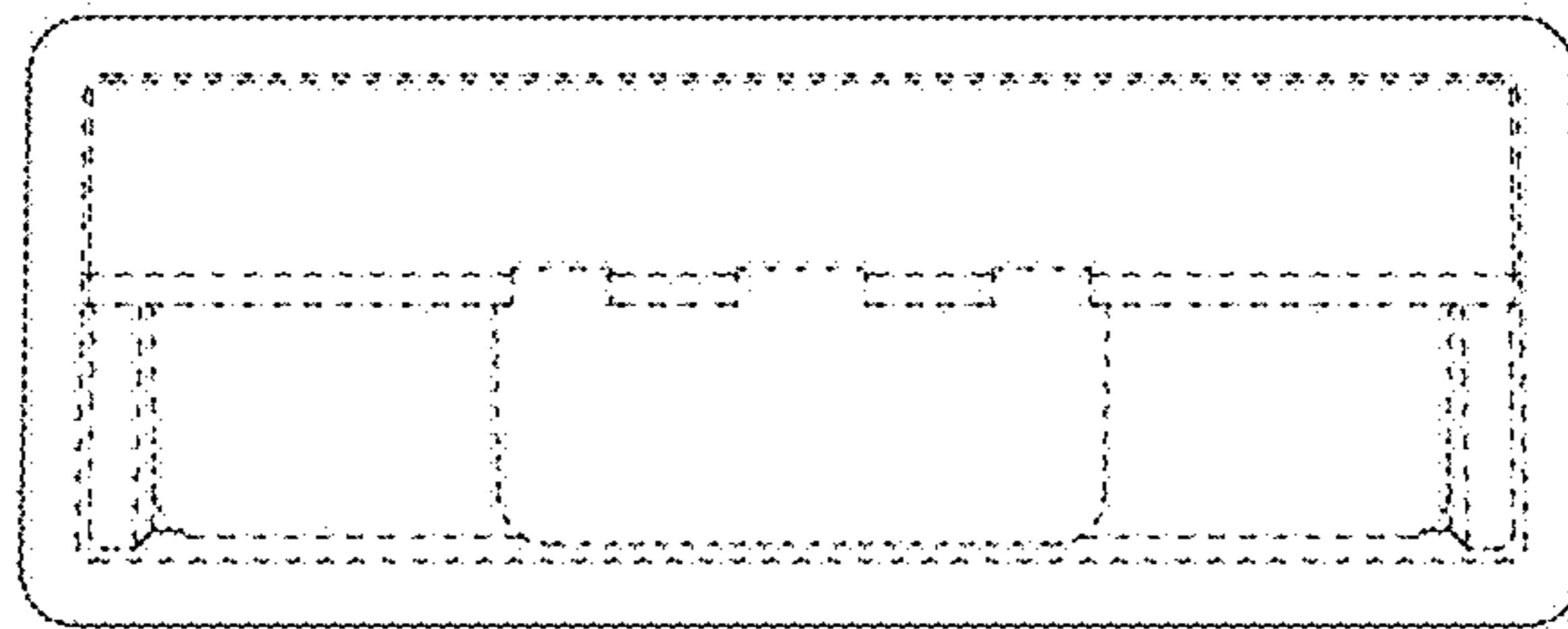
