The ornamental design for a display panel portion with a graphical user interface component for an aircraft maintenance interface, as shown and described.

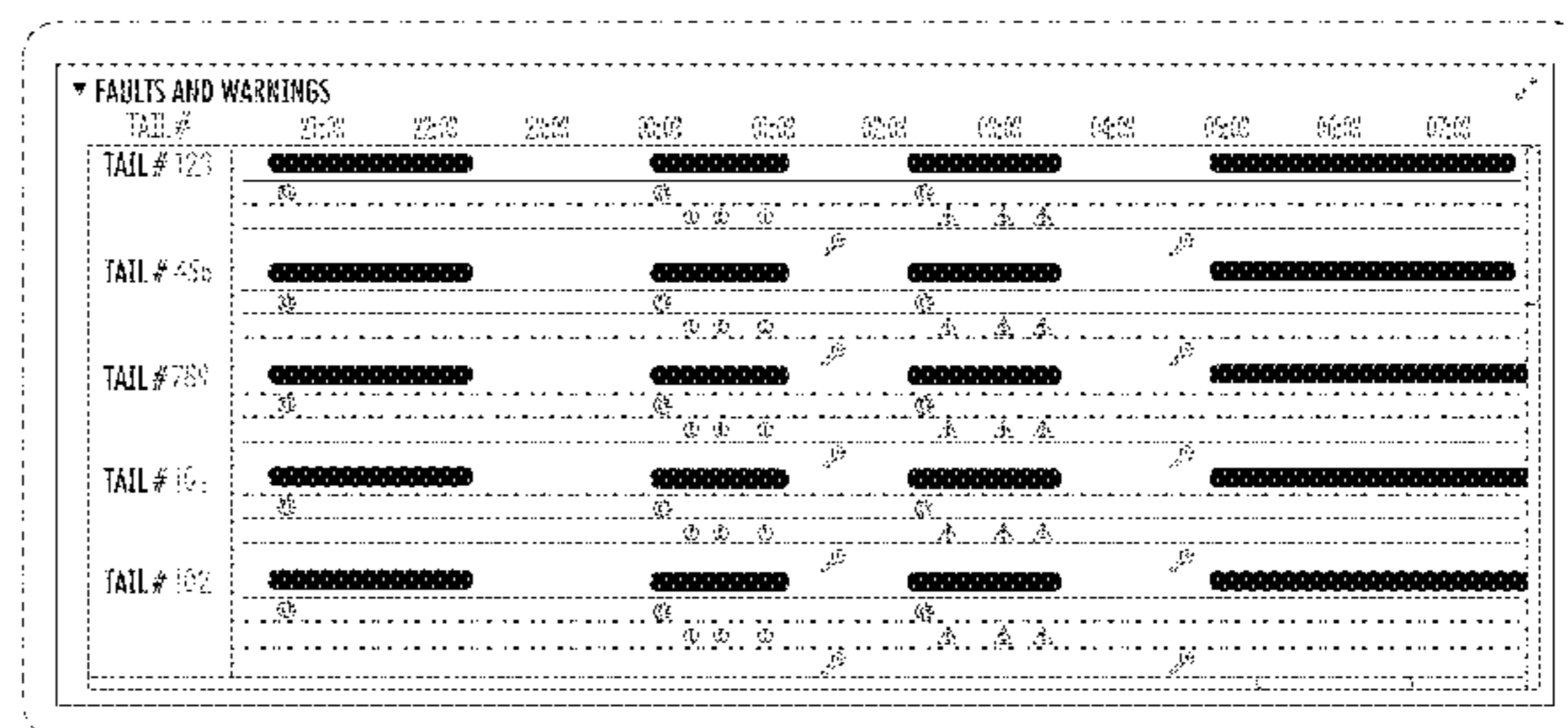
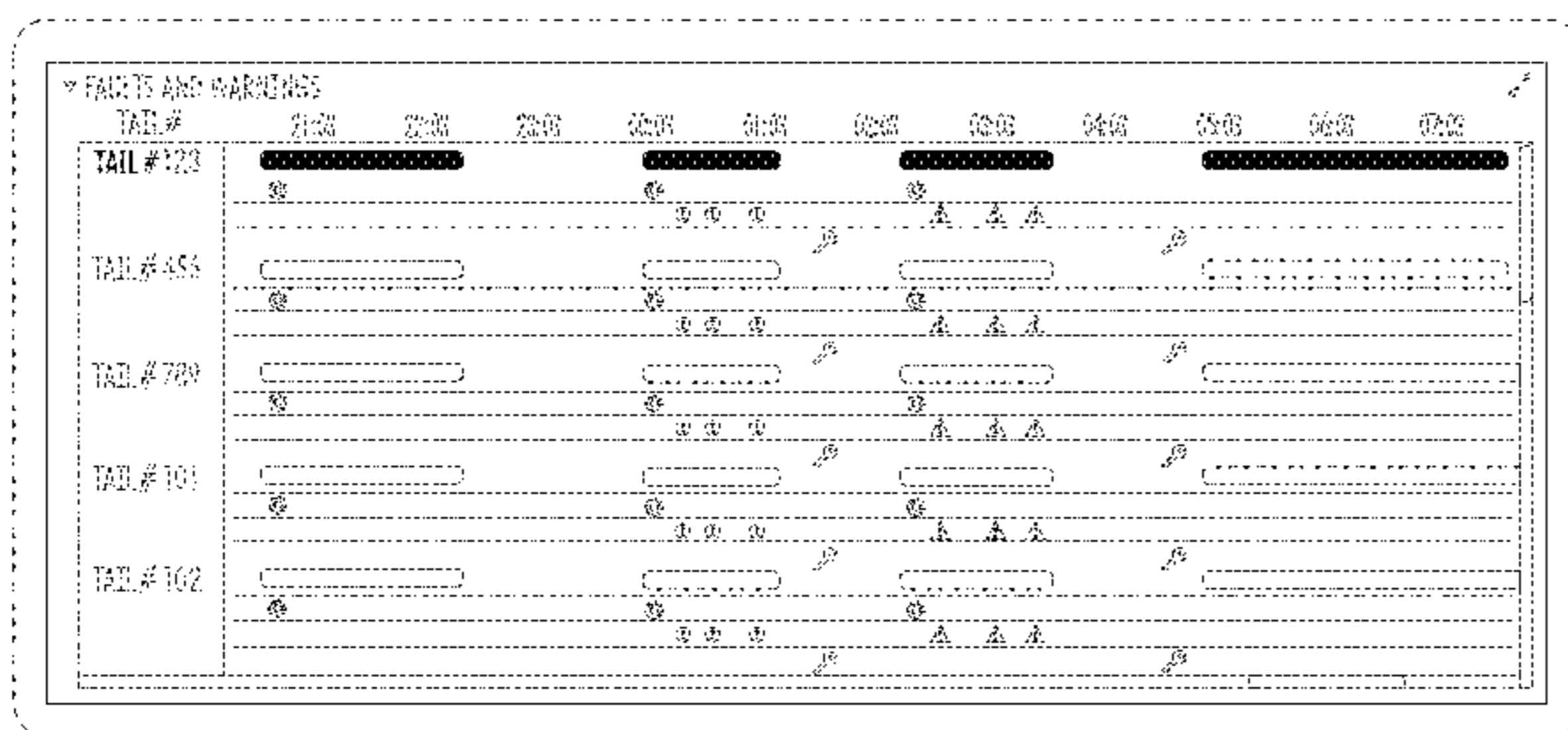
**DESCRIPTION**

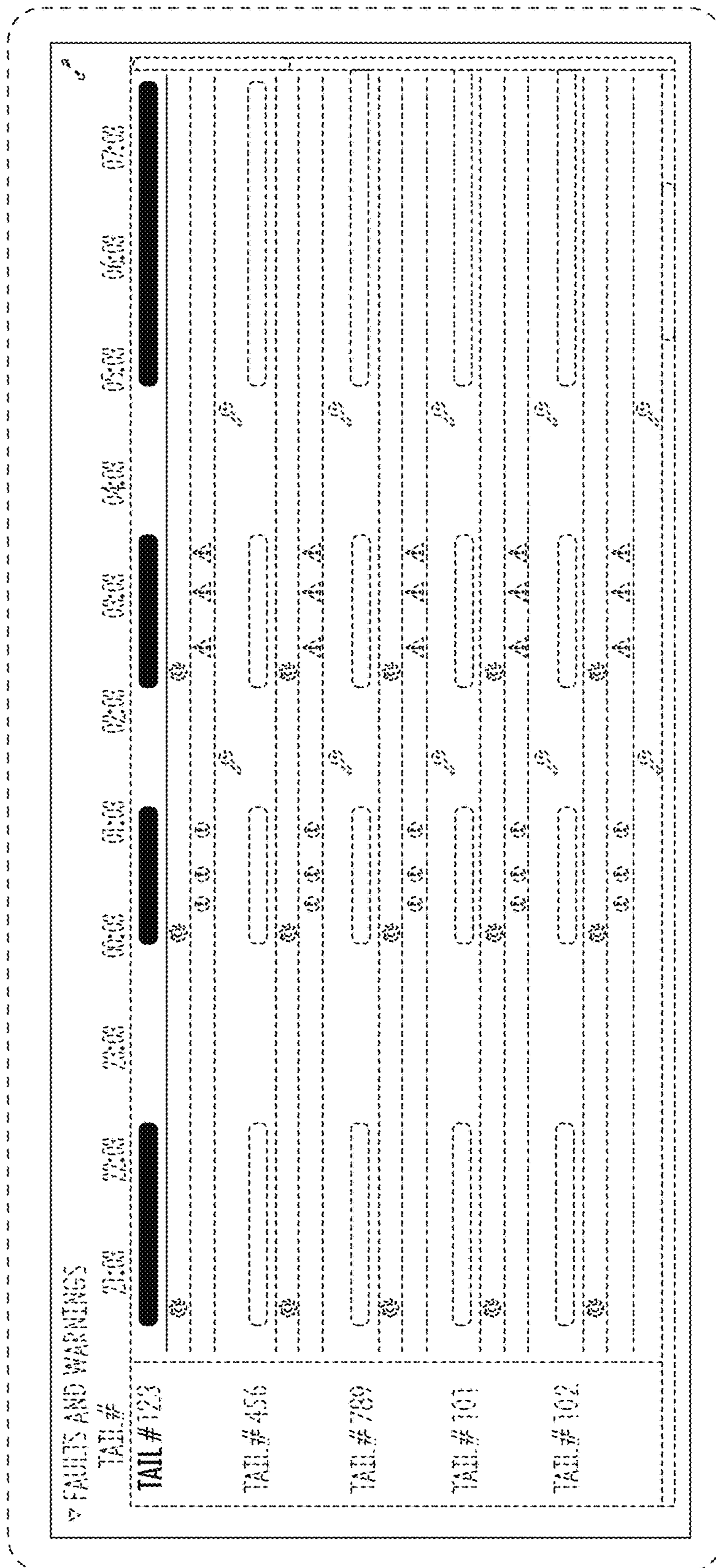

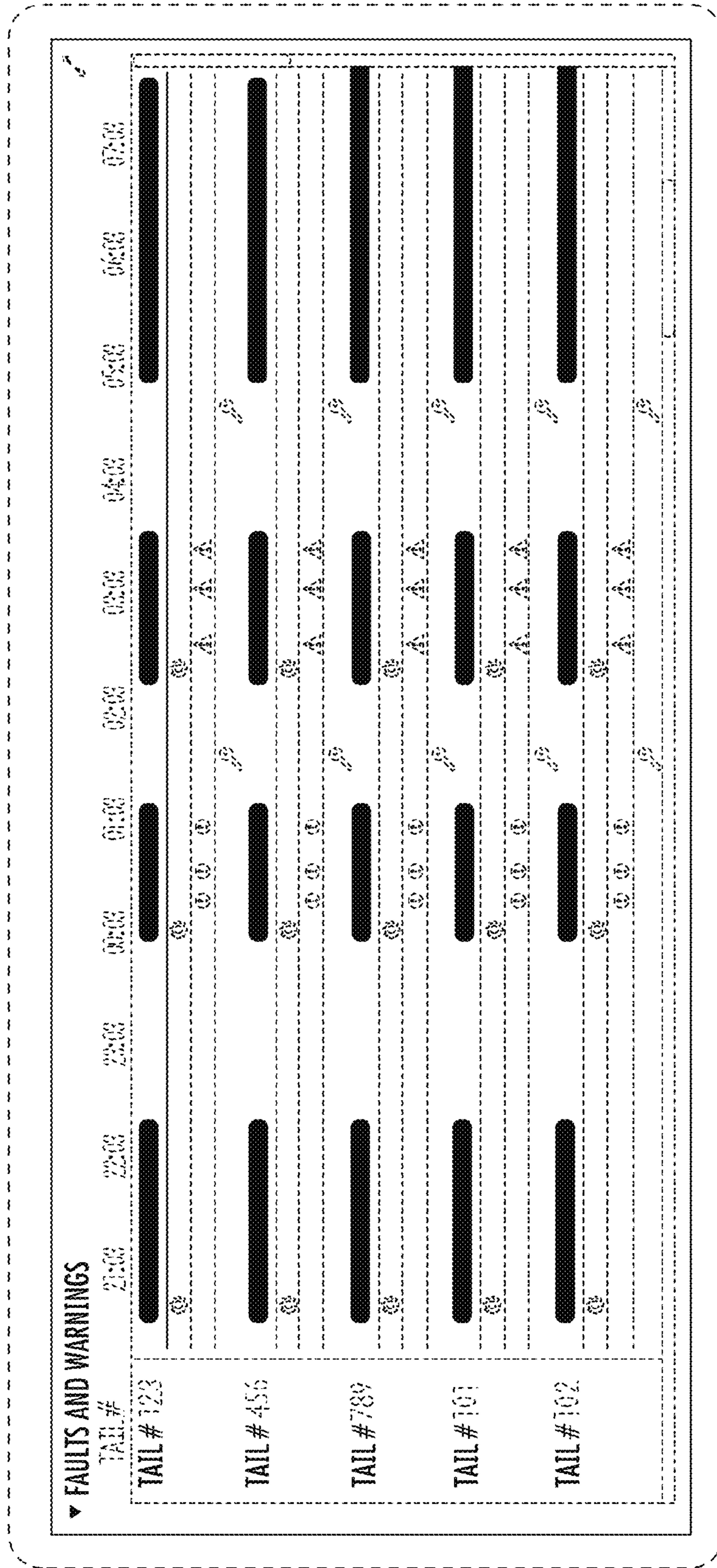
