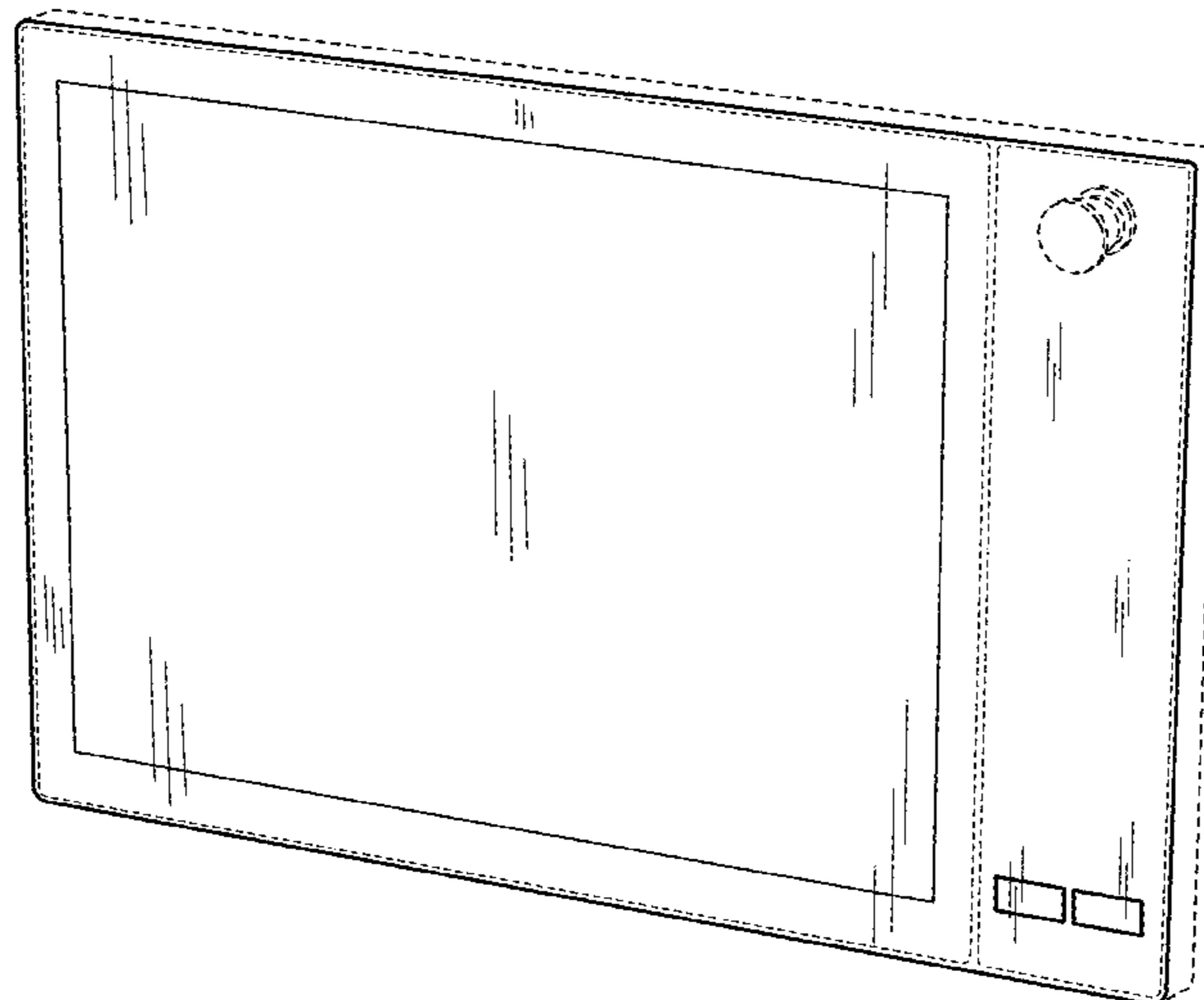

The ornamental design for a machine tool display panel, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of our machine tool display panel.
FIG. 2 is a front view thereof.

FIG. 4 is a left side elevational view thereof.
FIG. 5 is a right side elevational view thereof.
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

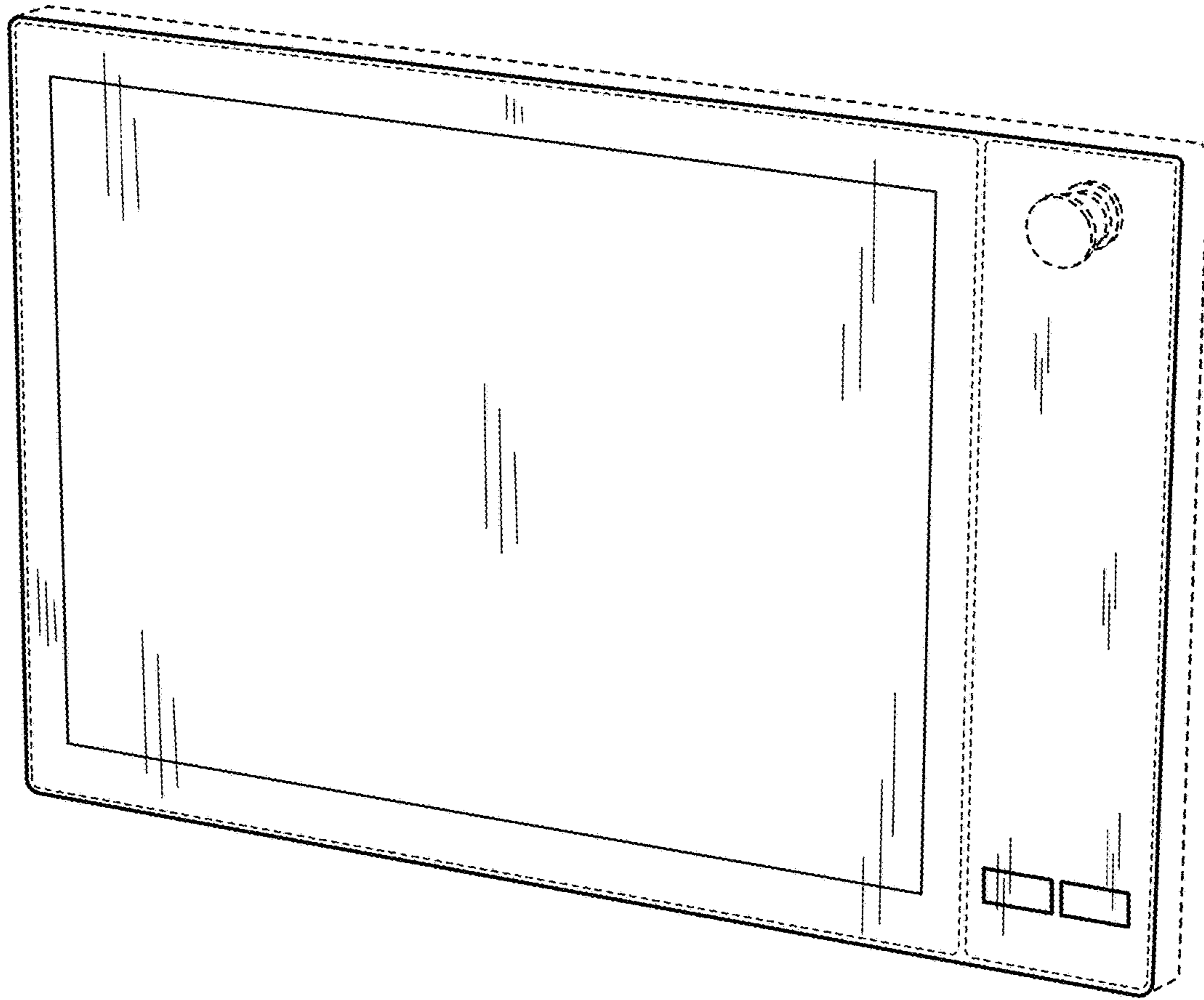

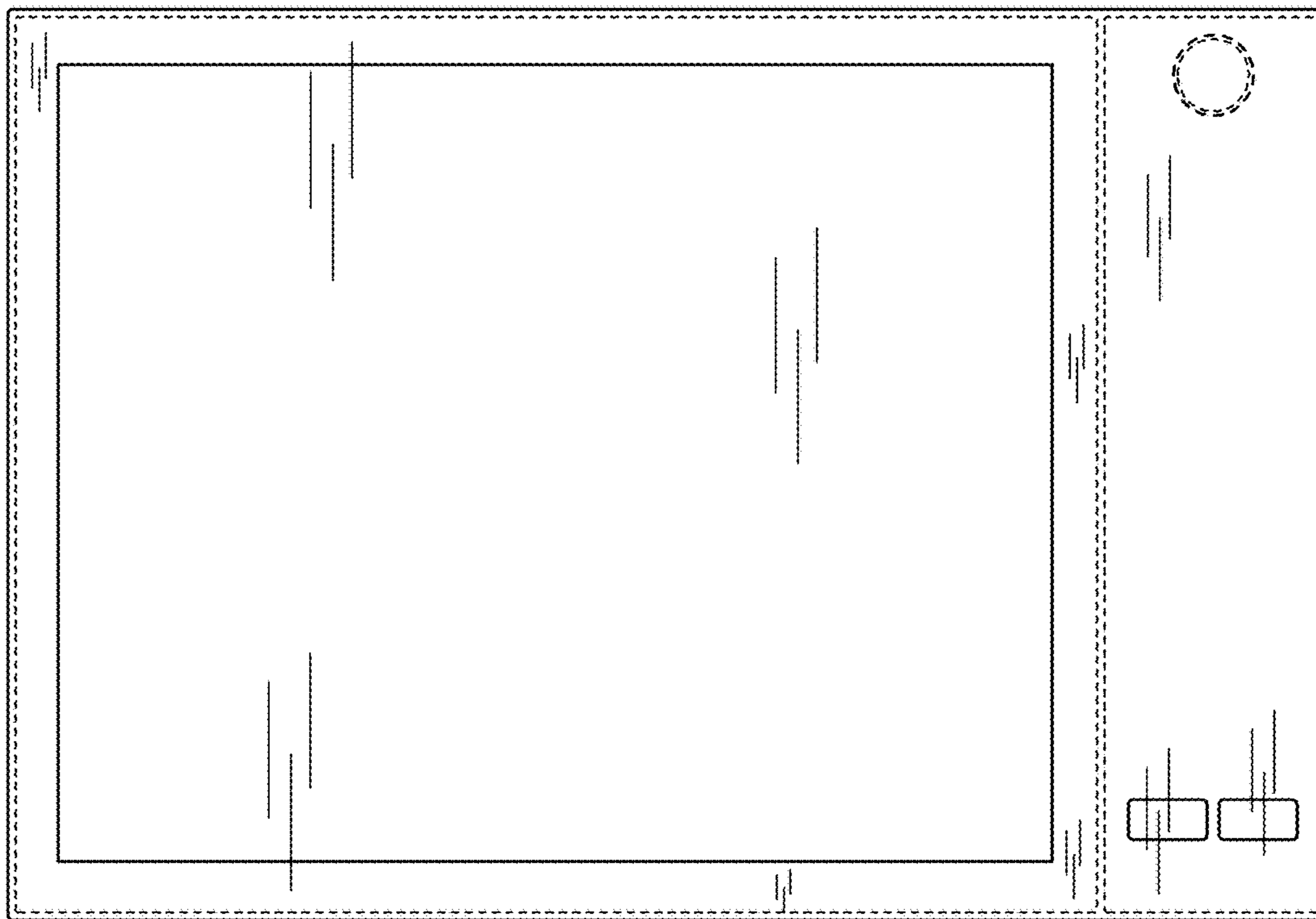

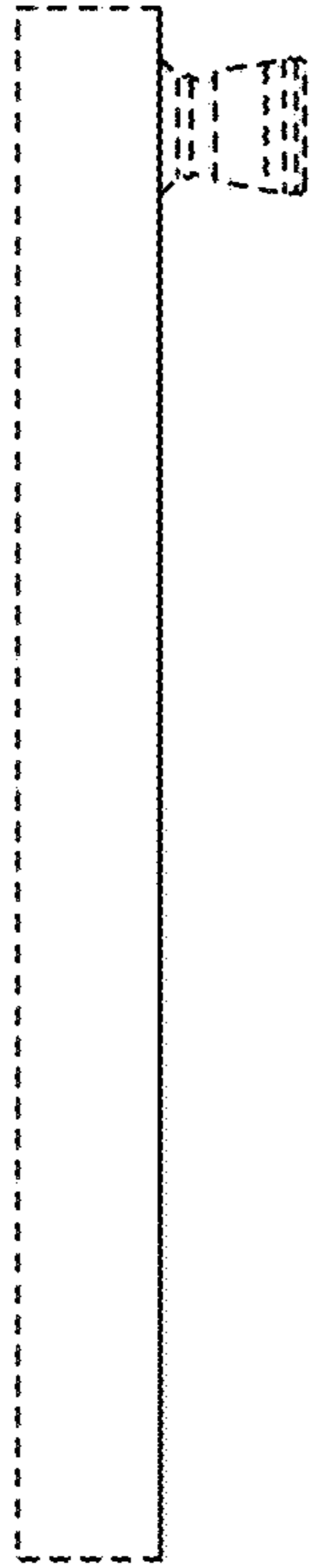

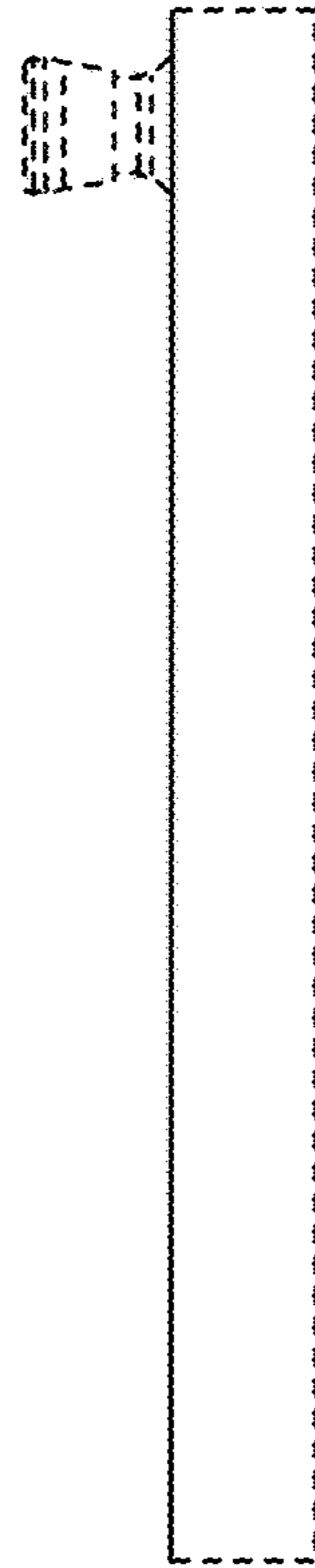

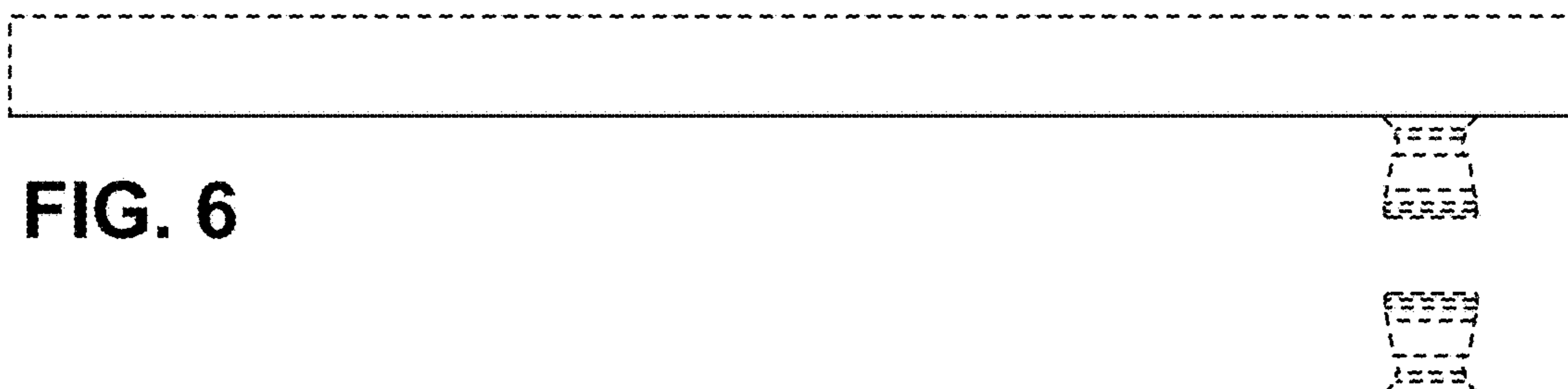
