**DESCRIPTION**

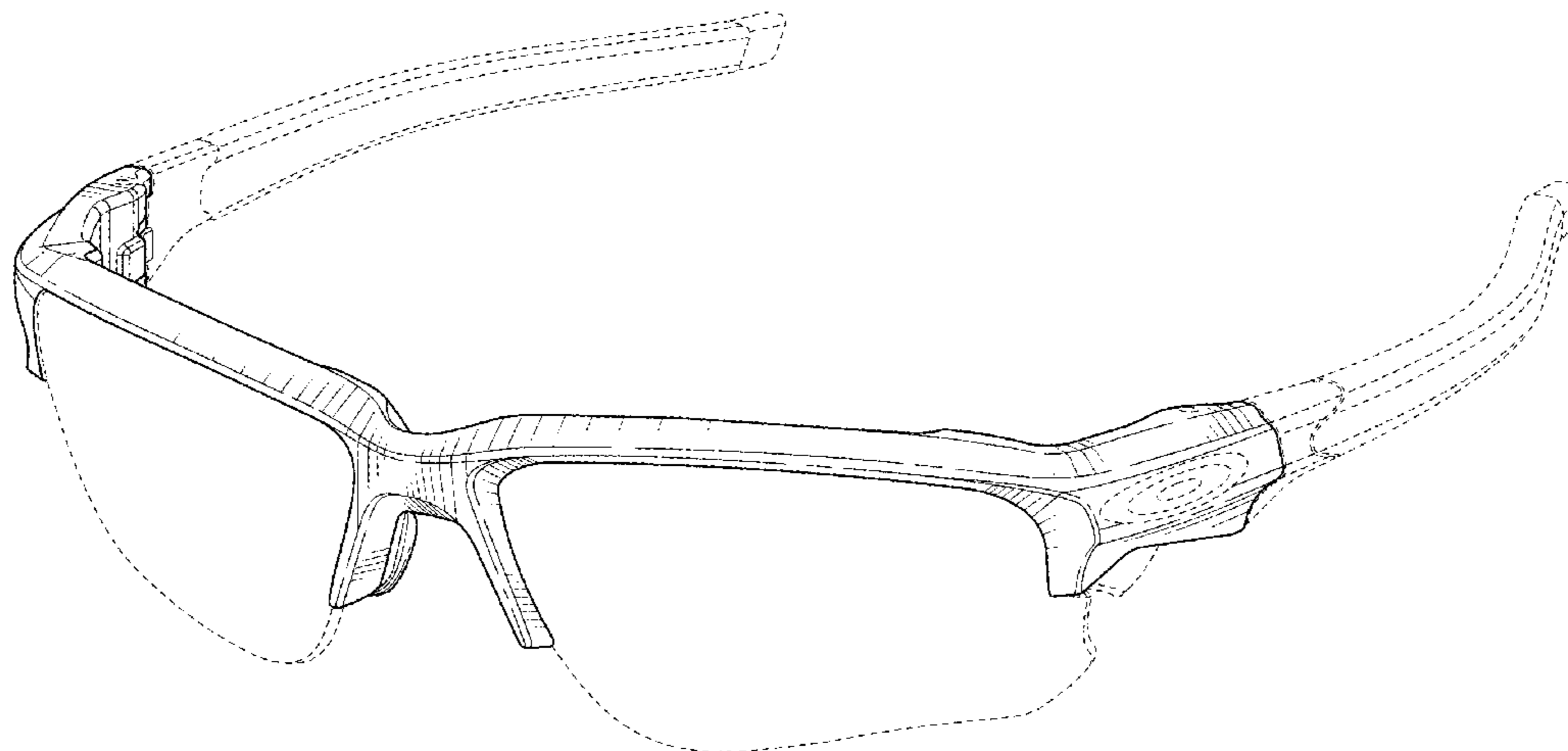
FIG. 1 is a front perspective view of an eyeglass component showing the new design;

FIG. 6 is a bottom plan view thereof.

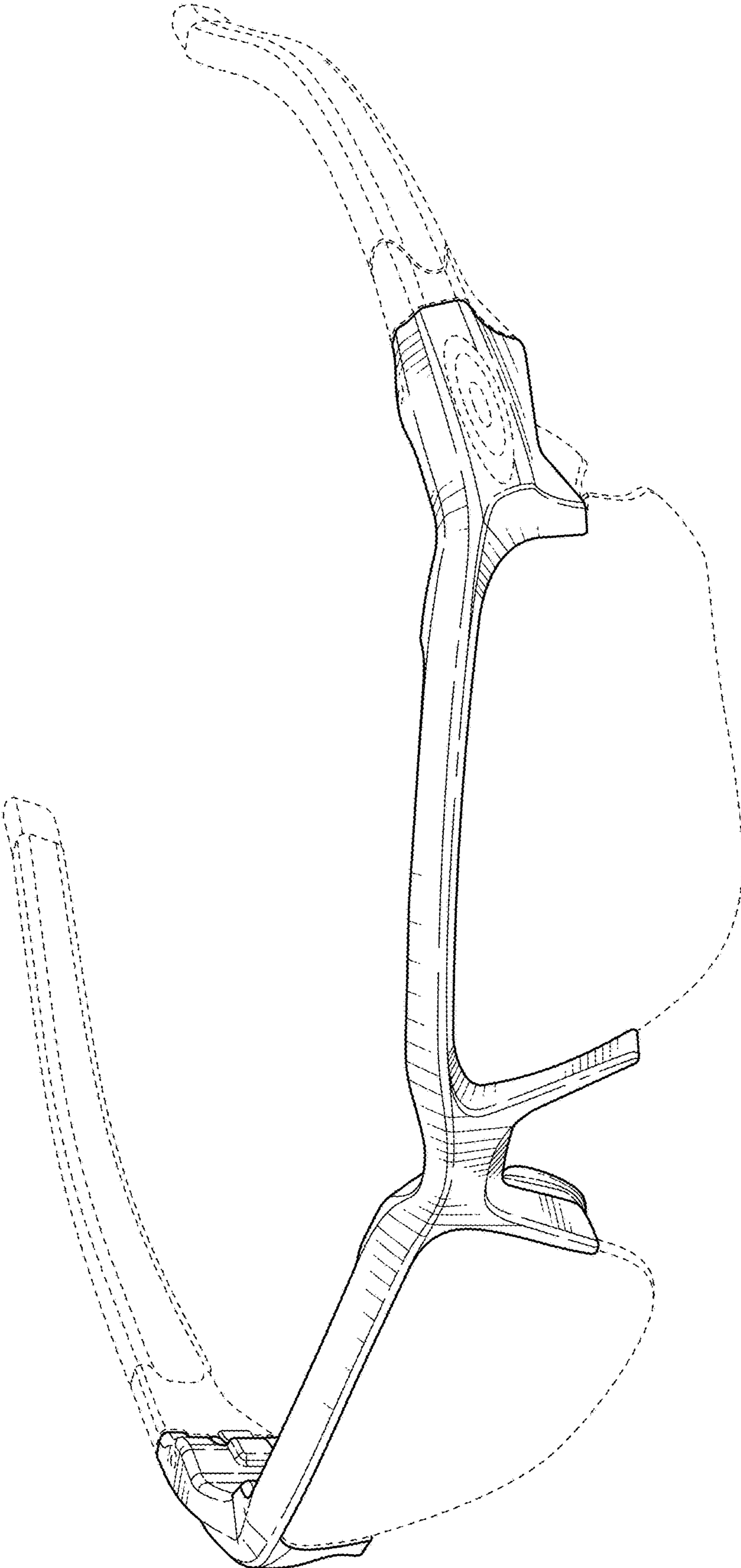

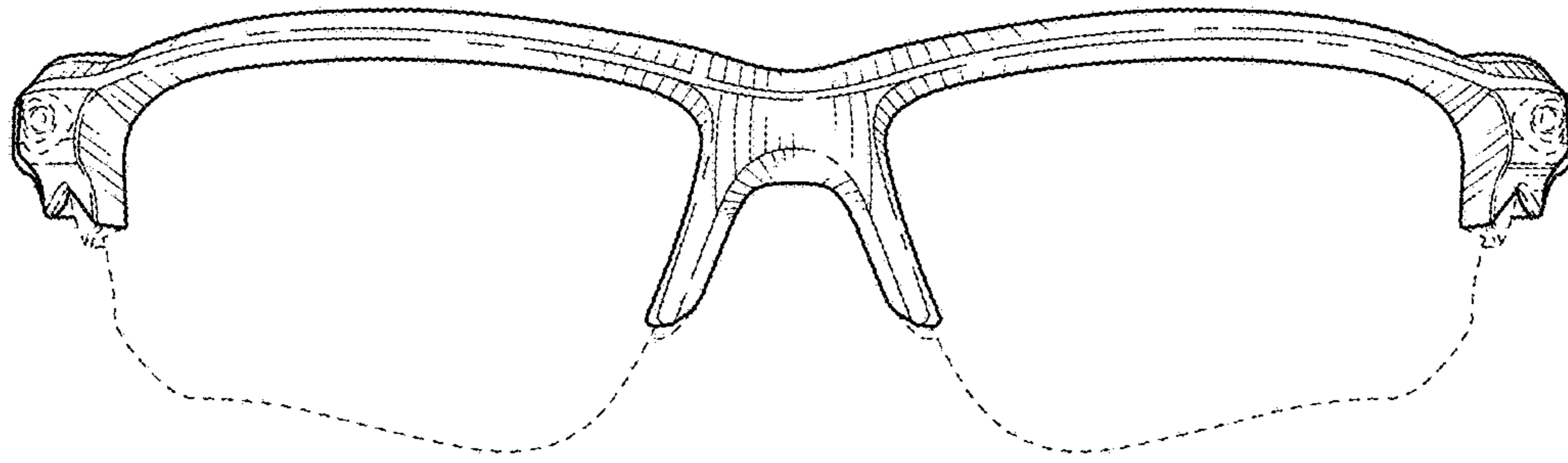

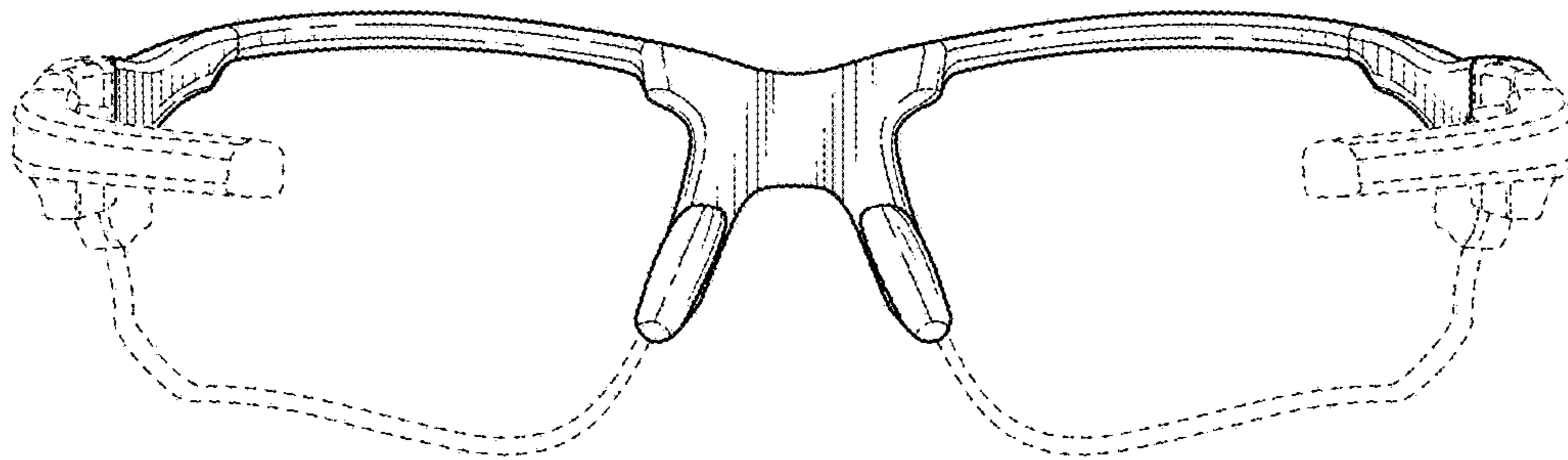

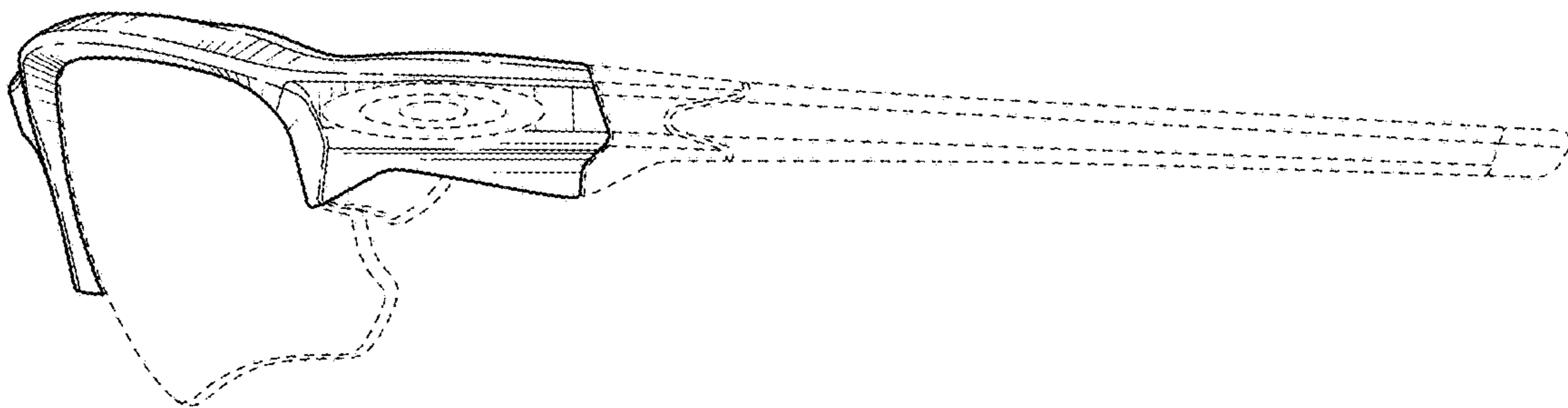

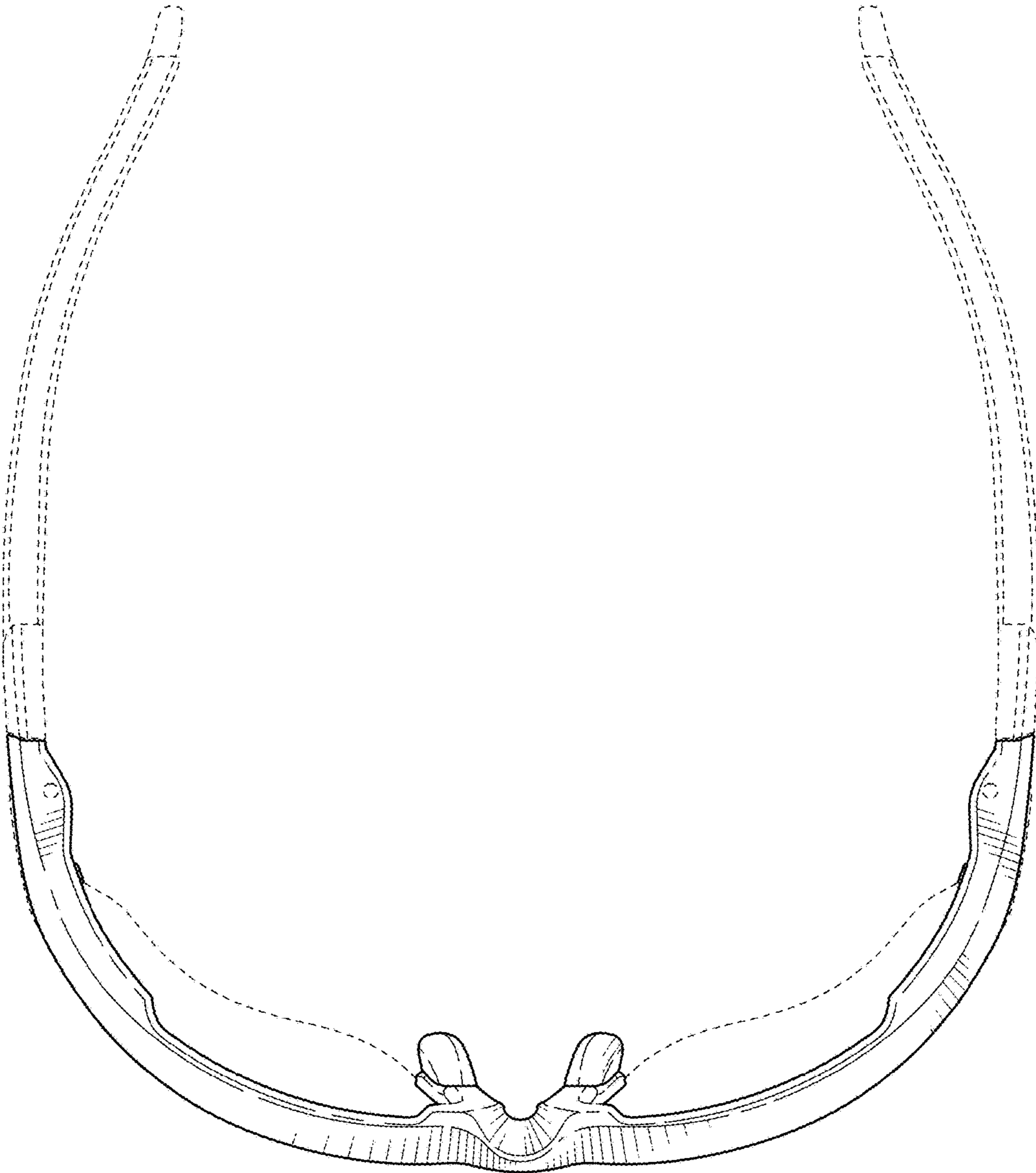

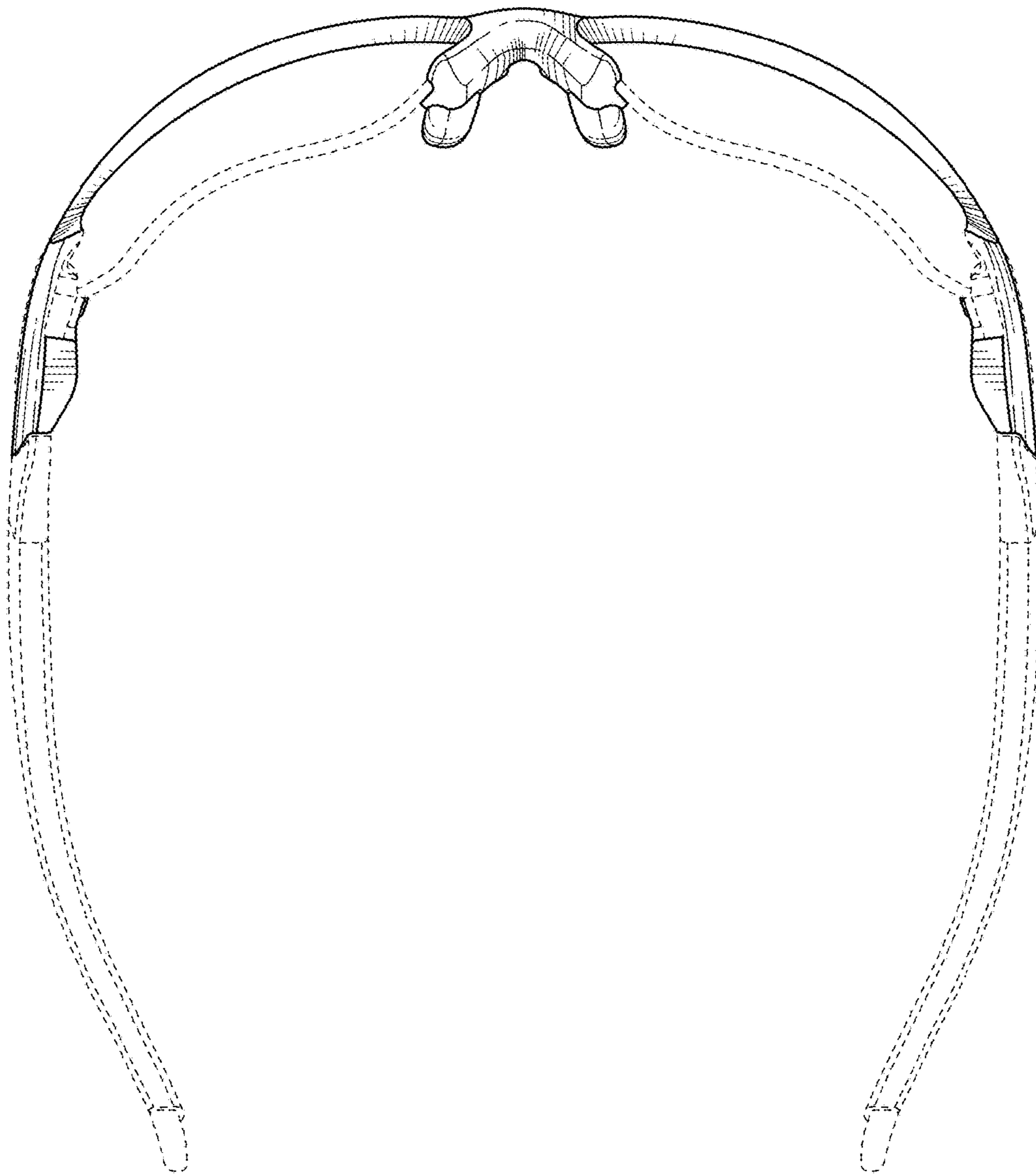
