(57) **CLAIM**

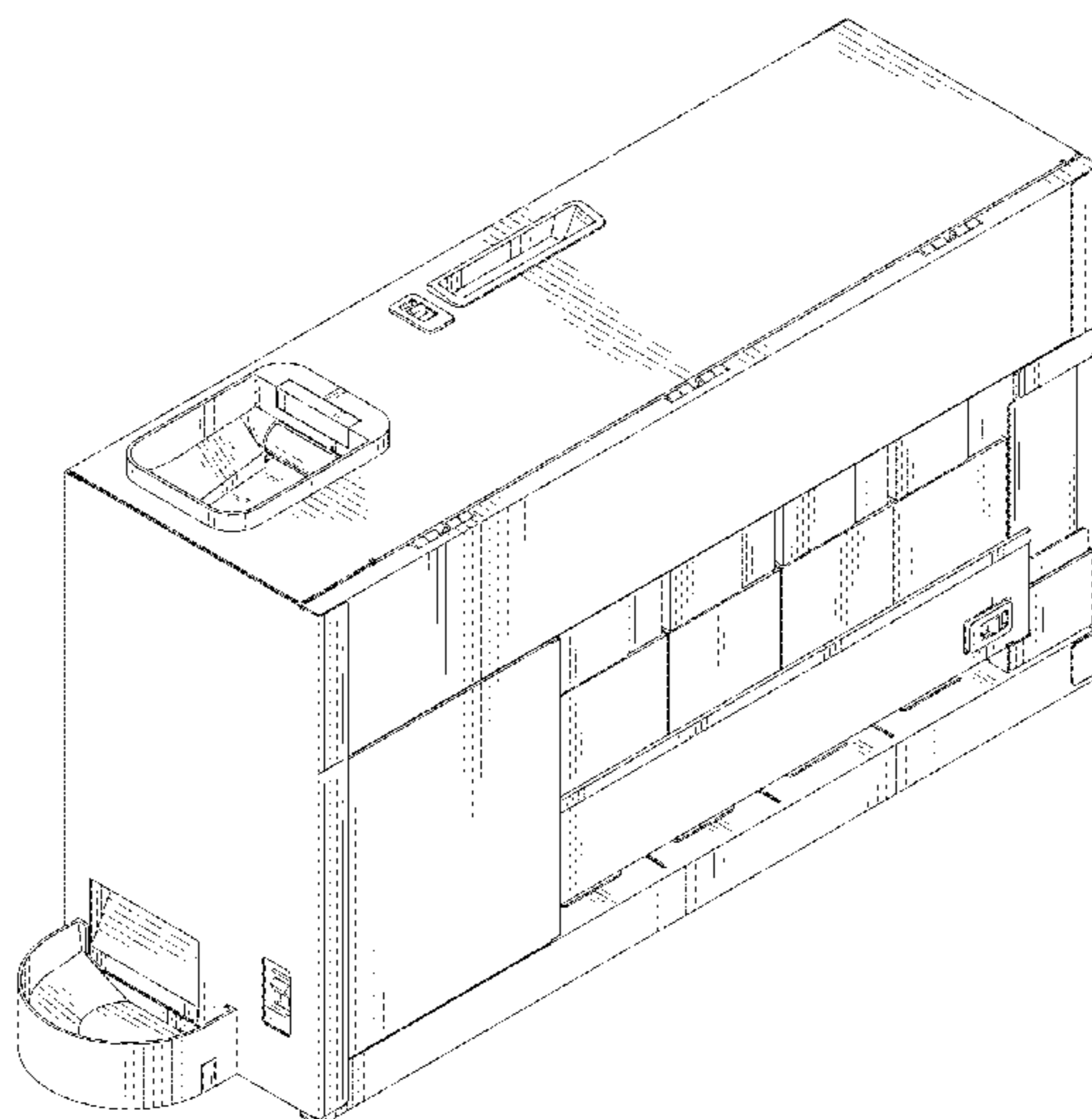
I claim an ornamental design for a coin depositing and dispensing apparatus, as shown and described.

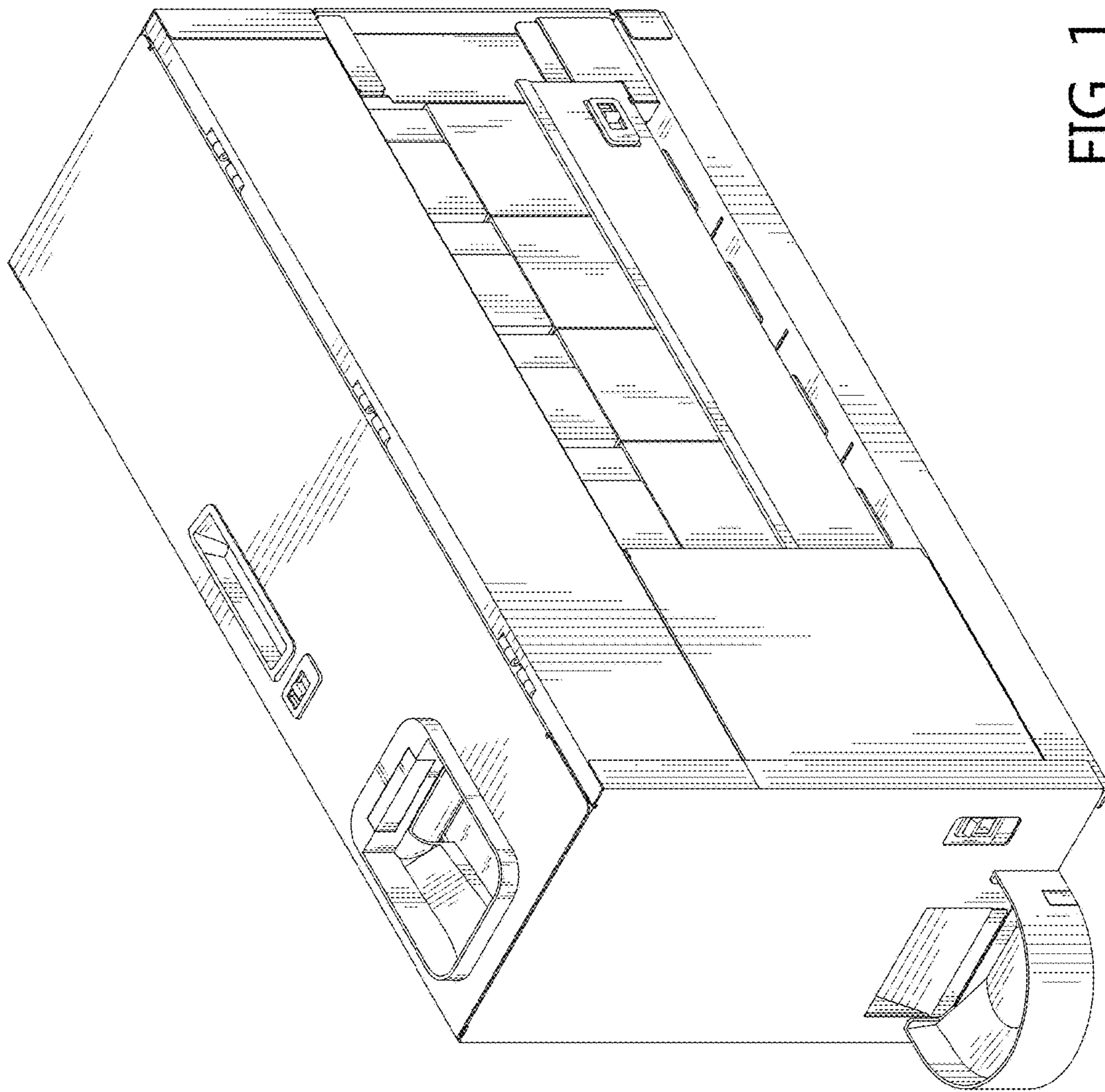

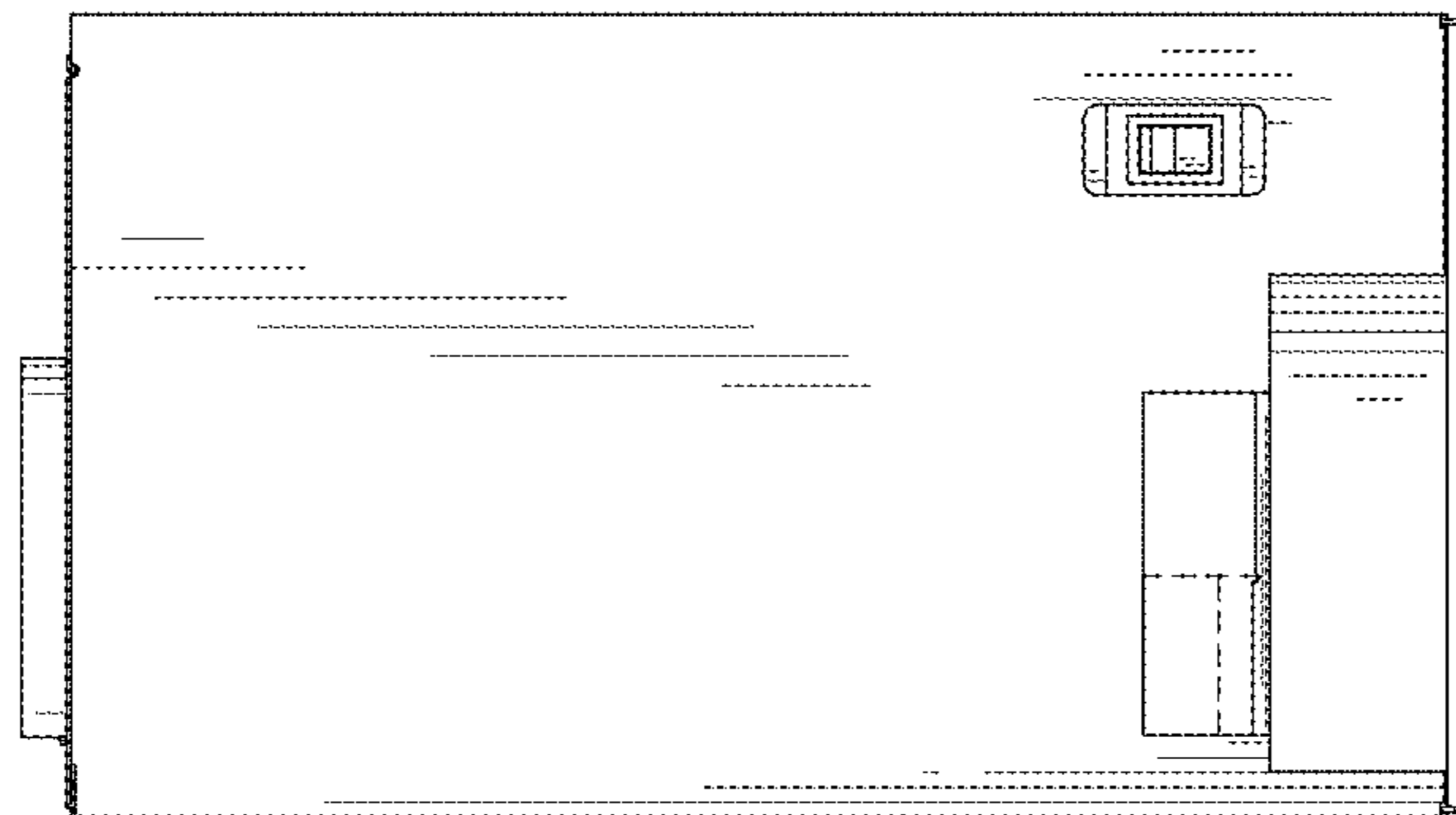

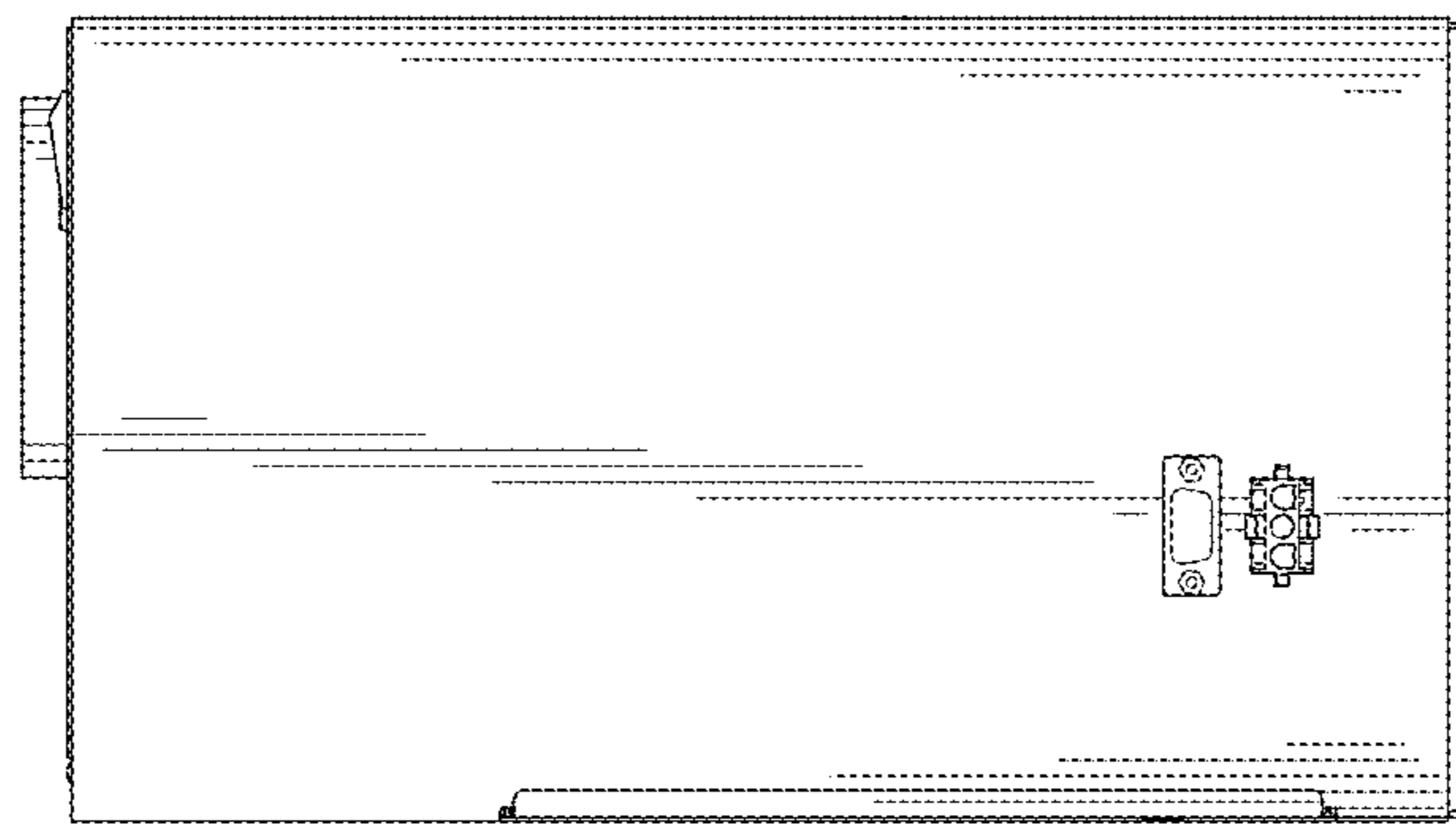

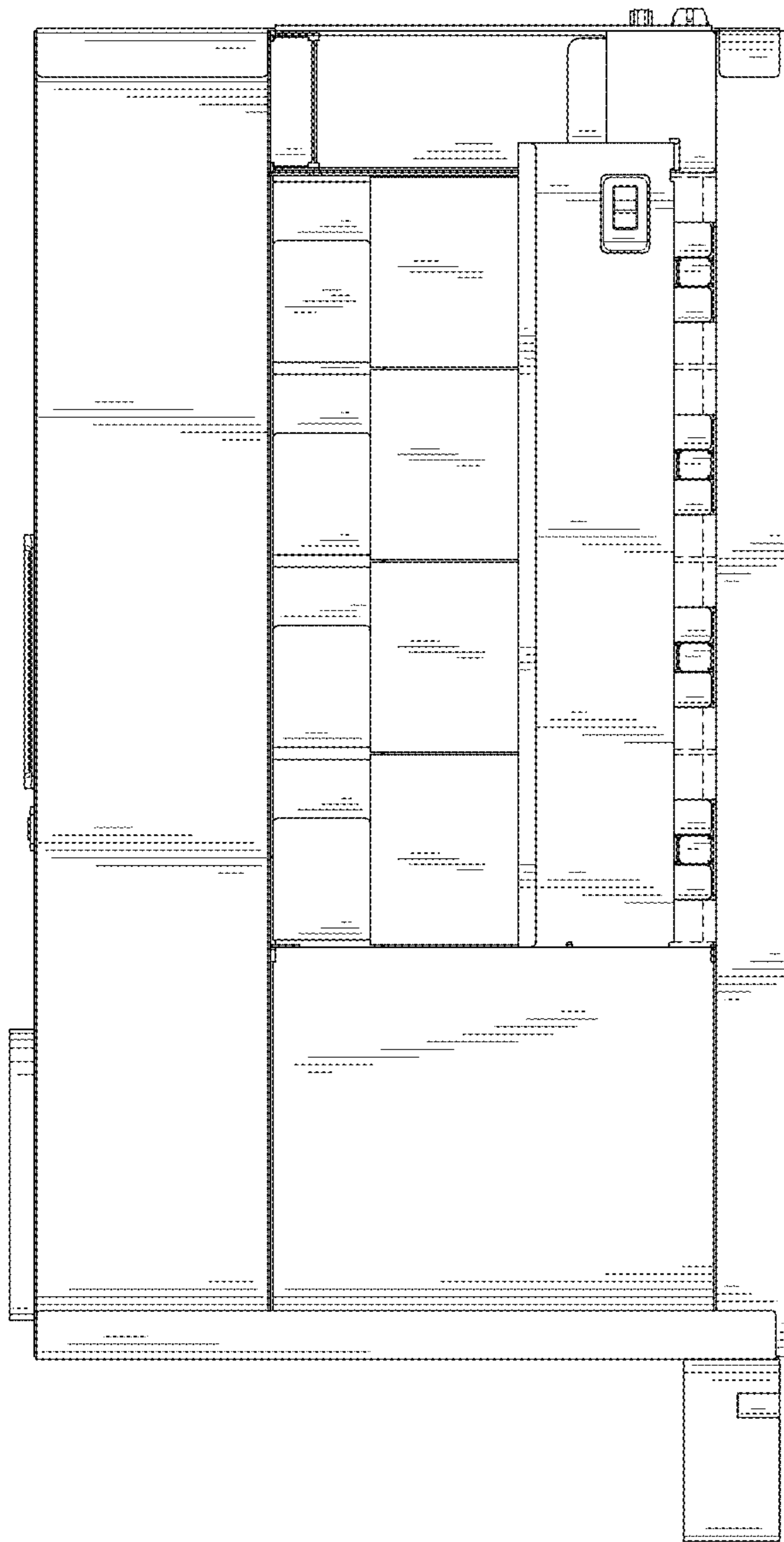

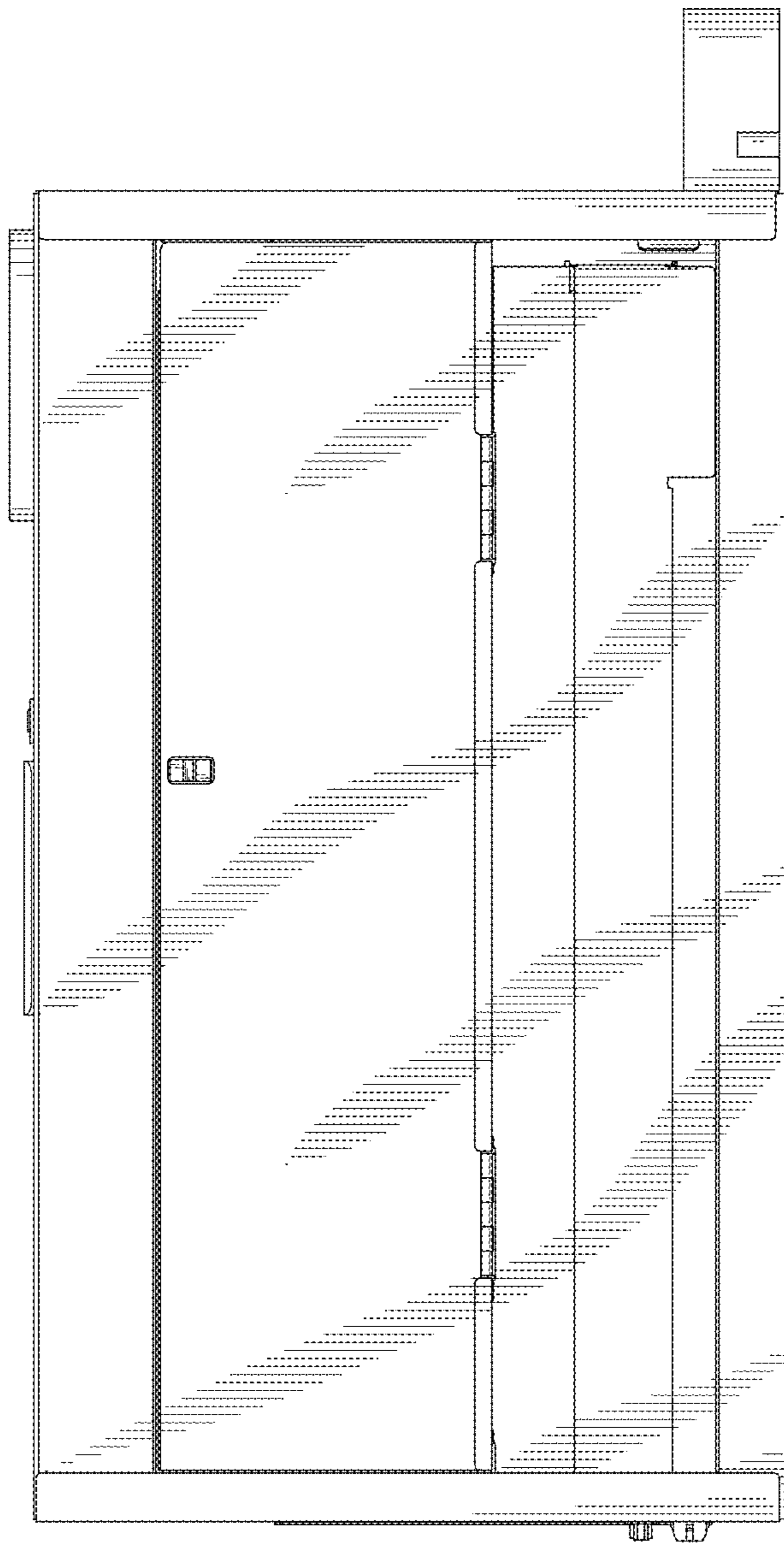

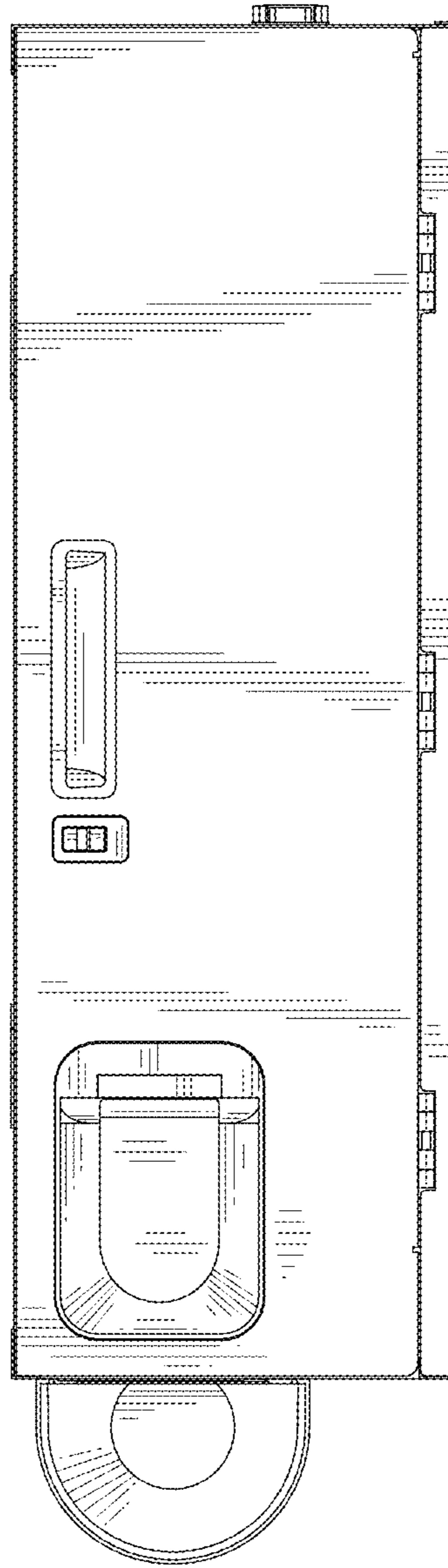

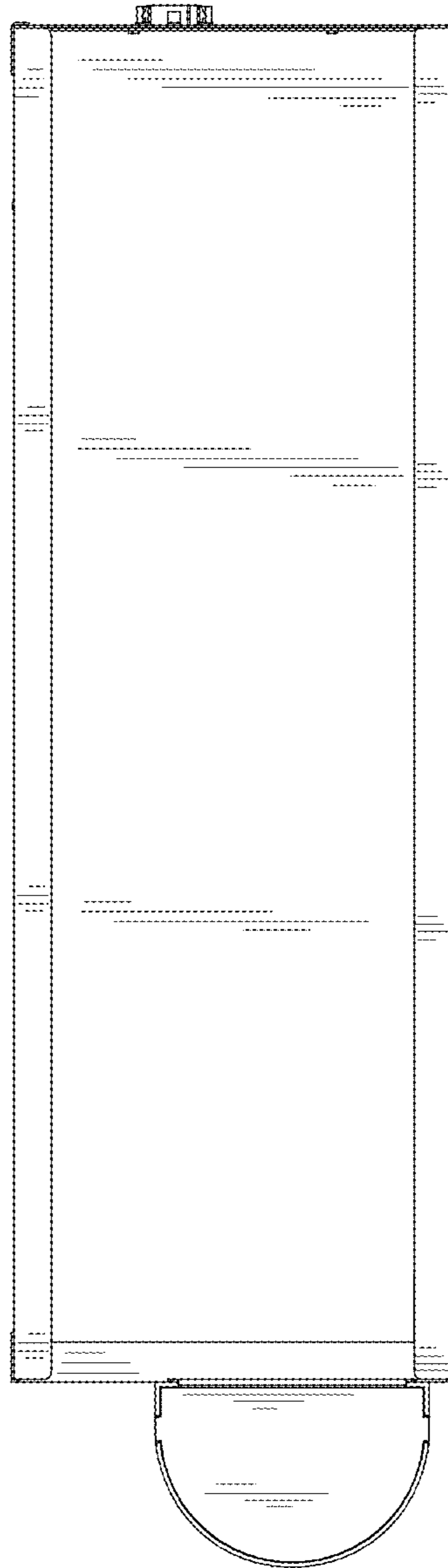
