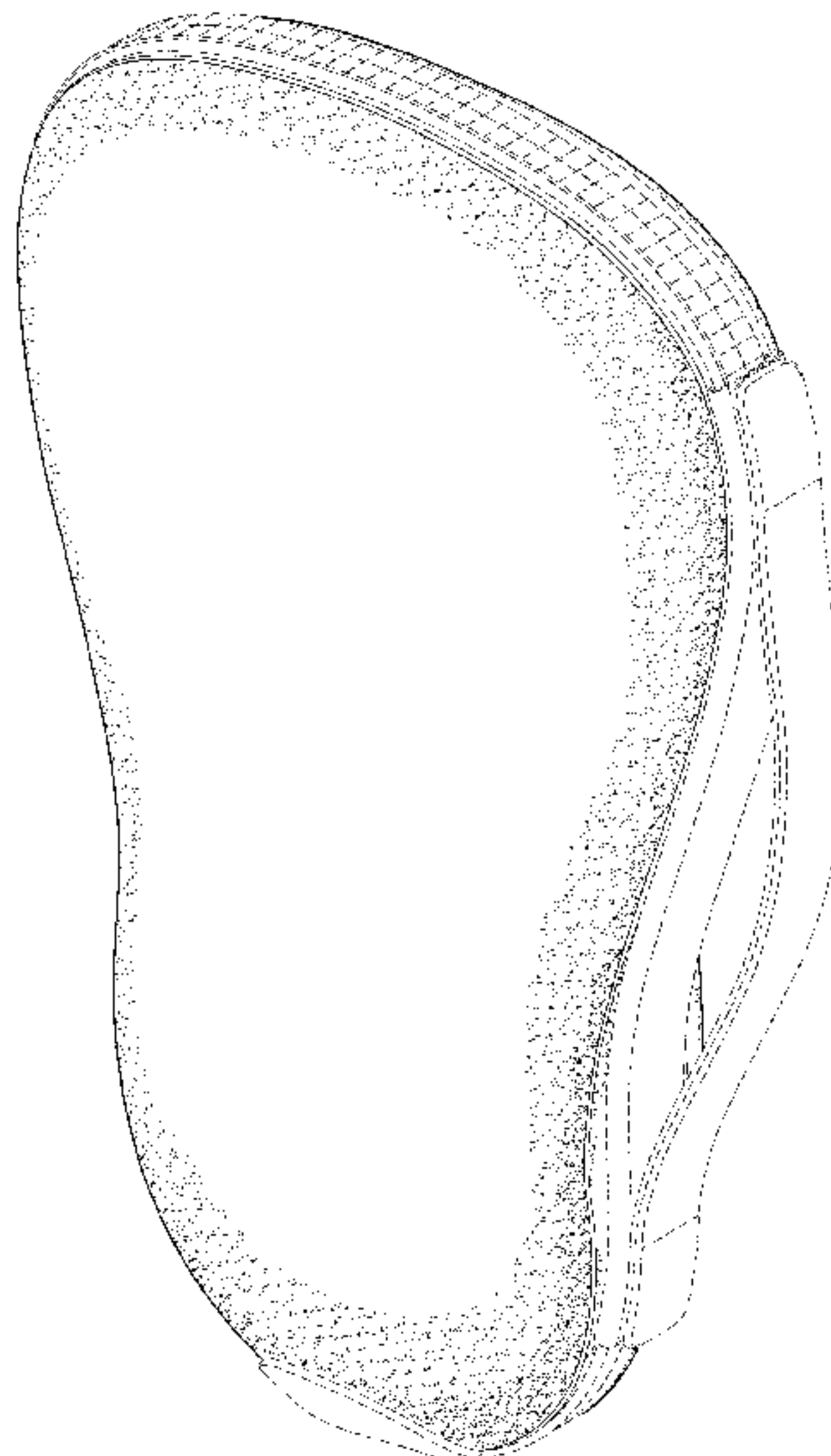
FIG. 1 is a front perspective view of a protective case for lacrosse head, shown in a closed position;

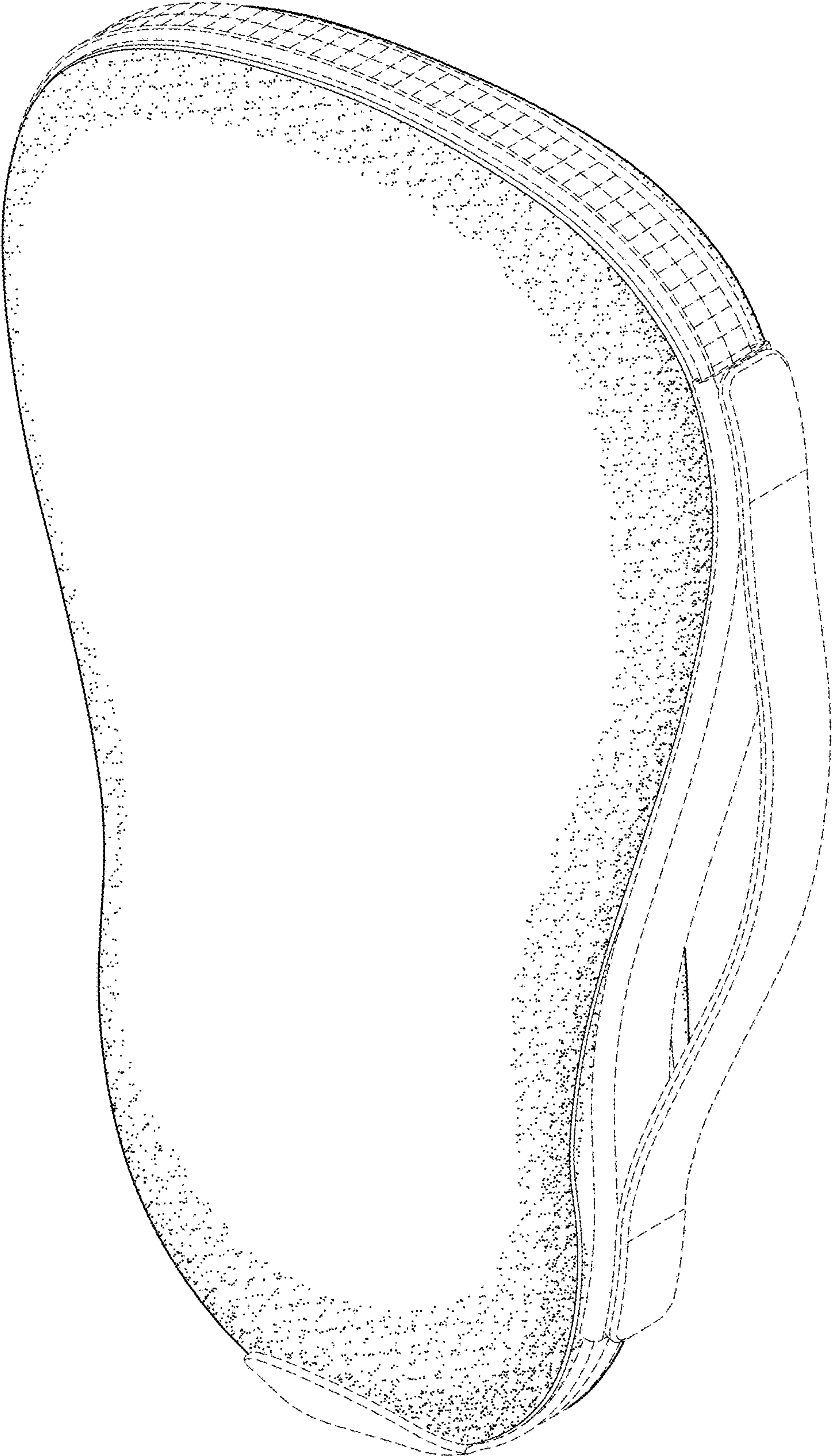

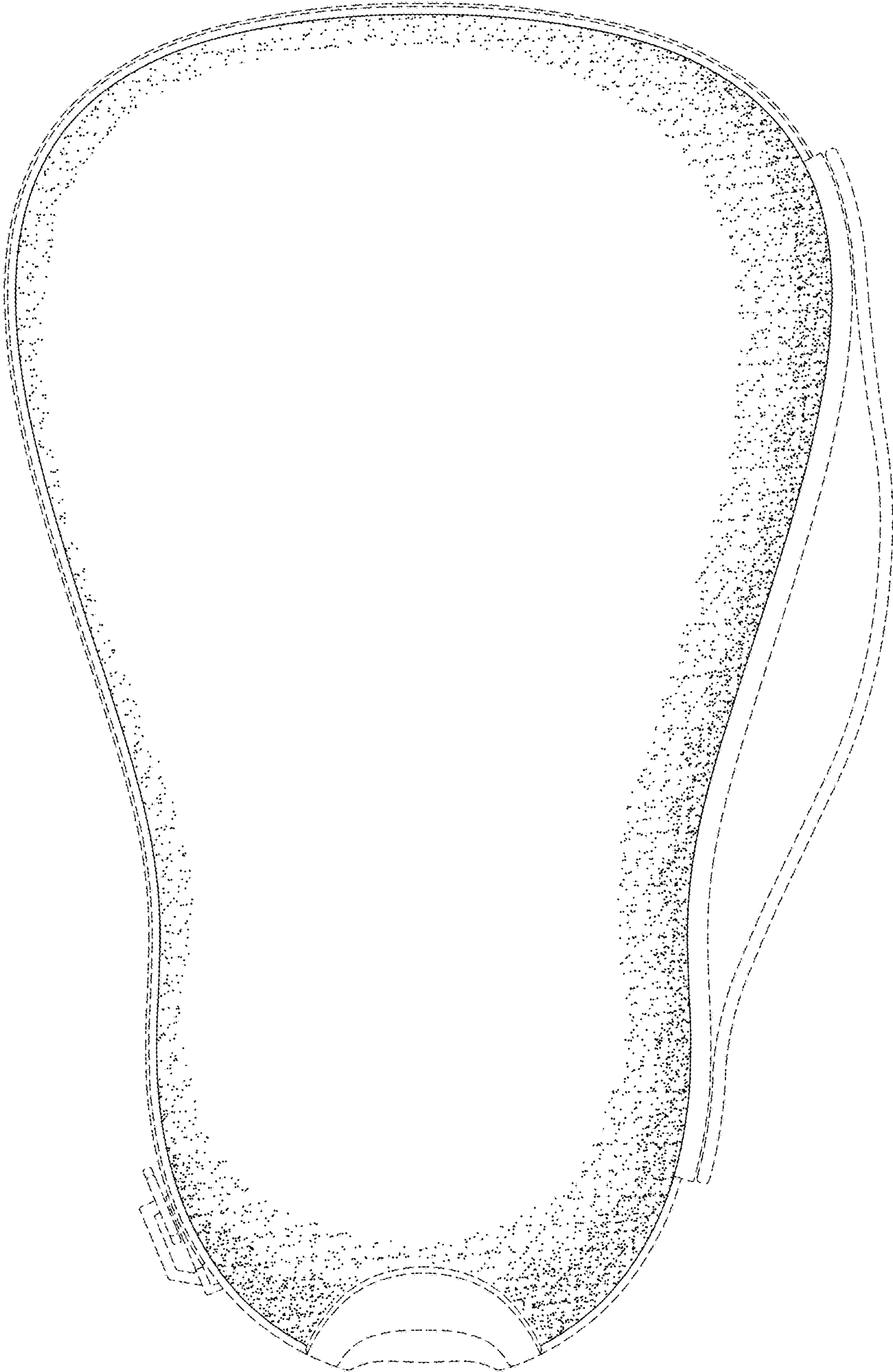

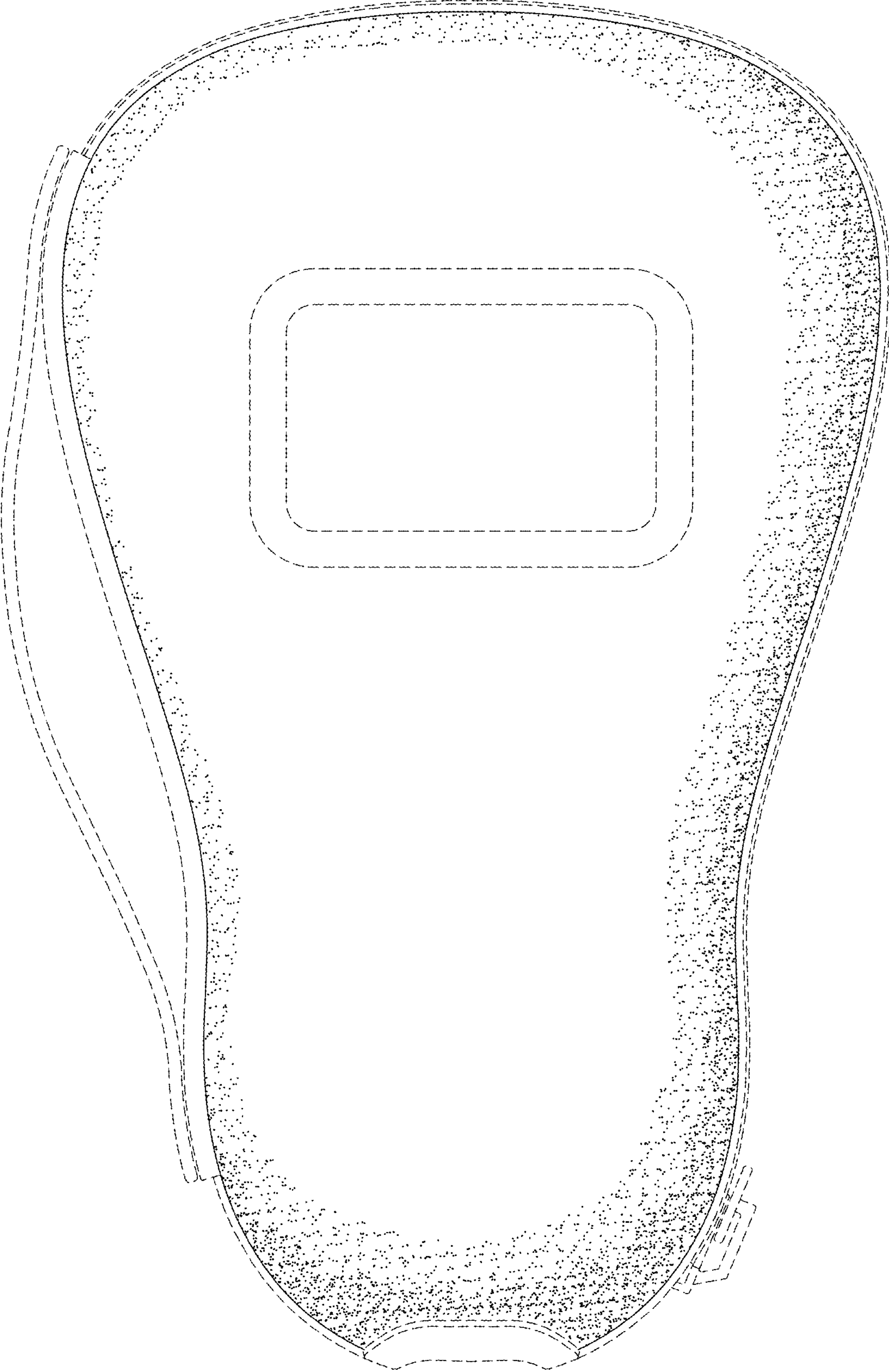

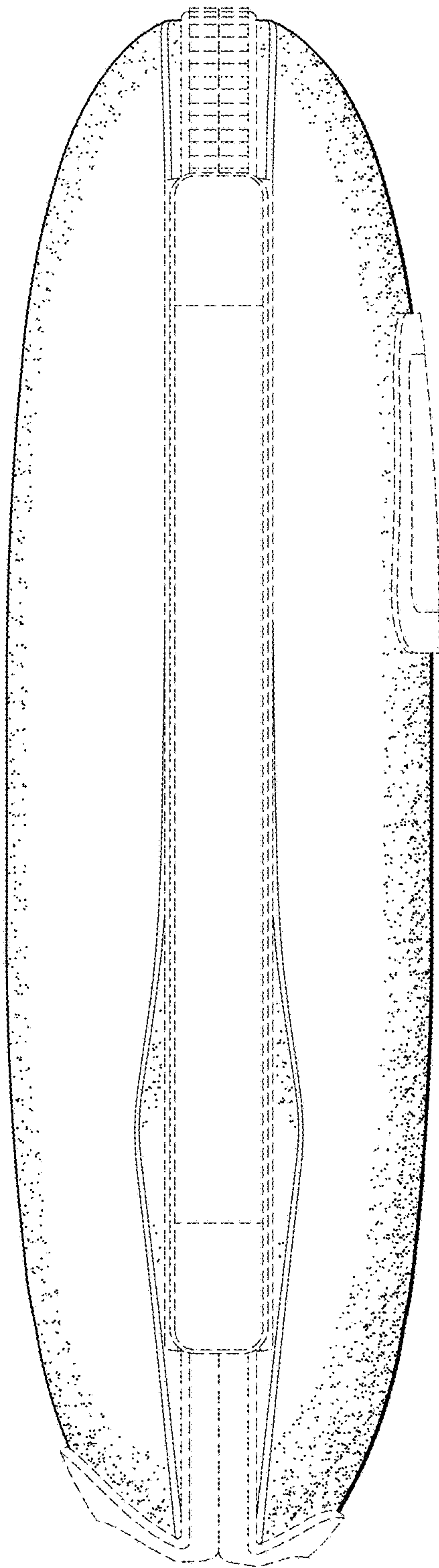

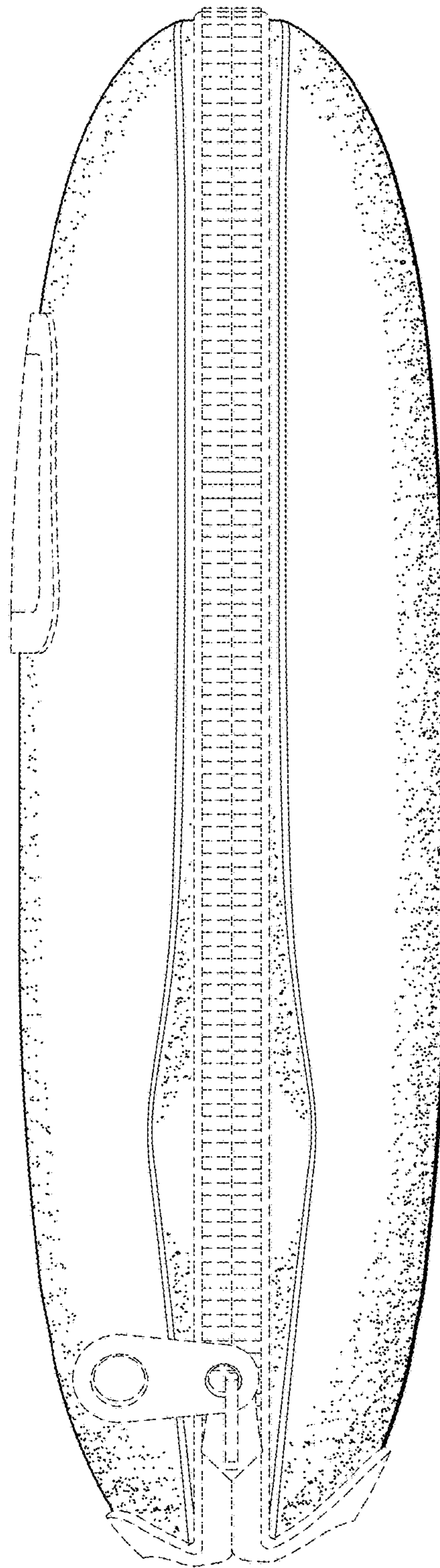

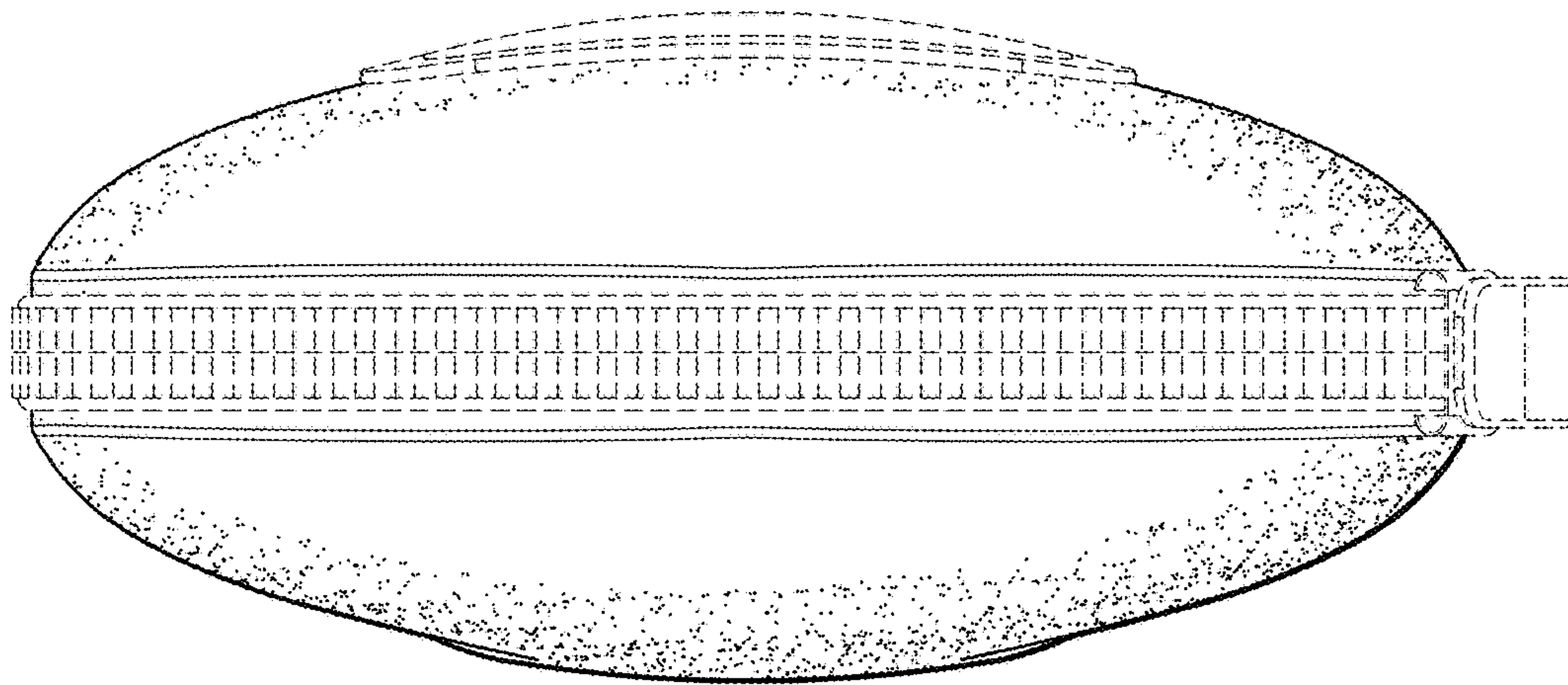

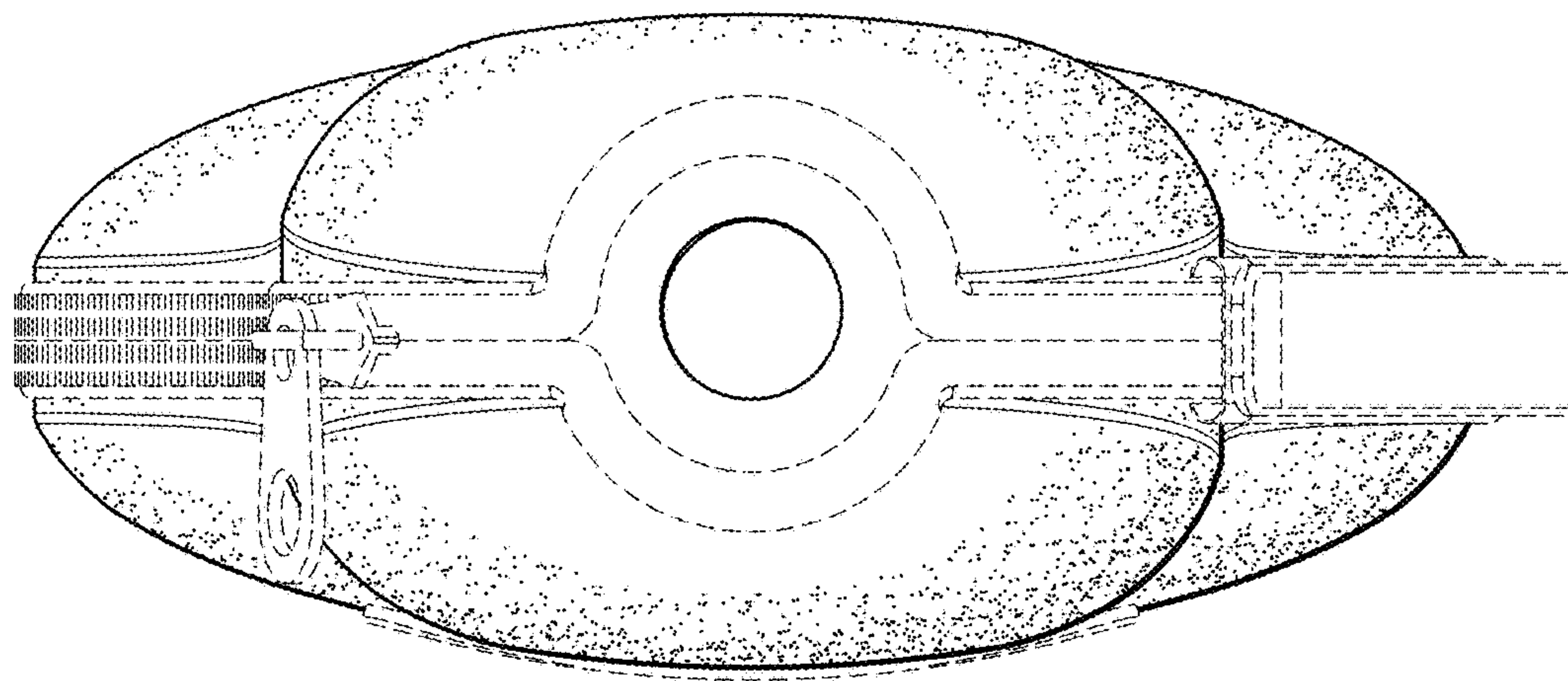

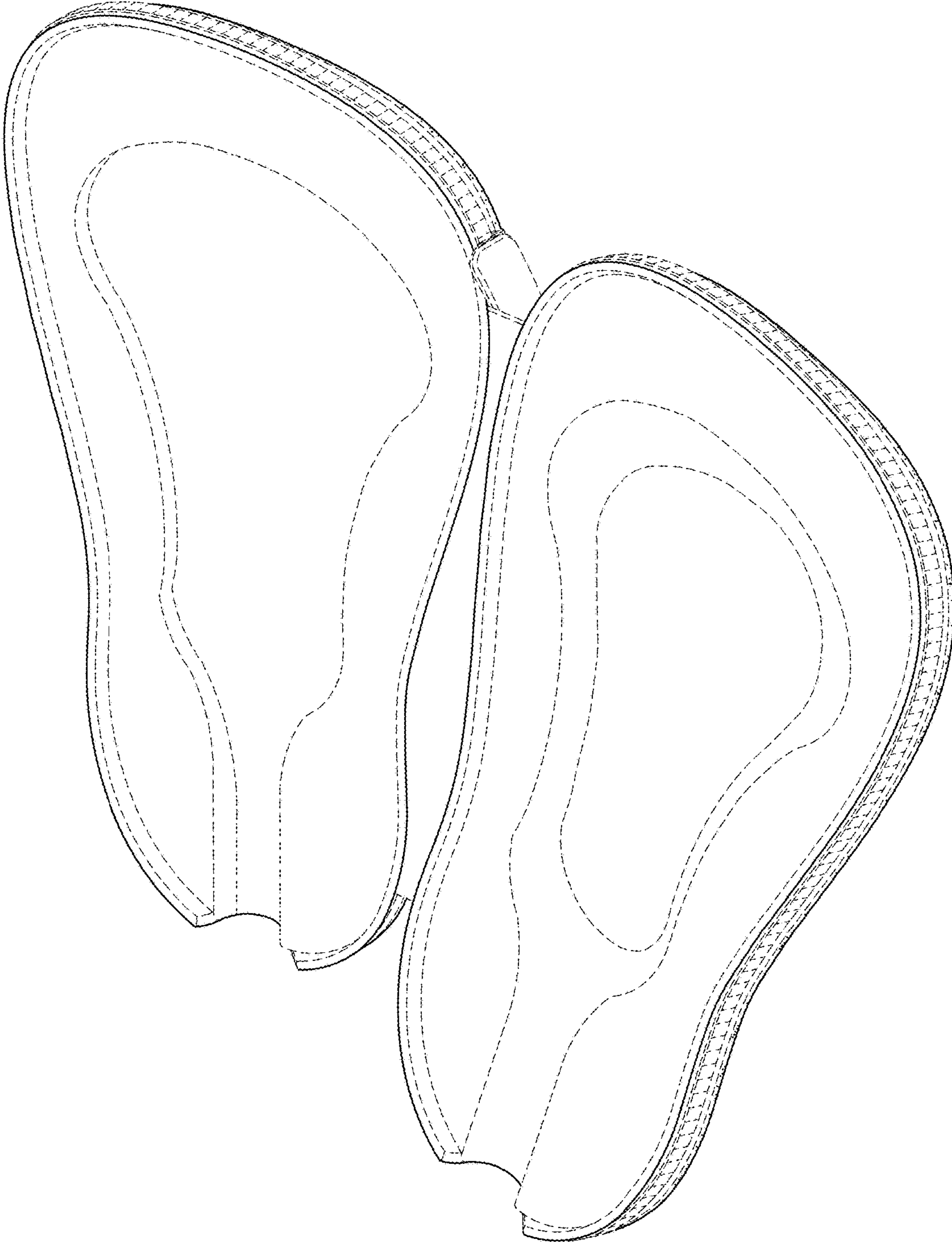
