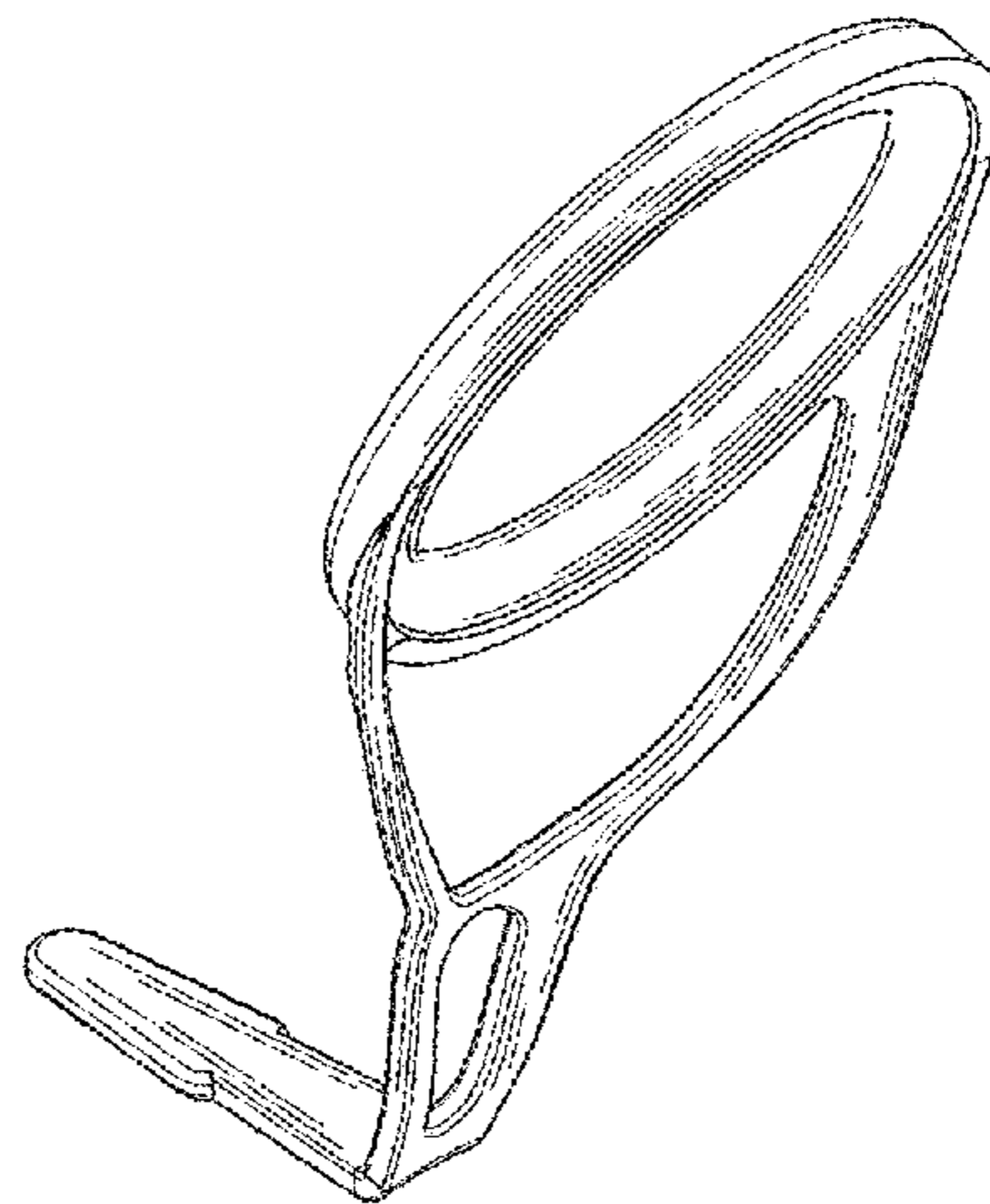
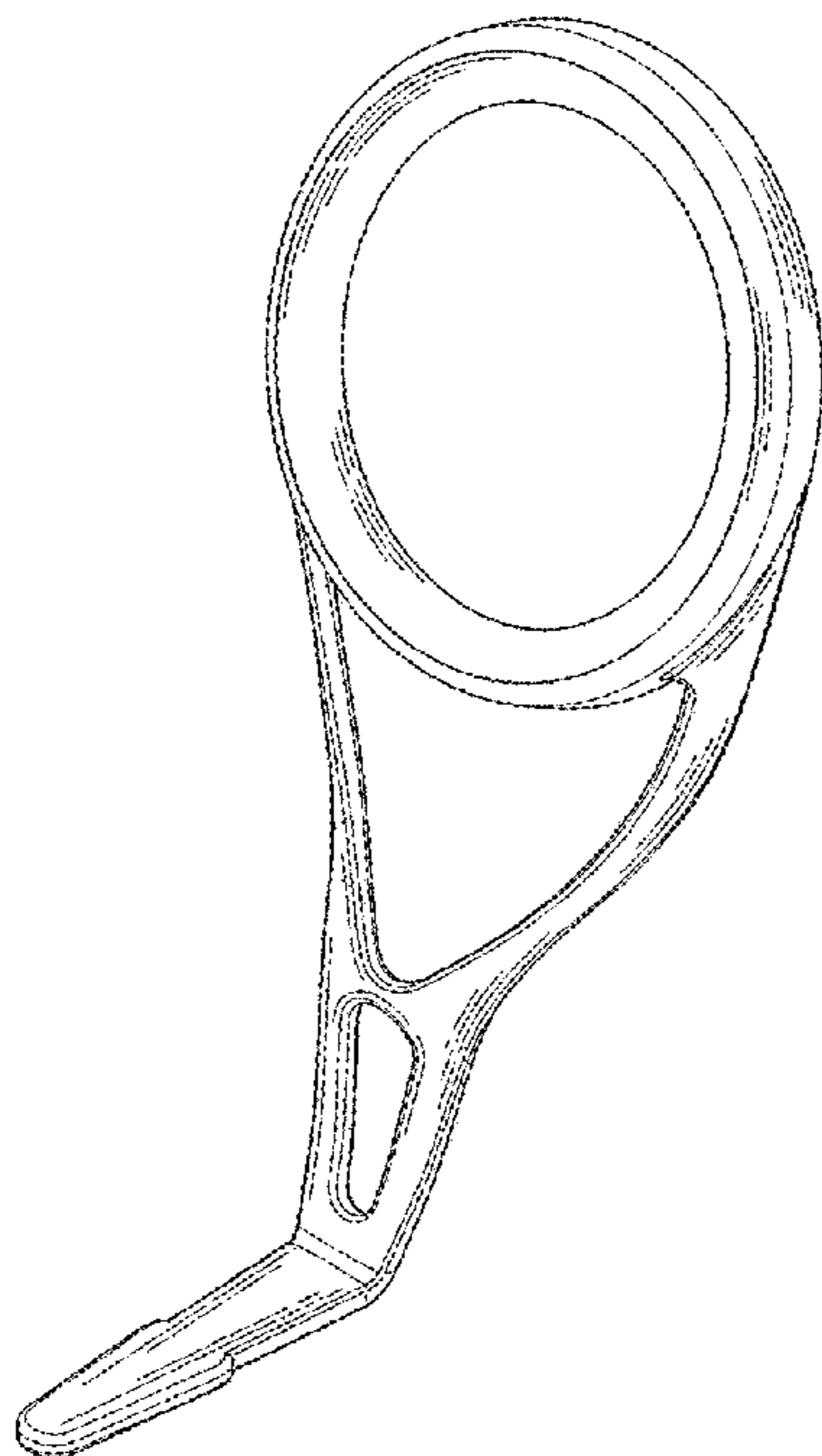

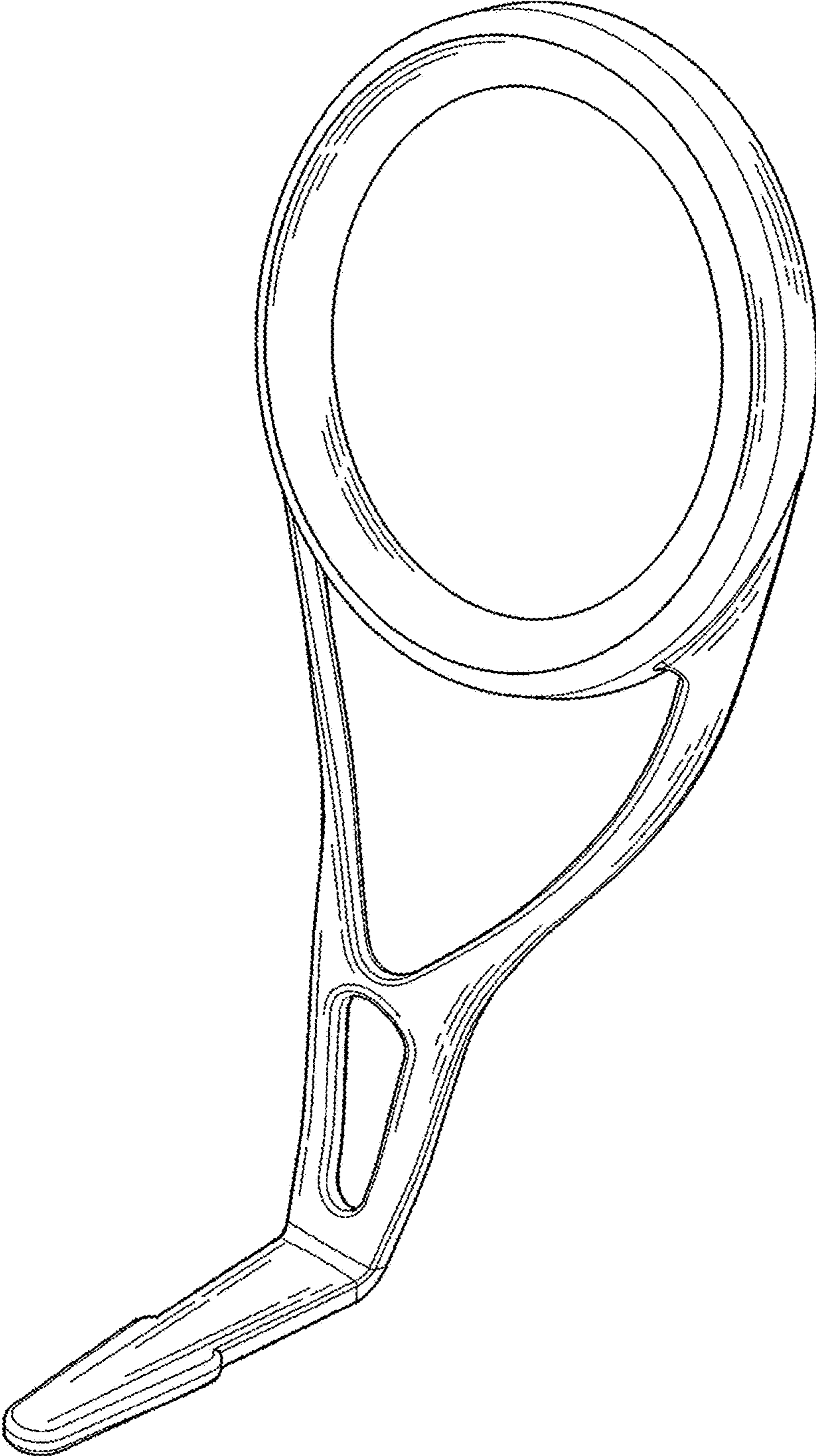
The ornamental design for the fishing rod line guide, as shown and described.

DESCRIPTION

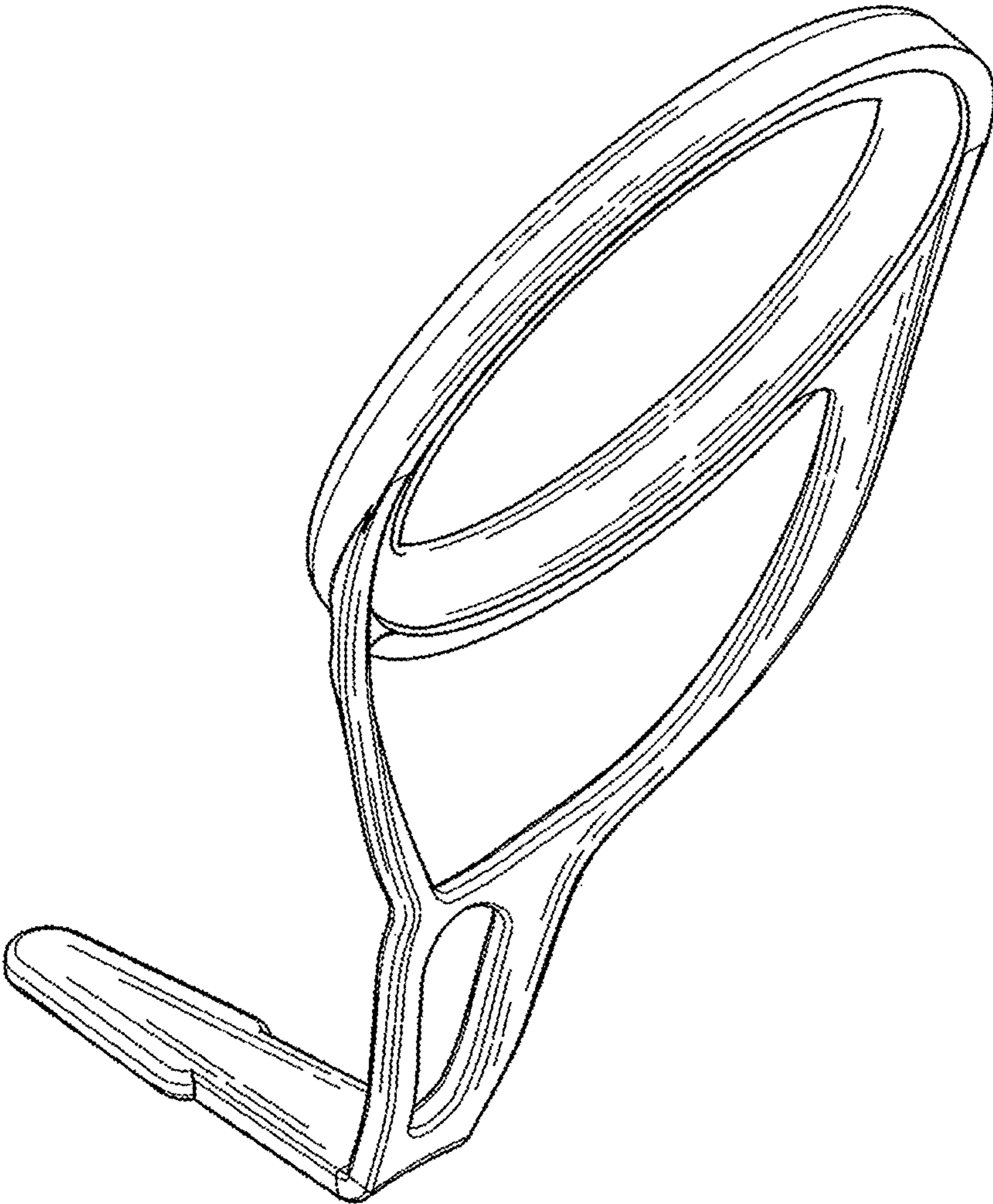
FIG. 1 is a perspective view of the fishing rod line guide showing my new design;

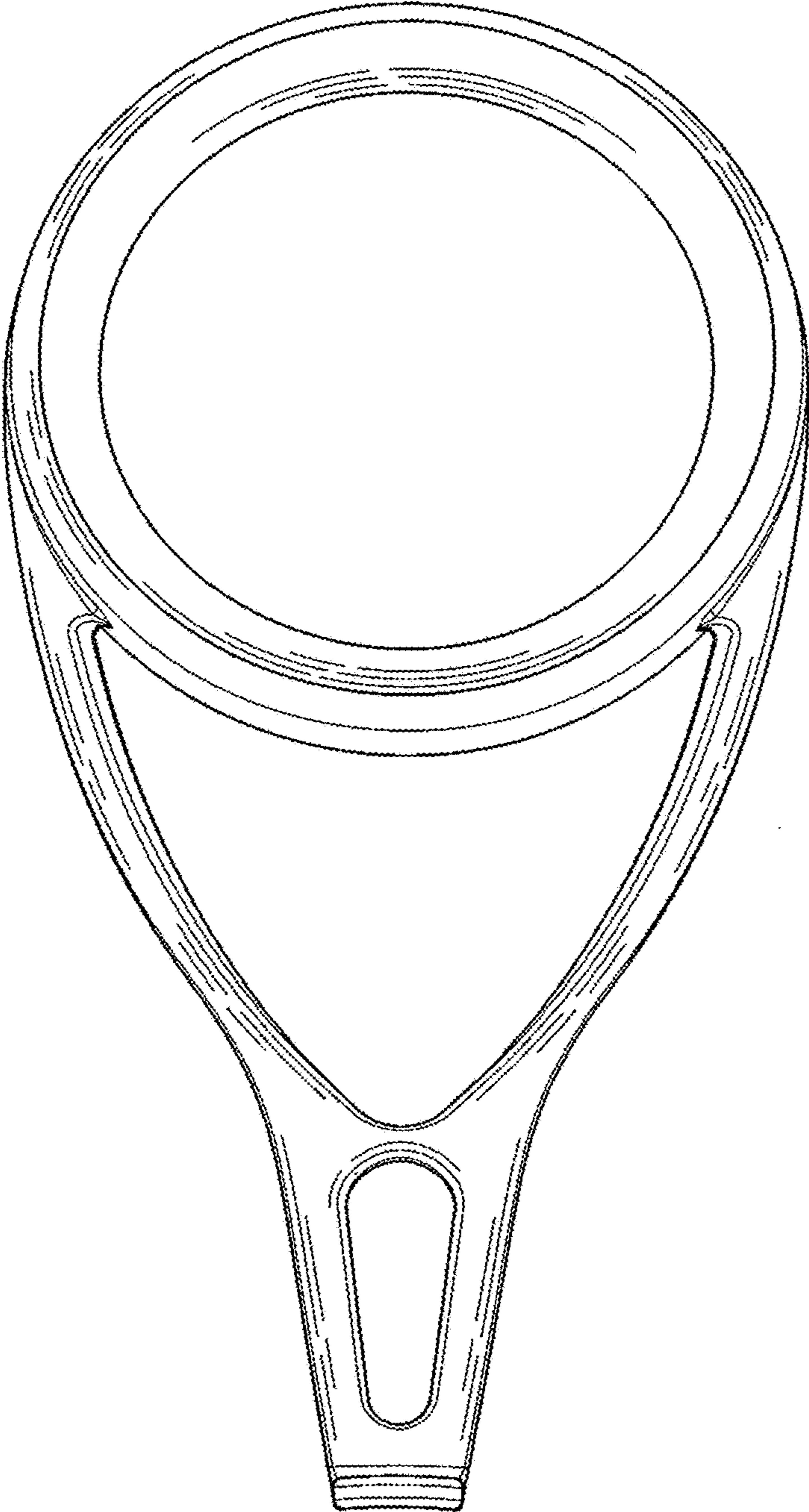

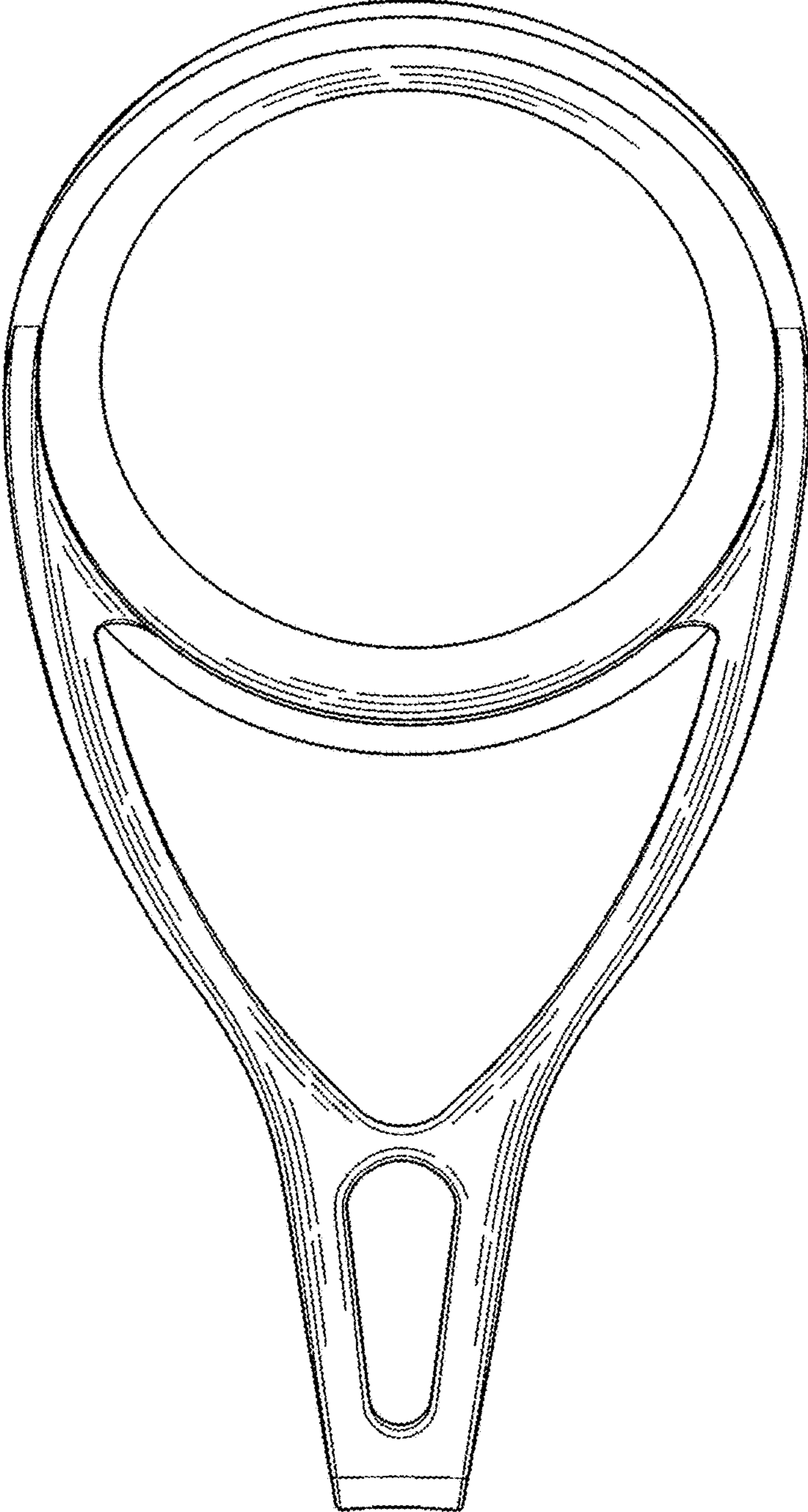

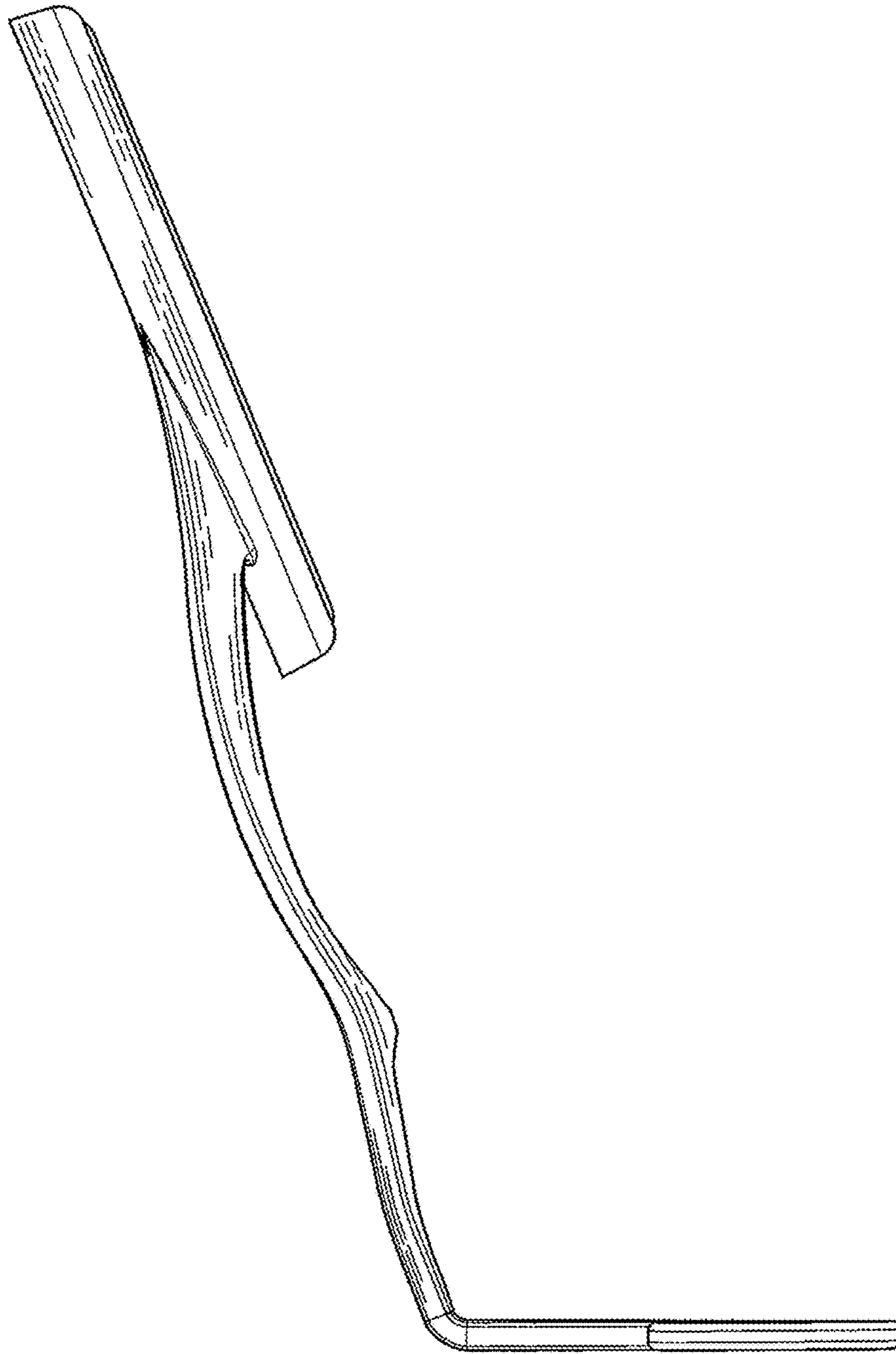

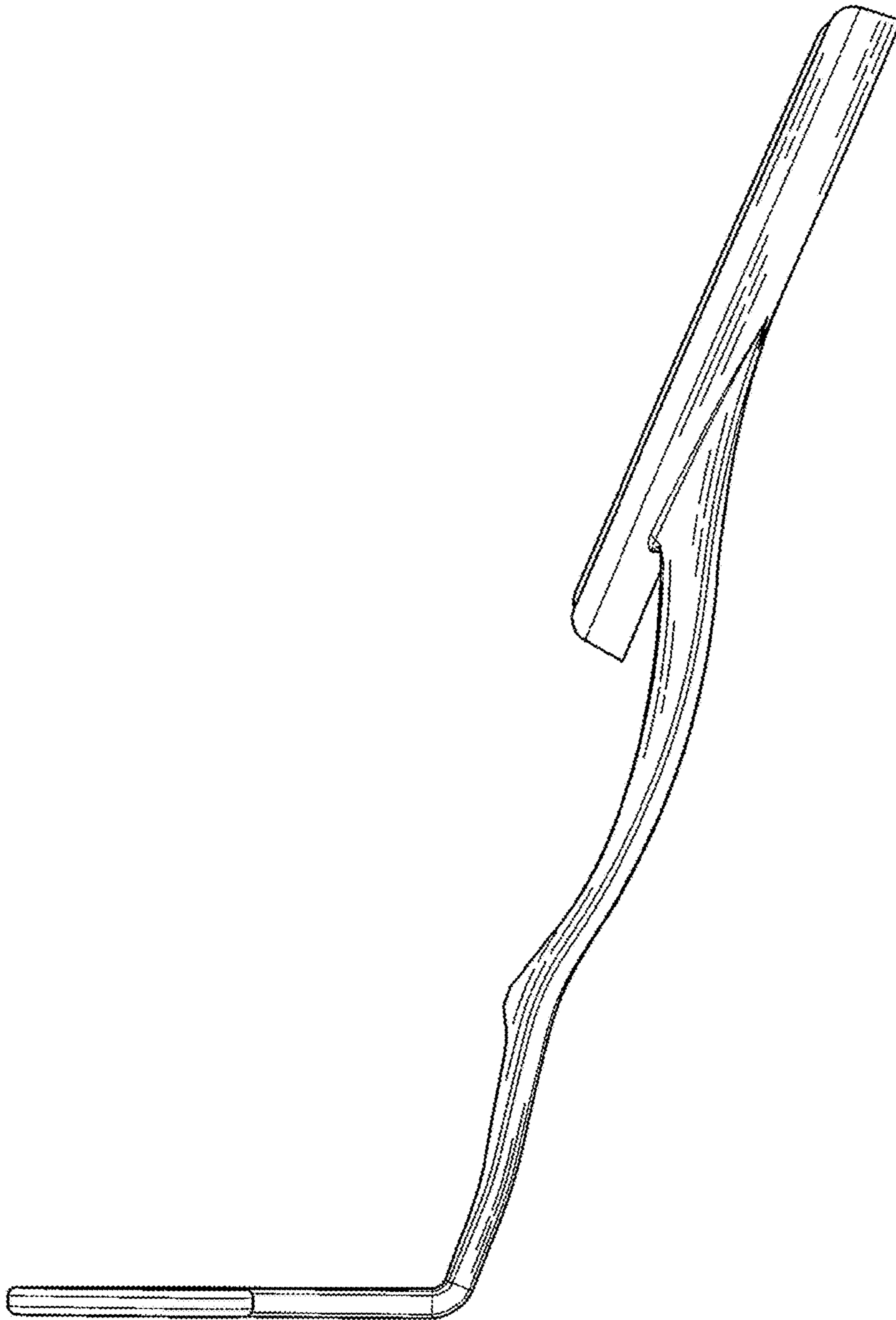

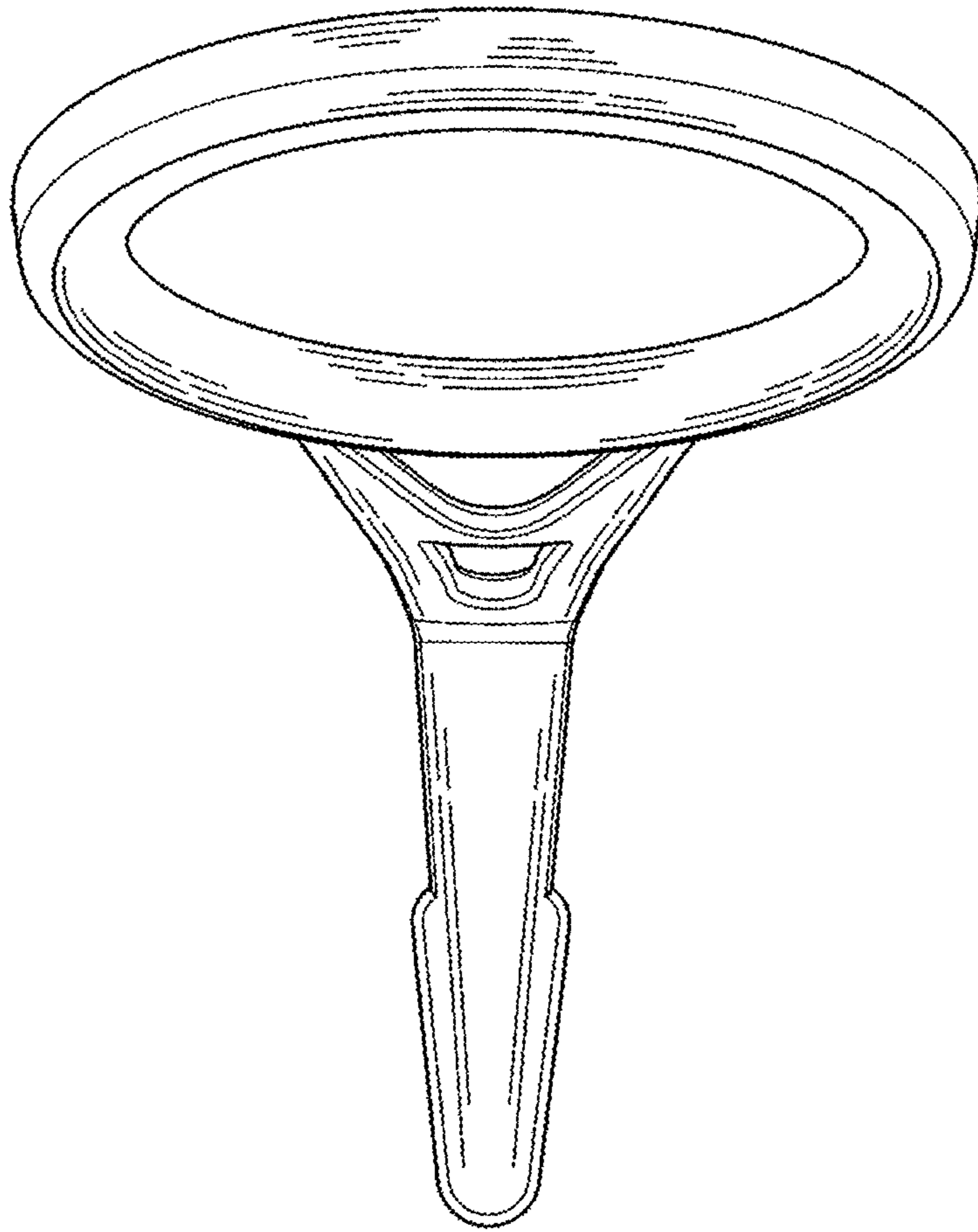

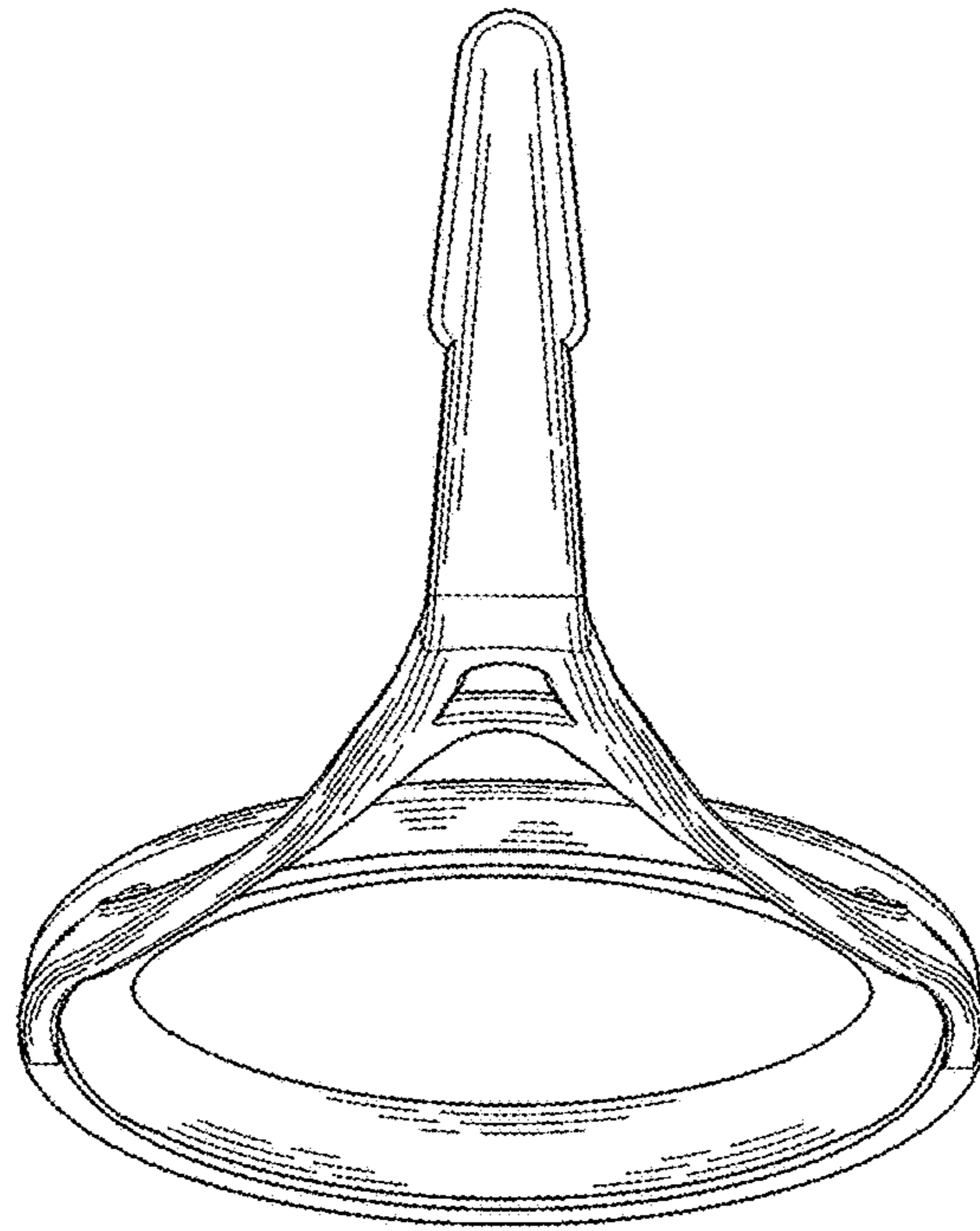
