(57) **CLAIM**

The ornamental design for a tippet ring applicator, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the design of a tippet ring applicator;
 FIG. 2 is a perspective view of the tippet ring applicator in use with a tippet ring and clip shown in broken lines;
 FIG. 3 is a left side elevational view of the design of FIG. 2;
 FIG. 4 is a front elevational view of the design of FIG. 2;
 FIG. 5 is a right side elevational view of the design of FIG. 2;
 FIG. 6 is a rear elevational view of the design of FIG. 2;
 FIG. 7 is a bottom plan view of the design of FIG. 2; and,
 FIG. 8 is a top plan view of the design of FIG. 2.
 The broken lines showing the remainder of the tippet ring applicator are directed to environment. The broken lines in FIGS. 2-8 indicate a non-claimed portion of the tippet ring applicator, including the tippet ring and clip and are for illustrative purposes only. None of the broken lines form a part of the claimed design.

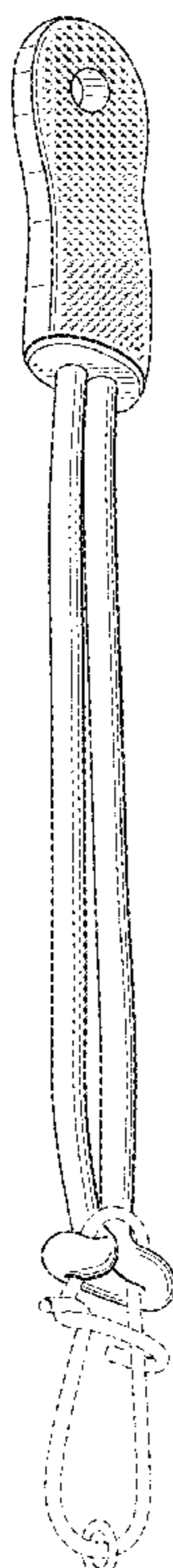

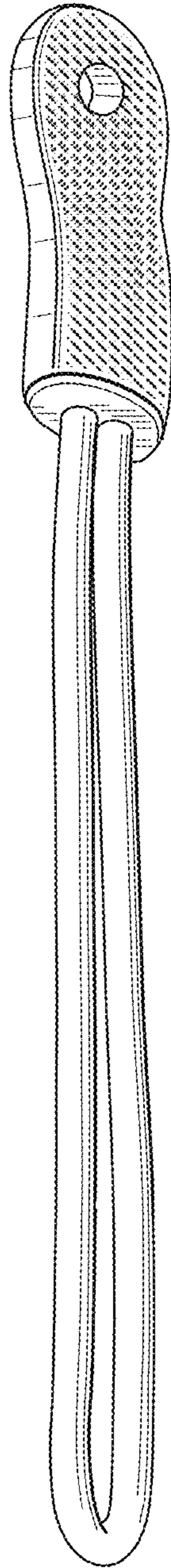

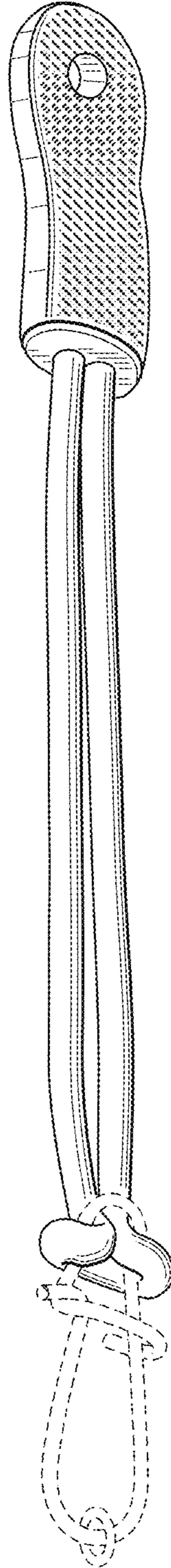

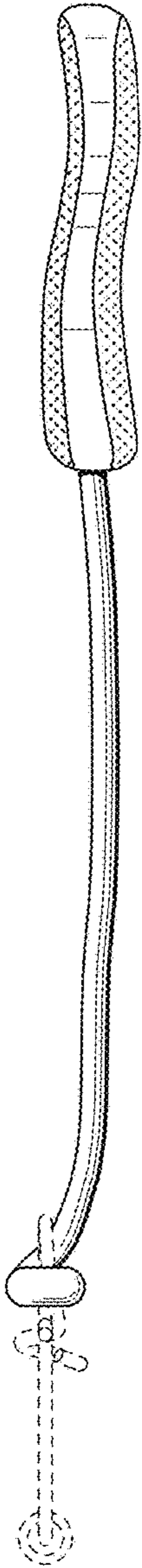

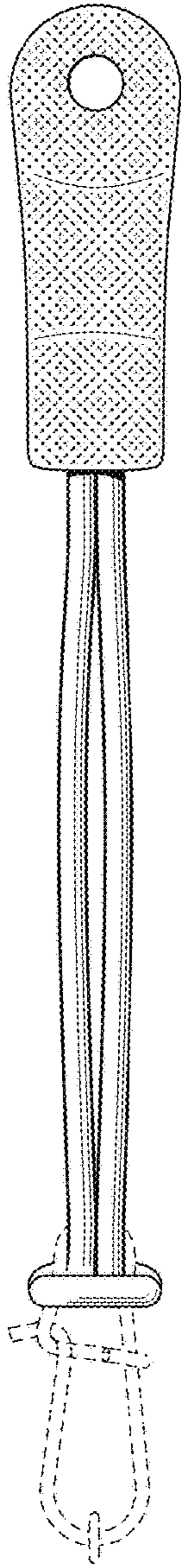

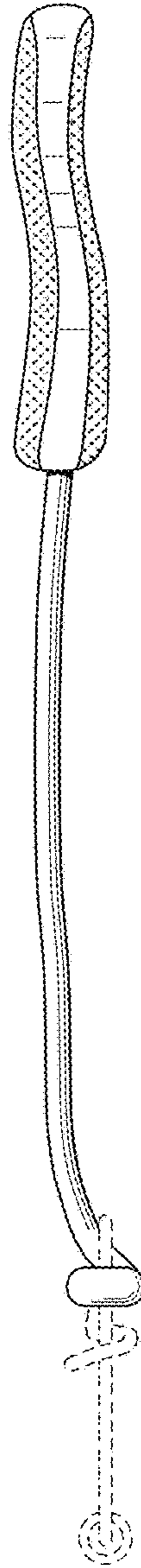

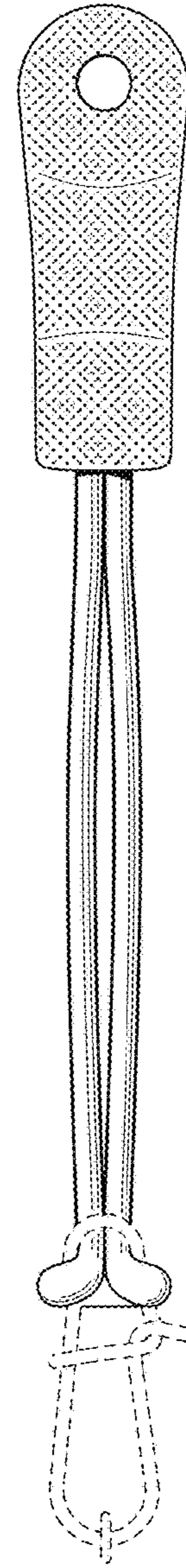
