(57) **CLAIM**

The ornamental design for a cover for air purifier, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cover for air purifier showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left-side view thereof;
FIG. 5 is a right-side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof; and,
FIG. 8 is a rear perspective view thereof.
The broken lines illustrating portions of the cover for air purifier define boundary of the unclaimed design and form no part of the claimed design.

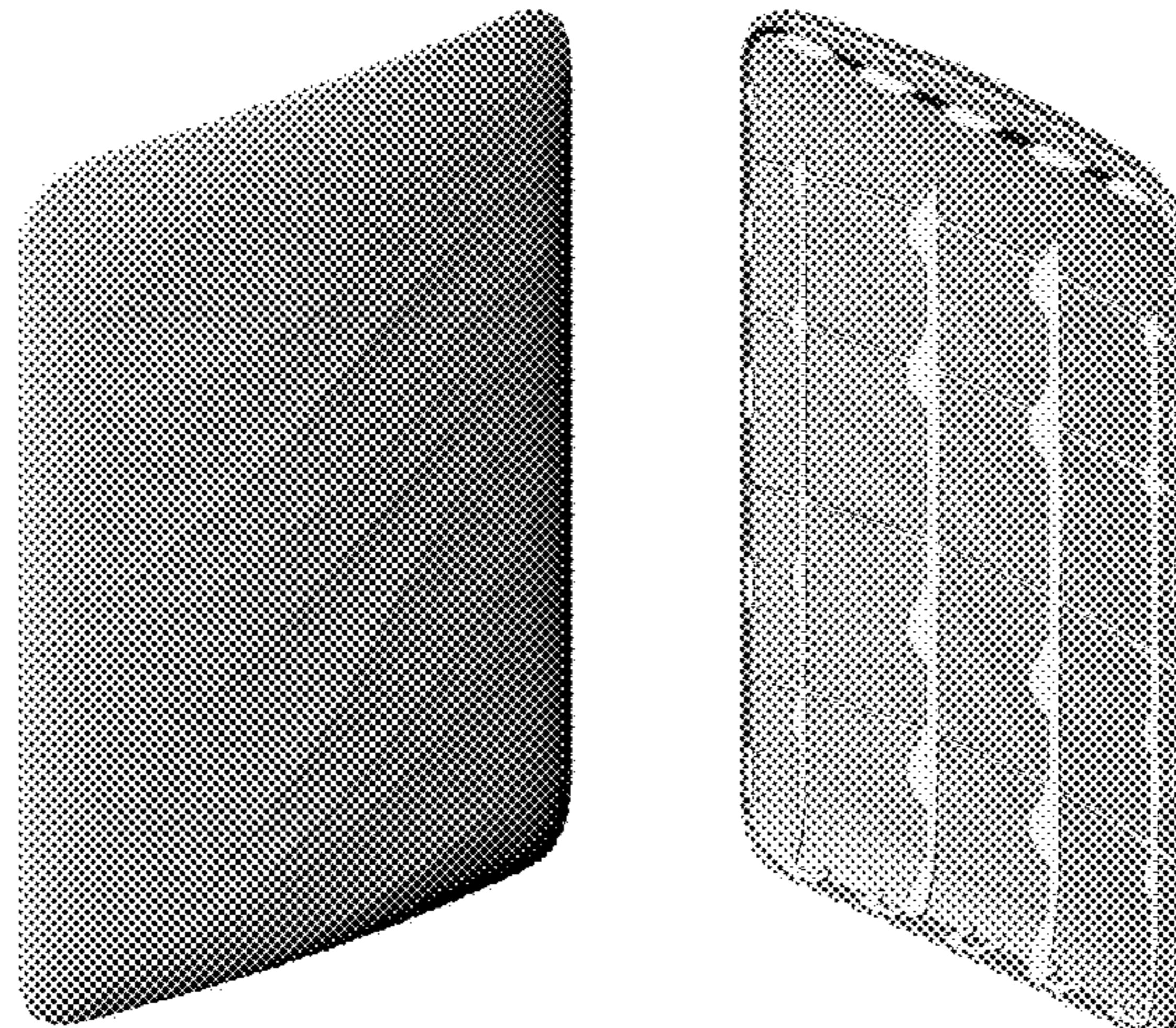

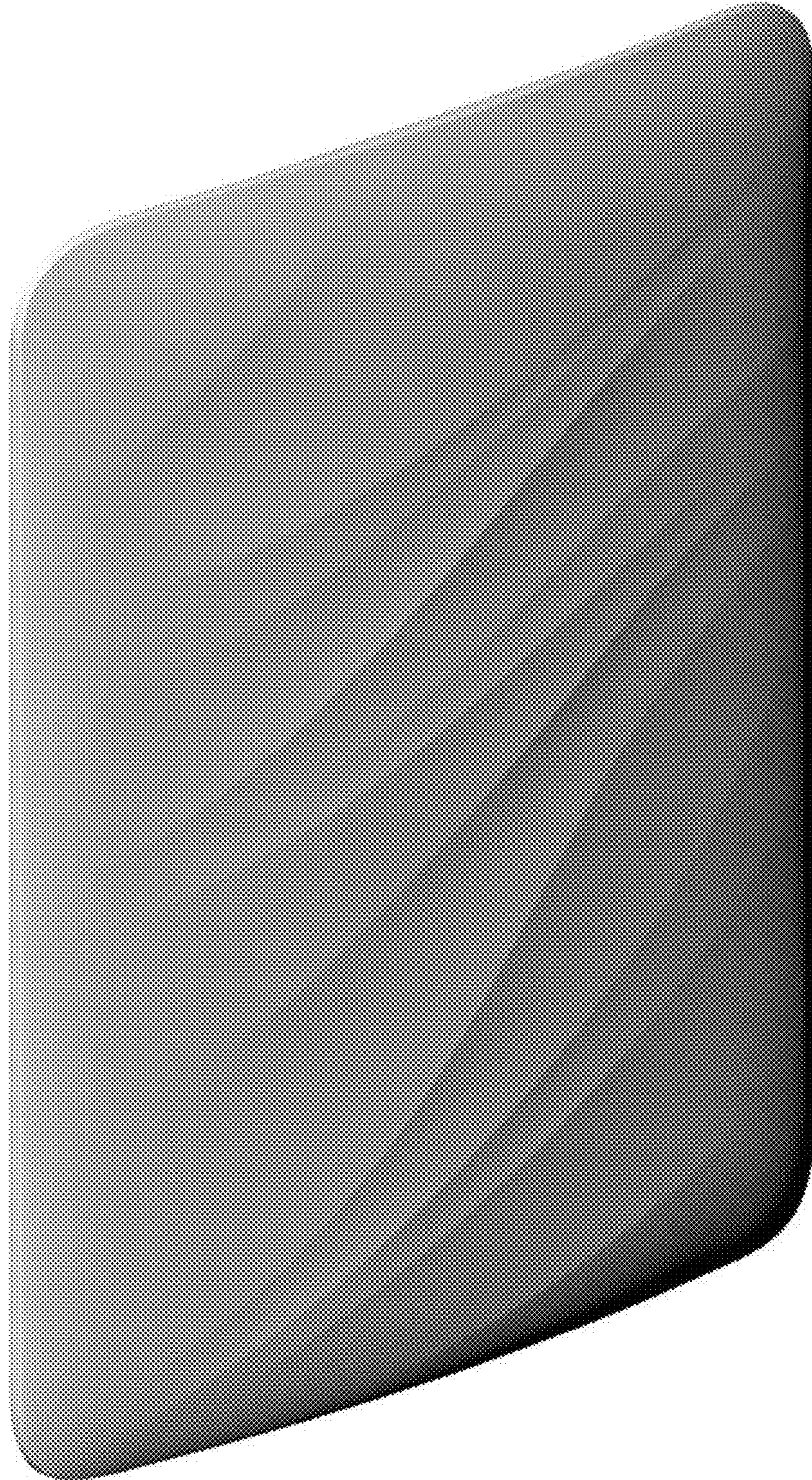

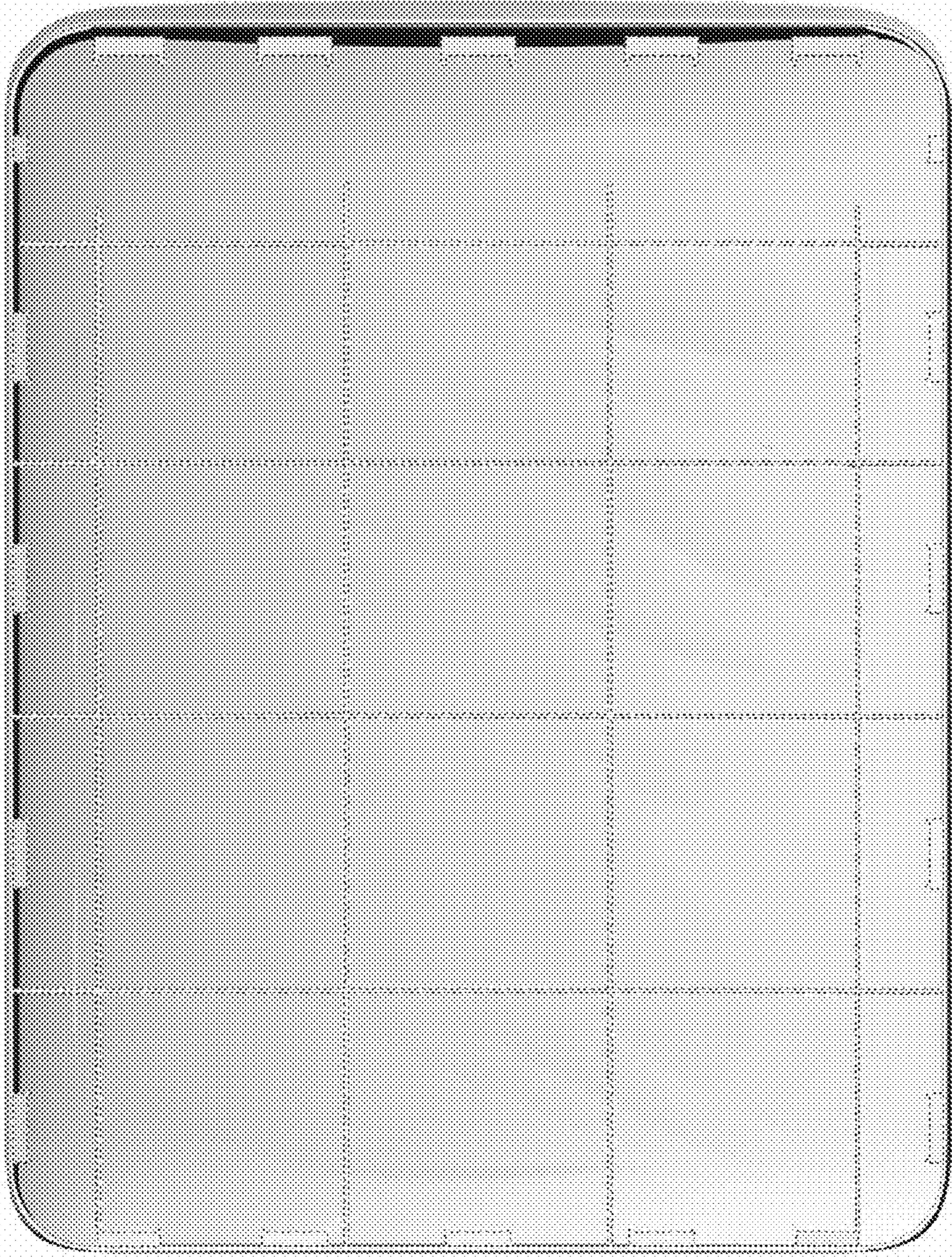

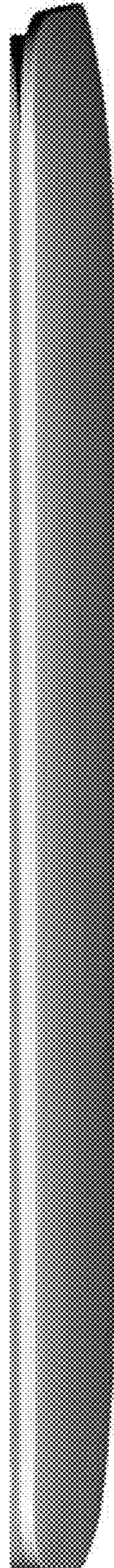

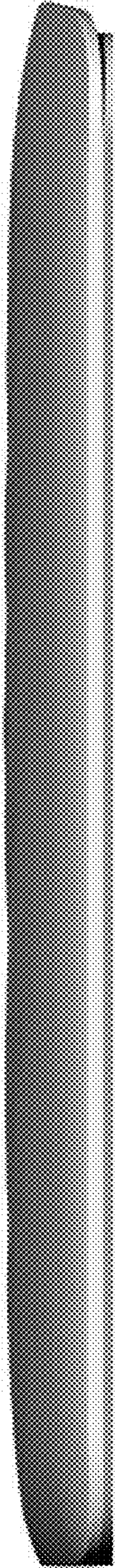
