**DESCRIPTION**

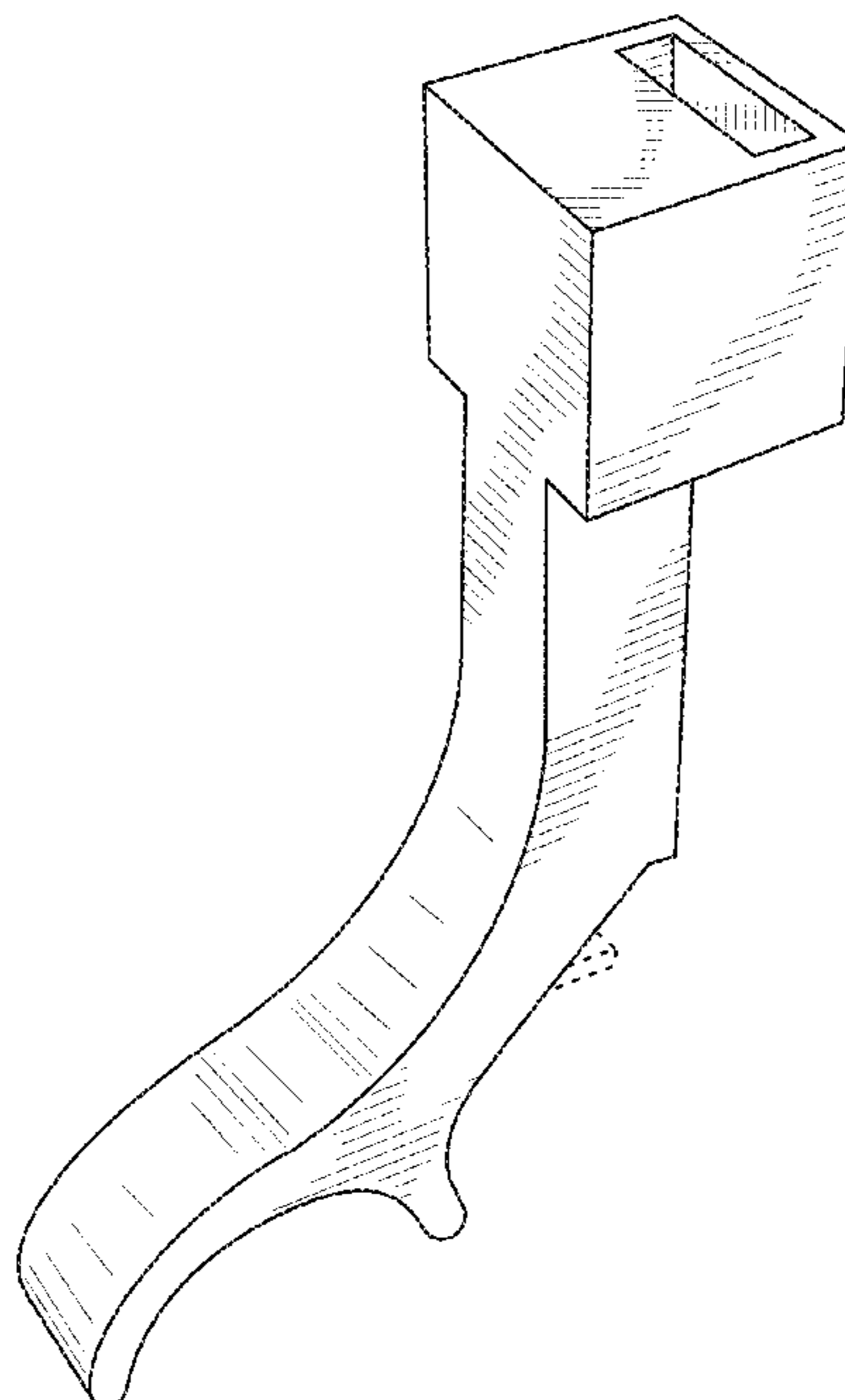

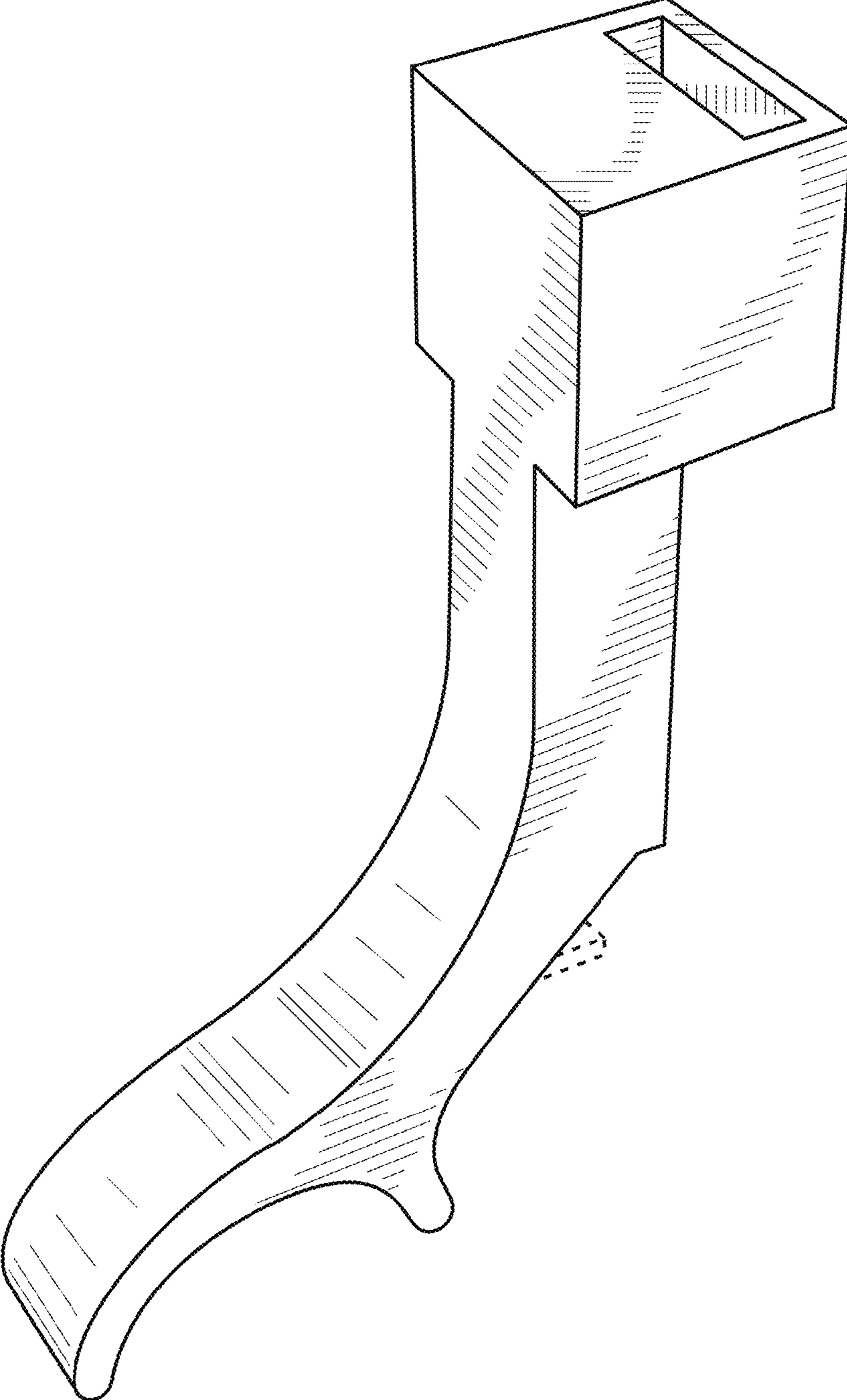

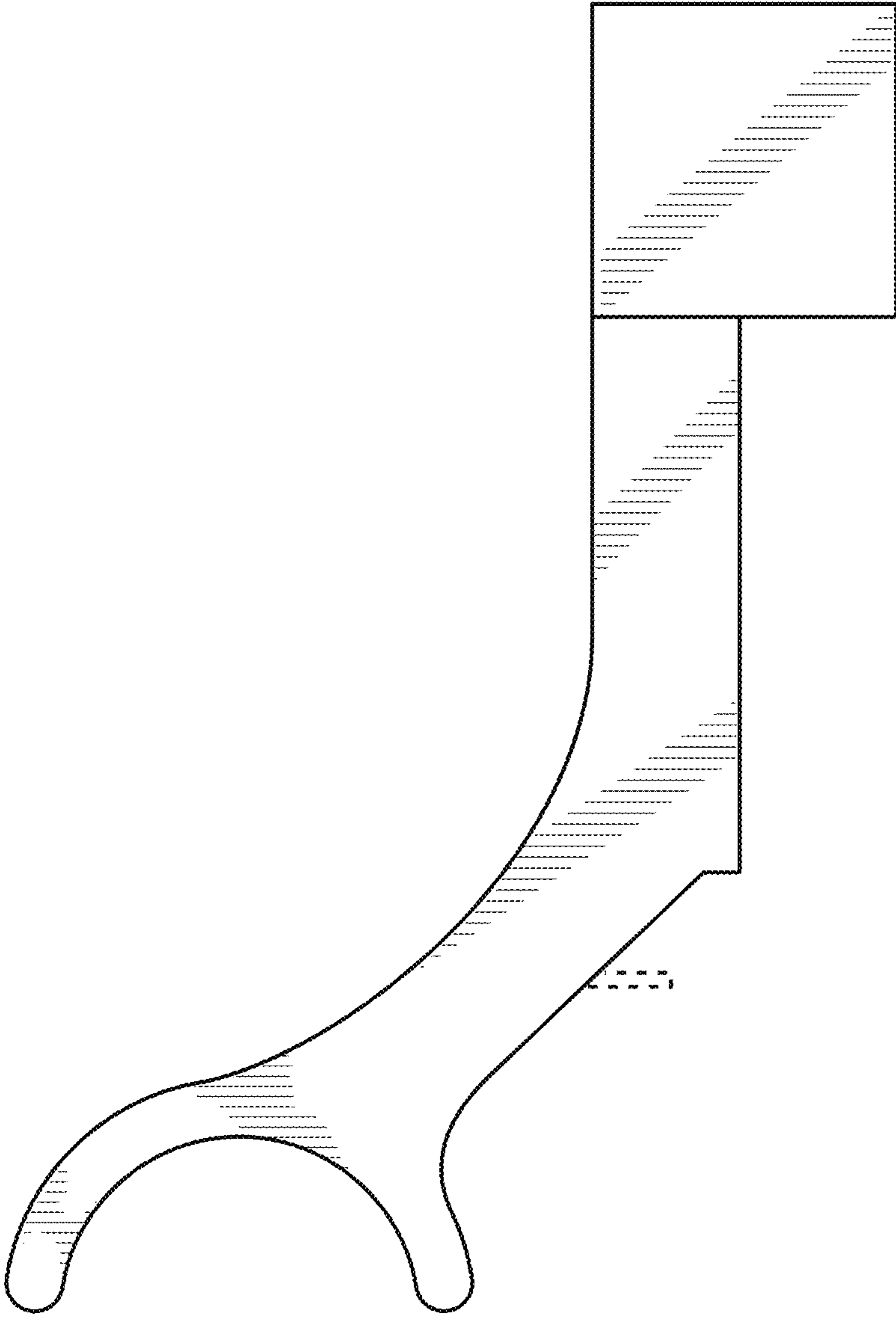

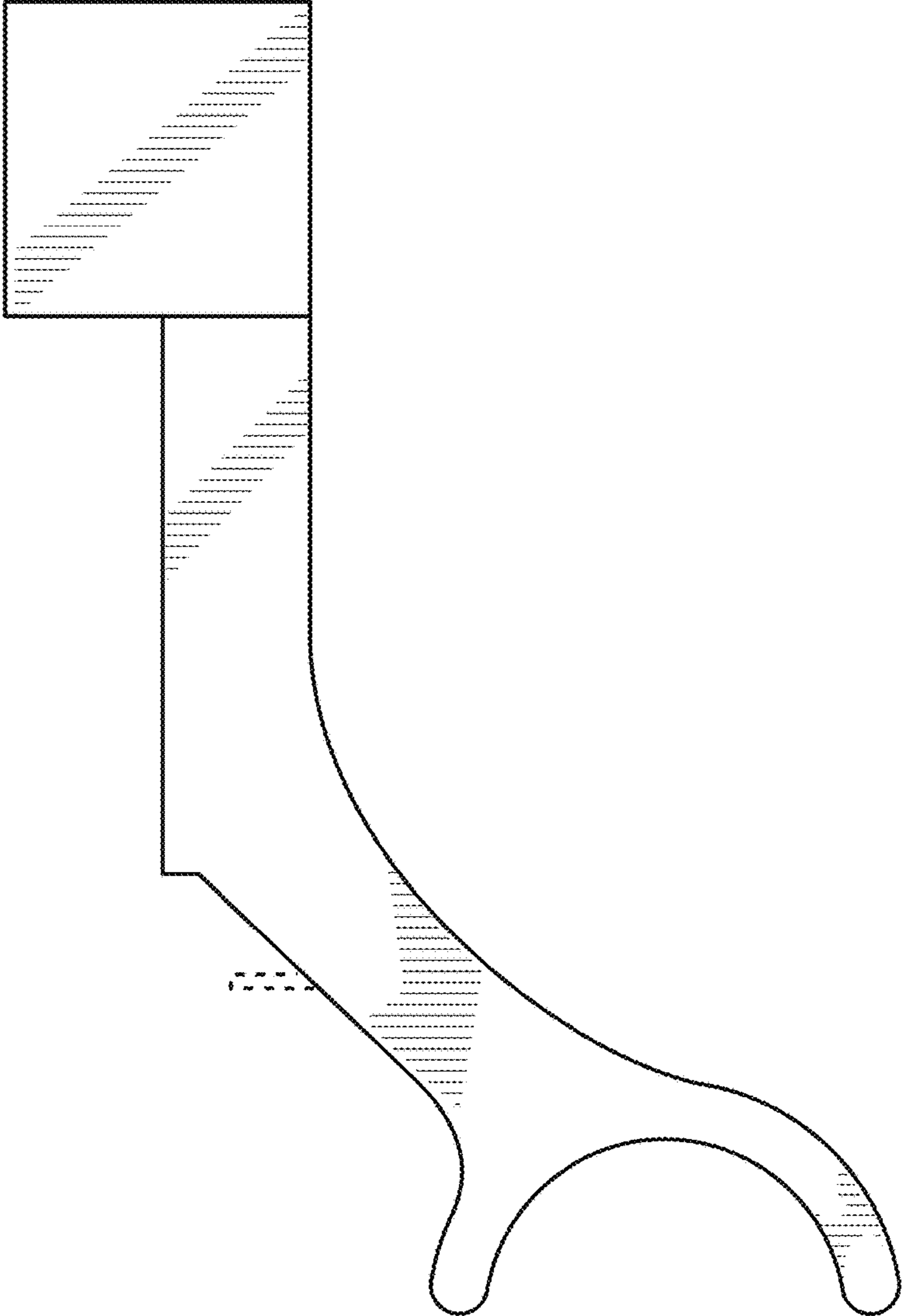

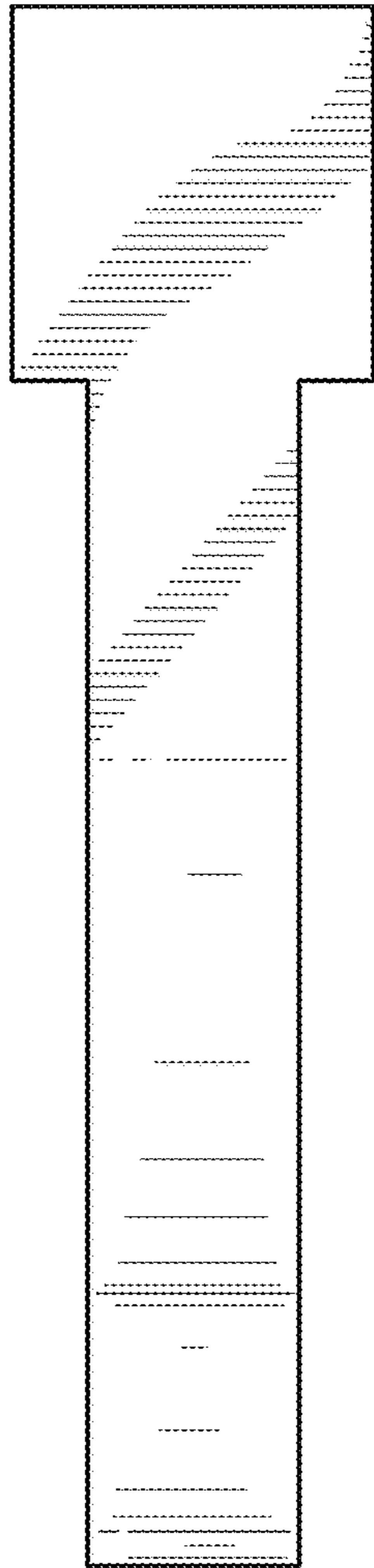

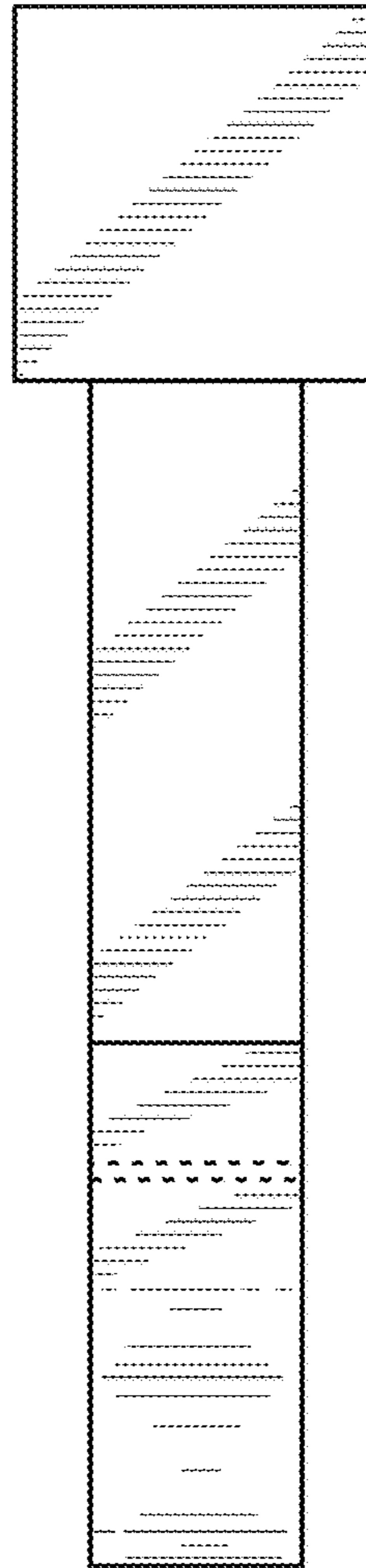

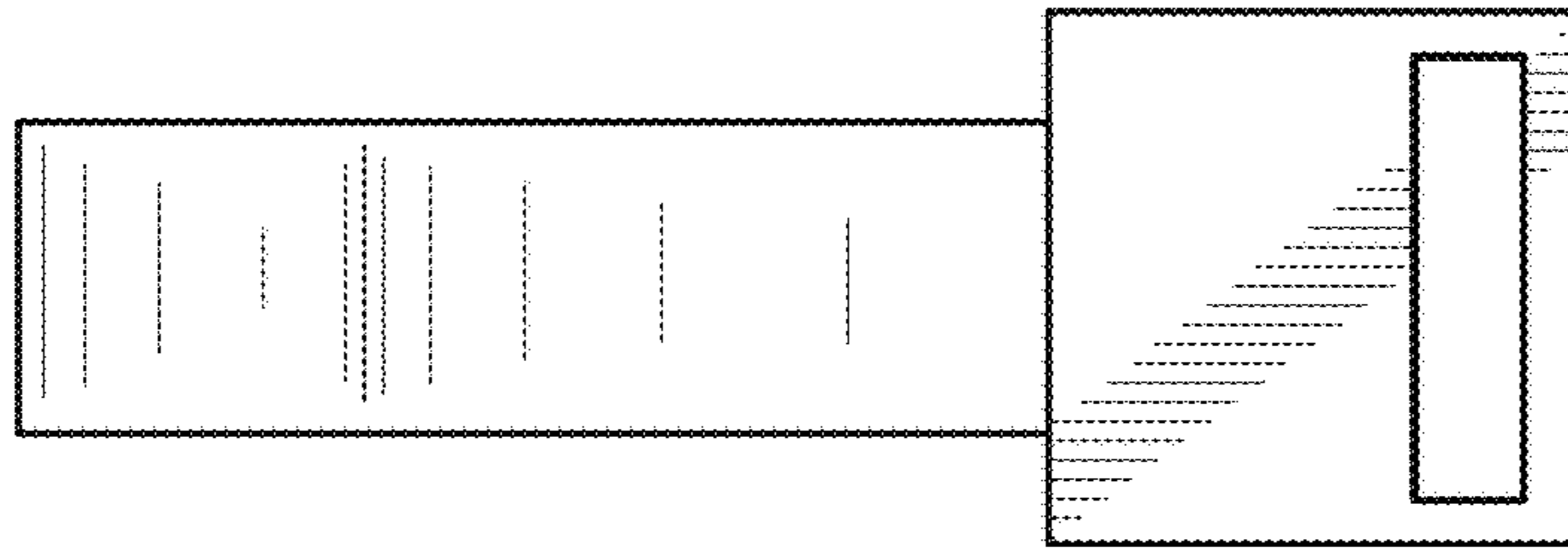

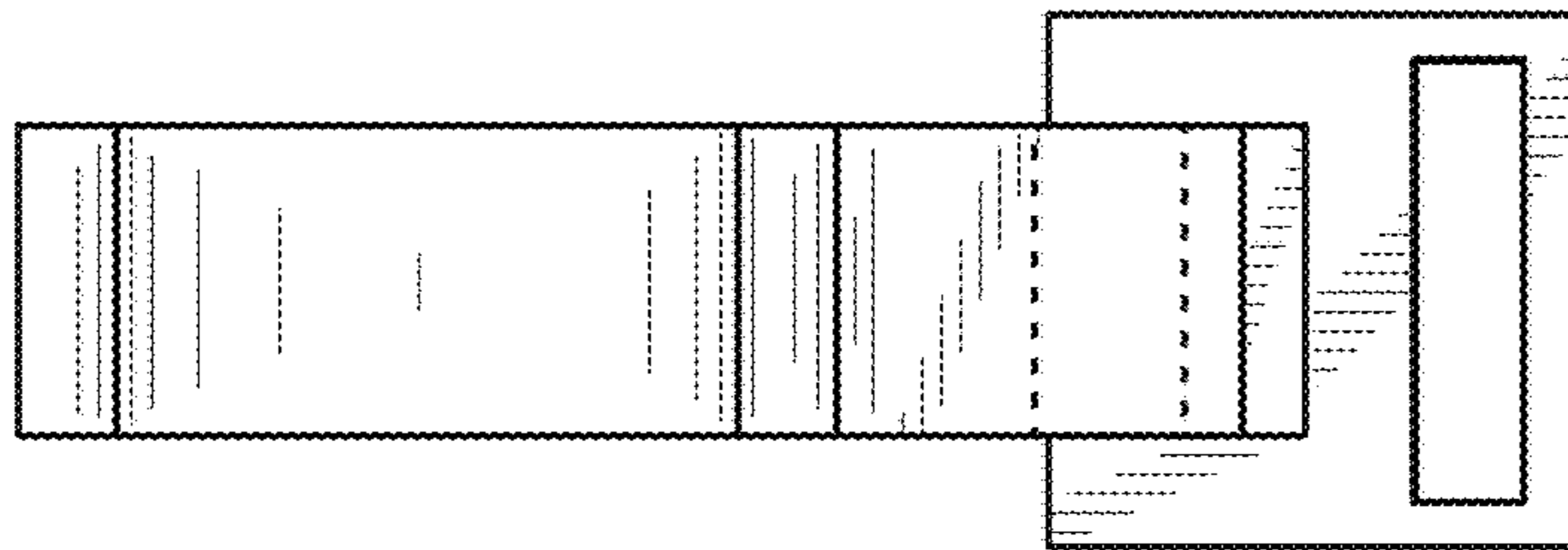
