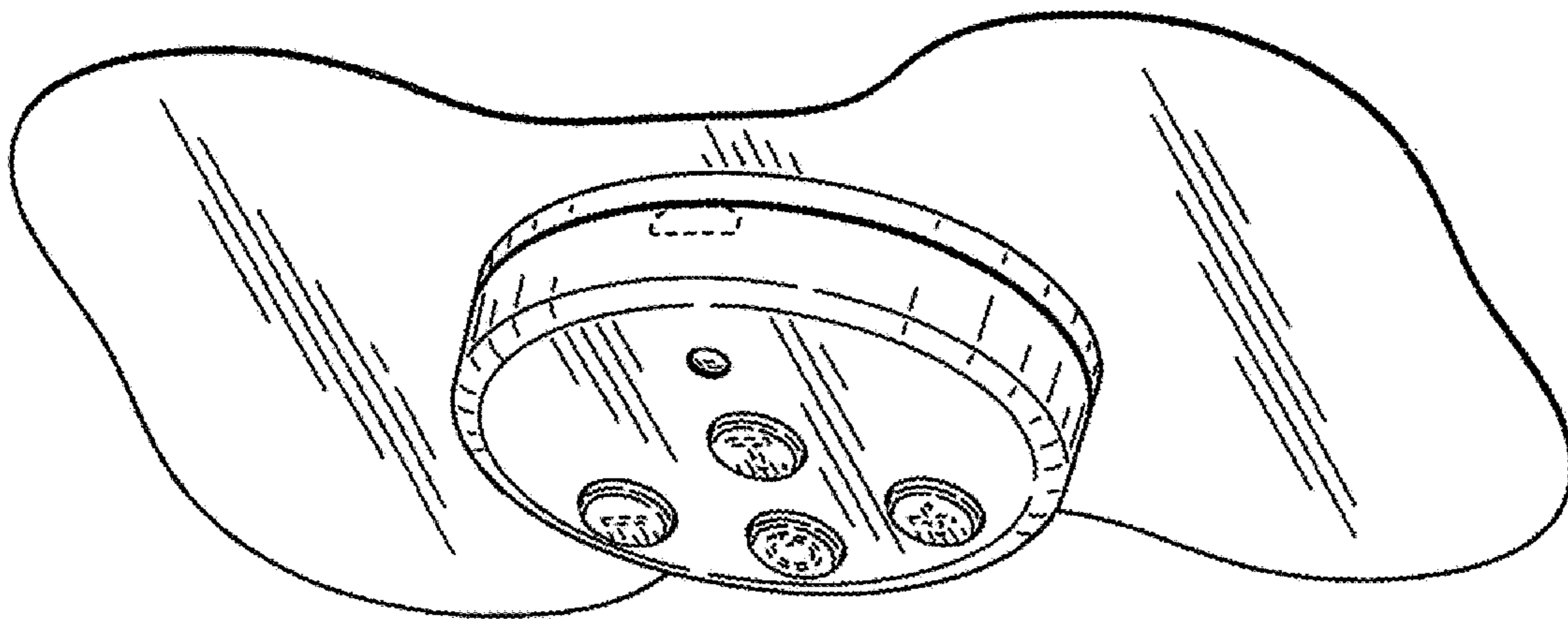
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevation view of the butterfly-shaped stimulation system showing my design; FIG. 2 is a rear elevation view thereof; FIG. 3 is a left-side elevation view thereof; FIG. 4 is a right-side elevation view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; and, FIG. 7 is a front perspective view thereof. 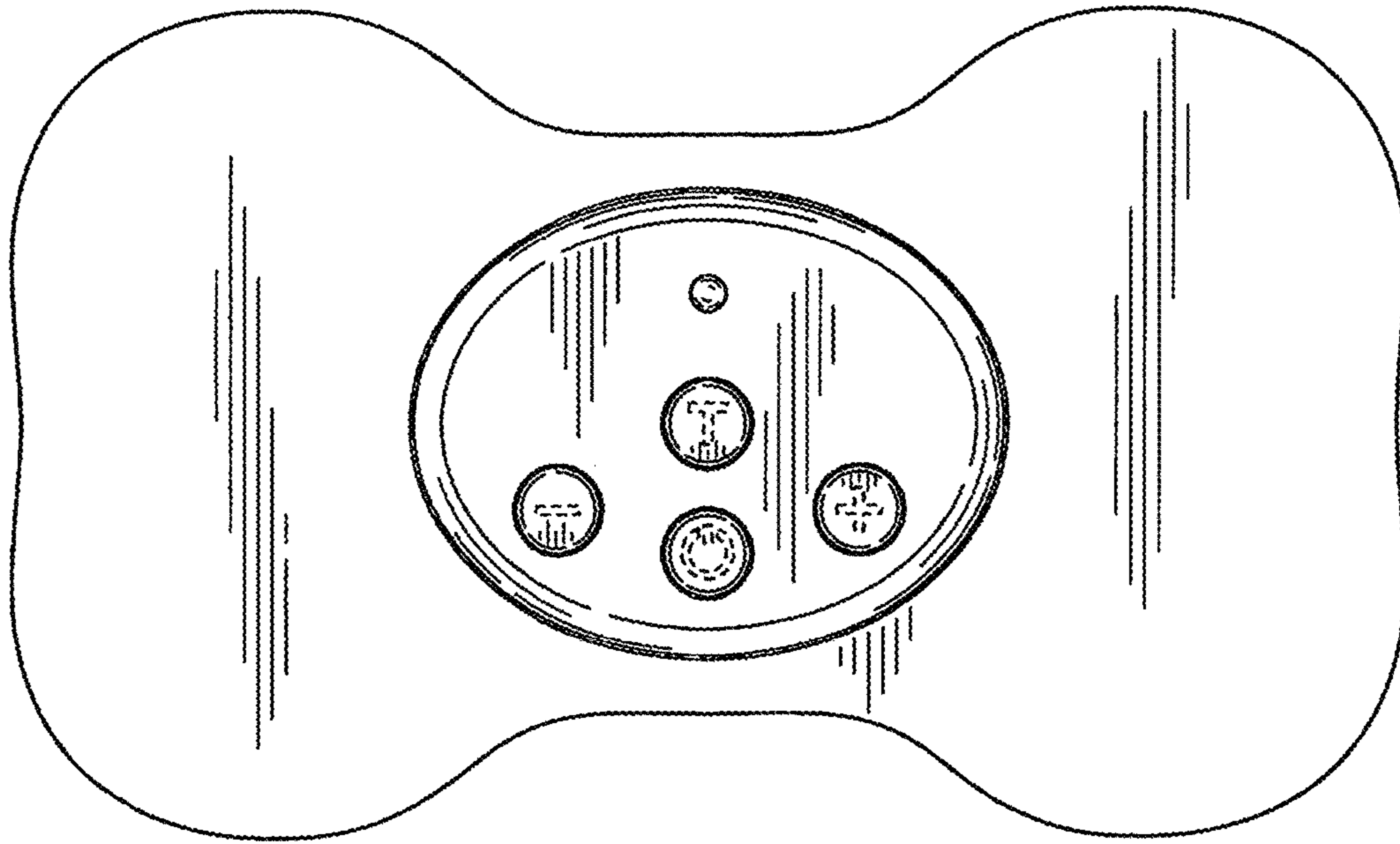

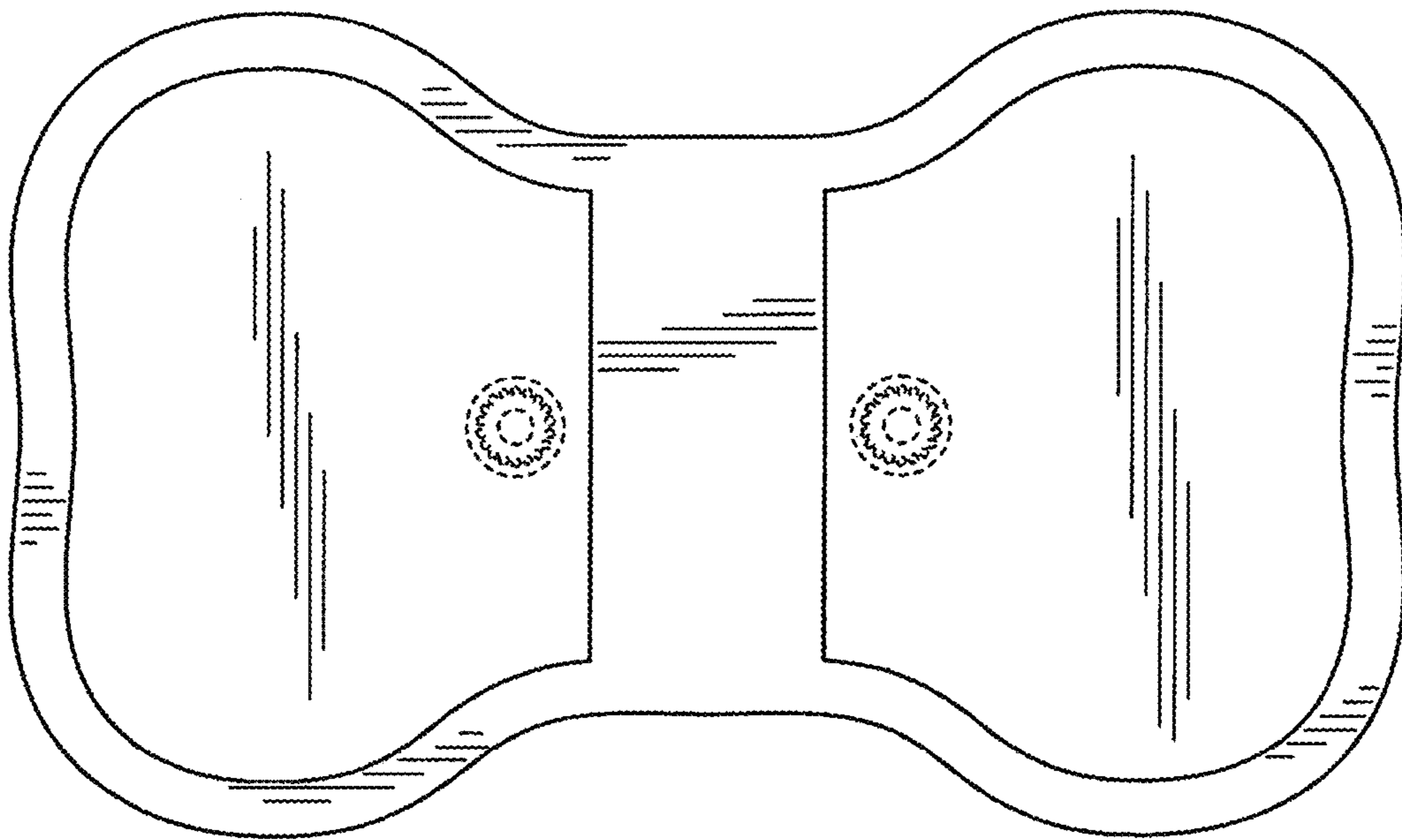

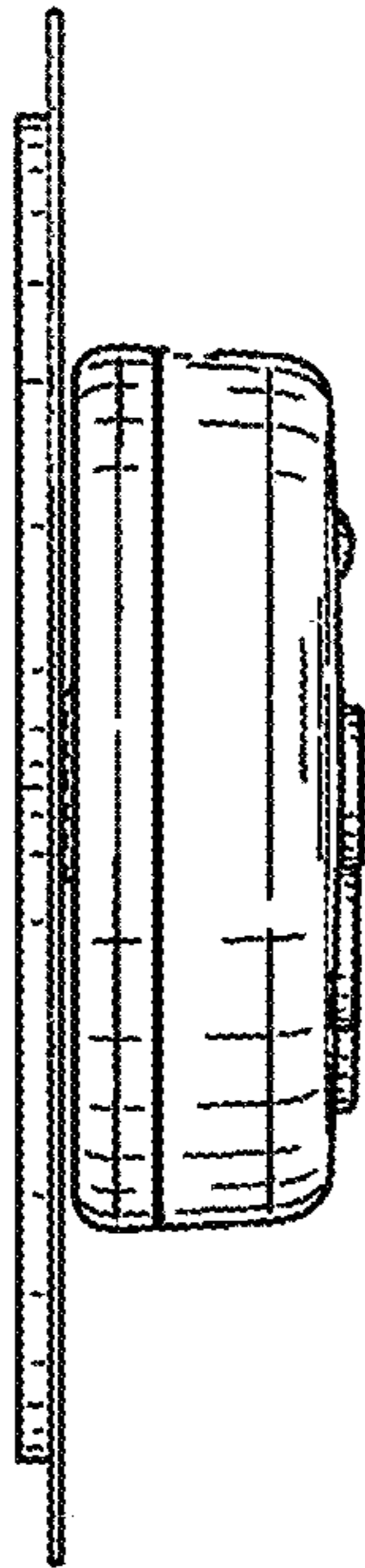

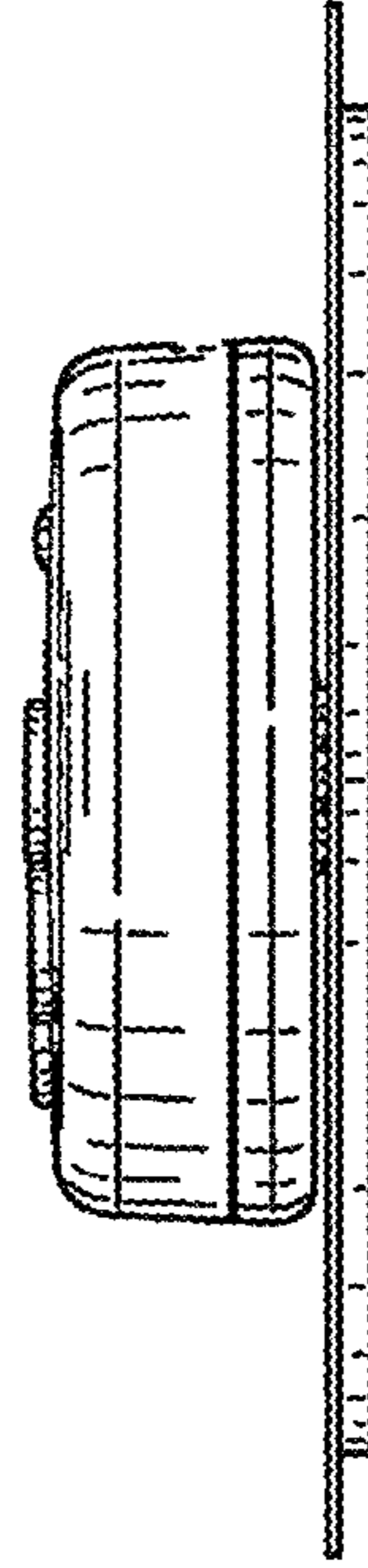

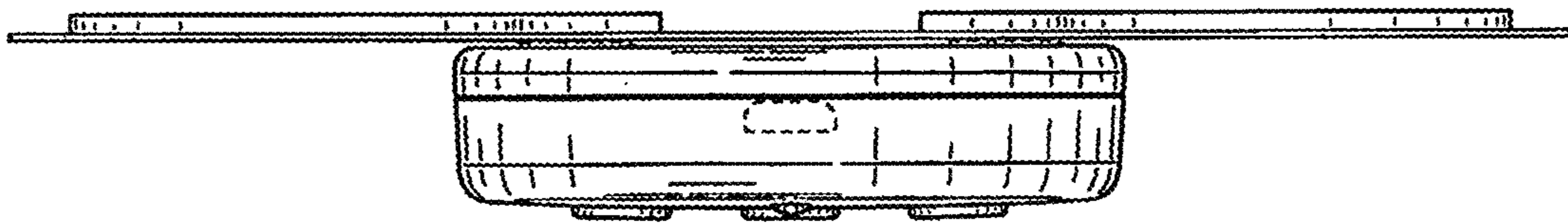

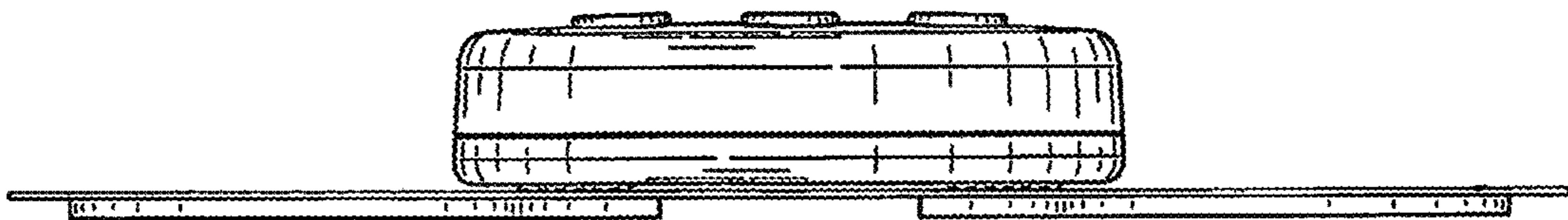

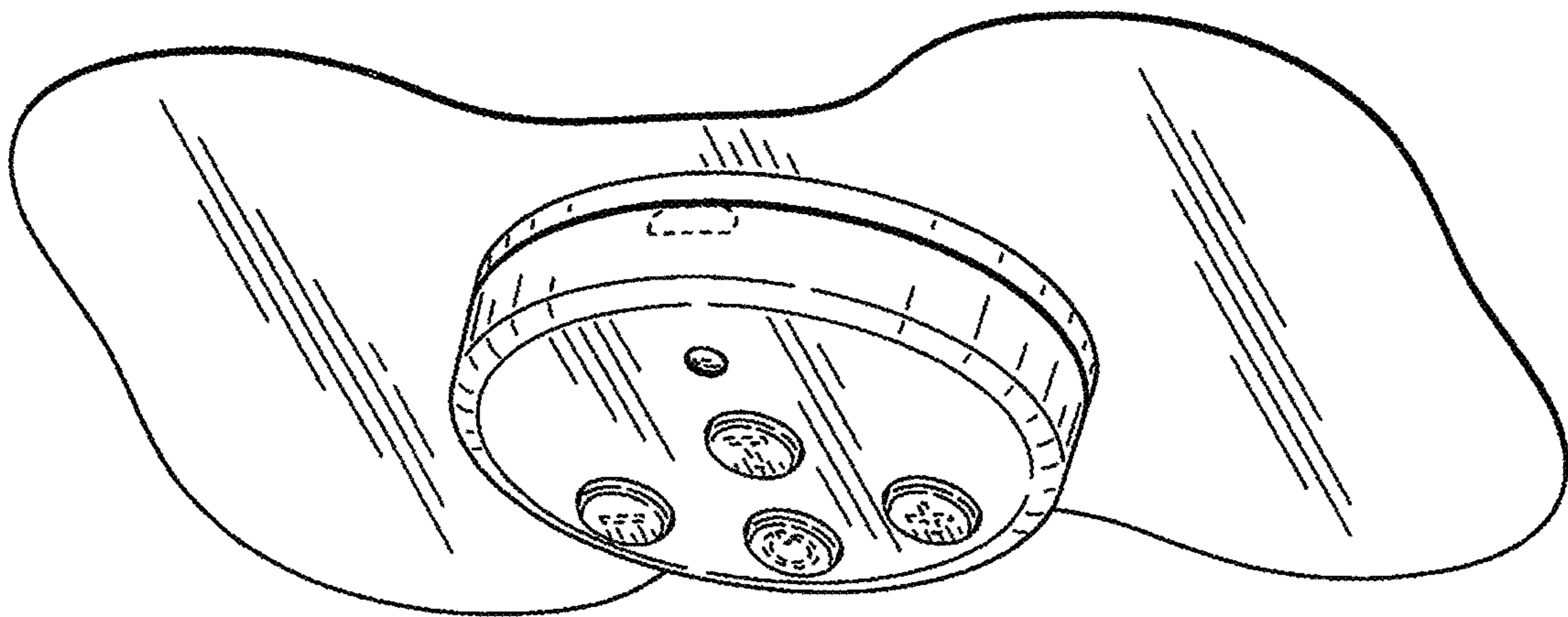
