(57) **CLAIM**

The ornamental design for a glove, as shown and described.

DESCRIPTION

The present application is related to U.S. application Ser. No. 15/072,904, filed on Mar. 17, 2016, the entire contents and disclosure of which are incorporated by reference herein.

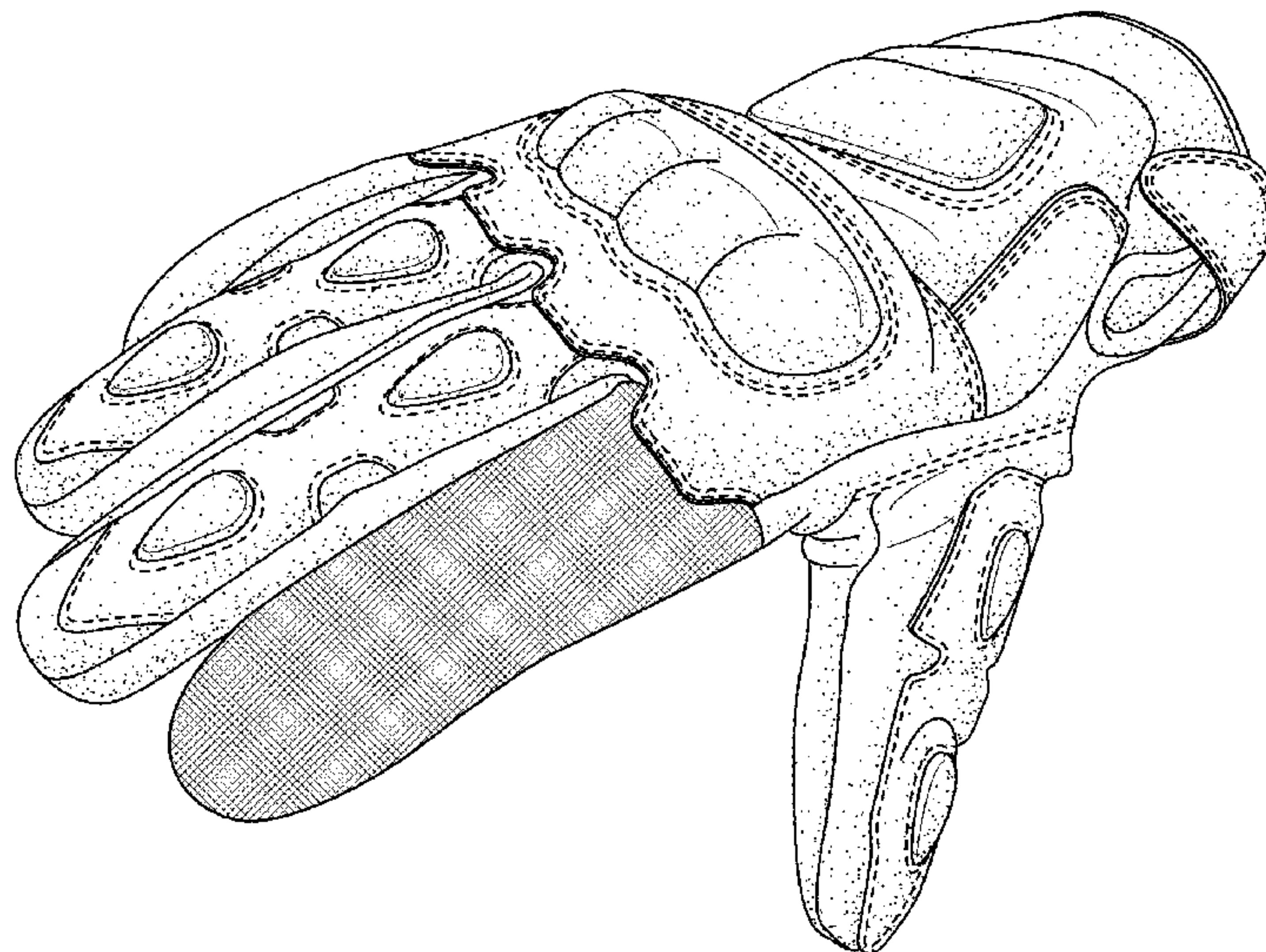
FIG. 1 is a rear and left side perspective view of a glove; FIG. 2 is a rear elevational view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

The figures depict a glove for a right hand. A glove for a left hand is a mirror image of the glove shown.

The diamond pattern on the index finger of the glove and inside of the glove represents a cut and abrasion resistant composite yarn as described in the related application listed above.

The broken lines in the drawings illustrate subject matter that forms no part of the claimed design.

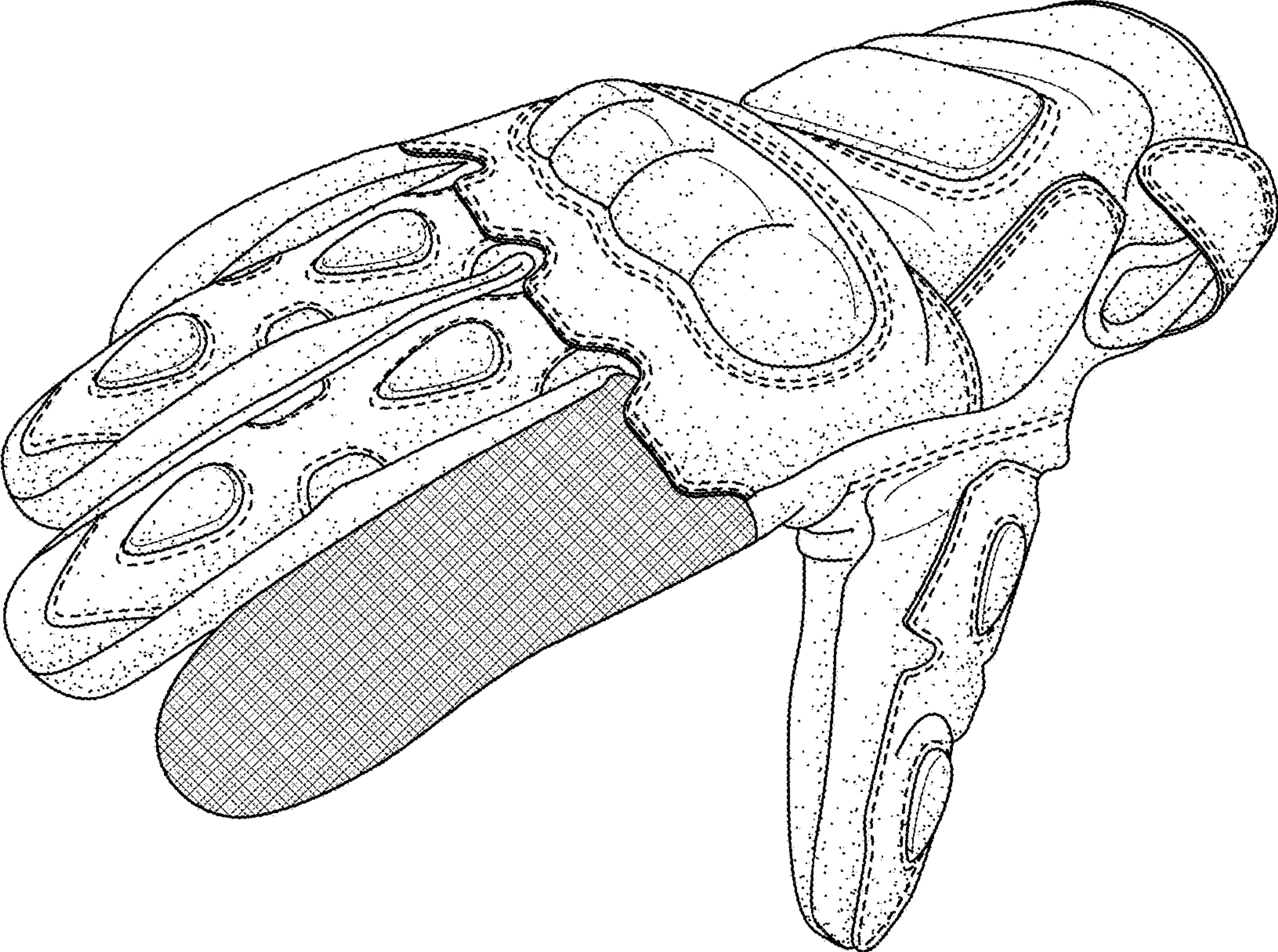

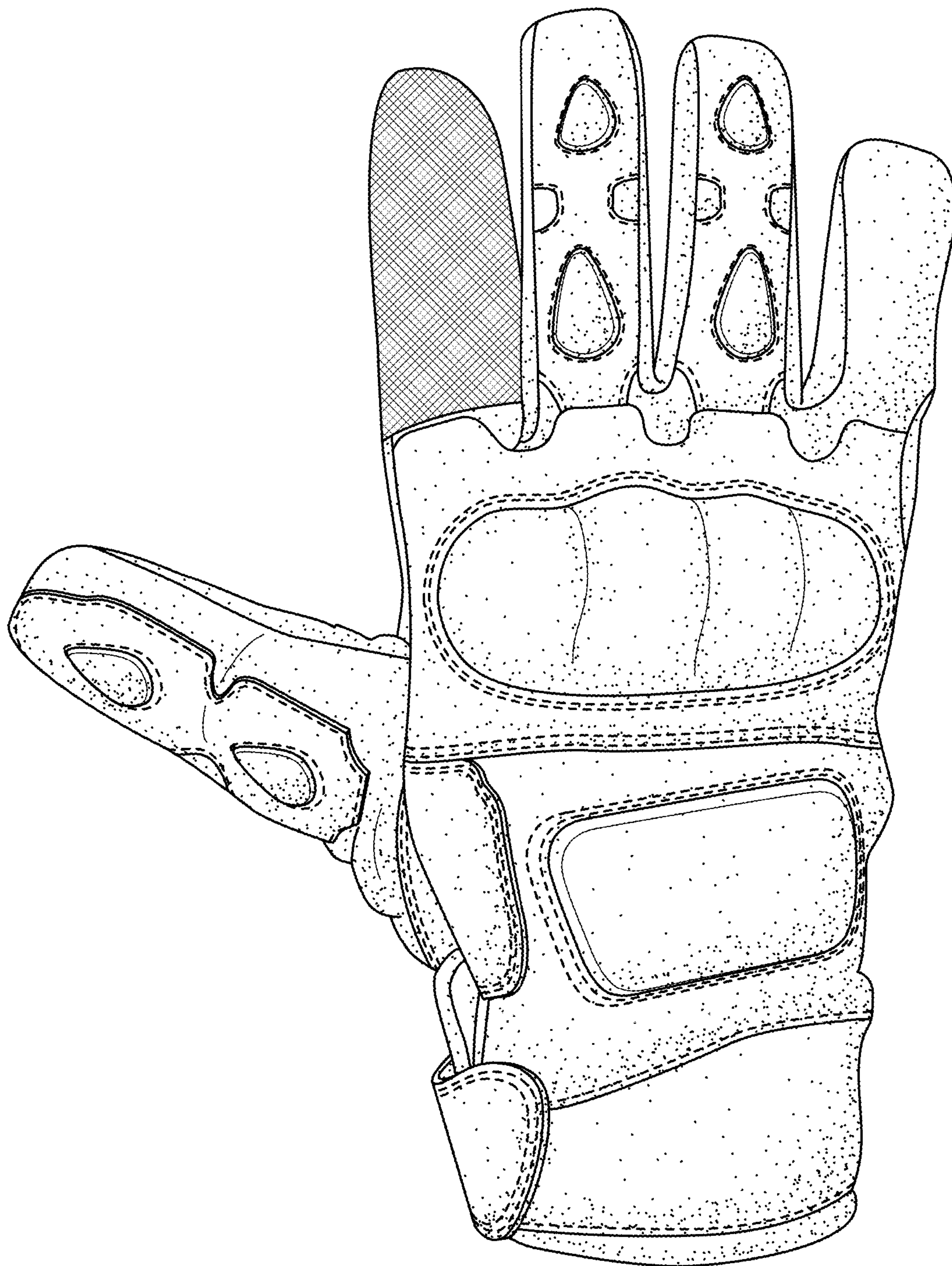

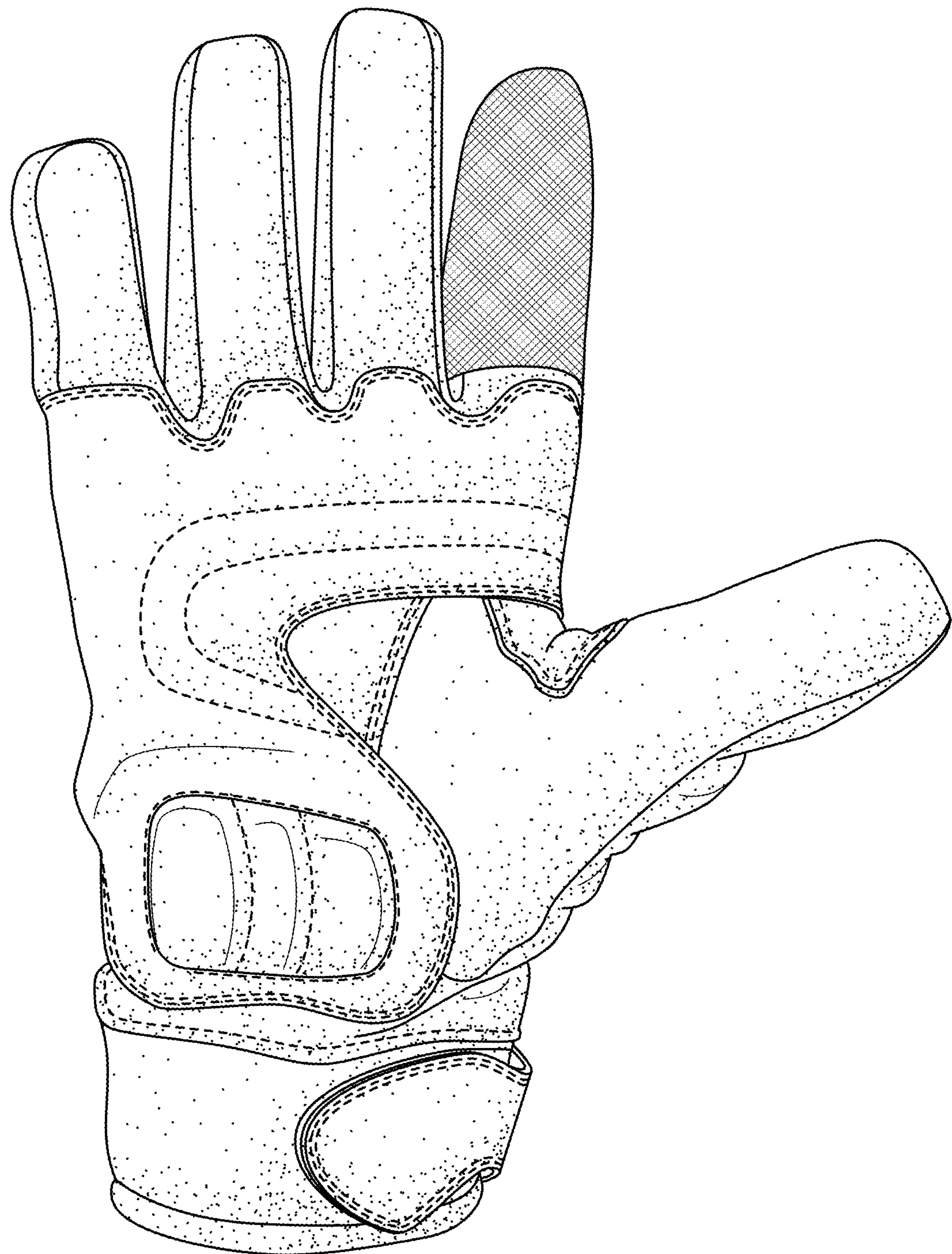

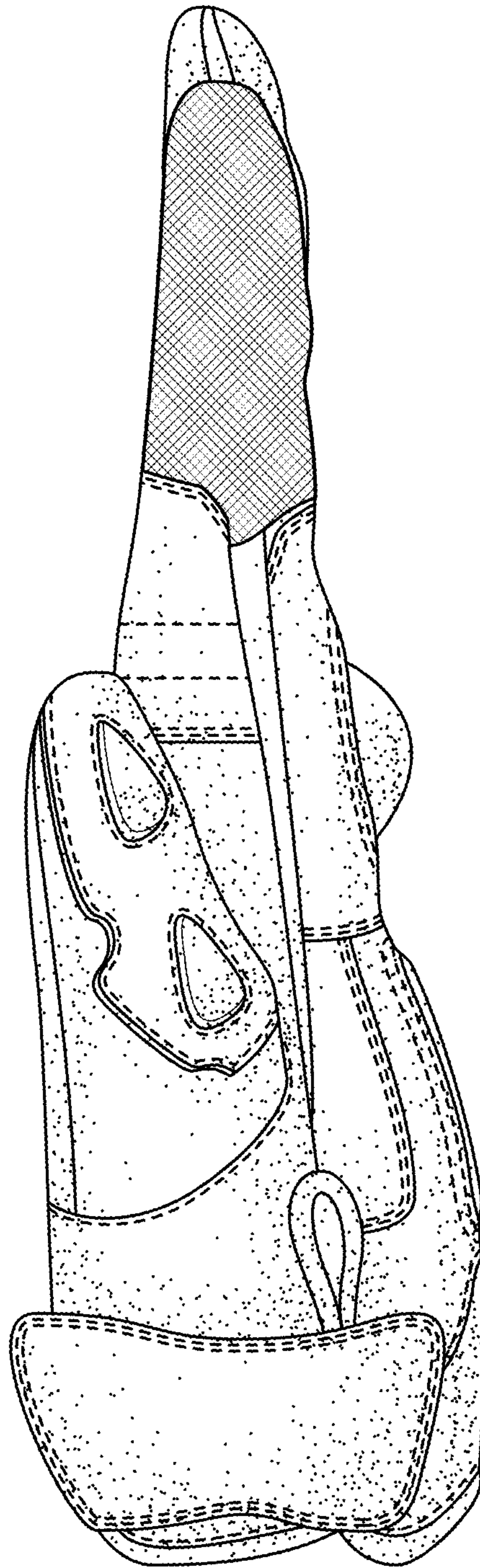

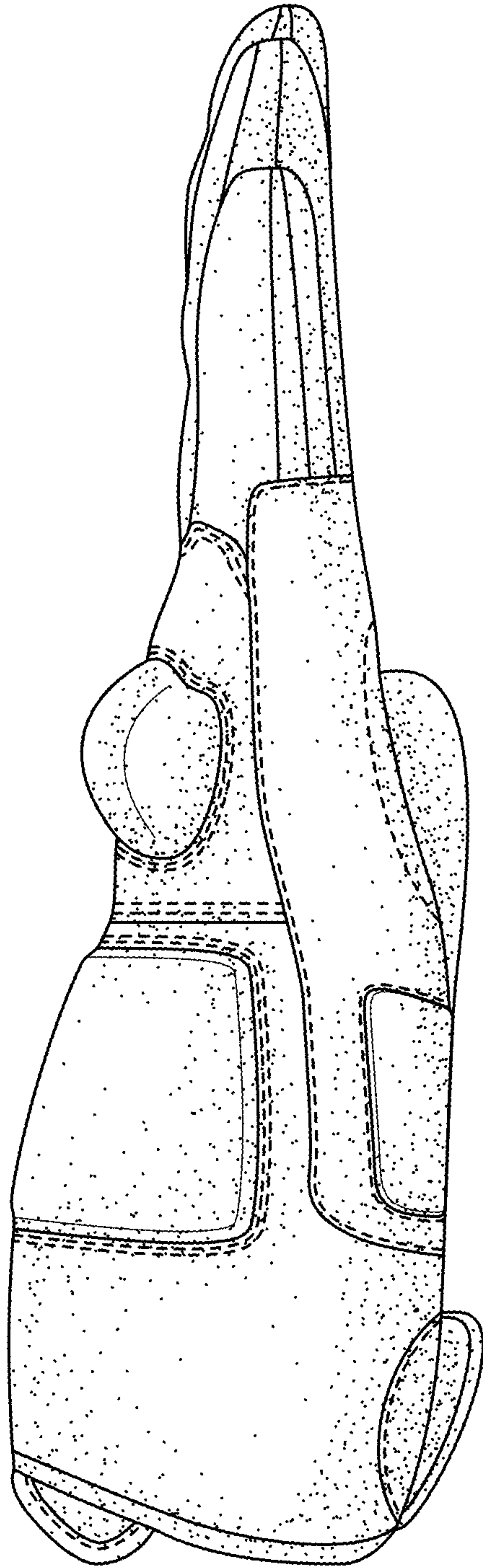

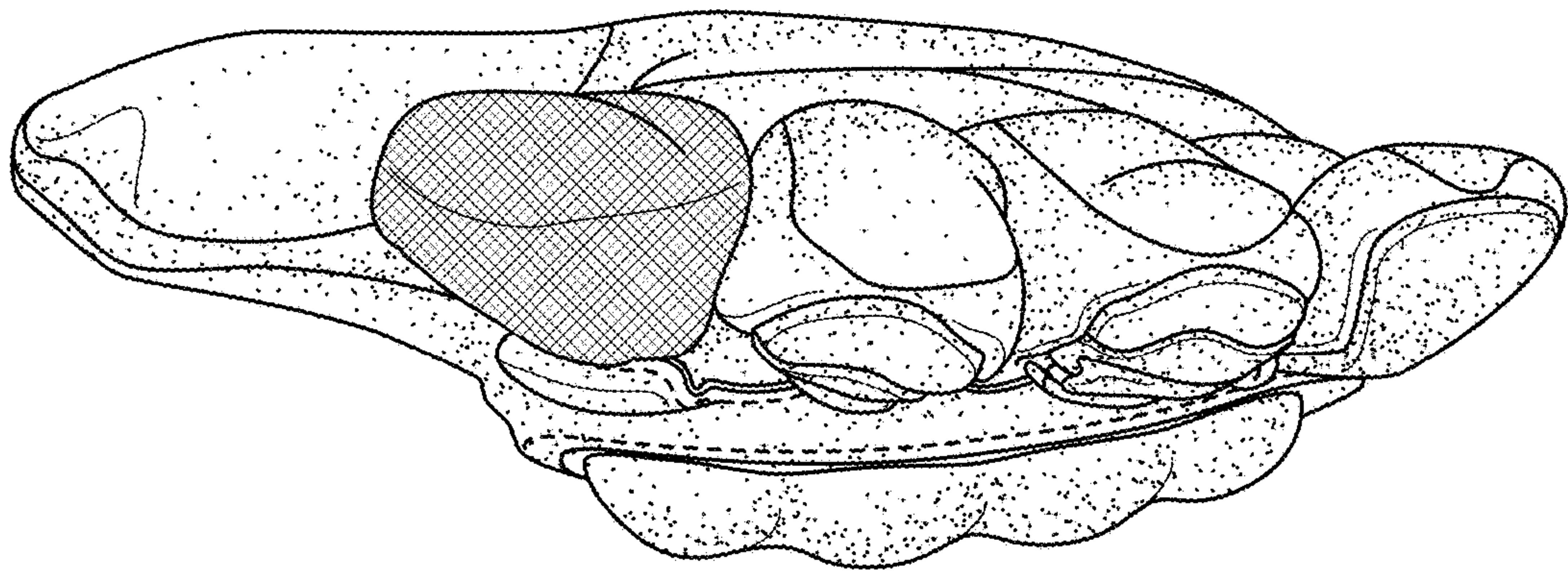

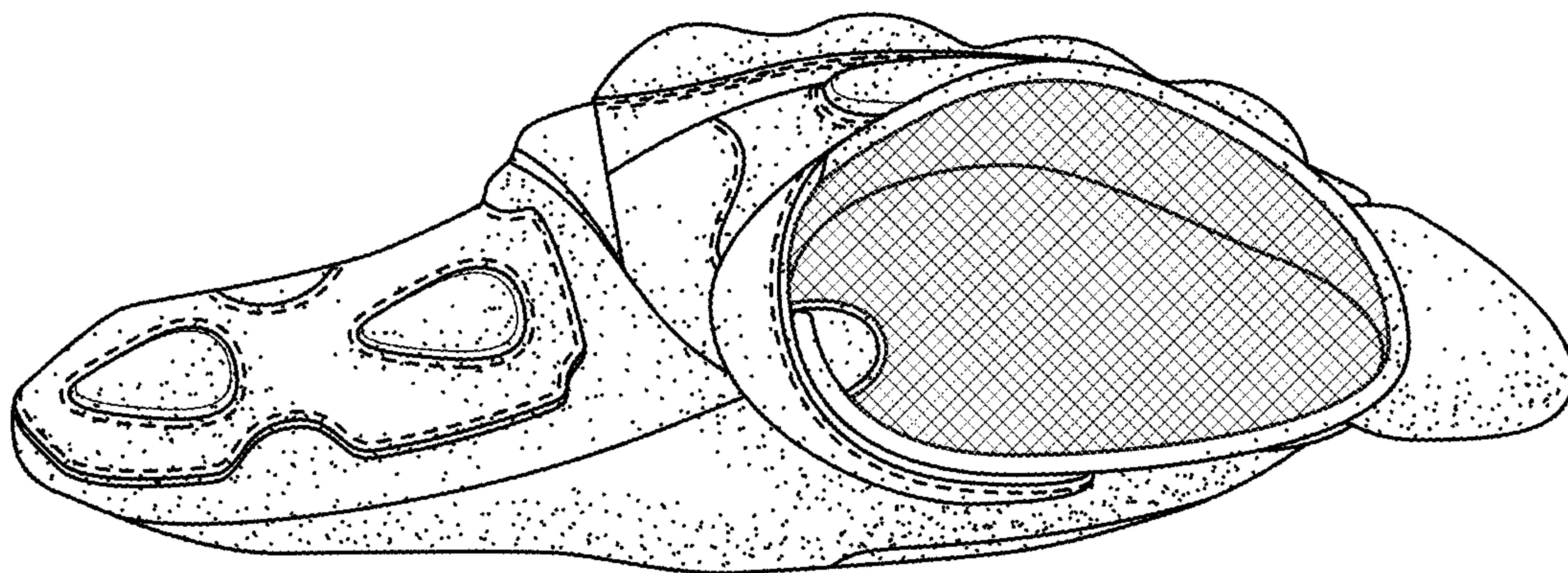
