(57) **CLAIM**

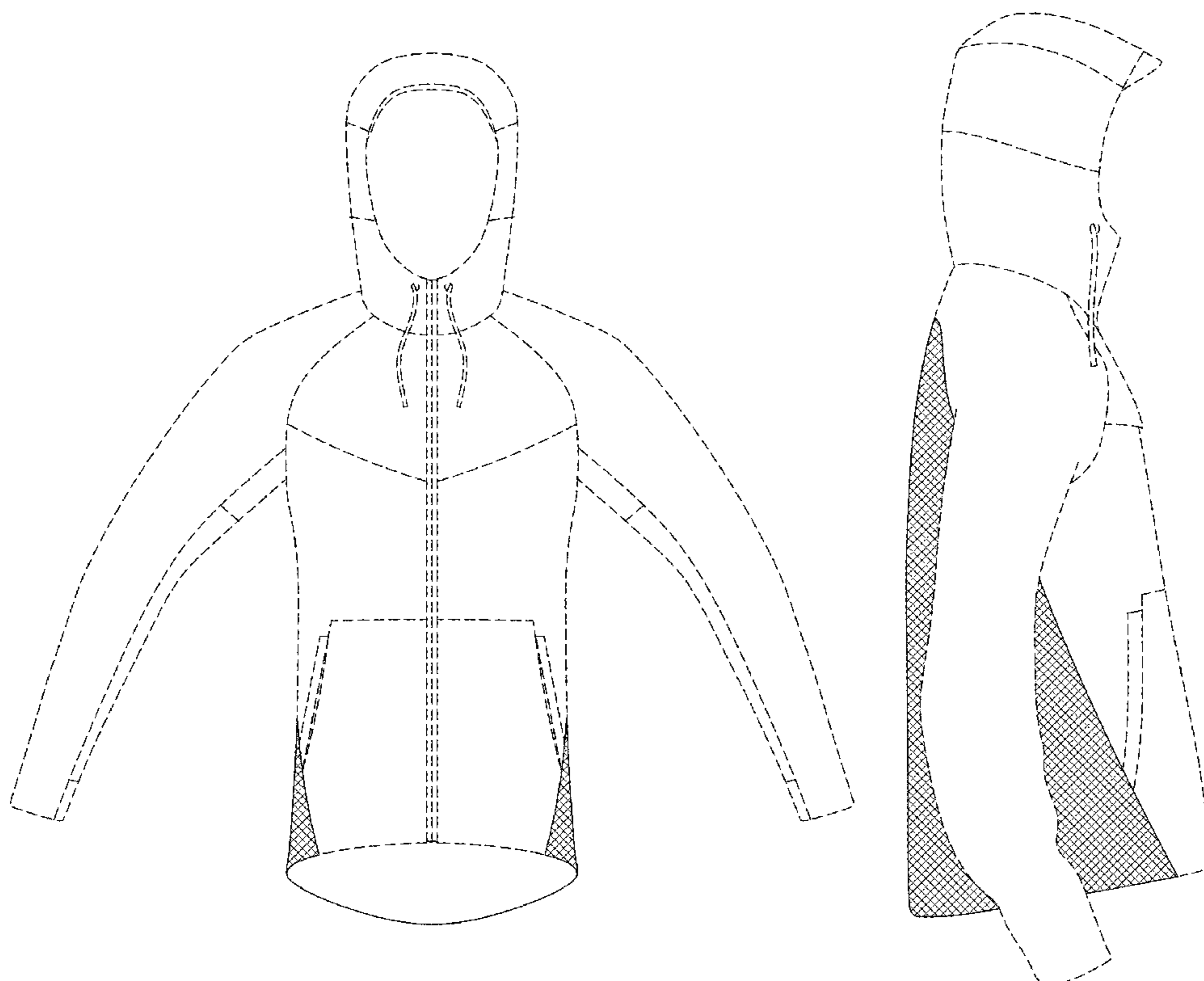
The ornamental design for a jacket, as shown and described.

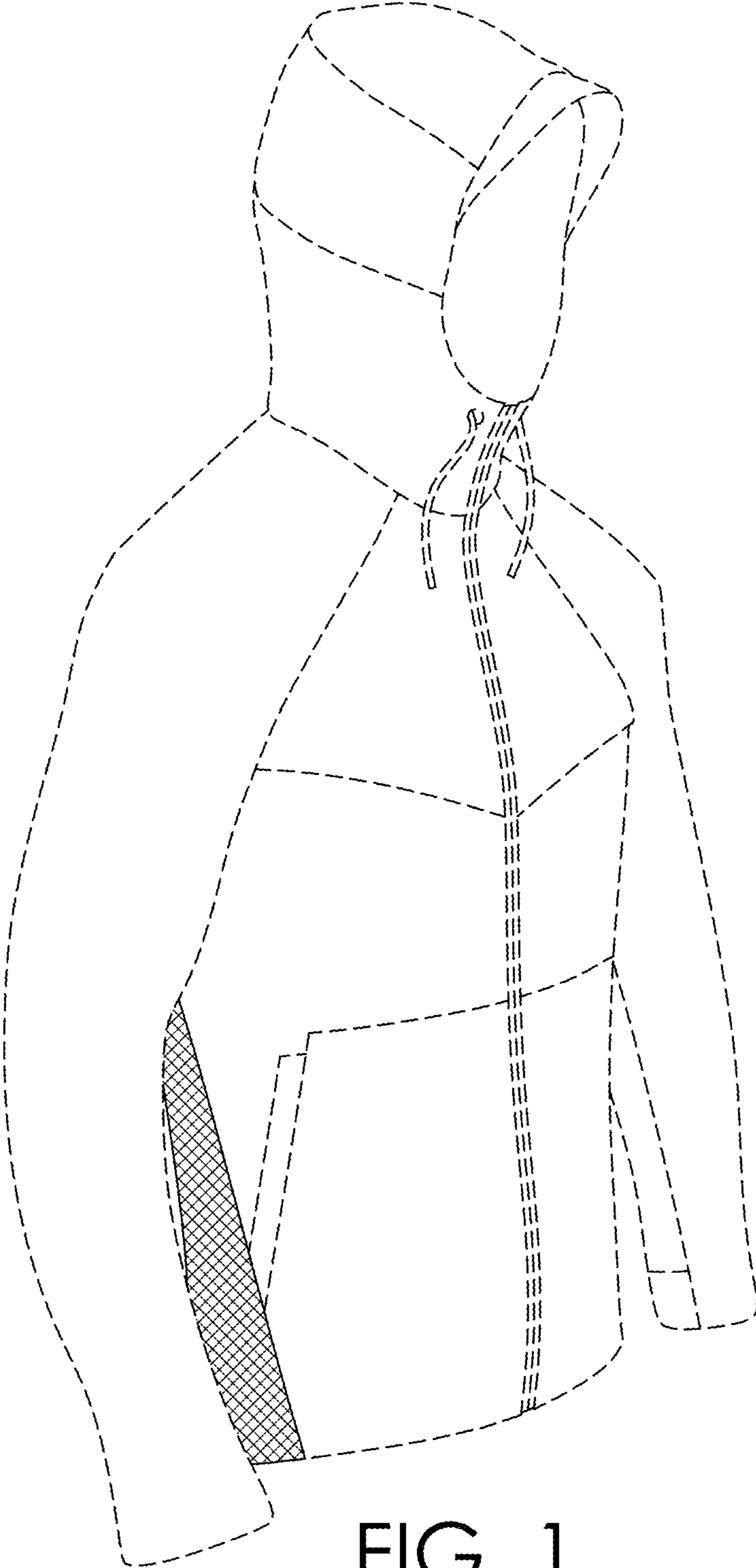

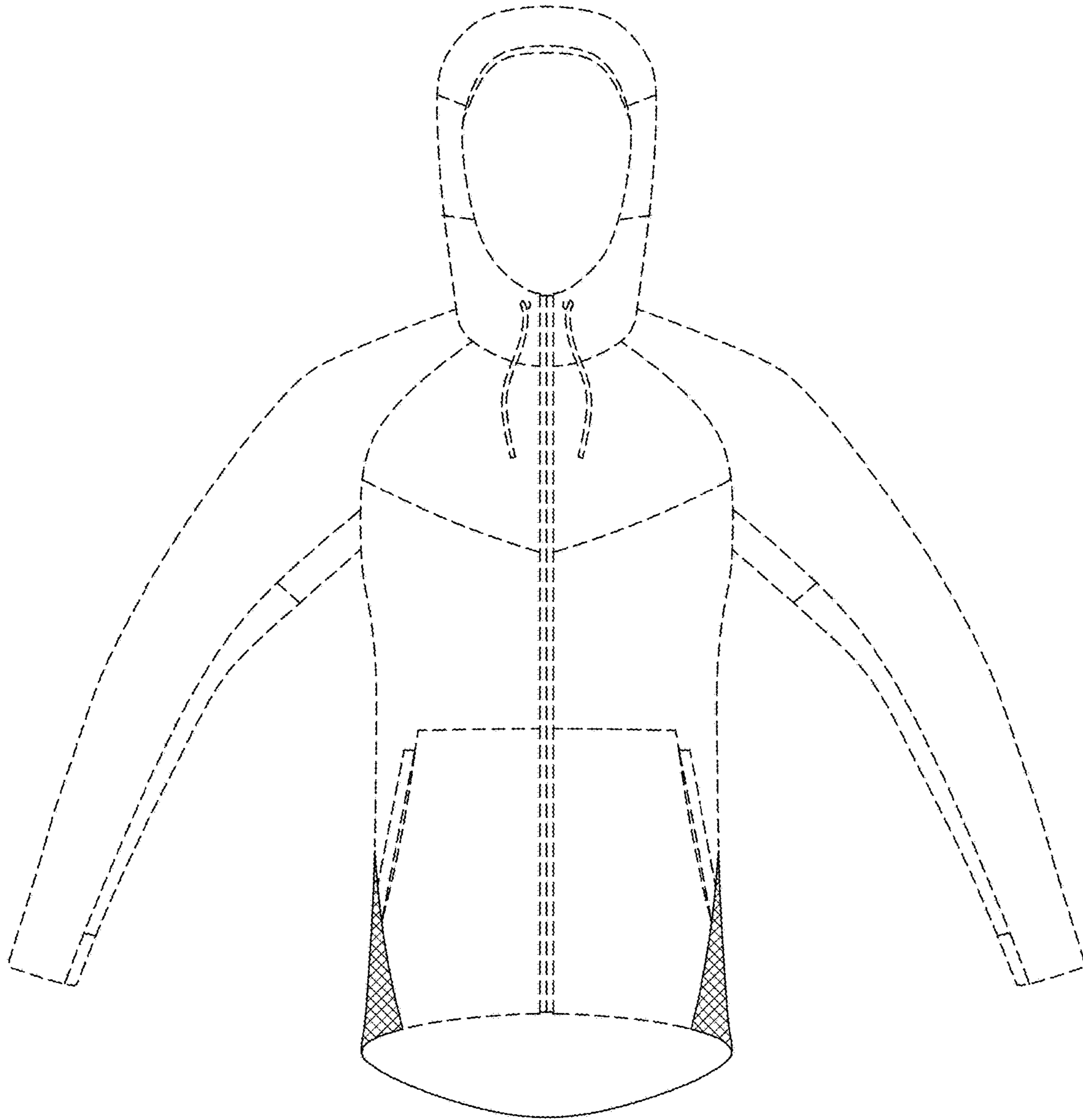

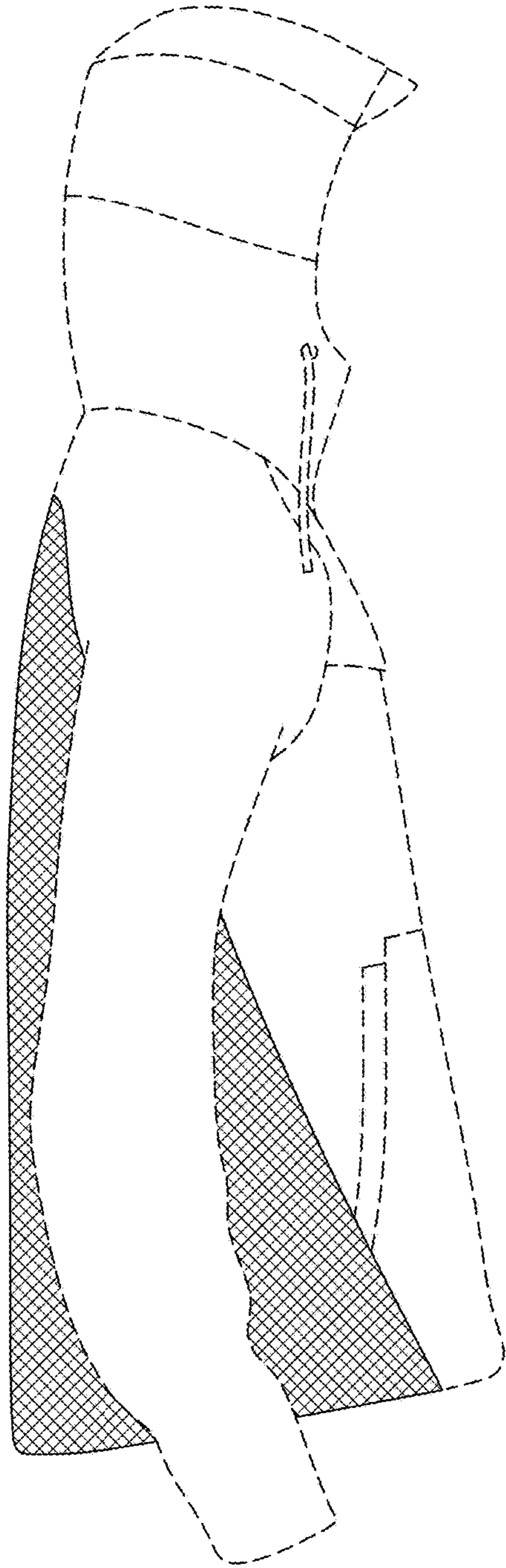

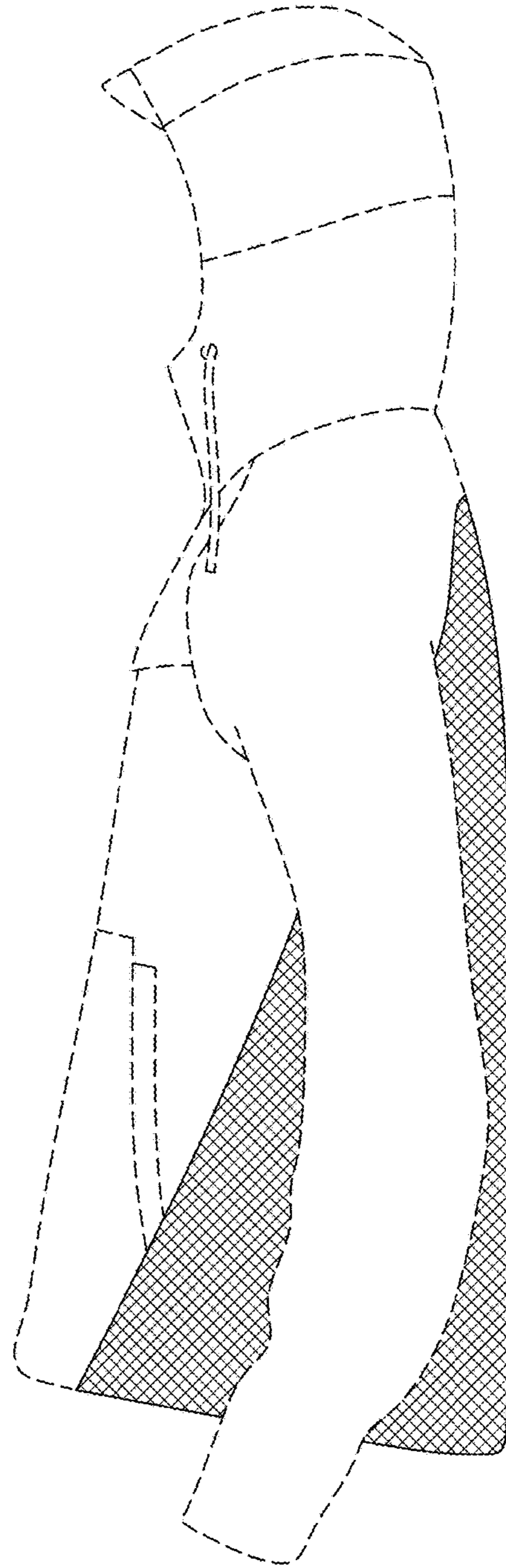

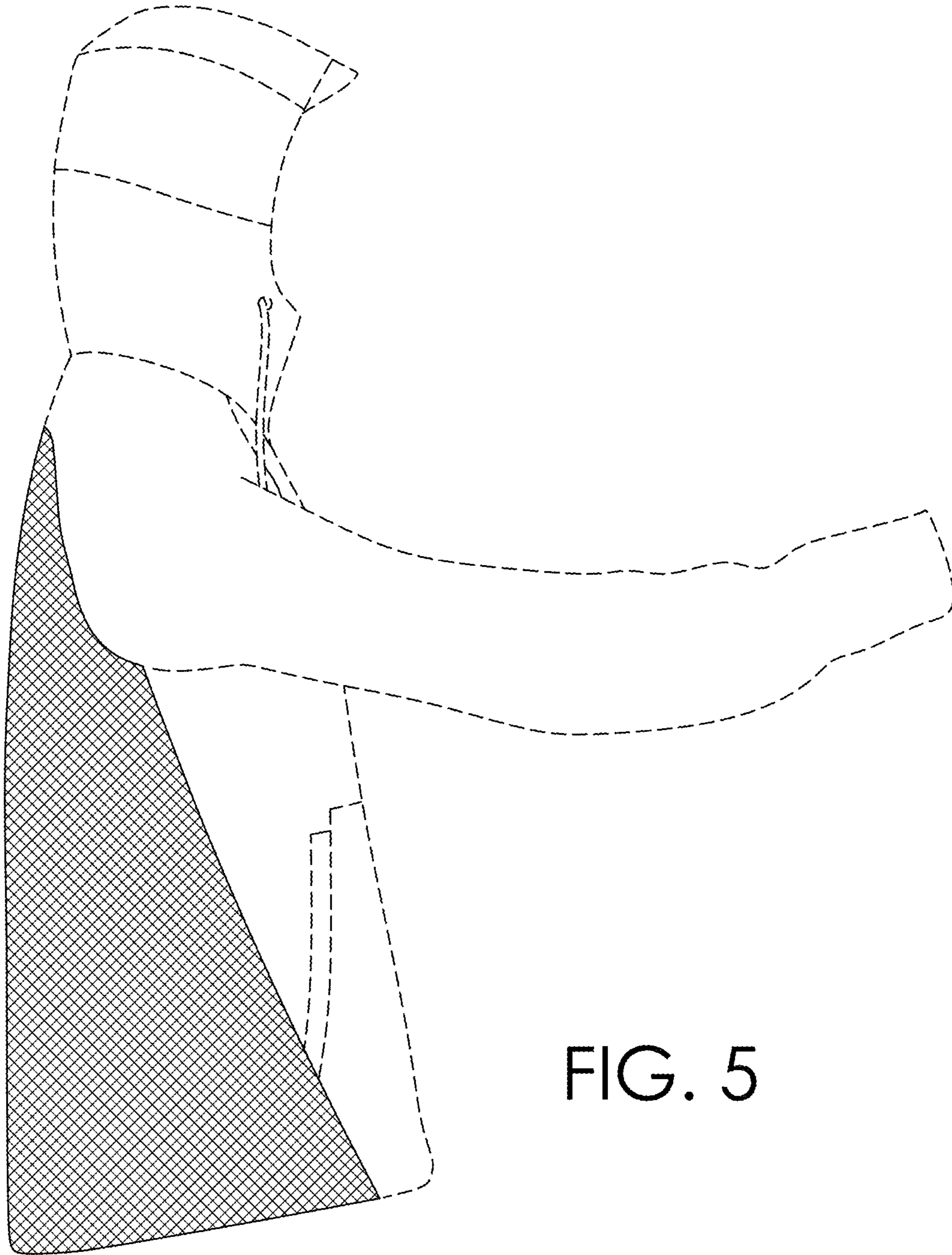

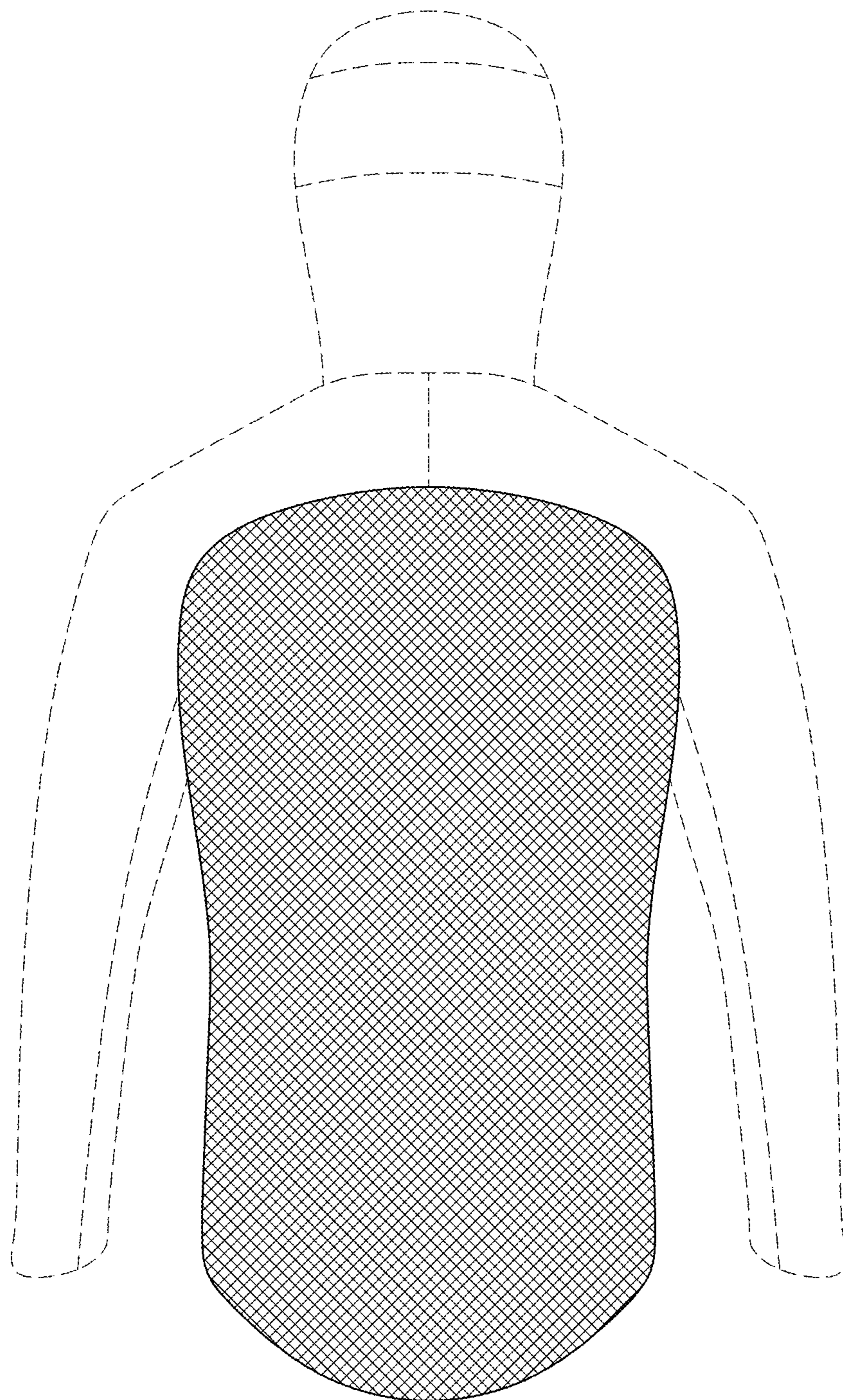
