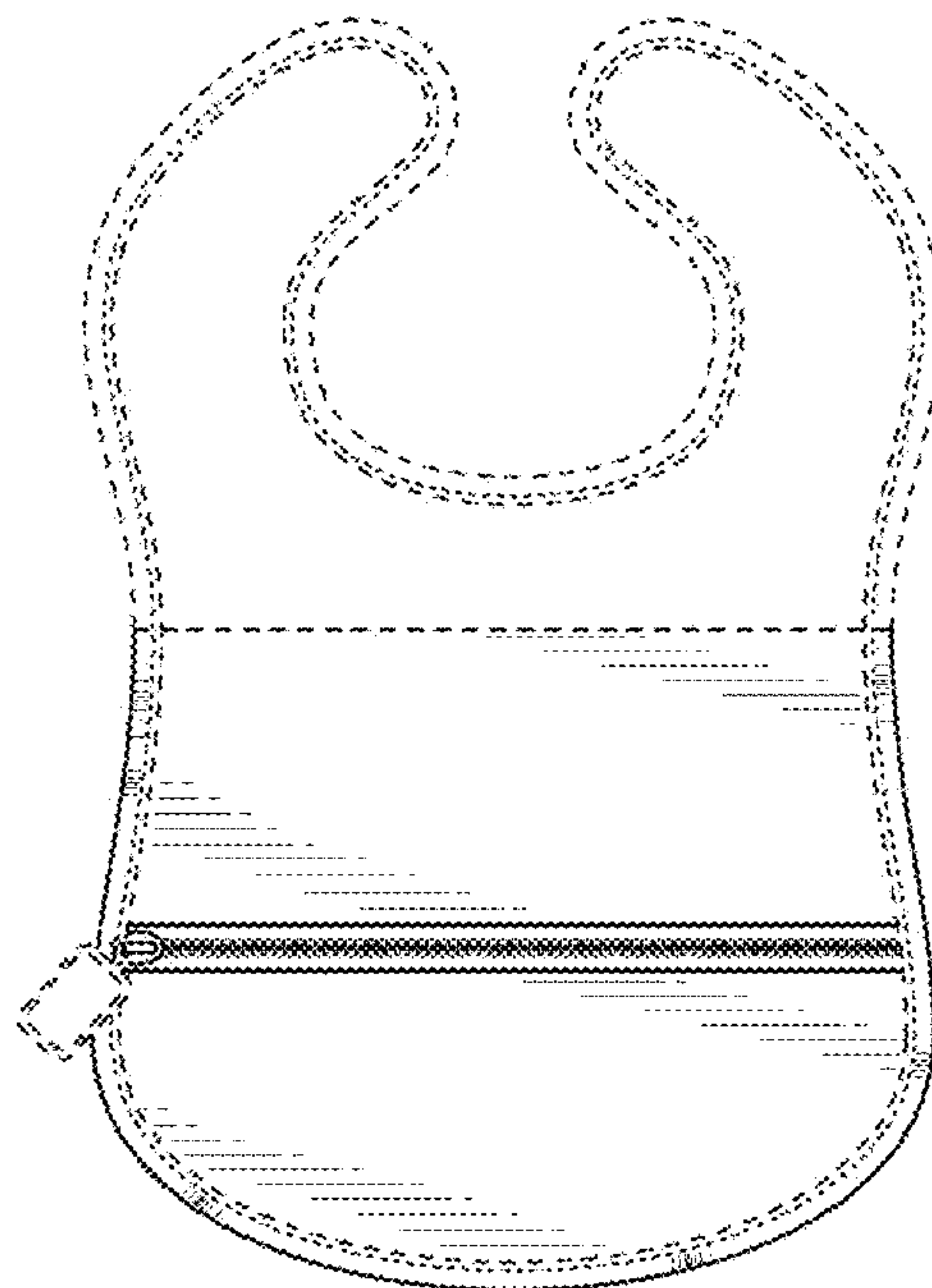
(57) **CLAIM**

The ornamental design for a bib, as shown and described.

DESCRIPTION

FIG. 1 is a first front view of the bib having a zipper in a closed configuration;
FIG. 2 is a second front view thereof with the zipper in an open configuration;
FIG. 3 is a rear view thereof;
FIG. 4 is a side view thereof; and,
FIG. 5 is a top-side view thereof.
The details shown in broken lines form no part of the claimed design.

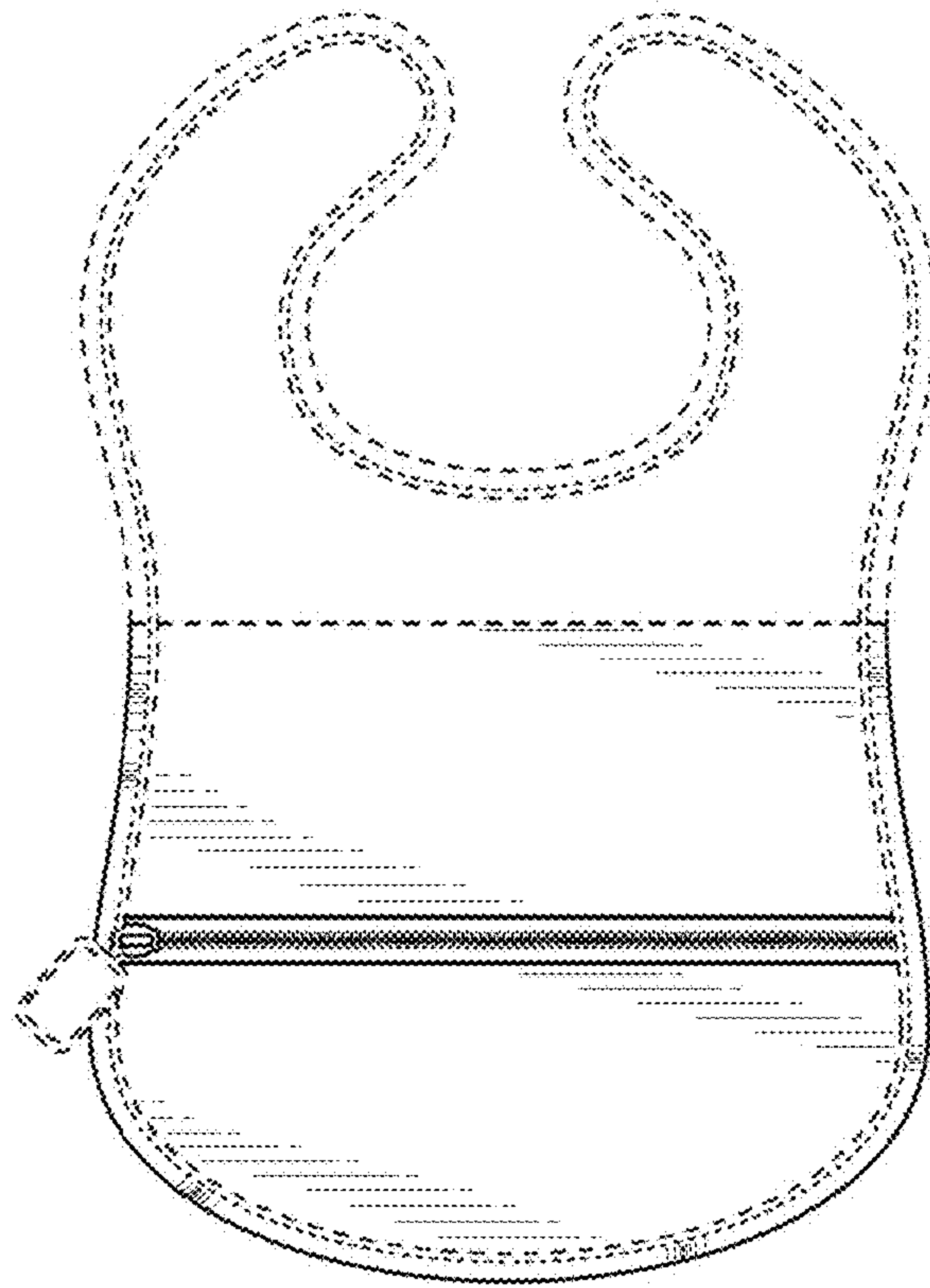

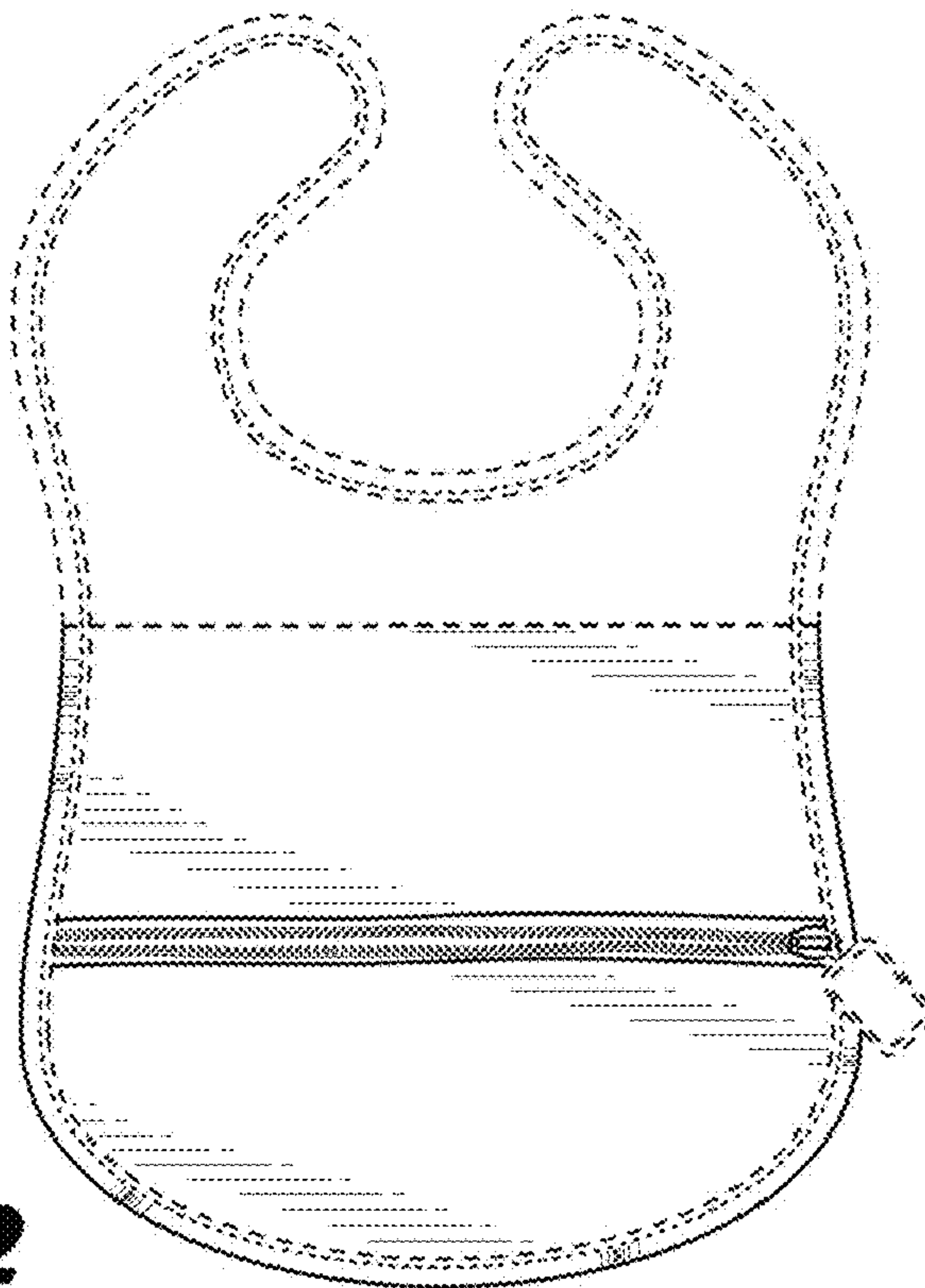

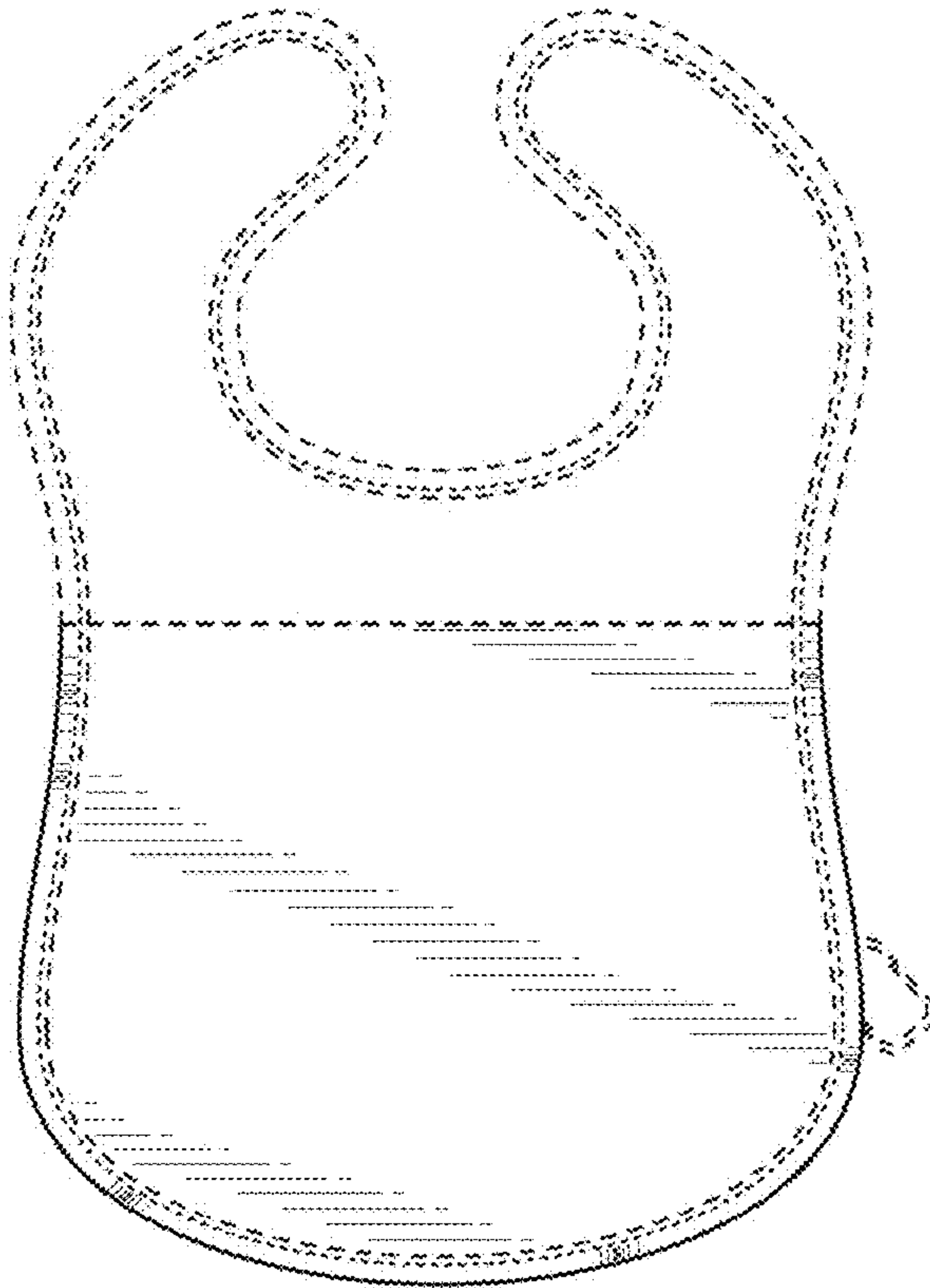

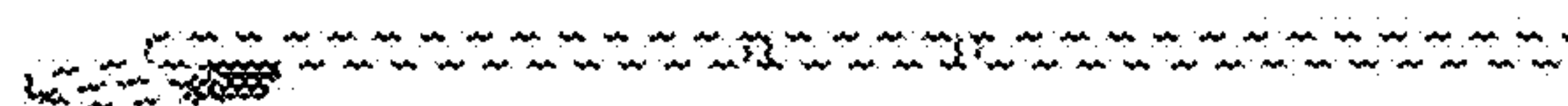
