**DESCRIPTION**

FIG. 1 is a front perspective view of the present invention. FIG. 2 is a front elevation view of the invention as shown in FIG. 1.

The dashed lines in the views form no part of the claimed design and reflect environmental subject matter. No claim is made to the inner surface of the sun shade.

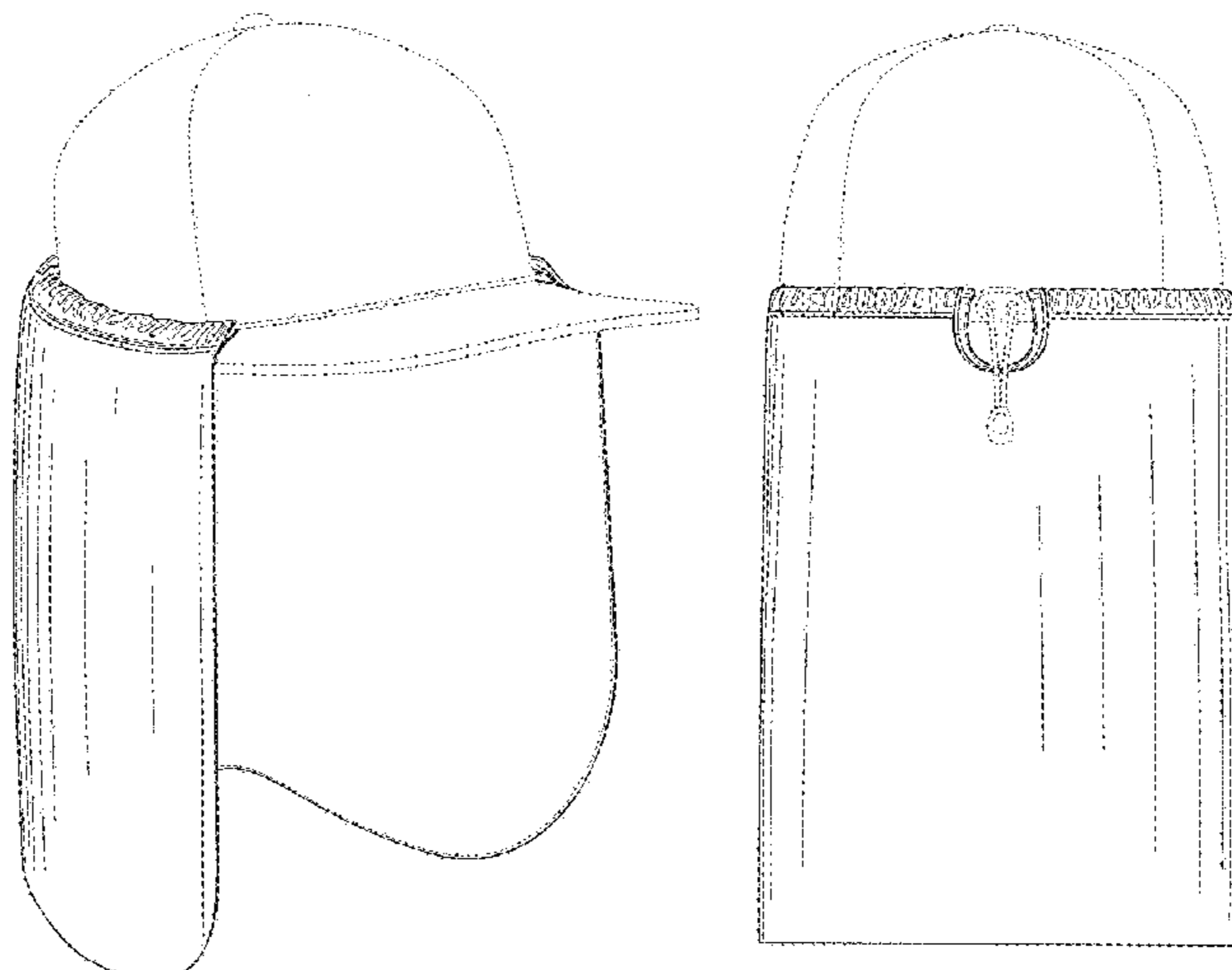

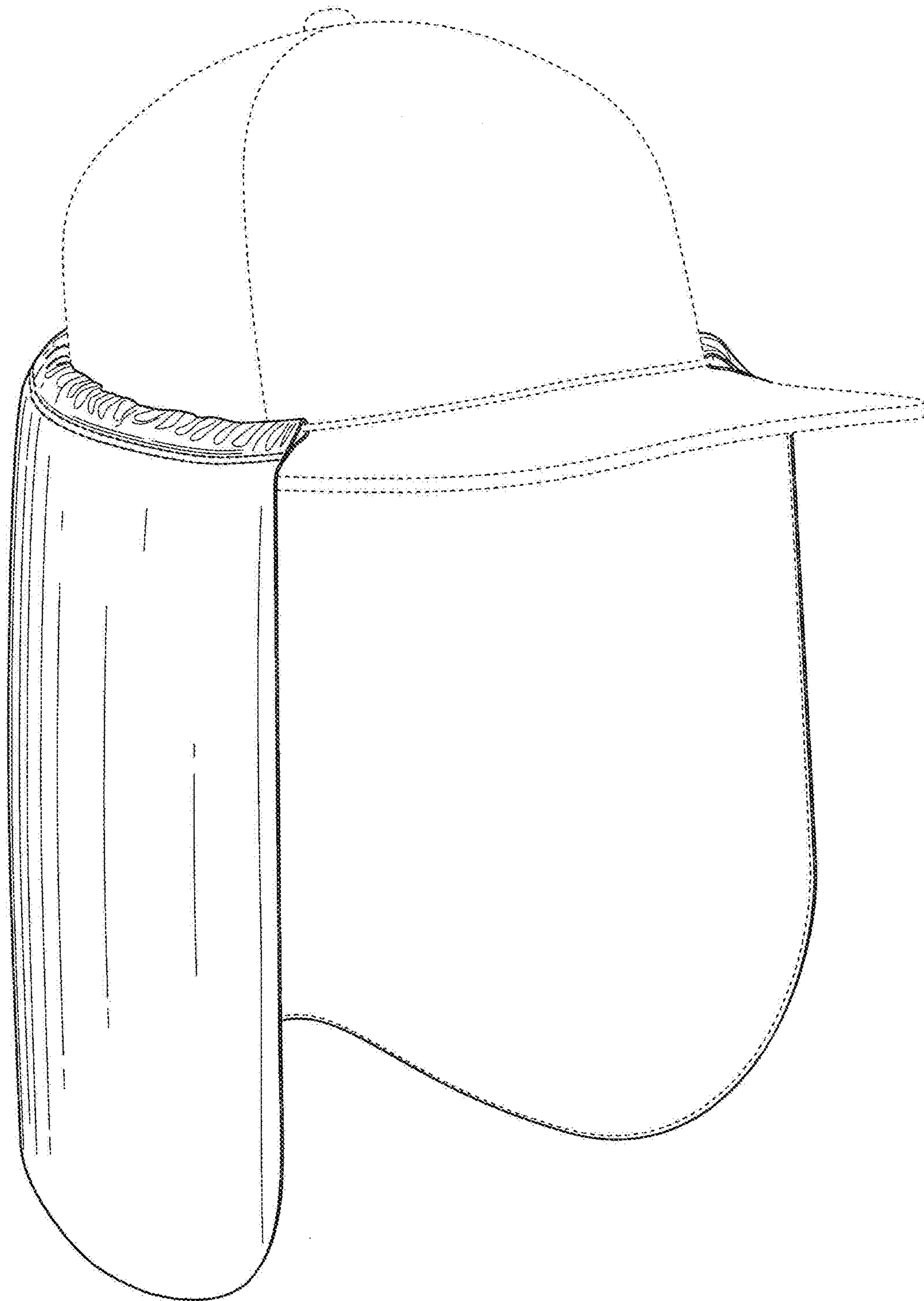

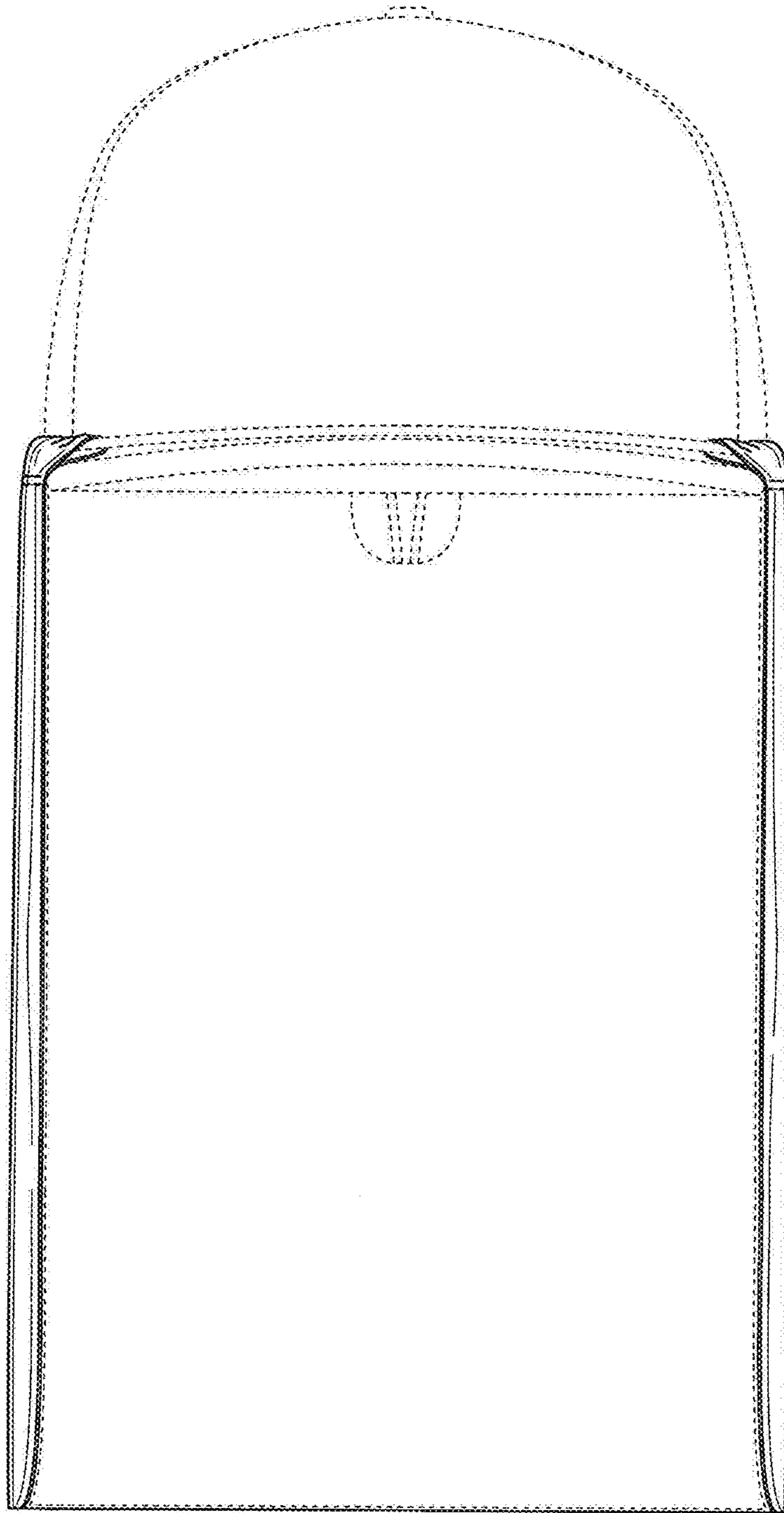

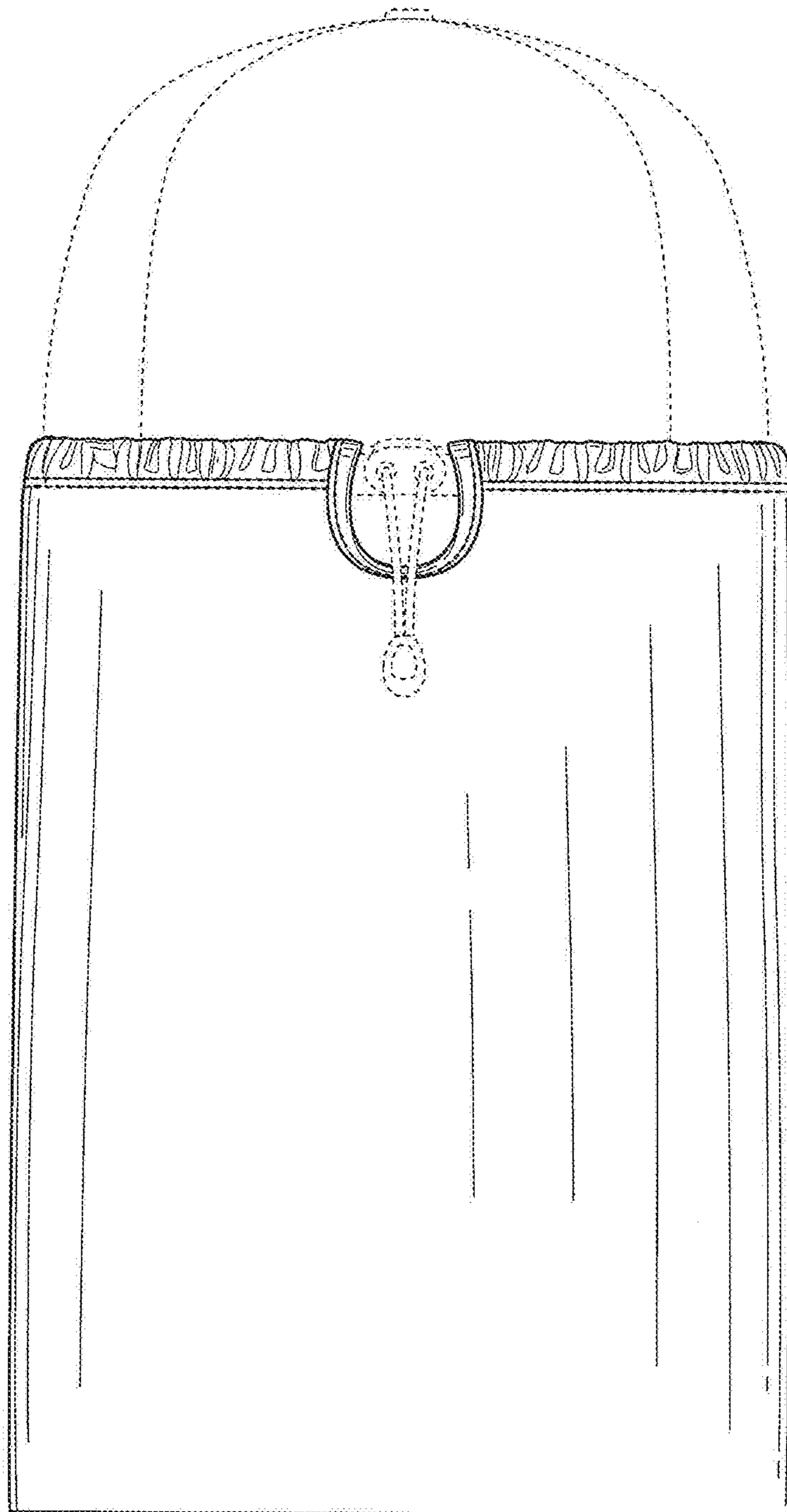

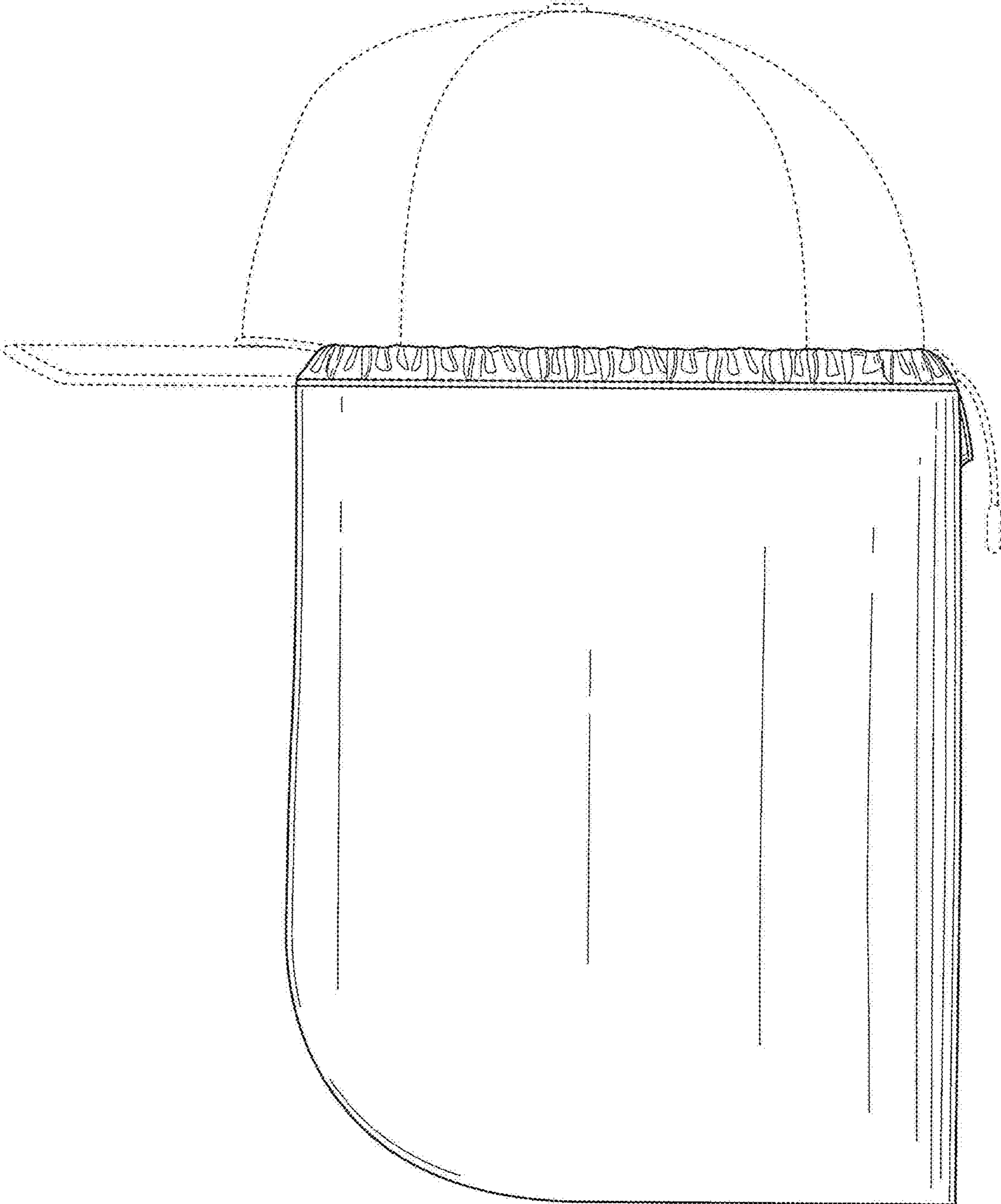

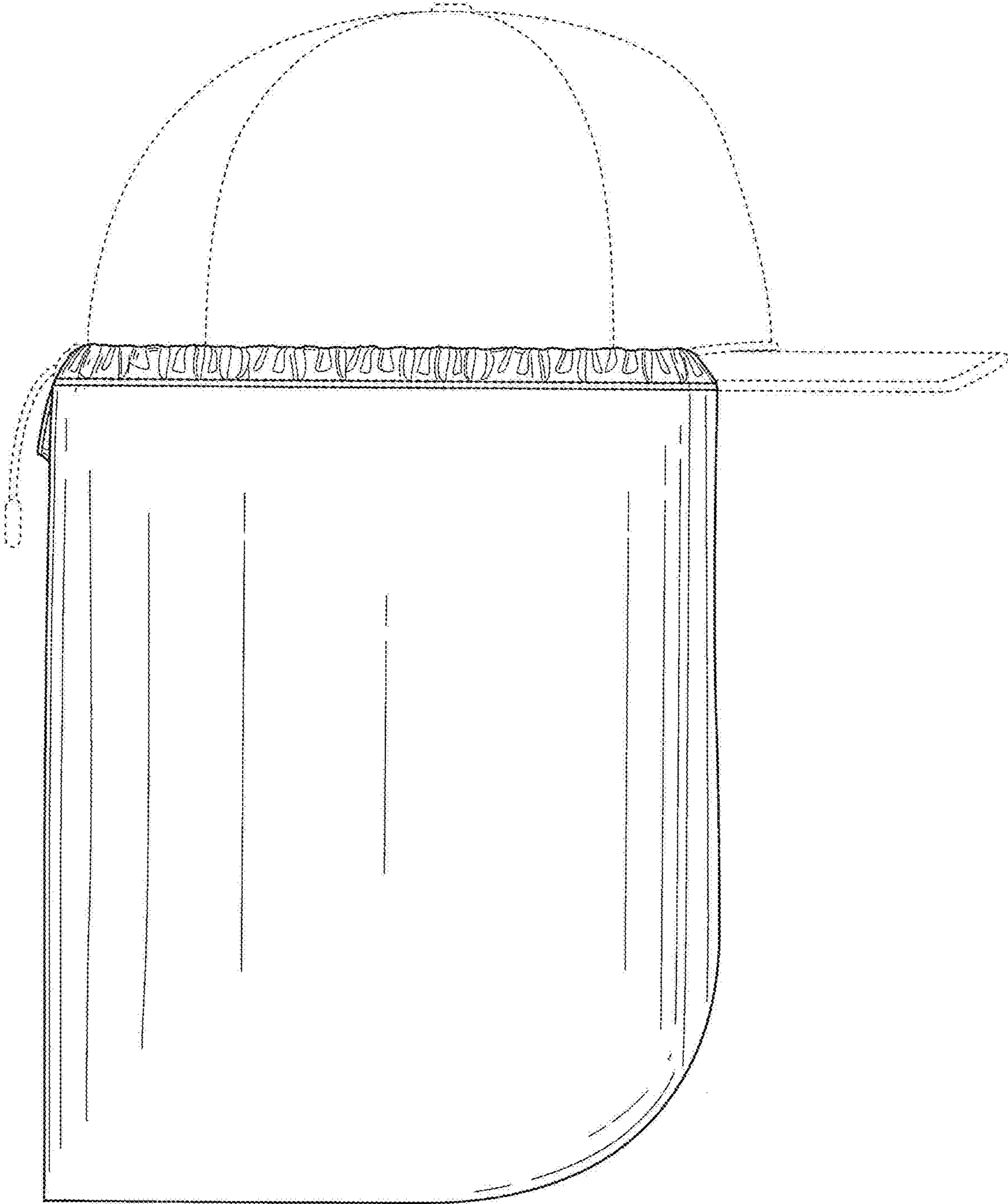

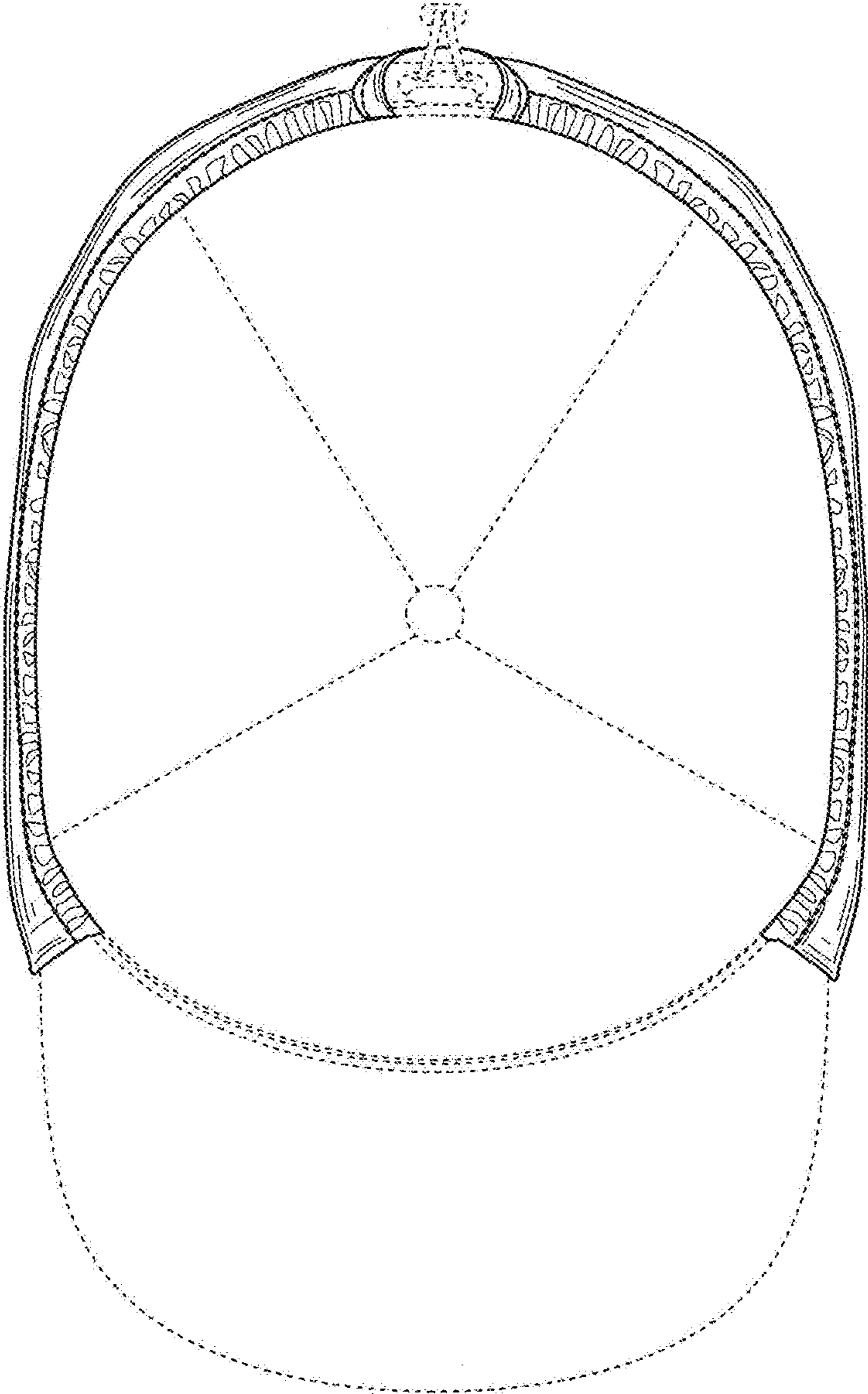

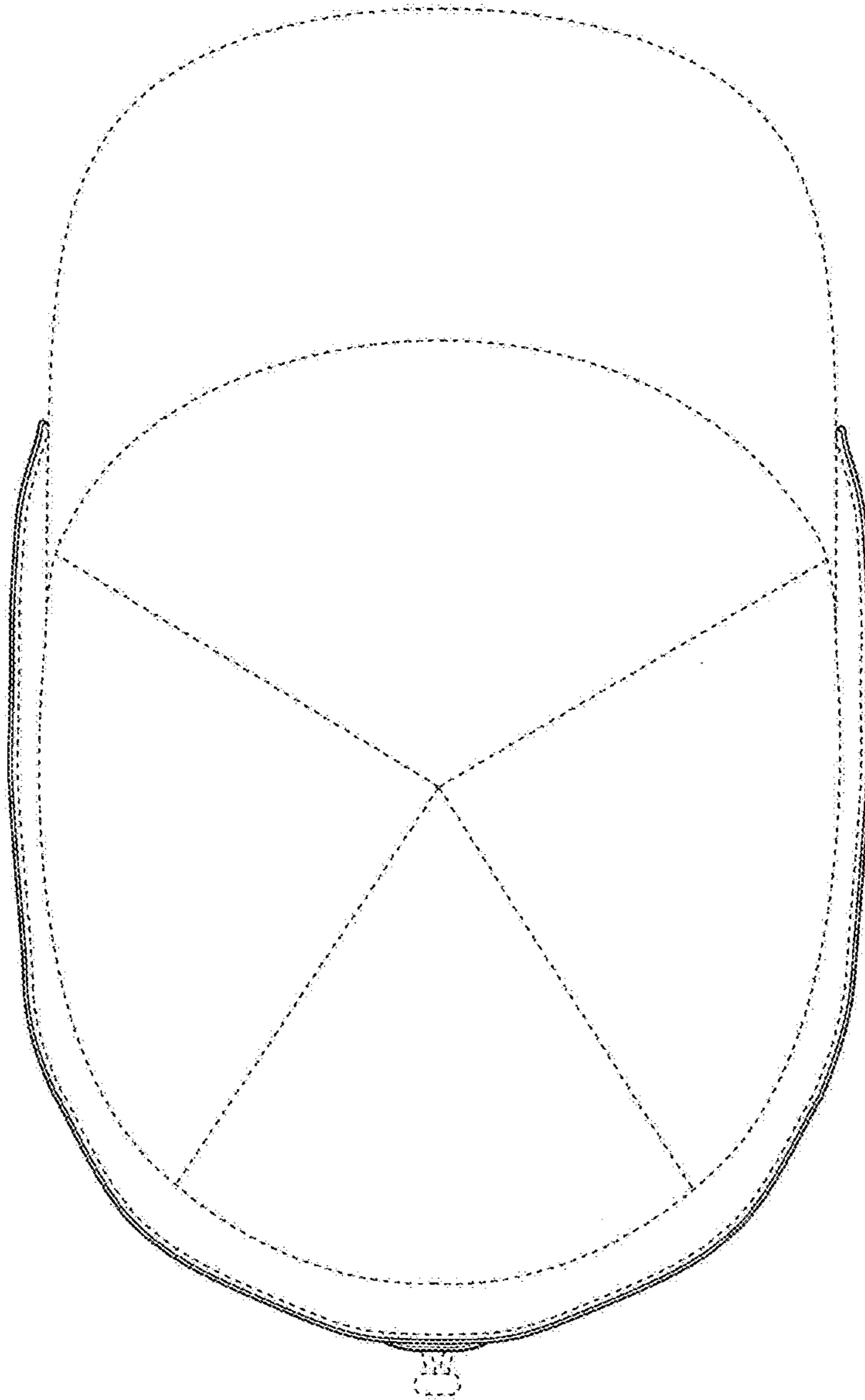
