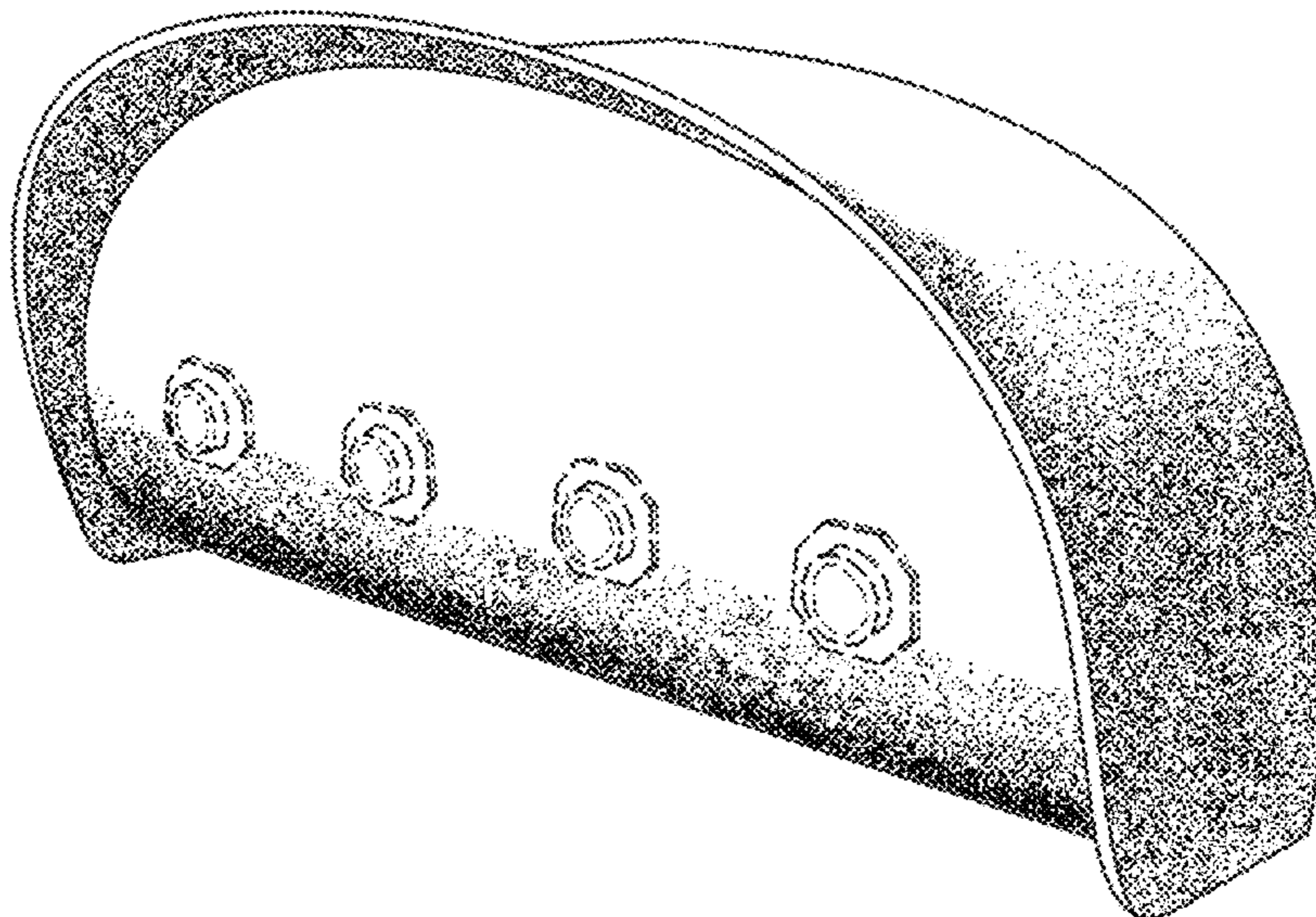

DESCRIPTION

FIG. 1 is a front right perspective view of an embodiment of our design.
FIG. 2 is a front elevational view of the embodiment shown in FIG. 1.
FIG. 3 is a top elevational view of the embodiment shown in FIG. 1.
FIG. 4 is a bottom elevational view of the embodiment shown in FIG. 1.
FIG. 5 is a left elevational view of the embodiment shown in FIG. 1.
FIG. 6 is a right elevational view of the embodiment shown in FIG. 1.
FIG. 7 is a front right perspective view of another embodiment of our design.
FIG. 8 is a front elevational view of the embodiment shown in FIG. 7.
FIG. 9 is a top elevational view of the embodiment shown in FIG. 7.
FIG. 10 is a bottom elevational view of the embodiment shown in FIG. 7.
FIG. 11 is a left elevational view of the embodiment shown in FIG. 7; and,
FIG. 12 is a right elevational view of the embodiment shown in FIG. 7.

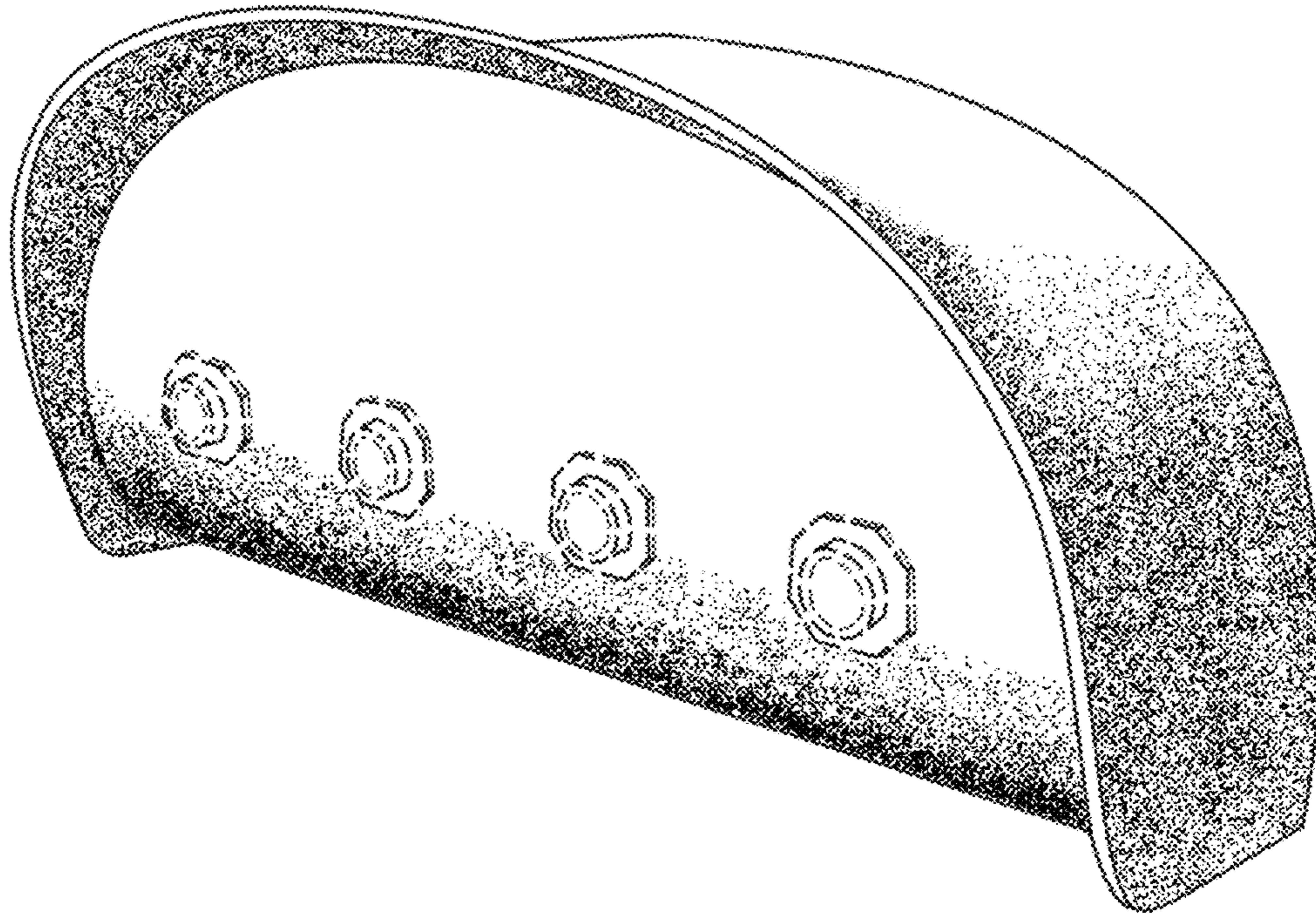

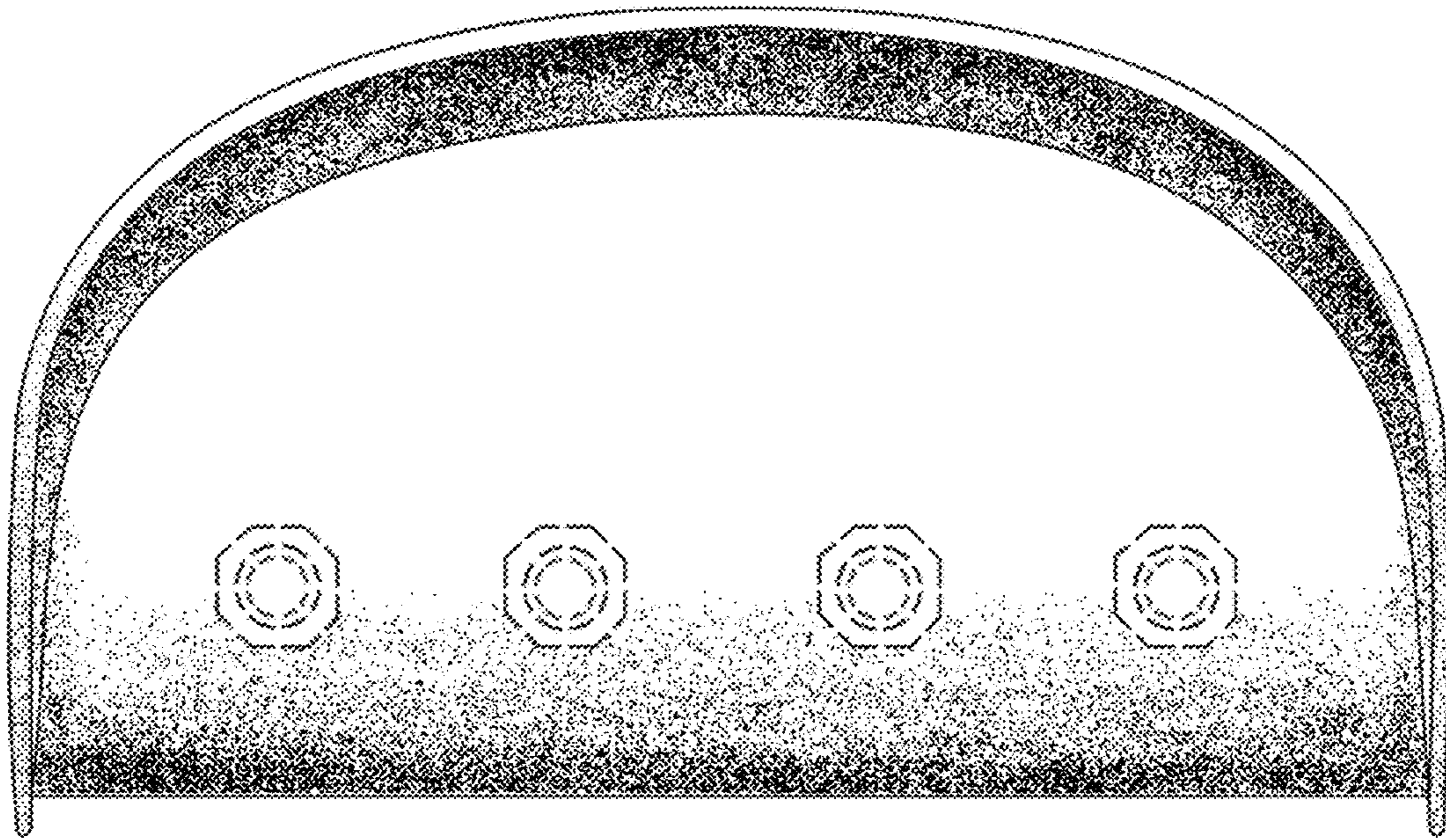

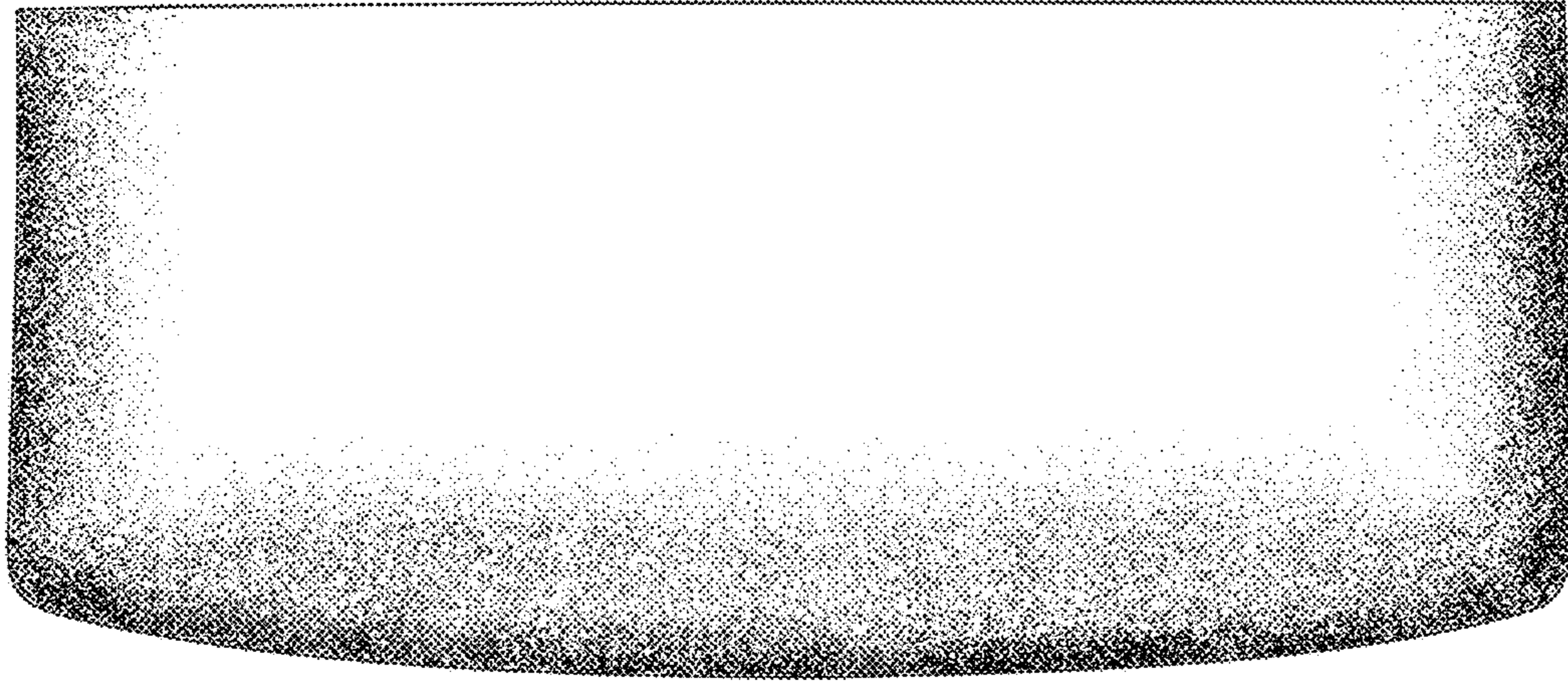

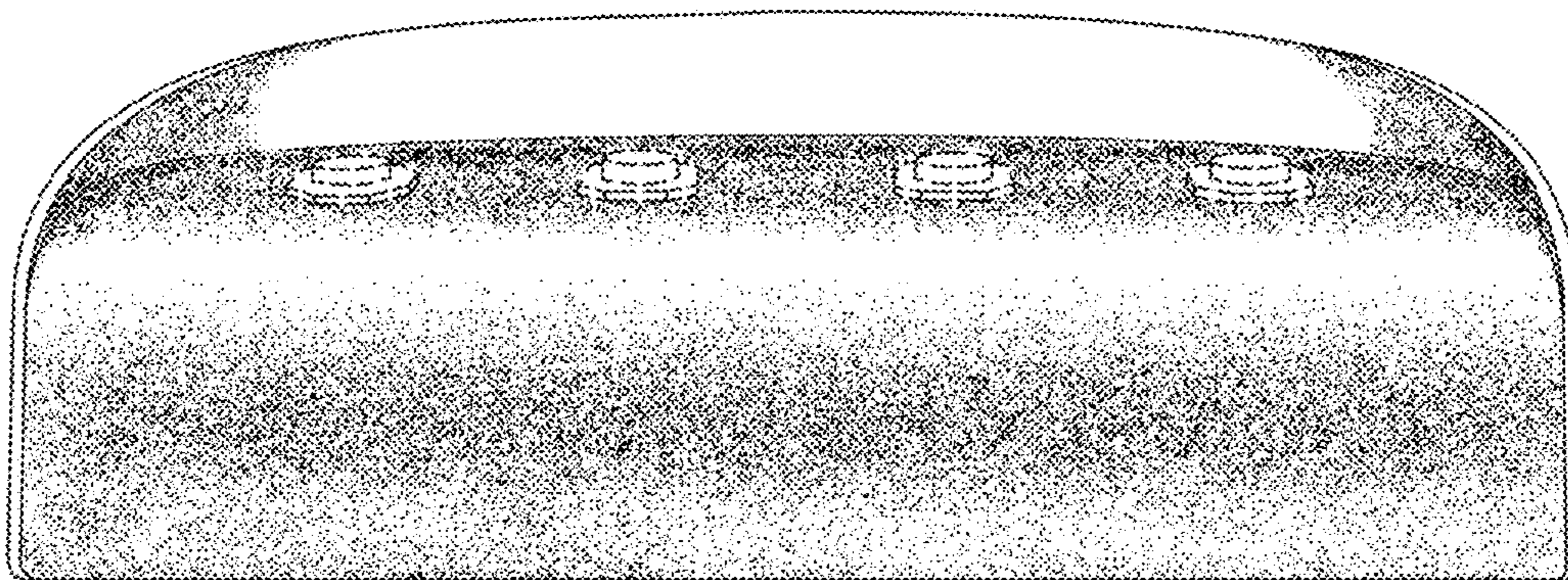

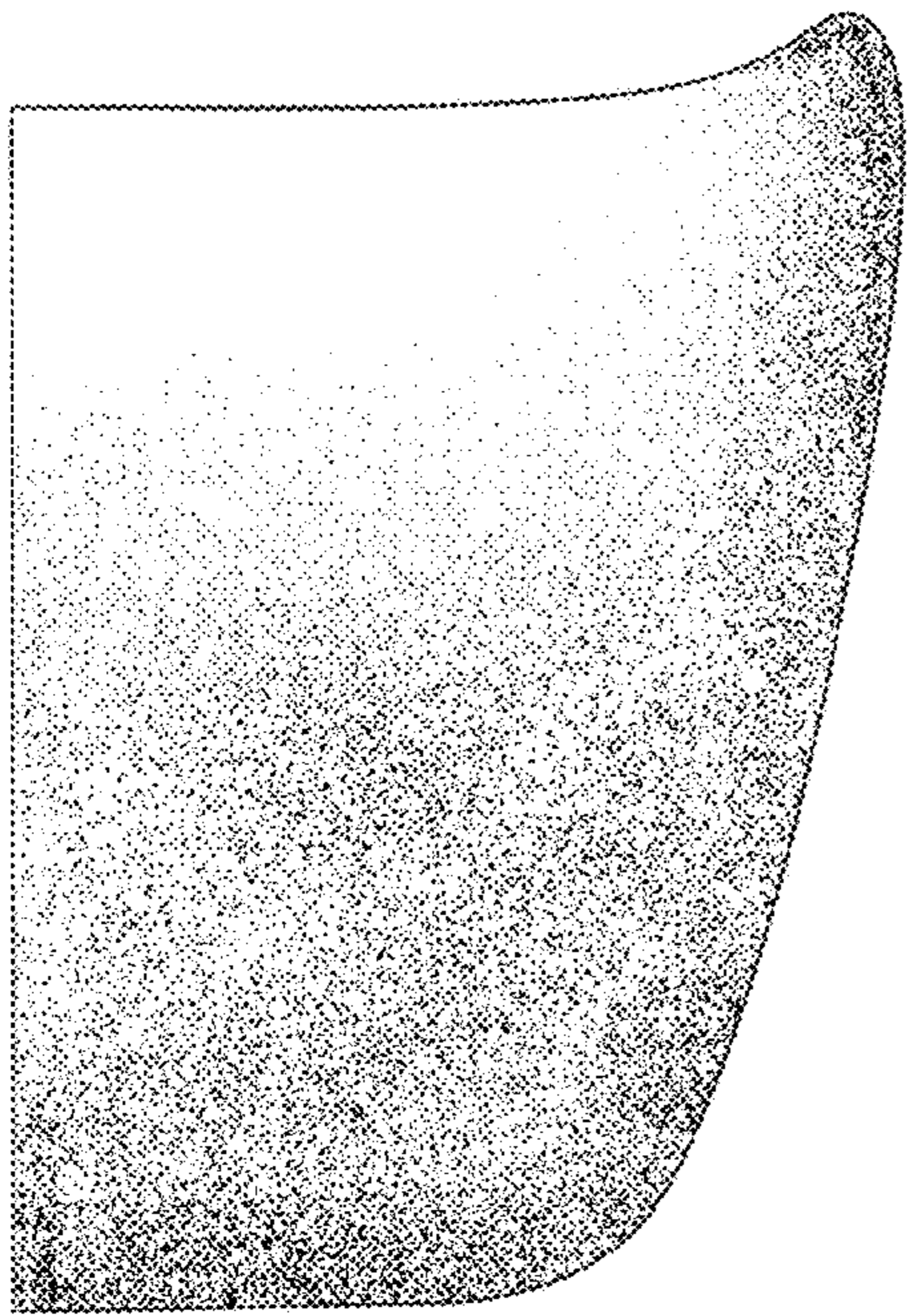

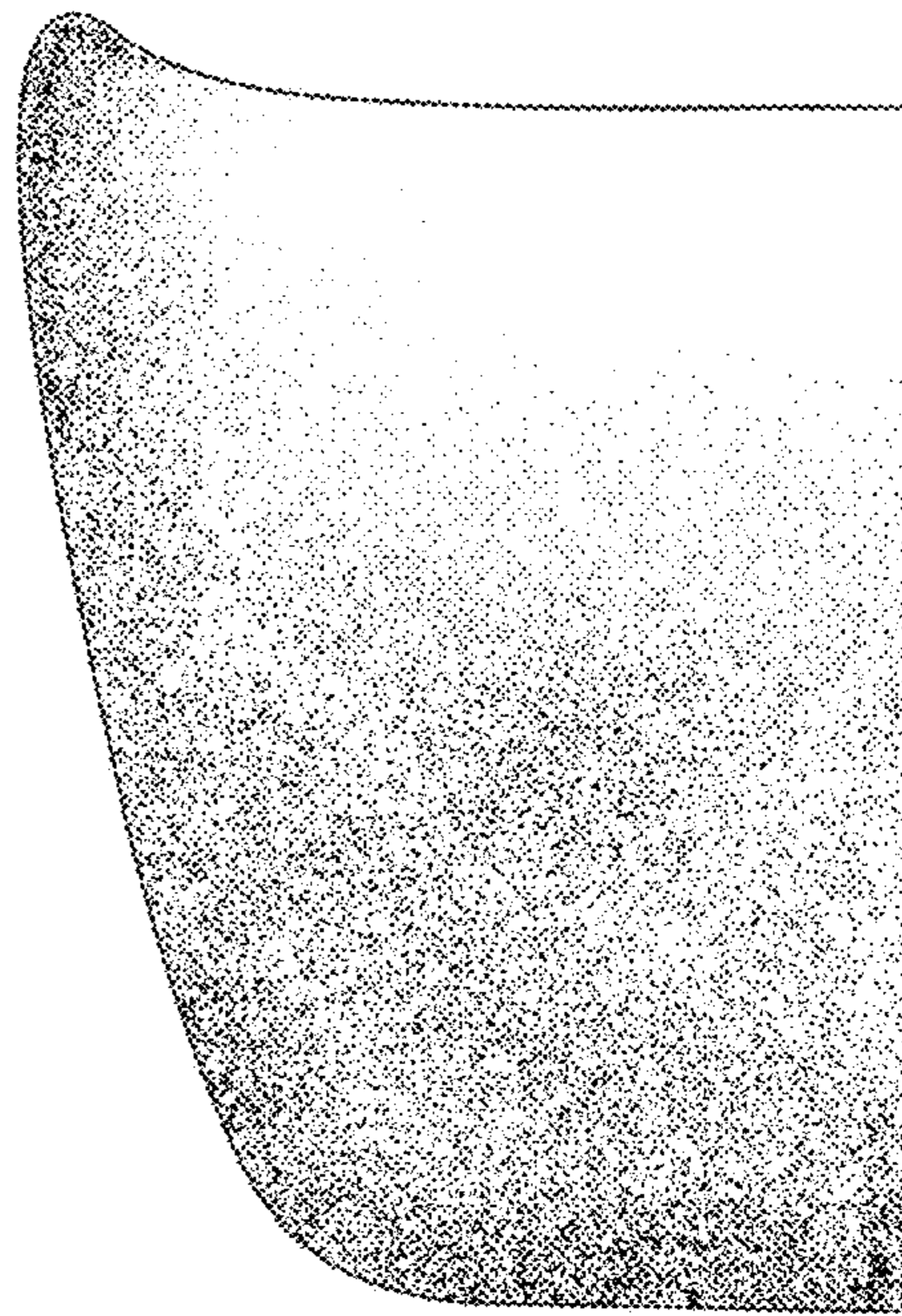

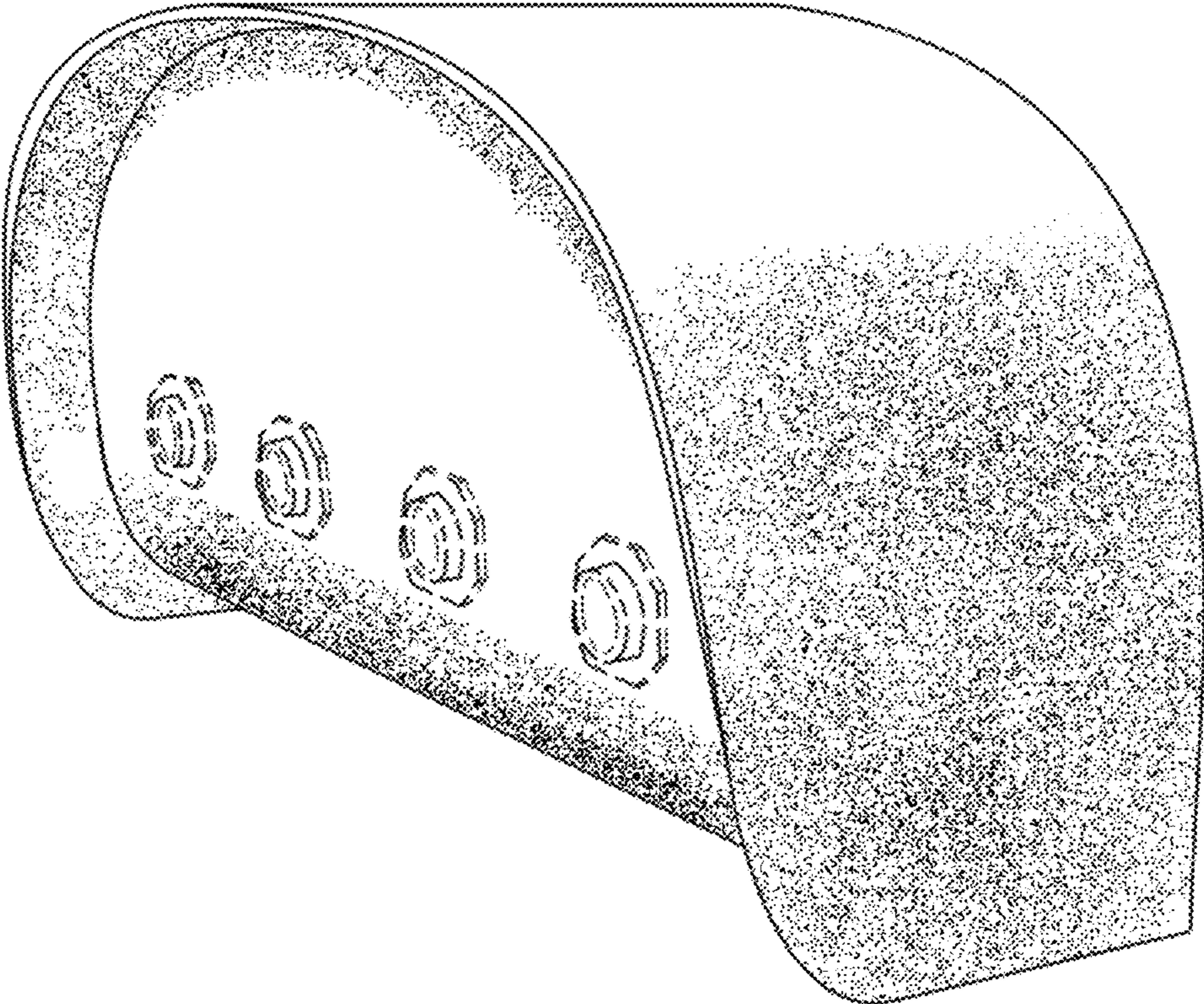

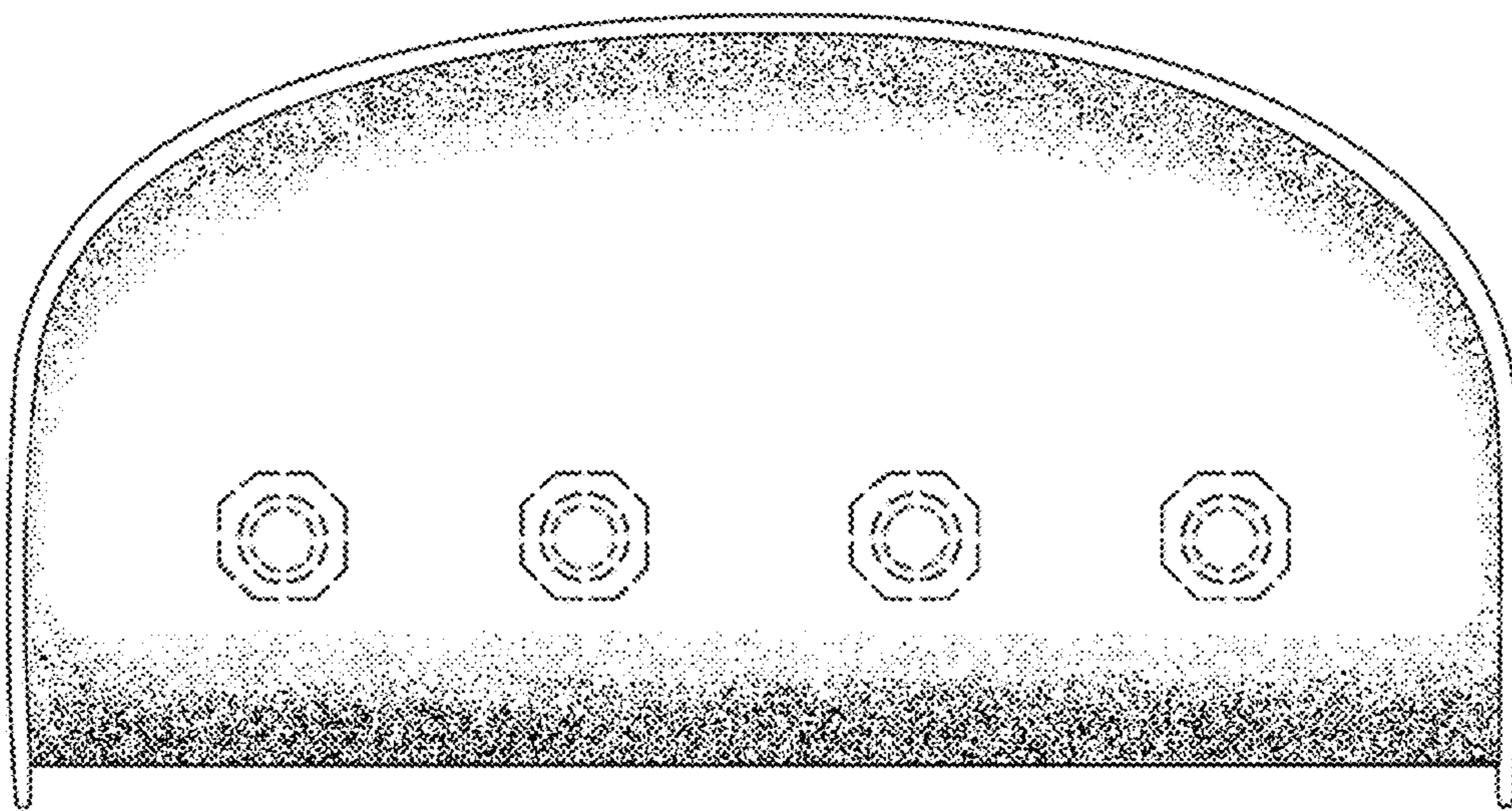

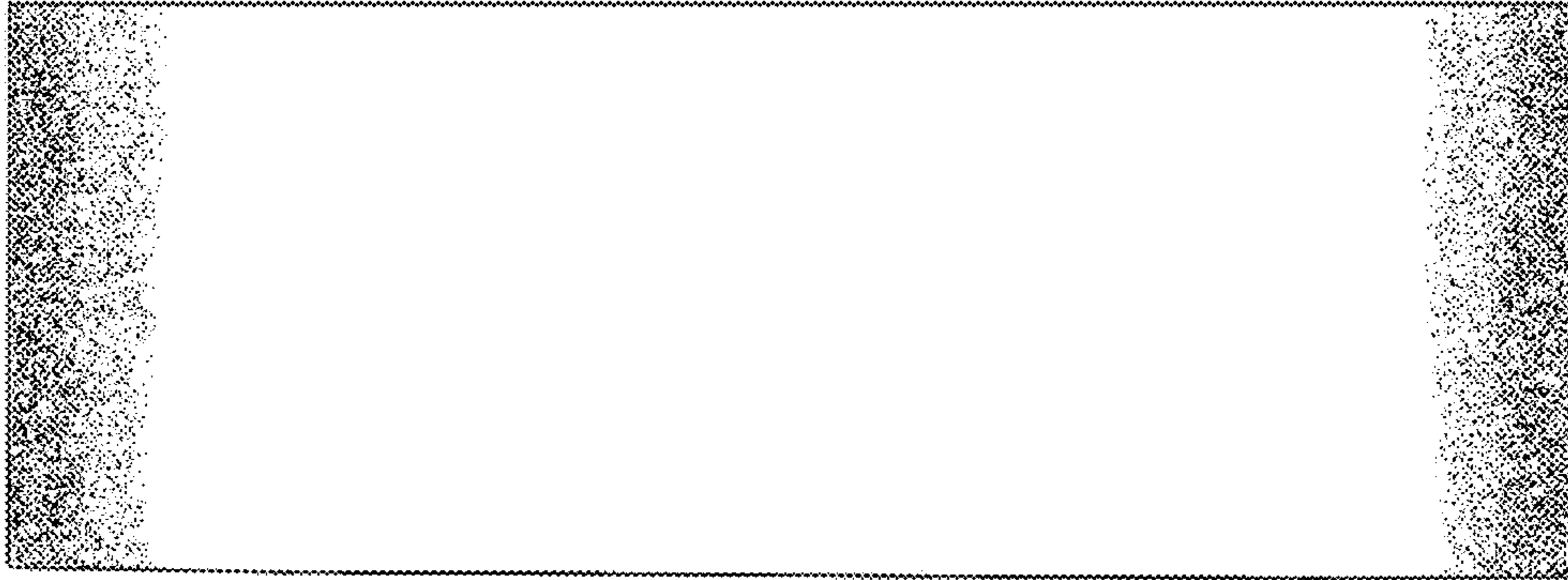

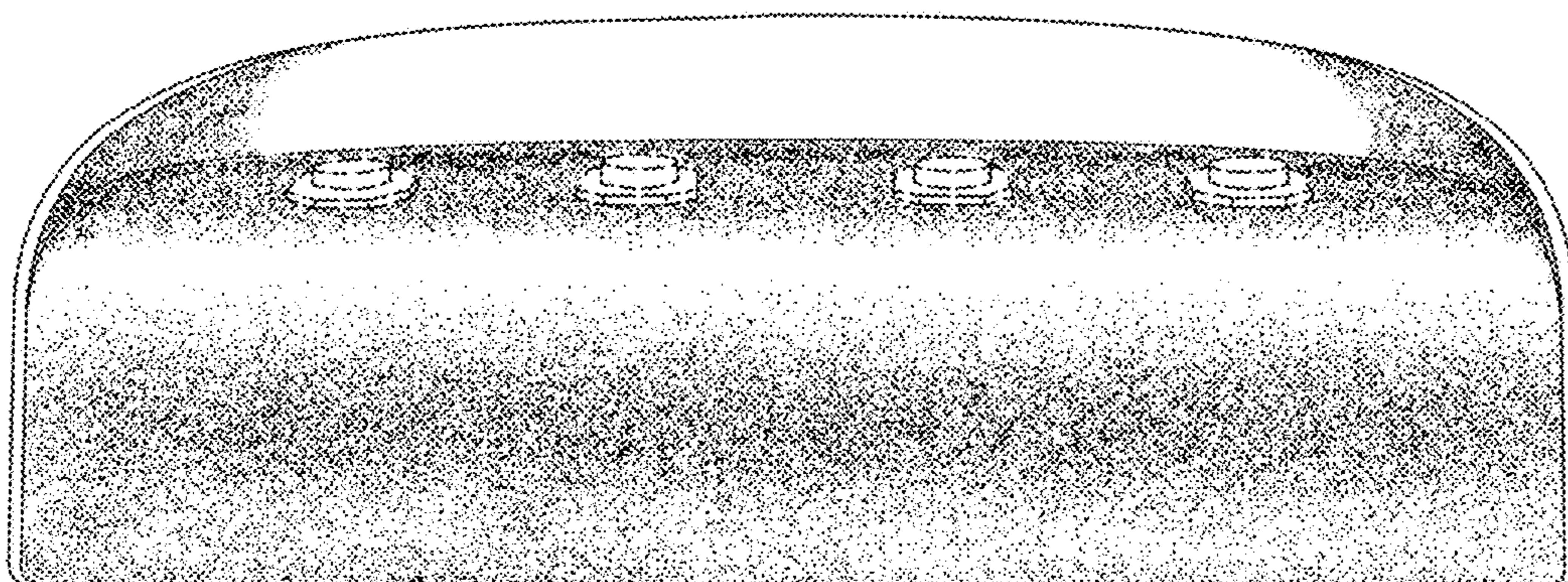

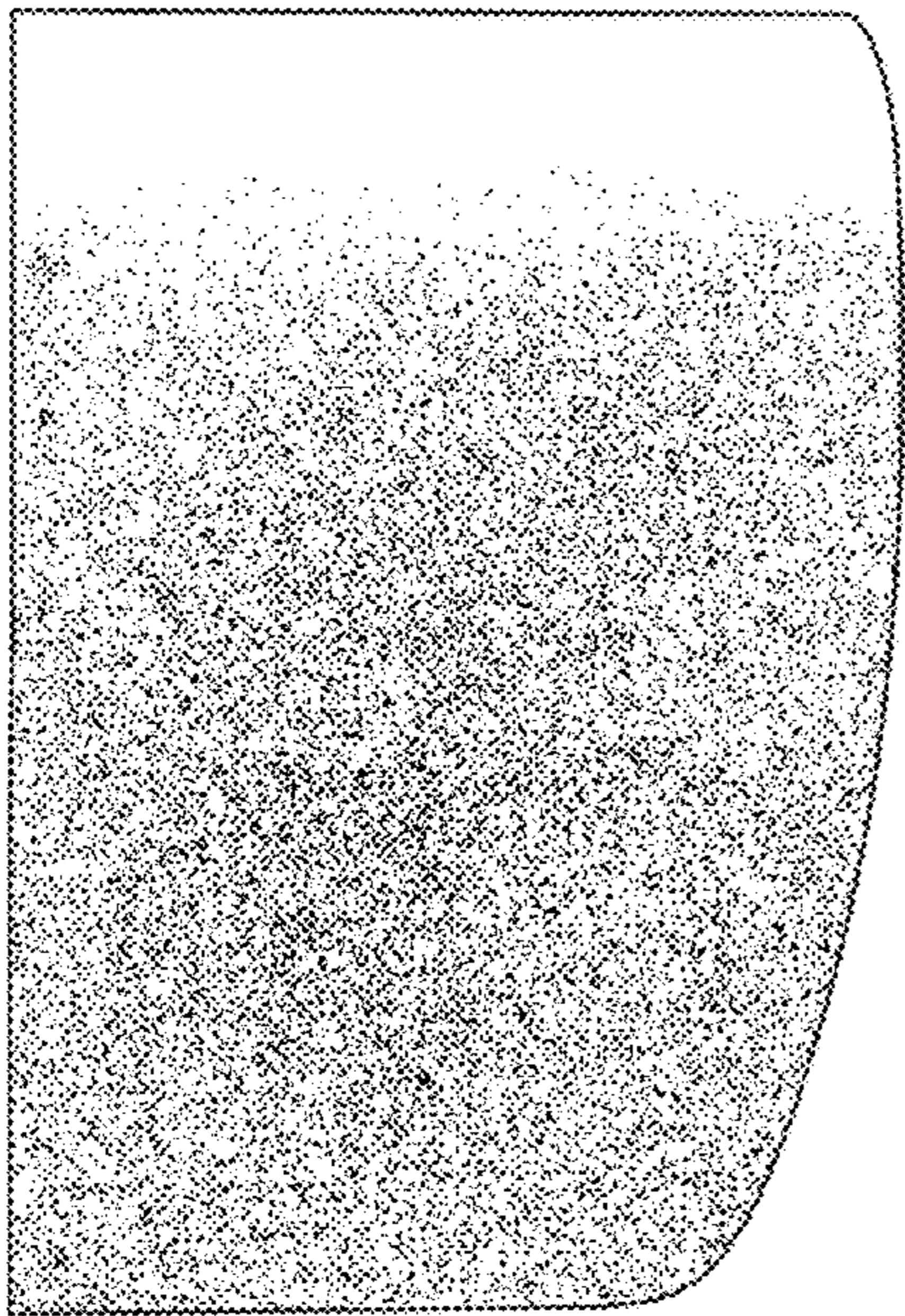

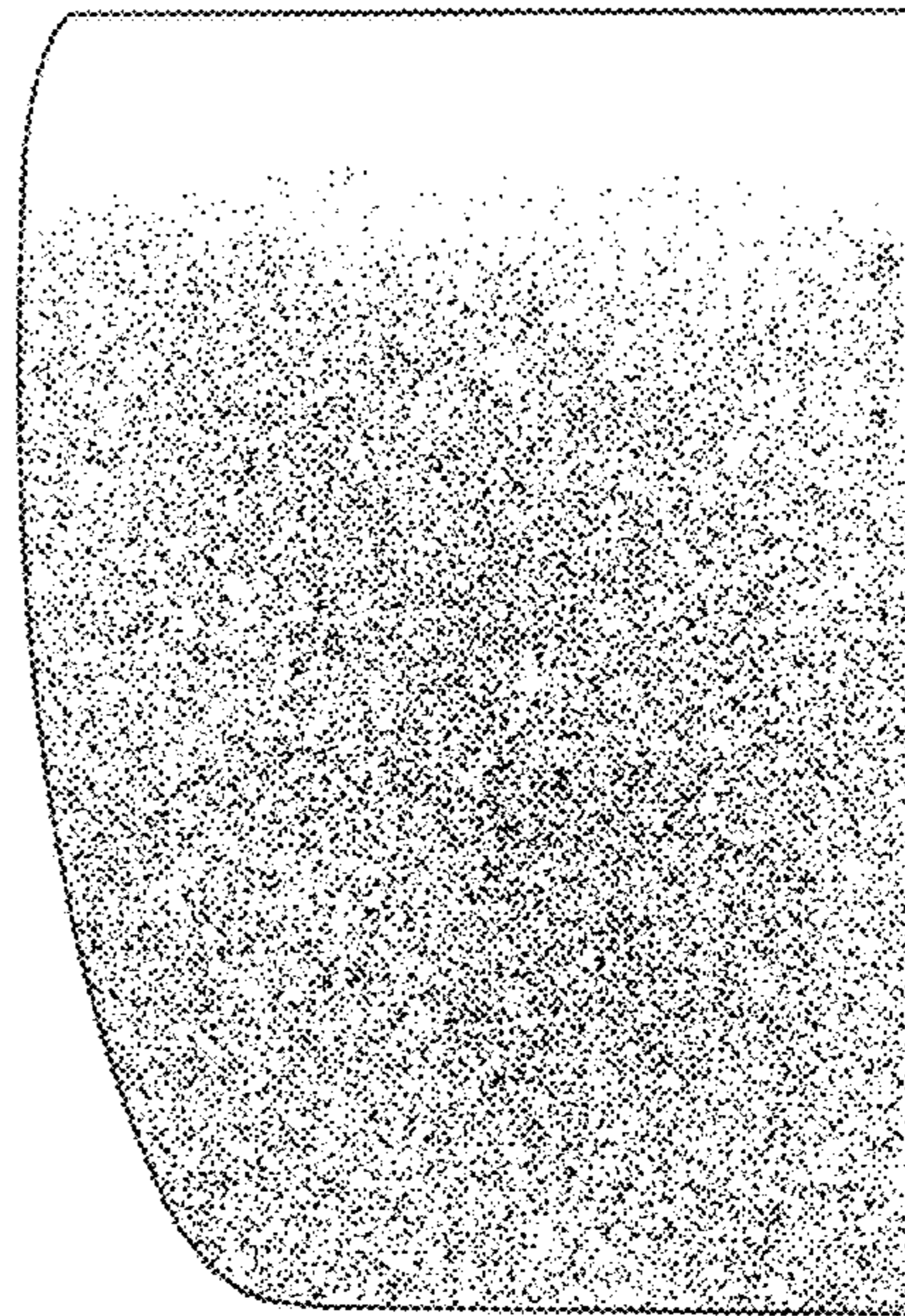
