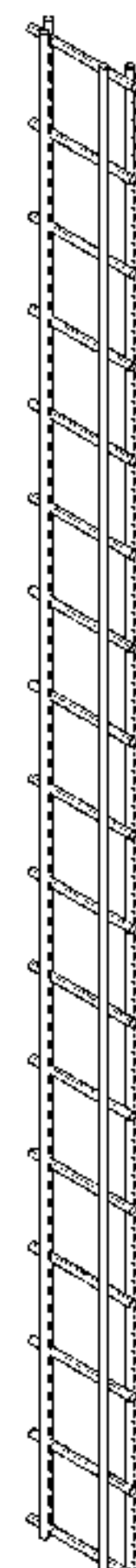

(57) **CLAIM**

We claim the ornamental design for basket display parts, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of basket display parts in accordance with a first embodiment of our new design, illustrating a vertical support or bracket for use with one or more baskets;  
 FIG. 2 is a front elevation view of the basket display parts of FIG. 1;  
 FIG. 3 is a rear elevation view of the basket display parts of FIG. 1;  
 FIG. 4 is a right side elevation view of the basket display parts of FIG. 1, the left side elevation view being a mirror image of the illustrated right side elevation view;  
 FIG. 5 is a top view of the basket display parts of FIG. 1;  
 FIG. 6 is a bottom view of the basket display parts of FIG. 1;  
 FIG. 7 is a perspective view of basket display parts in accordance with a second embodiment of our new design illustrating ends of a vertical support or bracket for use with one or more baskets;  
 FIG. 8 is a front elevation view of the basket display parts of FIG. 7;  
 FIG. 9 is a rear elevation view of the basket display parts of FIG. 7;  
 FIG. 10 is a right side elevation view of the basket display parts of FIG. 7, the left side elevation view being a mirror image of the illustrated right side elevation view;  
 FIG. 11 is a top view of the basket display parts of FIG. 7; and,  
 FIG. 12 is a bottom view of the basket display parts of FIG. 7.

The broken lines are for the purposes of illustrating the environment of the design only and form no part of the claimed design. Similarly, unshaded portions that appear between broken lines or beyond boundary or break lines in the figures form no part of the claimed design and indicate that a specific width, height and/or length forms no part of the claimed design. The break lines shown in FIGS. 7, 8, 9, 10, 11, and 12 are not part of the claimed design and represent that no particular length is claimed.

It will be understood that all lines in the drawings, including broken and solid lines, are intended to convey the full disclosure and variations of the designs and such variations shall be understood to be fully described herein.



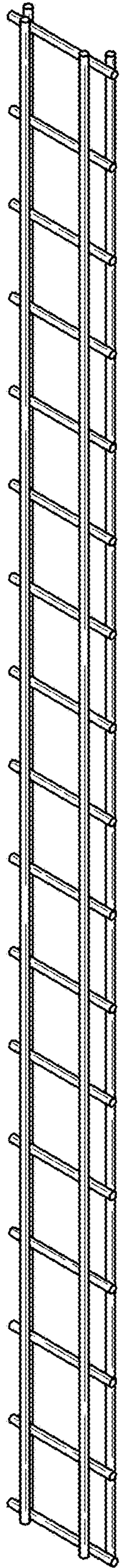

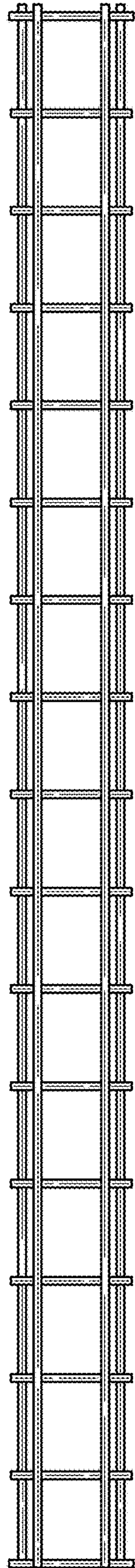

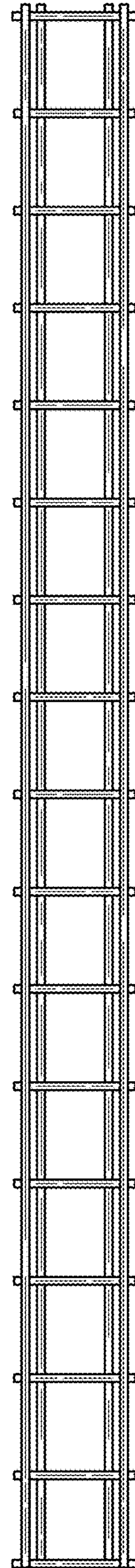

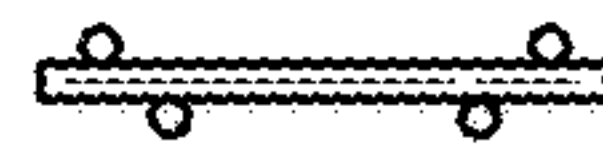
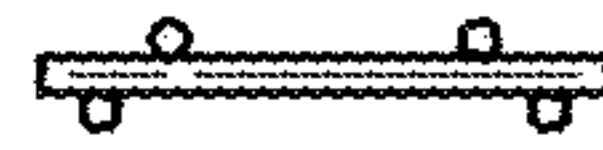

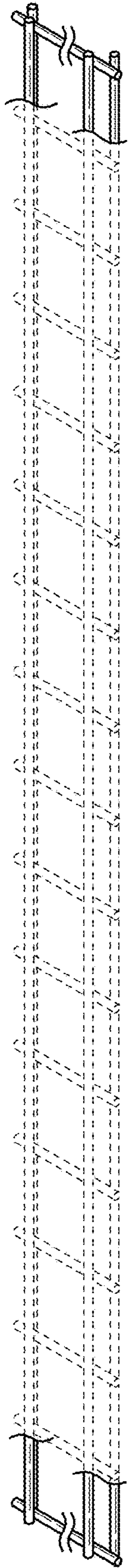

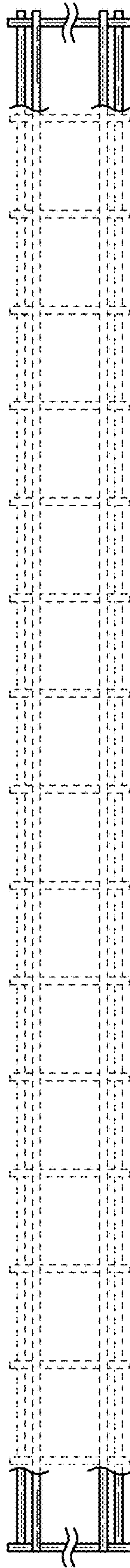

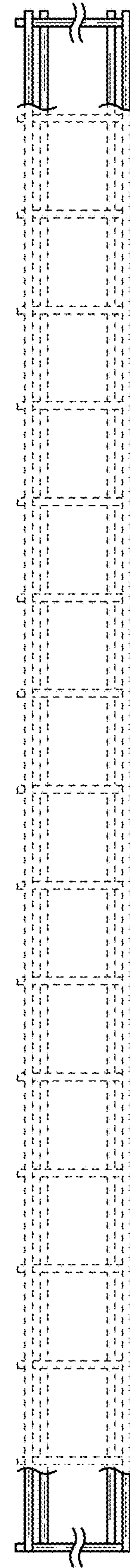

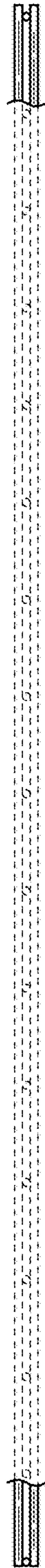

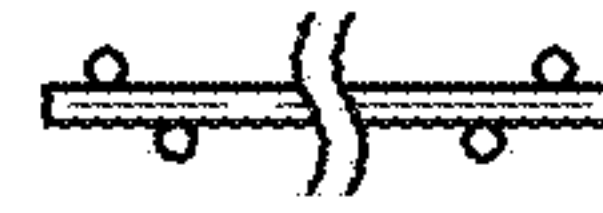
