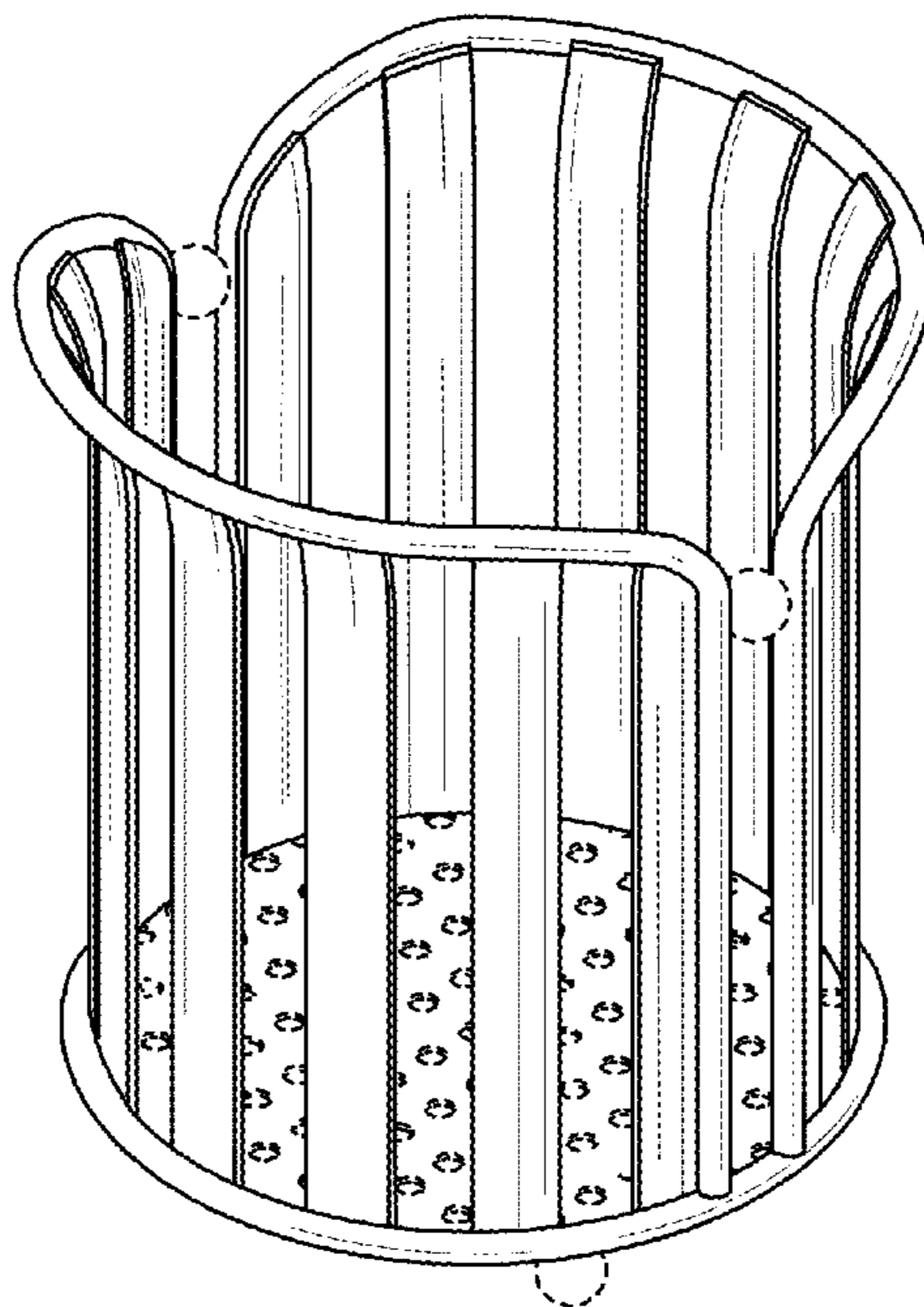
The ornamental design for a utensil holder, as shown and

DESCRIPTION

FIG. 1 is a top, front, right perspective view of a utensil
holder showing our new design;
FIG. 2 is a front elevation view thereof;

FIG. 5 is a right side elevation view thereof;

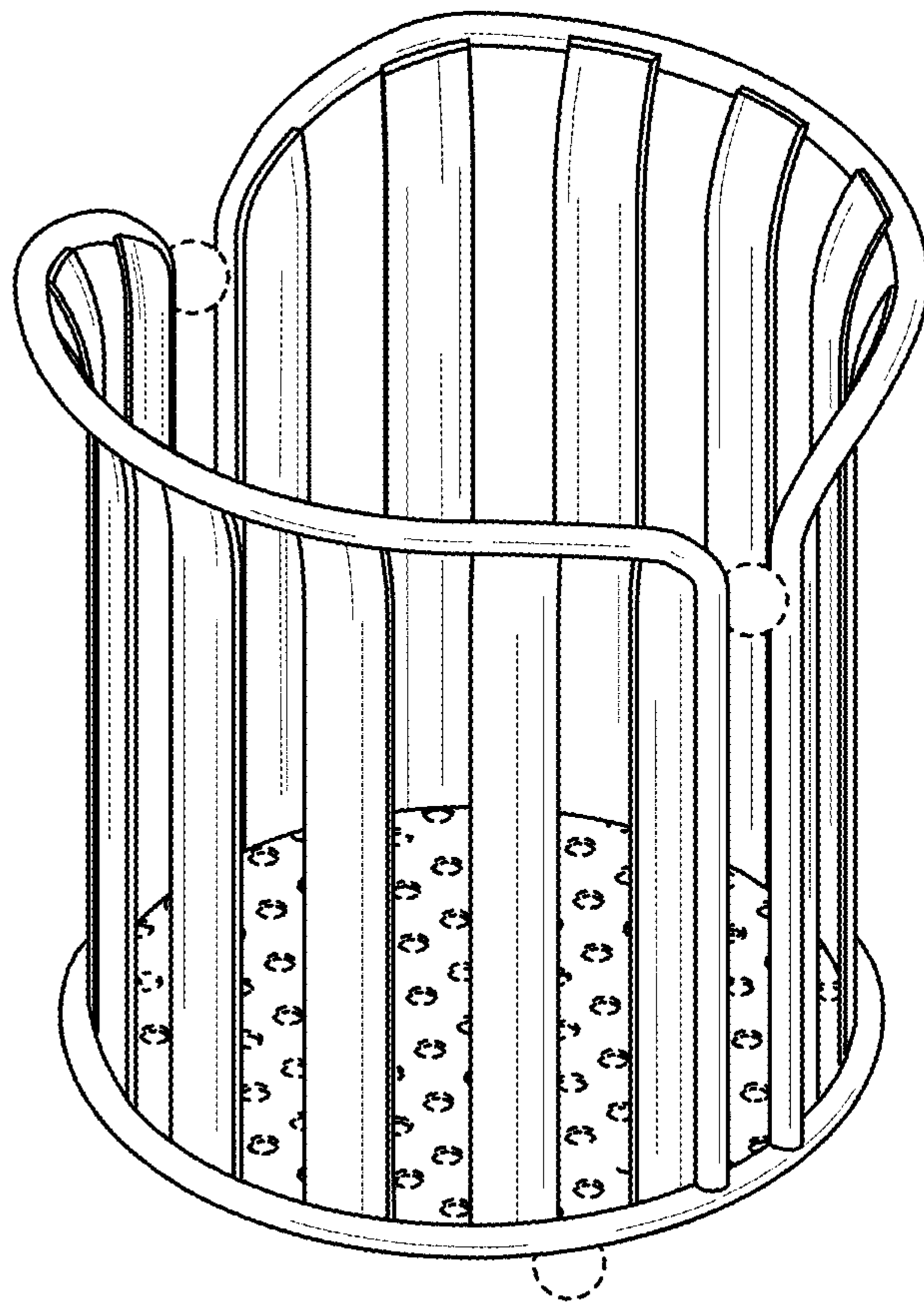

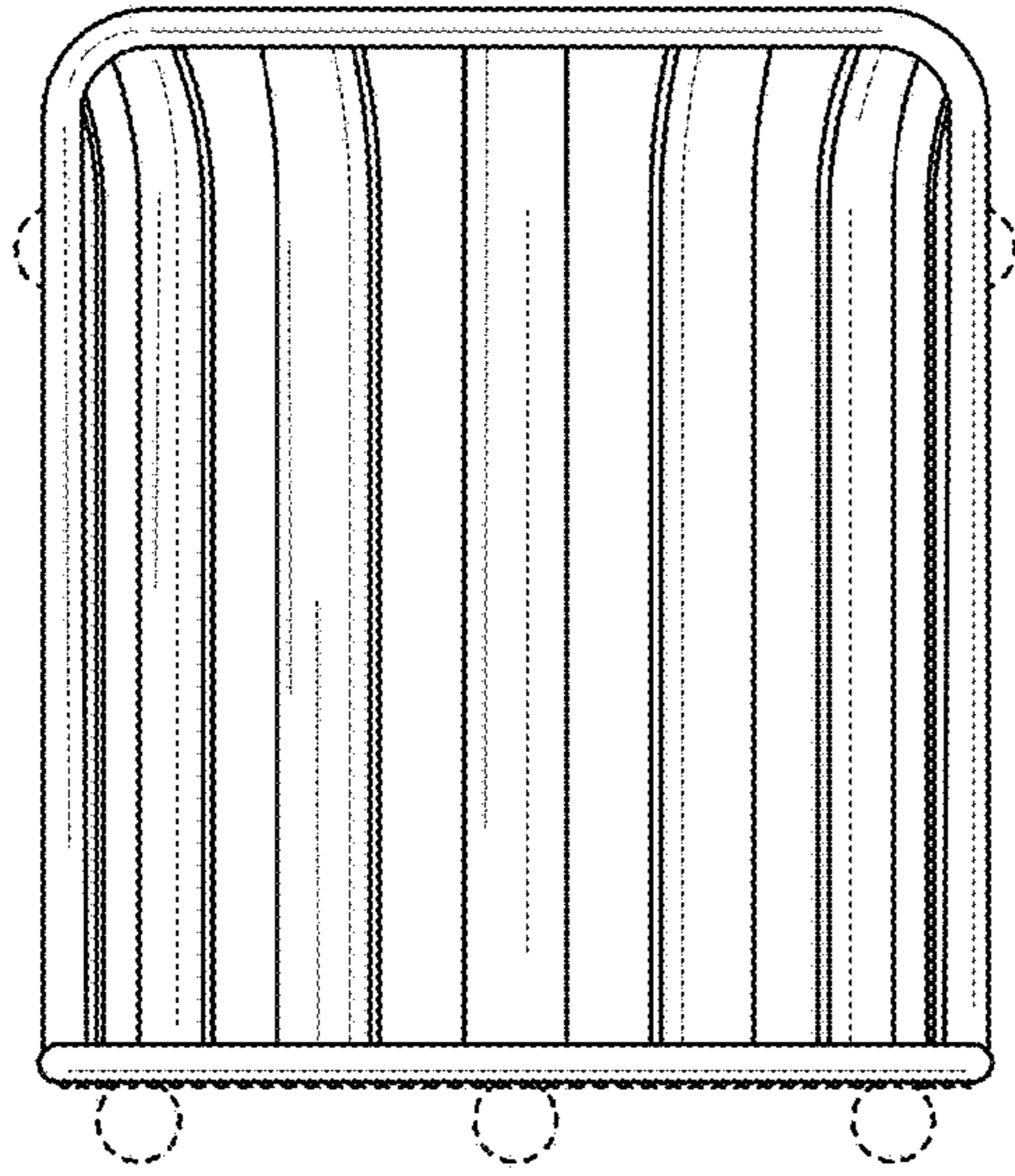

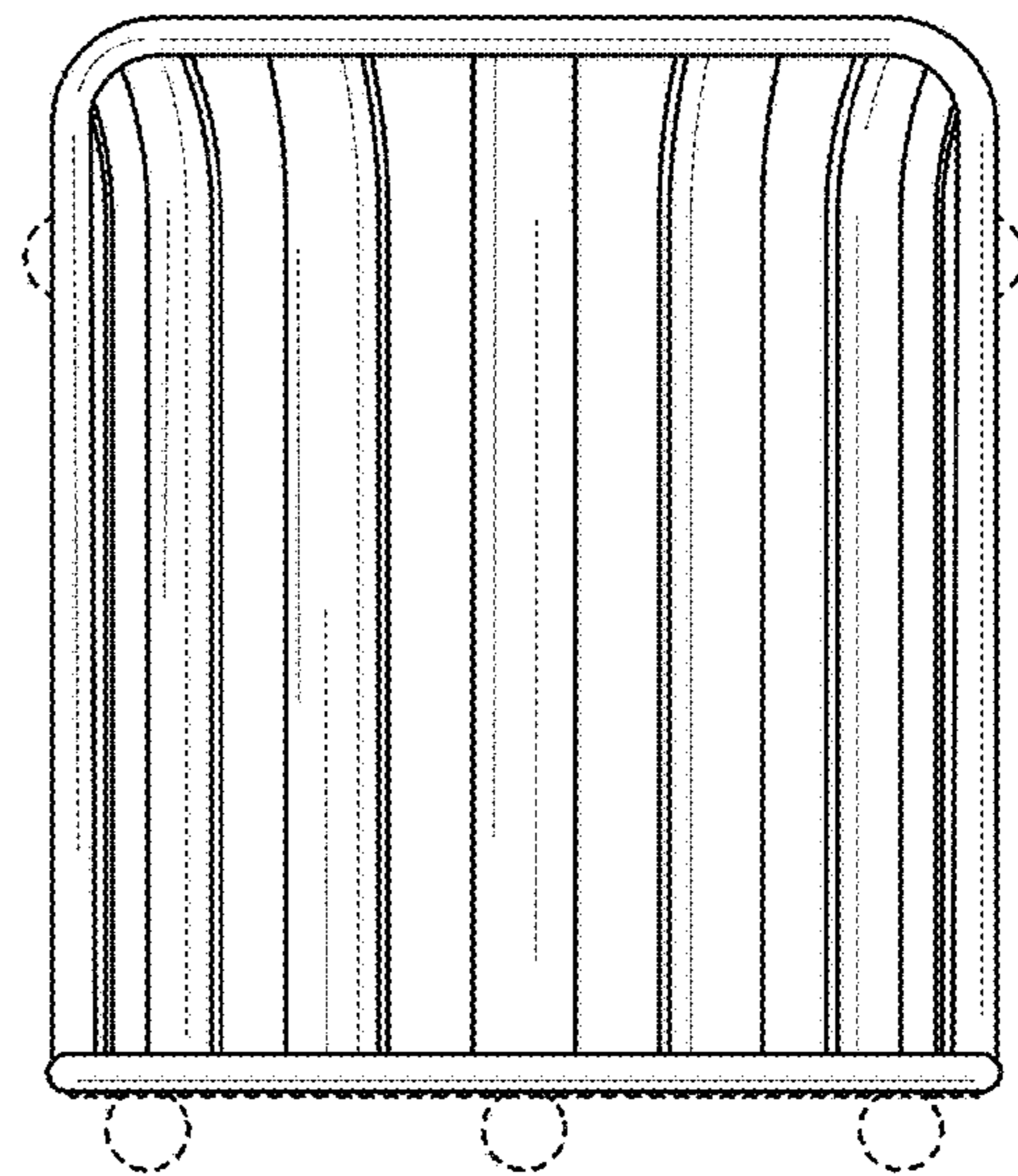

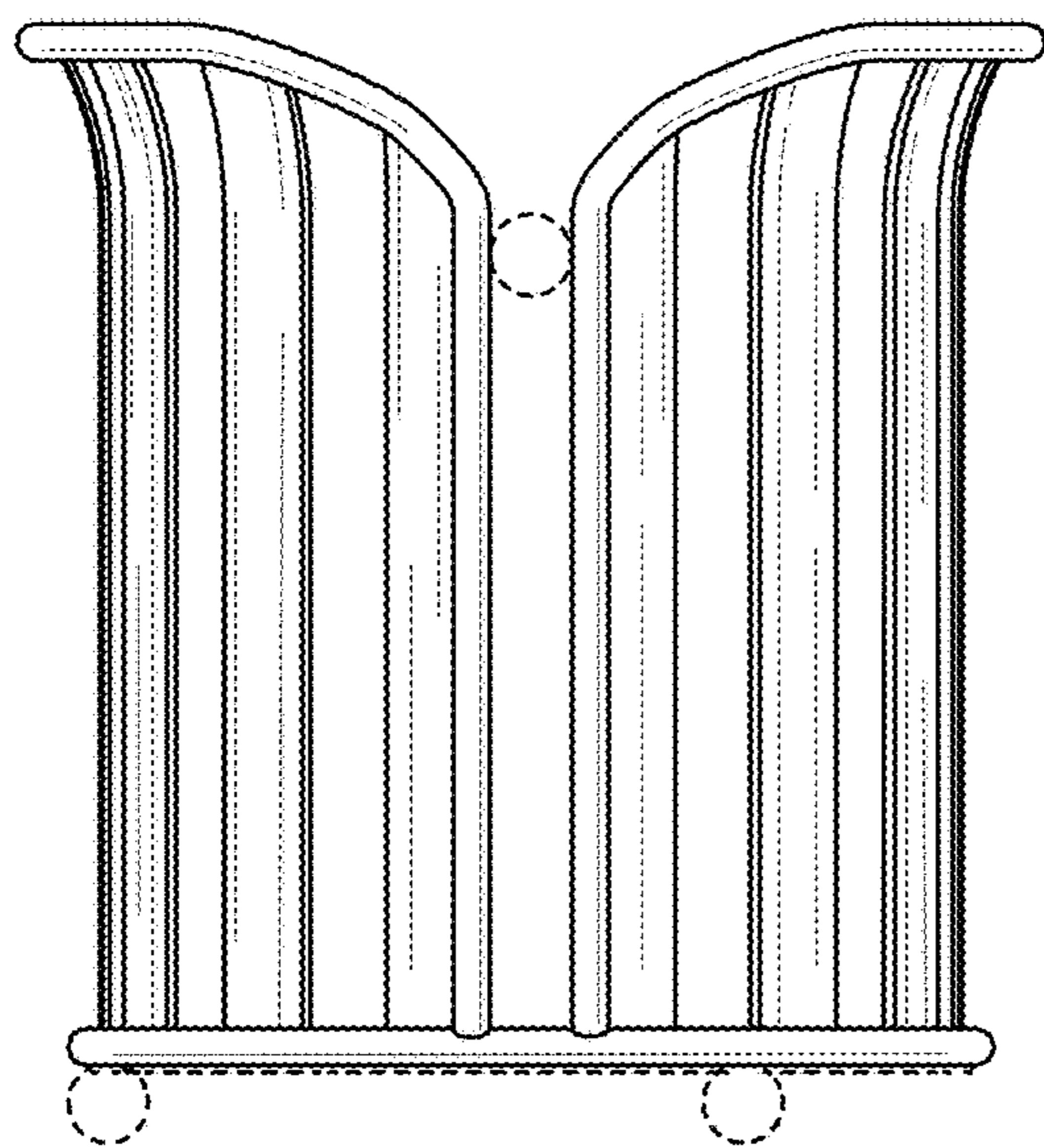

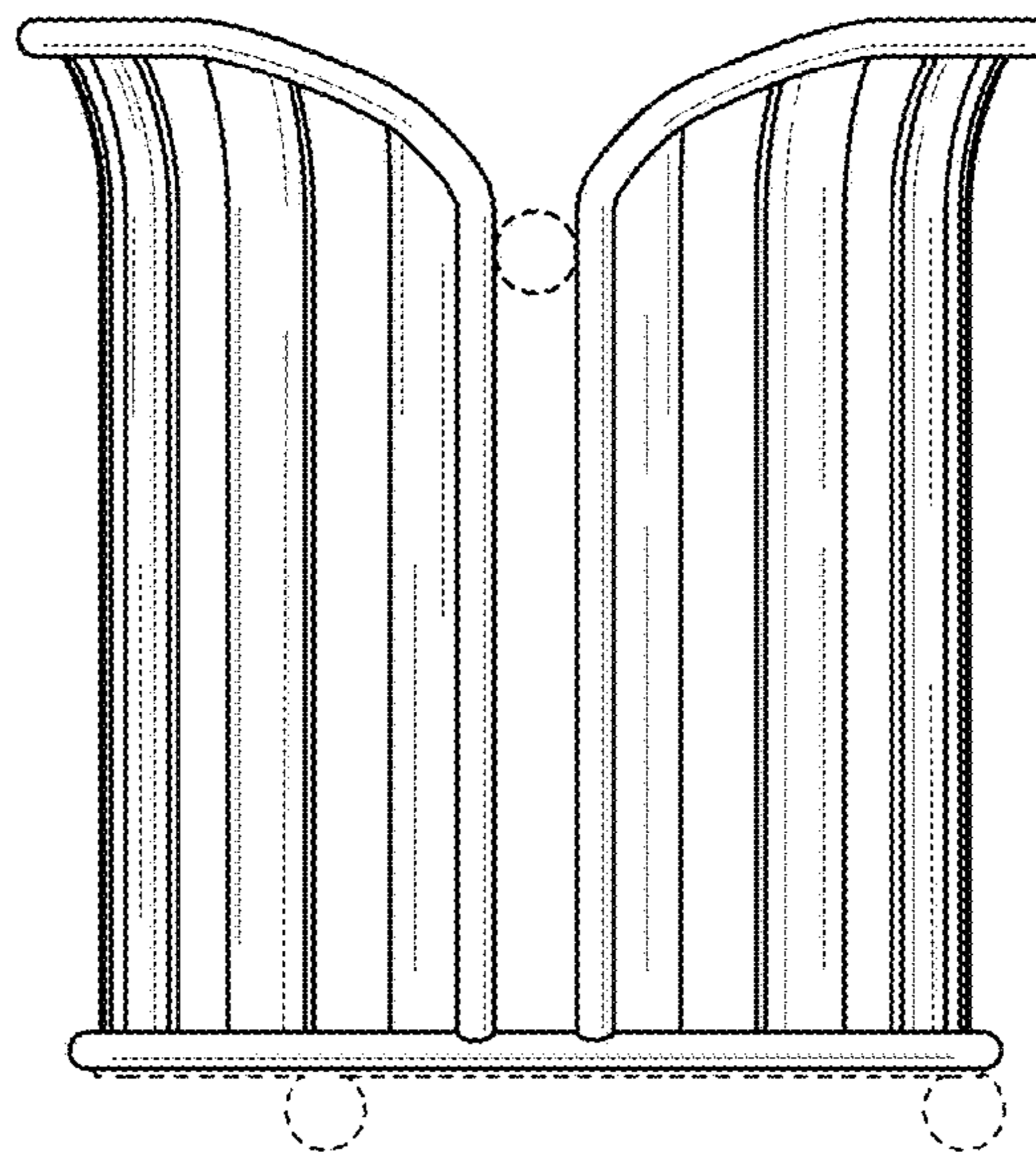

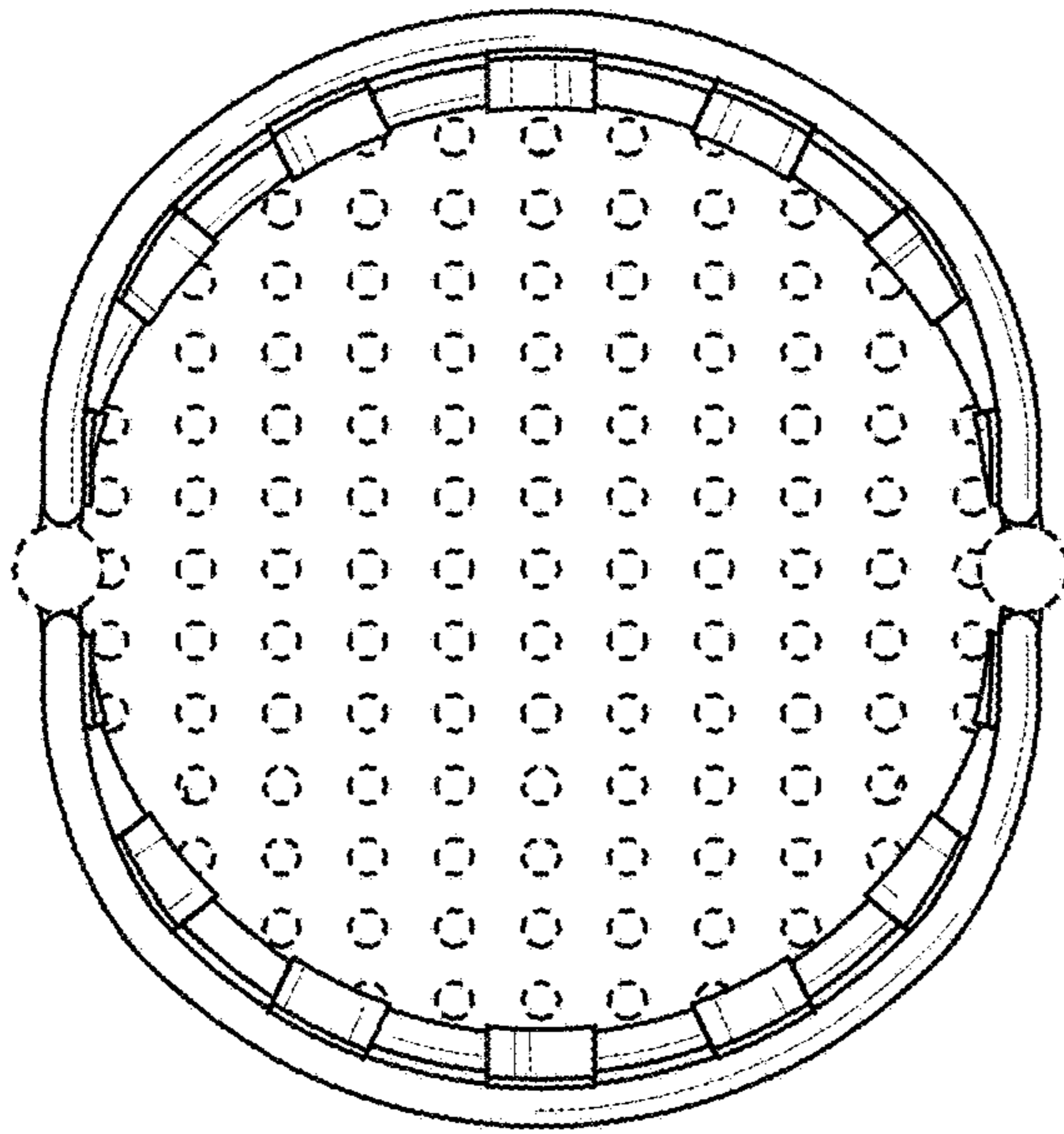

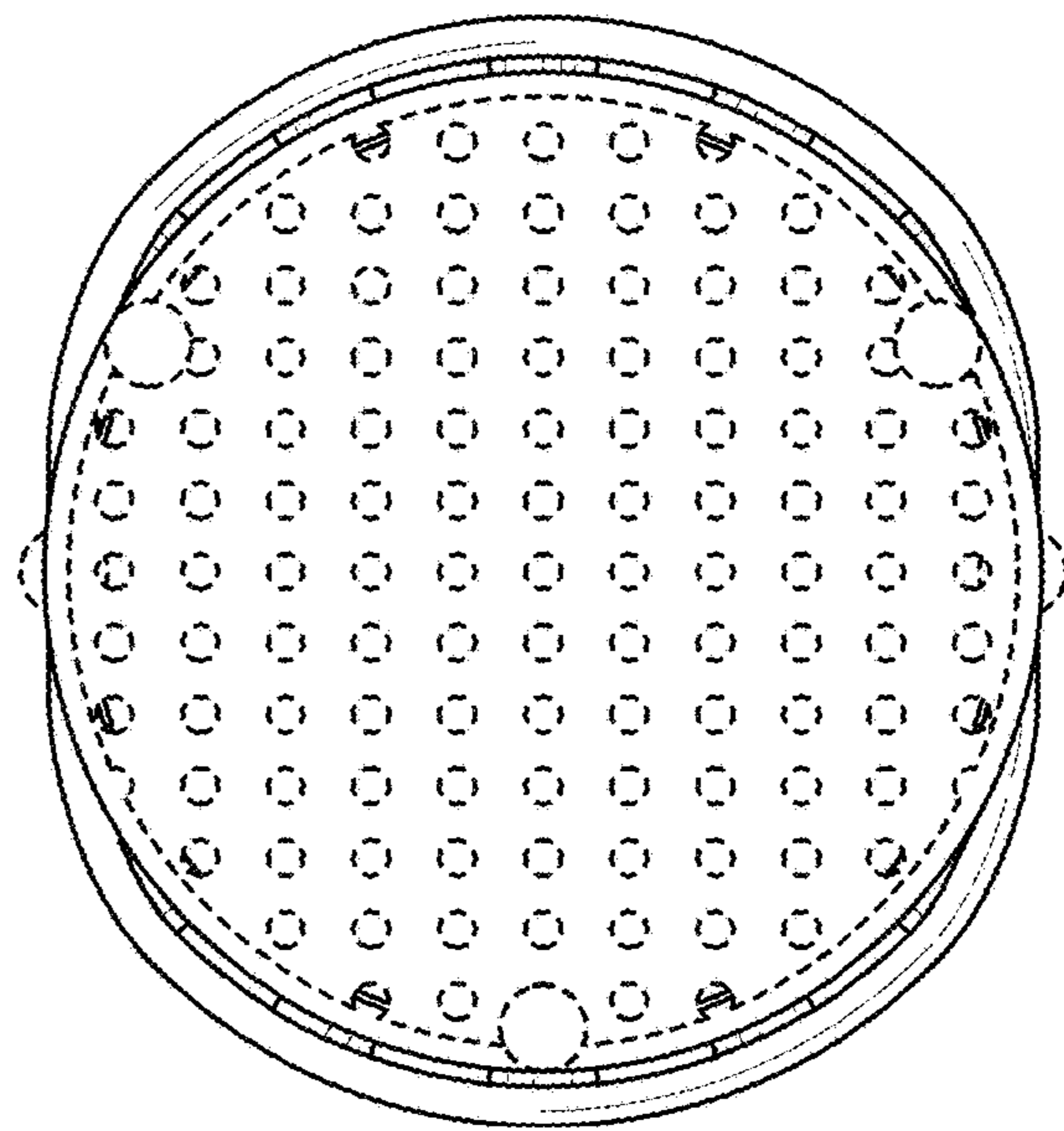
