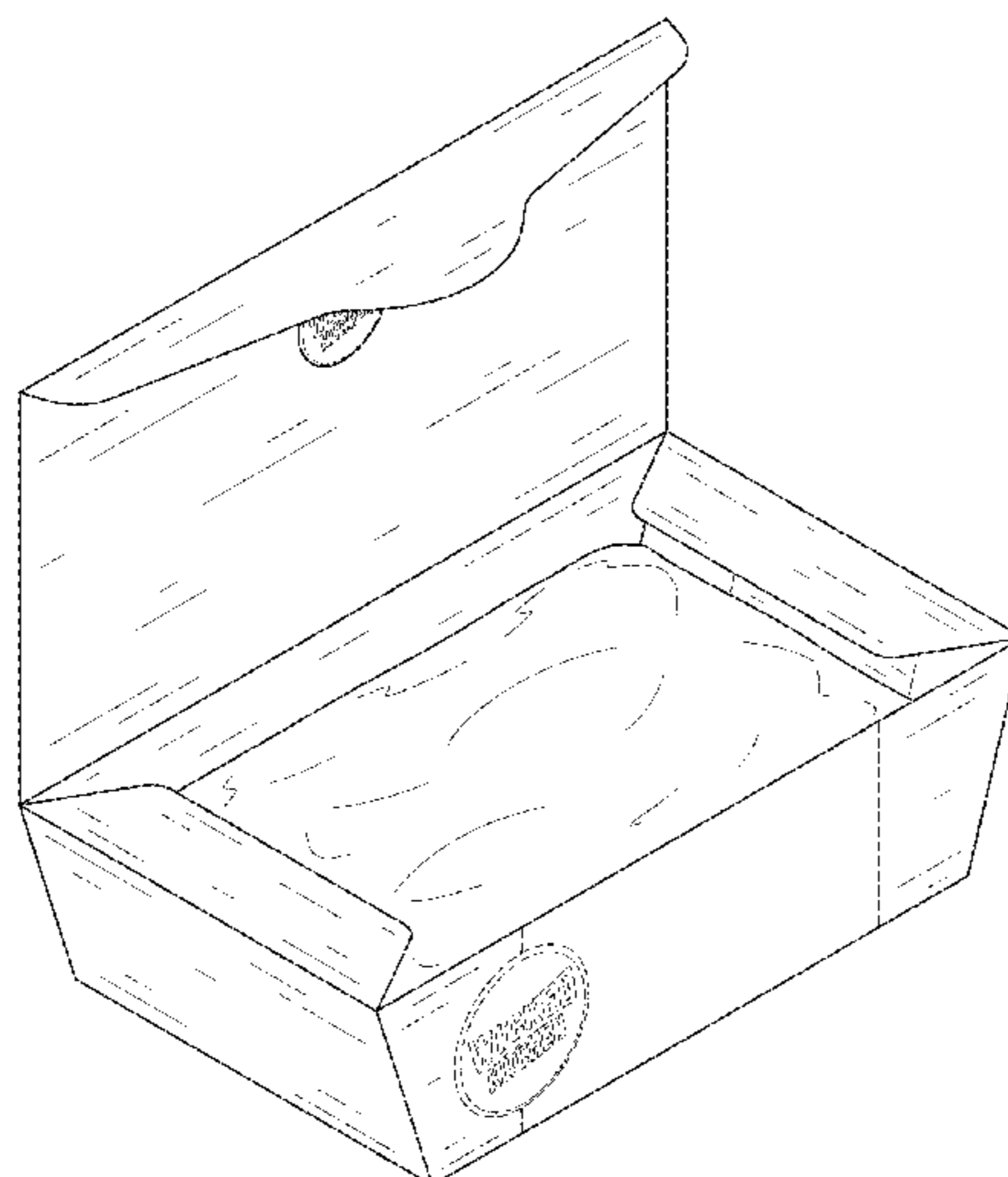

FIG. 7 is an isometric view of the food package with bag of FIG. 1.

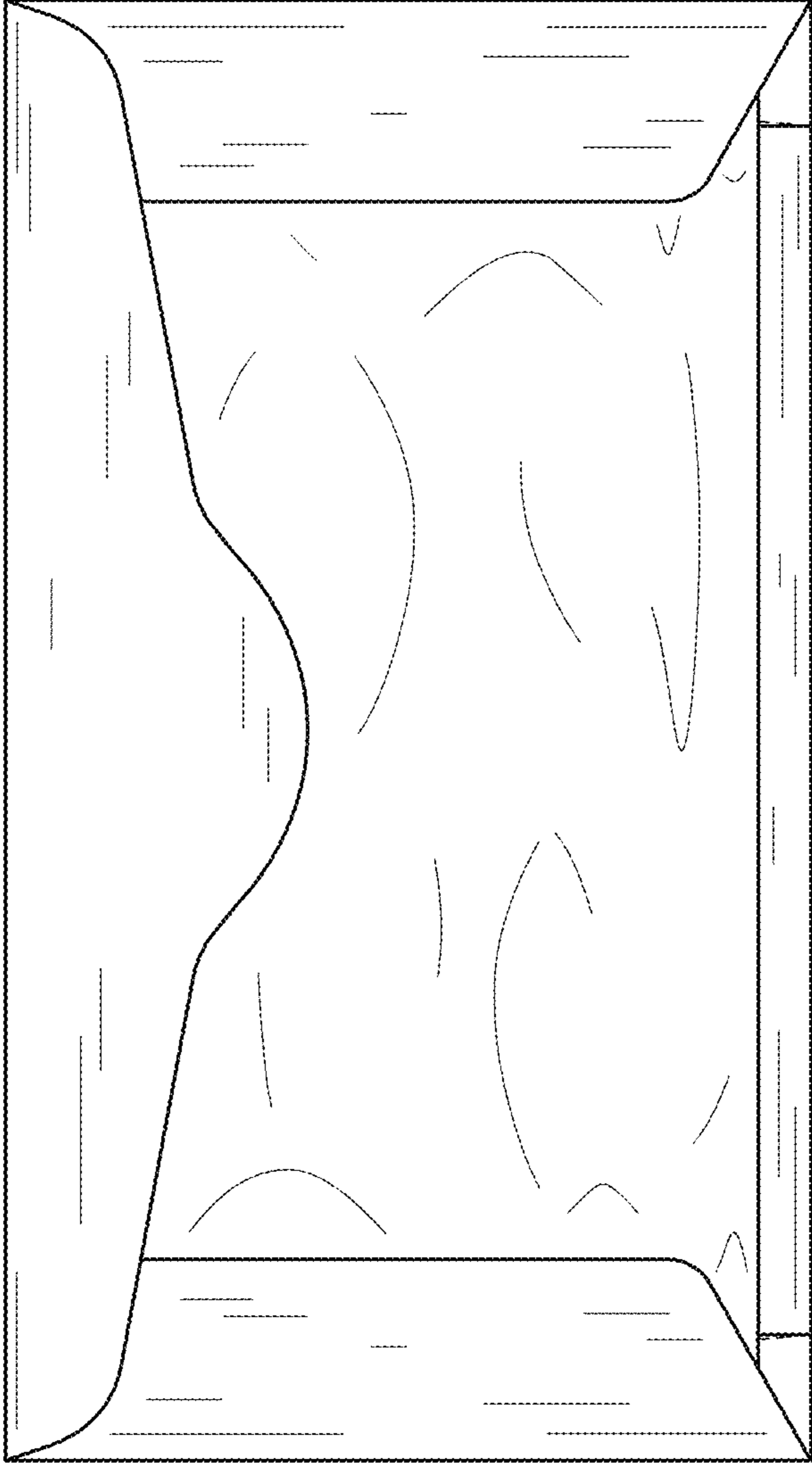

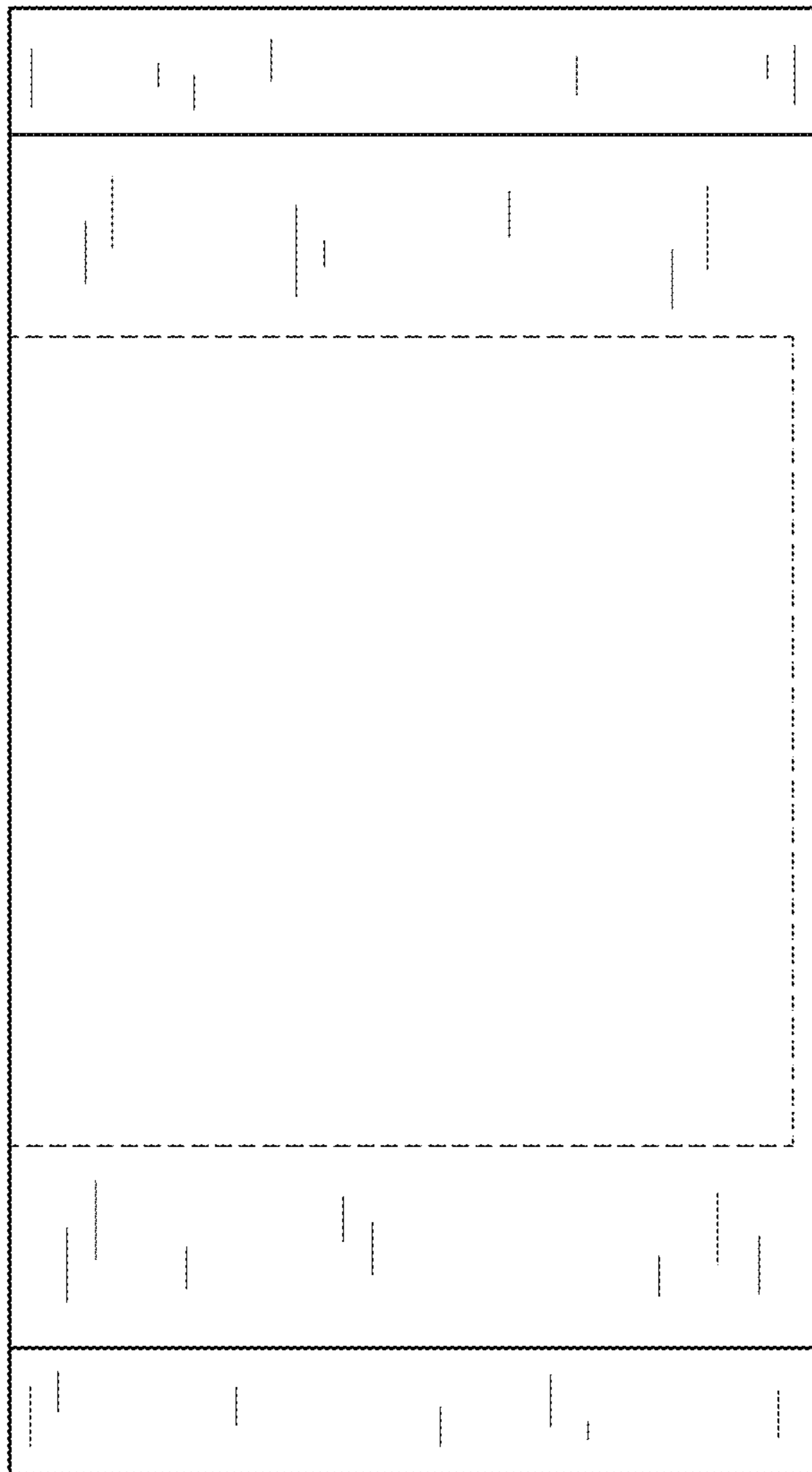
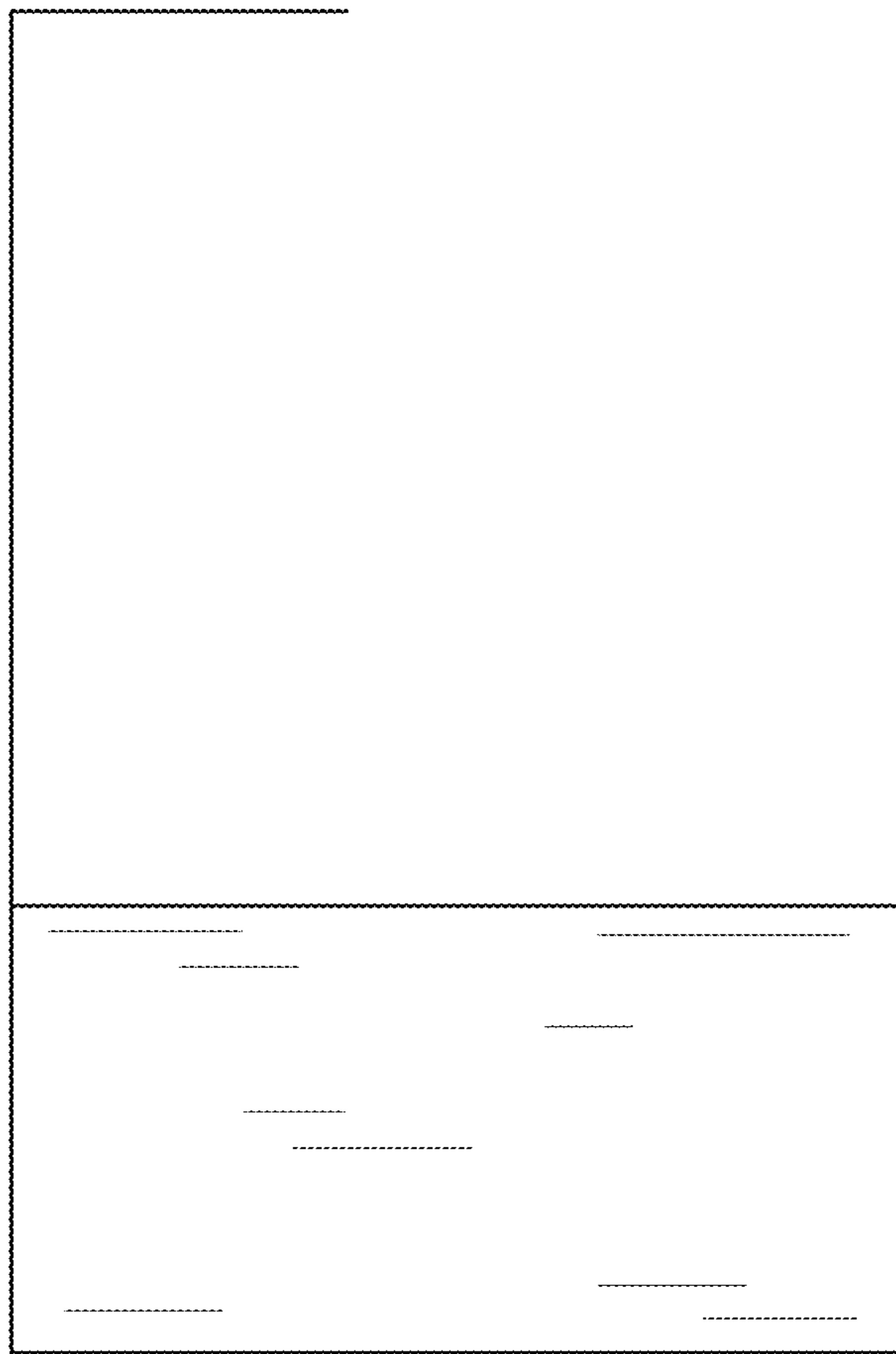

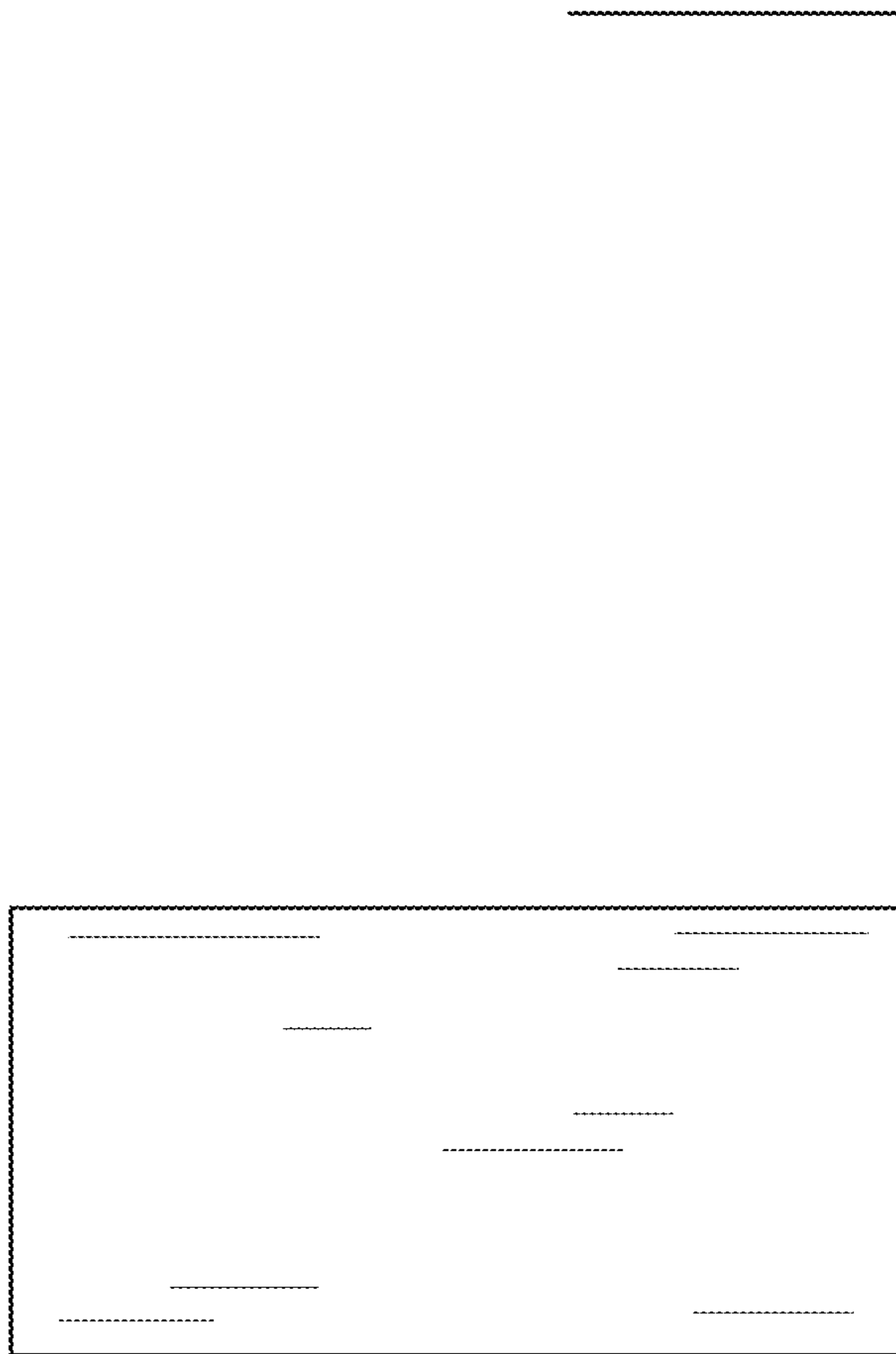

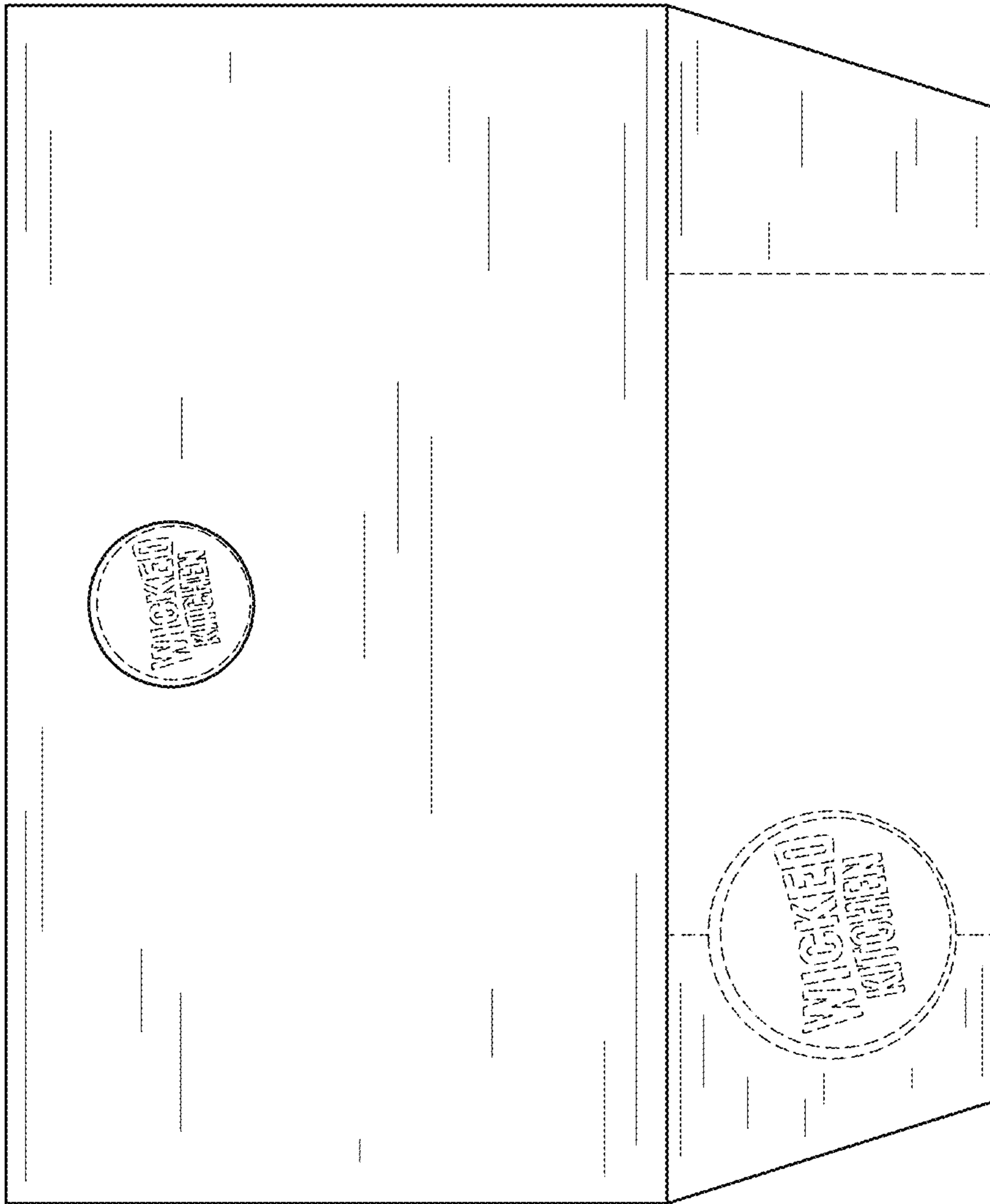

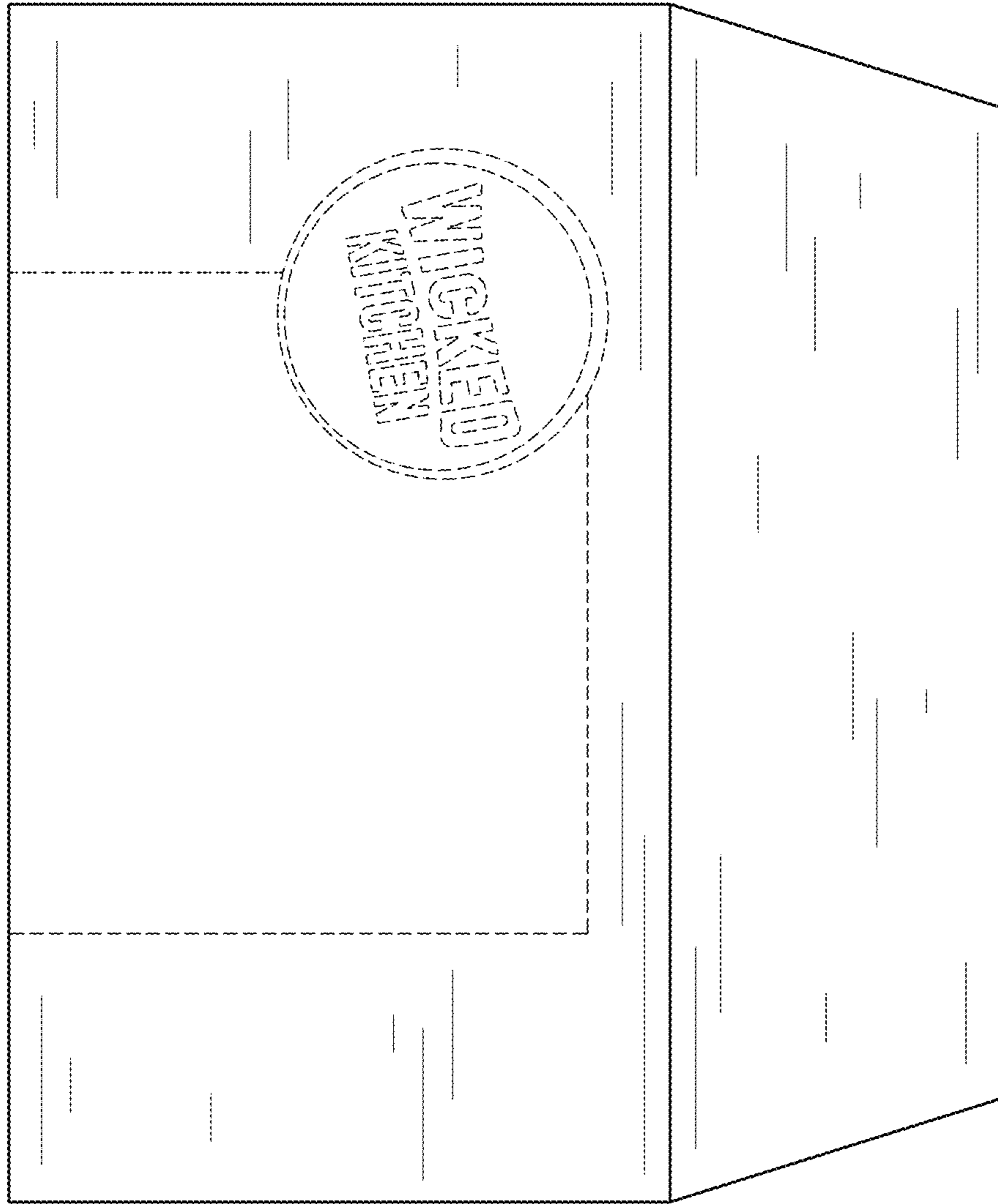
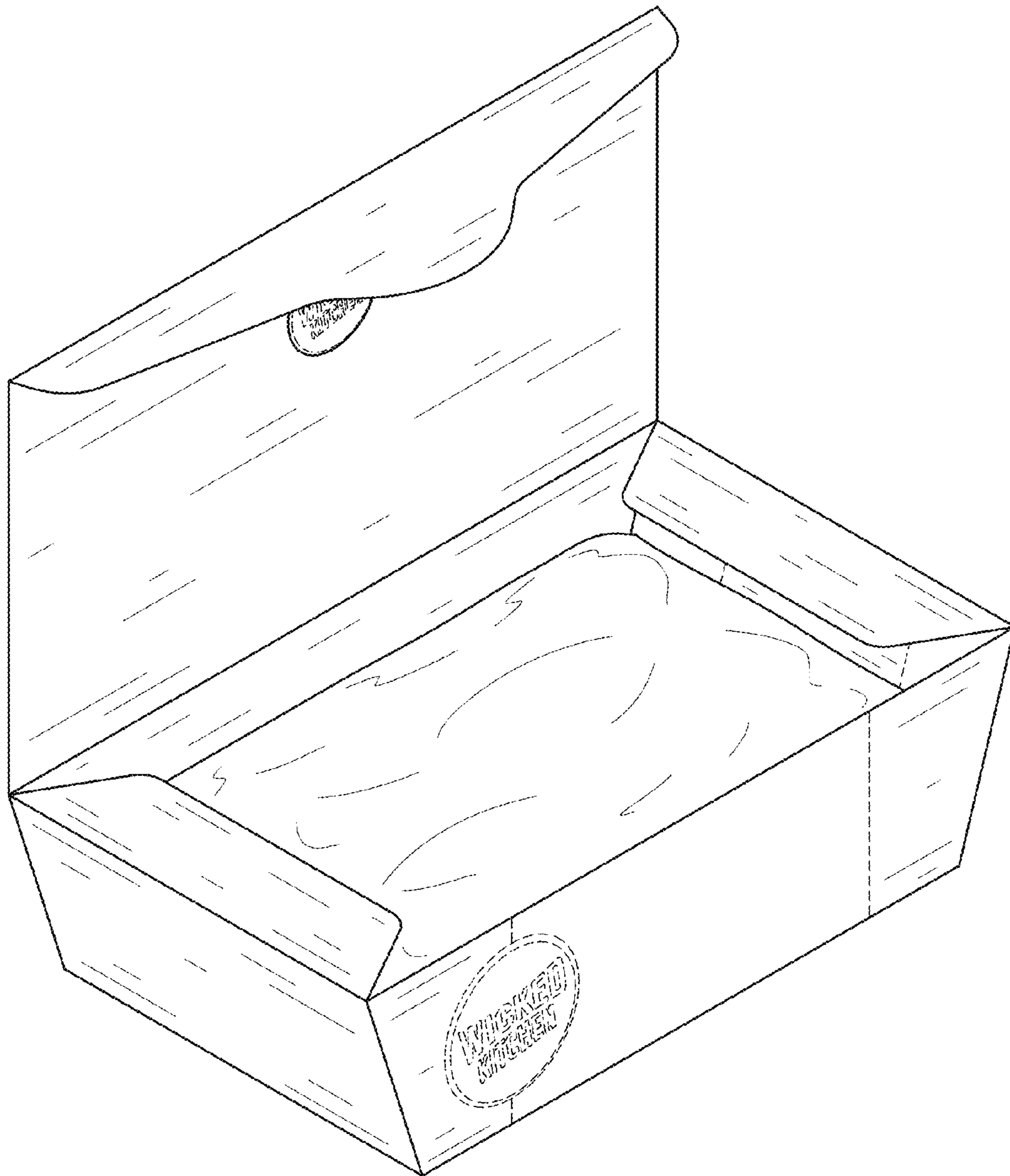
