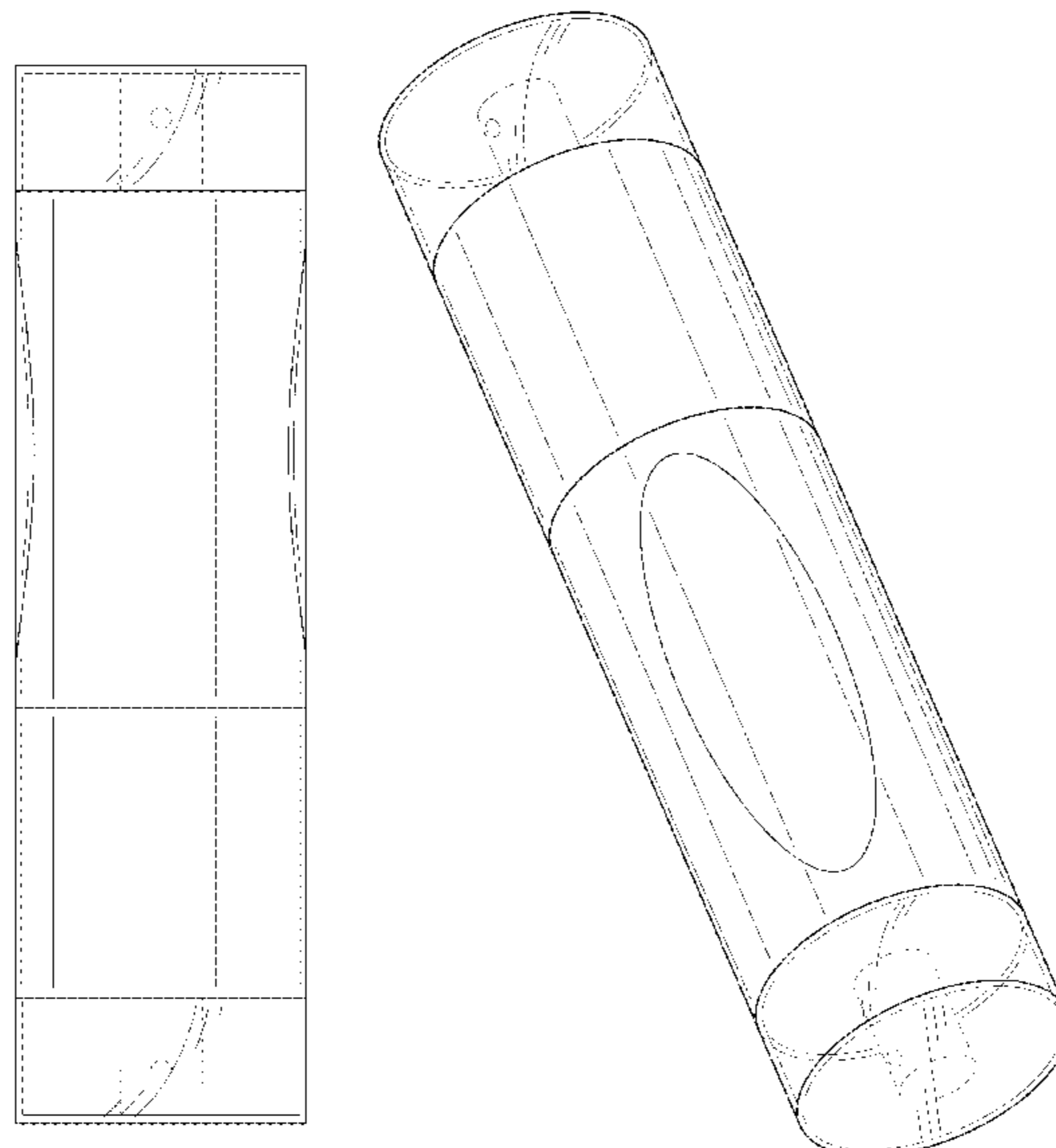

The ornamental design for a dual-dispensing container, as shown and described herein.

**DESCRIPTION**

FIG. 1 is a front elevational view of the dual dispensing container showing our new design;  
FIG. 2 is a left side elevational view thereof;  
FIG. 3 is a right side elevational view thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is a top front perspective view thereof; and,  
FIG. 7 is a bottom front and side perspective view thereof.  
The broken lines are included for the purpose of illustrating a portion of the dual dispensing container that forms no part of the claimed design.

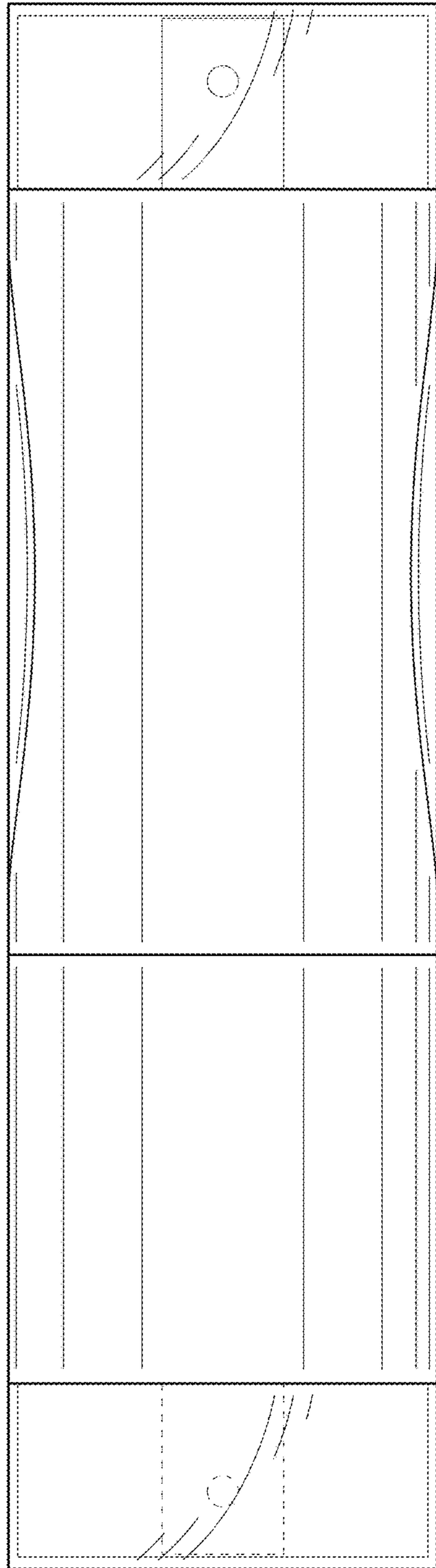

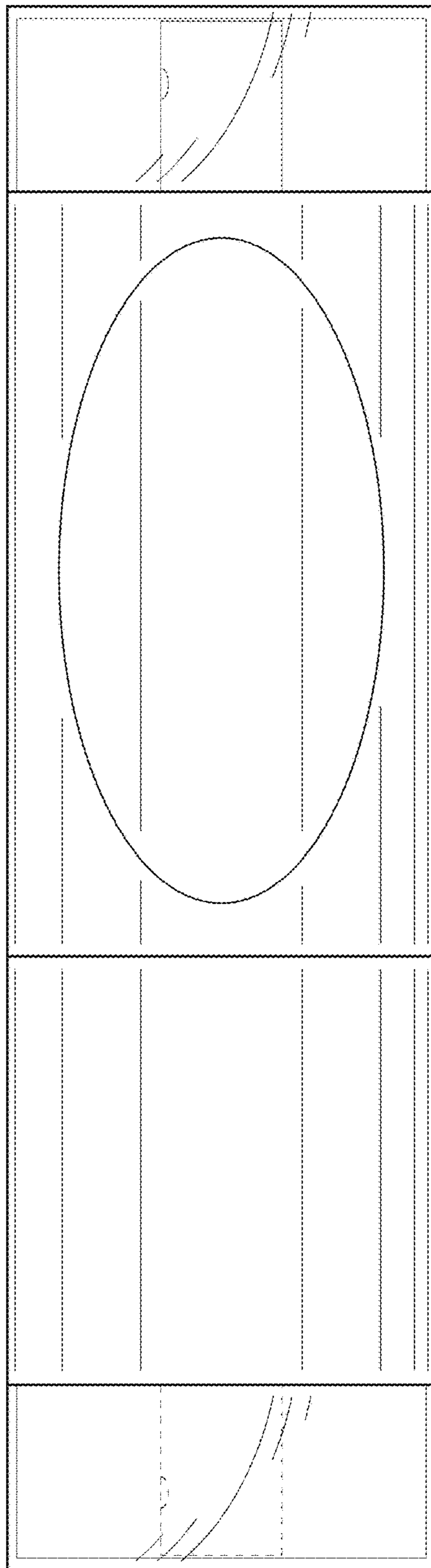

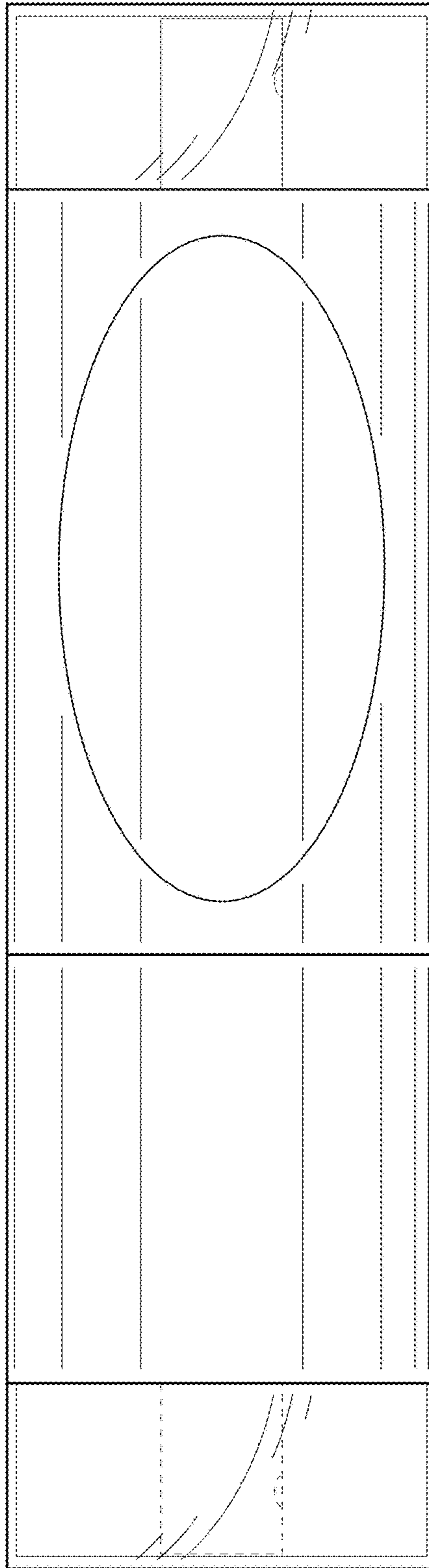

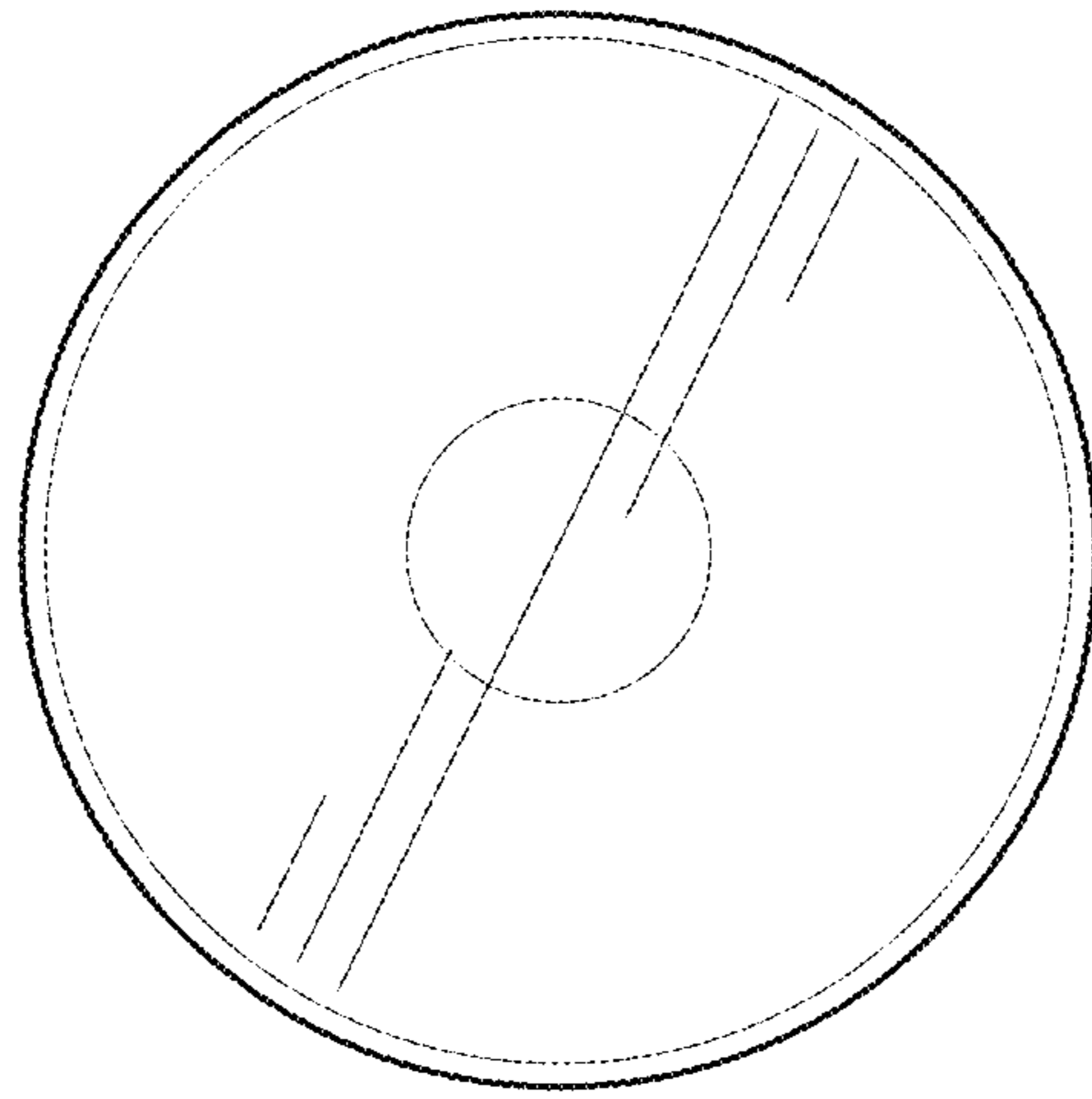

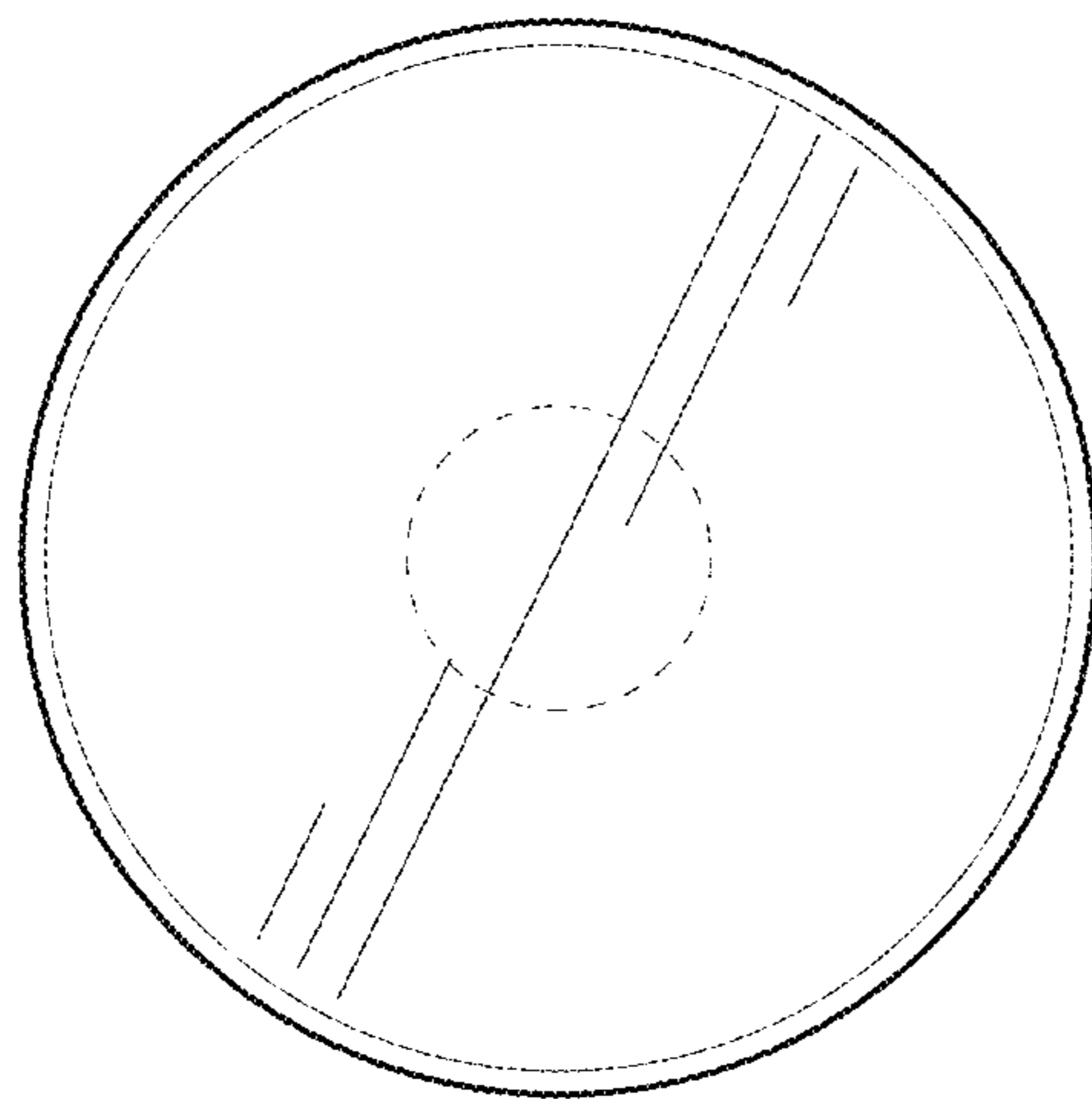

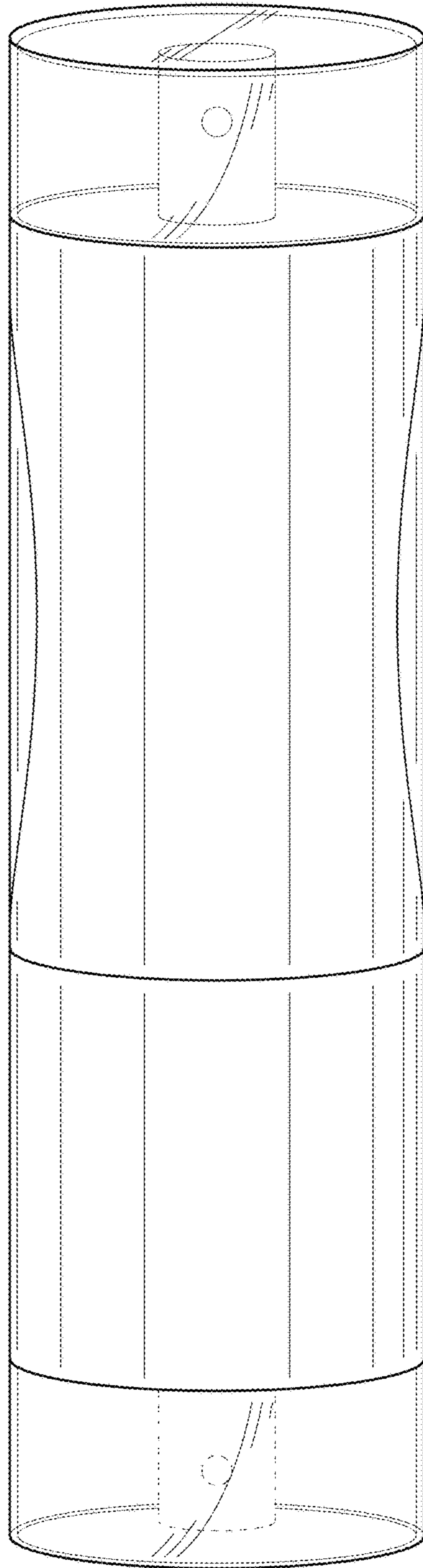

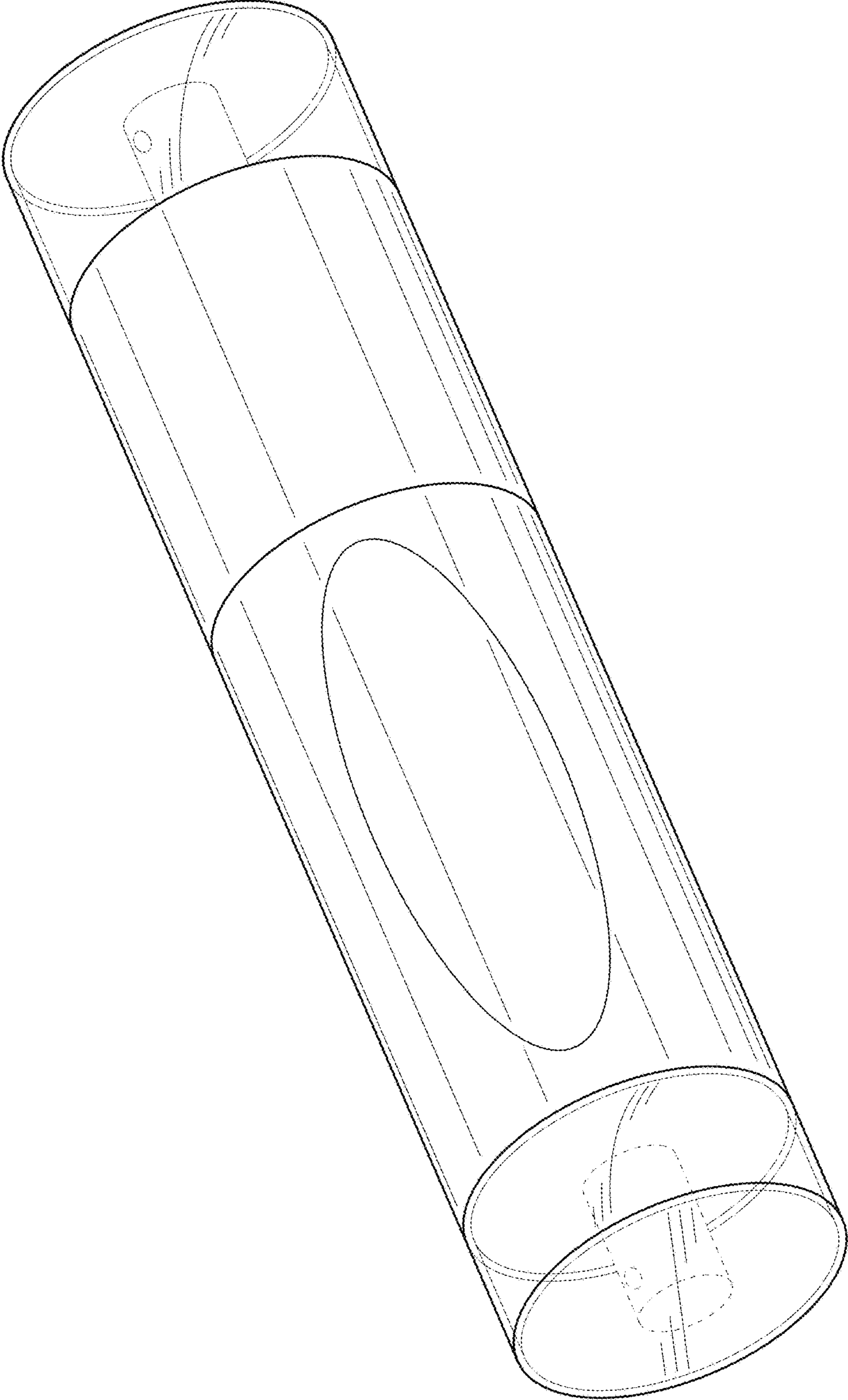
