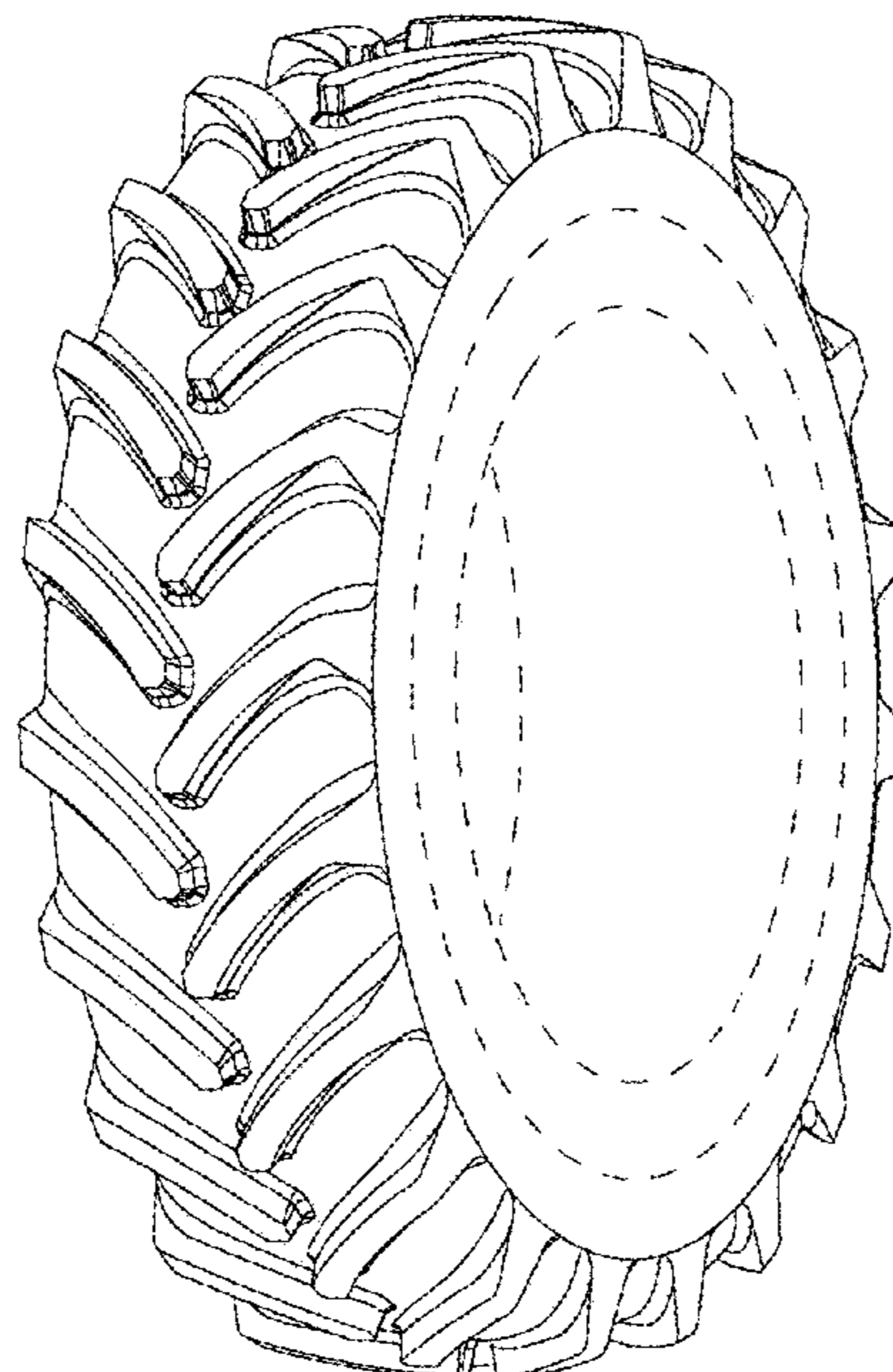
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is front perspective view of the tire tread showing our design;  
 FIG. 2 is a front view thereof;

 FIG. 5 is a second side view thereof;

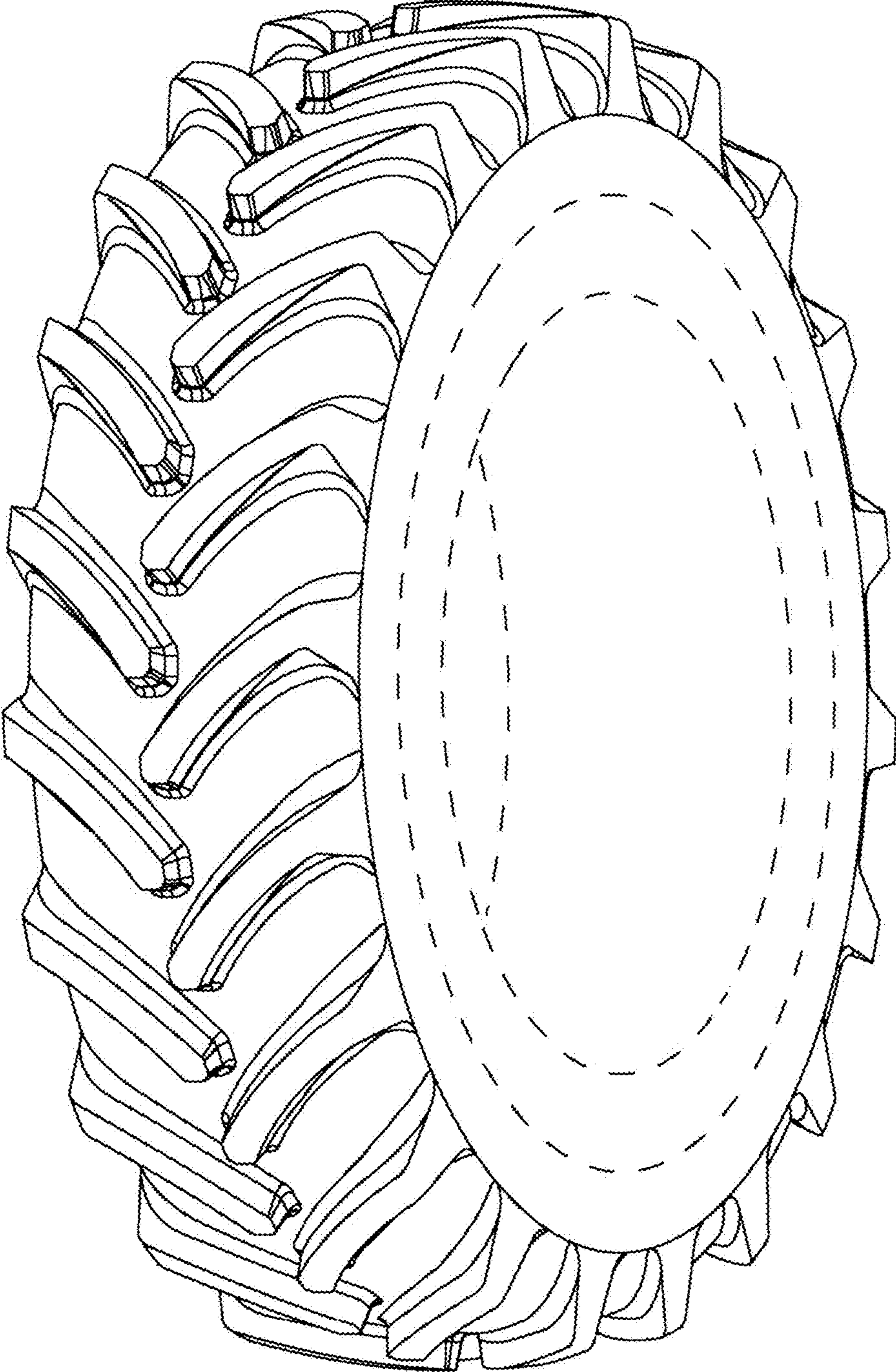

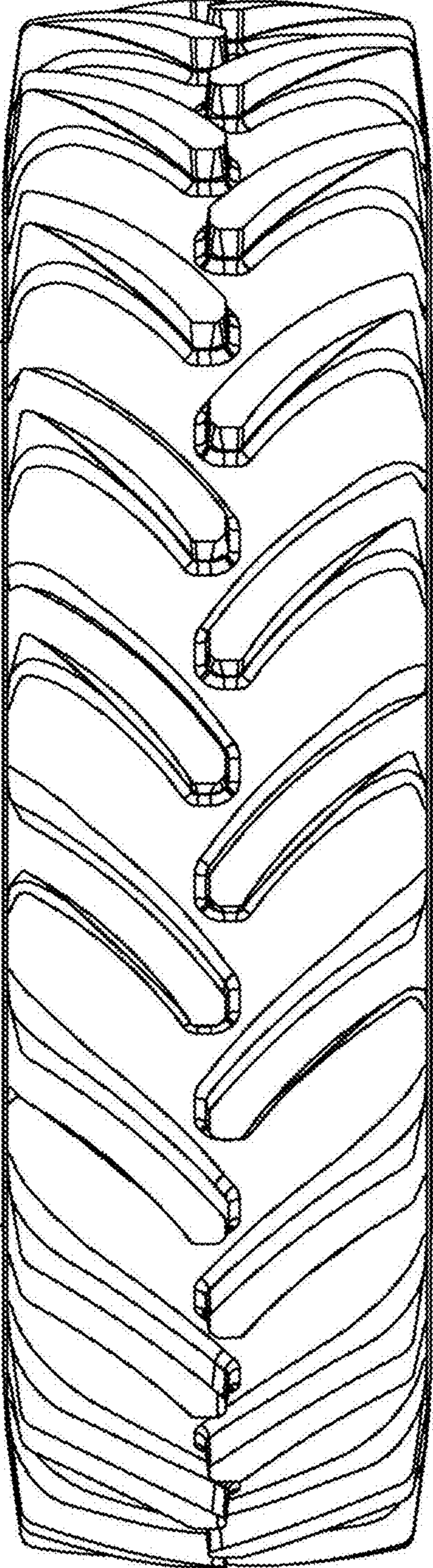

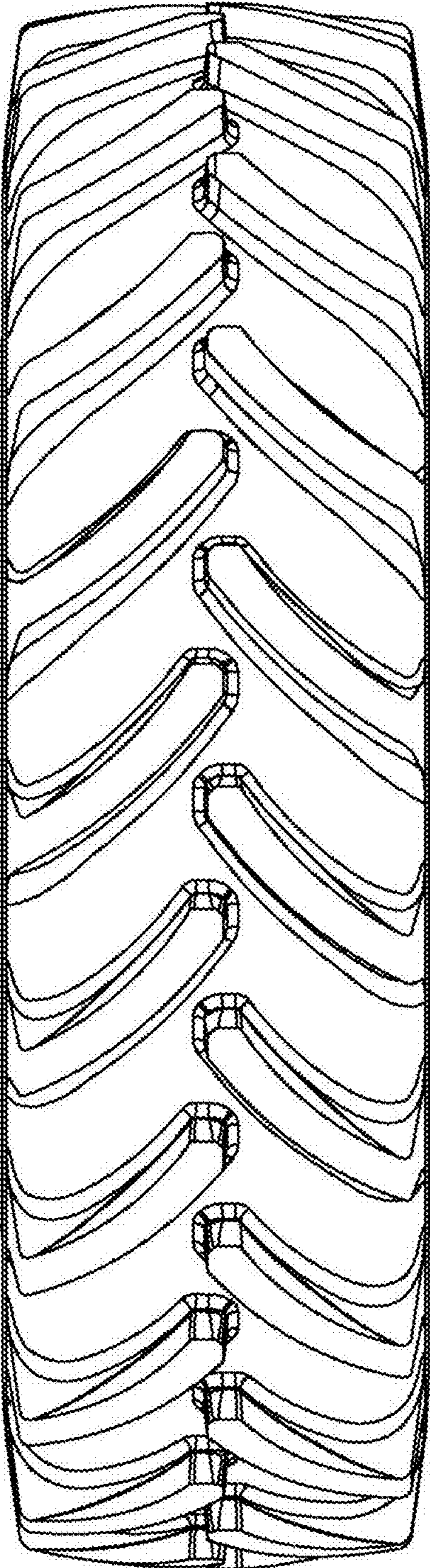

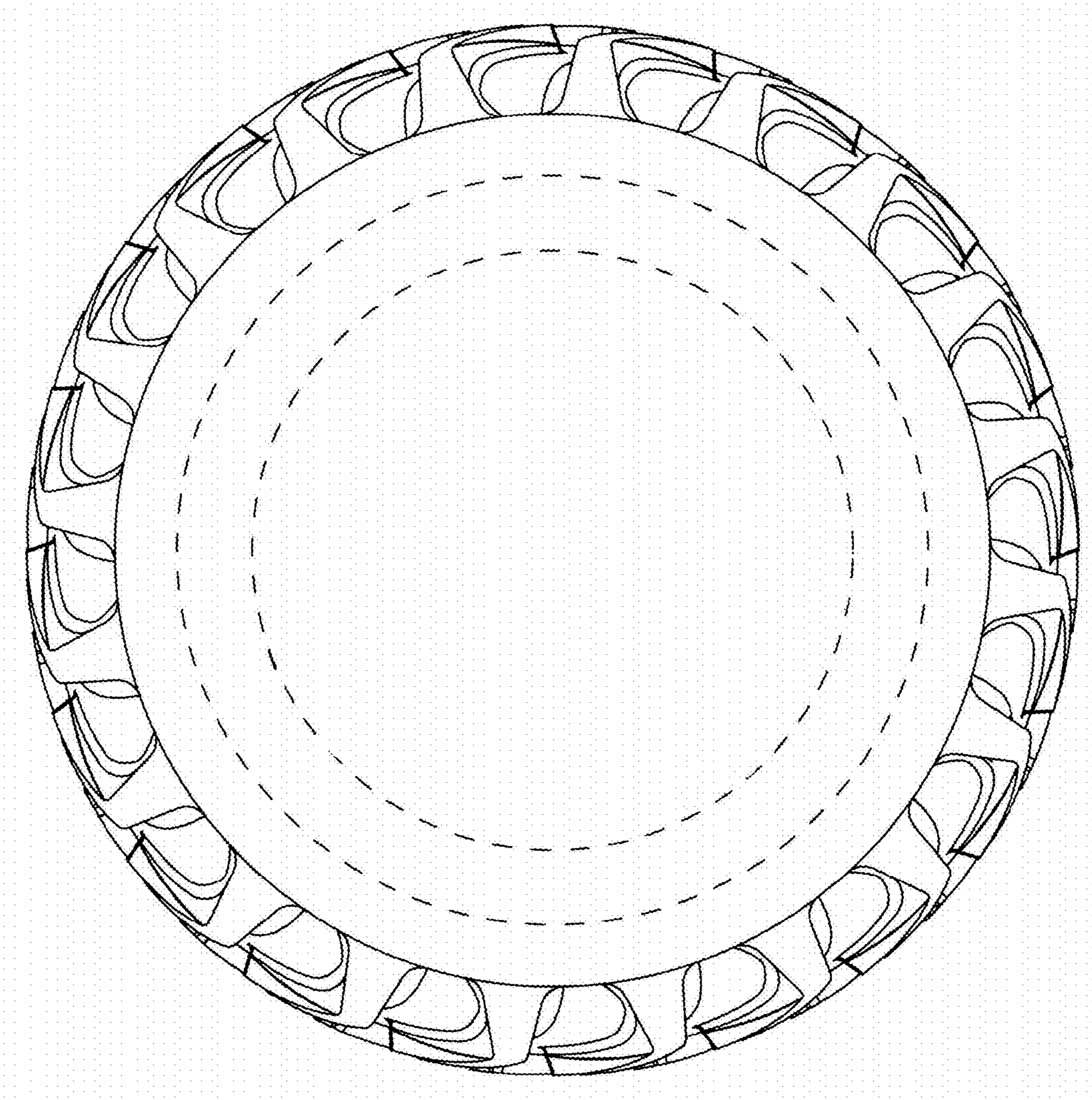

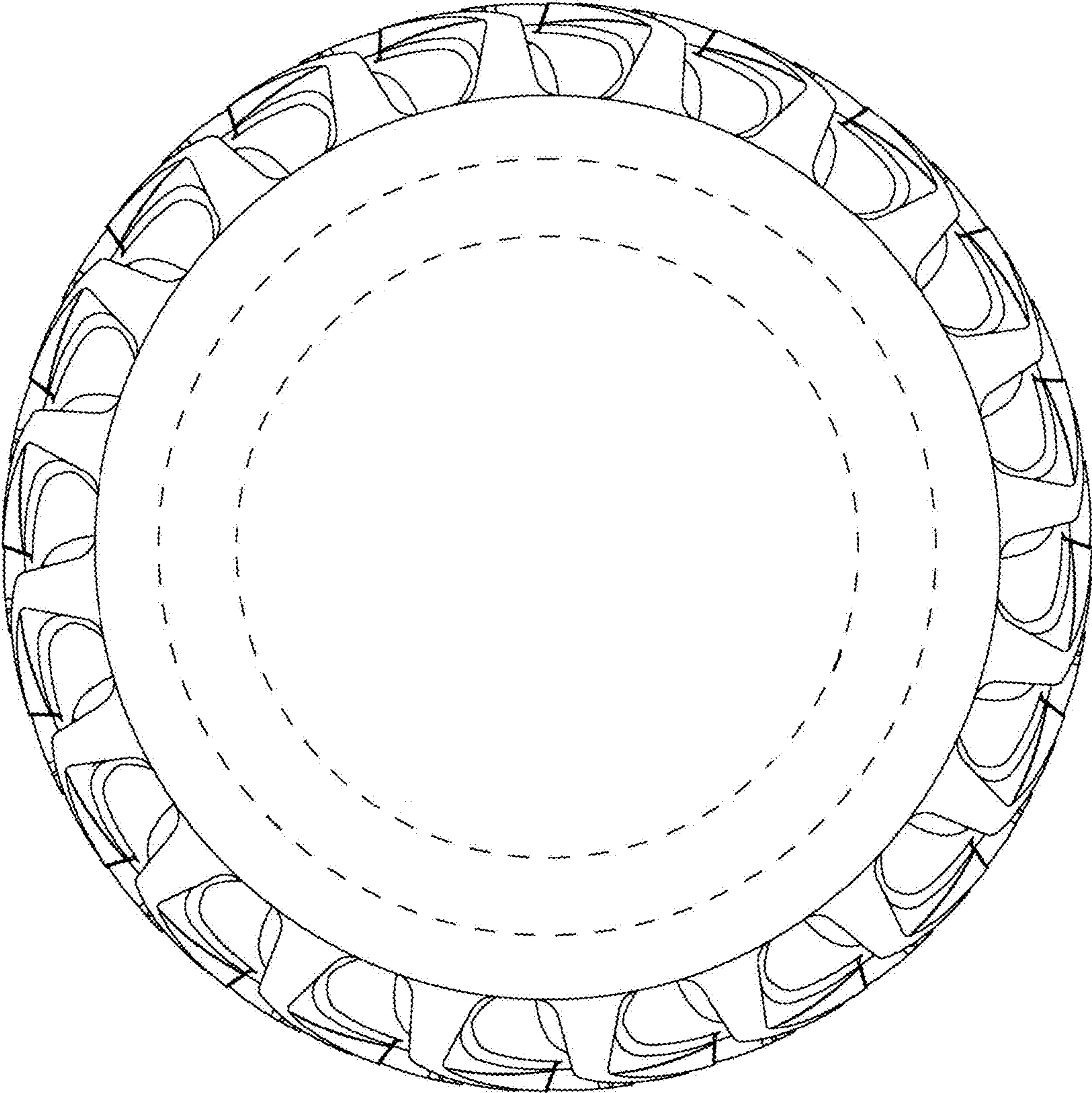

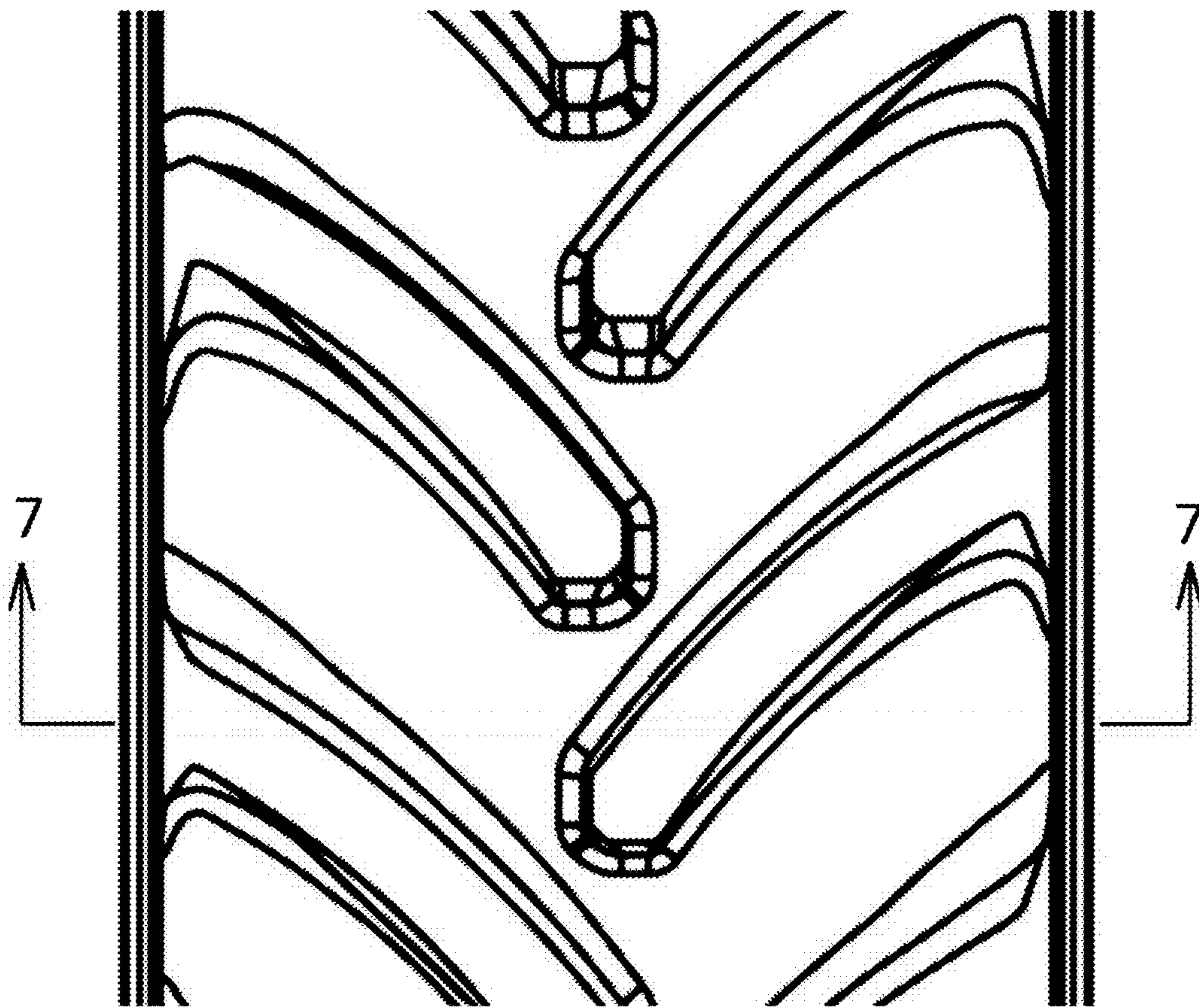

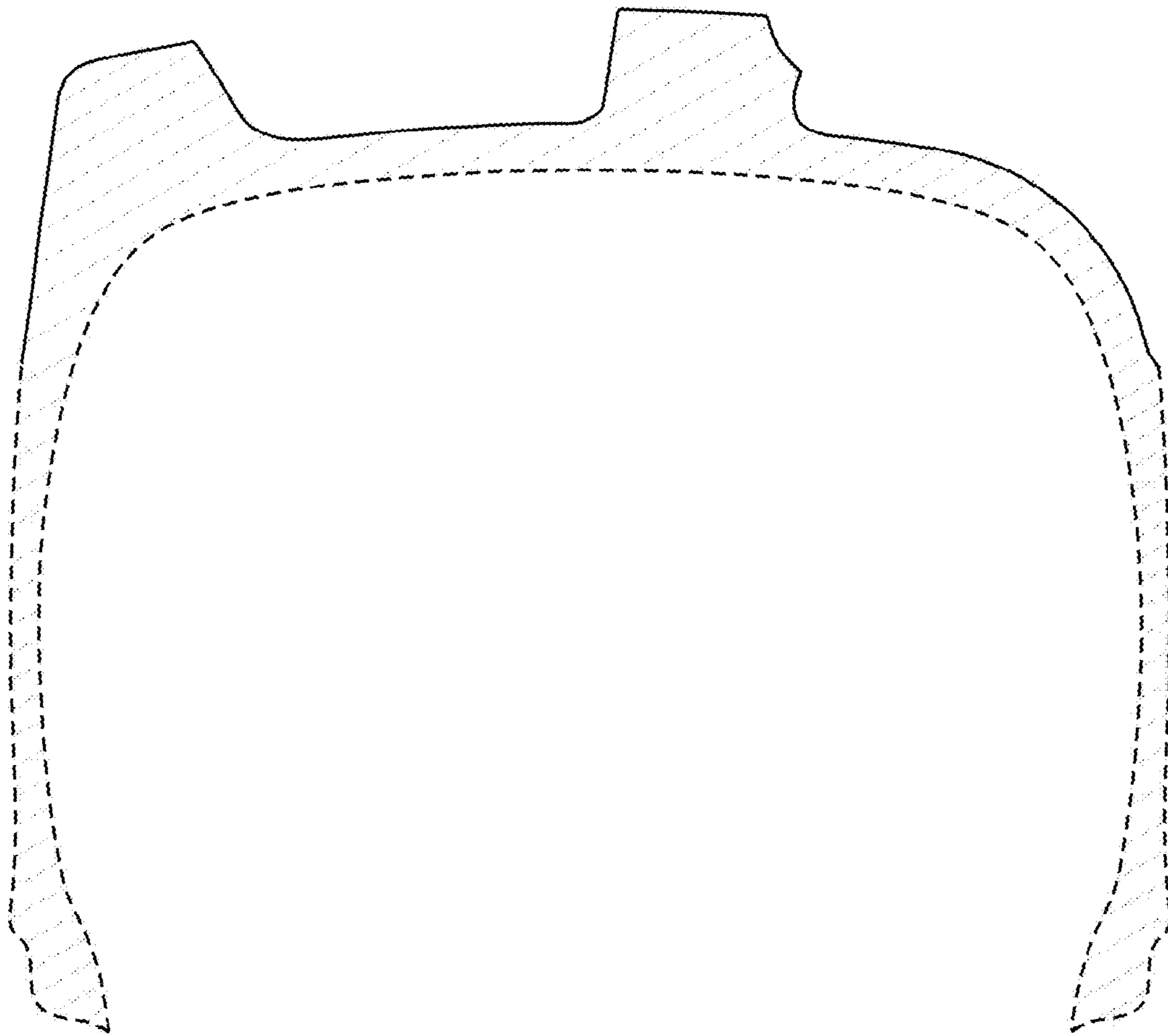
