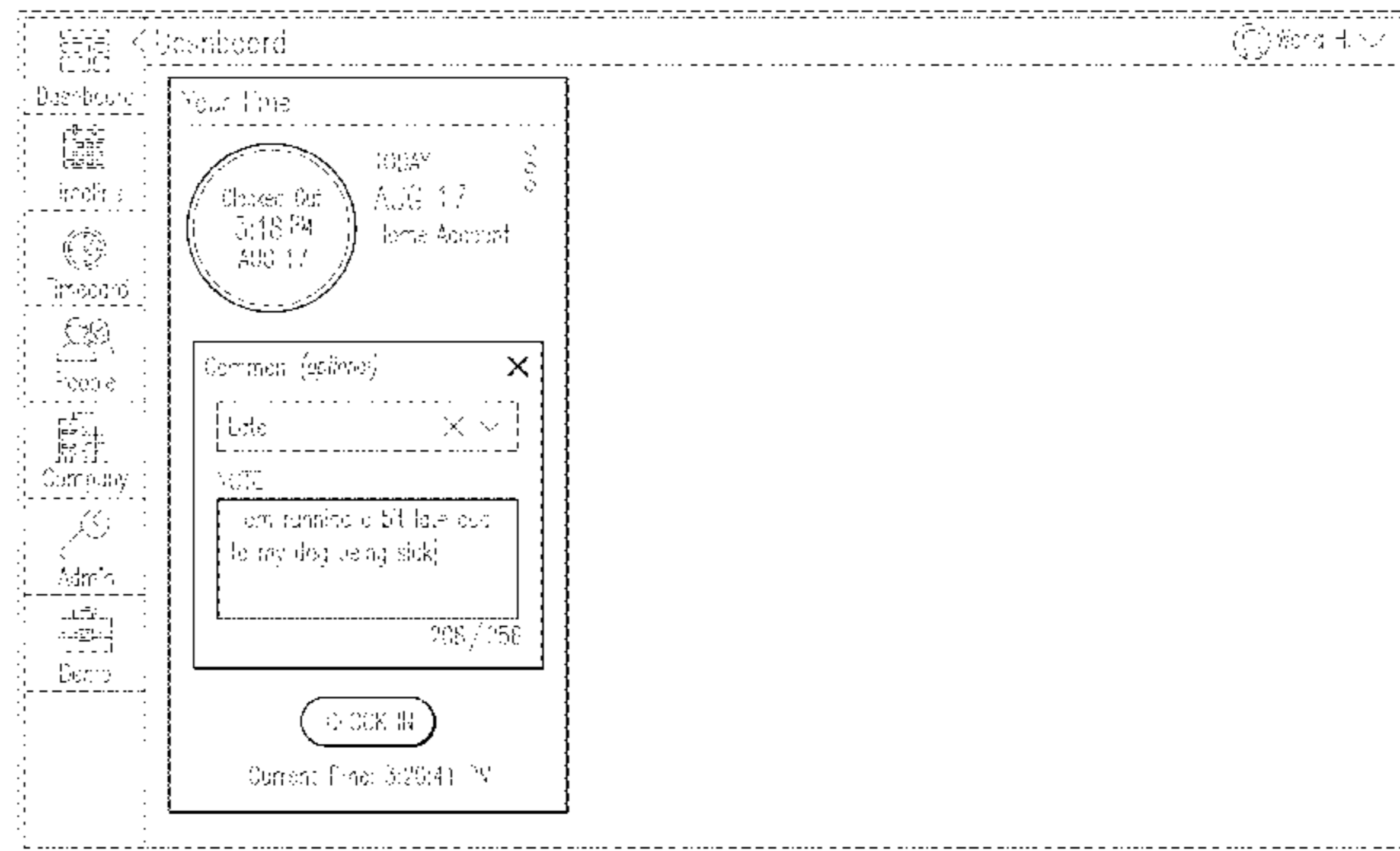
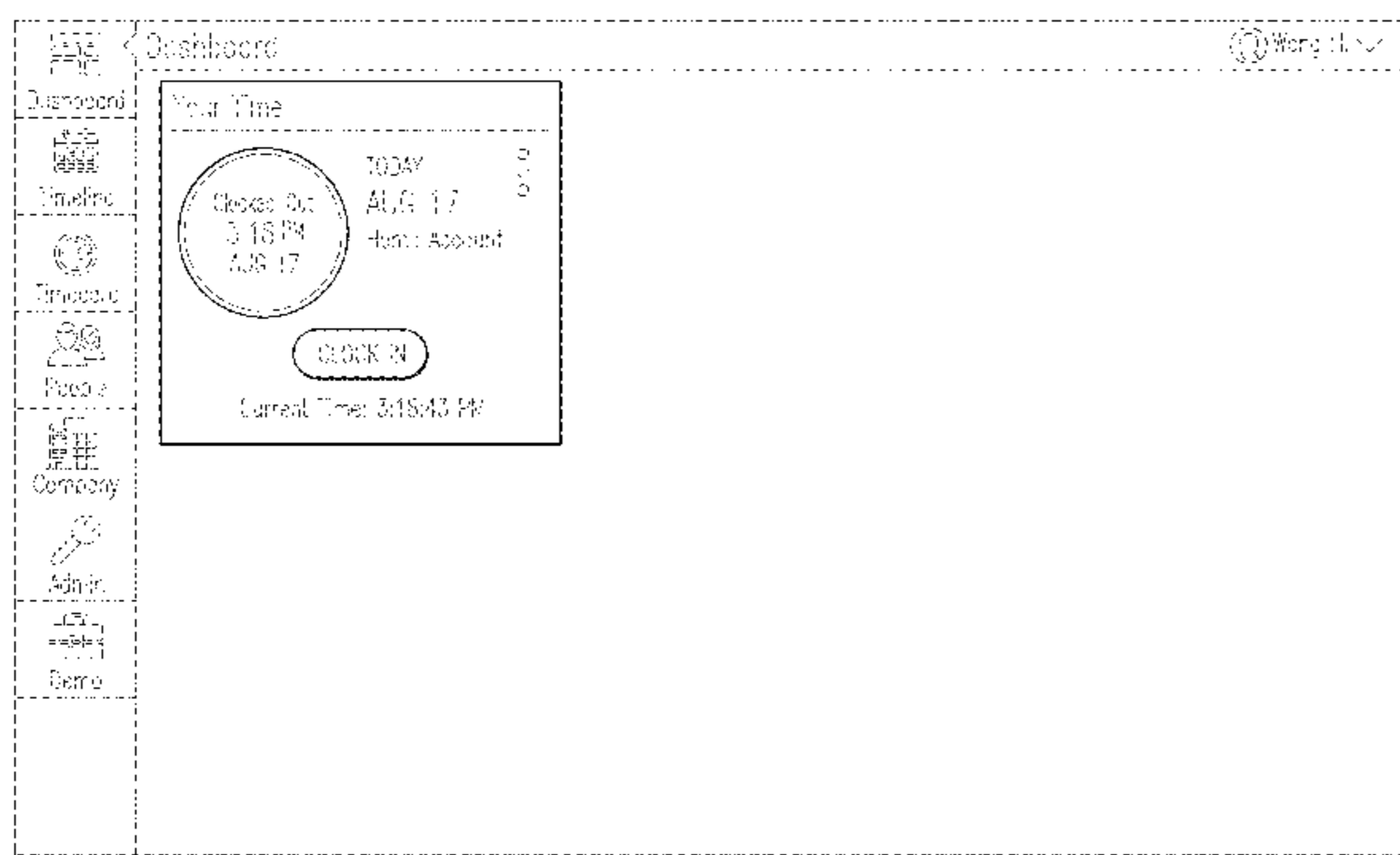
(57) **CLAIM**

The ornamental design for a display screen with animated graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 10 is a view of a fourth embodiment of a display screen with an animated graphical user interface;

FIG. 12 is a third view of the fourth embodiment of the display screen with the animated graphical user interface.

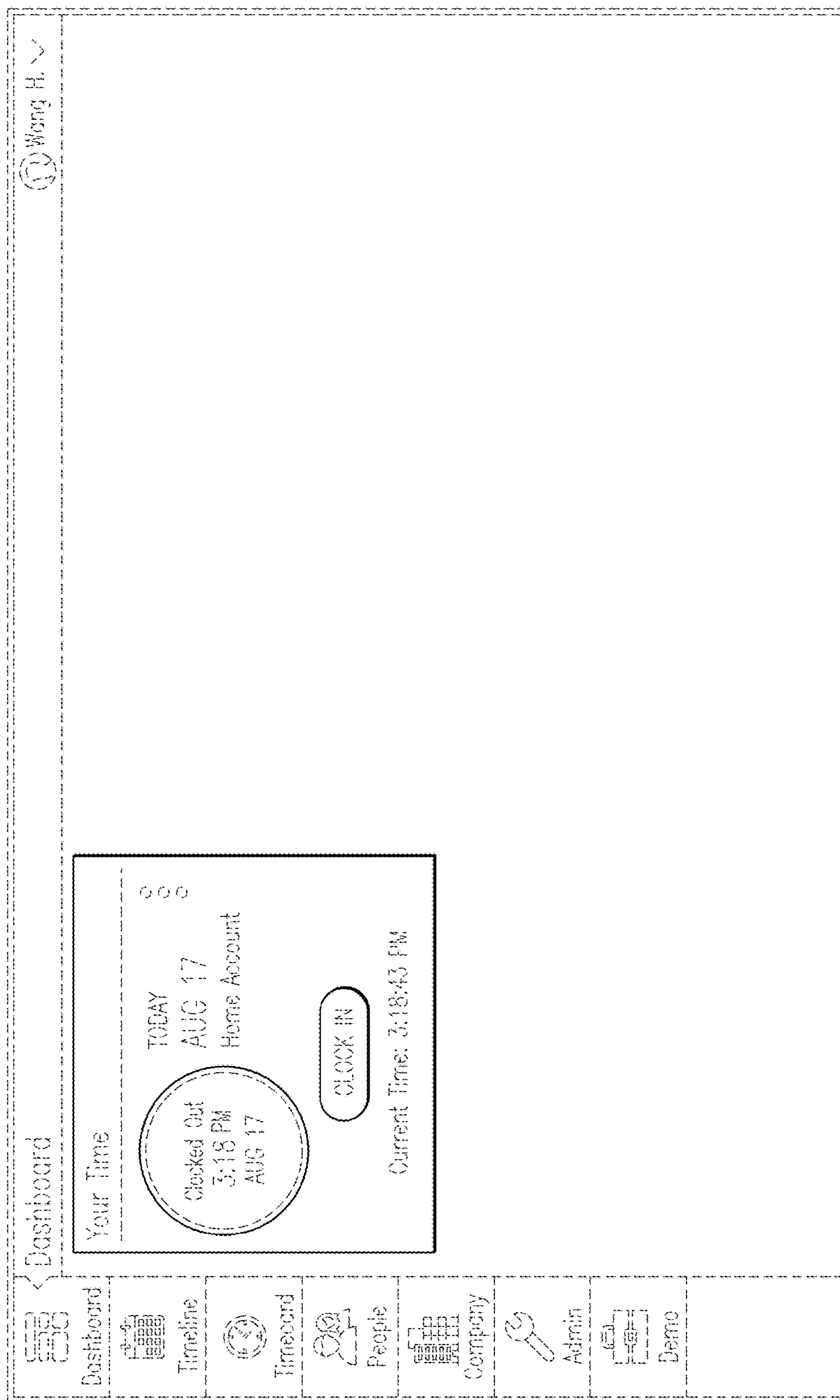

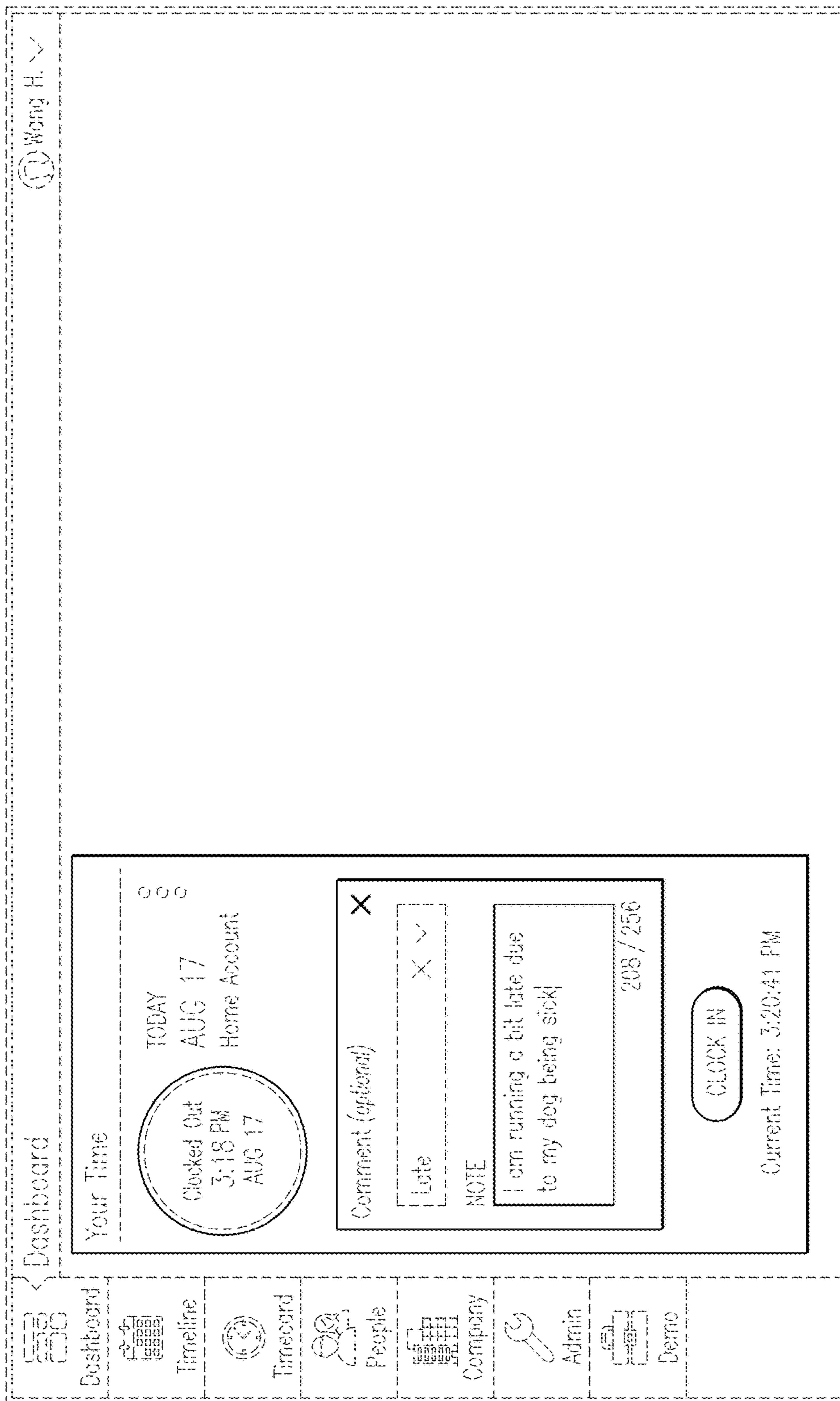

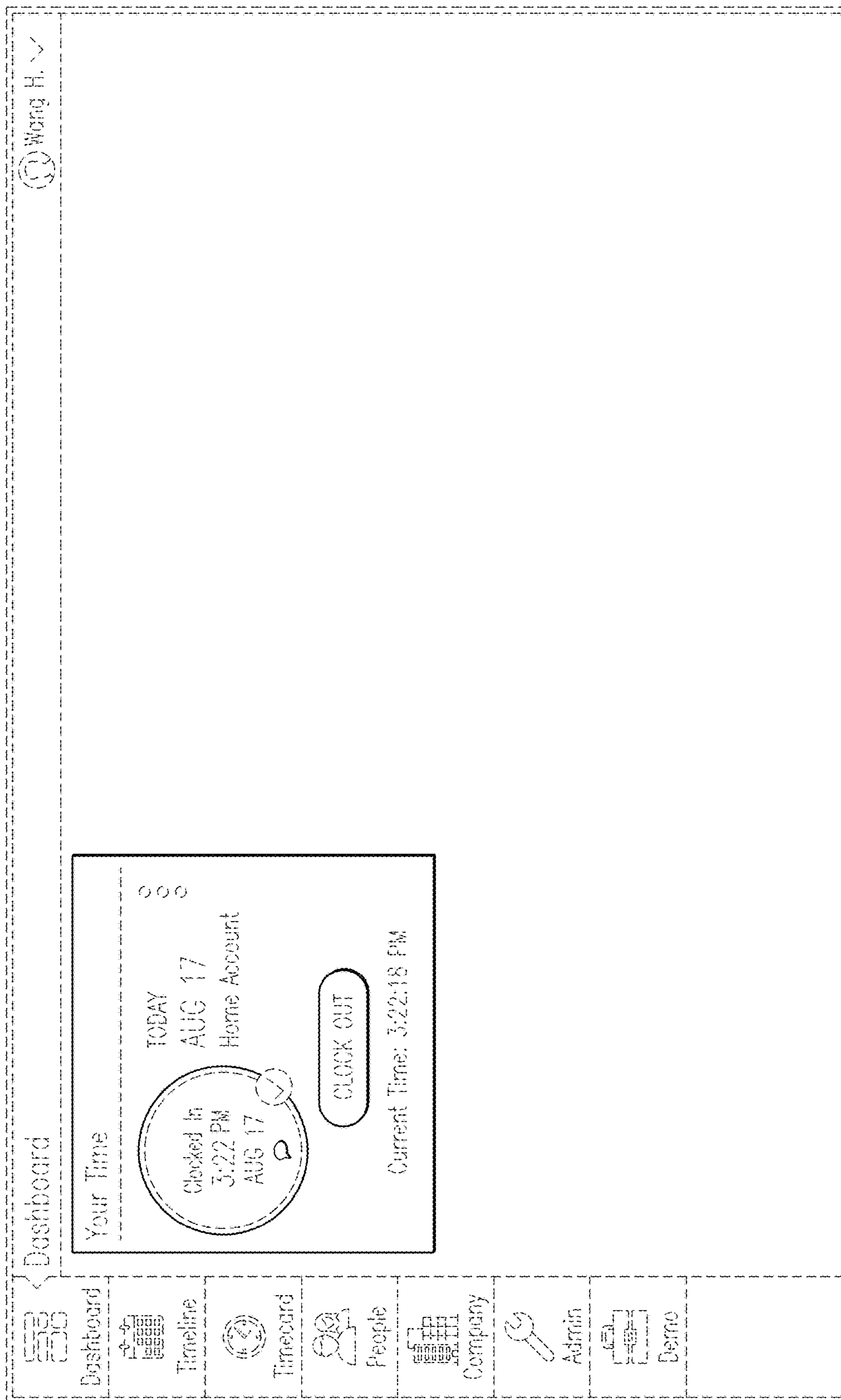

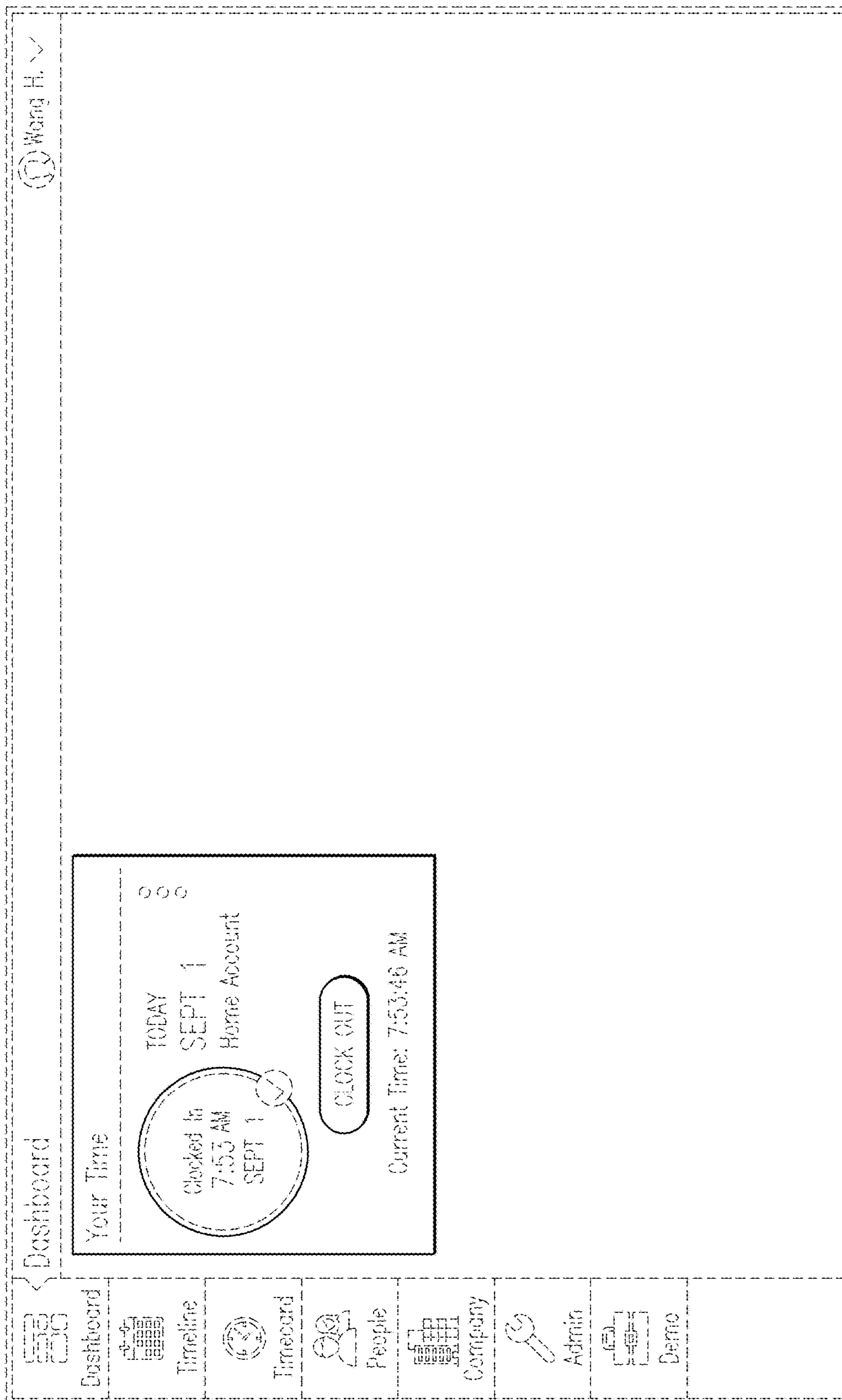

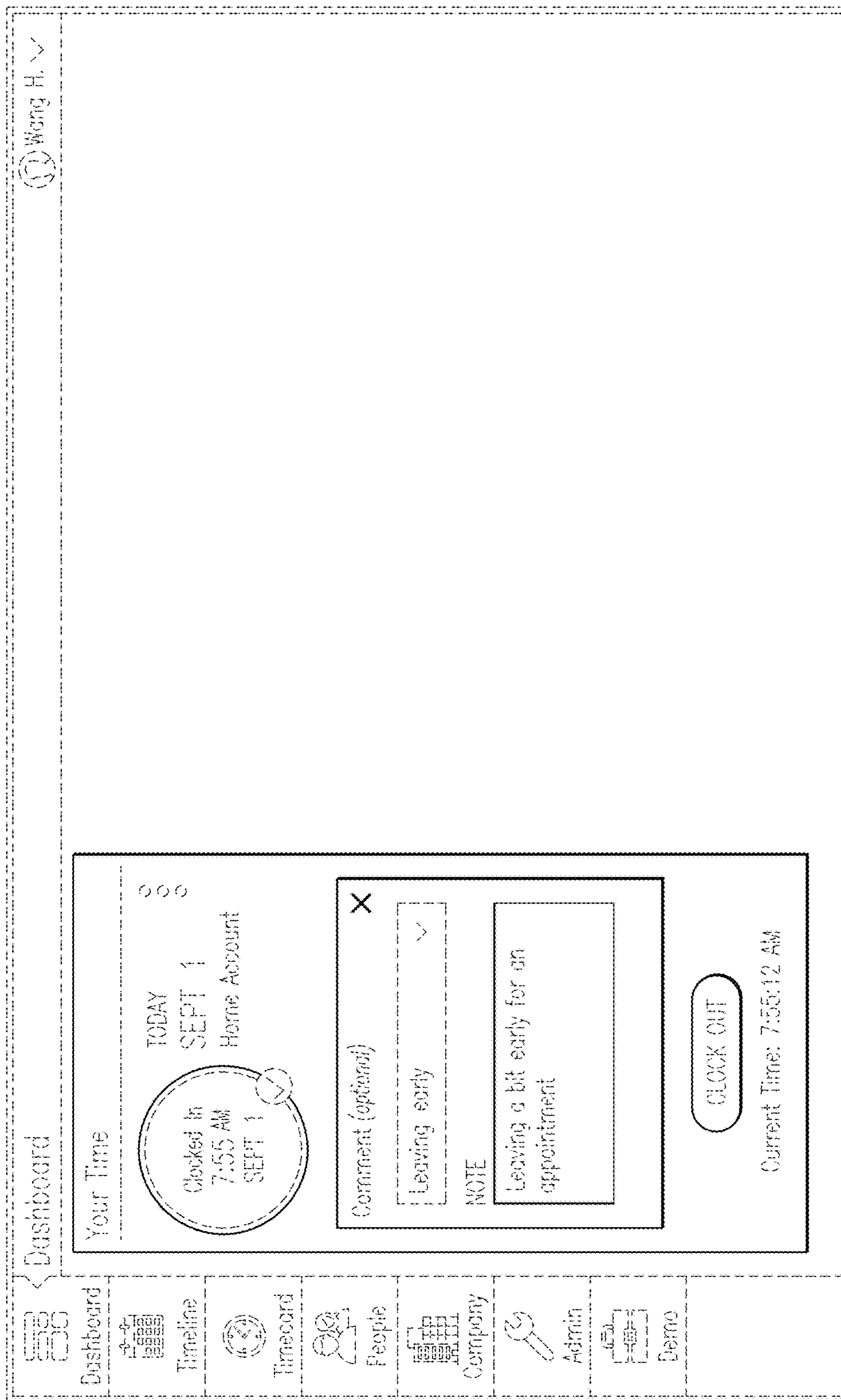

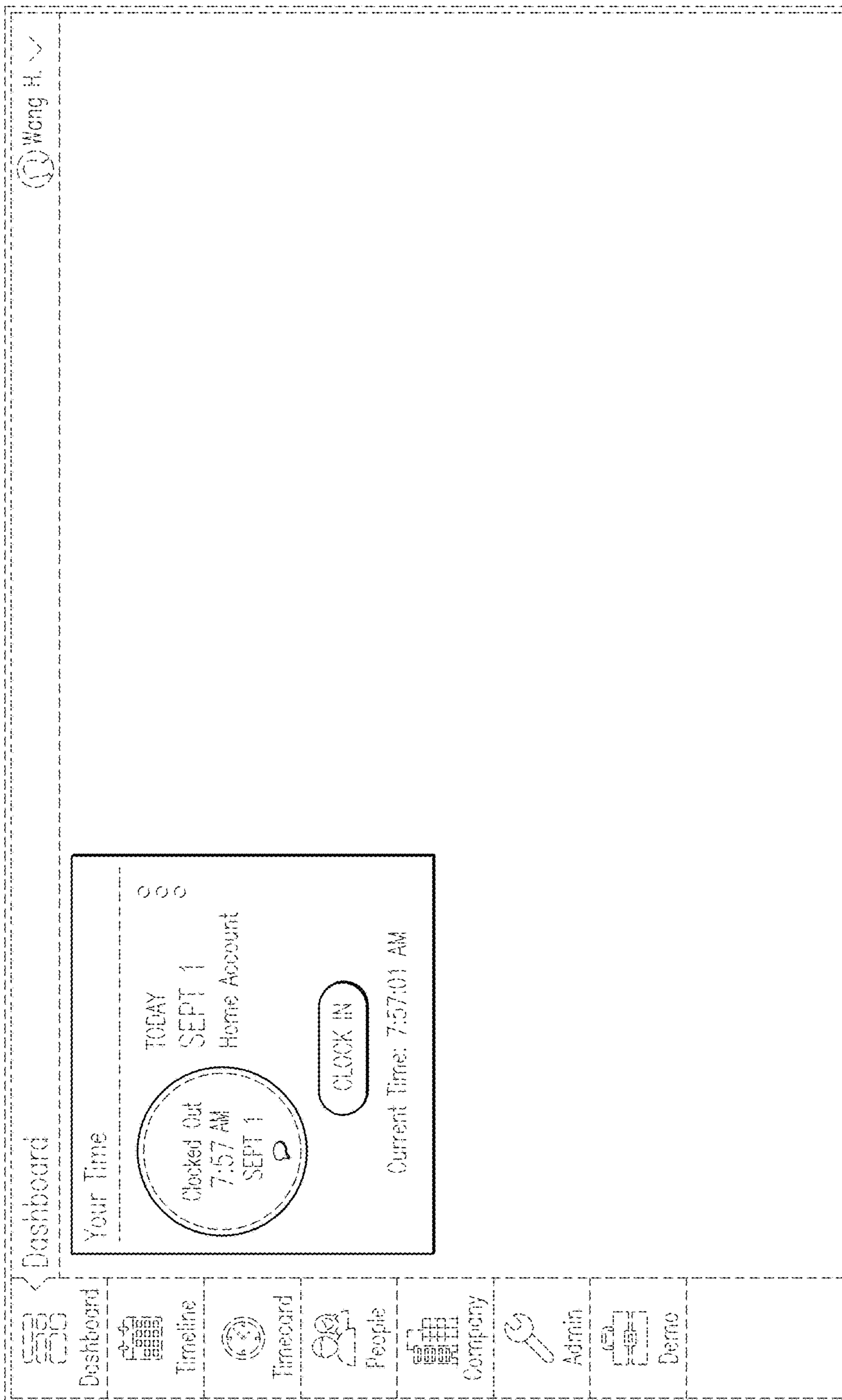

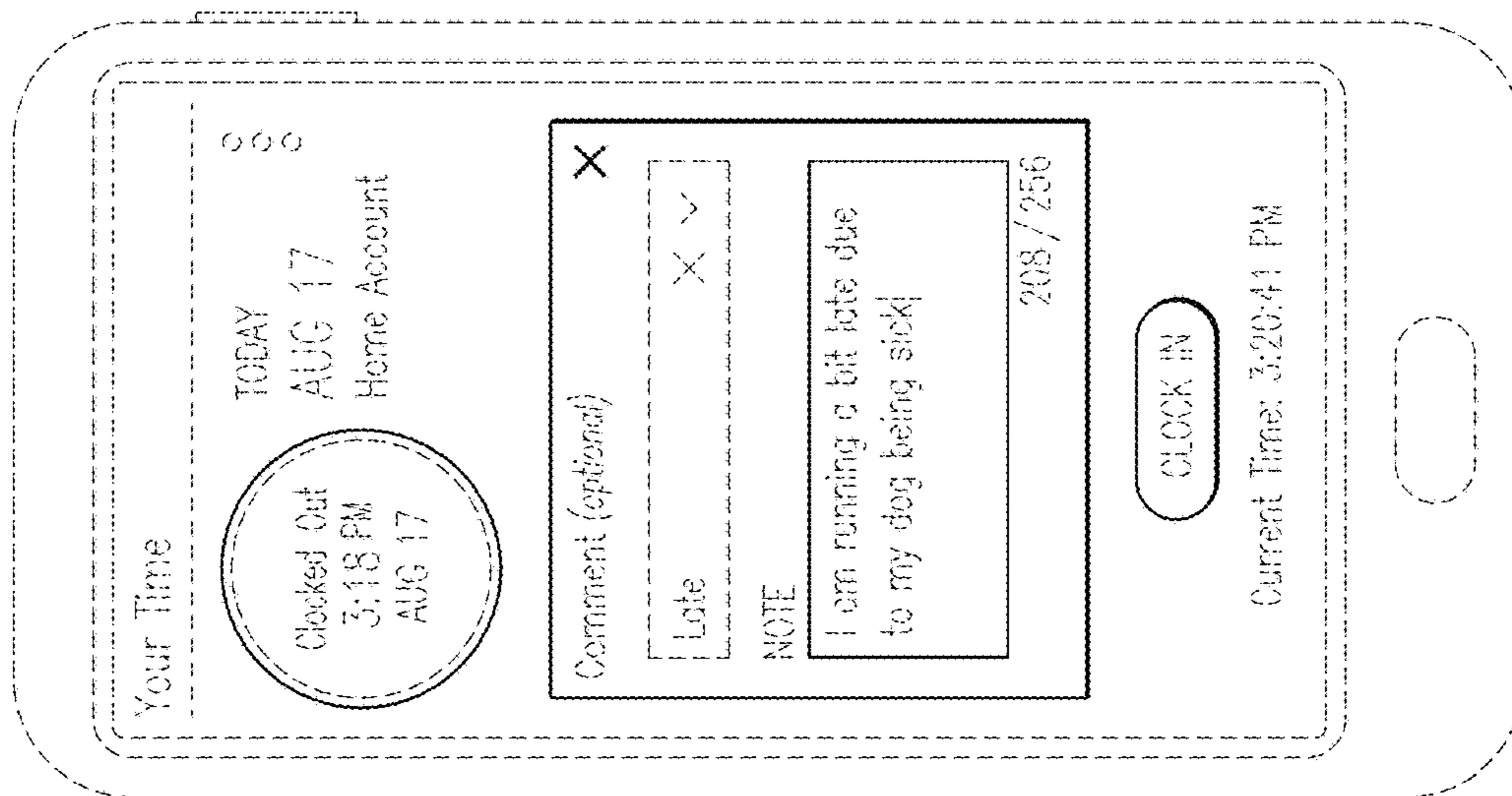

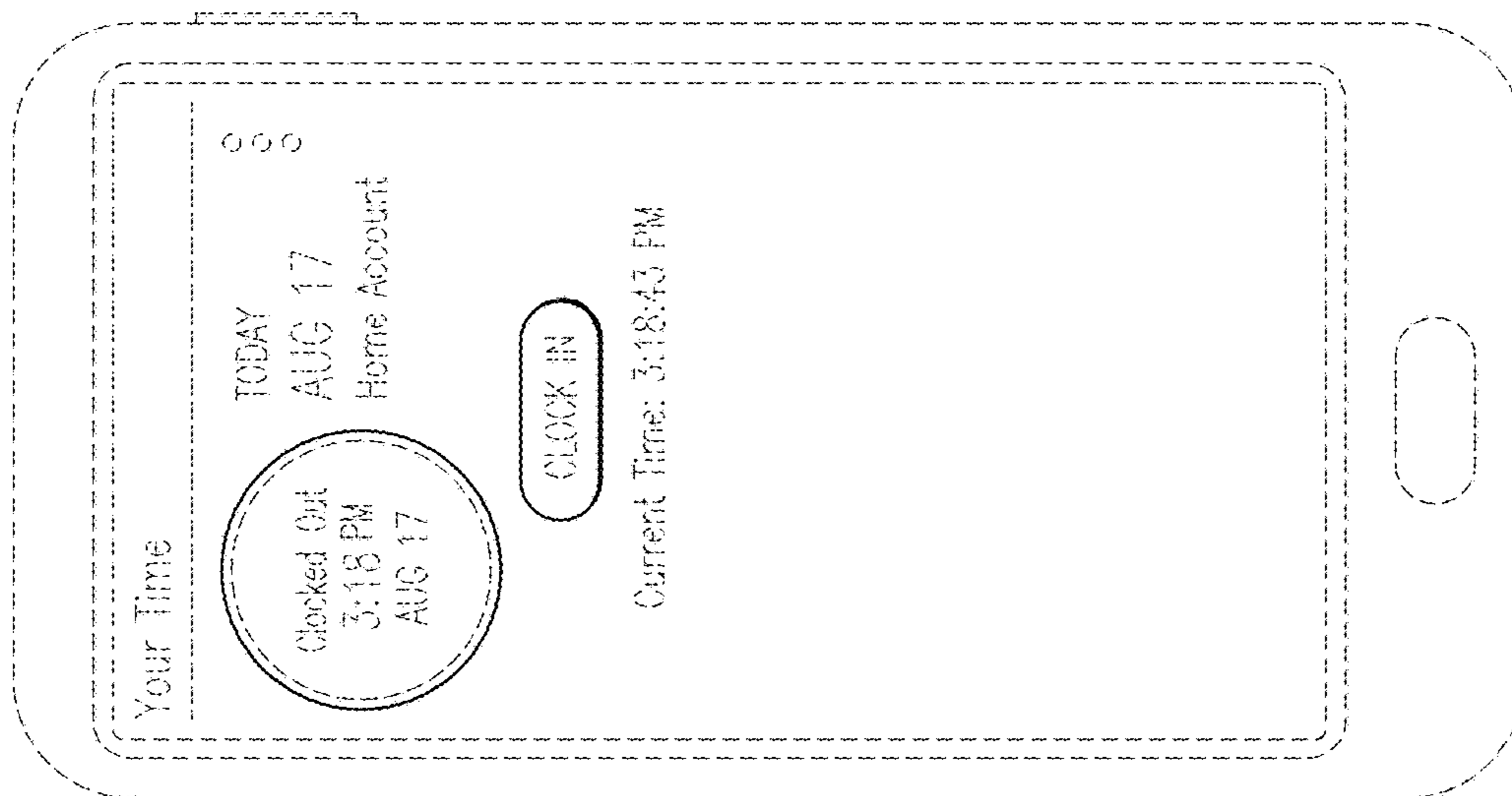

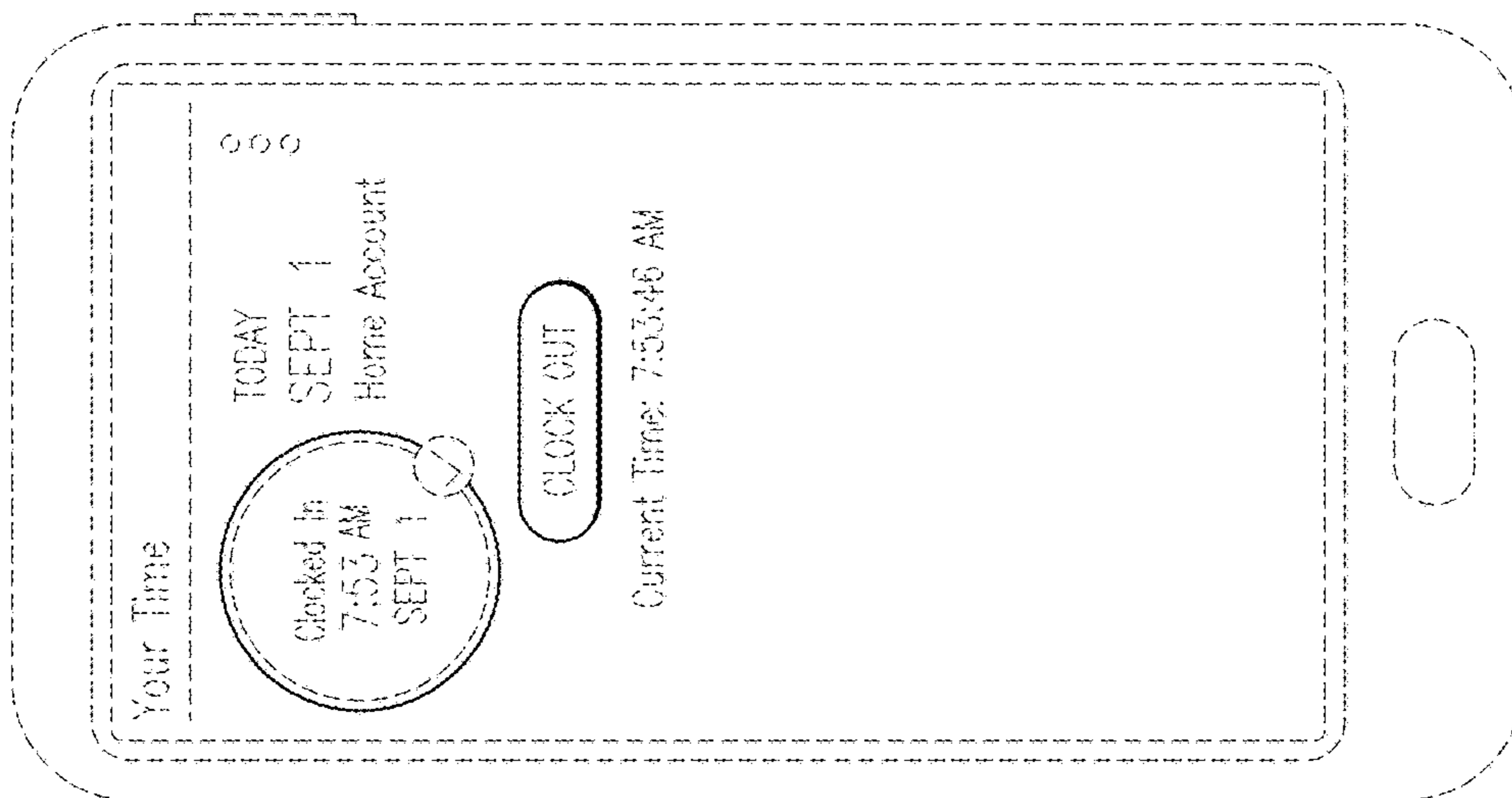

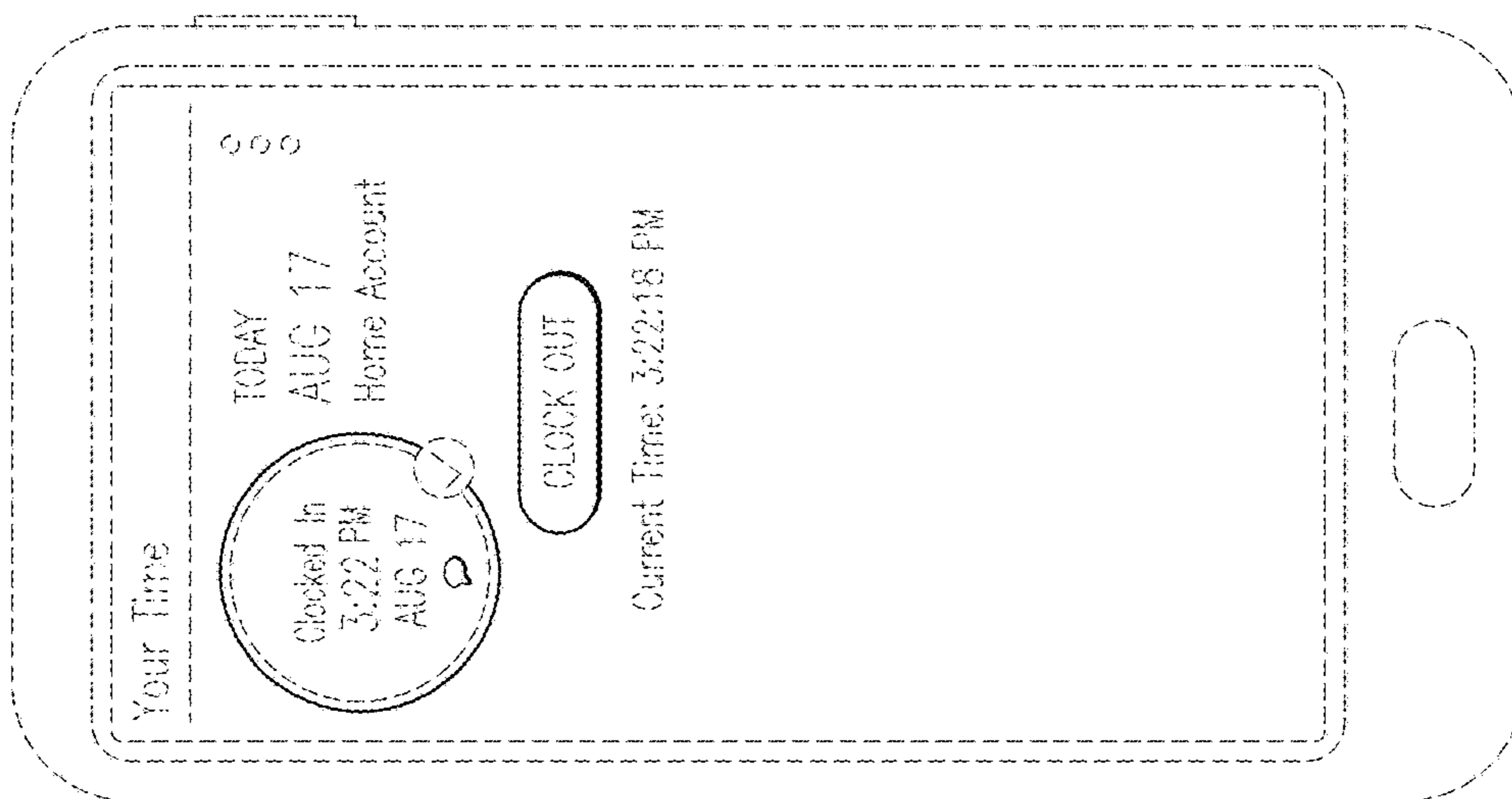

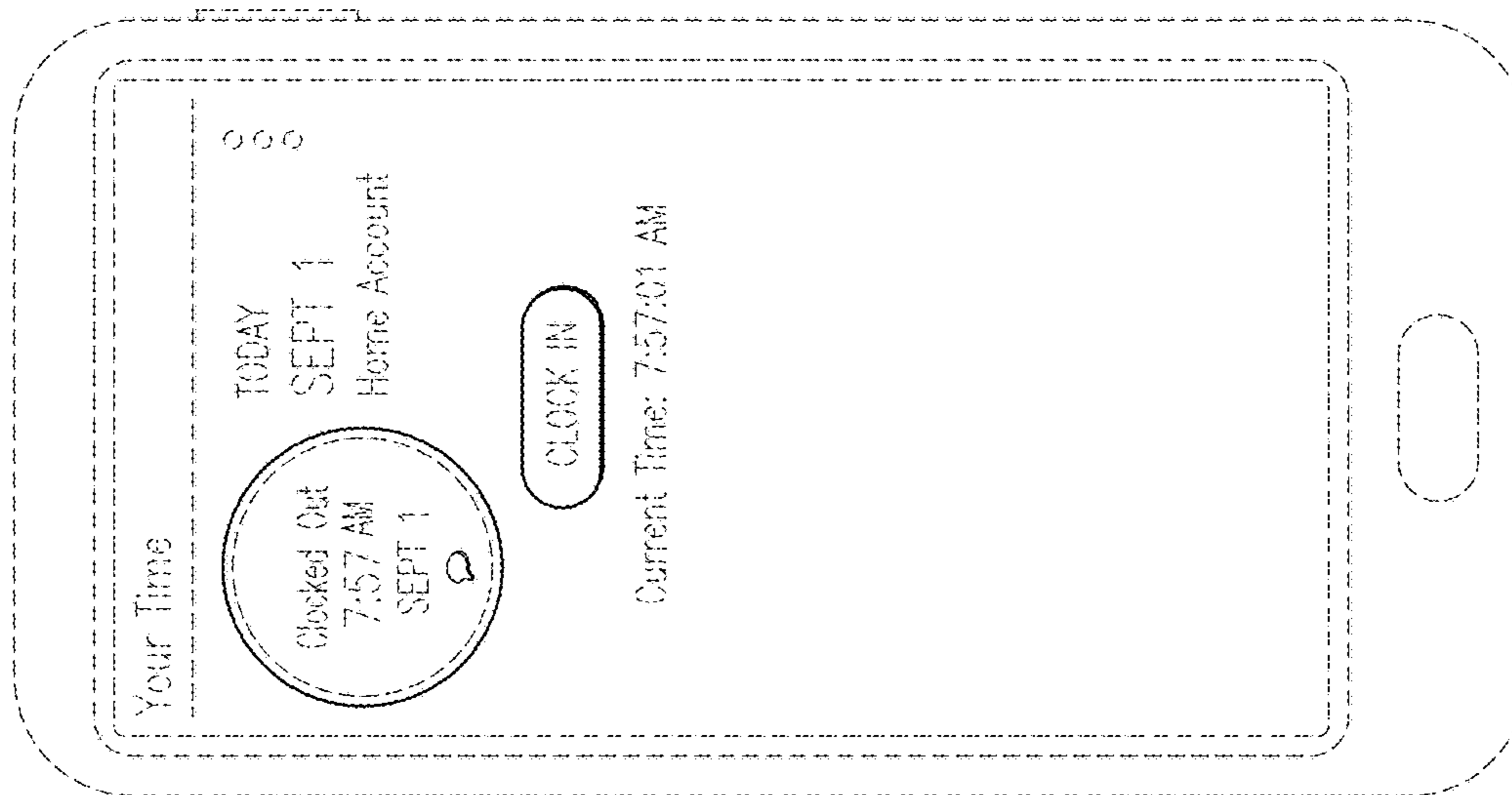

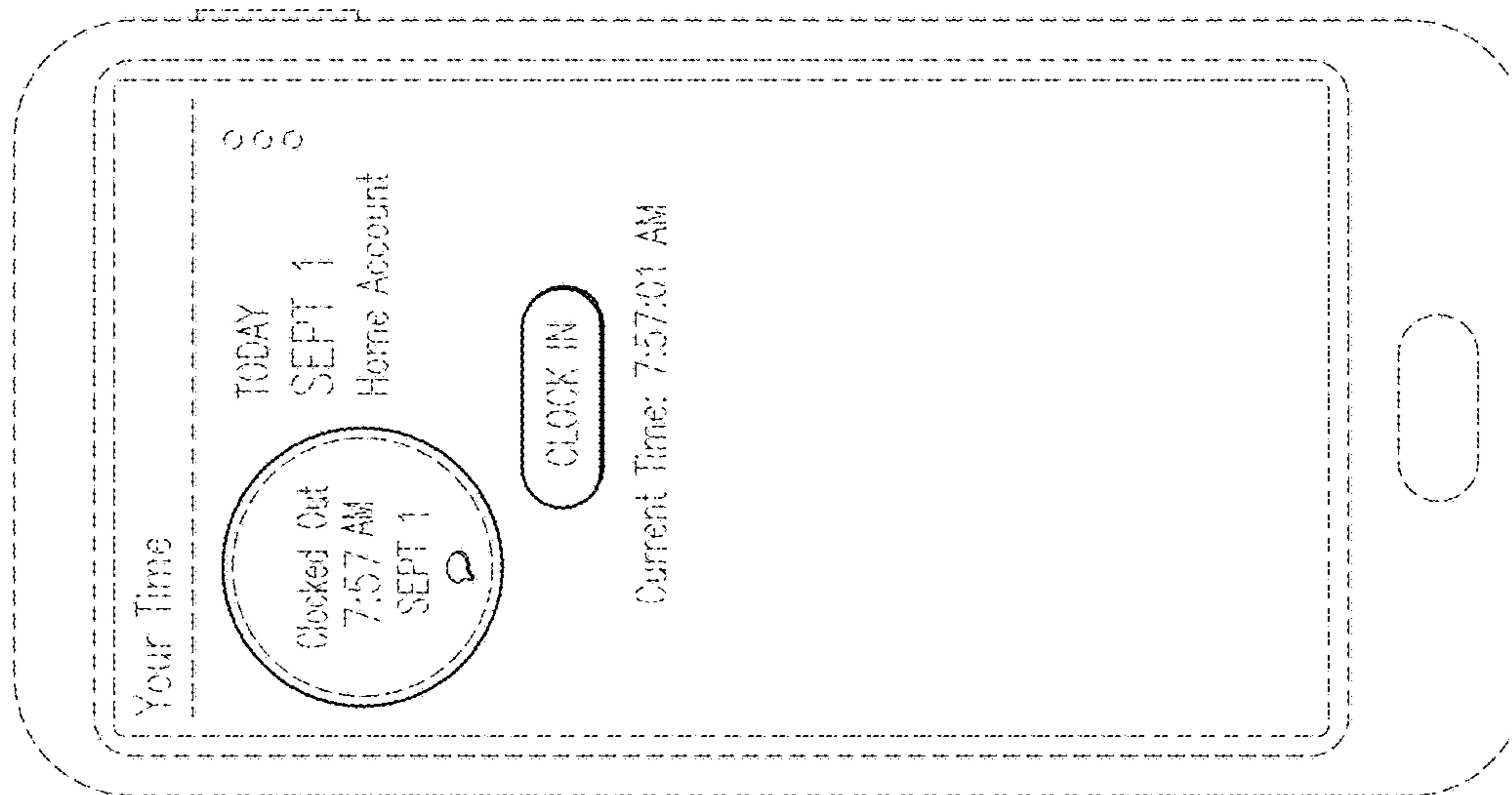
