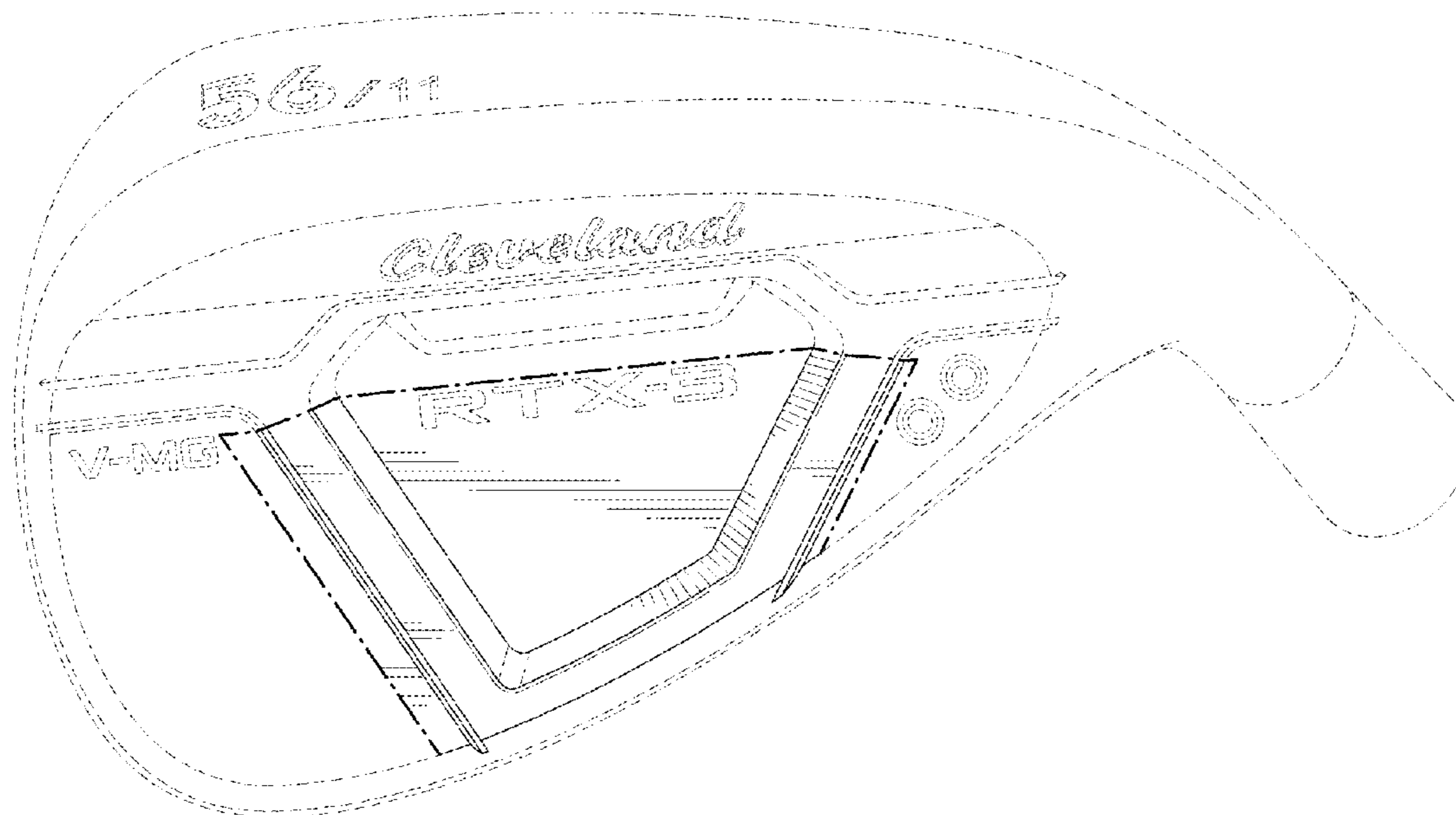
(57) **CLAIM**

The ornamental design for a golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a front, top perspective view of the golf club head; FIG. 2 is a rear, bottom perspective view thereof; and FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a toe-side elevational view thereof; FIG. 6 is a heel-side elevational view thereof; FIG. 7 is a rear elevational view thereof; and, FIG. 8 is a rear, bottom, heel-side perspective view thereof. The broken lines depict unclaimed portions of the golf club head, and thus form no part of the claimed design. The dot-dash chain lines depict boundaries of the claimed subject matter and thus form no part of the claimed design.

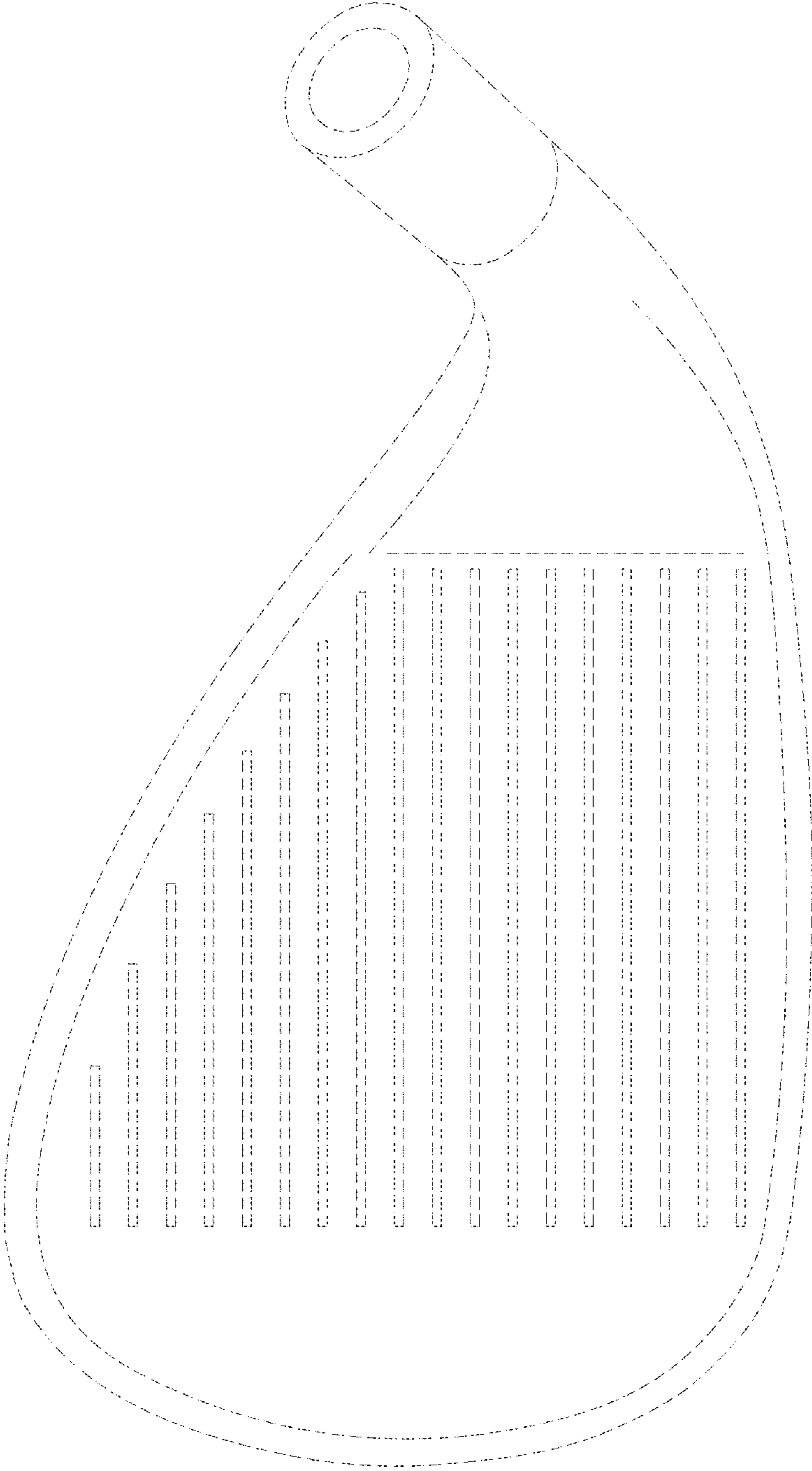

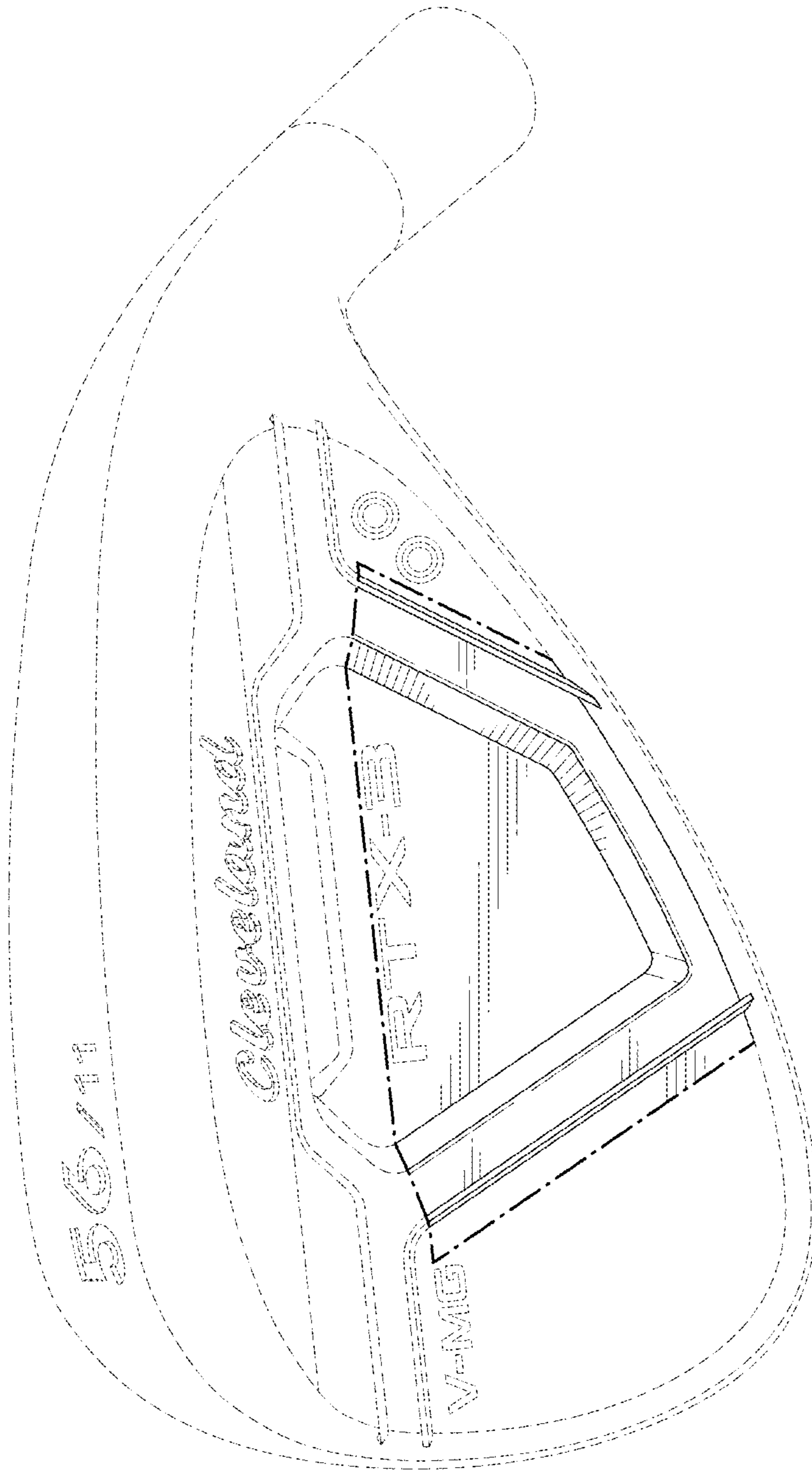

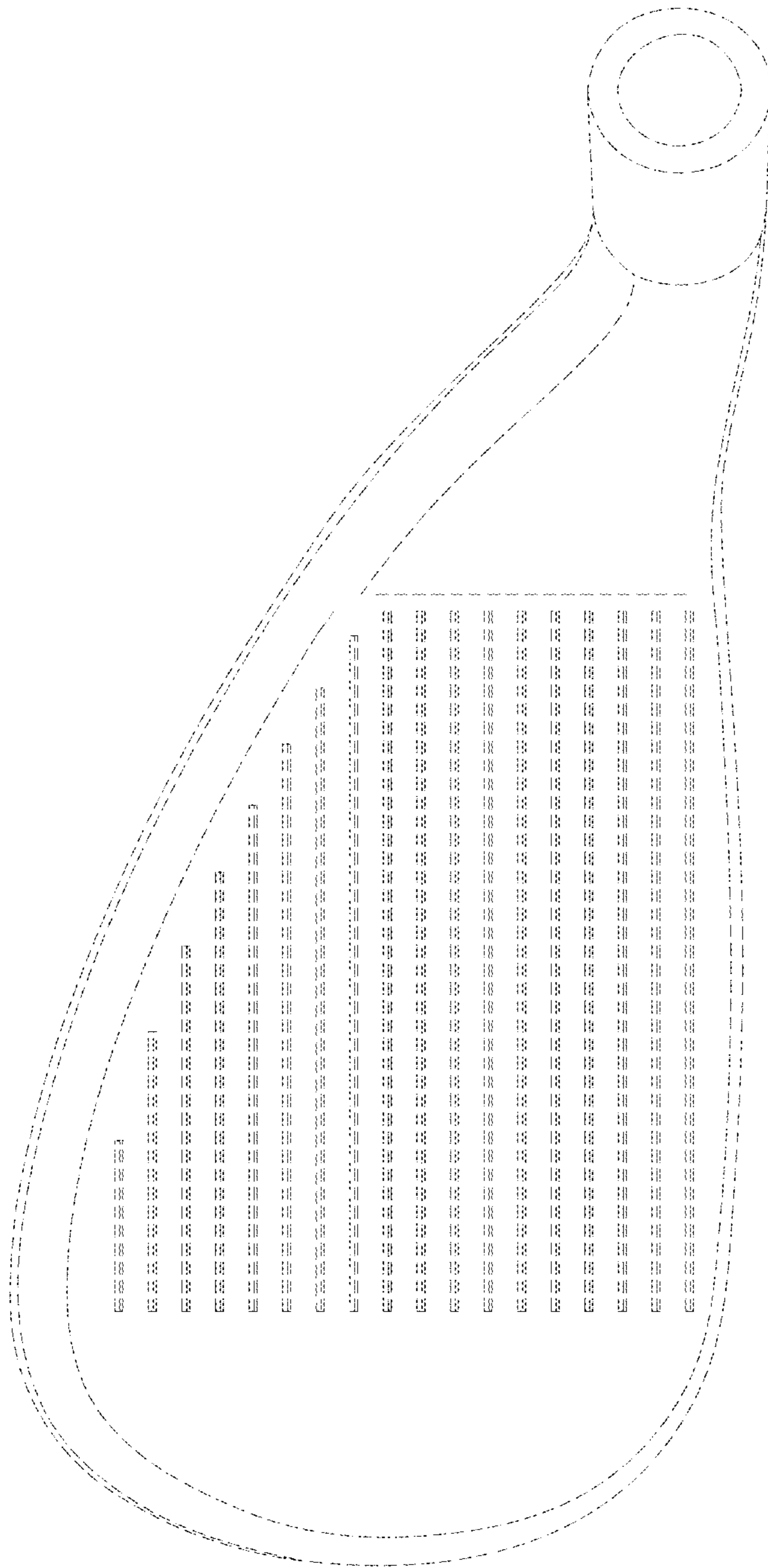

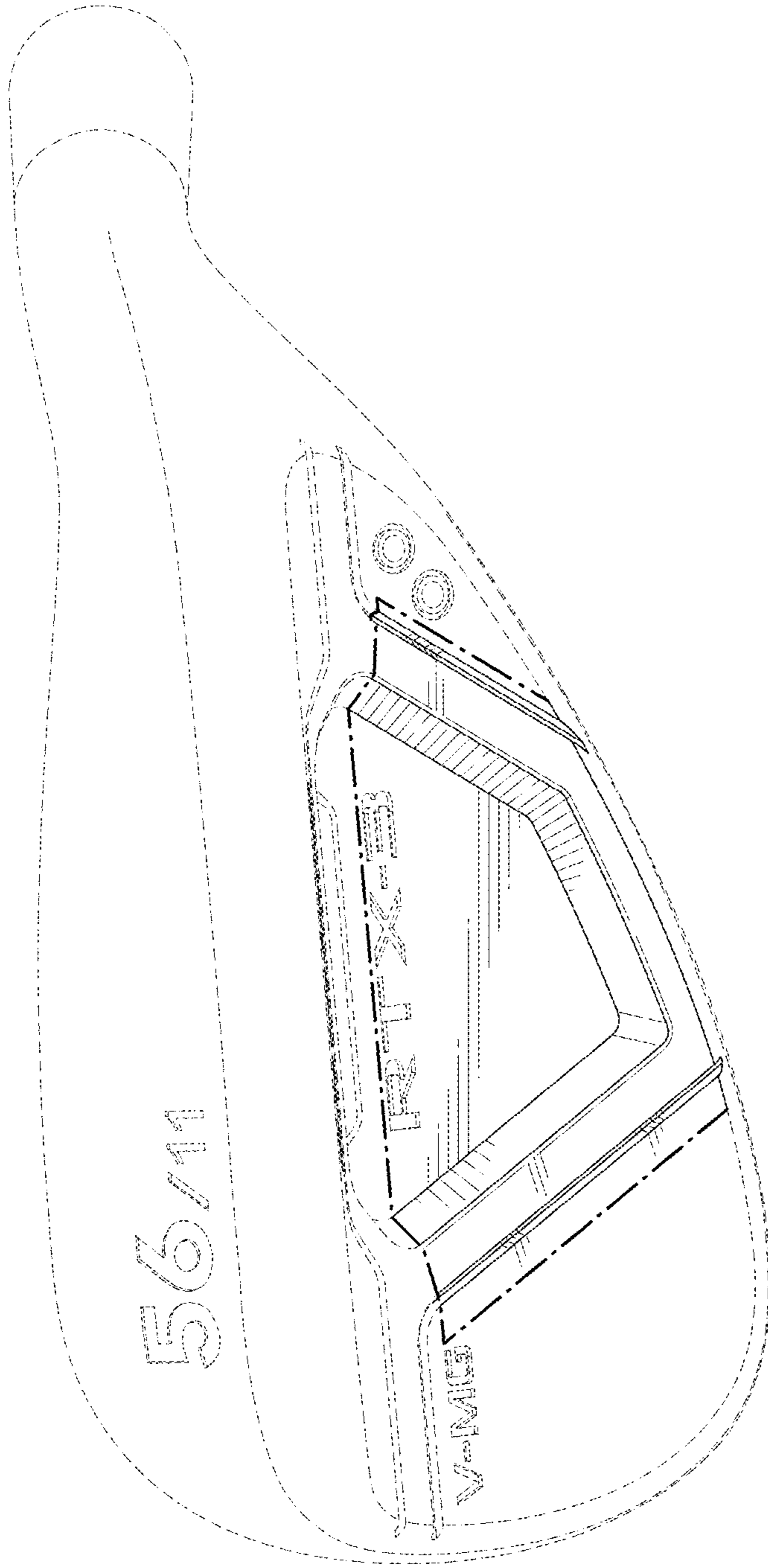

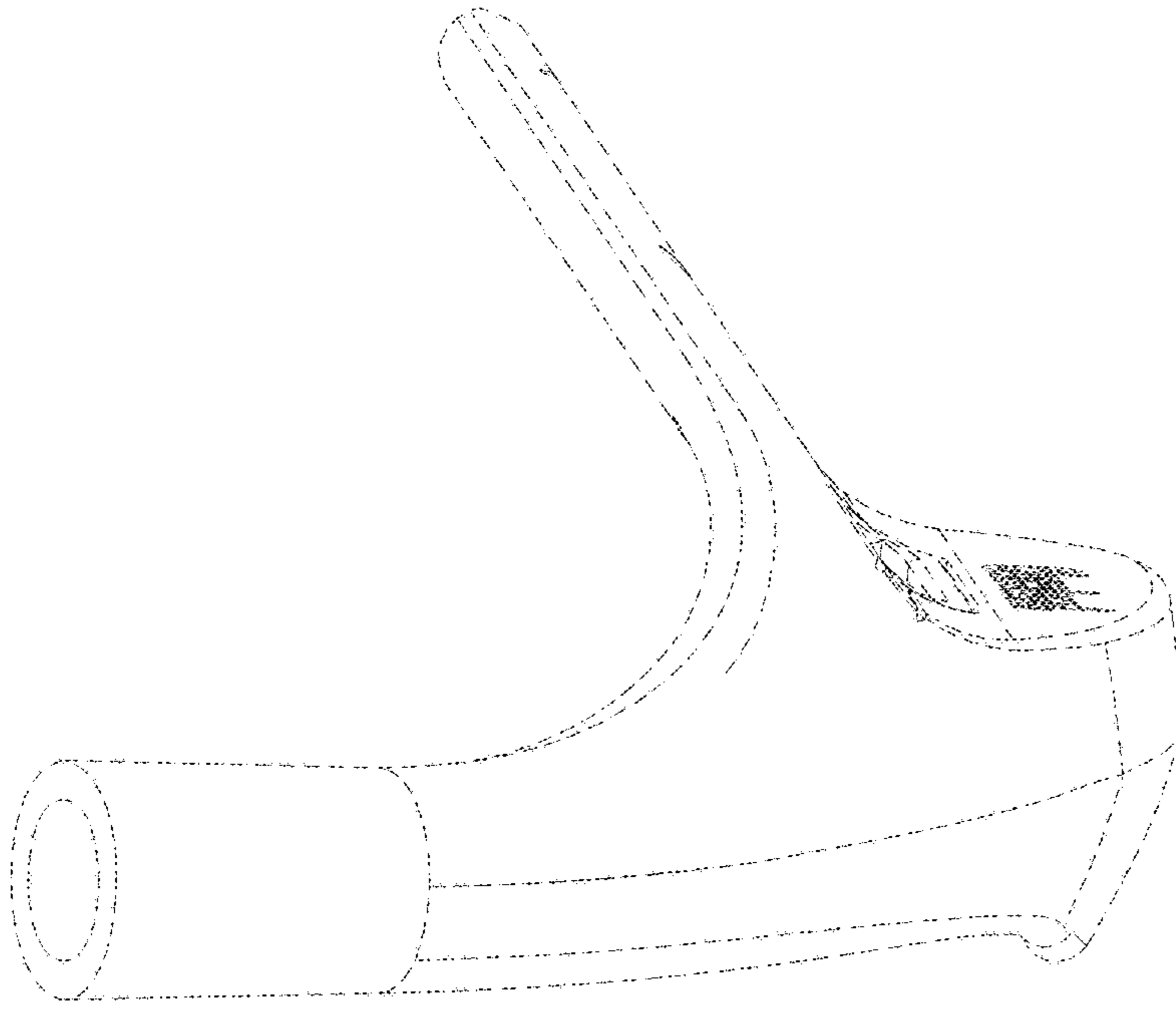

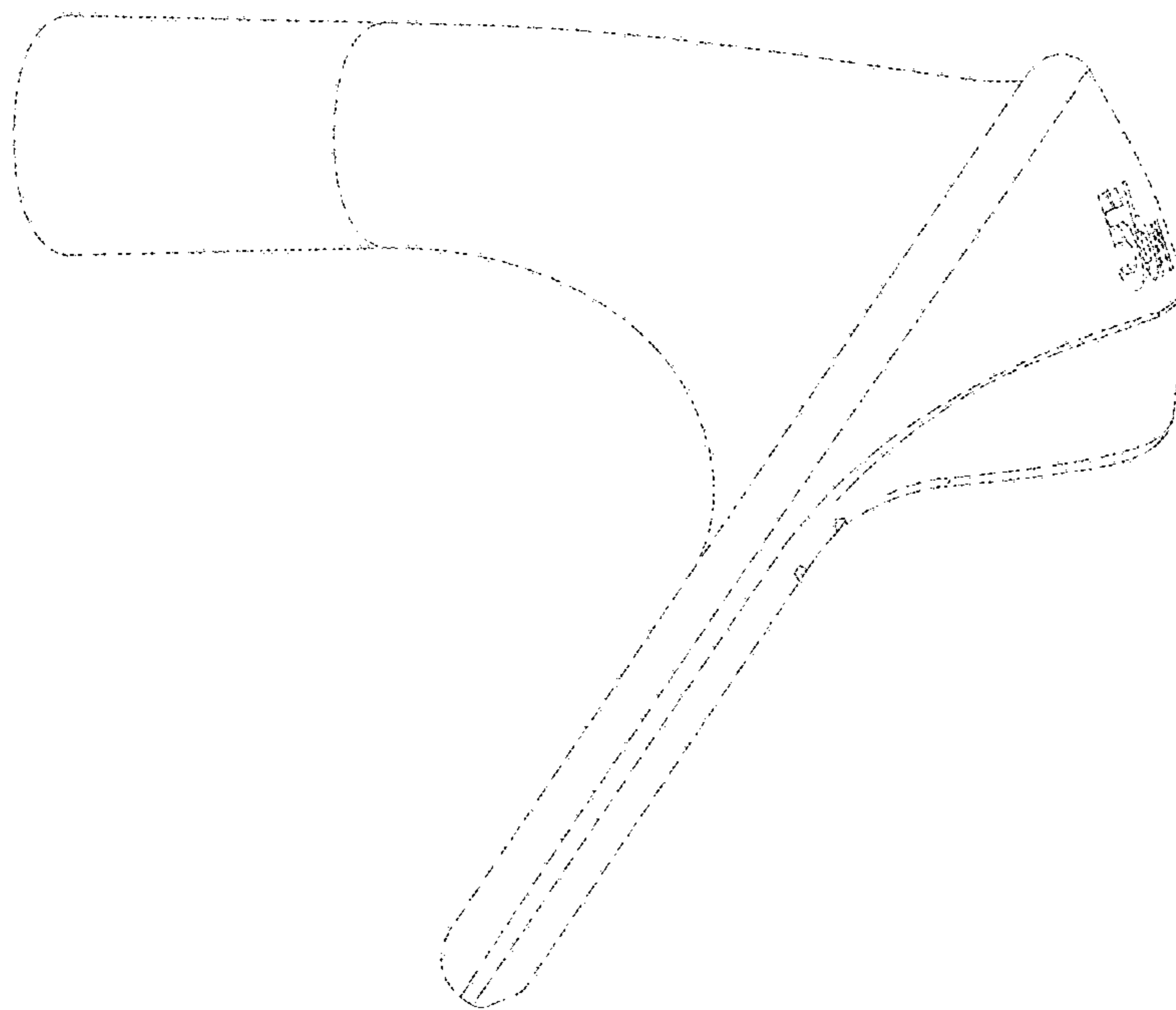

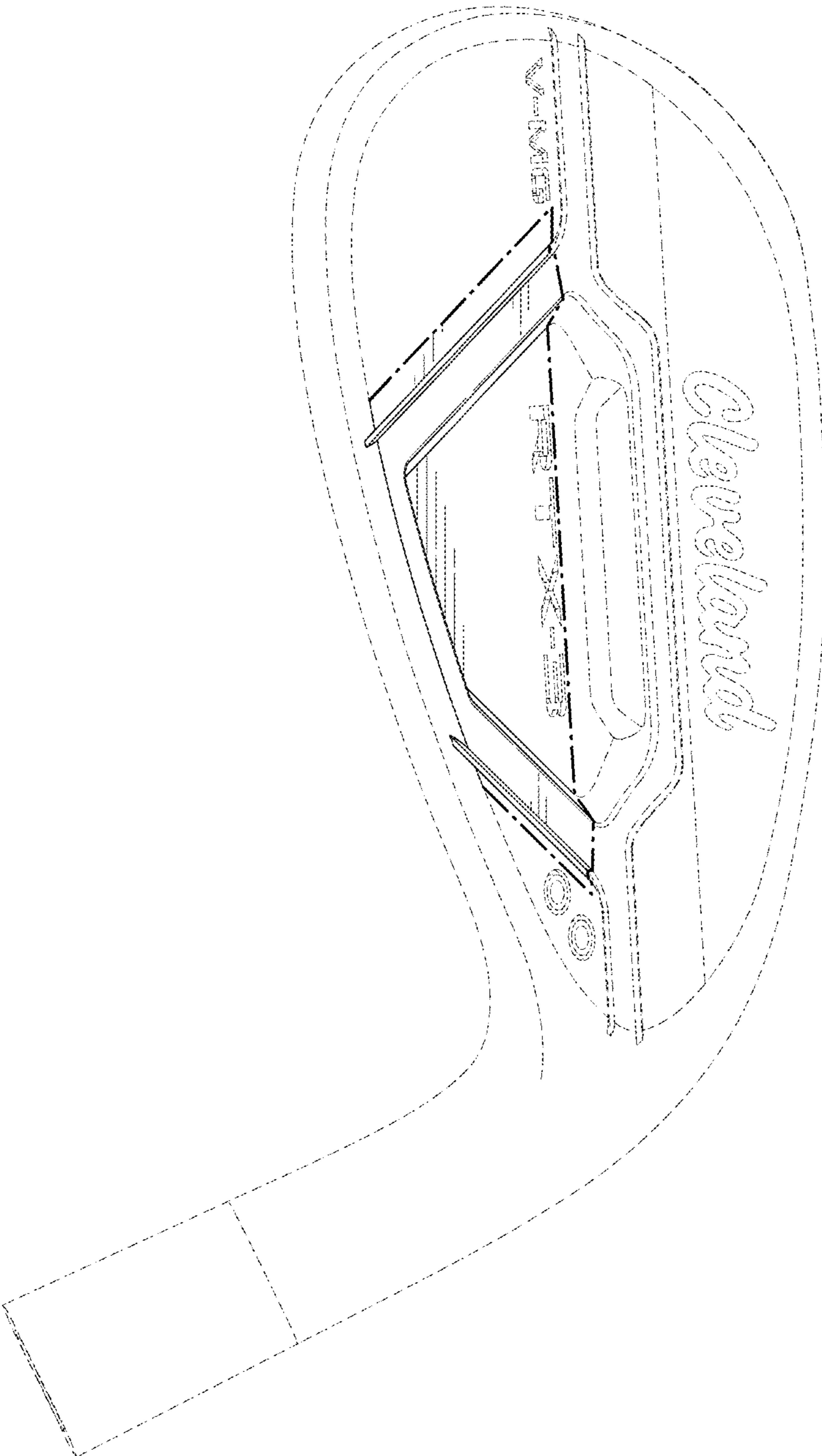

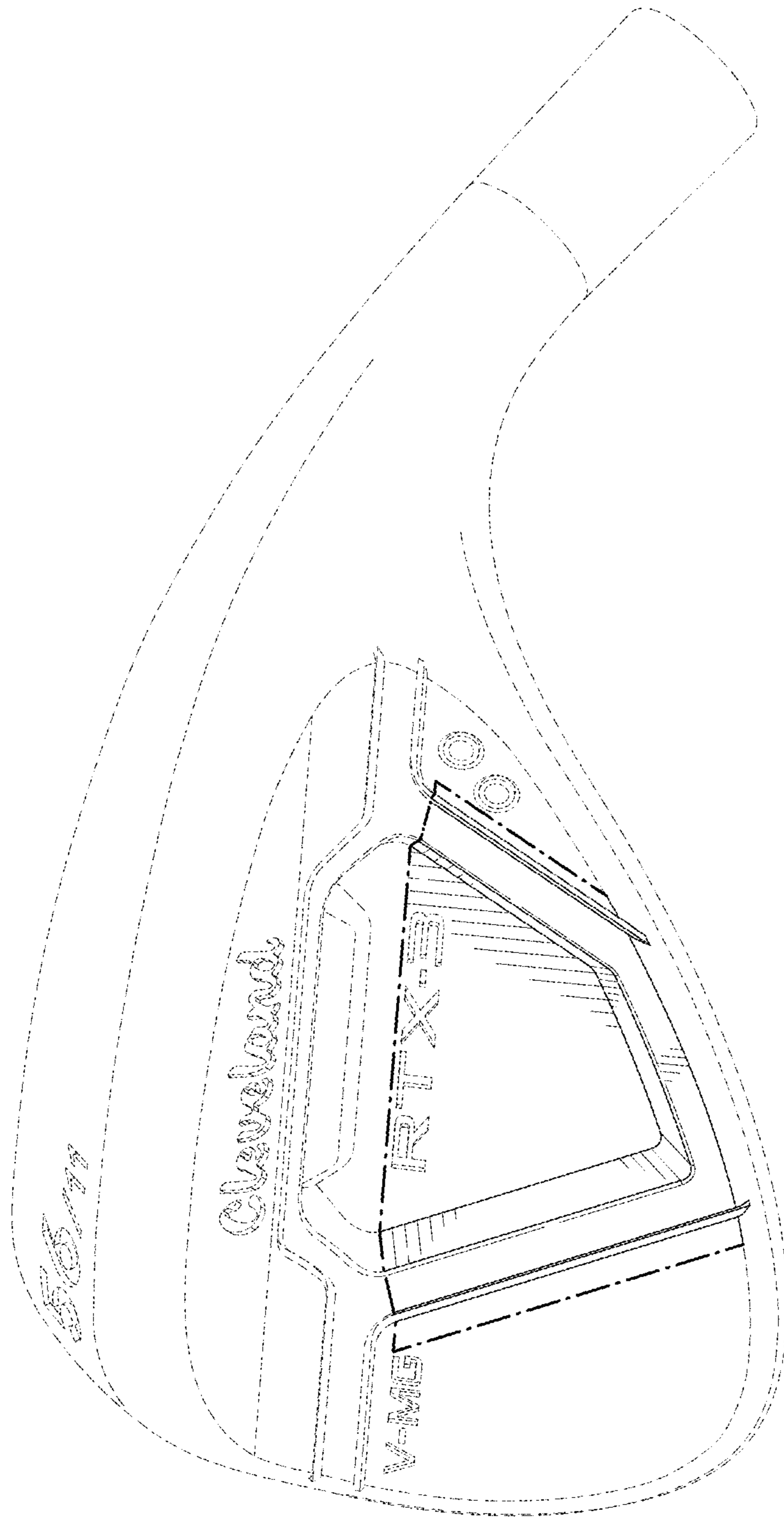
