FIG. 5 is a left elevation view thereof;

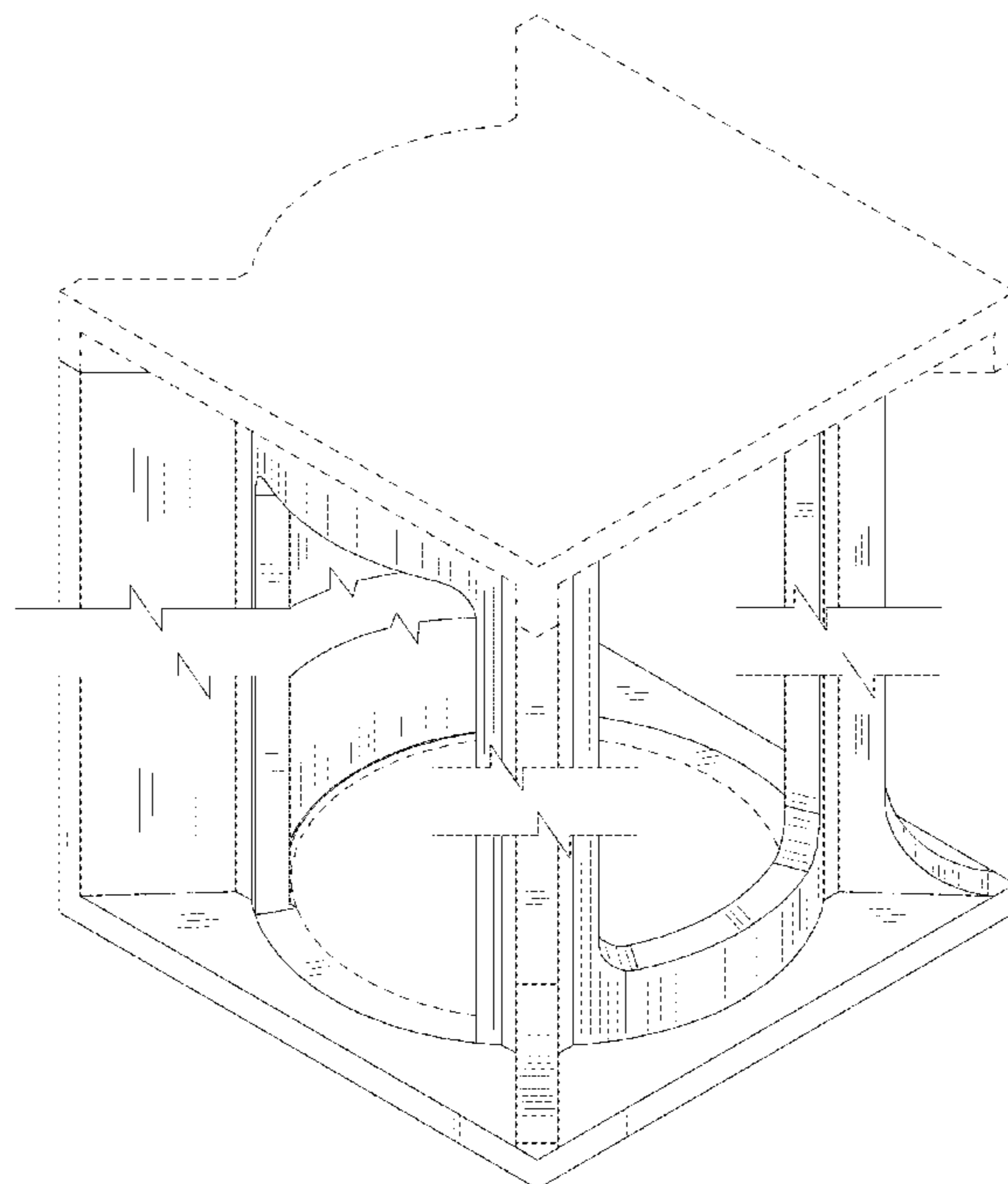
FIG. 6 is a front elevation view thereof; and,

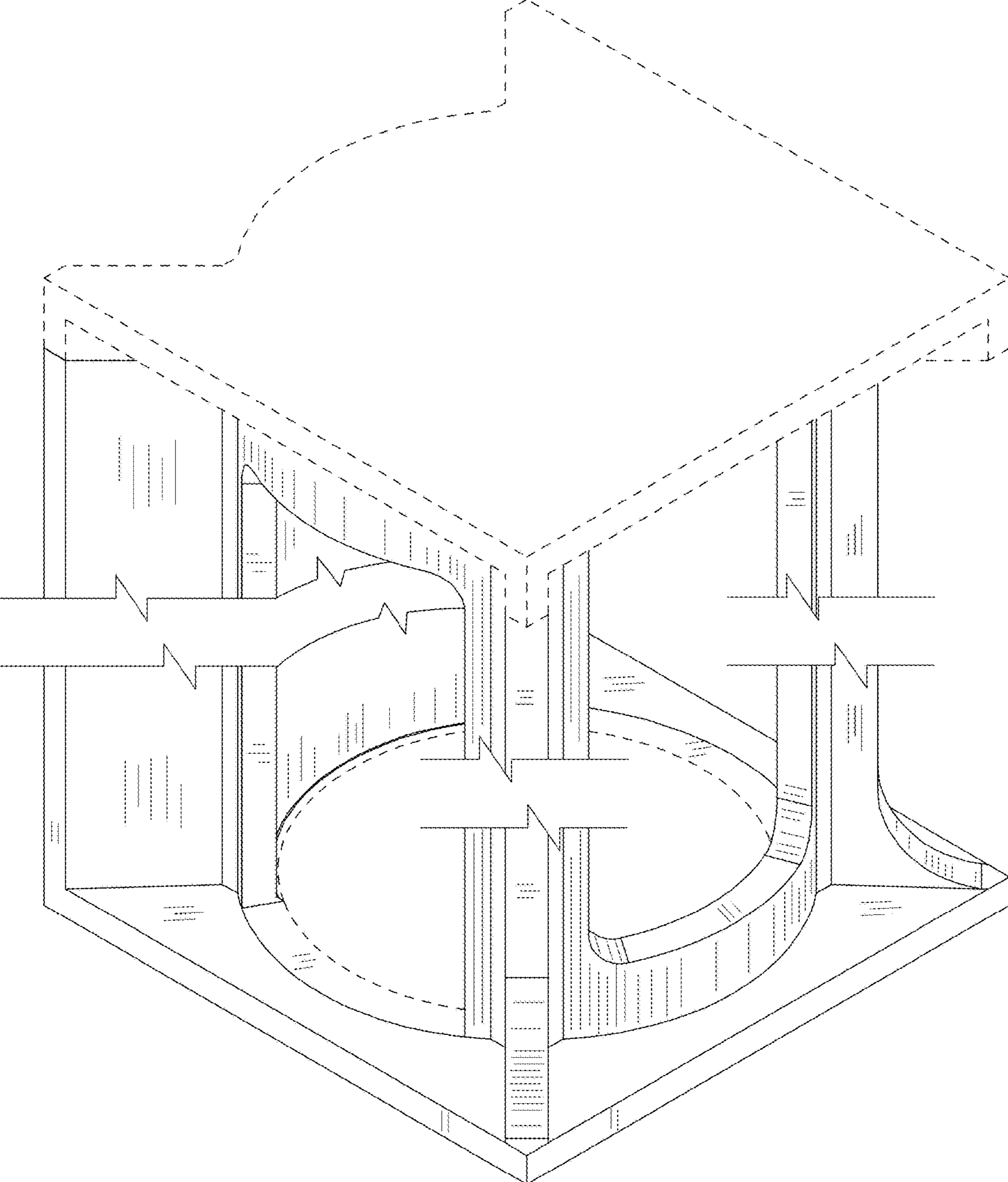

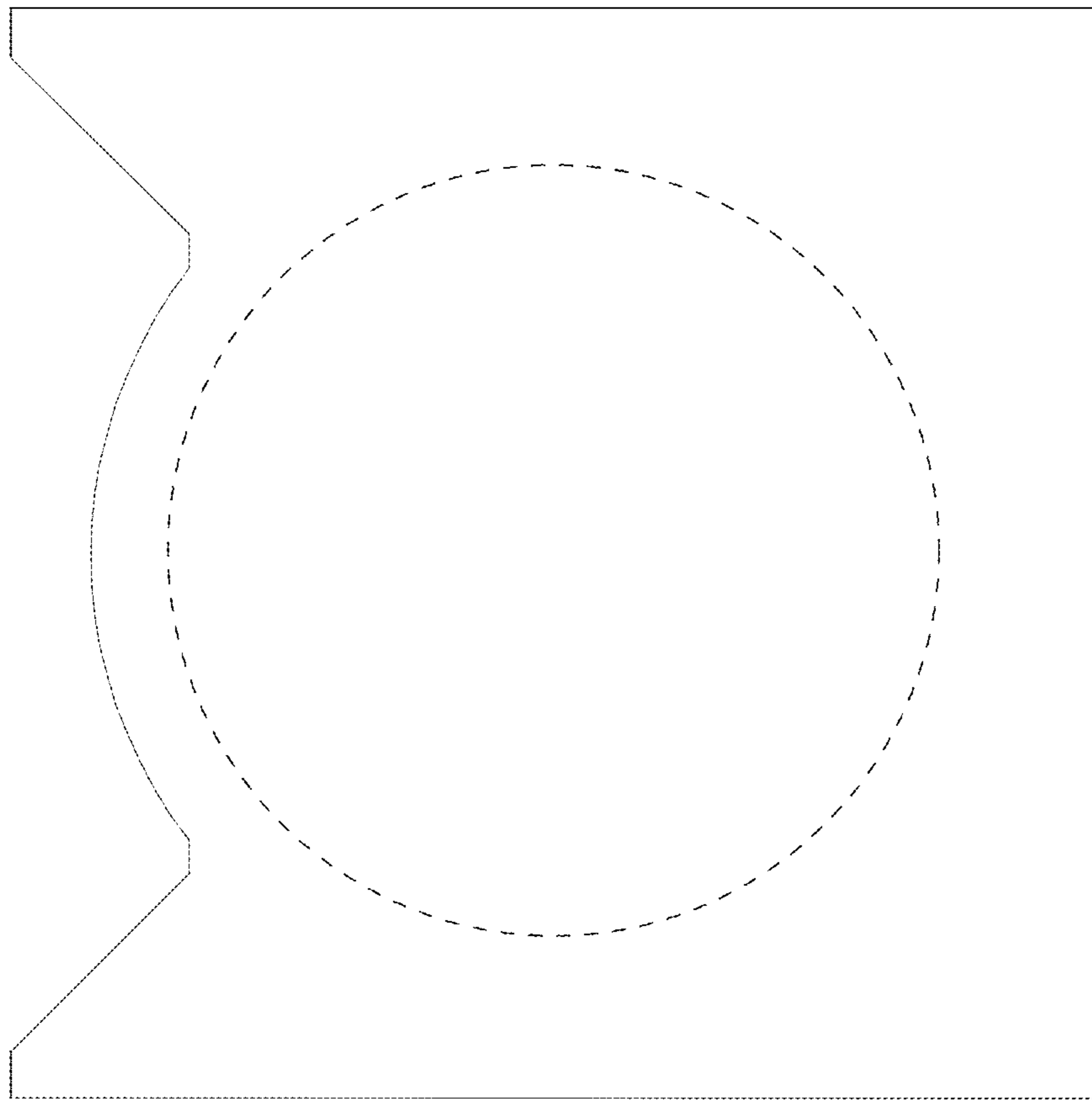

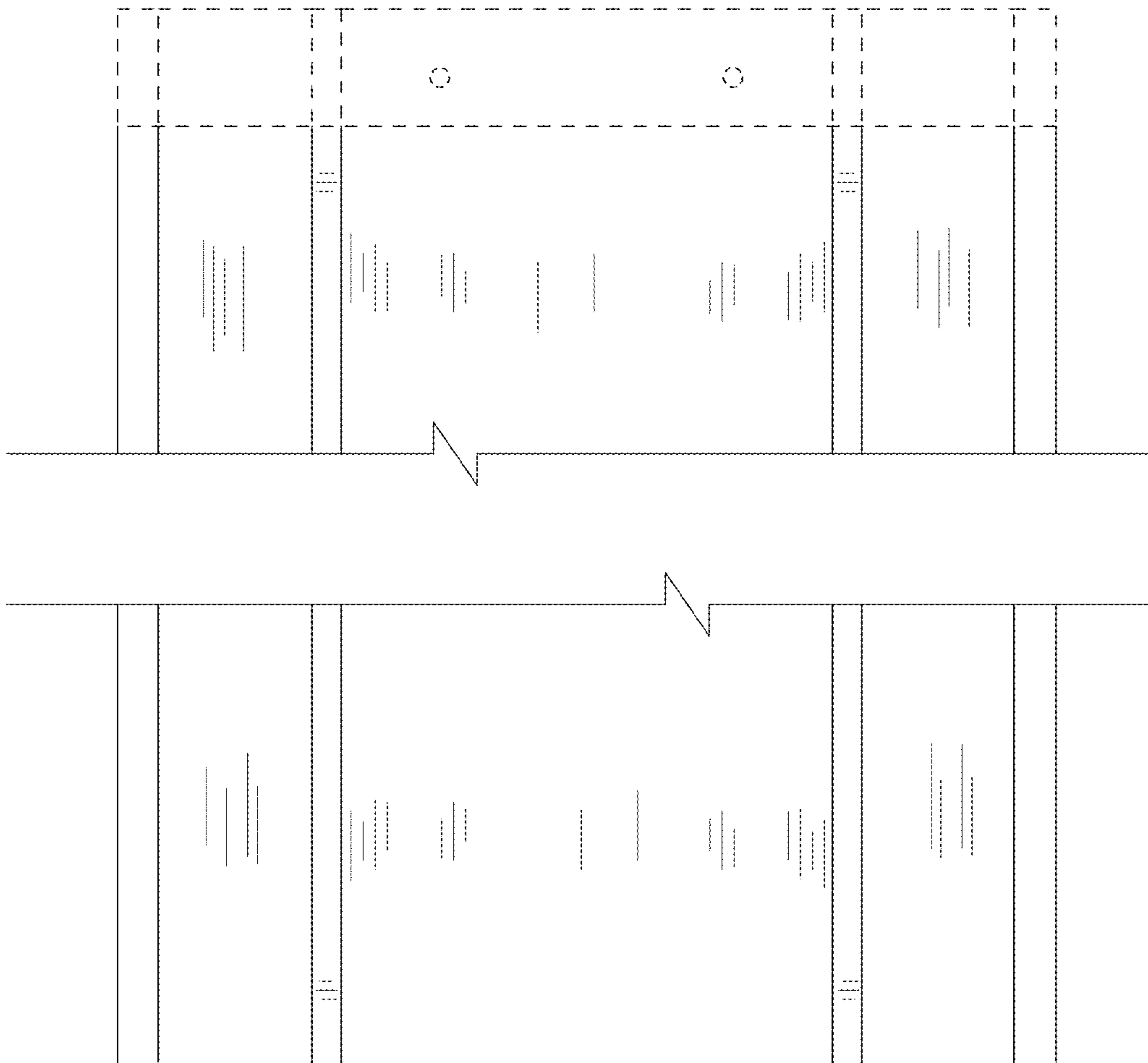

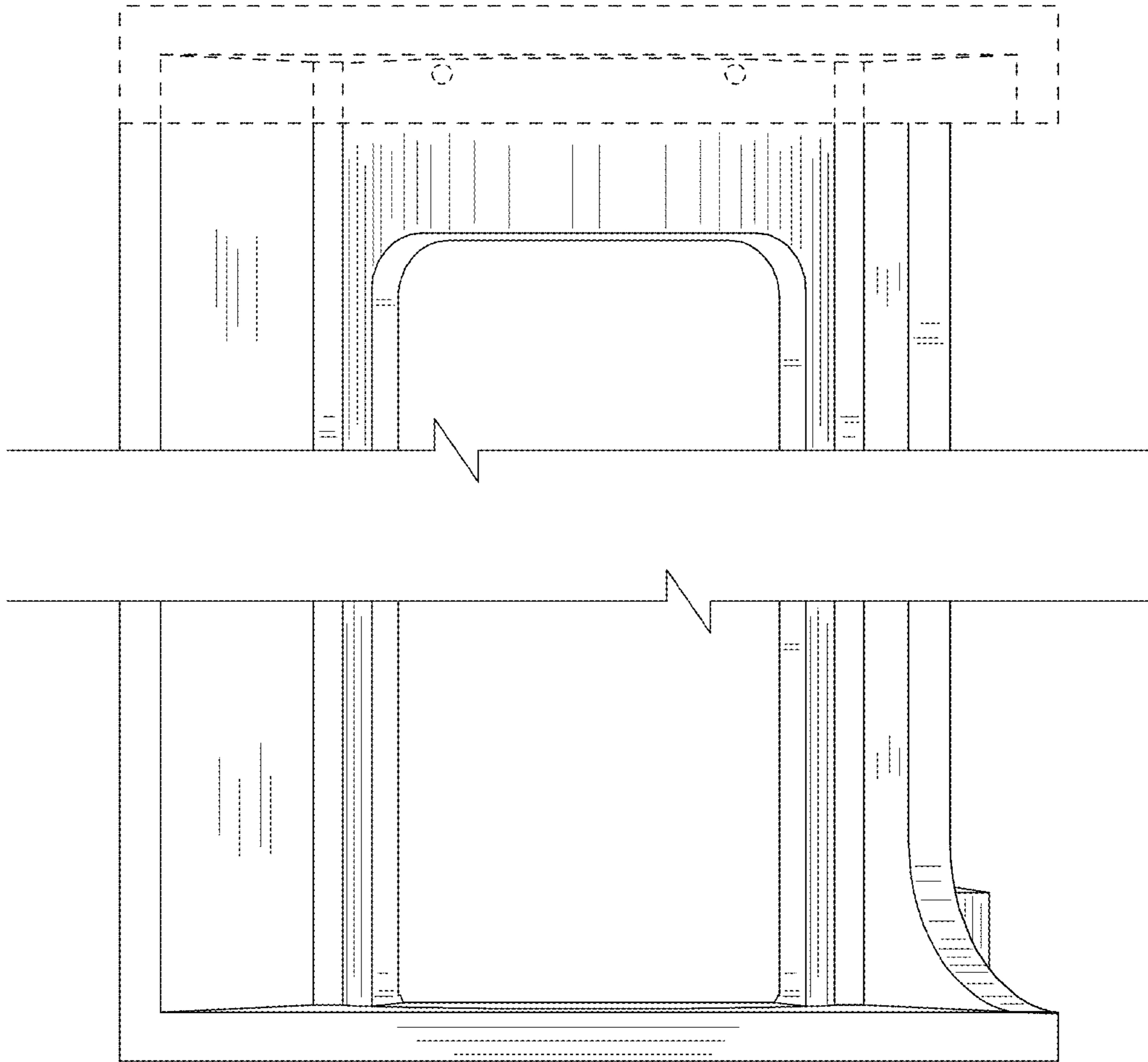

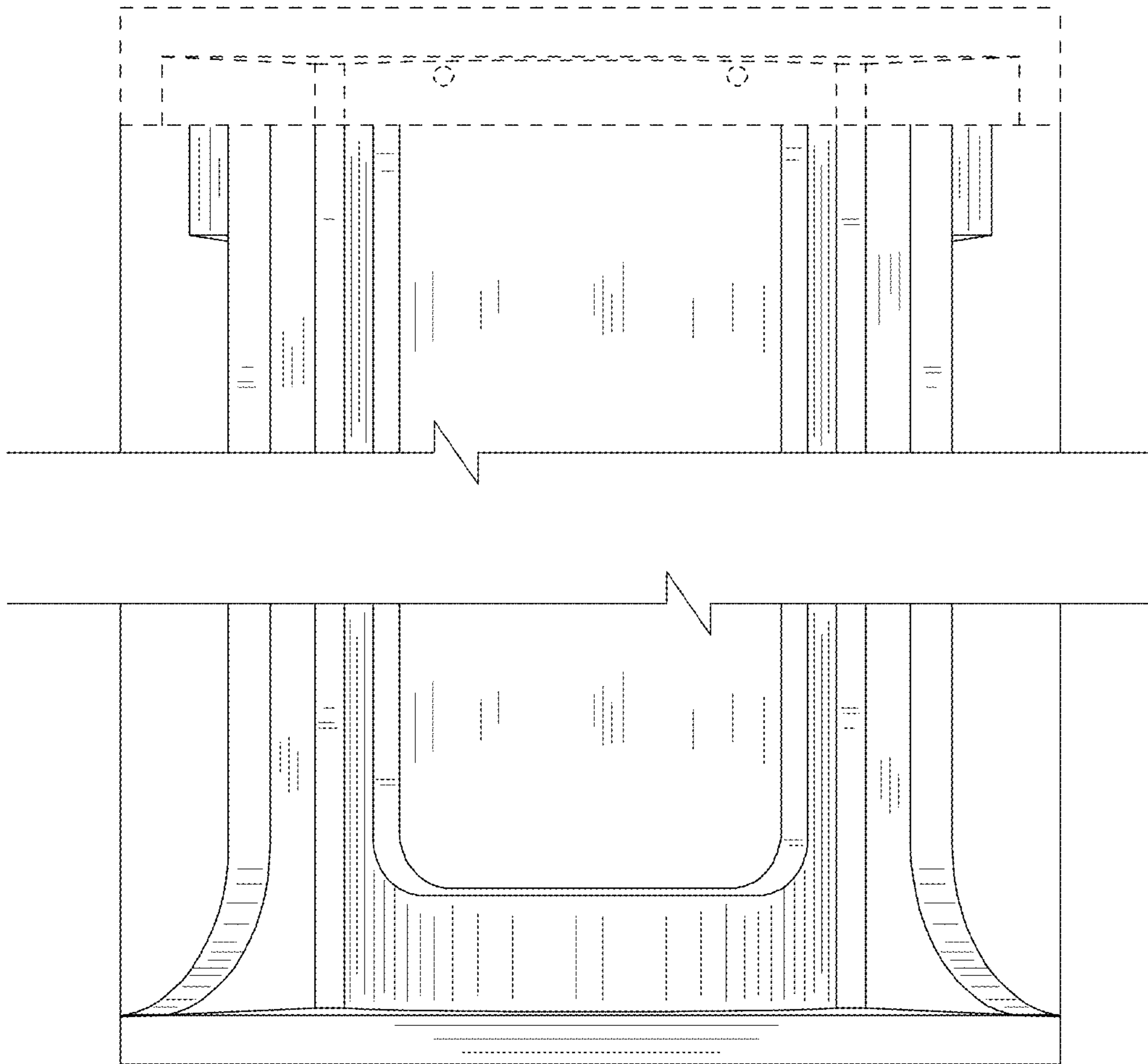

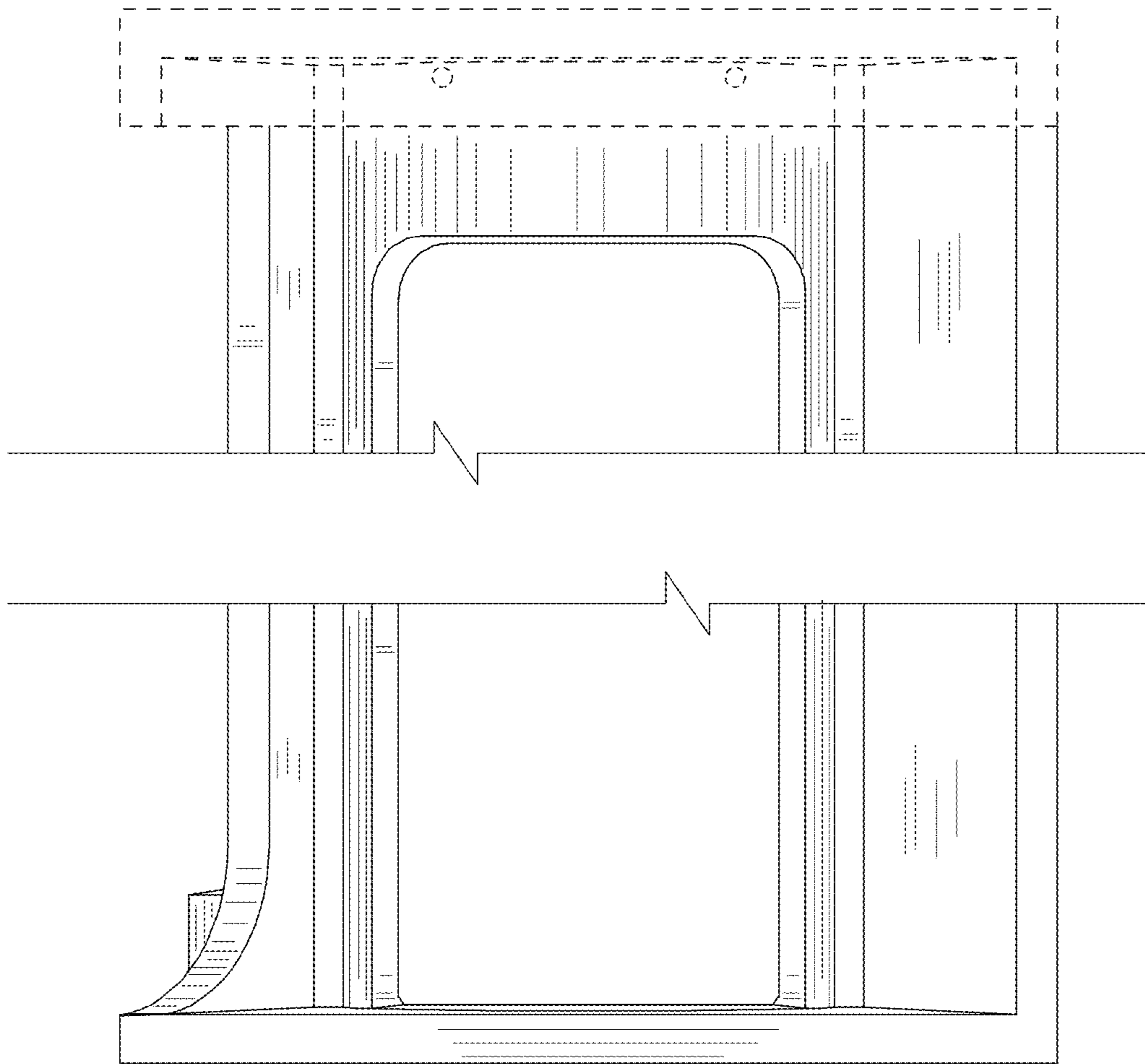
