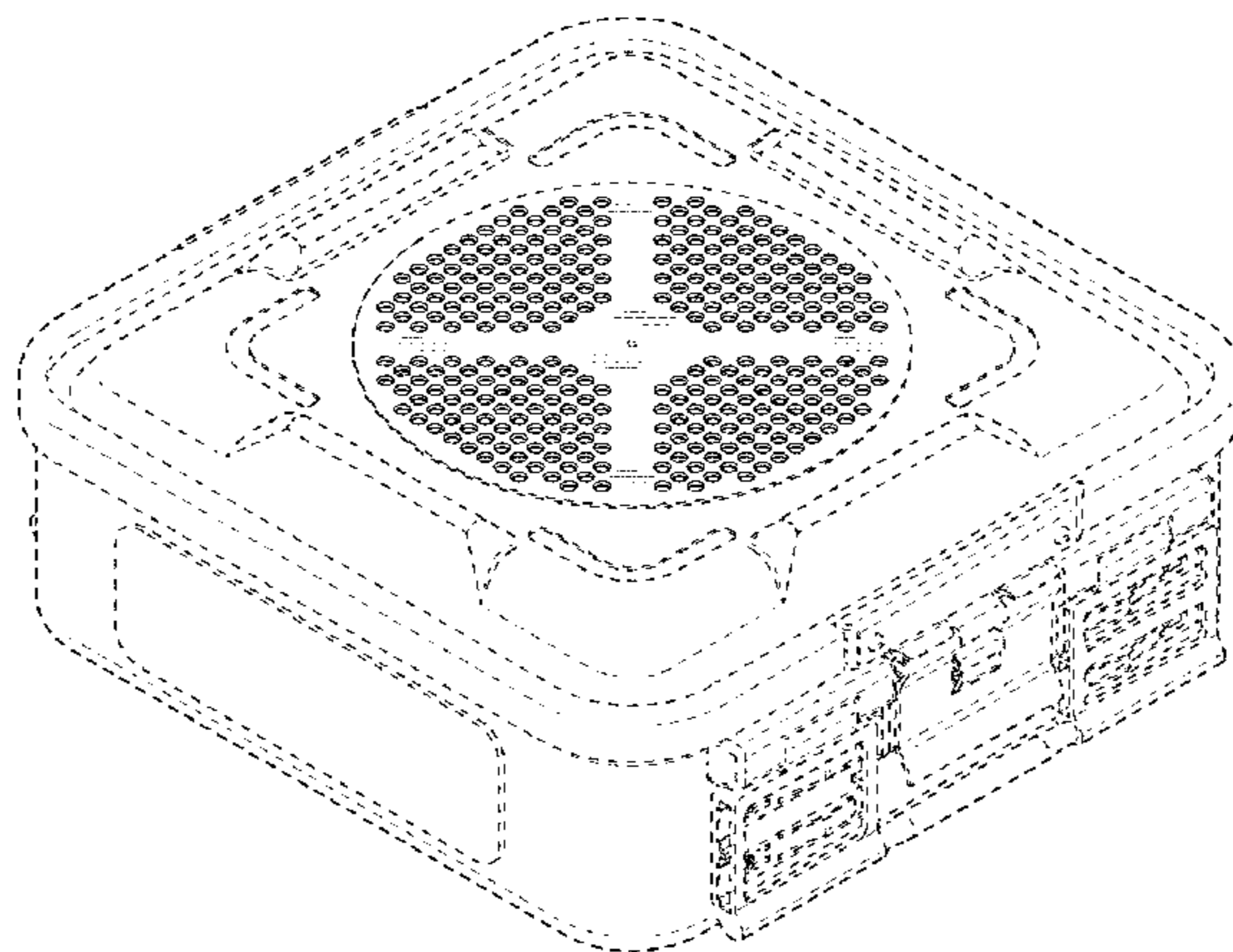
The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a container in accordance with my new design;

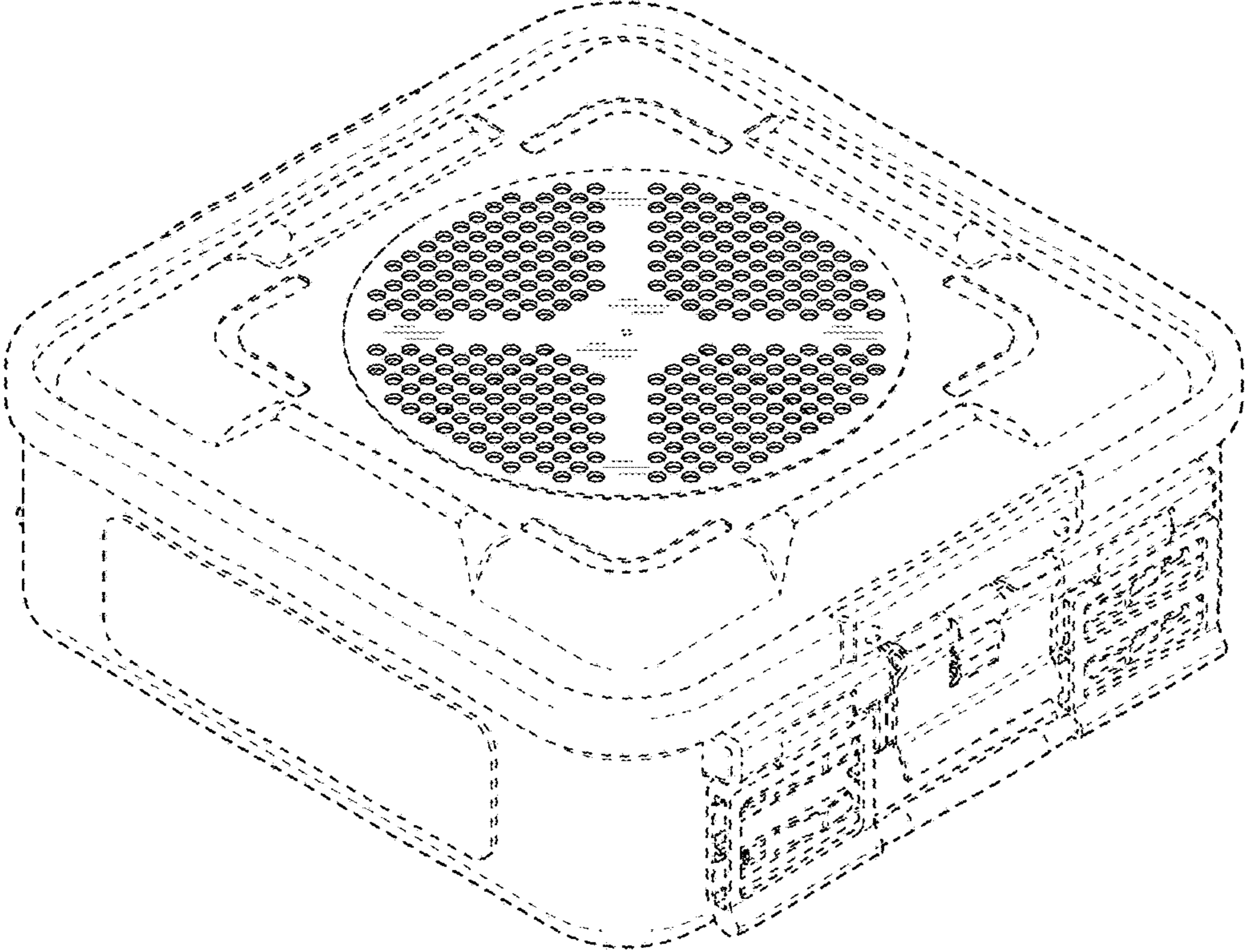

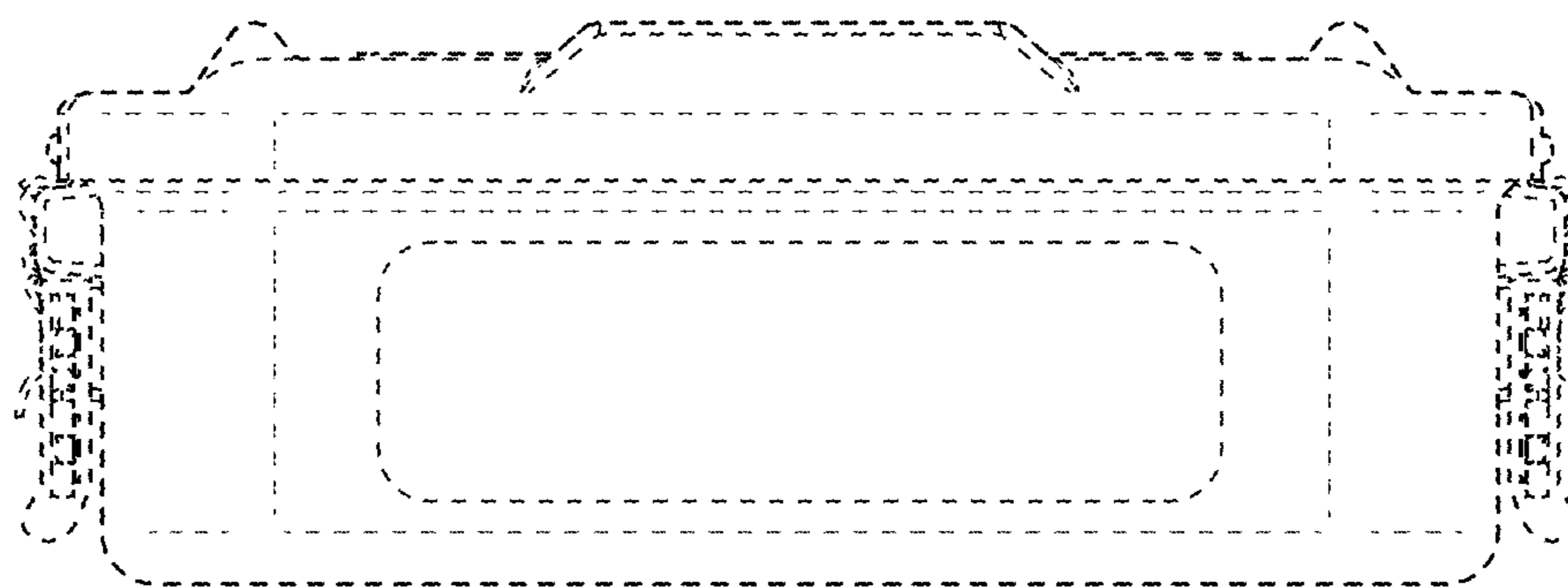

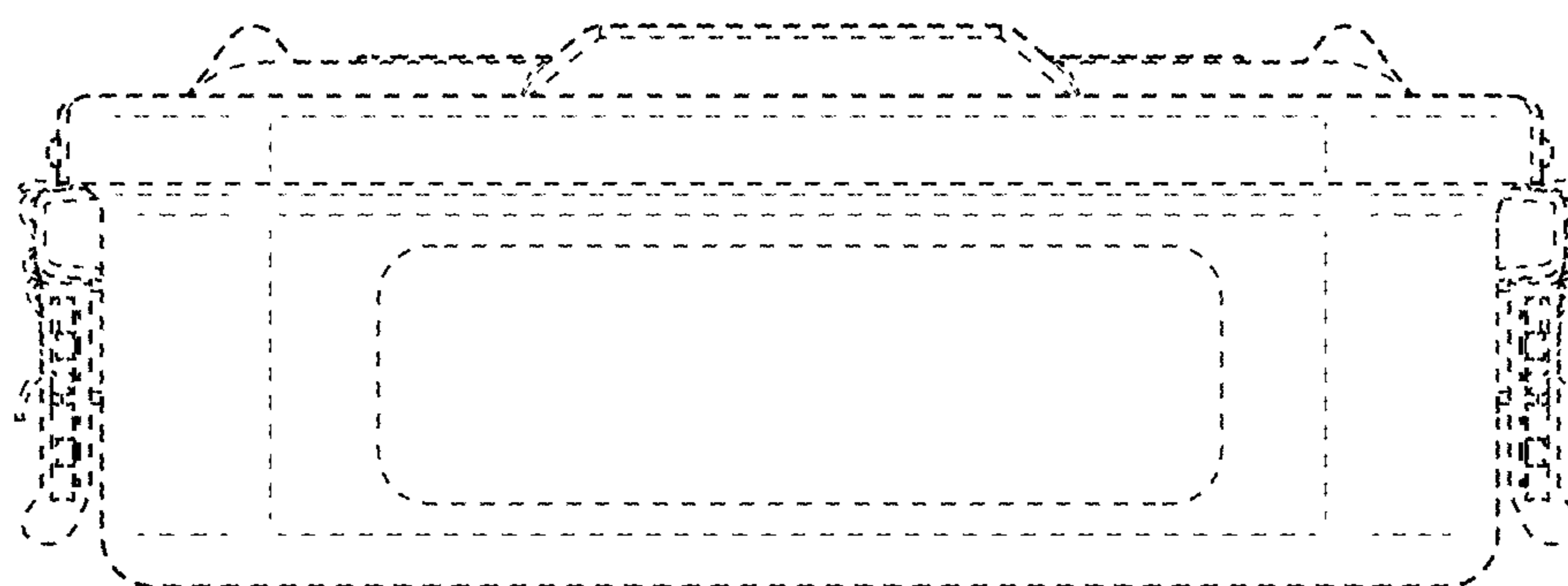

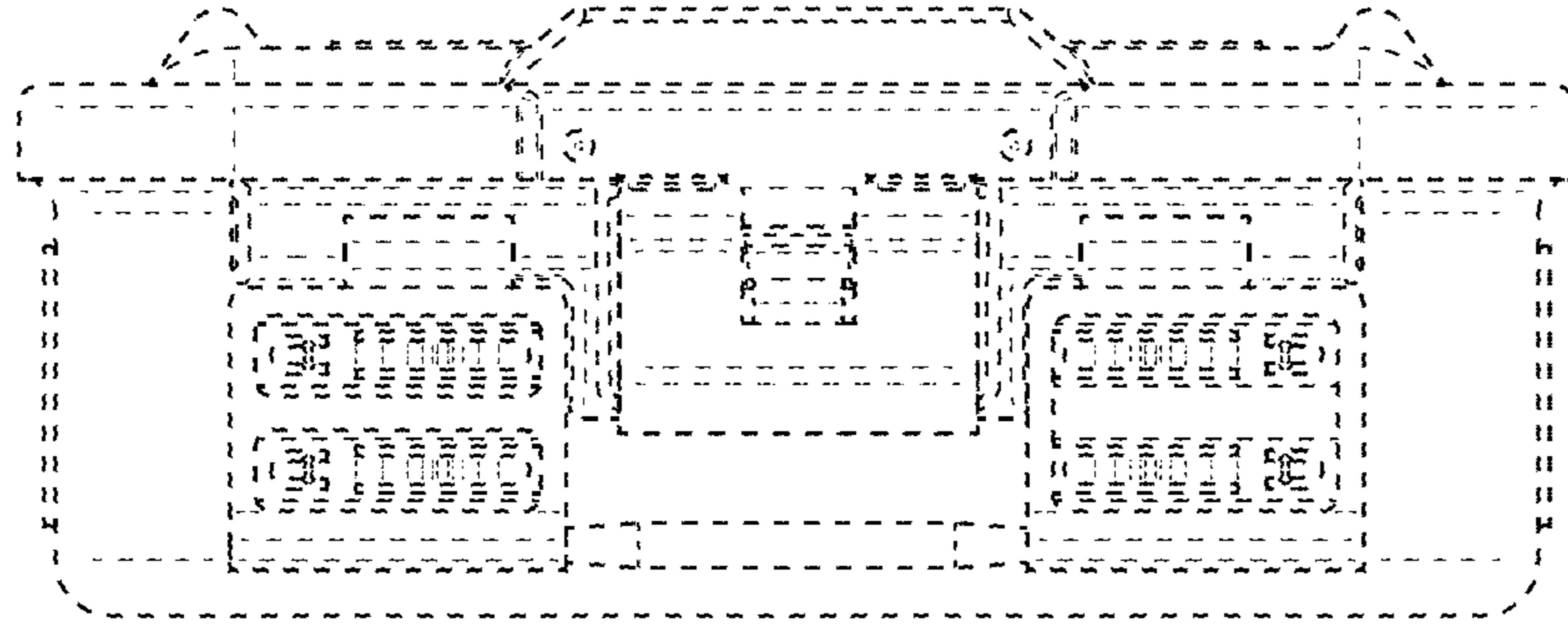

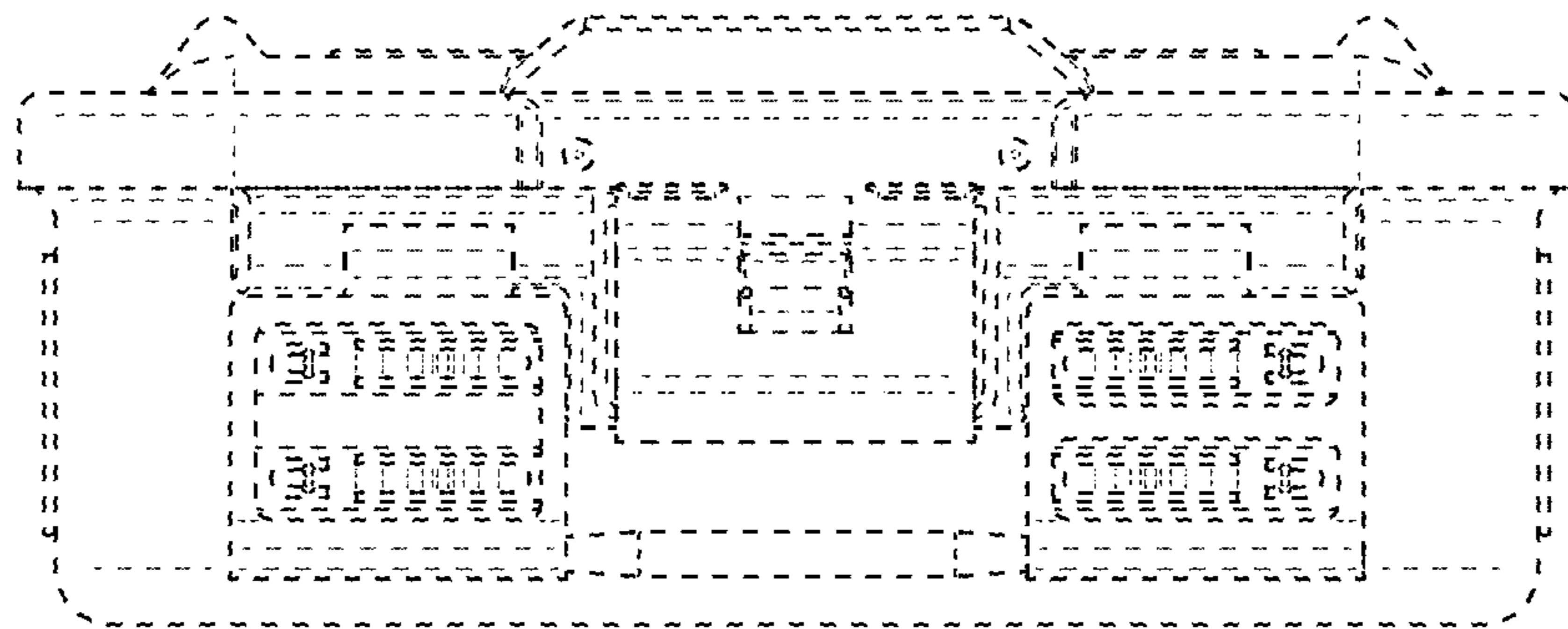

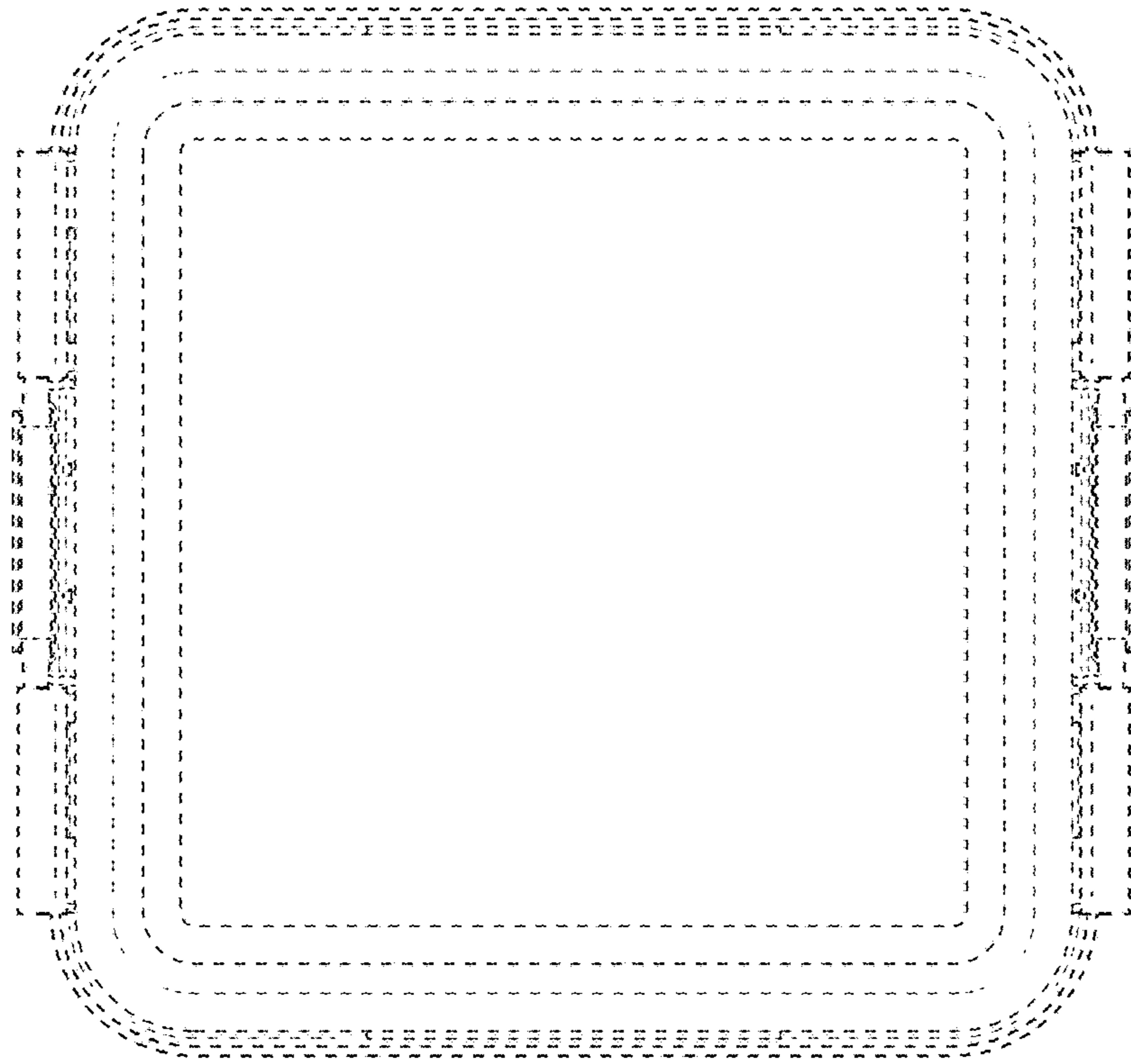

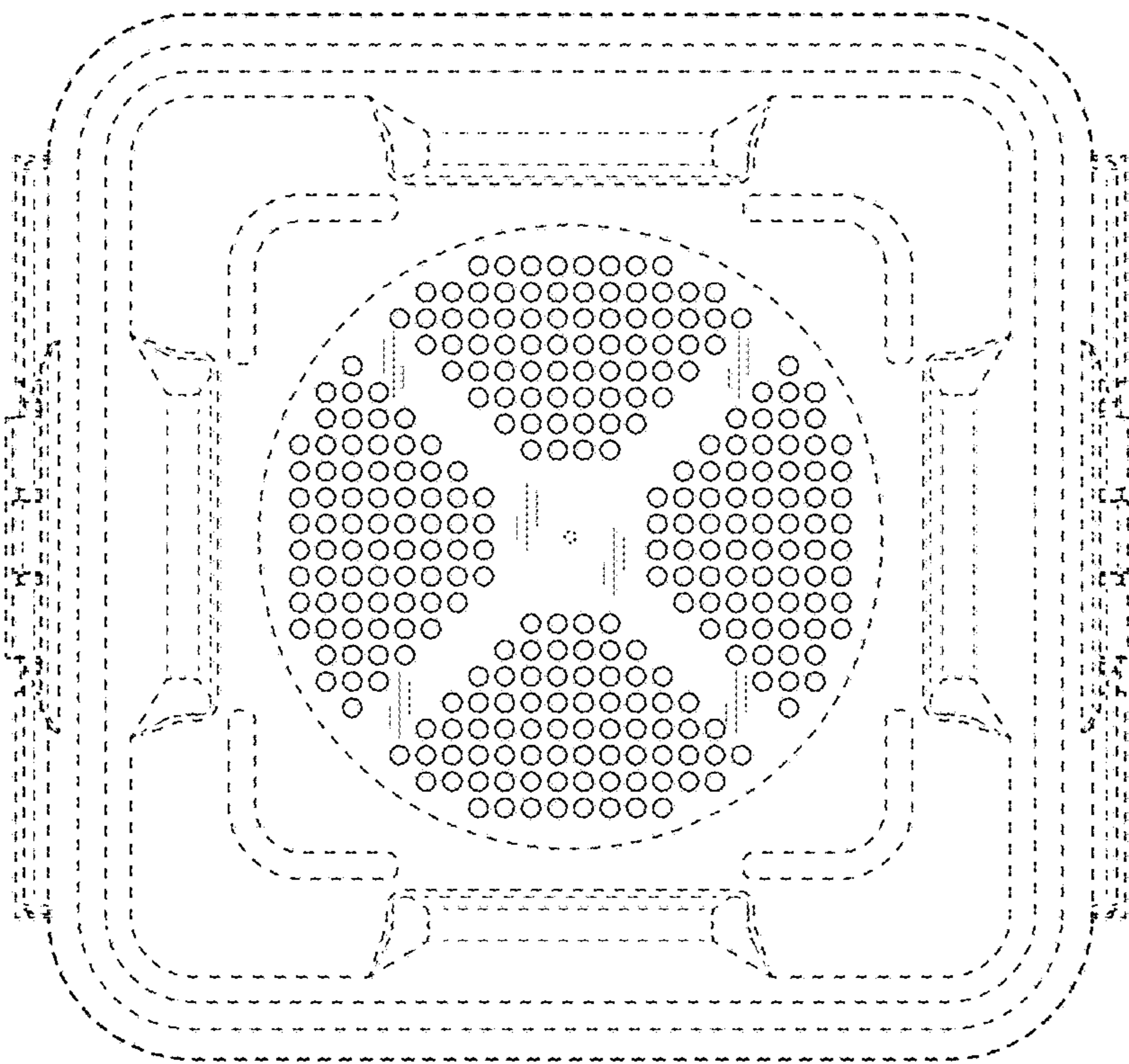
