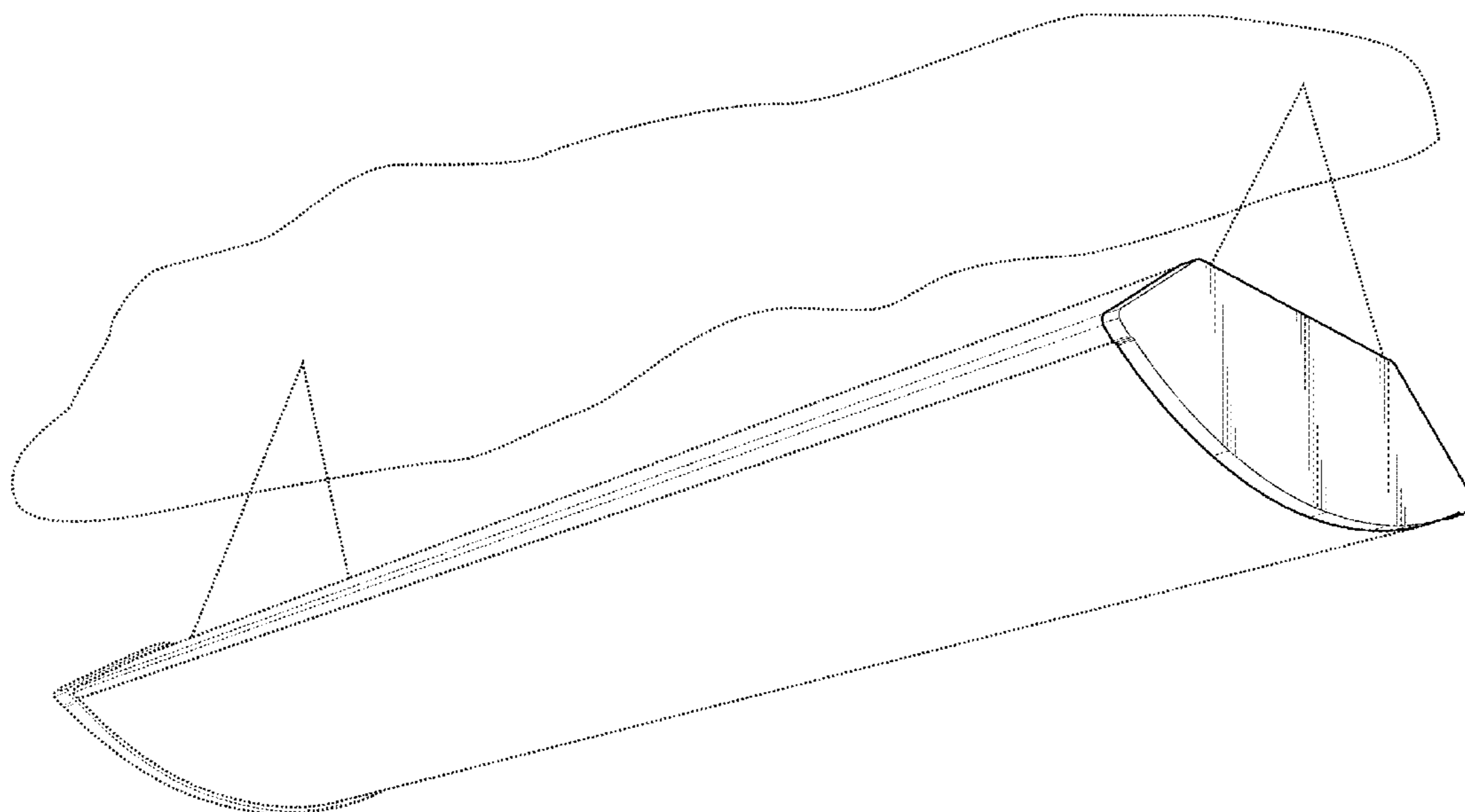
(57) **CLAIM**

We claim the ornamental design for a luminaire end cap, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a luminaire end cap embodying the new design.
FIG. 2 is a front elevation view of the end cap of FIG. 1.
FIG. 3 is a top plan view of the end cap of FIG. 1.
FIG. 4 is a side elevation view of the end cap of FIG. 1, taken from the left side.
FIG. 5 is a side elevation view of the end cap of FIG. 1, taken from the right side.
FIG. 6 is a bottom plan view of the end cap of FIG. 1; and, FIG. 7 is a rear elevation view of the end cap of FIG. 1.
Any structure illustrated in broken lines is environmental in nature and forms no part of the claimed design.

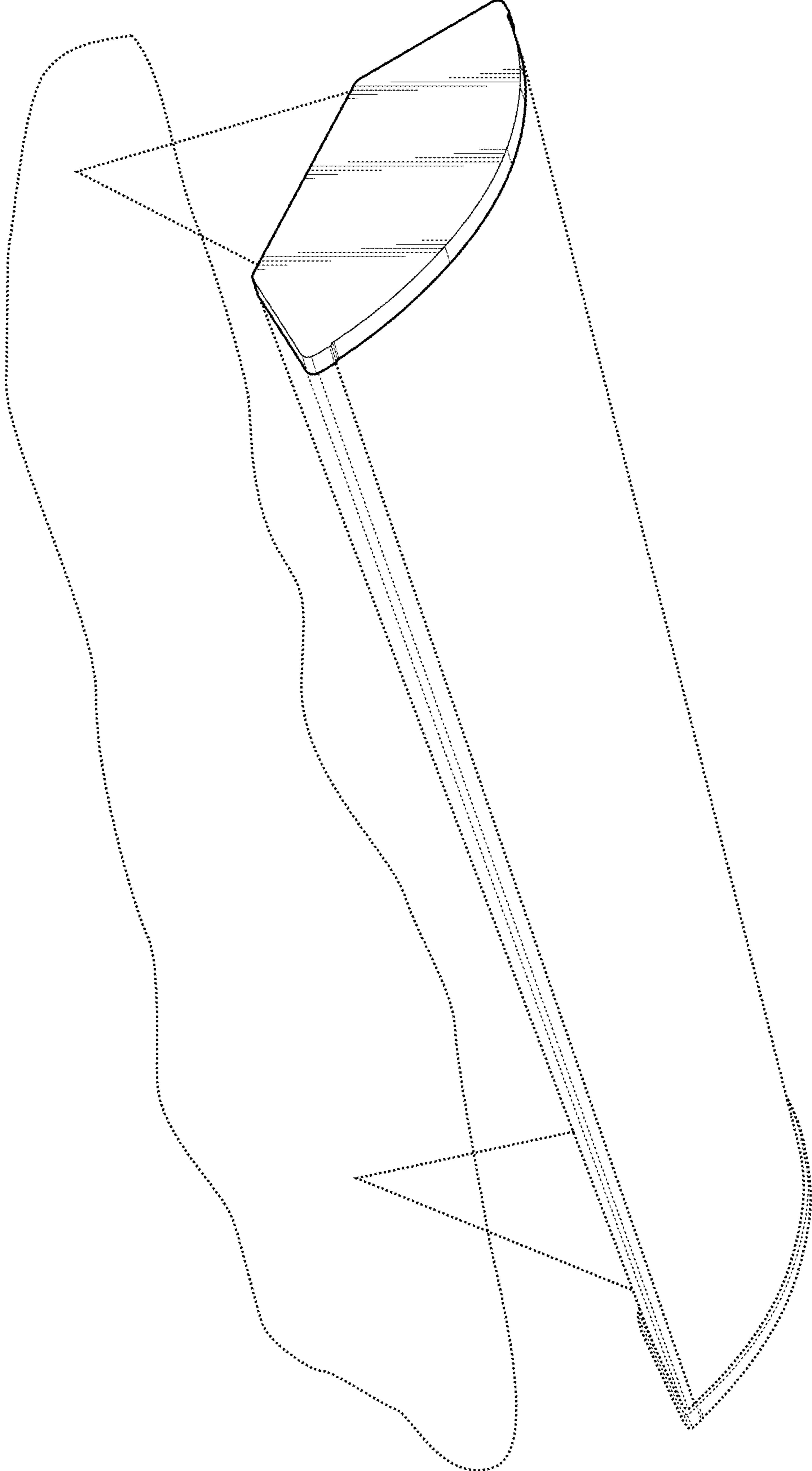

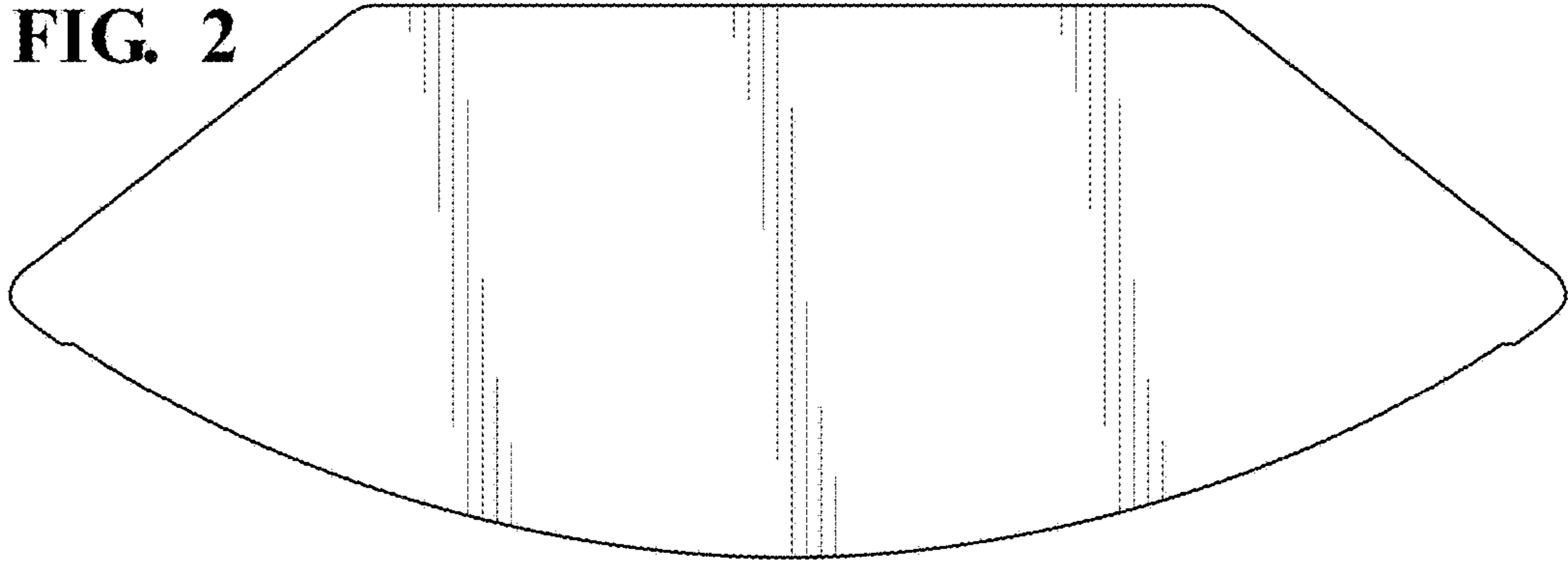

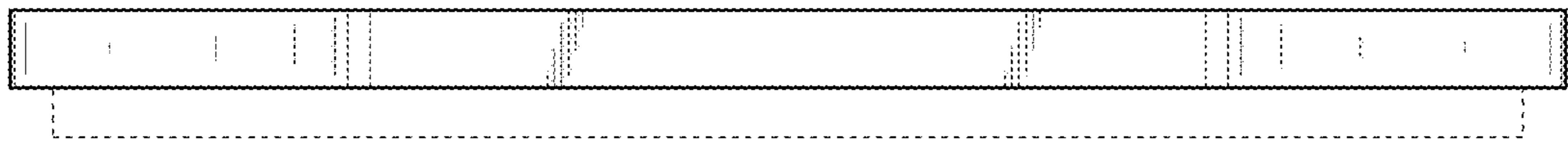

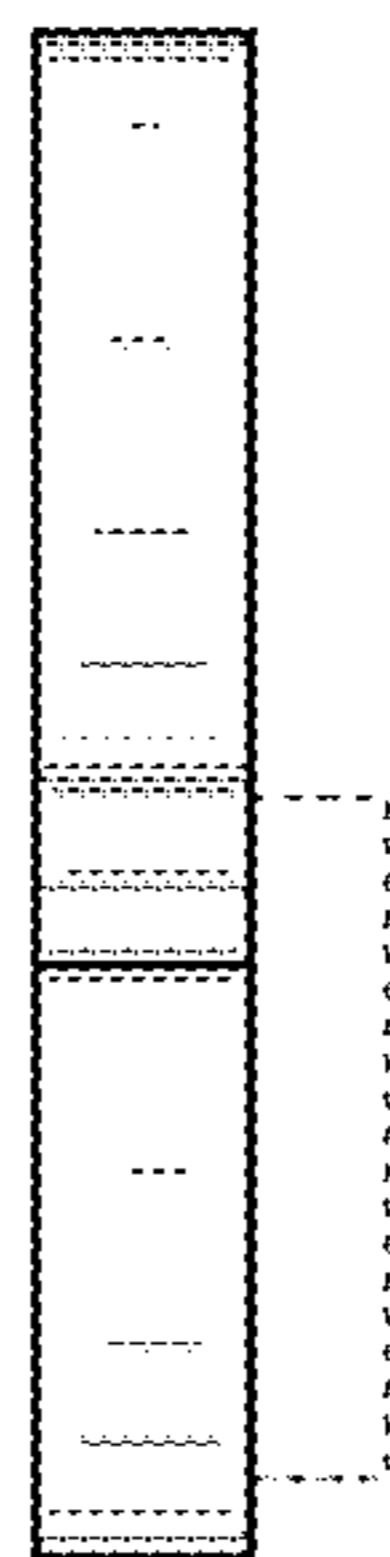

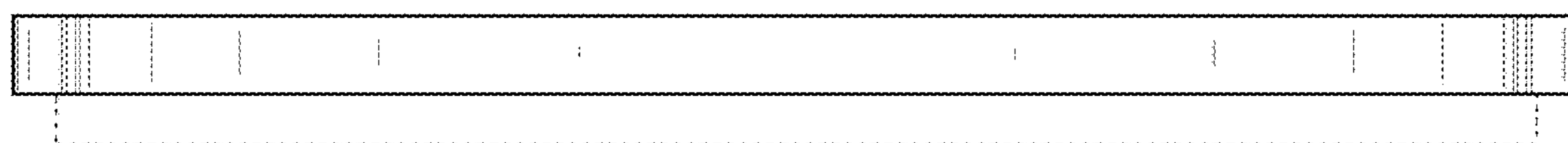

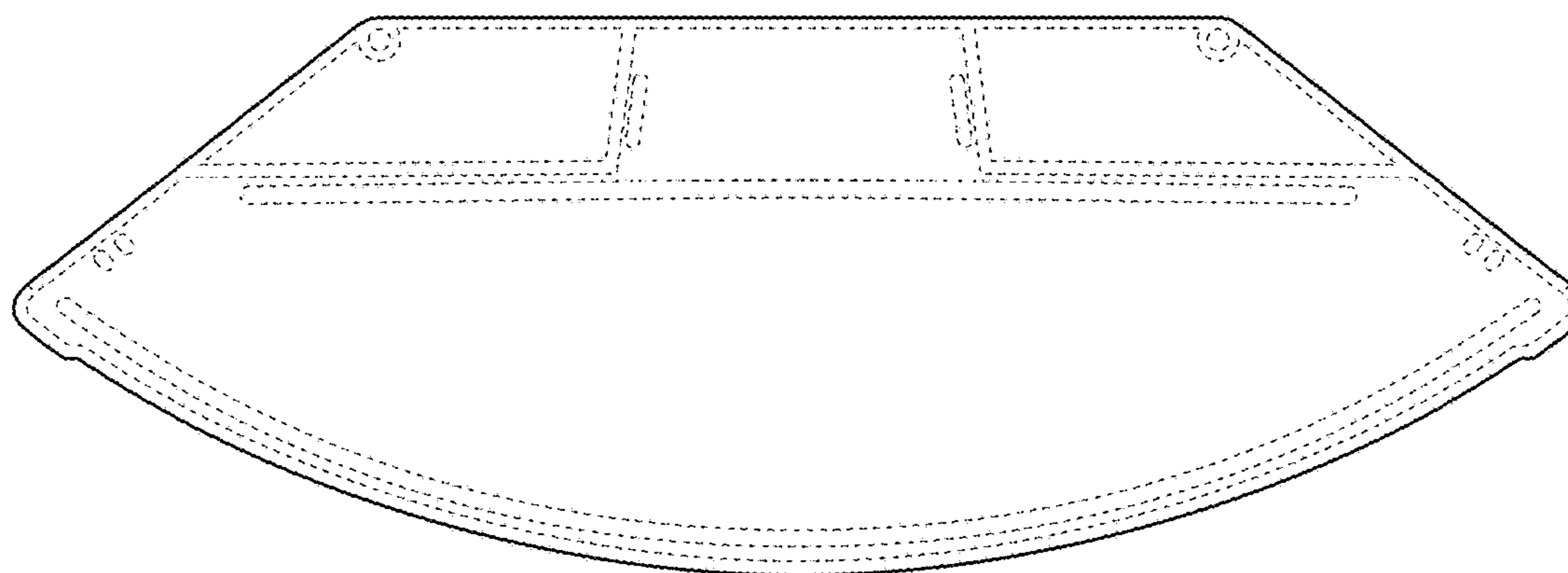
