(57) **CLAIM**

The ornamental design for a pair of boots for pet, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a pair of boots for pet, showing our new design;

FIG. 2 is a bottom plan view thereof;

FIG. 3 is a bottom plan view thereof, with the securing straps disengaged and extended for clarity of disclosure;

FIG. 4 is a right side elevational view of the right boot thereof, shown removed from the pair of boots for pet for clarity of disclosure;

FIG. 5 is a left side elevational view of the left boot thereof, shown removed from the pair of boots for pet for clarity of disclosure;

FIG. 6 is a front elevational view of the left boot thereof, shown removed from the pair of boots for pet for clarity of disclosure; and,

FIG. 7 is a bottom plan view of the right boot thereof, shown removed from the pair of boots for pet for clarity of disclosure and with the securing strap unfastened.

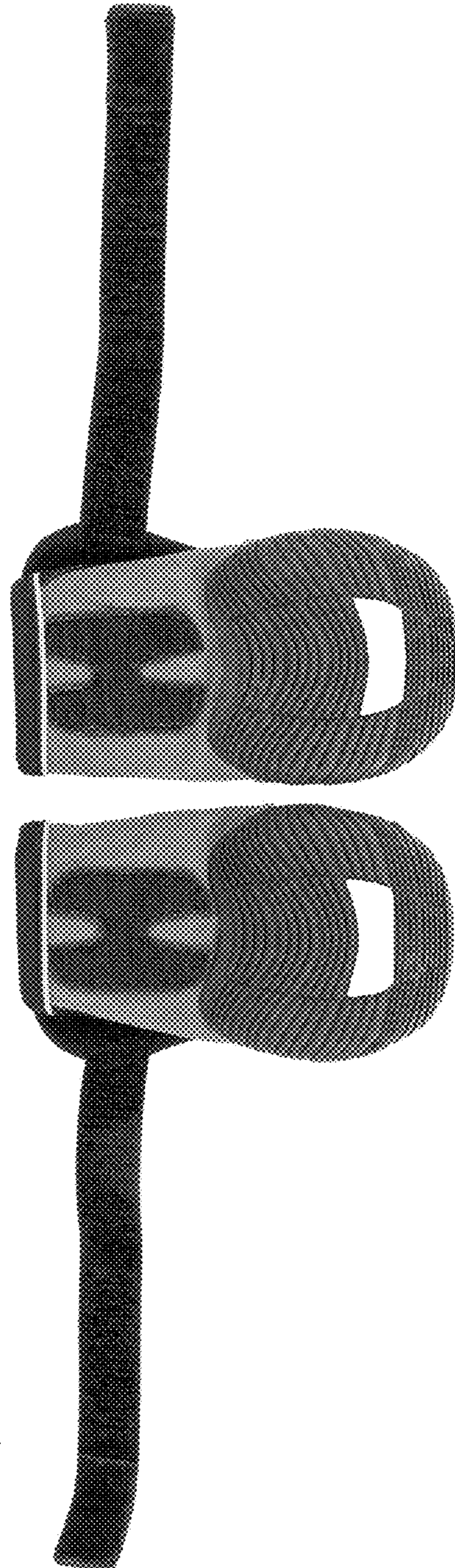

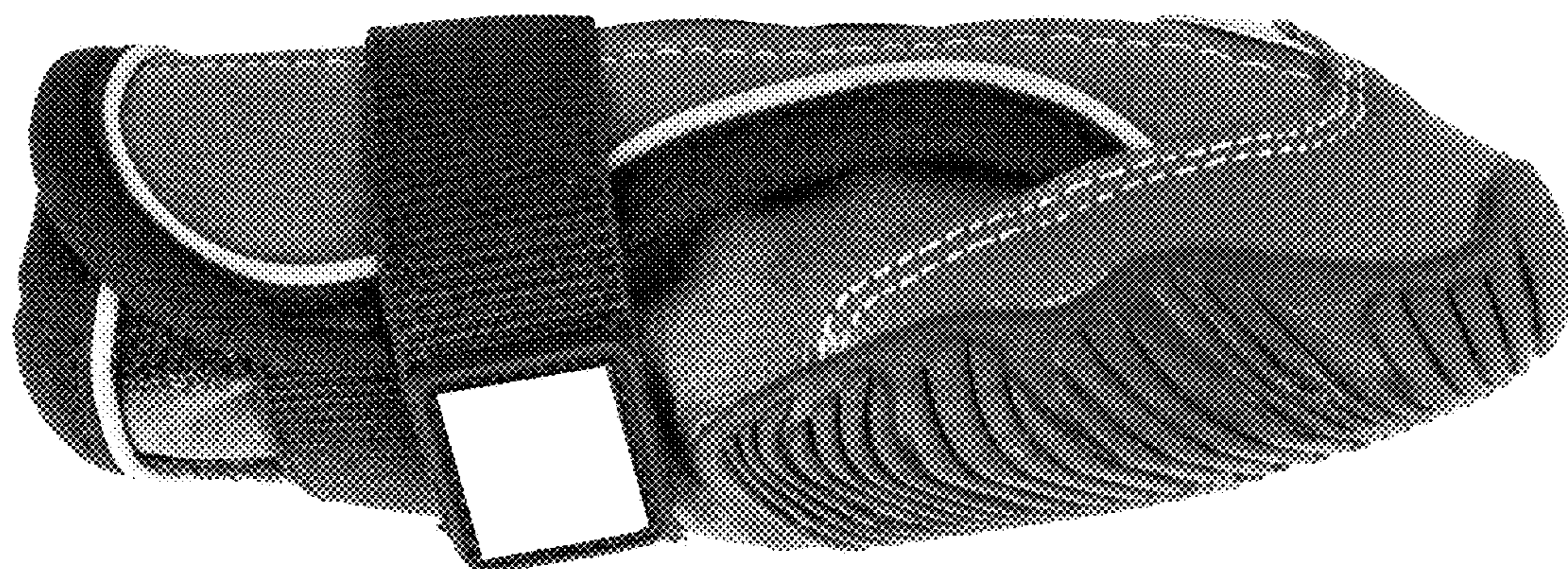

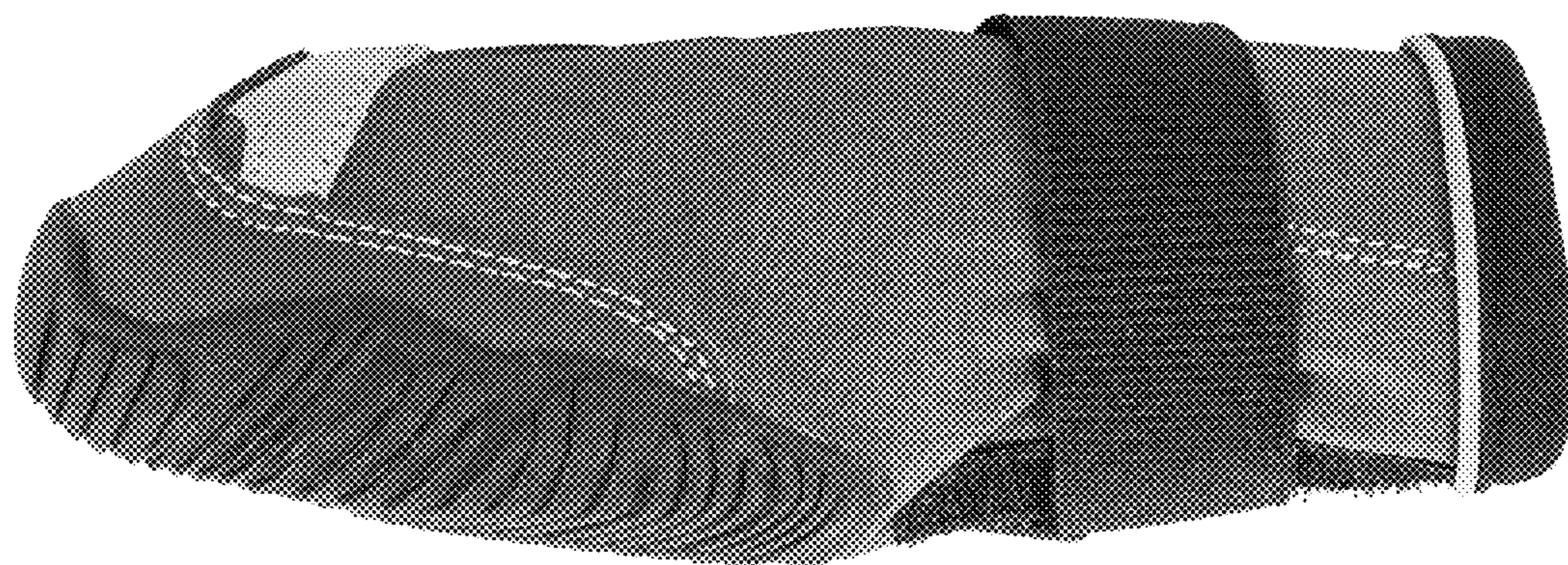

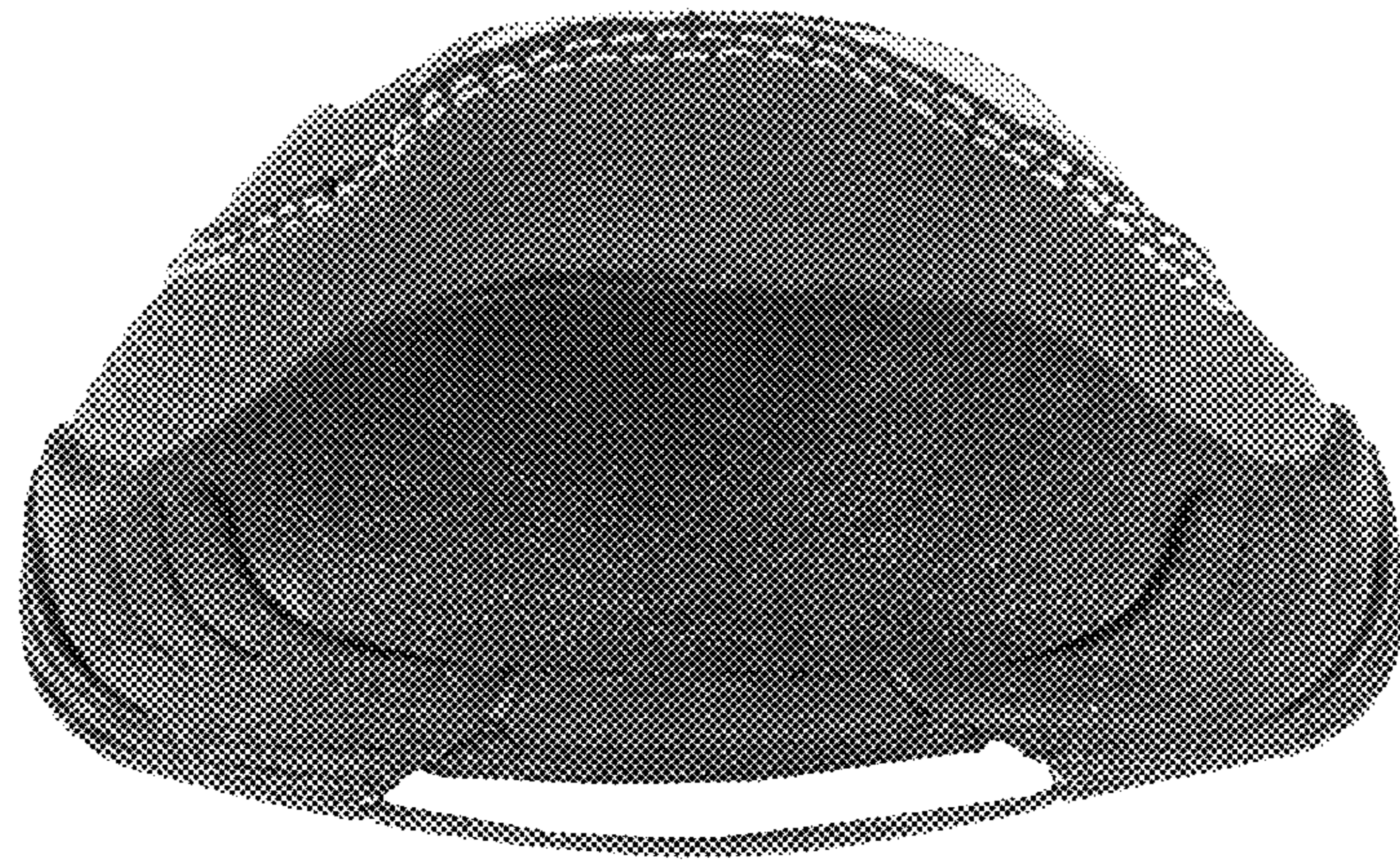
