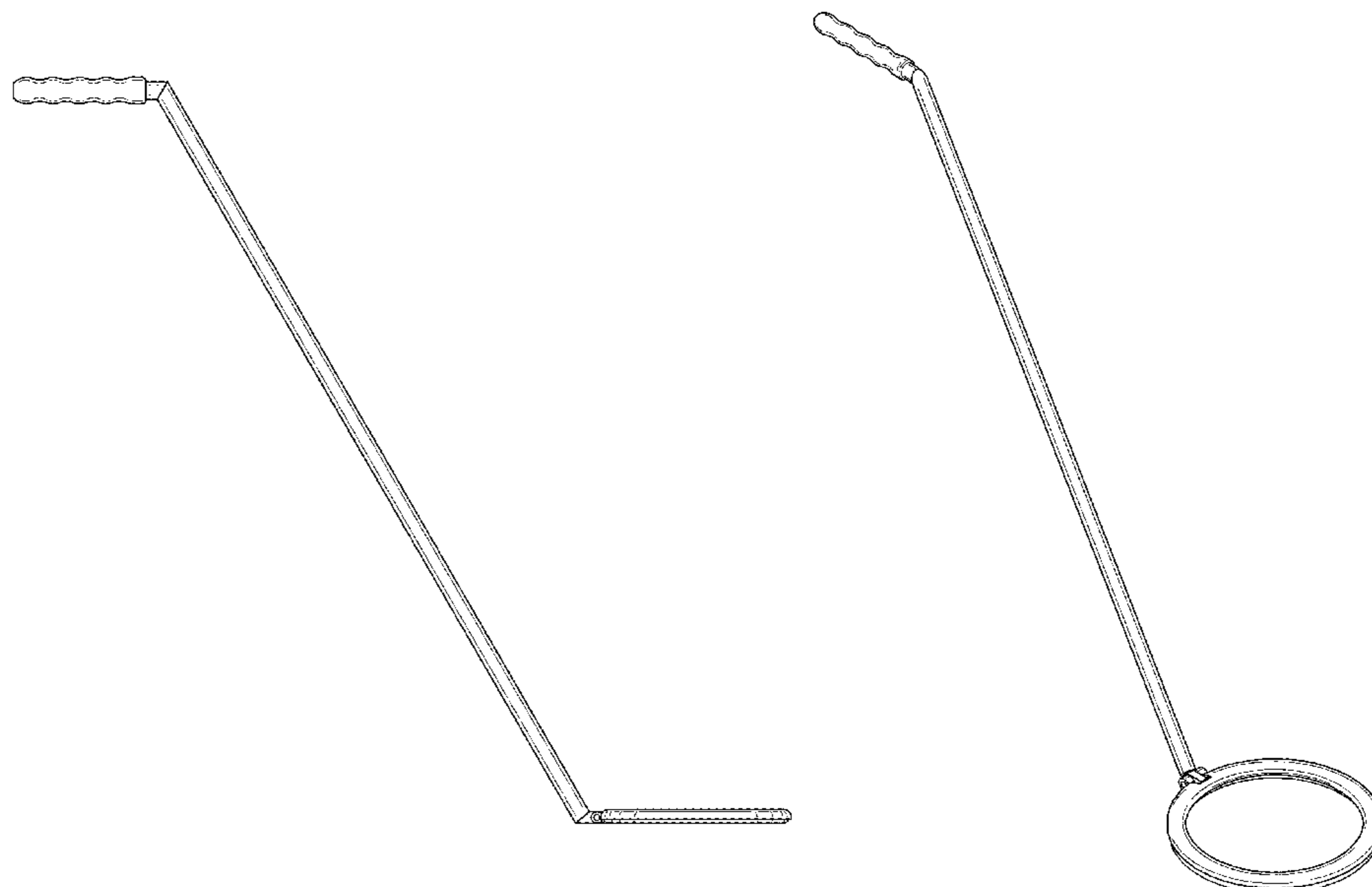
(57) **CLAIM**

The ornamental design for a feces disposal bag holder, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a feces disposal bag holder showing my new design, a back view being a mirror image thereof; FIG. 2 is a left side view of the feces disposal bag holder; FIG. 3 is a right side view of the feces disposal bag holder; FIG. 4 is a top view of the feces disposal bag holder; FIG. 5 is a bottom view of the feces disposal bag holder; and, FIG. 6 is a top front side perspective view of the feces disposal bag holder.

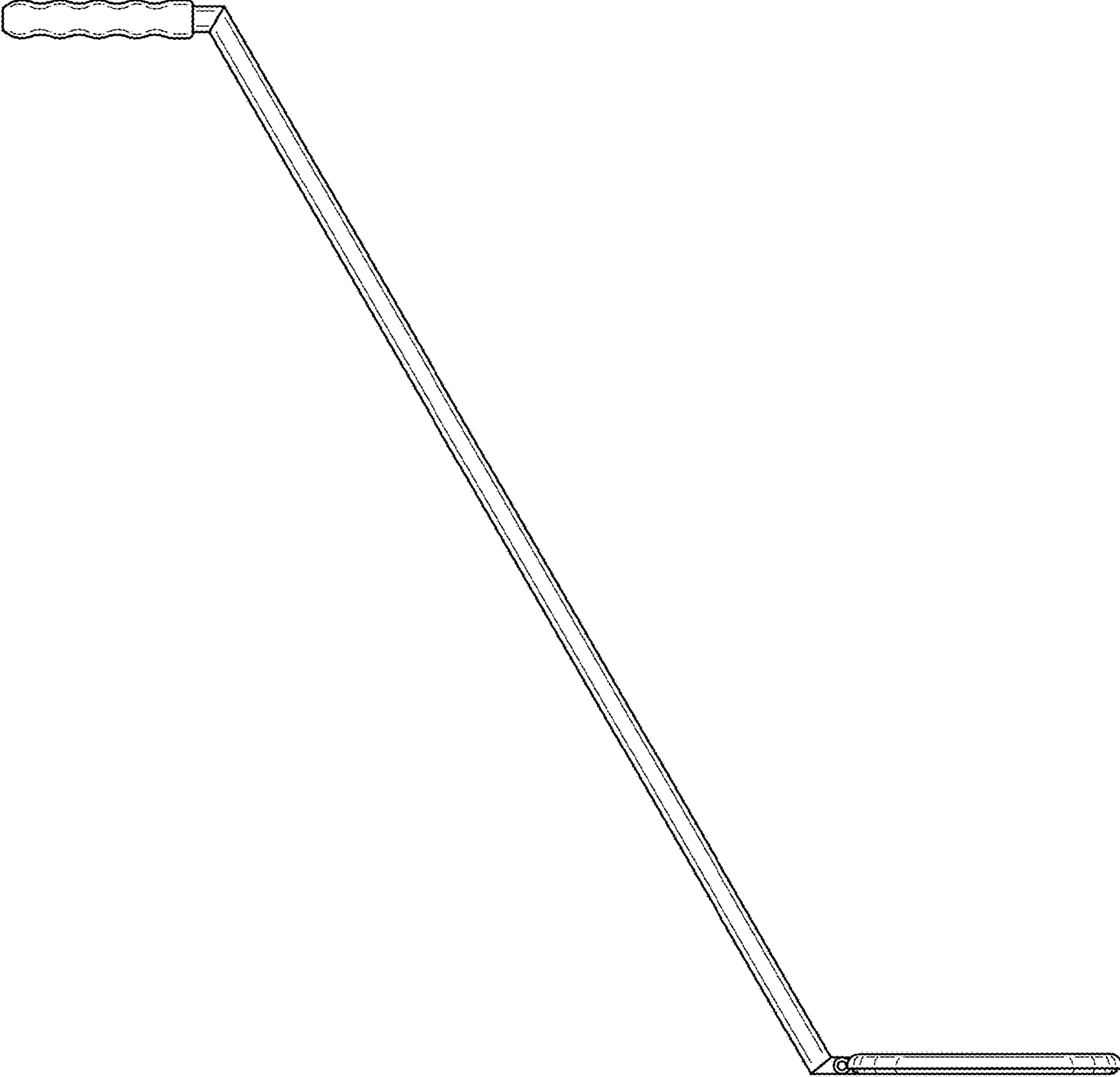

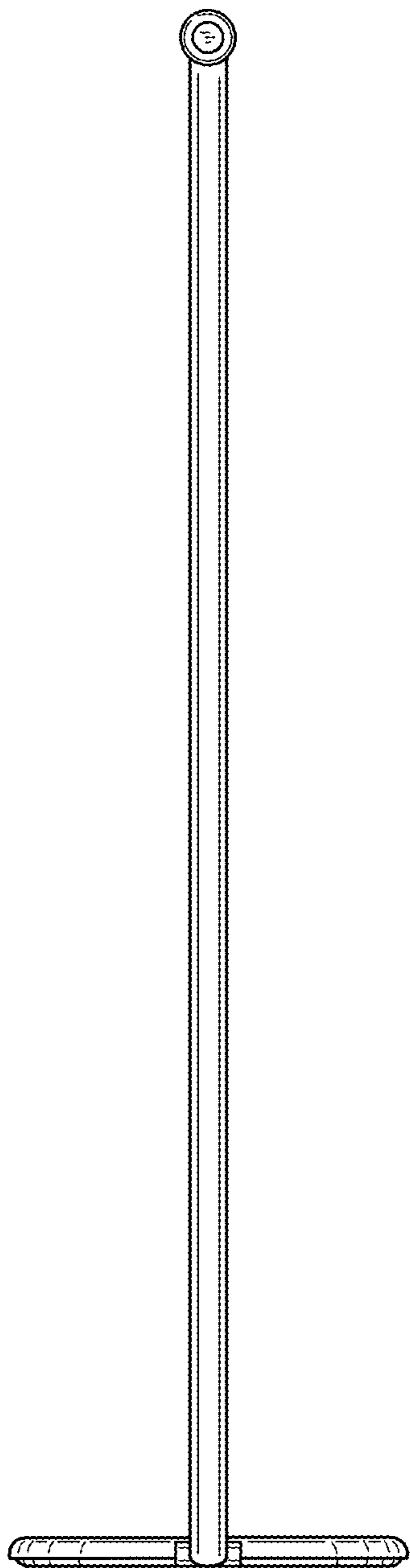

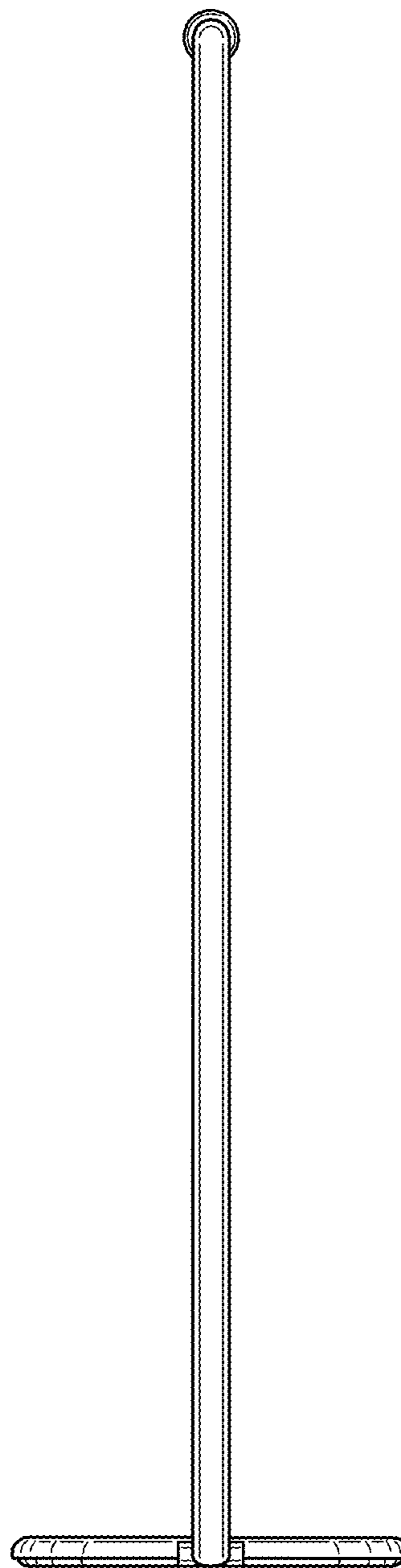

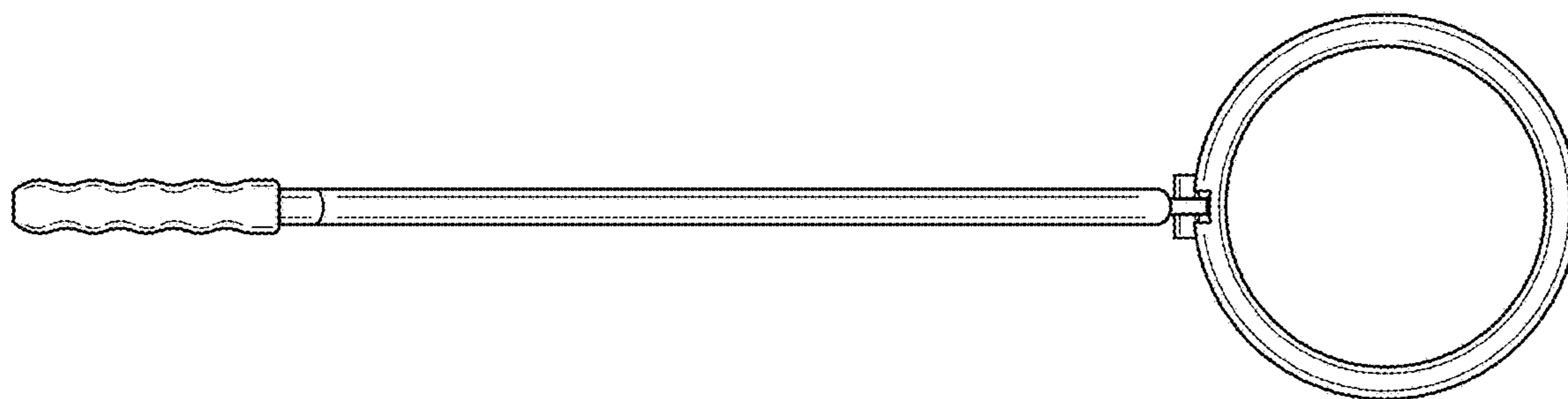

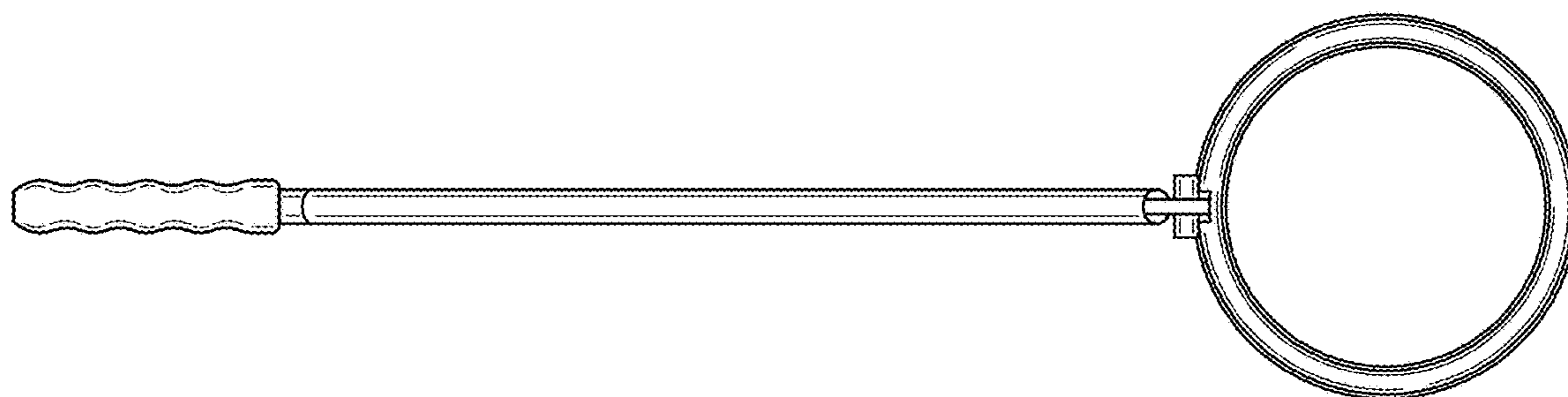
