(57) **CLAIM**

The ornamental design for a garment, as shown and described.

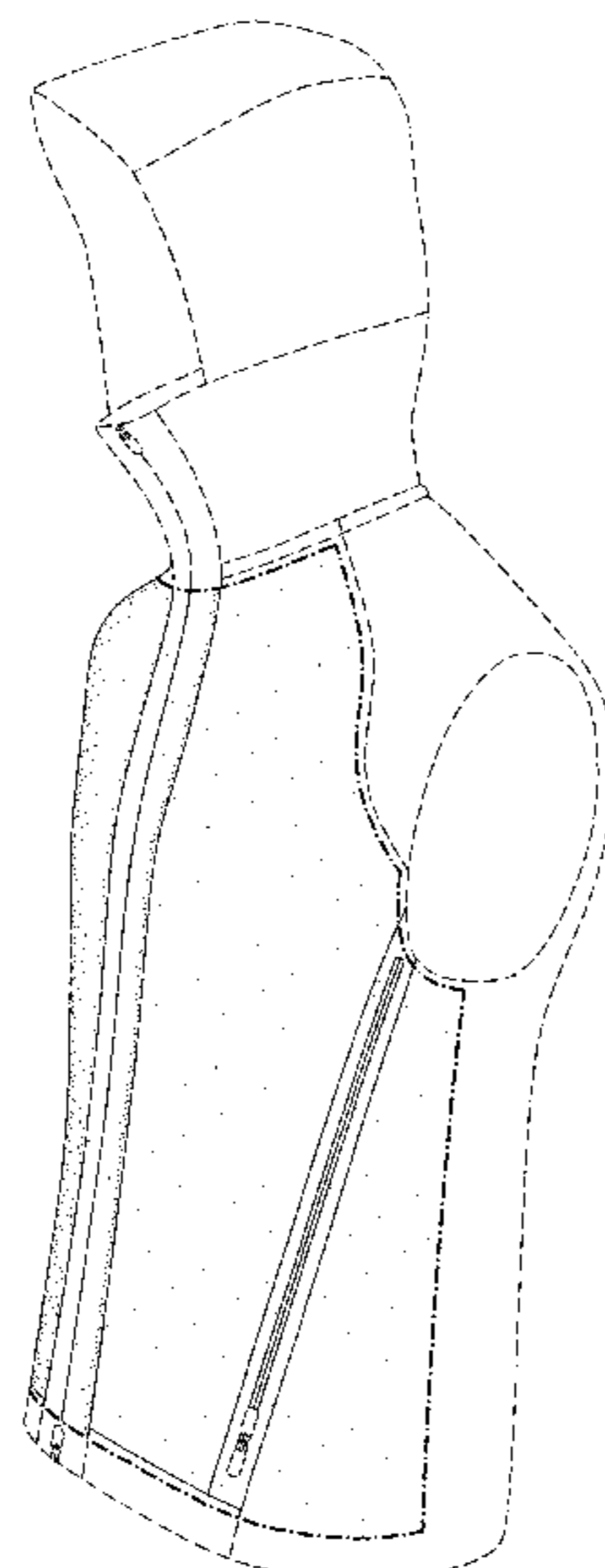
DESCRIPTION

FIG. 1 is a front, right perspective view of a garment showing a first embodiment of the present design in an in-use configuration;
FIG. 2 is a front, left perspective view thereof;
FIG. 3 is a first side view thereof;
FIG. 4 is a second side view thereof;
FIG. 5 is a front view thereof;
FIG. 6 is a front view of the garment of FIG. 1 showing the first embodiment of the present design in a laid-flat configuration; and,
FIG. 7 is a back view thereof.

The broken lines with alternating dashes and dots, immediately adjacent to the shaded area, represent unclaimed boundaries of the design. The unshaded regions, demarcated by broken lines, represent unclaimed portions of the garment and form no part of the claimed design. The broken lines, which include even-length segments, that show the remainder of the garment, are for environmental purposes only and form no part of the claimed design. The shading represents the contour or curvature of the surfaces and does not represent any particular color, material, texture, or finish.

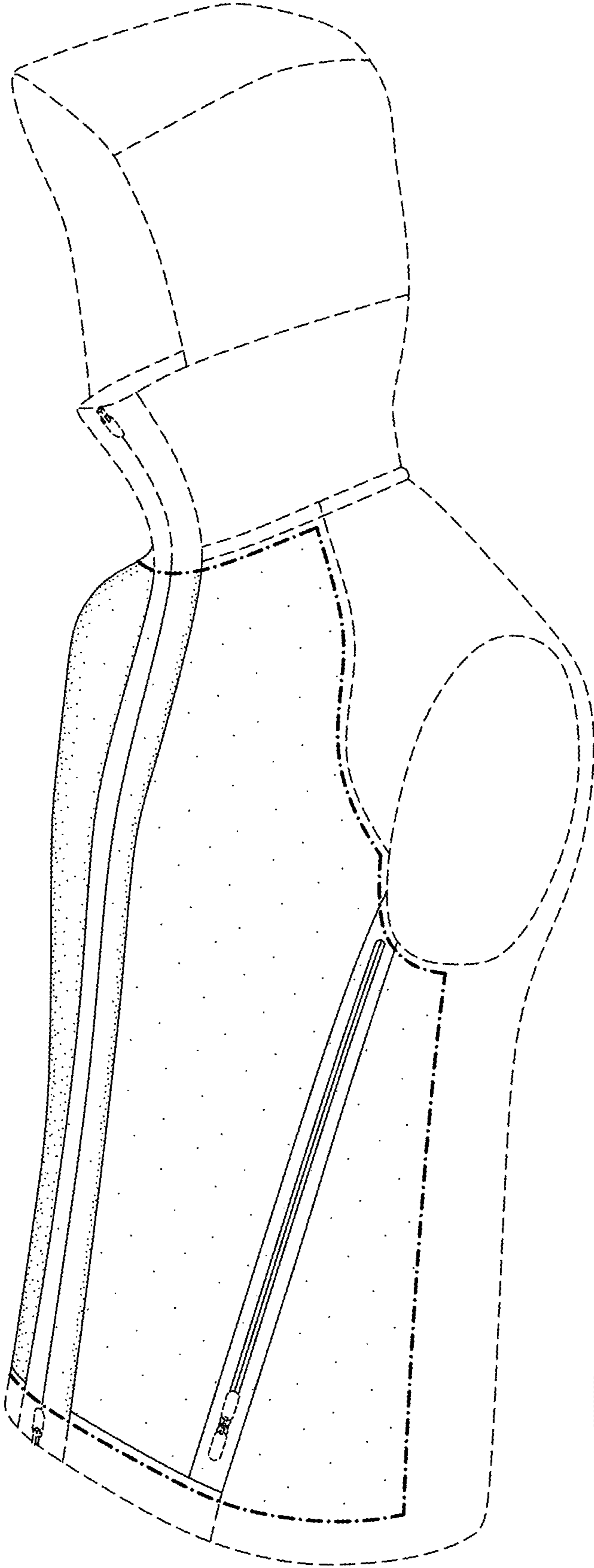

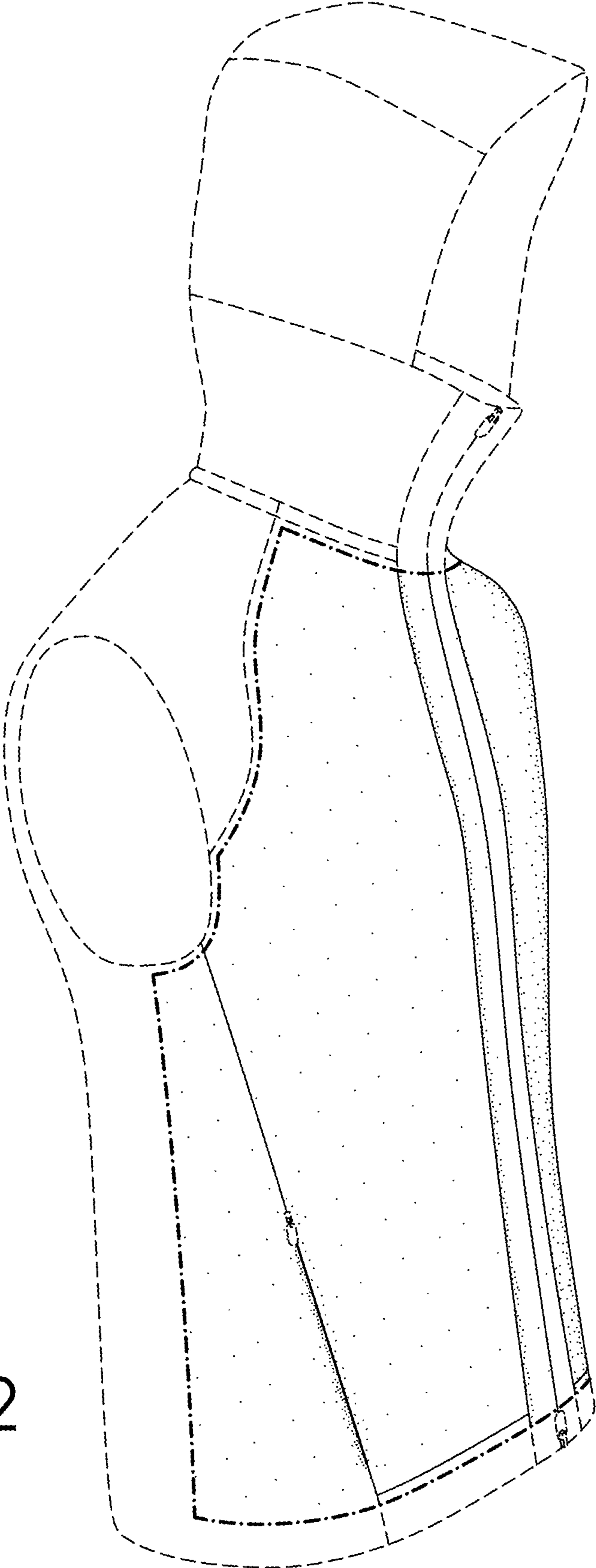

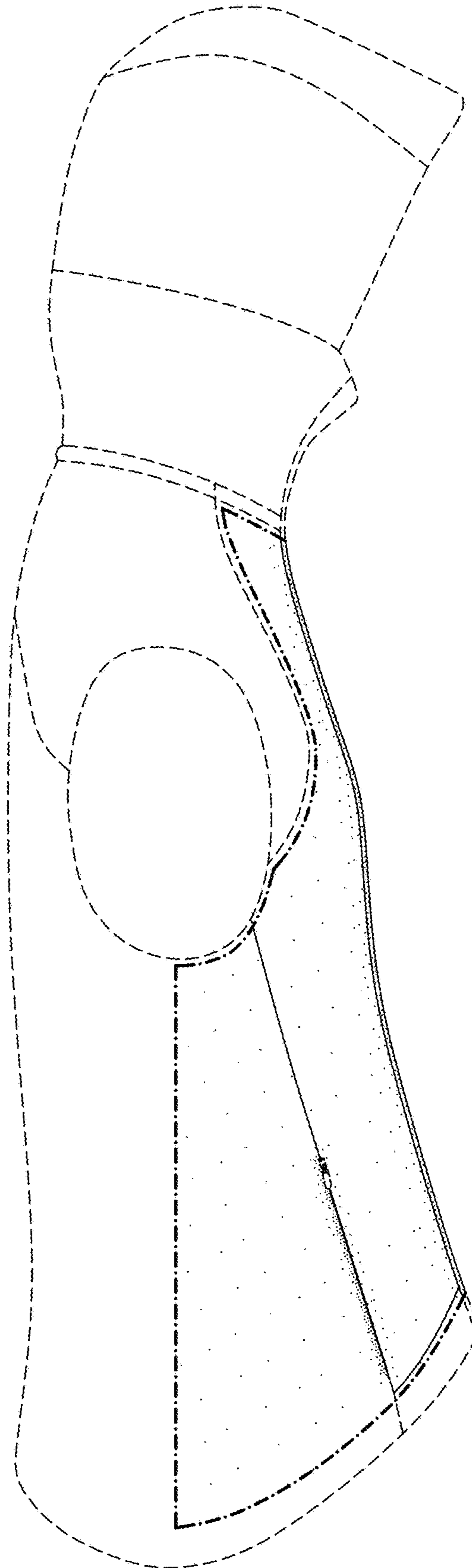

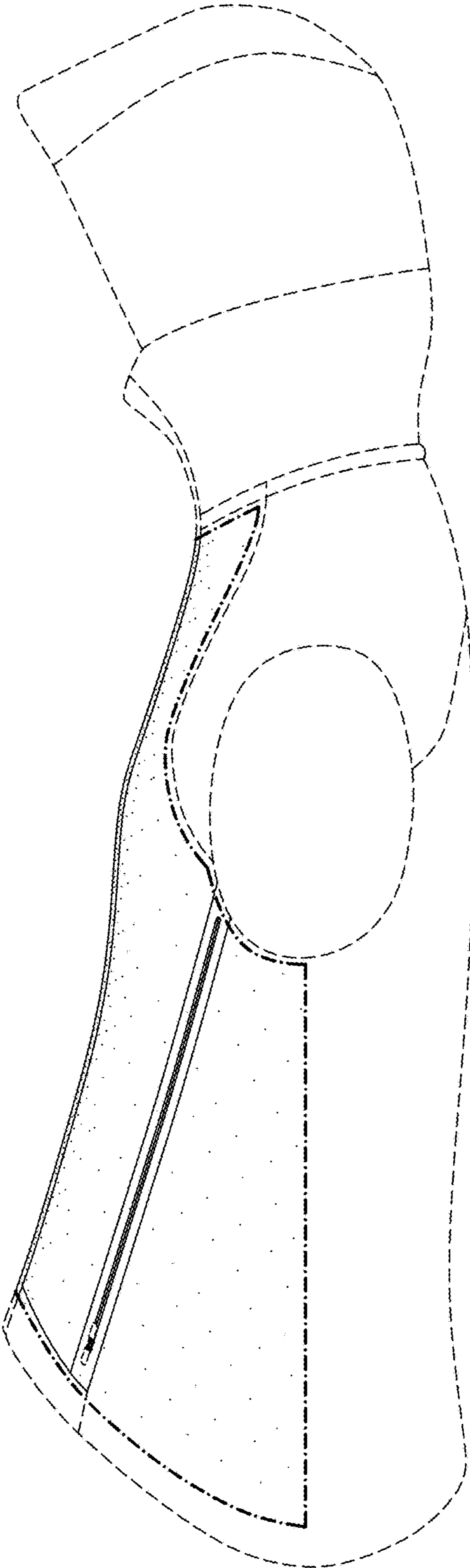

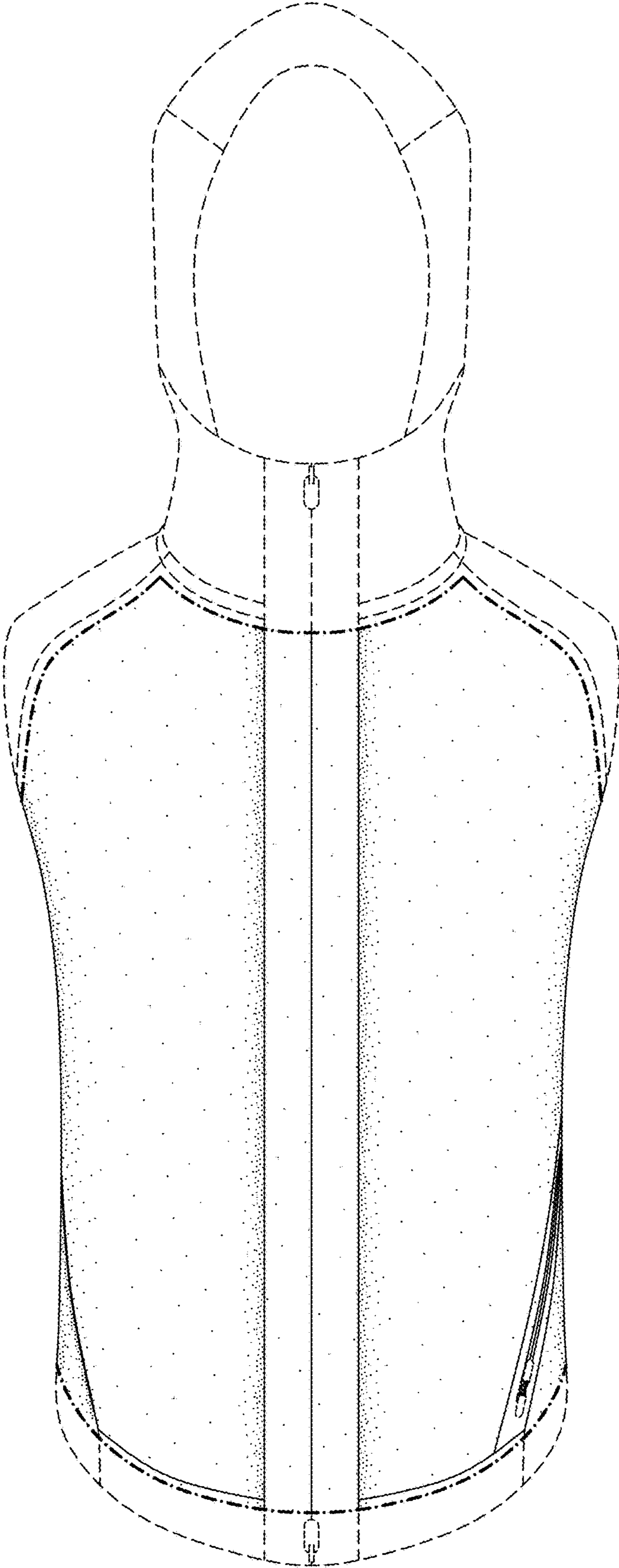

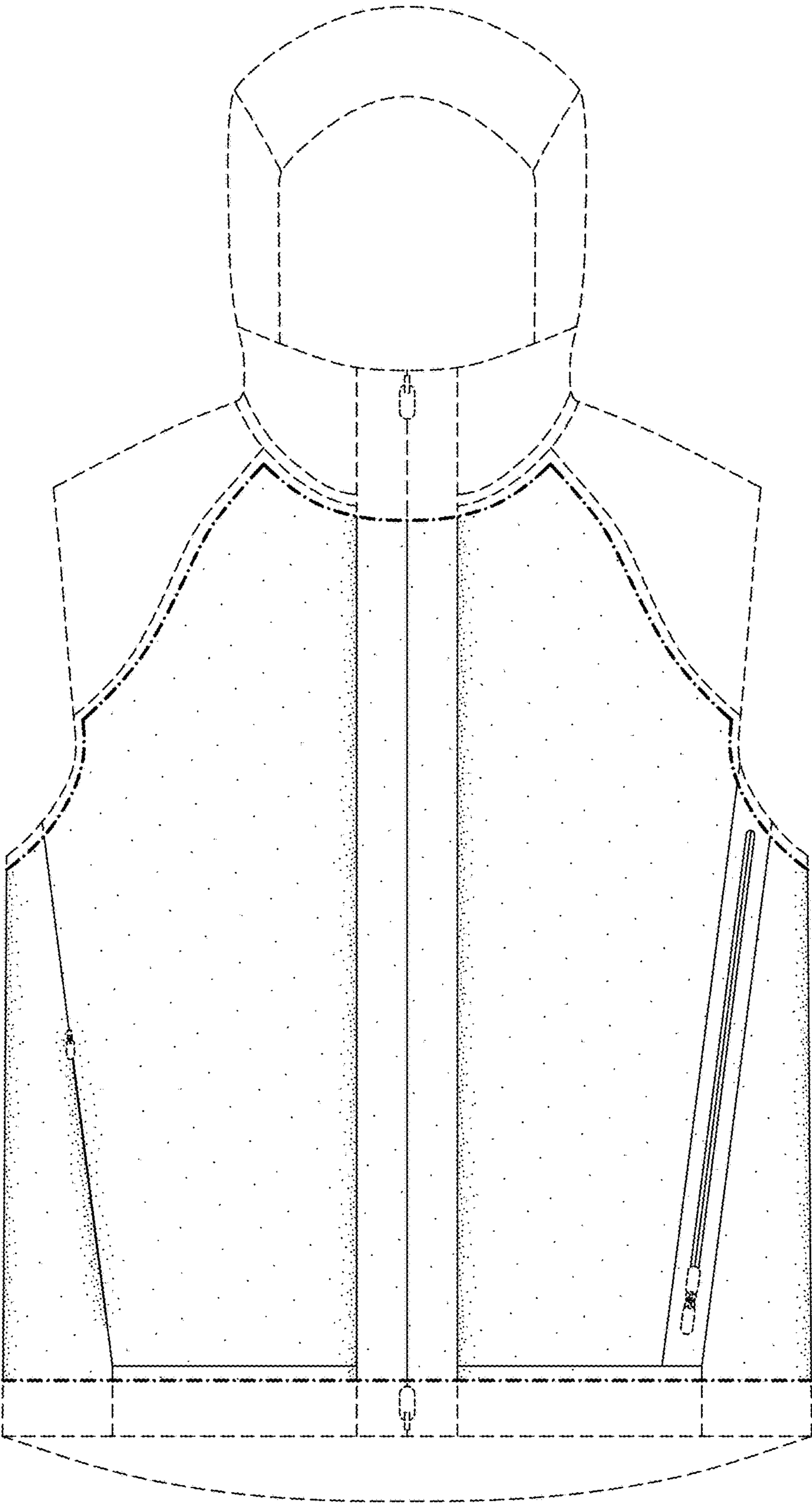

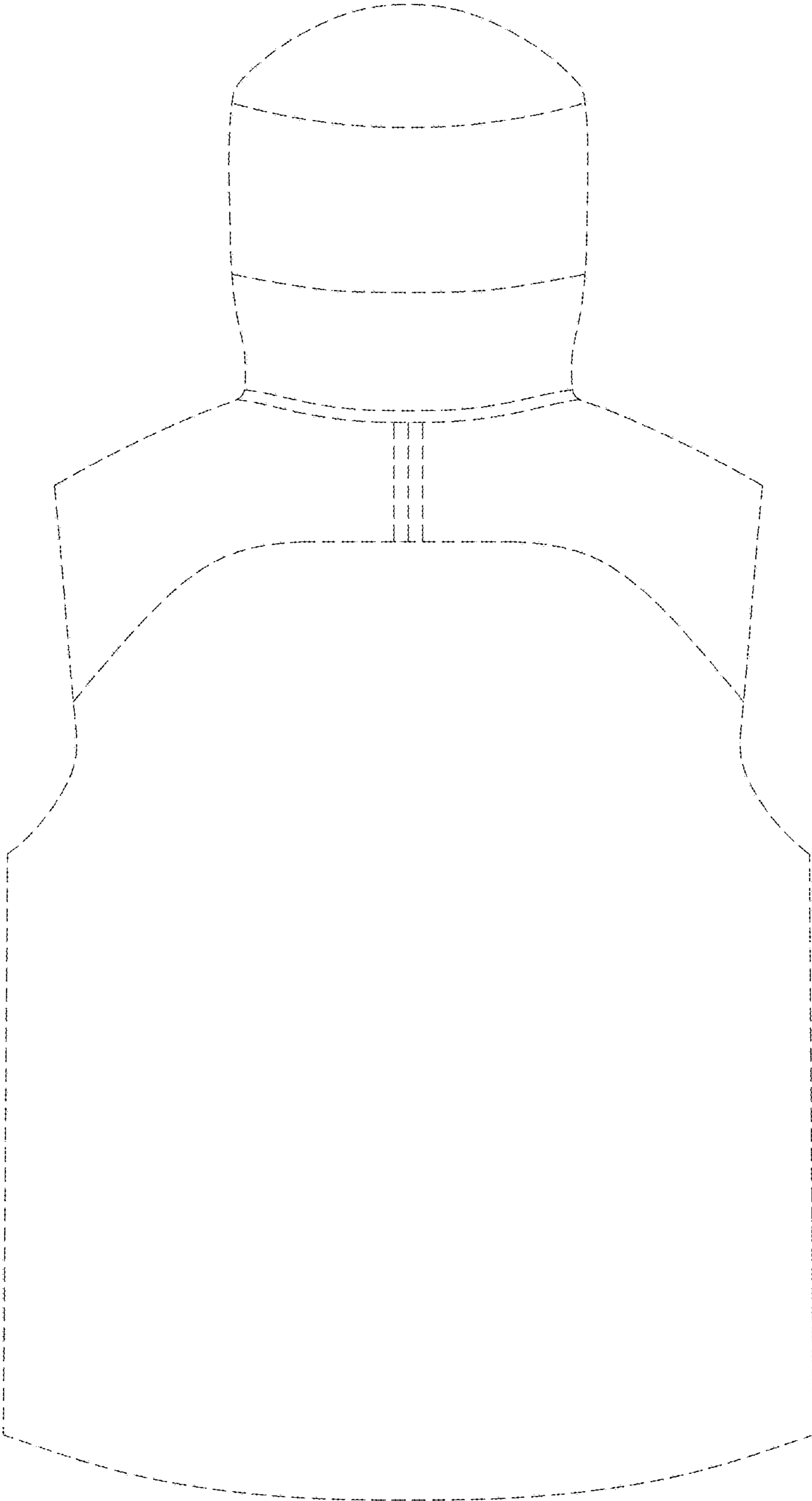
